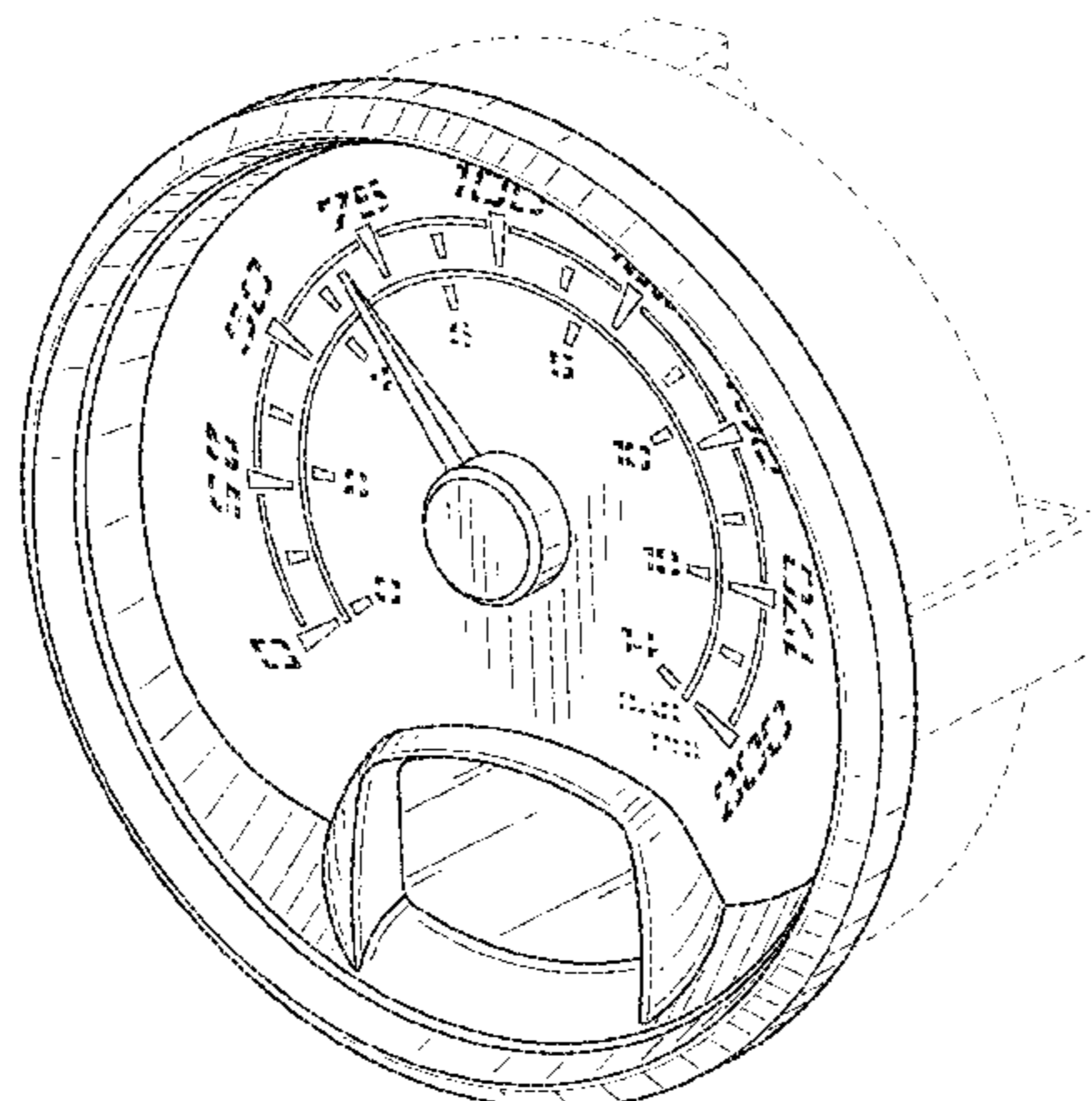
(57) **CLAIM**

We claim the ornamental design for a gauge, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a gauge embodying the invention;

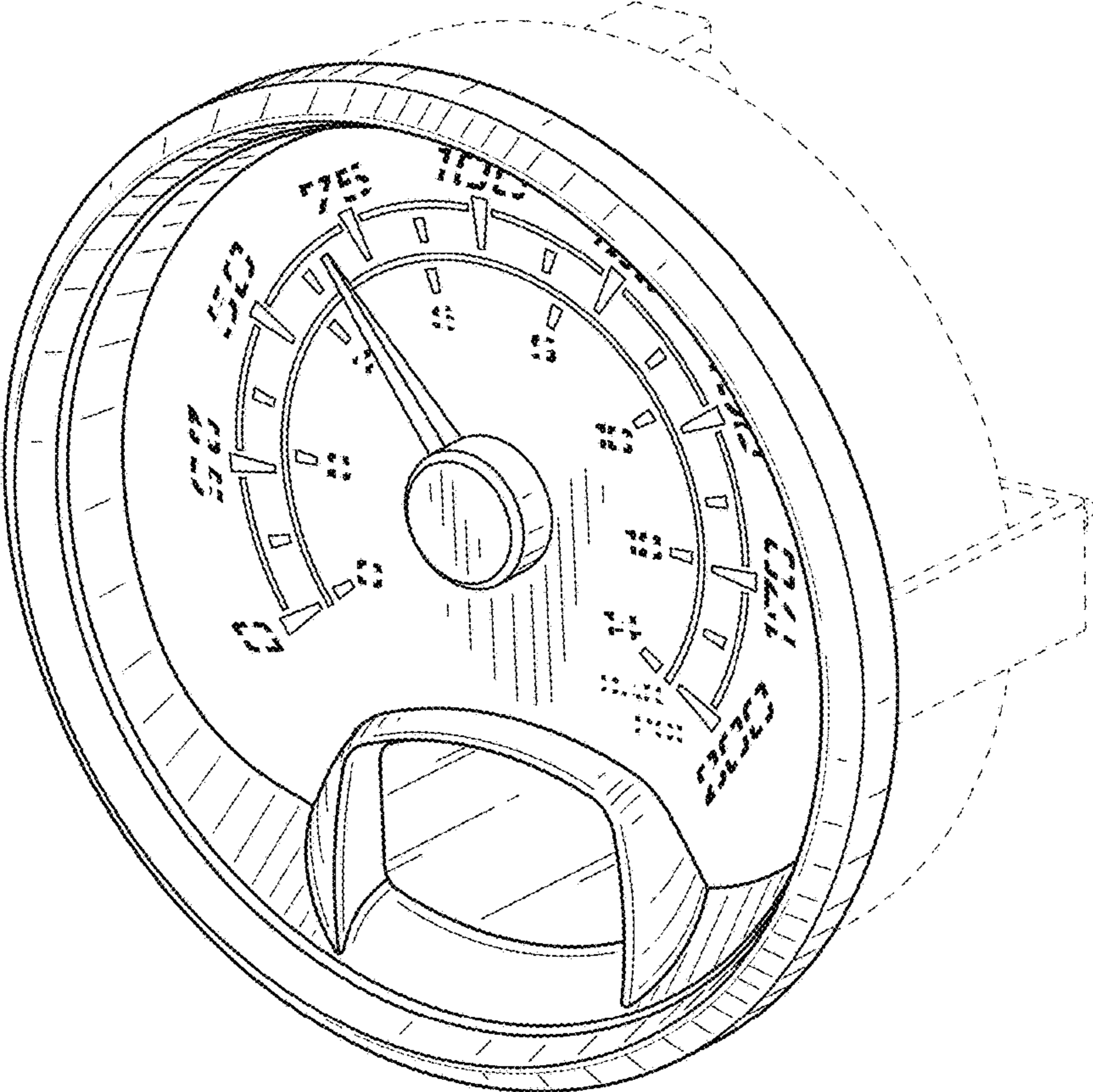

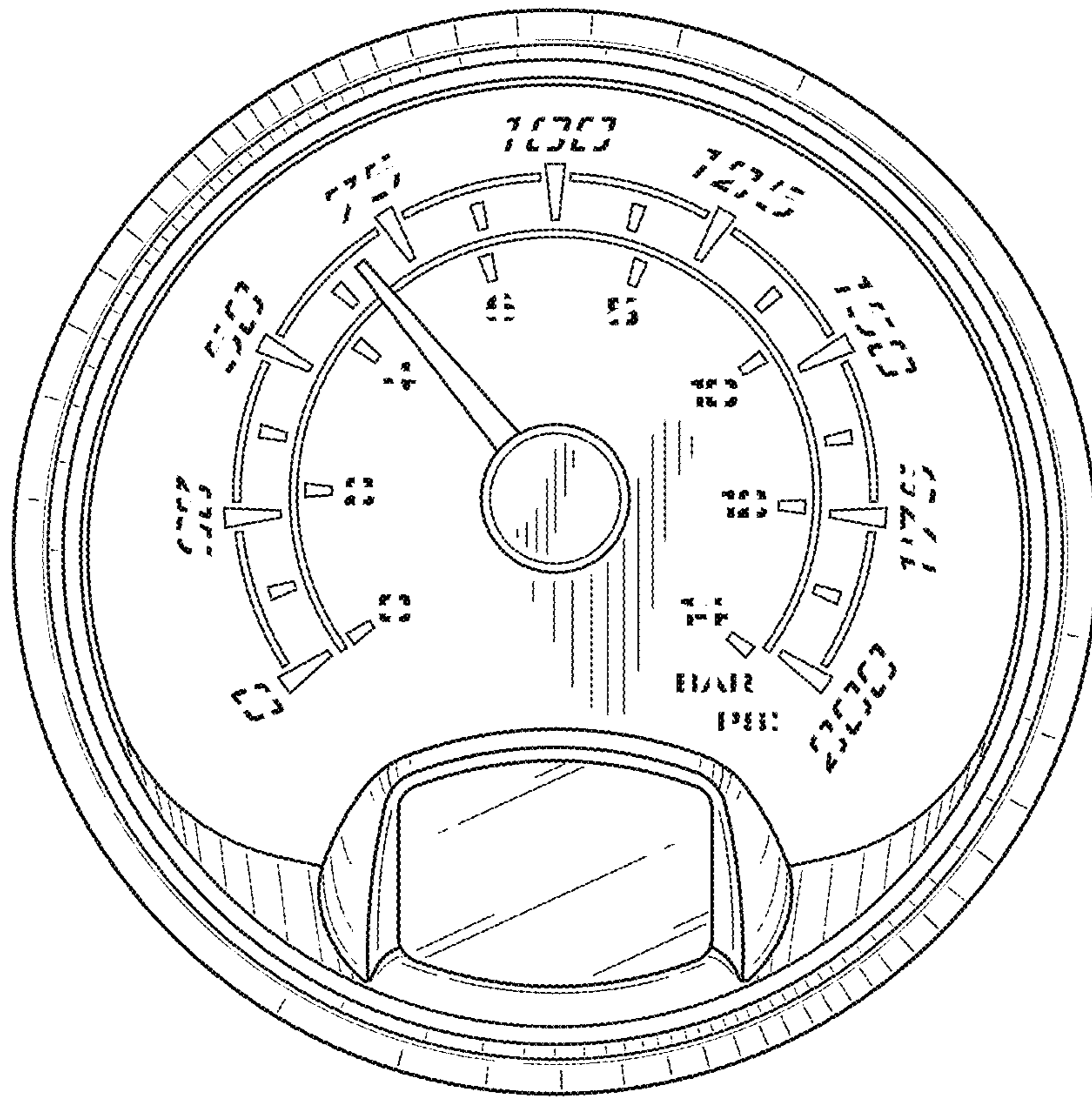

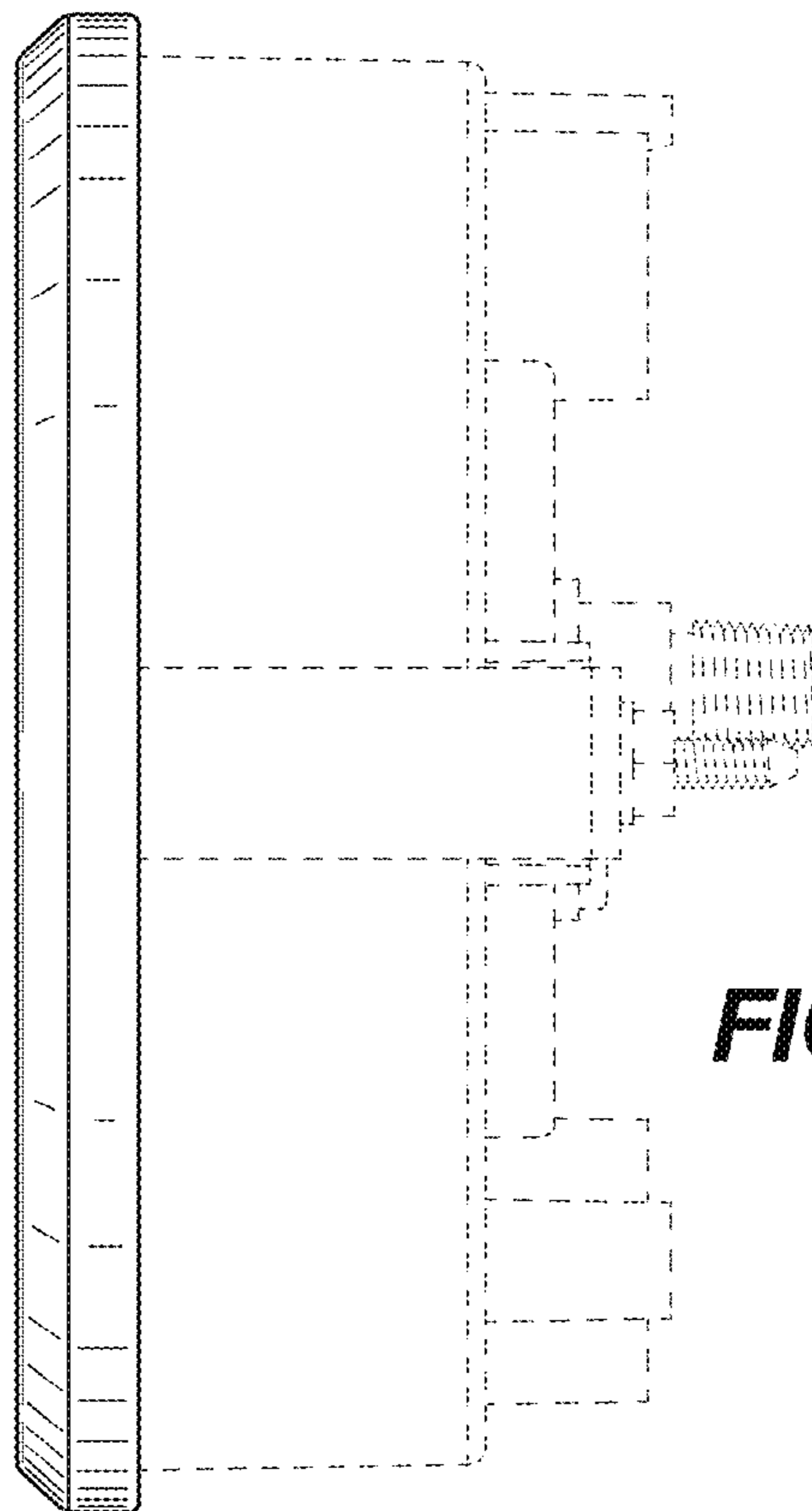
