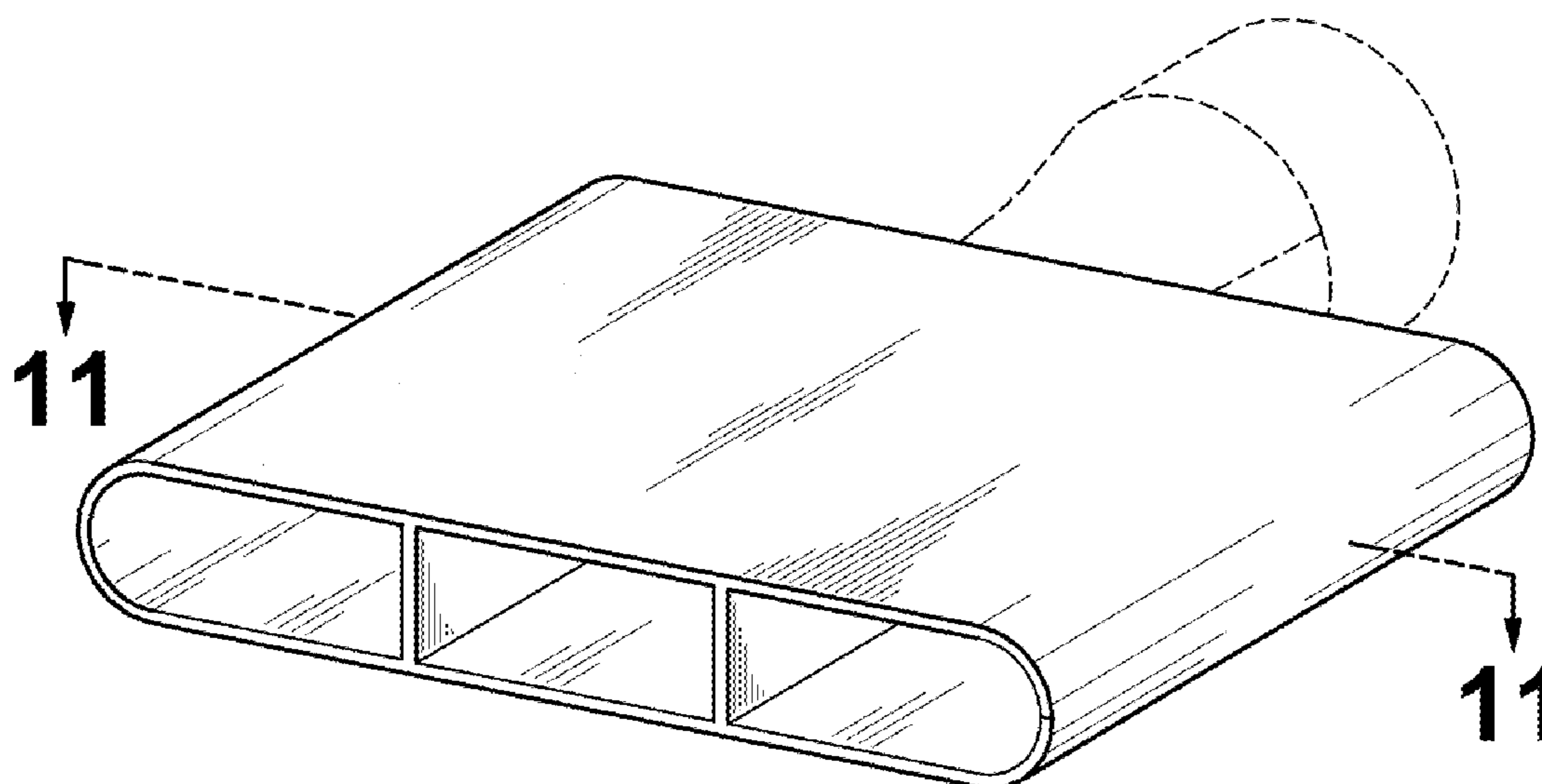
(57) **CLAIM**

The ornamental design for an exhaust tip, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front, top side perspective view of the exhaust tip showing the new design;
 FIG. 2 is a front, top right side perspective view thereof;
 FIG. 3 is a front, top left side perspective view thereof;
 FIG. 4 is a front elevation view thereof;

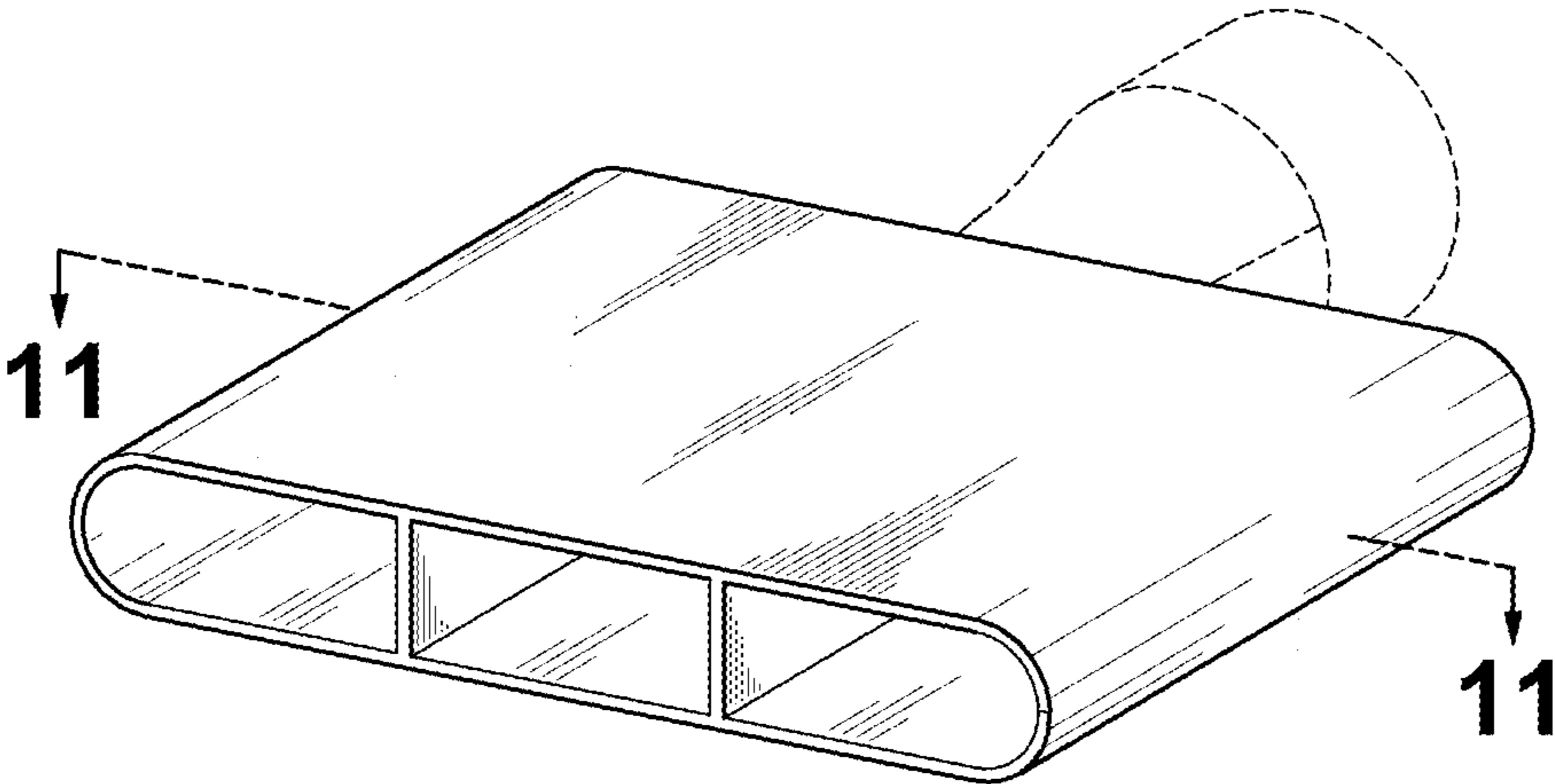

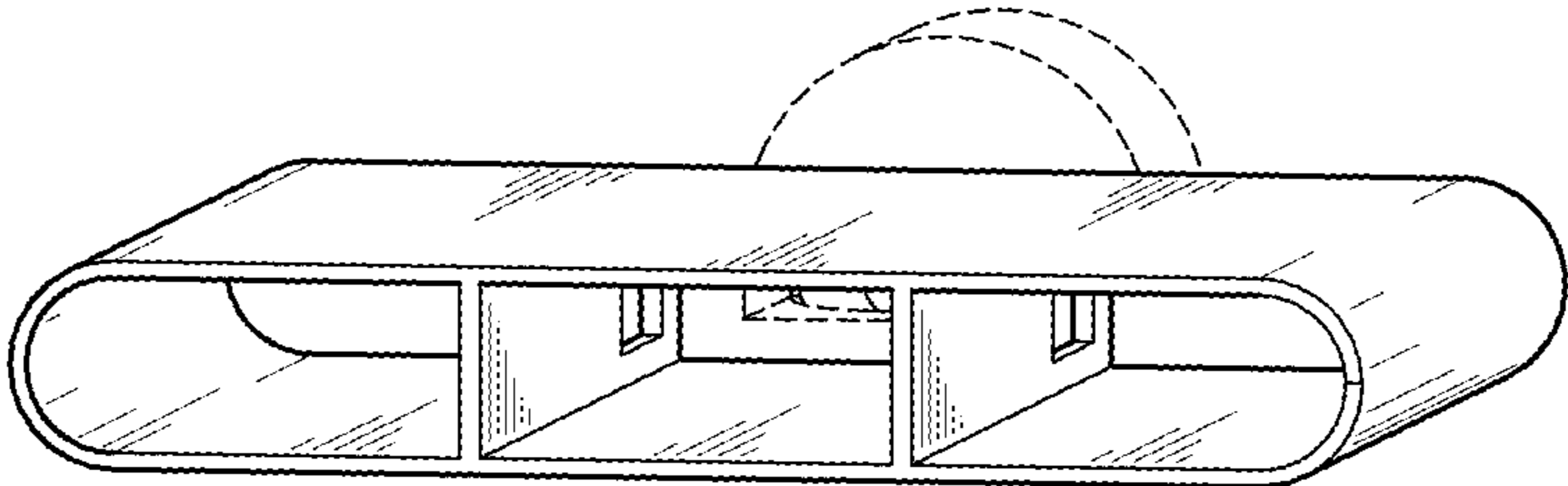

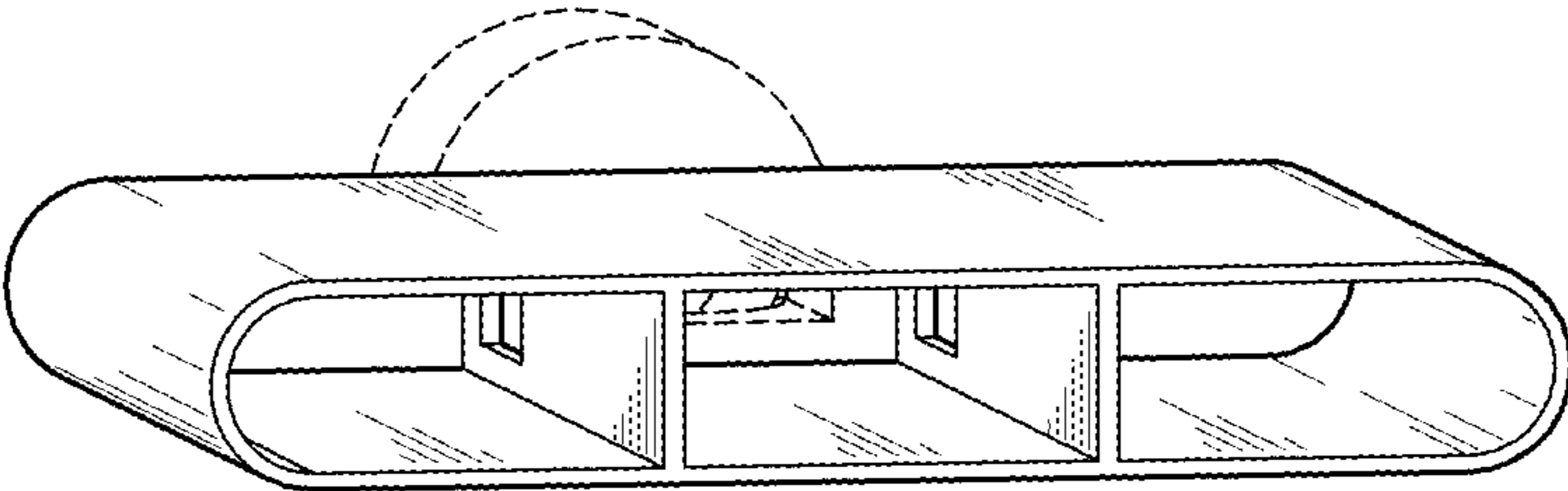

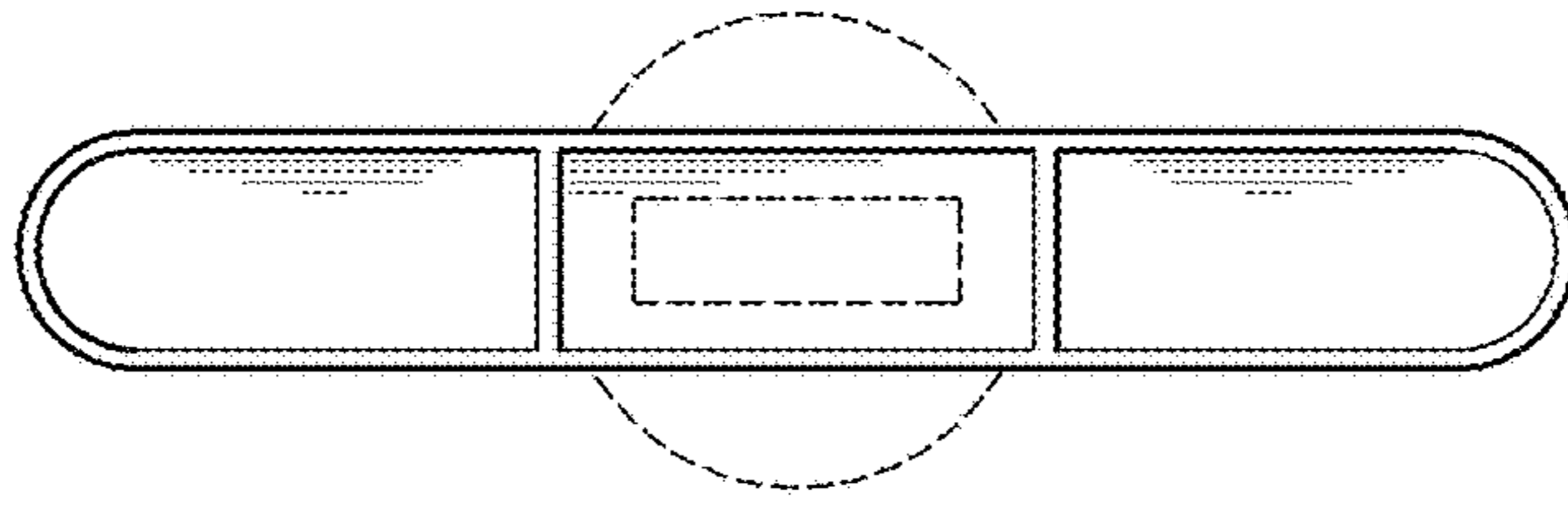

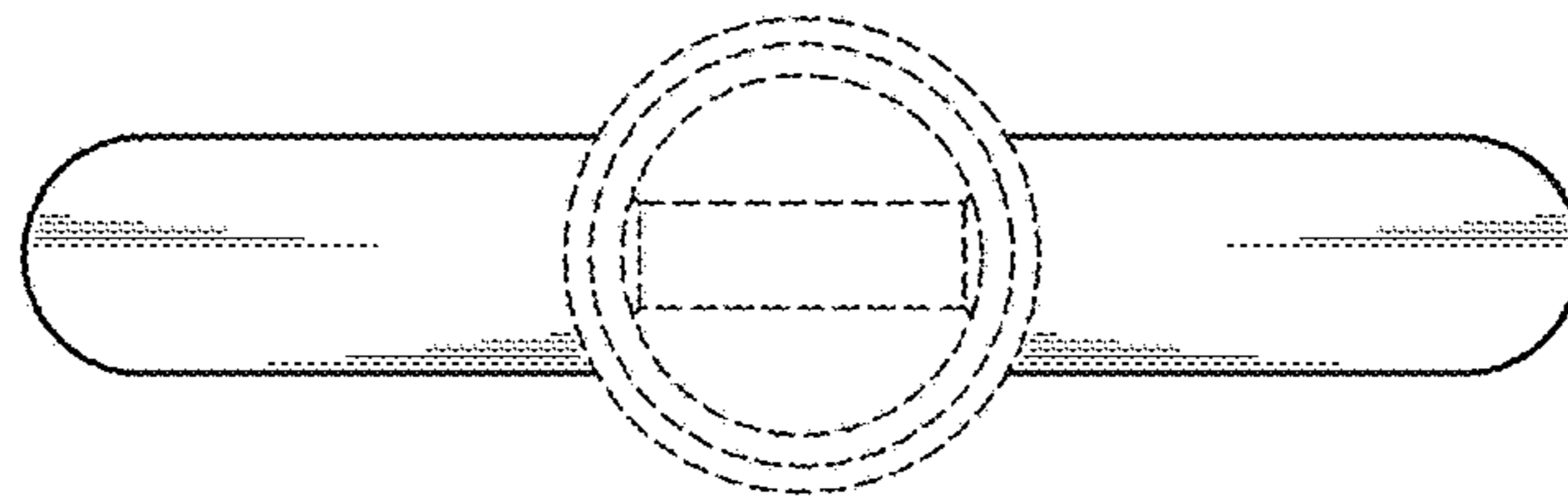

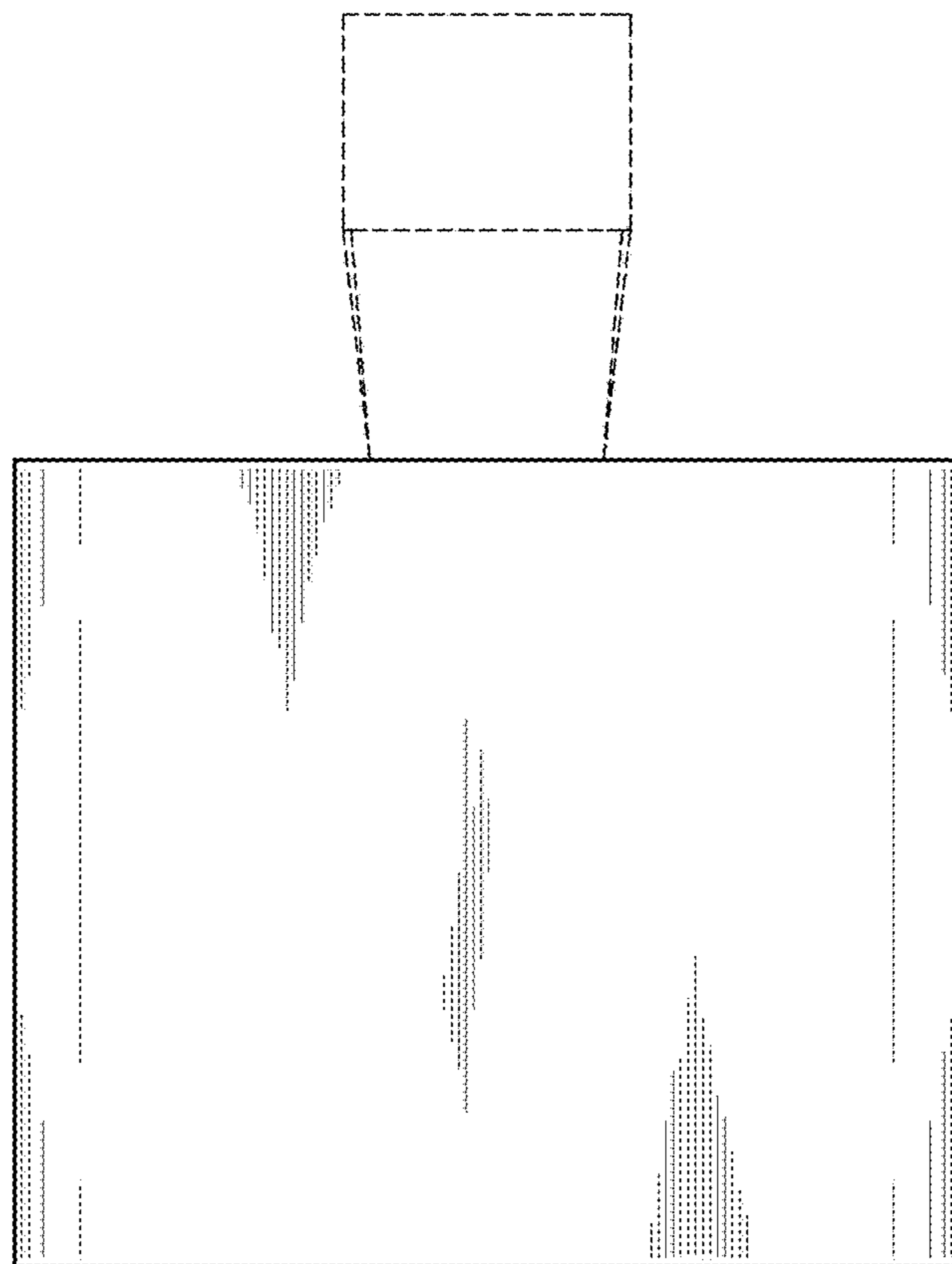

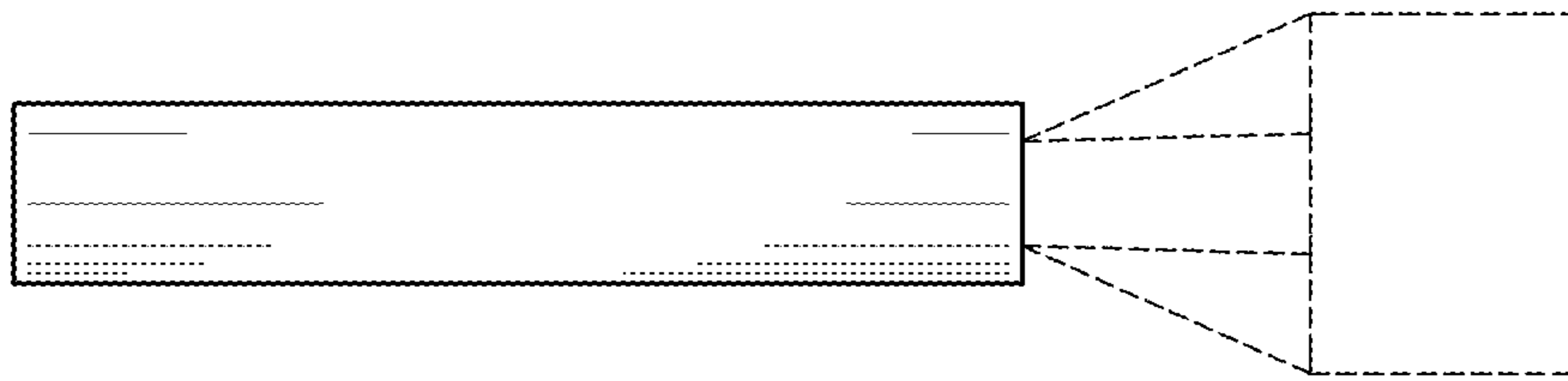

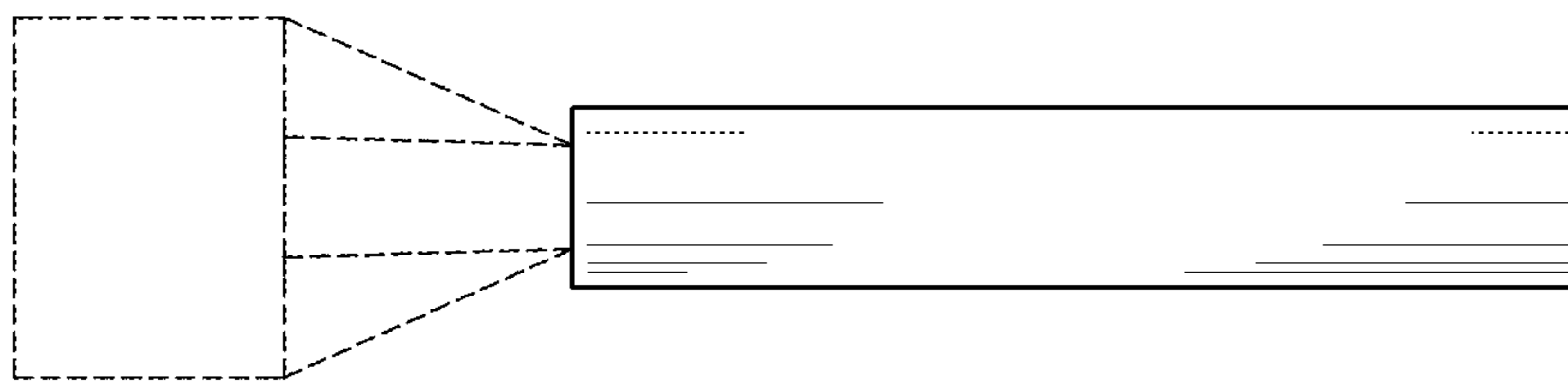

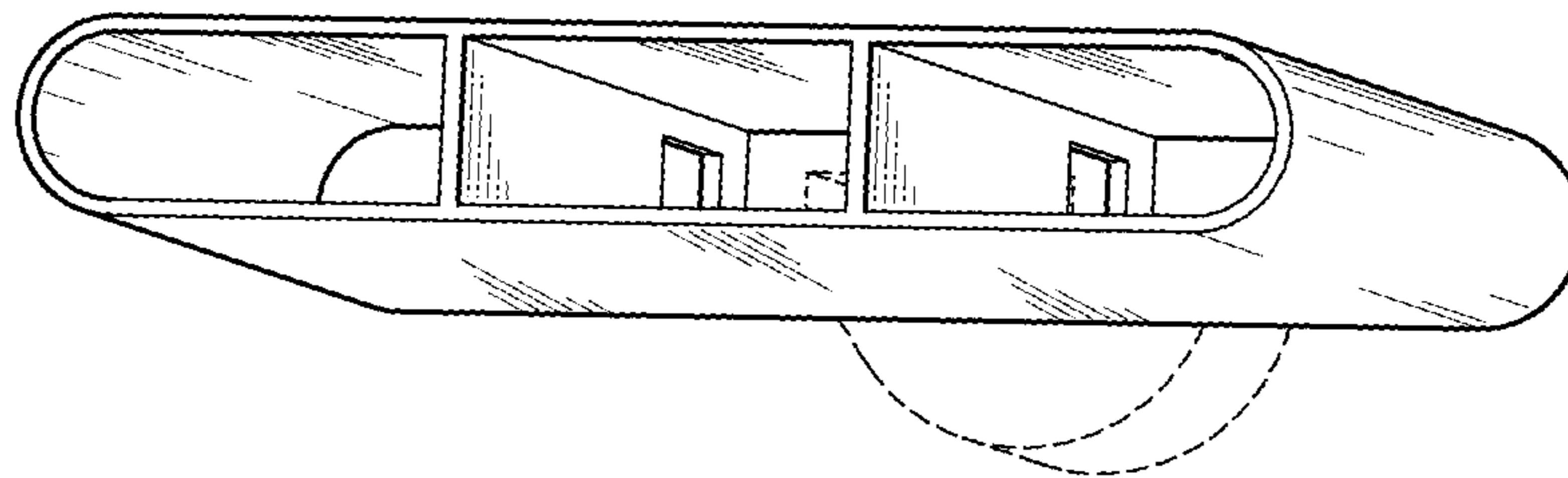

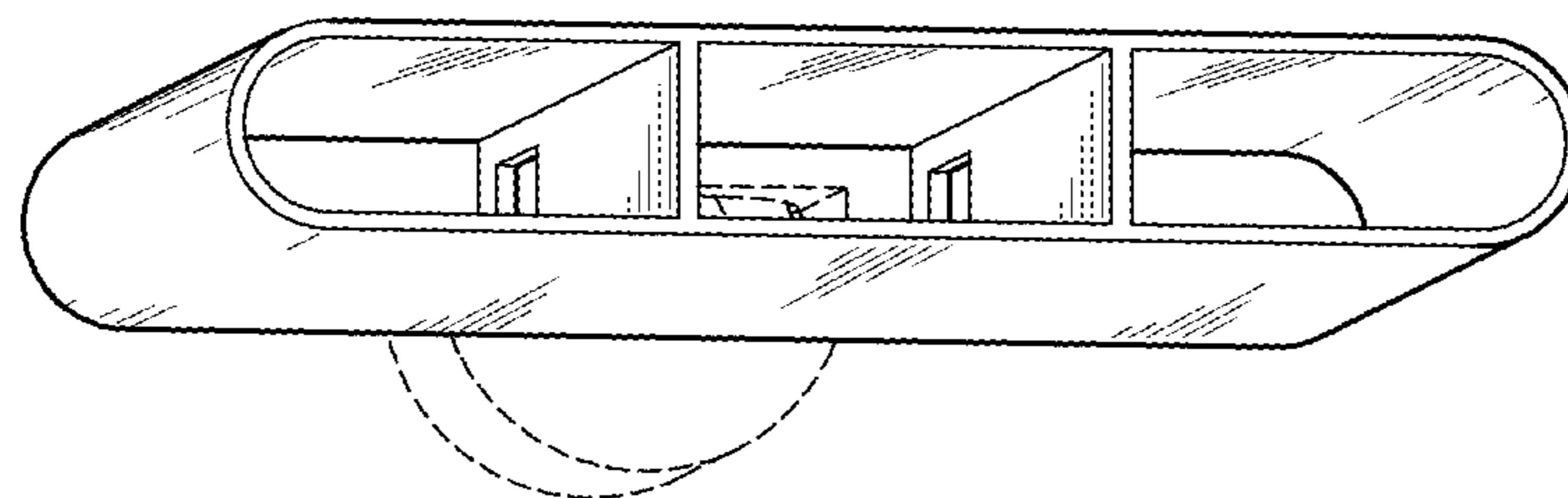

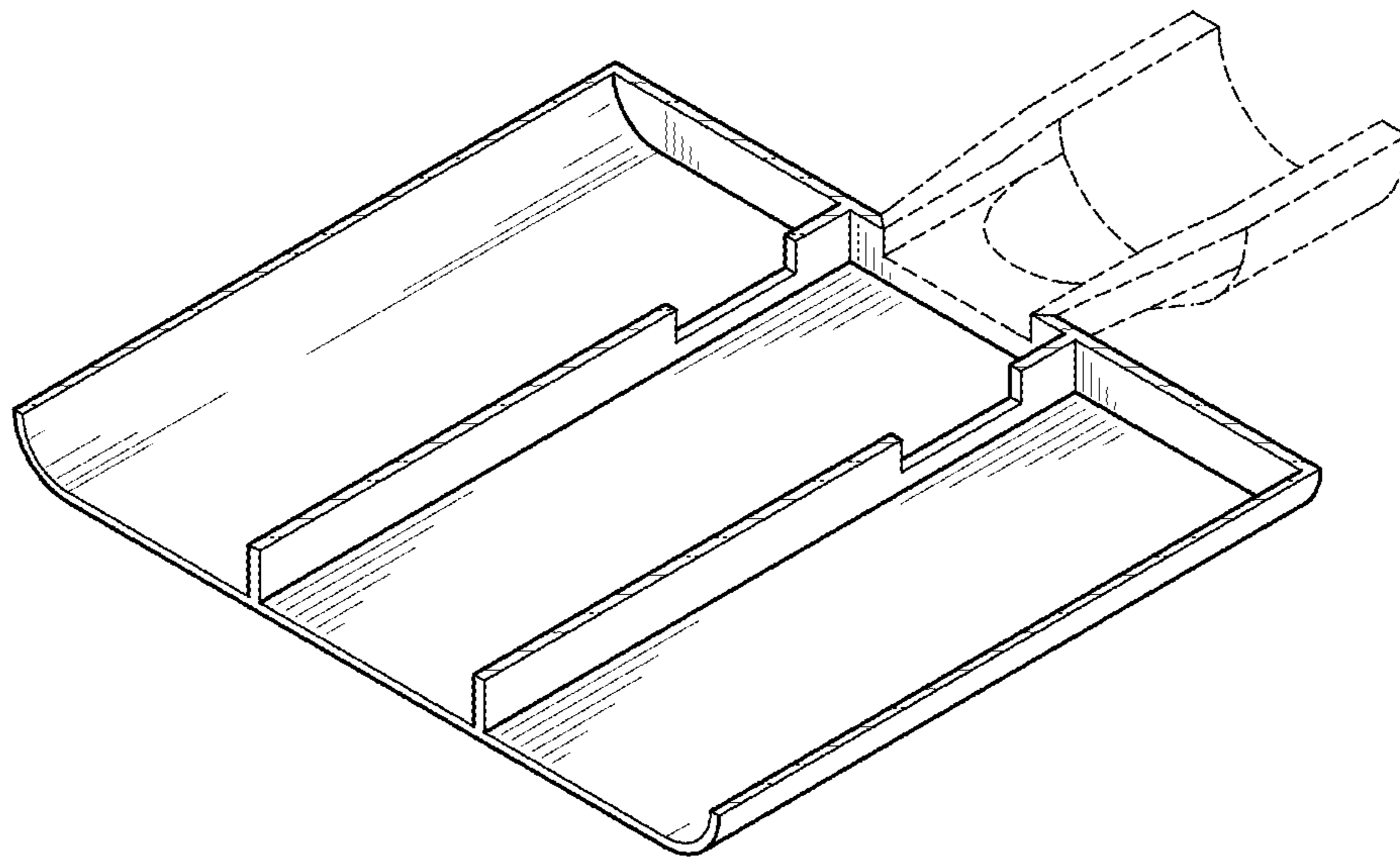
