DESCRIPTION

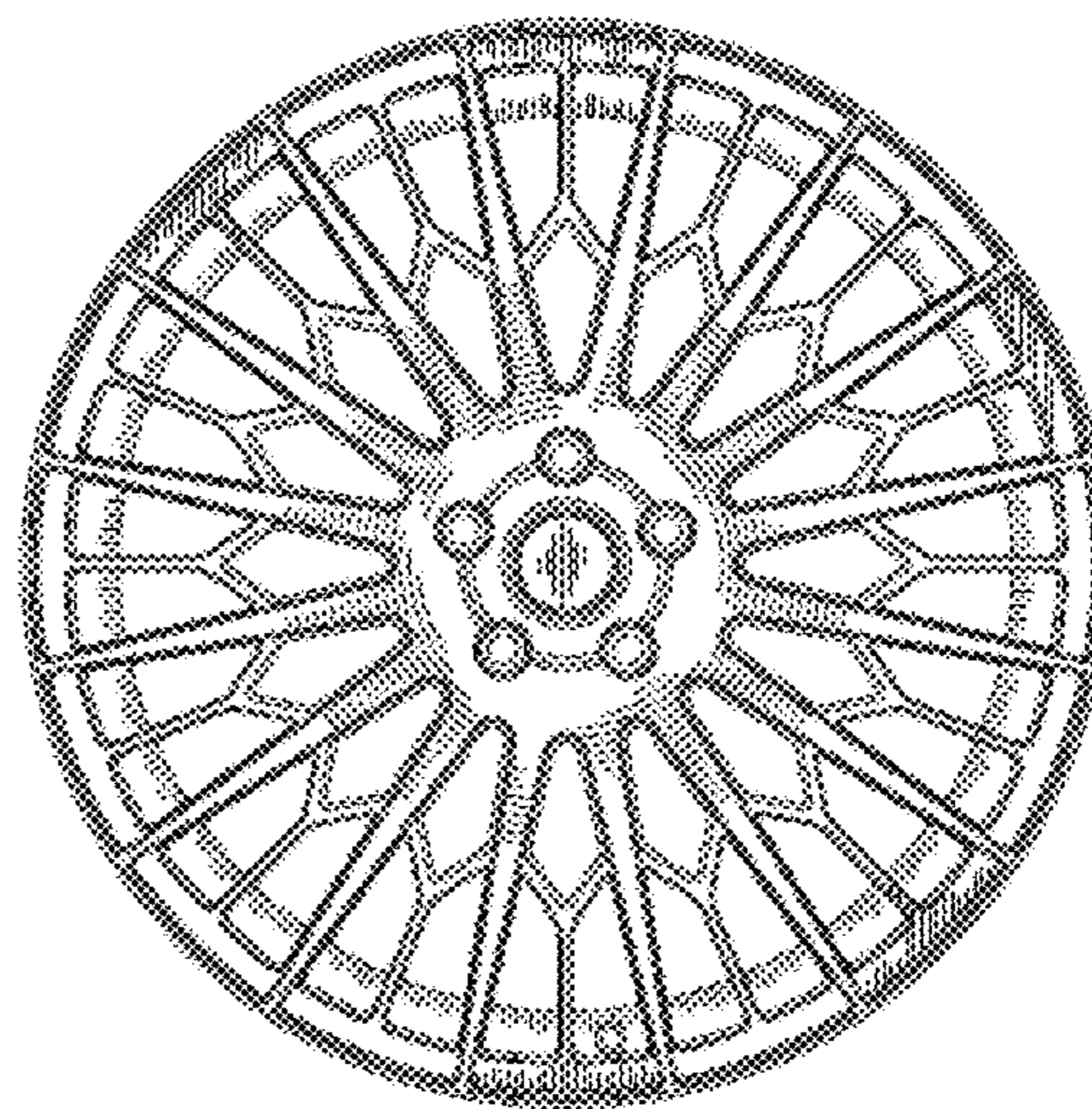
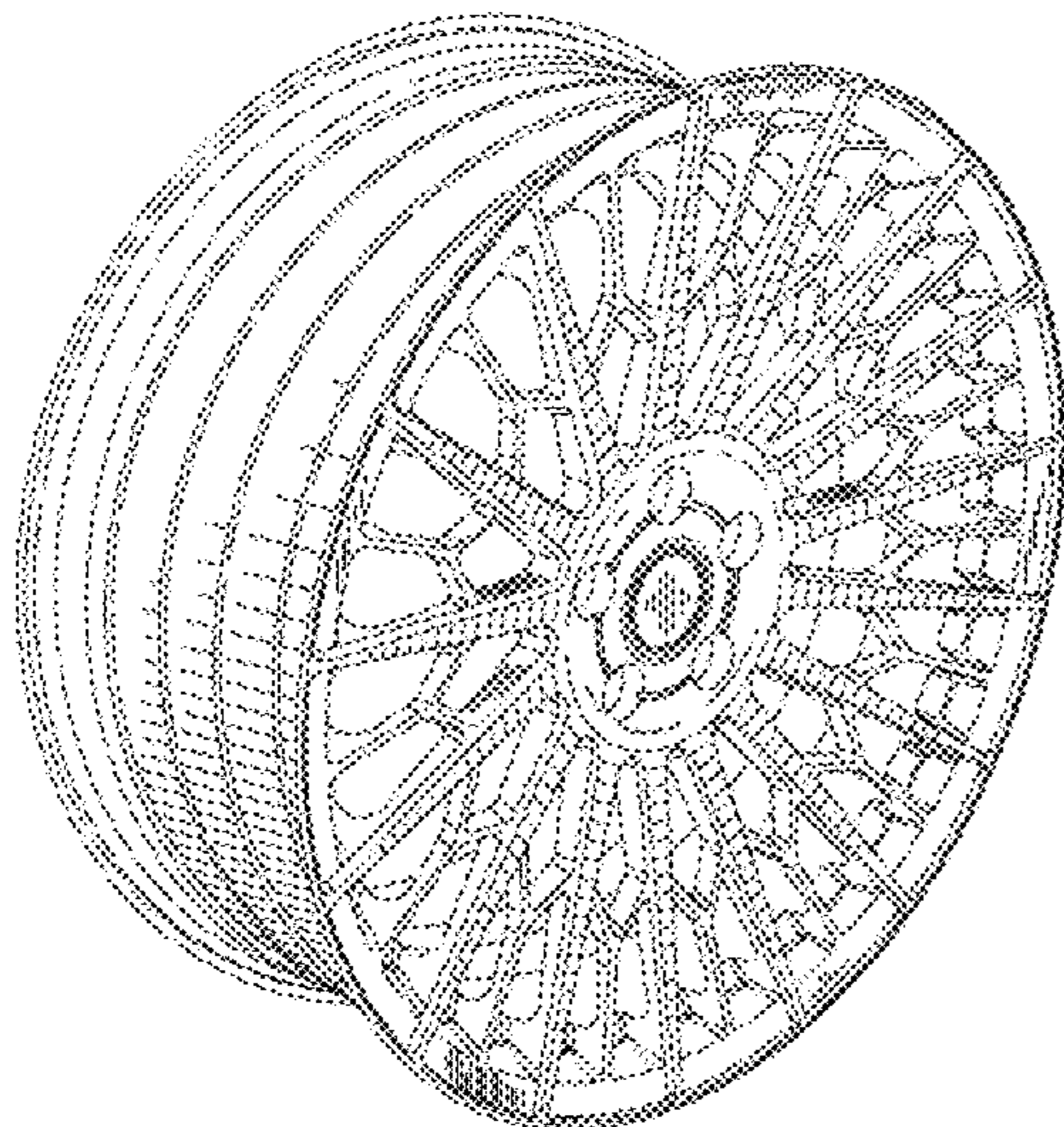
FIG. 1 is a perspective view of the vehicle wheel showing my new design;

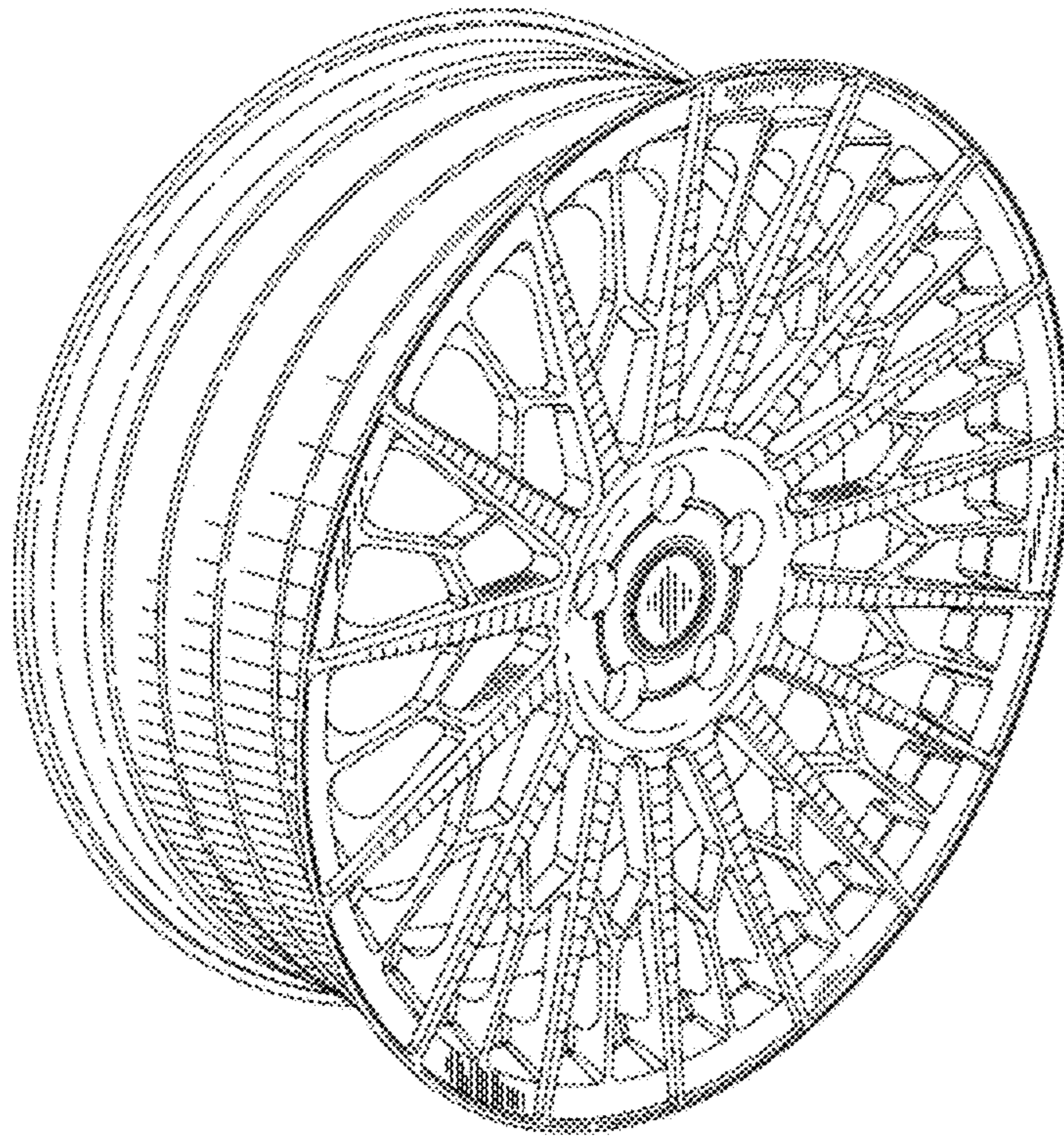

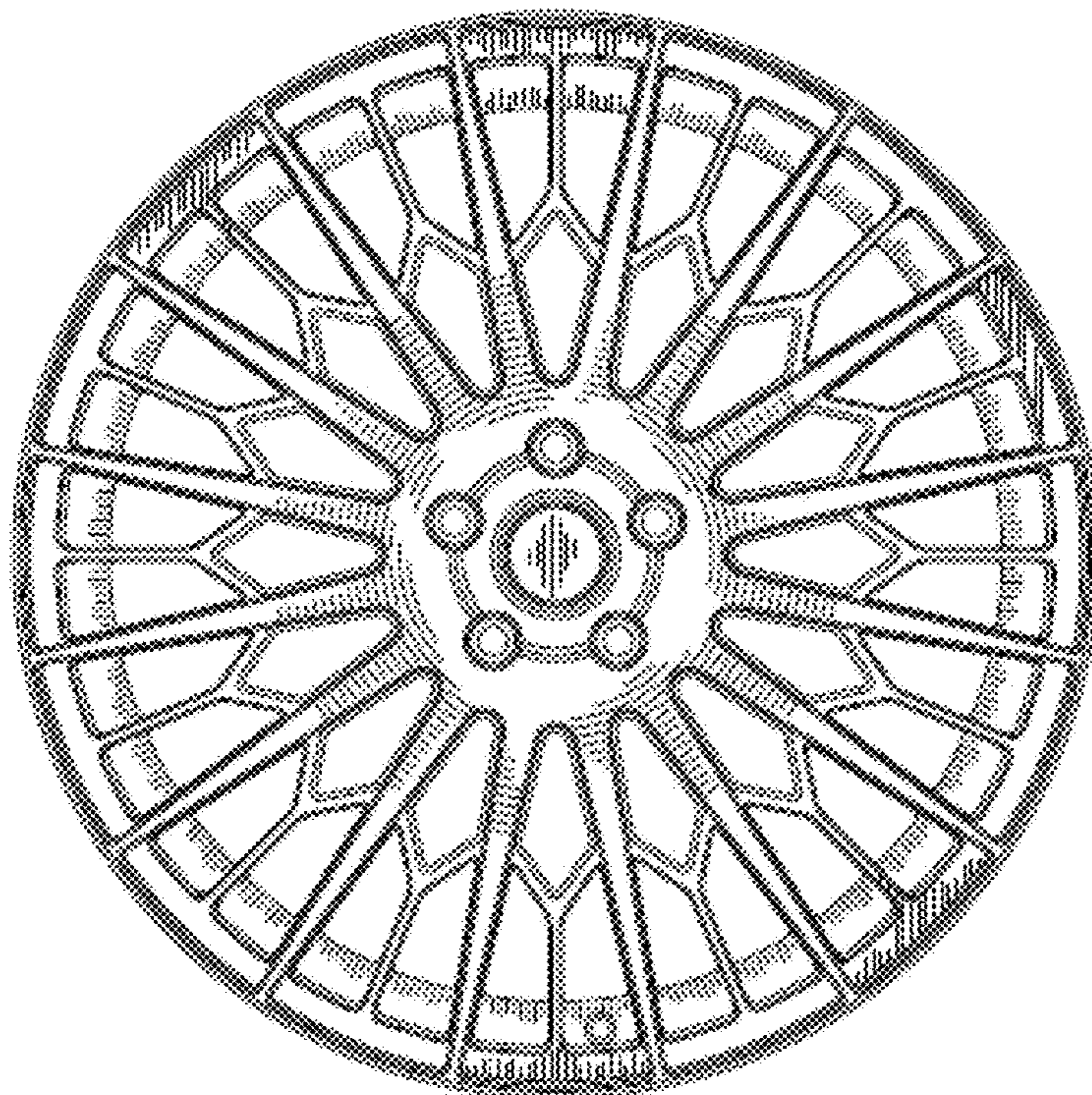

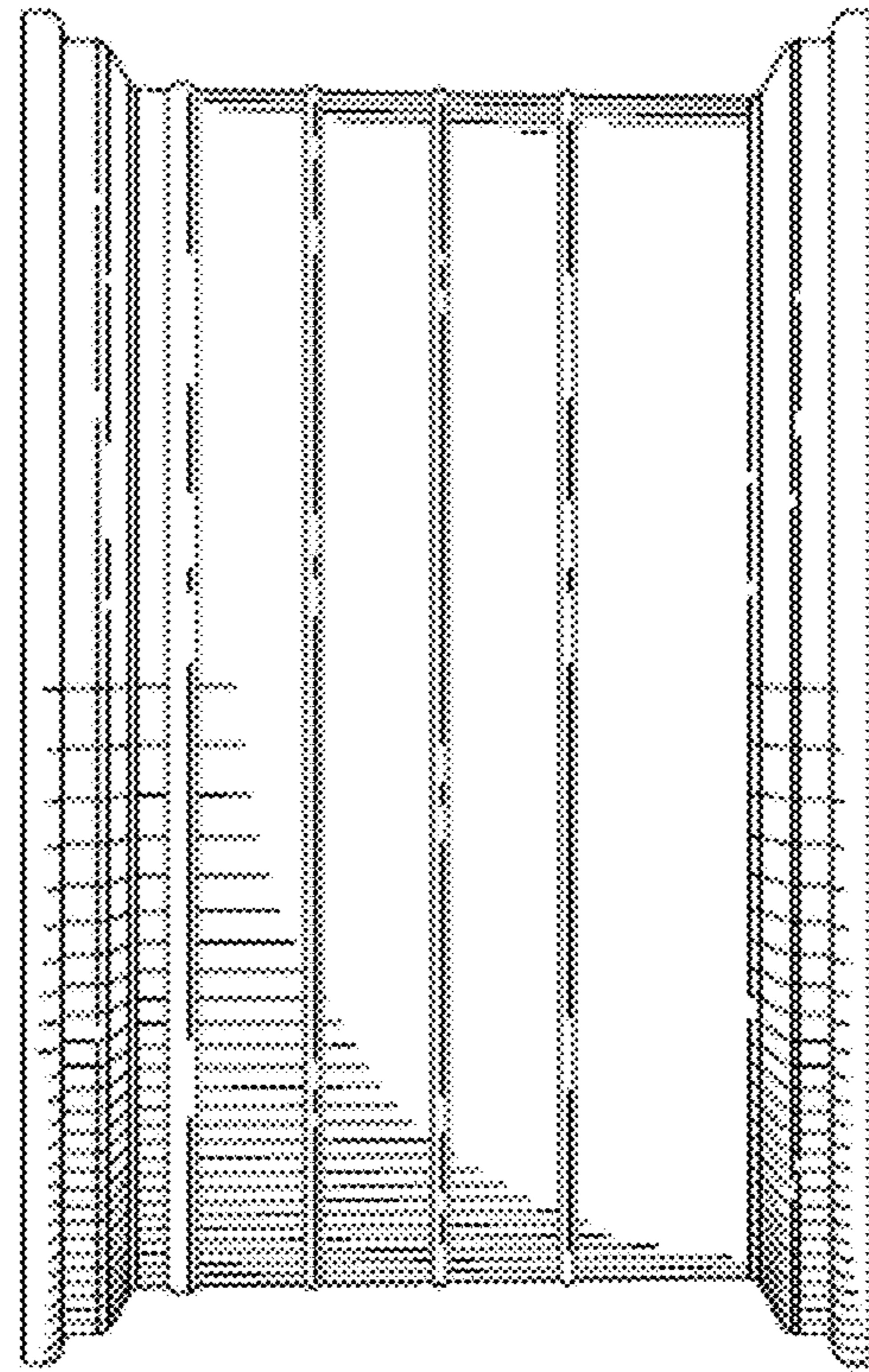

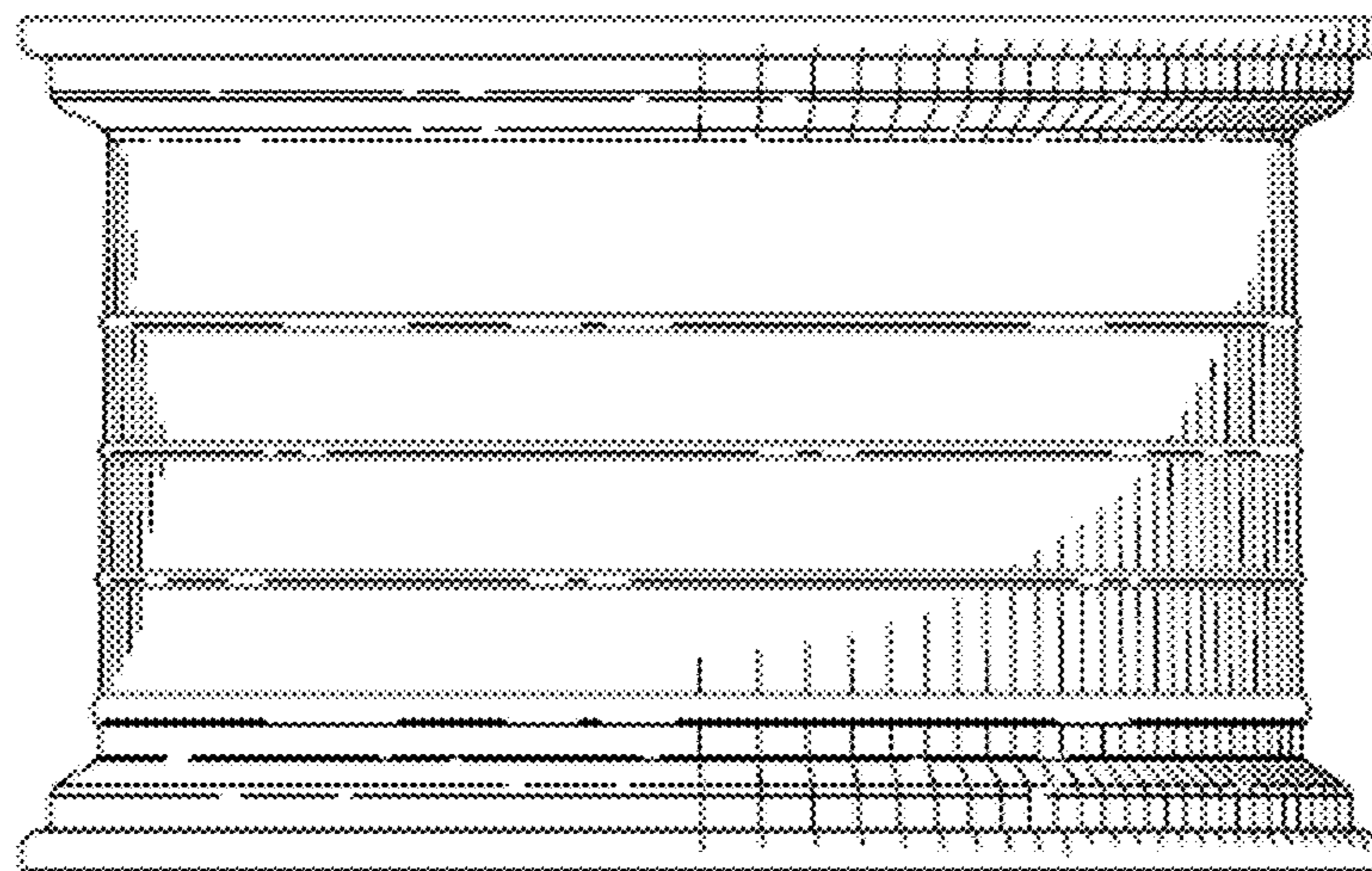
