(57) **CLAIM**

The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side perspective view of a tire showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a left side view thereof, the right side view being the mirror image thereof;

FIG. 4 is a partial front elevational view taken from FIG. 2 and shown in an enlarged scale;

FIG. 5 is an enlarged fragmentary front view taken from FIG. 2 showing a central circumferential tread band; and,

FIG. 6 is an enlarged fragmentary front view showing radially adjacent right cleats with adjacent cleat elements disposed laterally inboard, and with channels therebetween.
