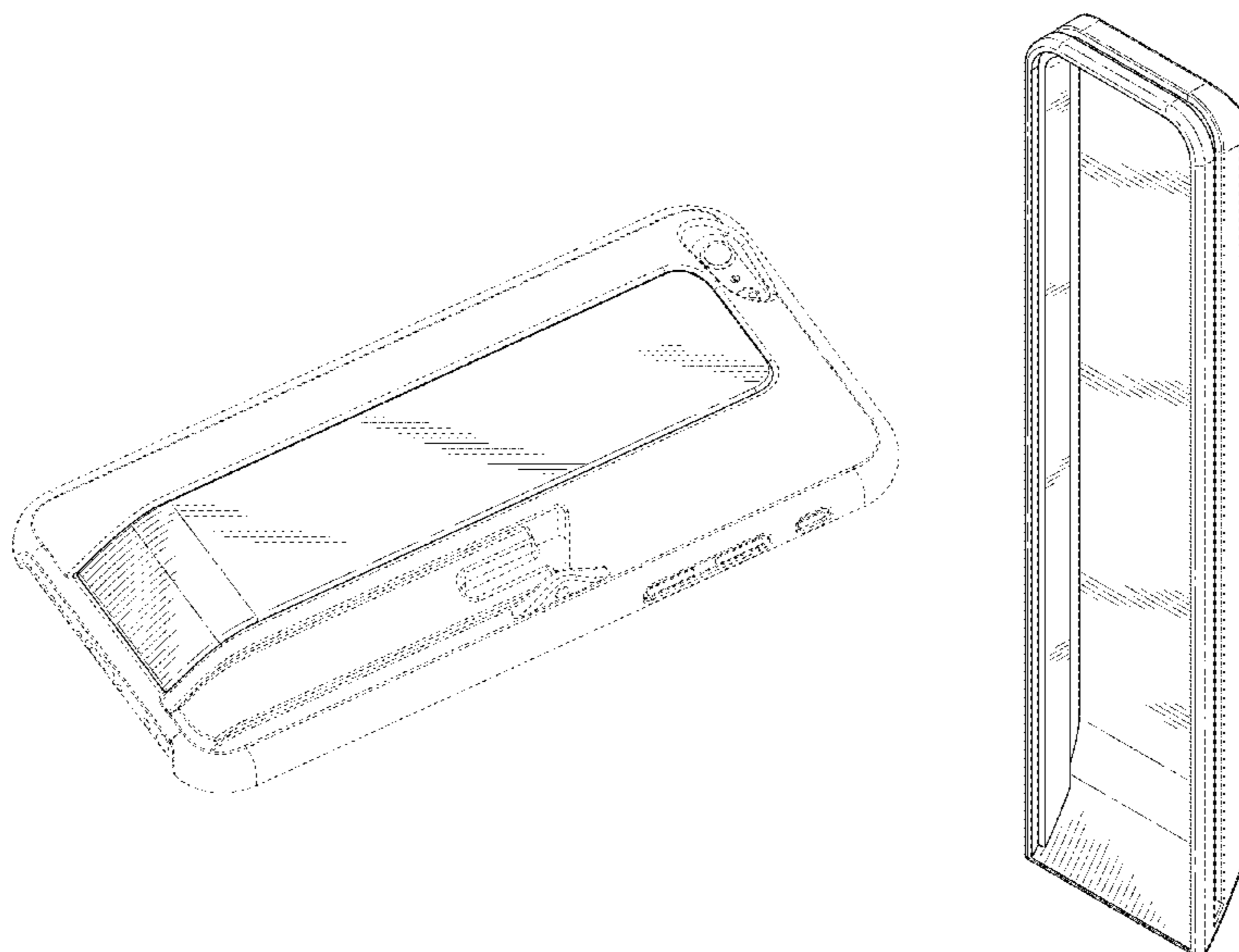
(57) **CLAIM**

I claim the ornamental design for a mobile phone case battery accessory, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear perspective view of a mobile phone case battery accessory, showing my new design; FIG. 2 is a front perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a right-side elevational view thereof, the left-side elevational view being a mirror image thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines showing a mobile phone in FIG. 1 depict environmental matter and form no part of the claimed design.

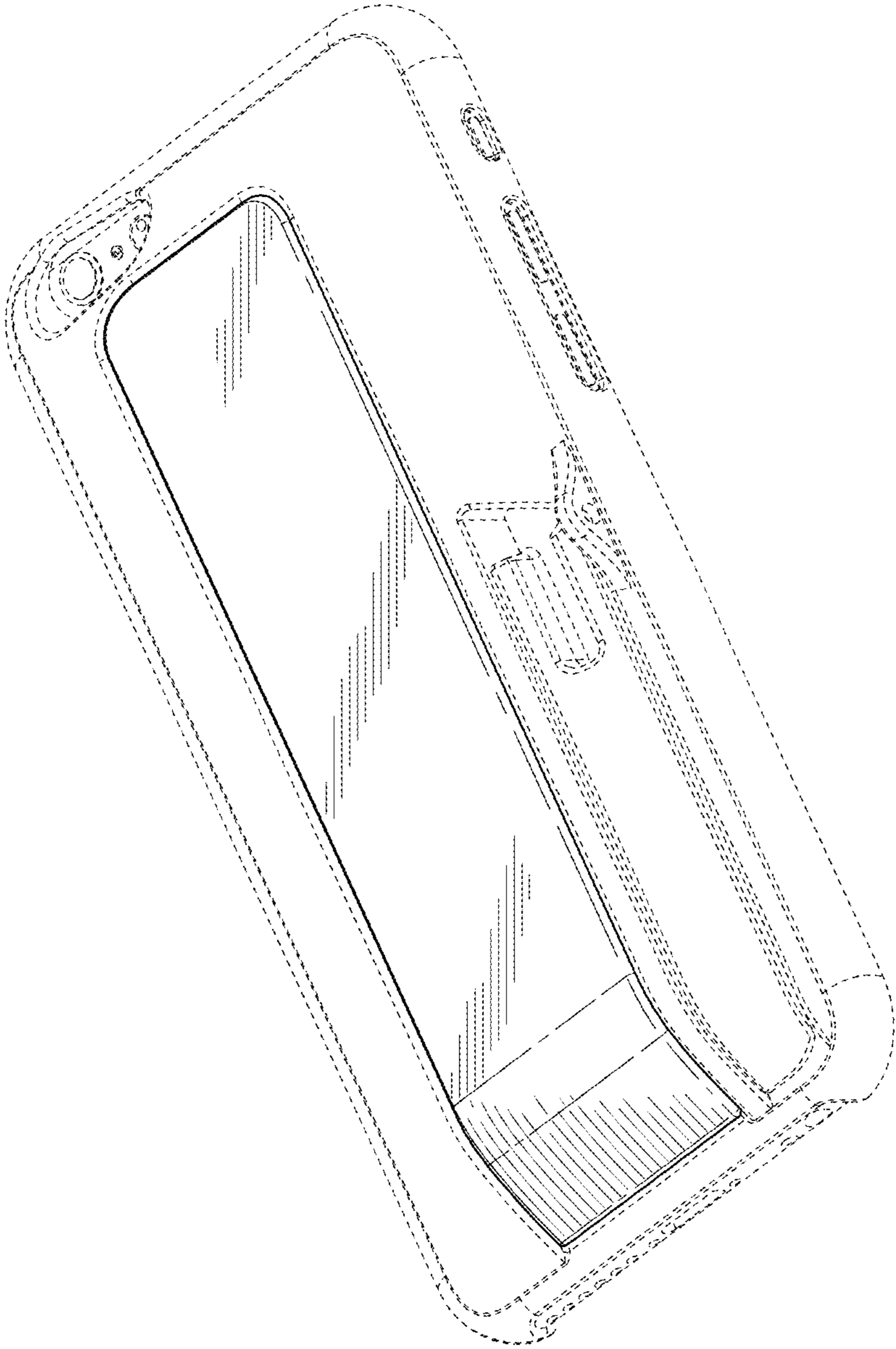

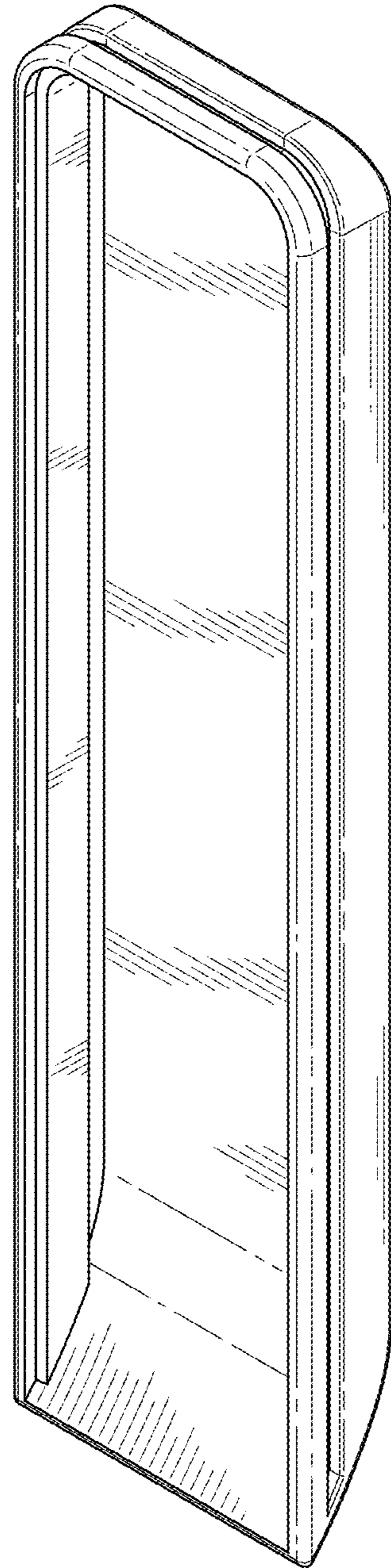

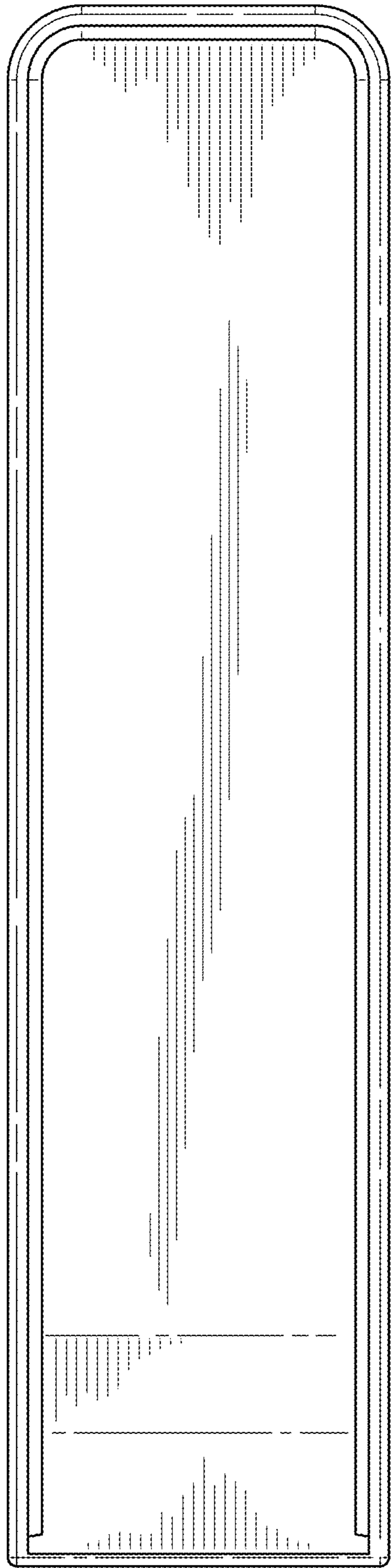

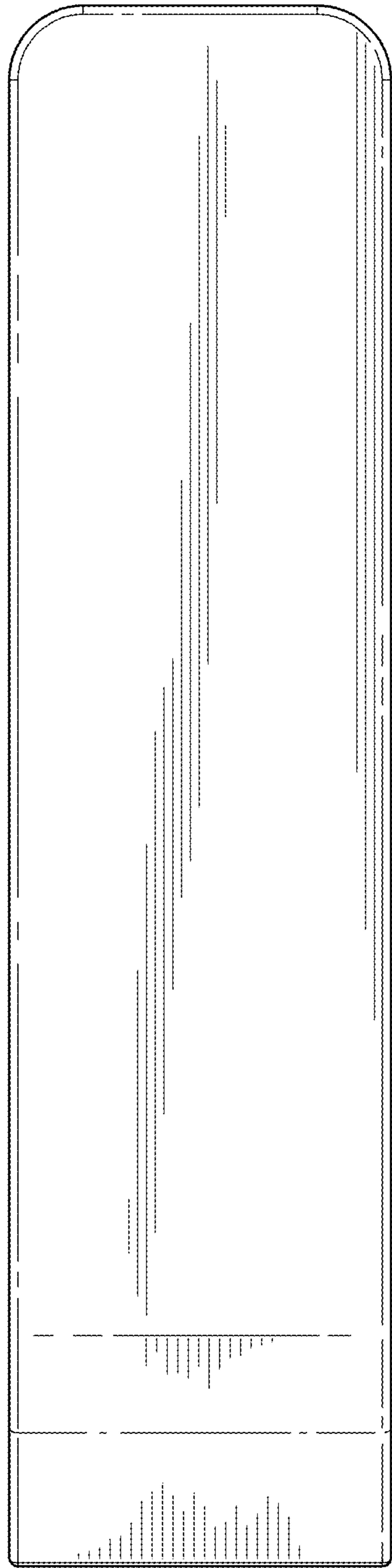

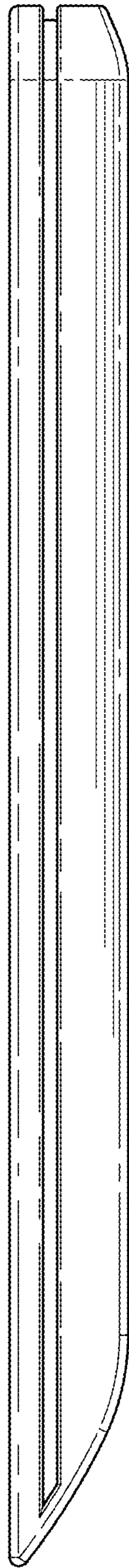

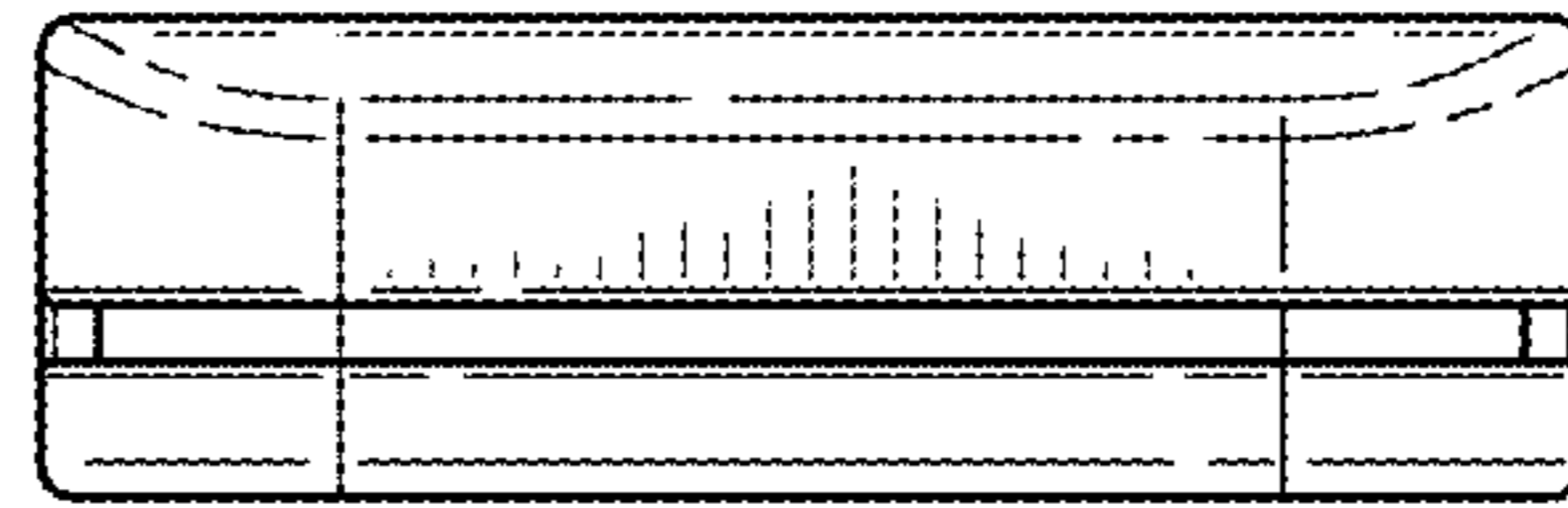

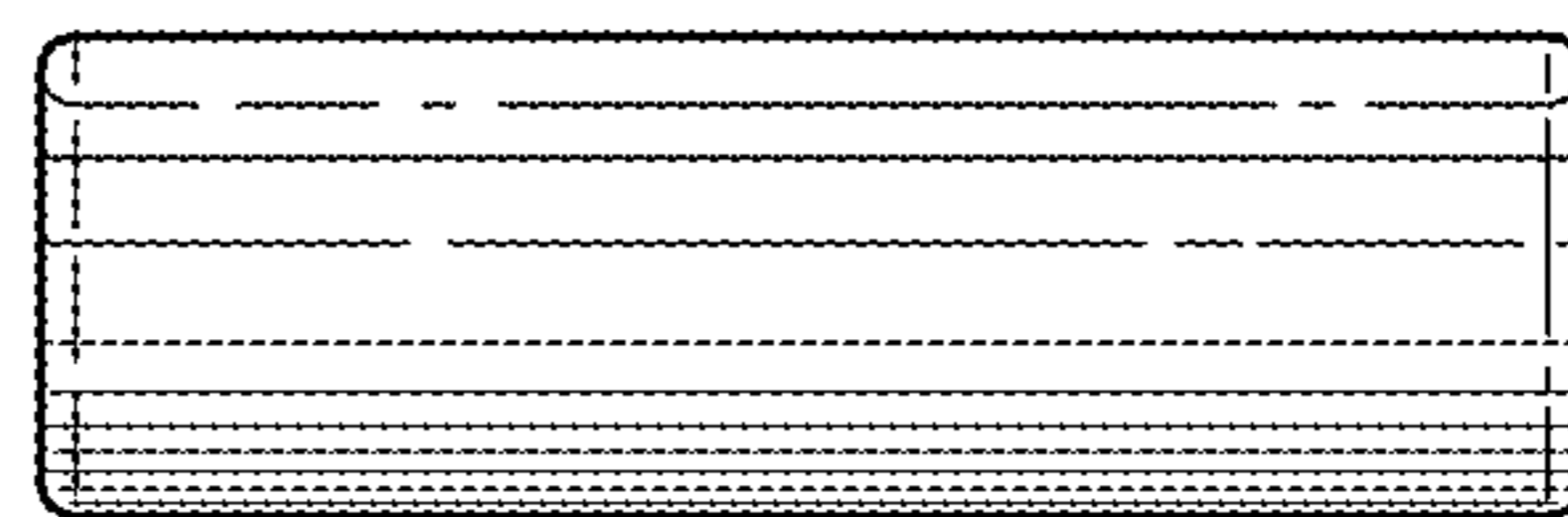
