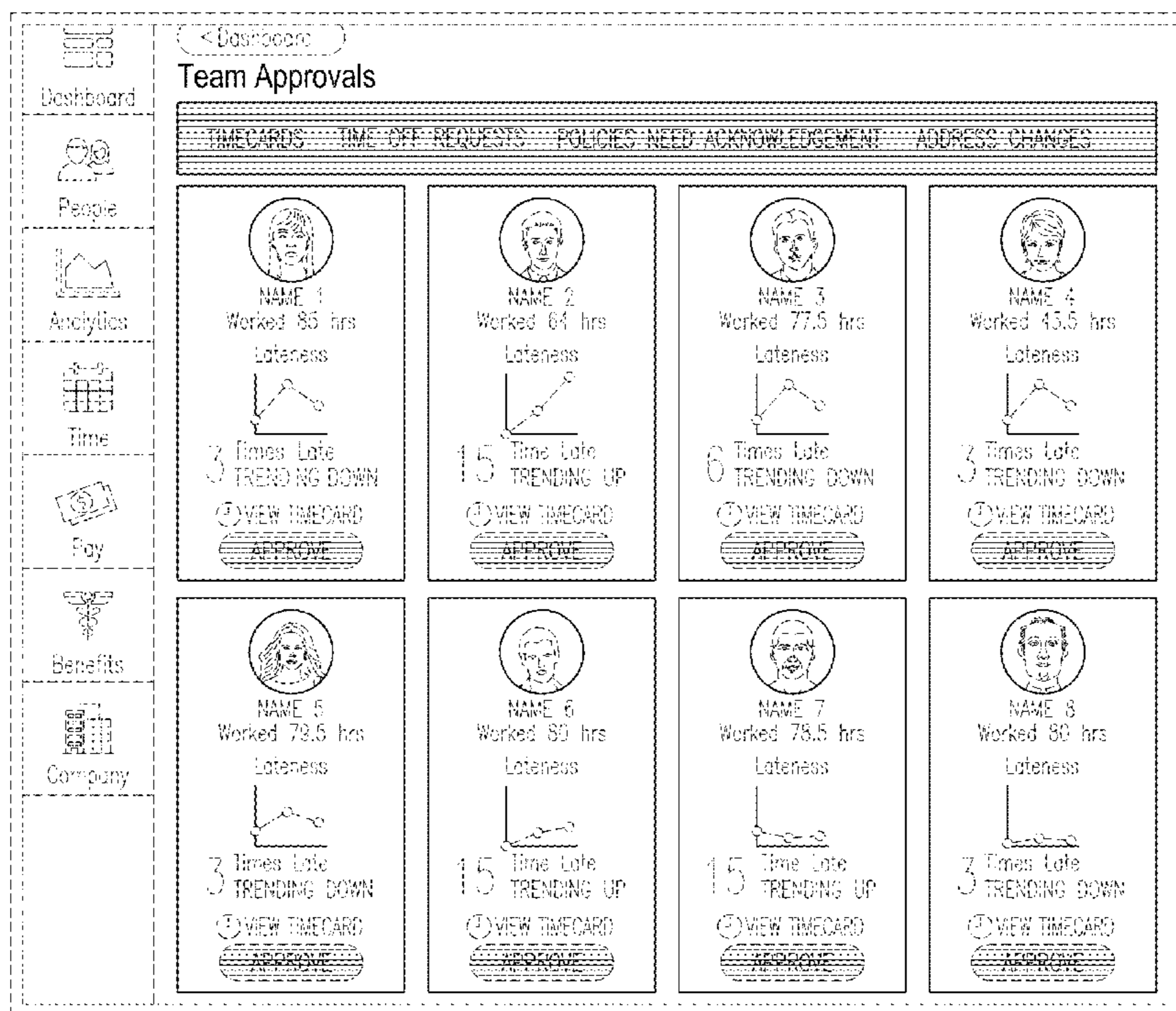
(57) **CLAIM**


The ornamental design for a display screen with graphical user interface, as shown and described.

DESCRIPTION


The sole FIGURE illustrates a front view of a display screen with graphical user interface.
The outermost broken line perimeter illustrates a display screen and forms no part of the claimed design. The remaining broken lines illustrate portions of a graphical user interface and form no part of the claimed design.
The portions of the FIGURE shown in a pattern of dense horizontal solid lines, comprising a rectangular bar and eight oblongs, illustrate areas of contrasting appearance that form part of the claimed design. The broken lines that outline the oblongs form no part of the claimed design.















