DESCRIPTION

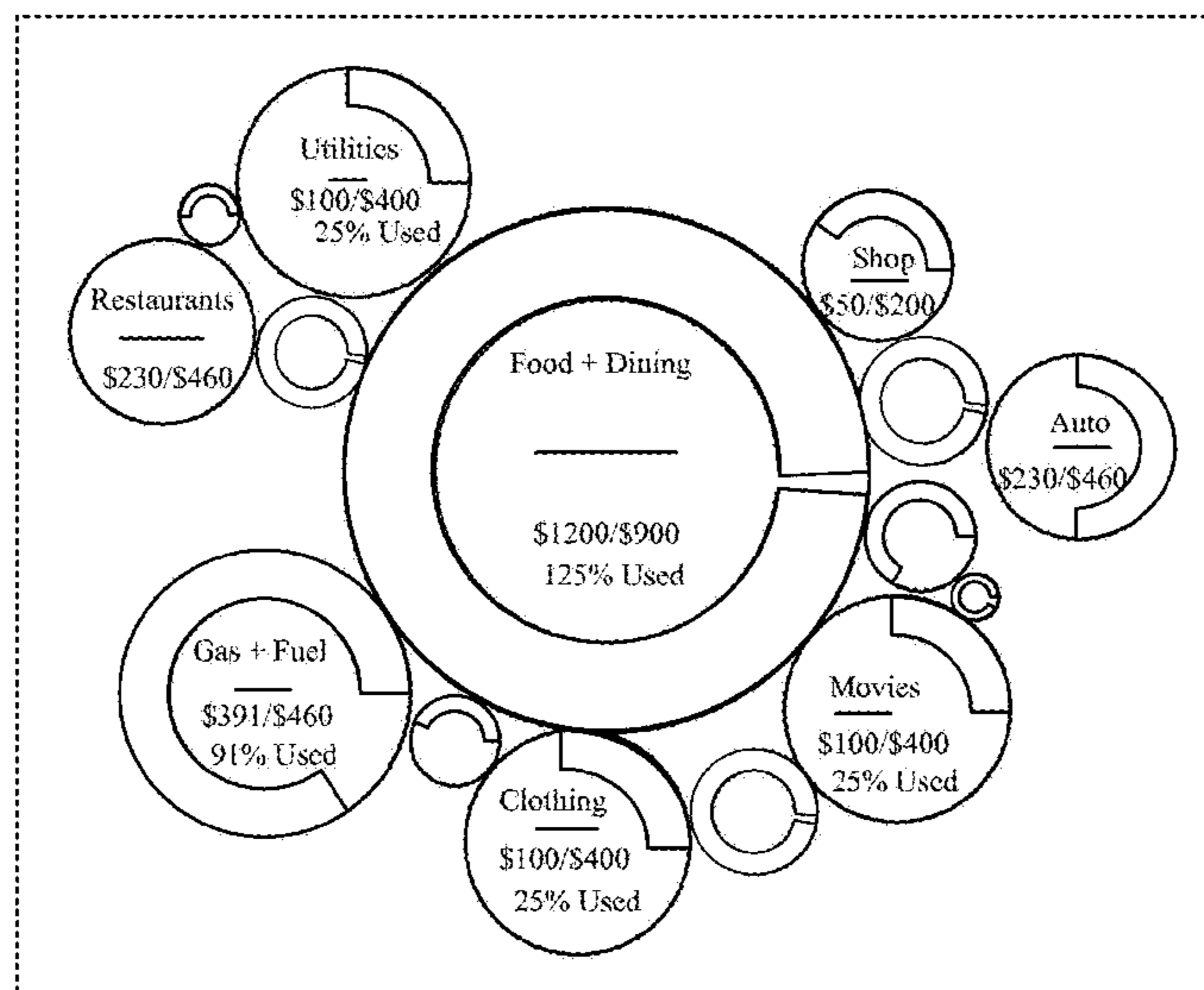
FIG. 1 is a front view of a first image of the display screen or portion thereof with animated graphical user interface; and,

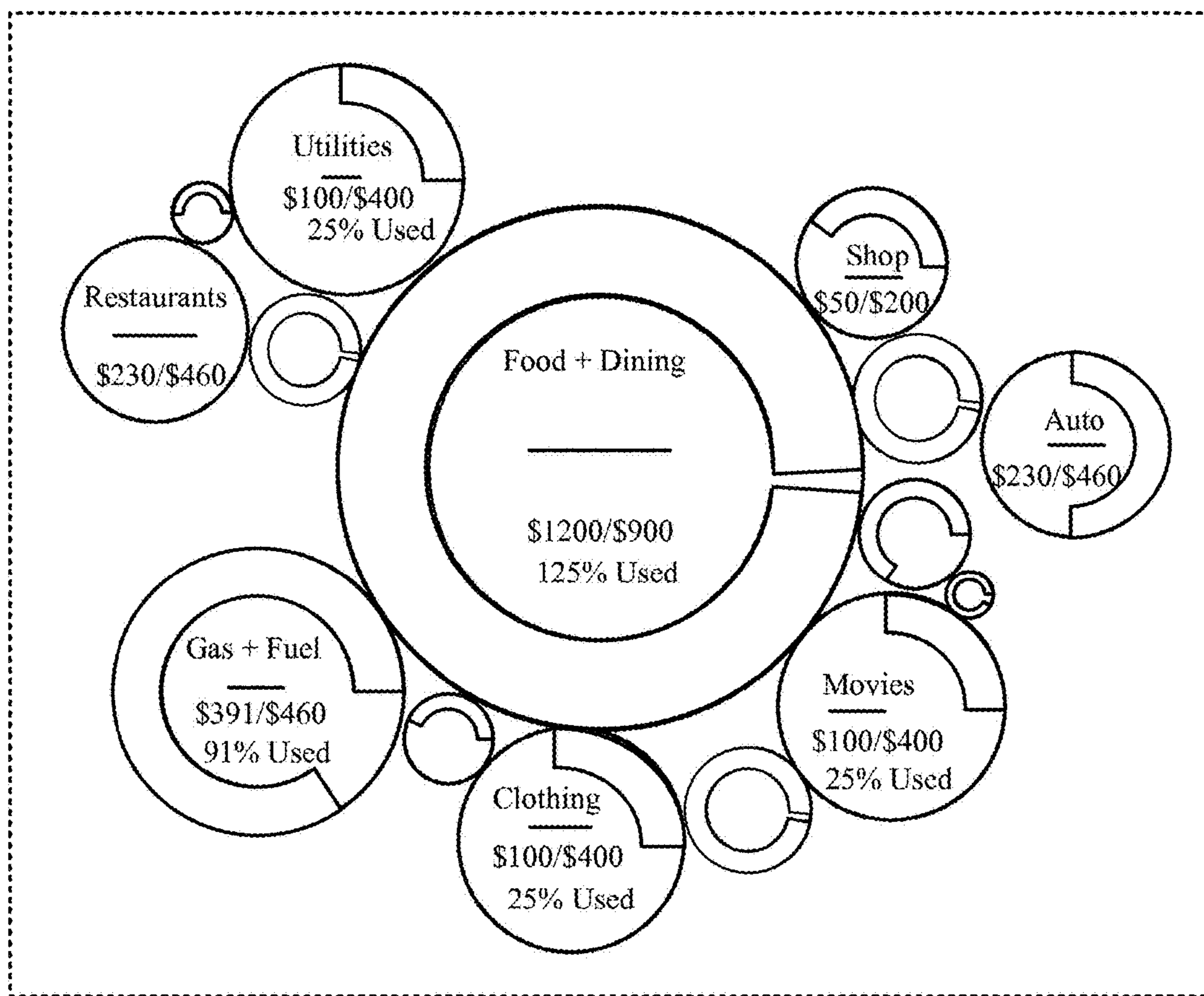

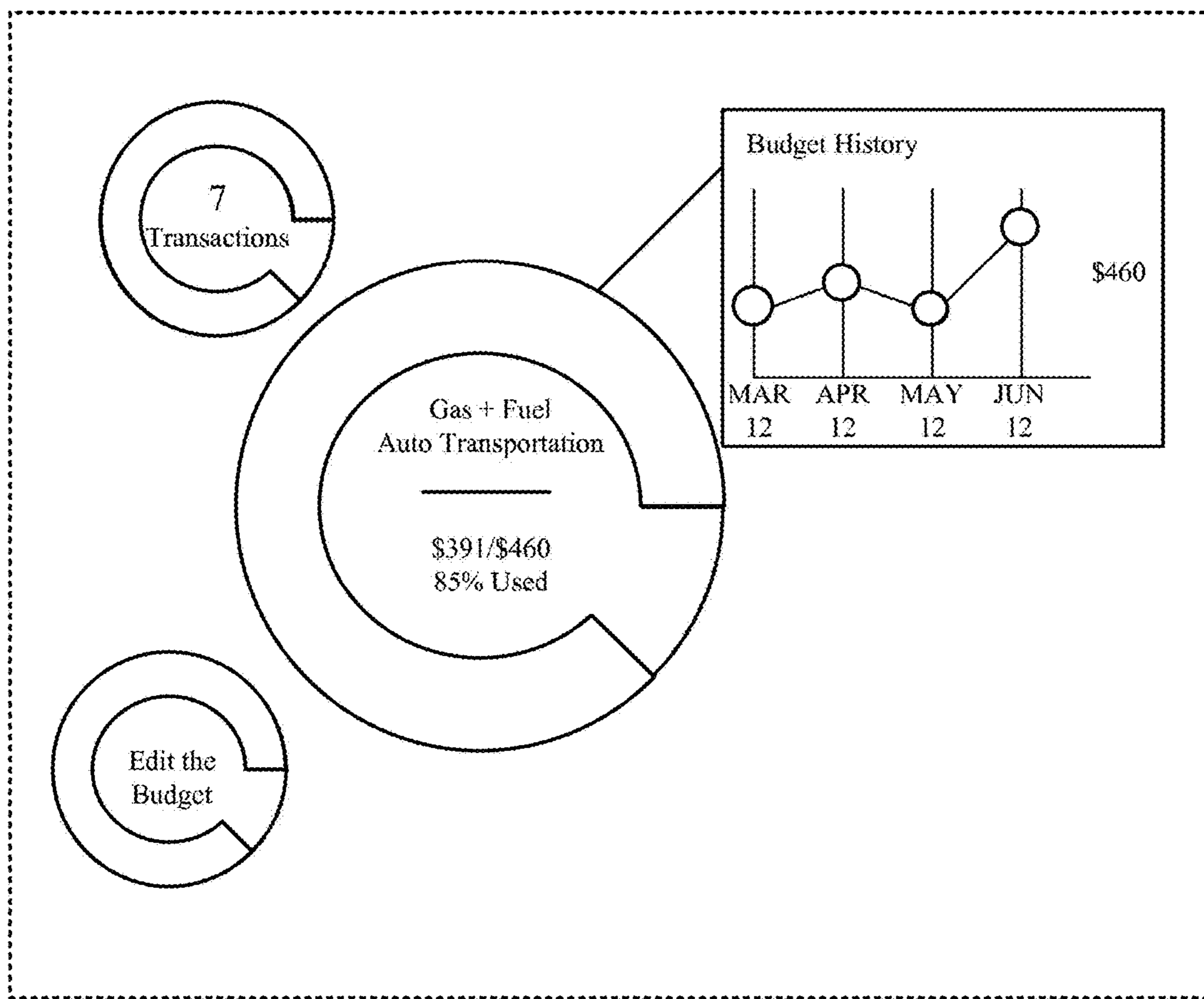
