What is claimed is the ornamental design for display screen or portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image in a sequence for a display screen or portion thereof with animated graphical user interface;

FIG. 2 is a second image thereof;

FIG. 3 is a third image thereof;



FIG. 4 is a fourth image thereof; and,










