(57) **CLAIM**

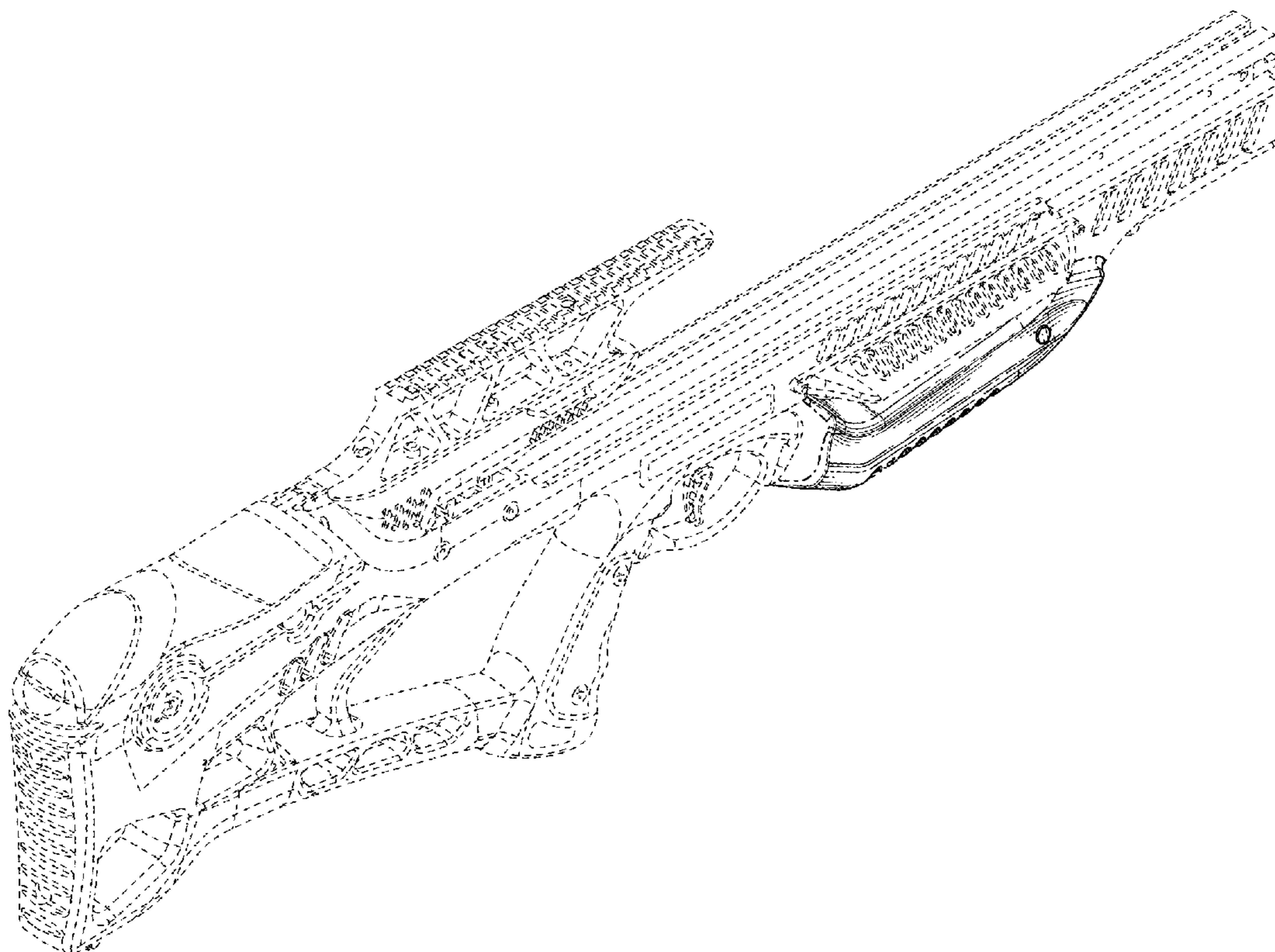
I claim the ornamental design for a crossbow stock, as shown and described.

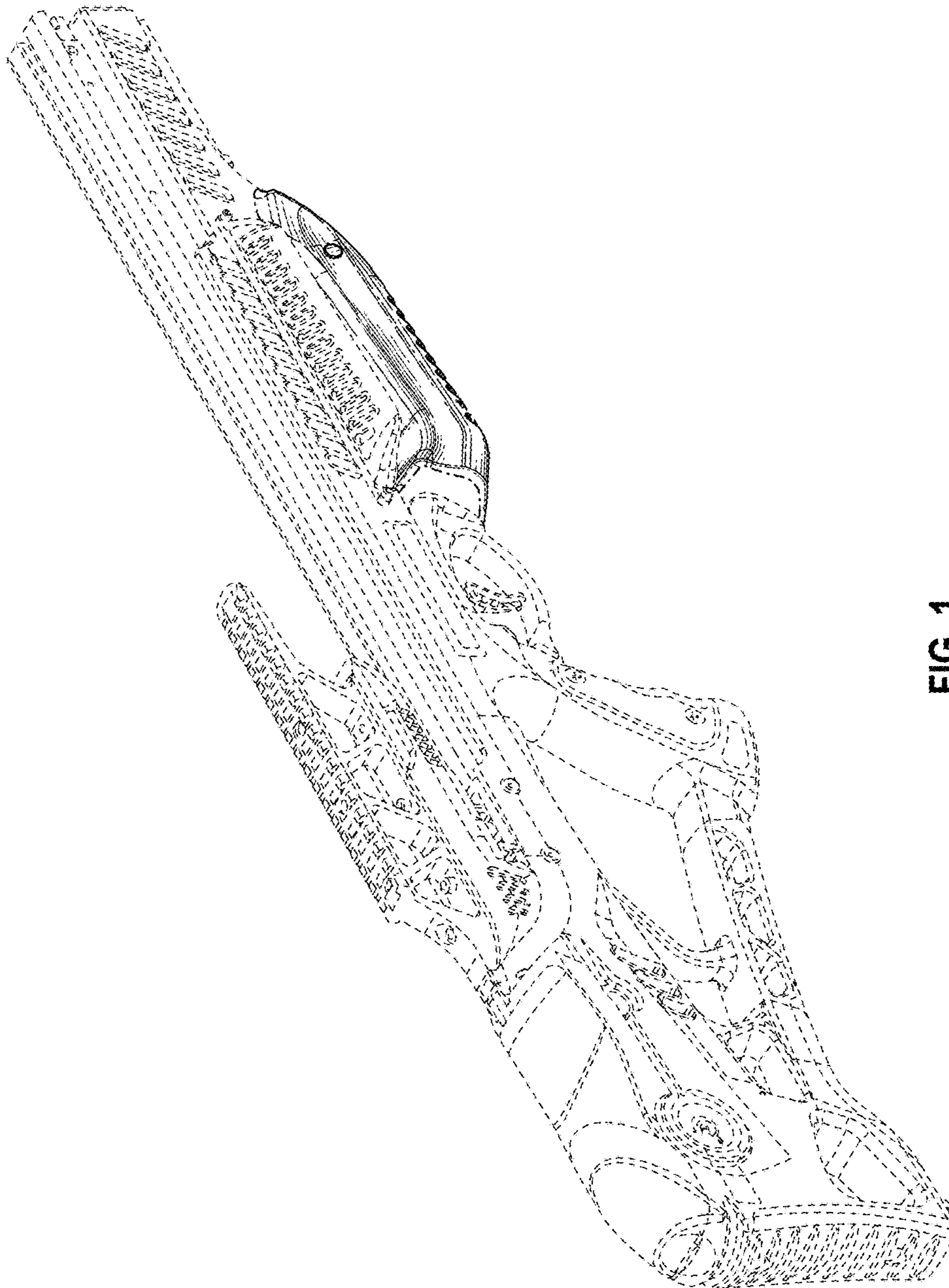

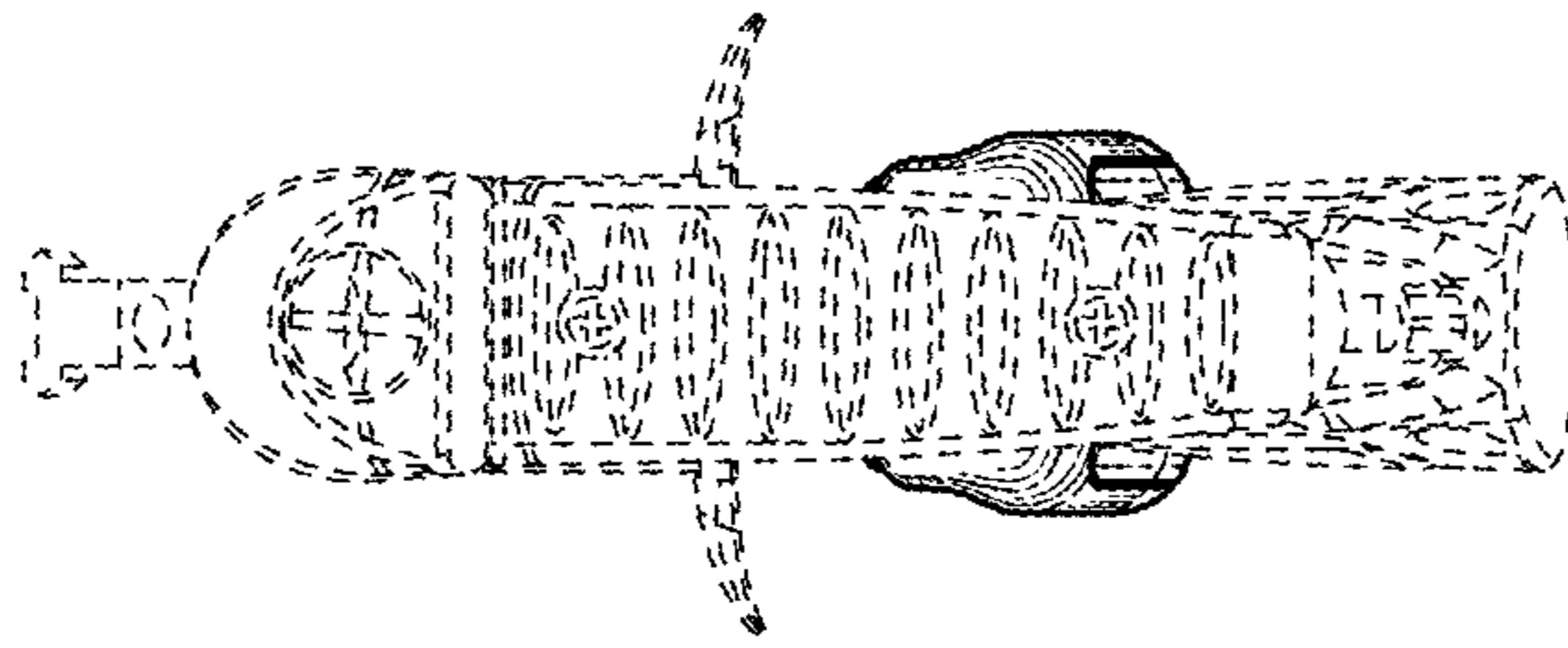

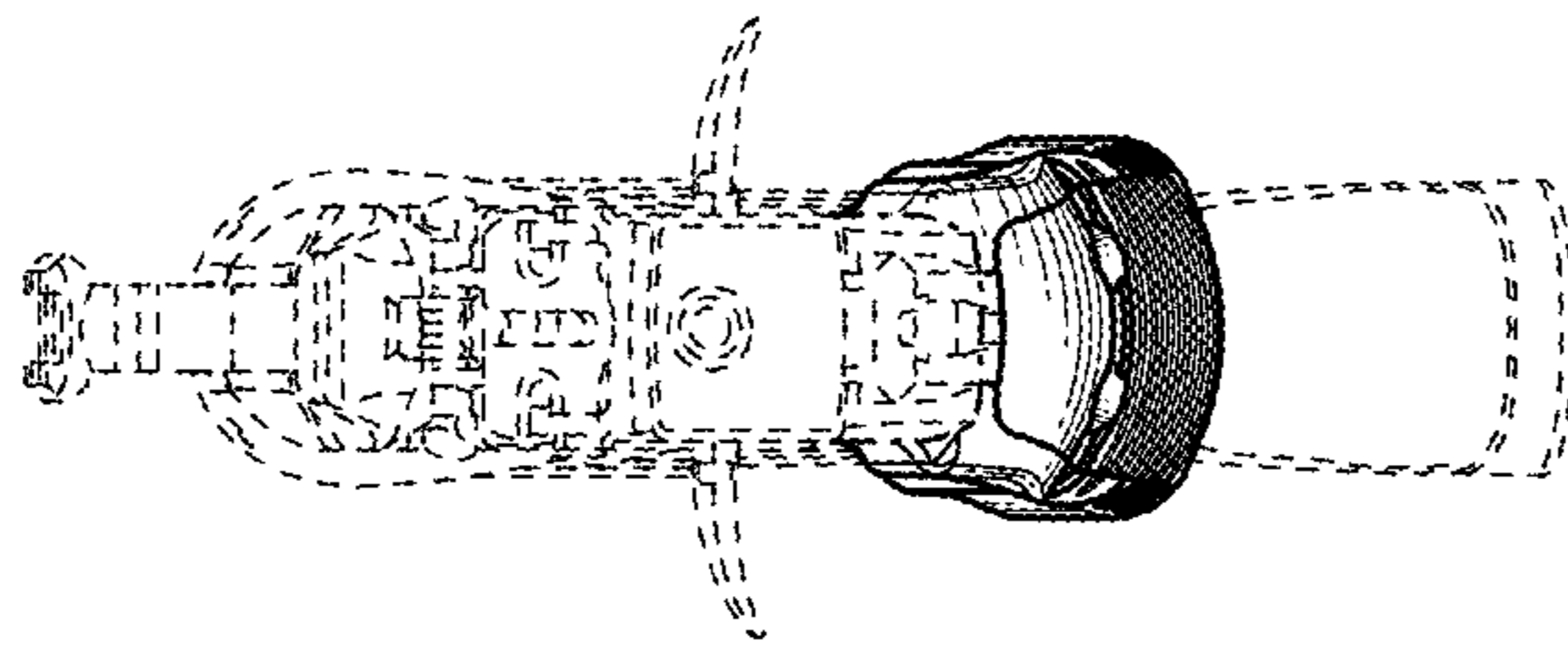

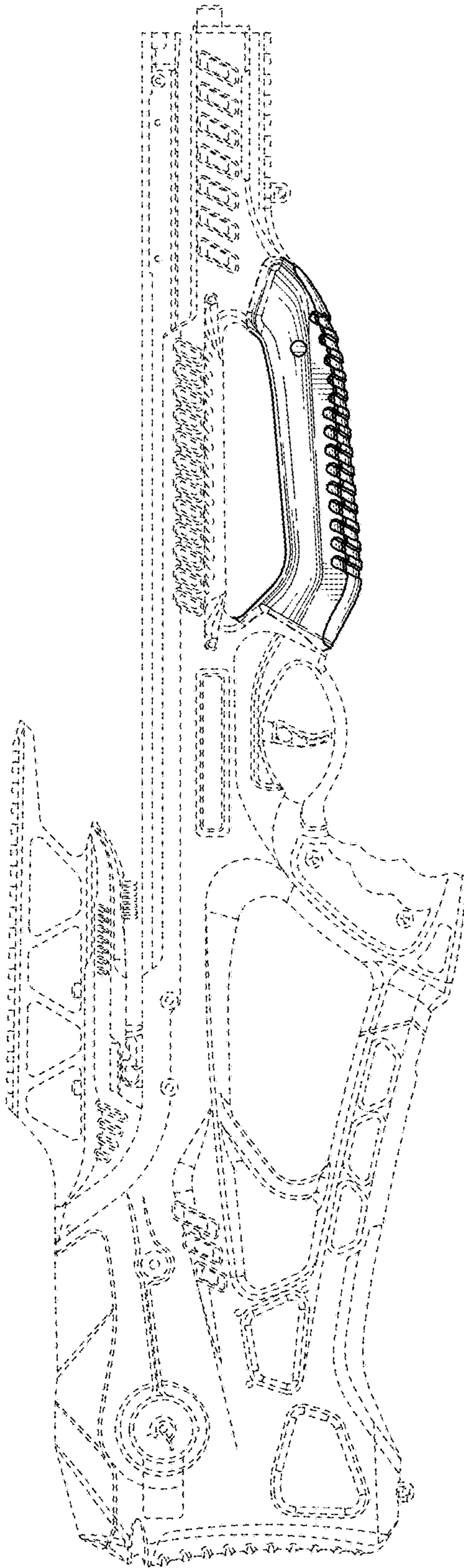

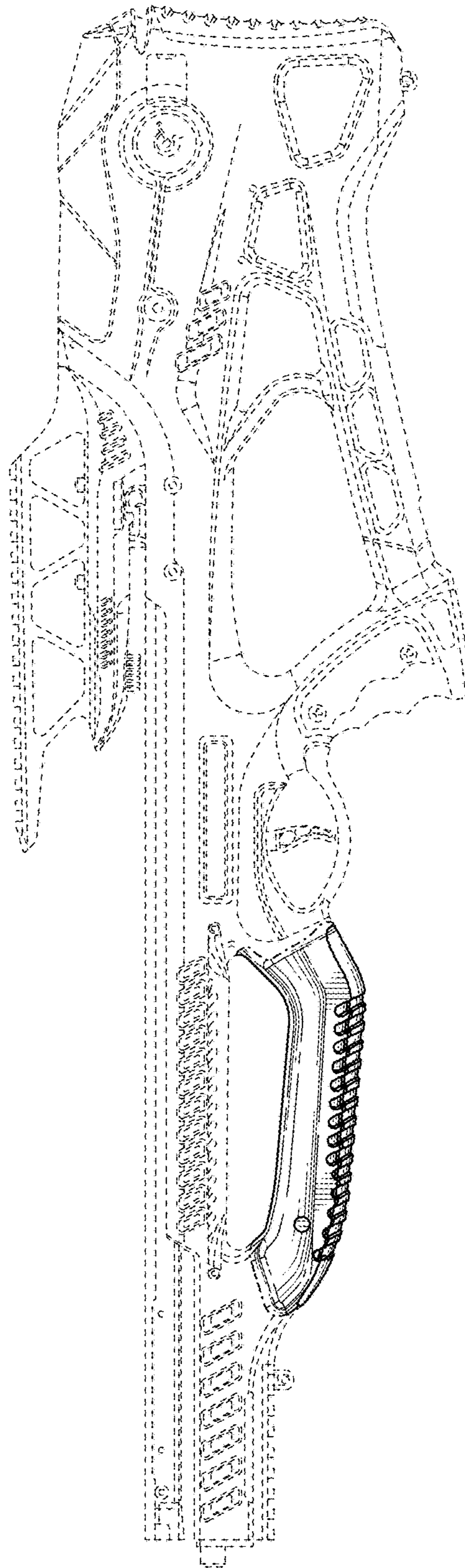

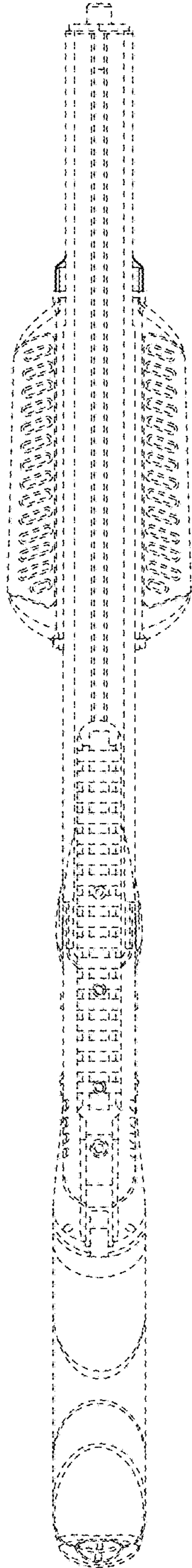

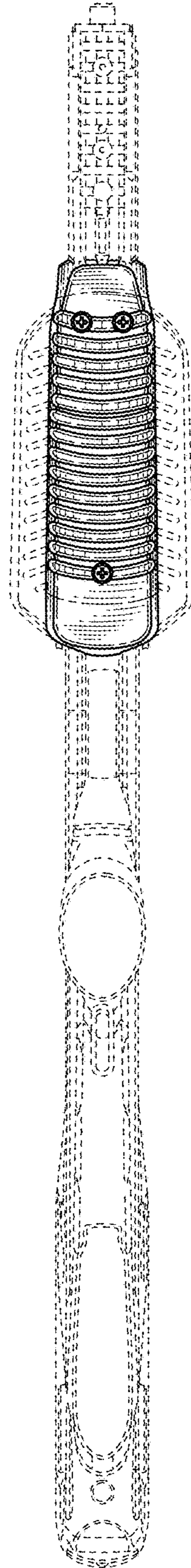
