FIG. 7 is a bottom view of a ventilator console of FIG. 1; and,

FIG. 8 is a perspective view of an alternate configuration of the ventilator console of FIG. 1.

The ventilator console in FIG. 8 includes broken lines that depict environmental or unclaimed portions of the ventilator console that form no part of the claimed design.

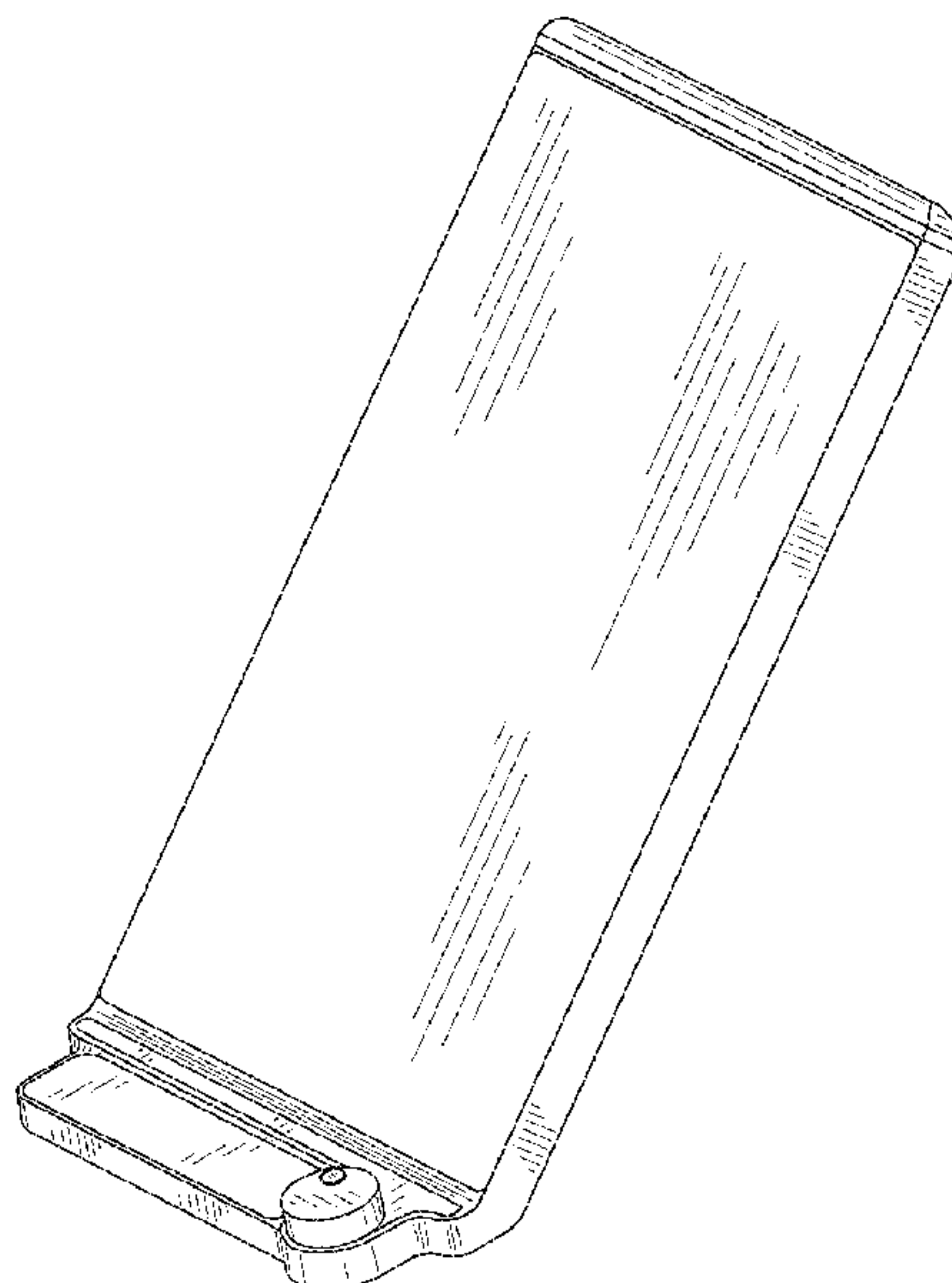

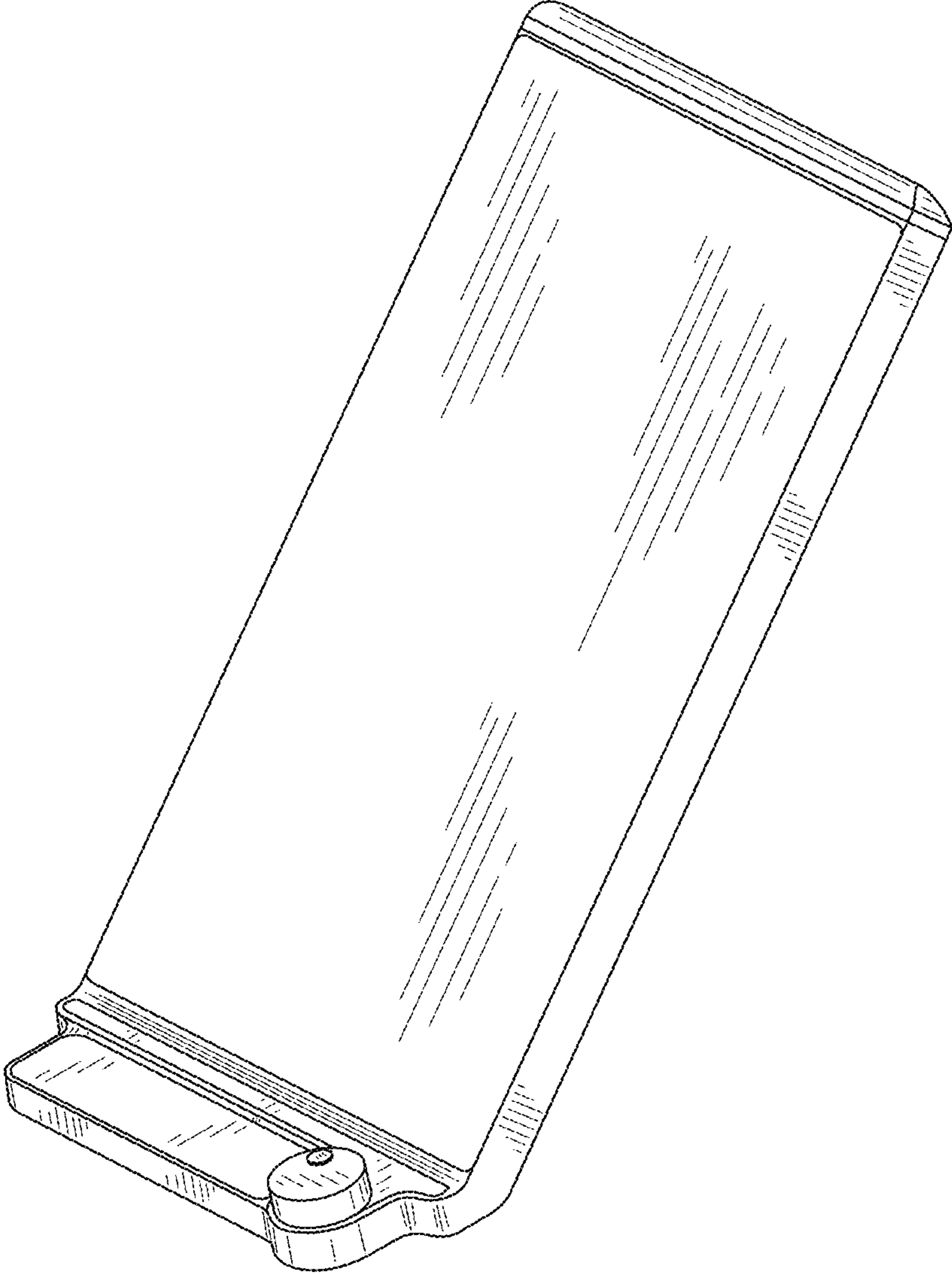

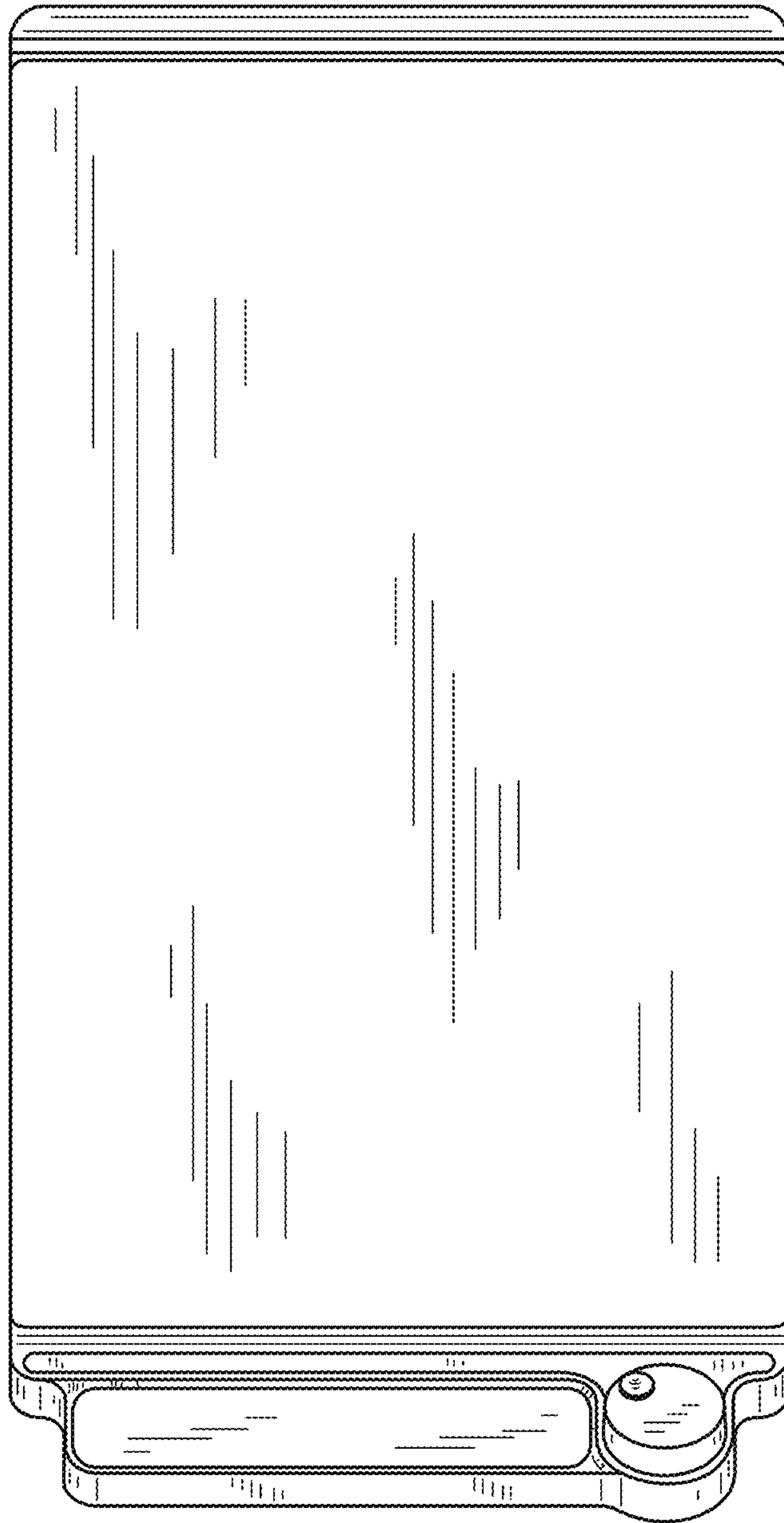

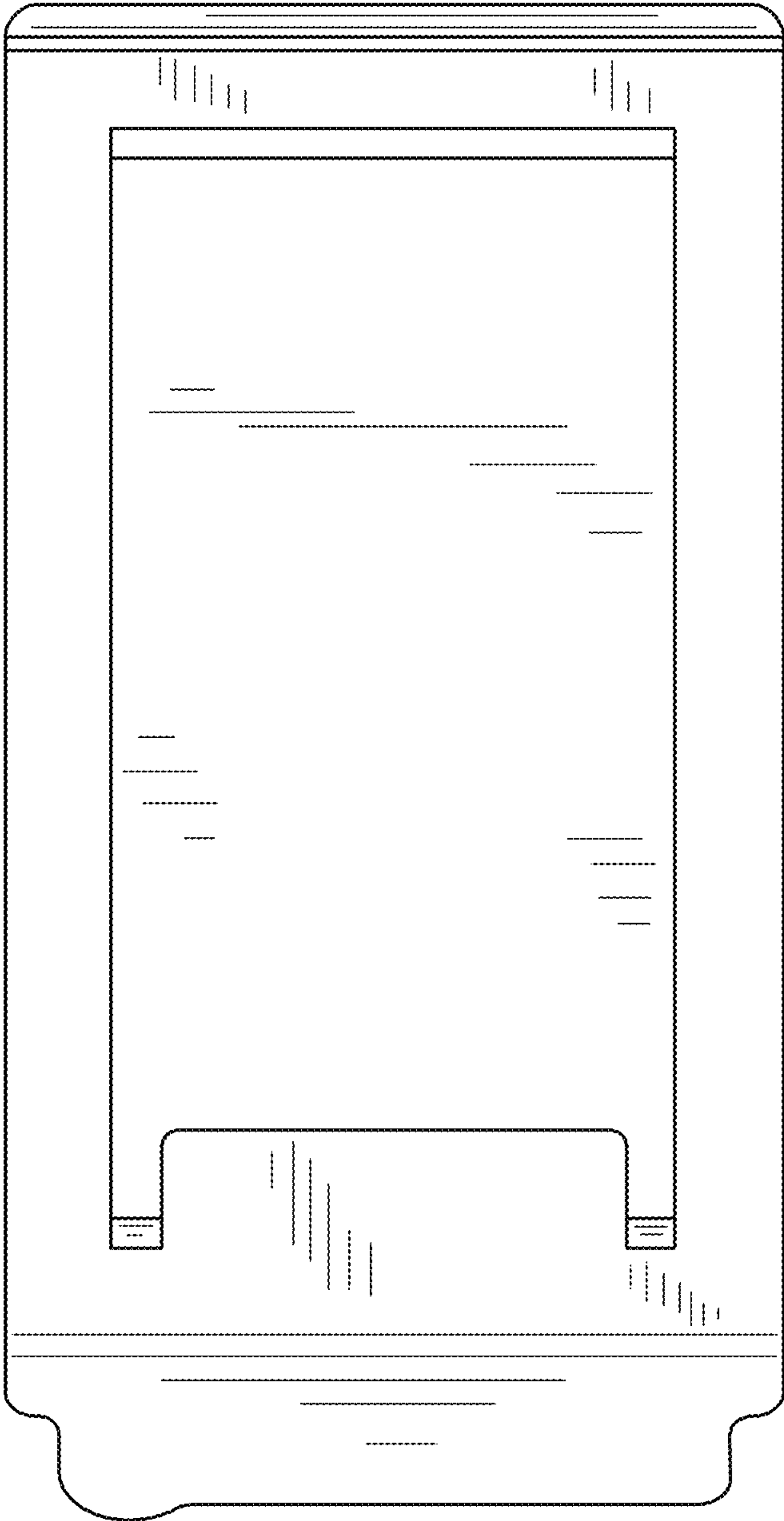

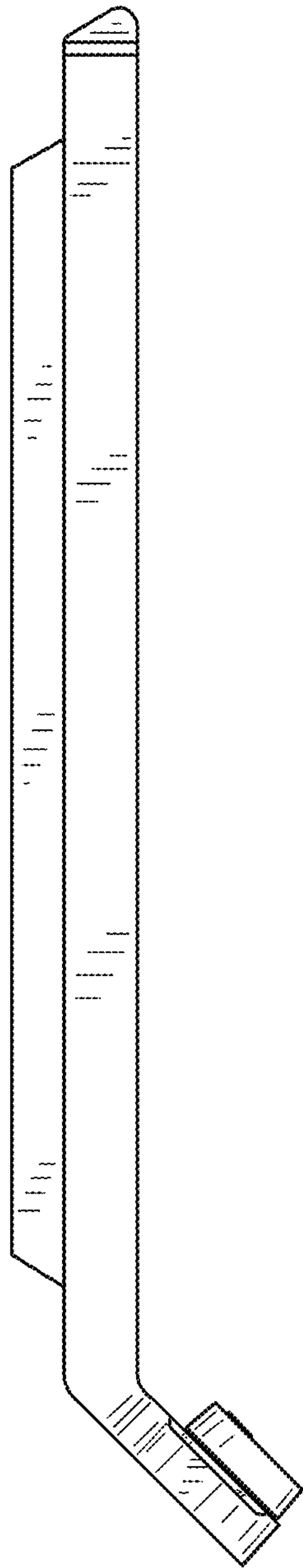

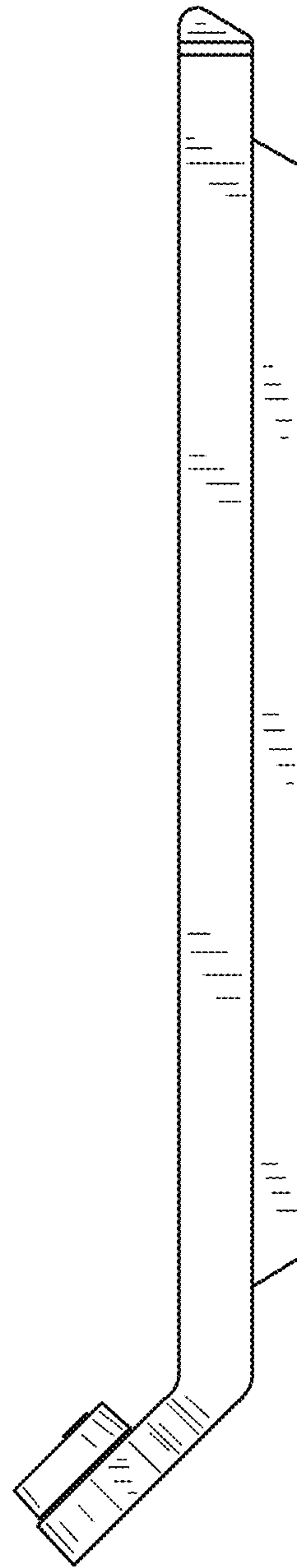

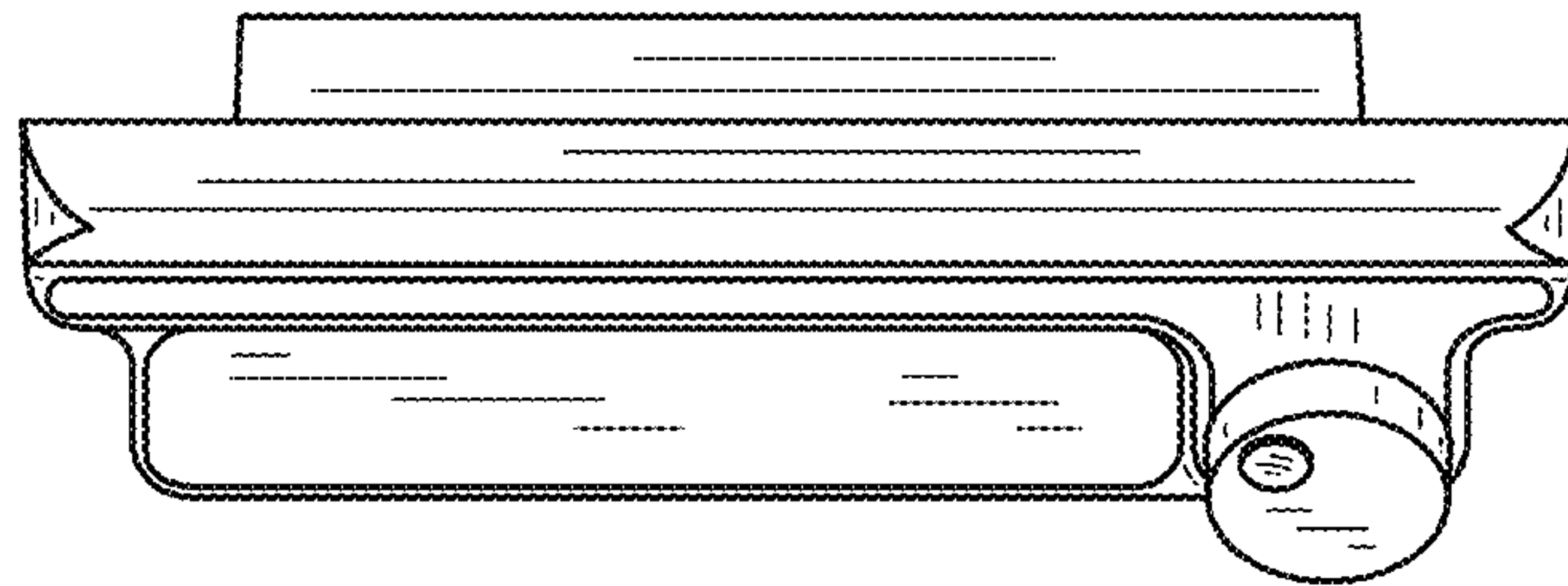

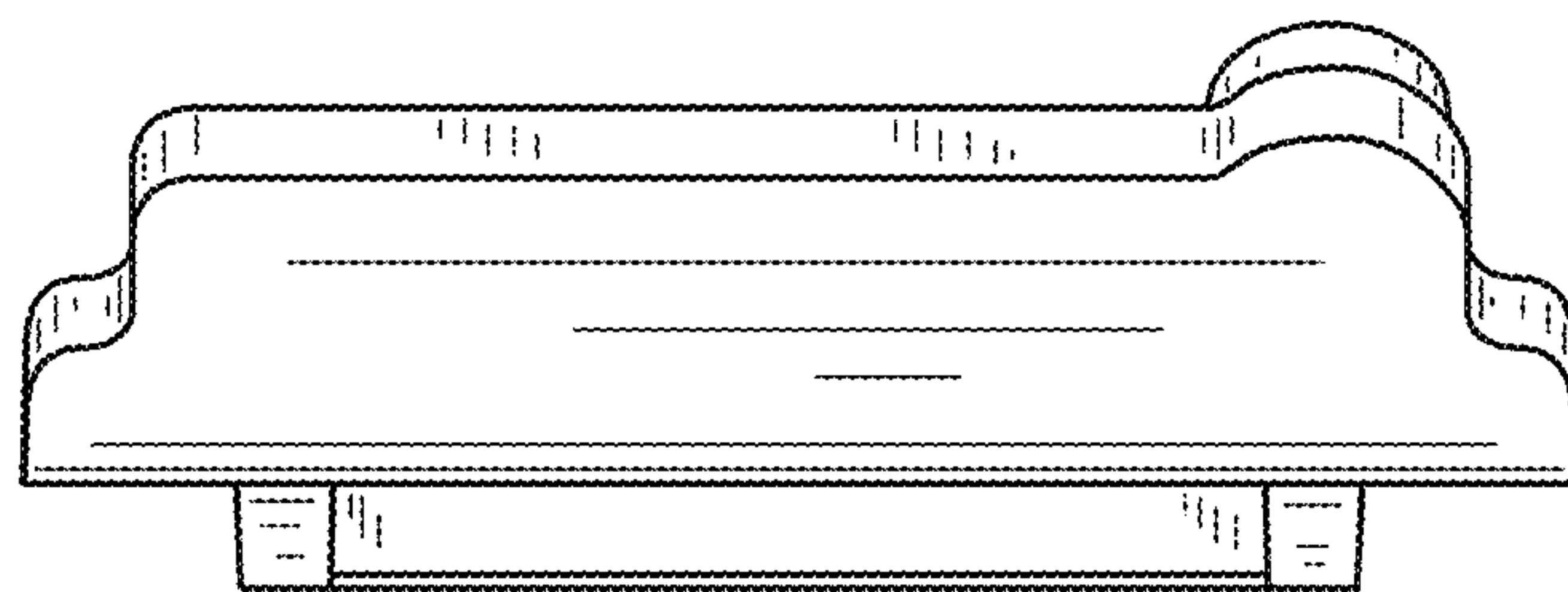

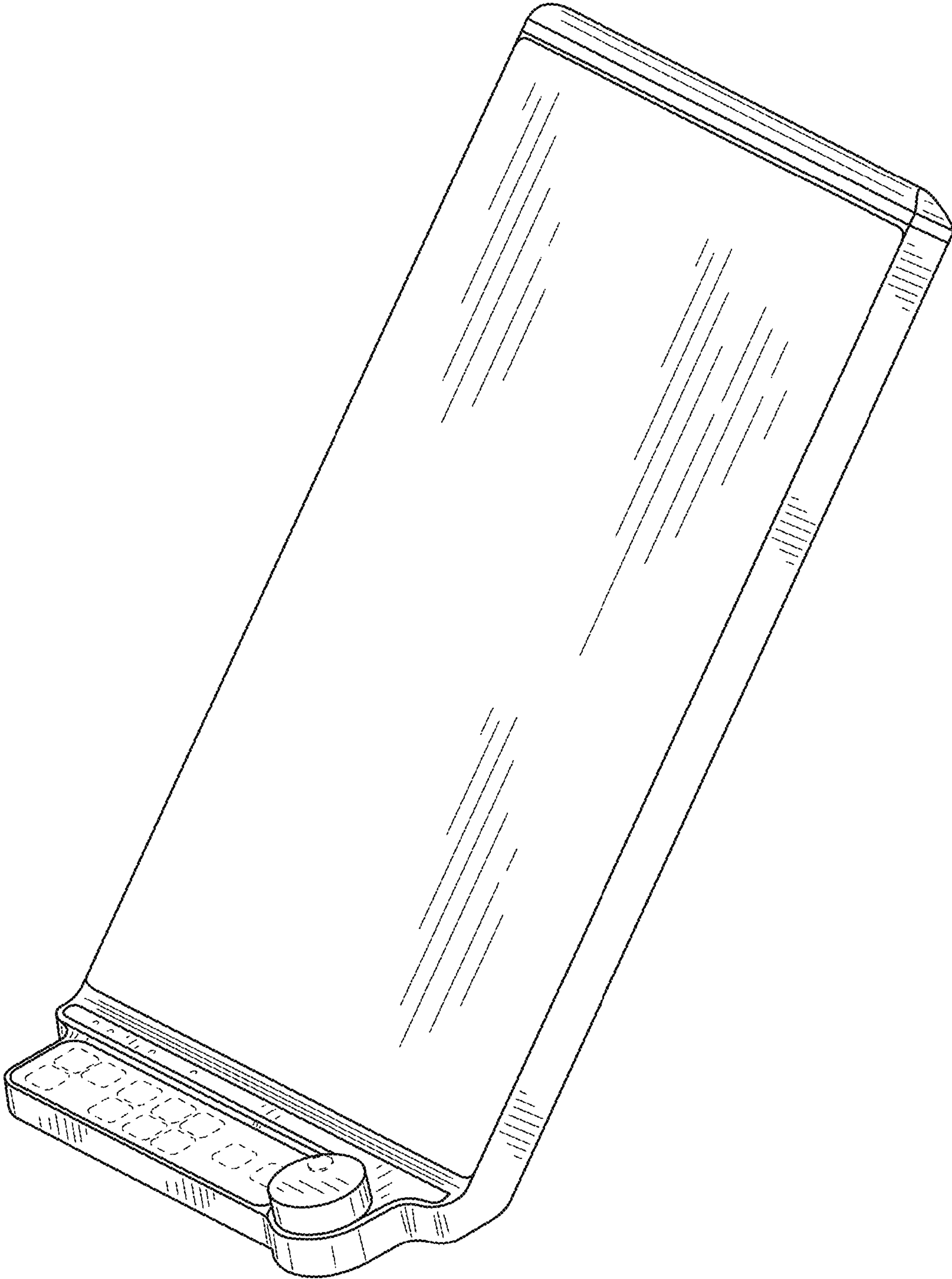
