(57) **CLAIM**

We claim the ornamental design for a lighted ring, as shown and described.

DESCRIPTION

FIG. 1 is a front and right perspective view of a lighted ring showing our new design;
FIG. 2 is top plan view of thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is an additional front and right perspective thereof, with the broken line disclosure of internal lighting elements shining through the ring walls forming no part of the claimed design;
FIG. 5 is an additional top plan view thereof, with the broken line disclosure of internal lighting elements shining through the ring walls forming no part of the claimed design; and,
FIG. 6 is an additional perspective view thereof with both the fragmentary disclosure of a bucket and the broken line disclosure of internal lighting elements shining through the ring walls forming no part of the claimed design.

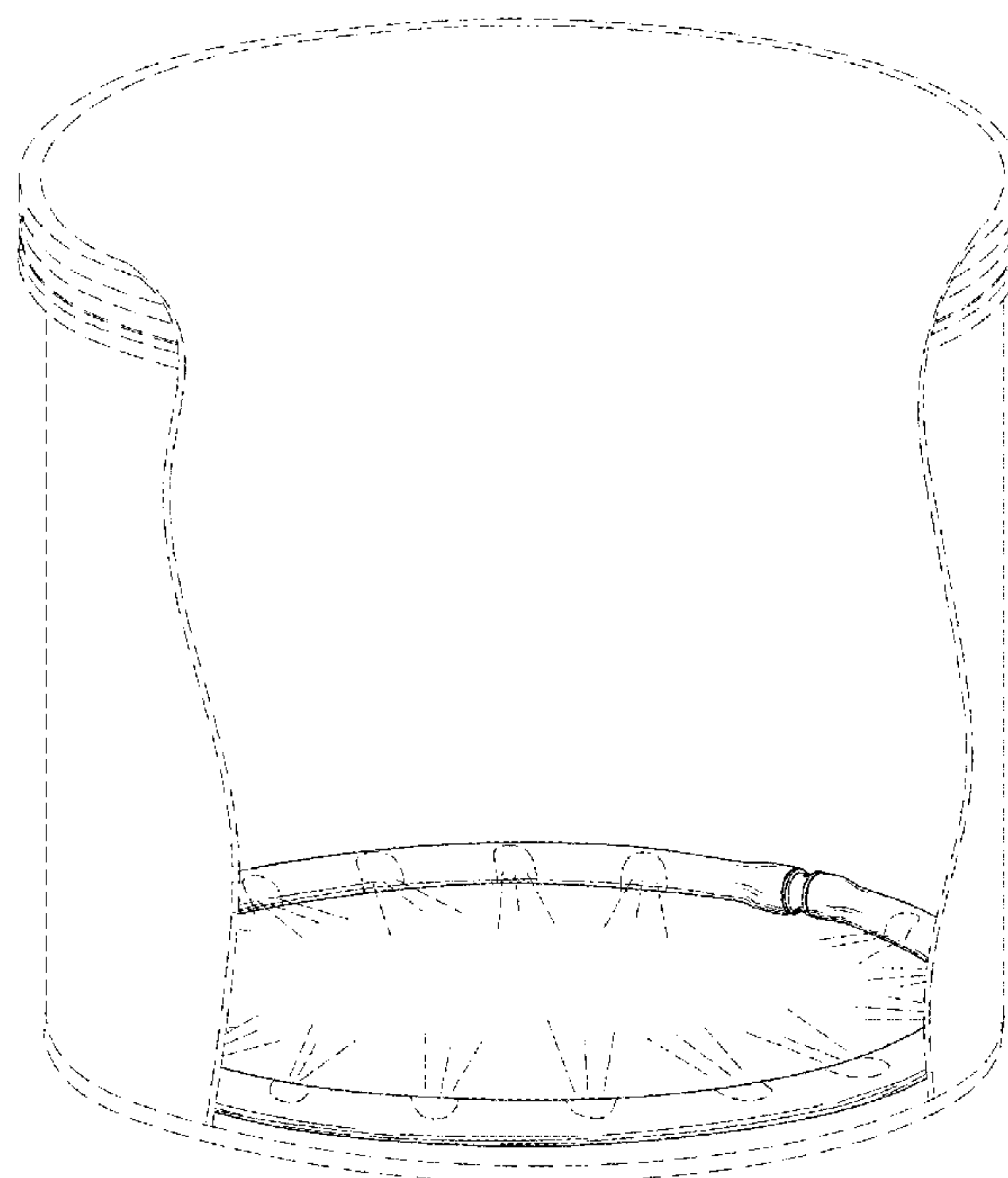

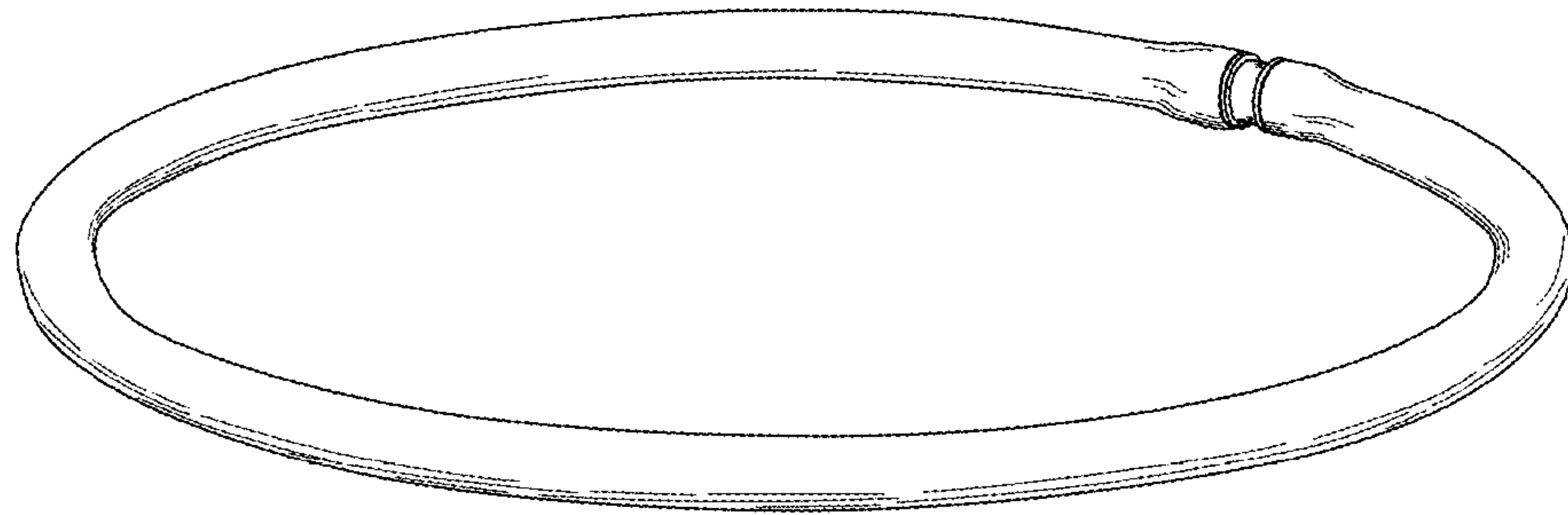

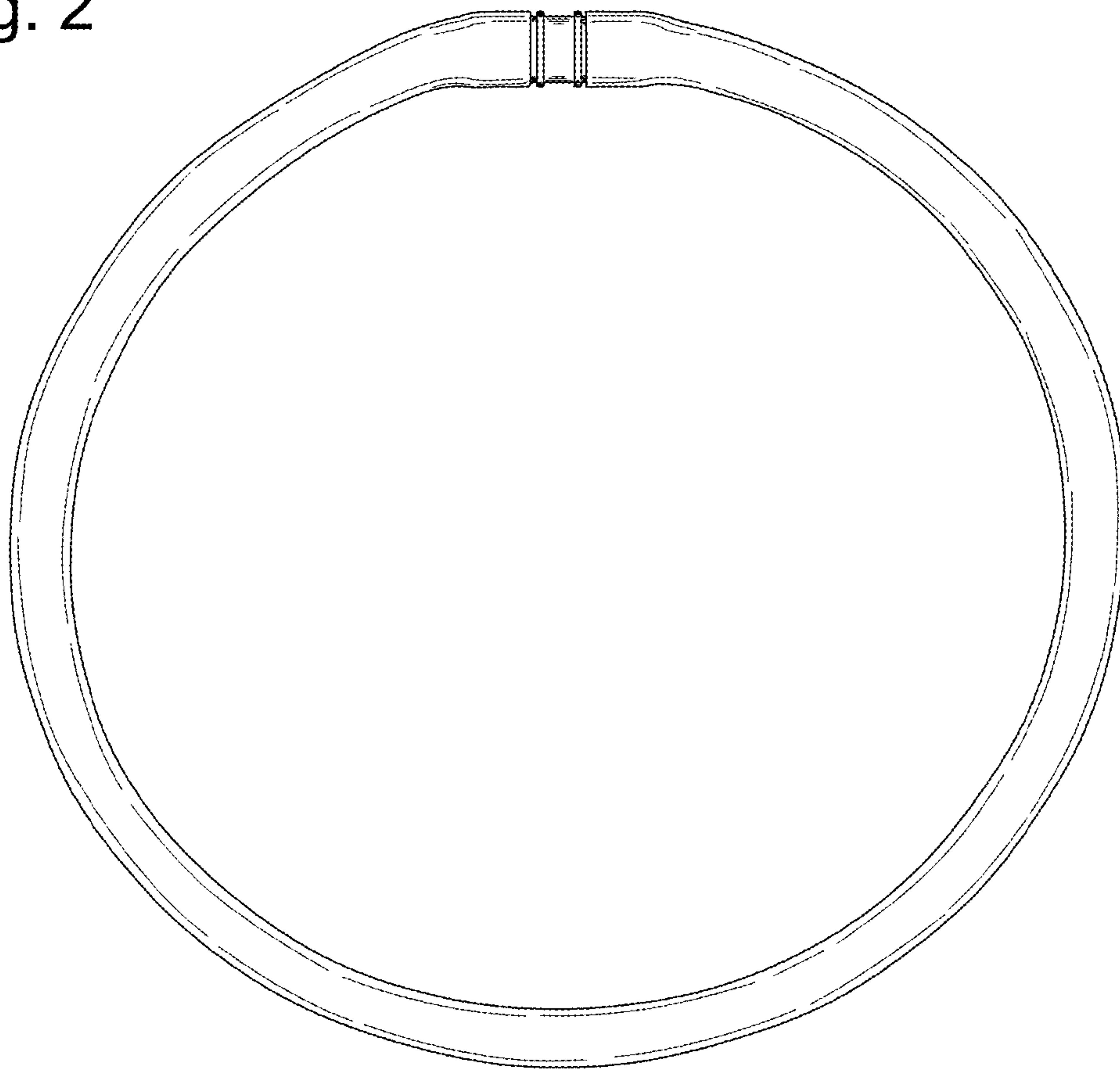

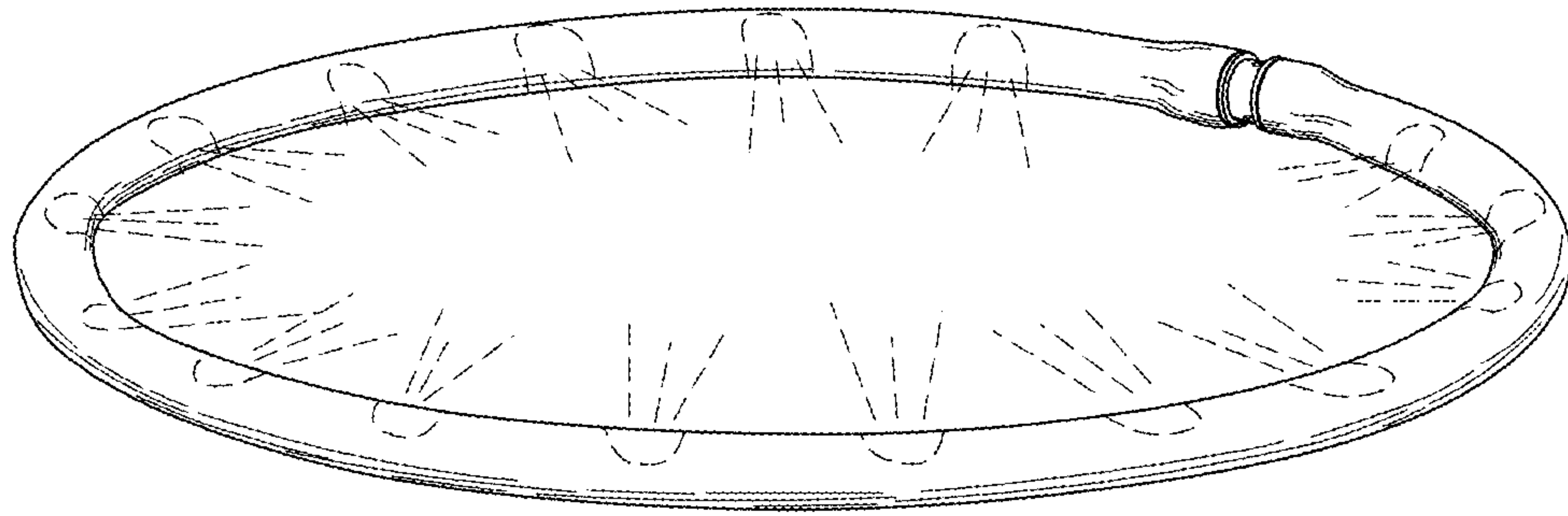

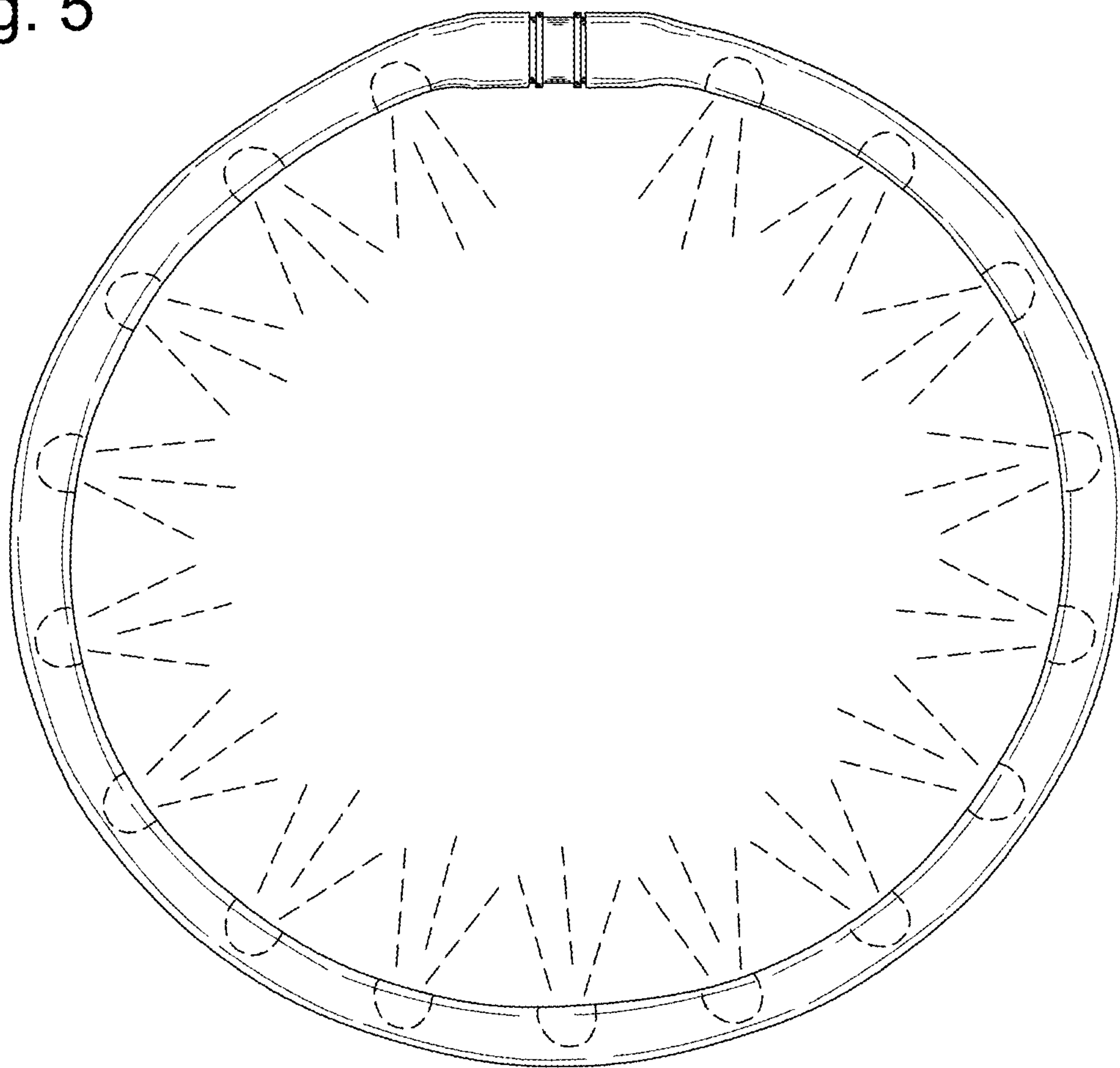
