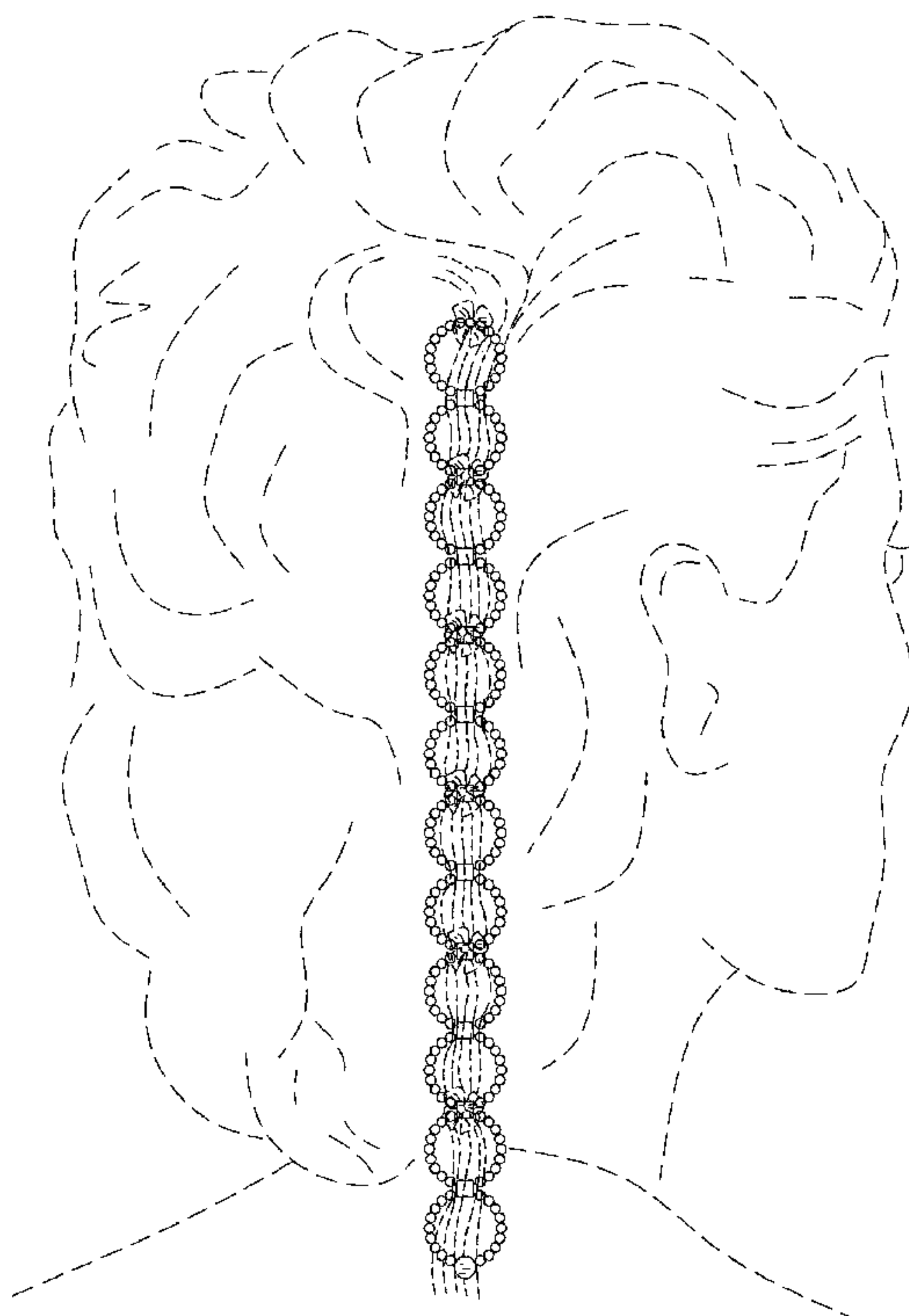
(57) **CLAIM**

The ornamental design for a hair holding band, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a hair holding band showing my new design;
FIG. 2 is a left side view of the hair holding band, a right side view being a mirror image thereof;
FIG. 3 is a top view of the hair holding band;
FIG. 4 is a bottom view of the hair holding band; and,
FIG. 5 is a front view of the hair holding band in use.

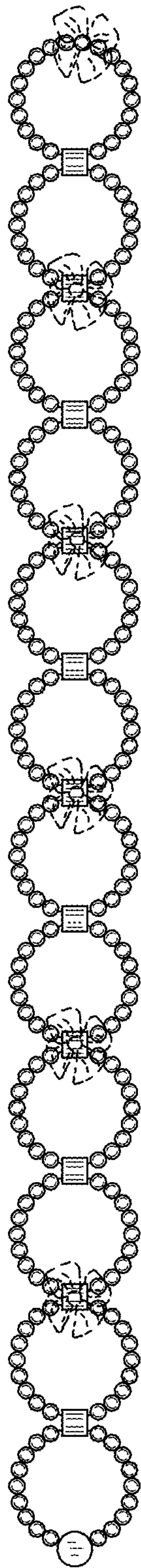

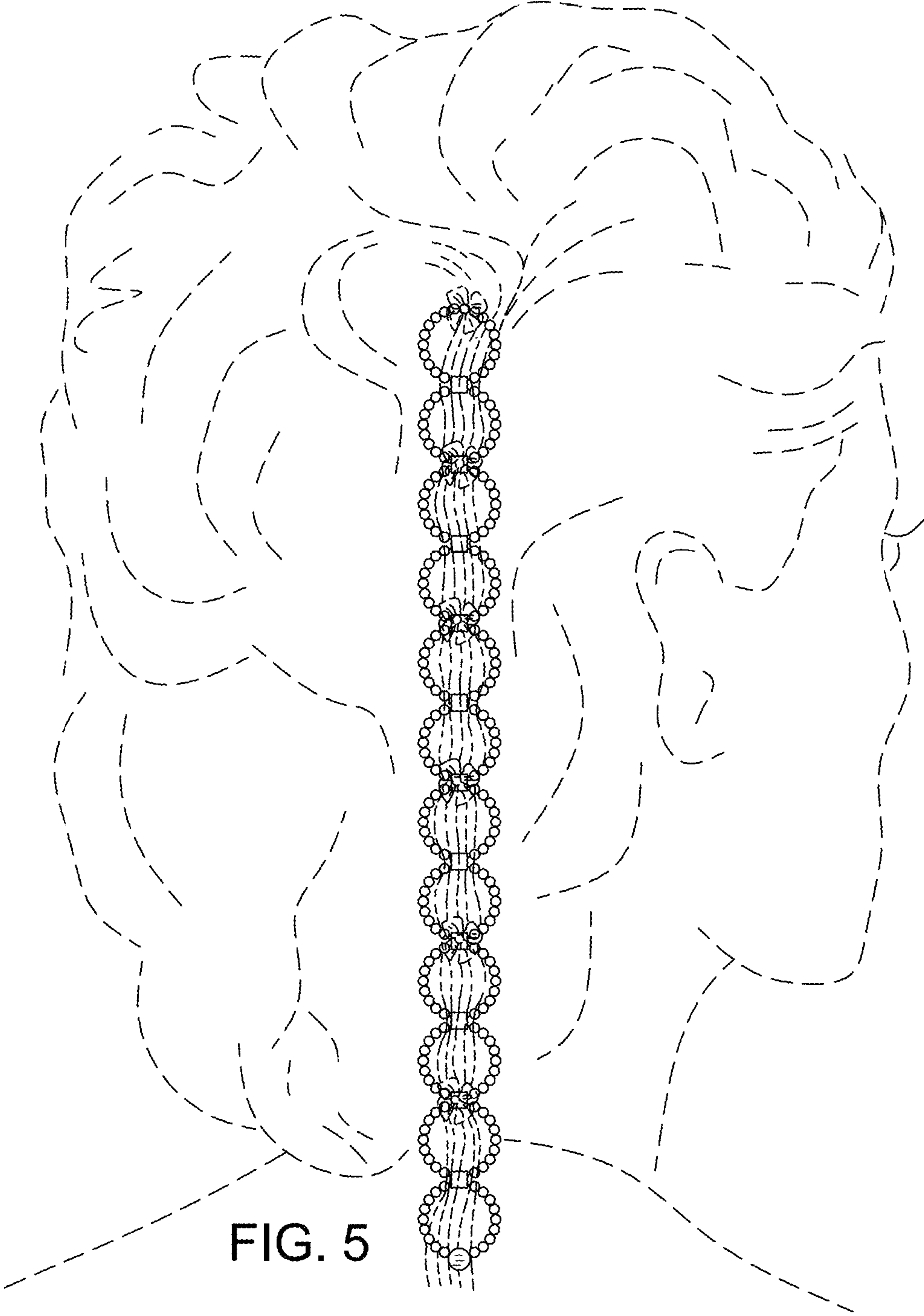
