FIG. 5 is a left side view of FIG. 4.

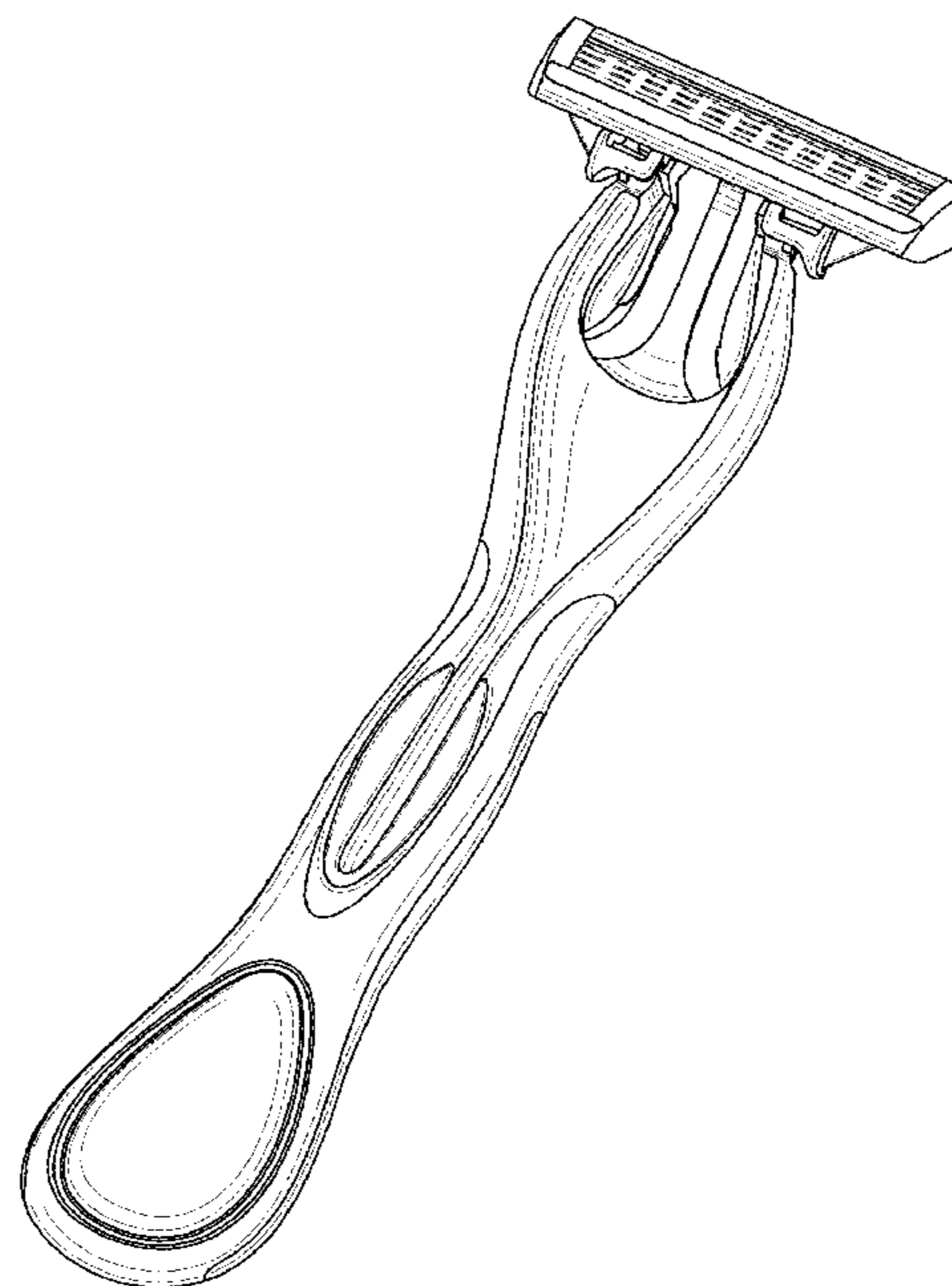
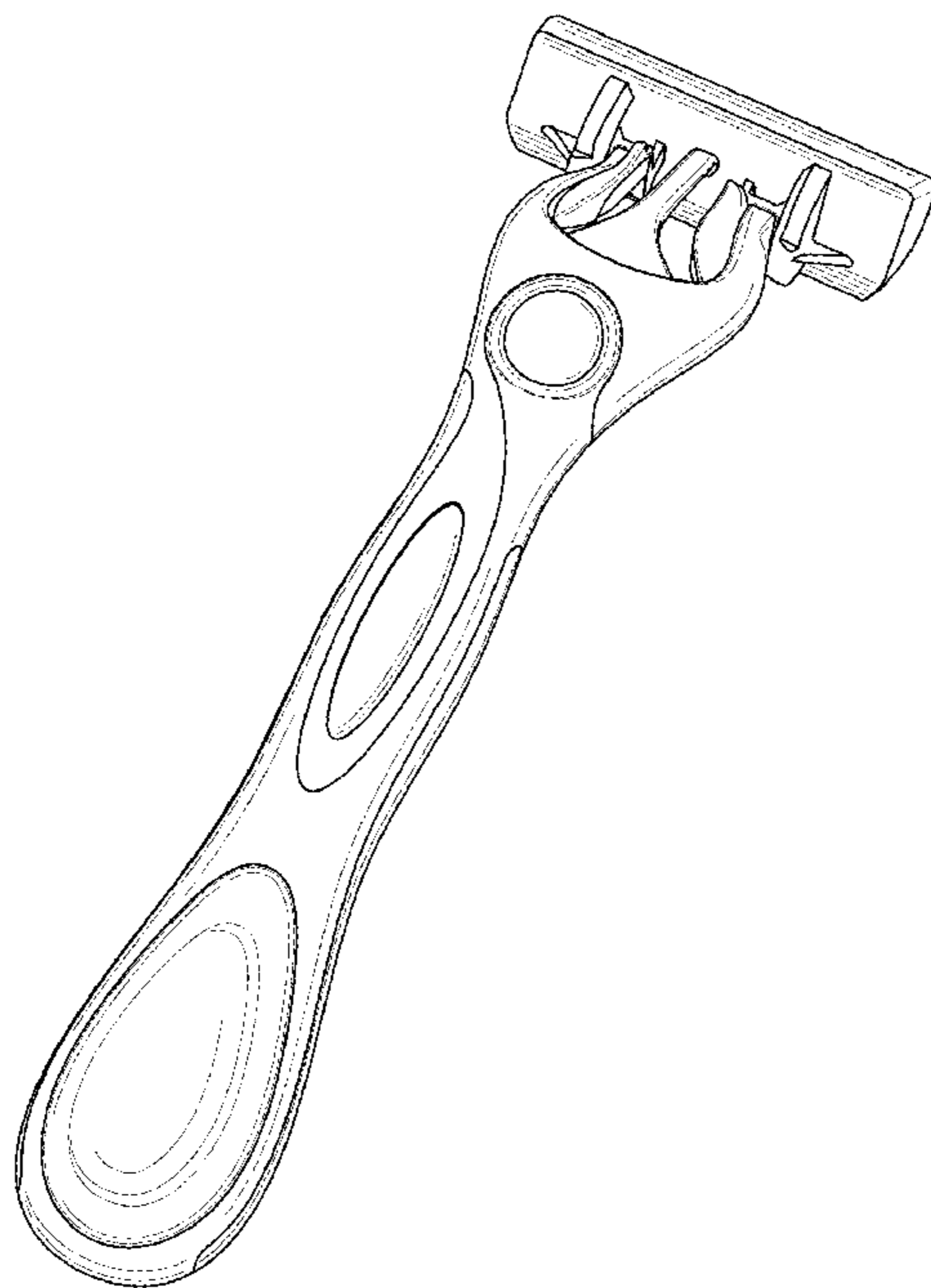
FIG. 6 is a right side view of FIG. 4.

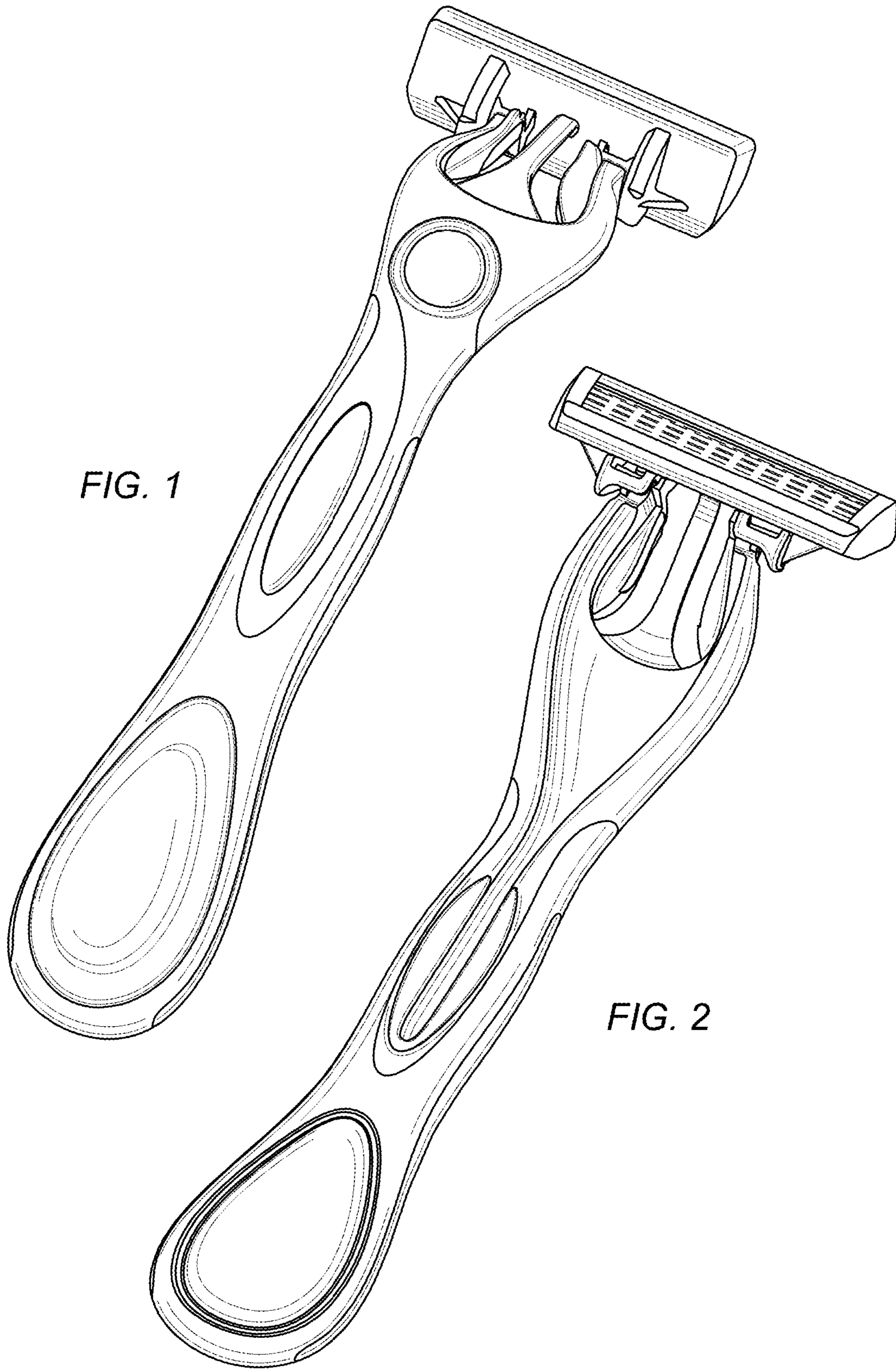

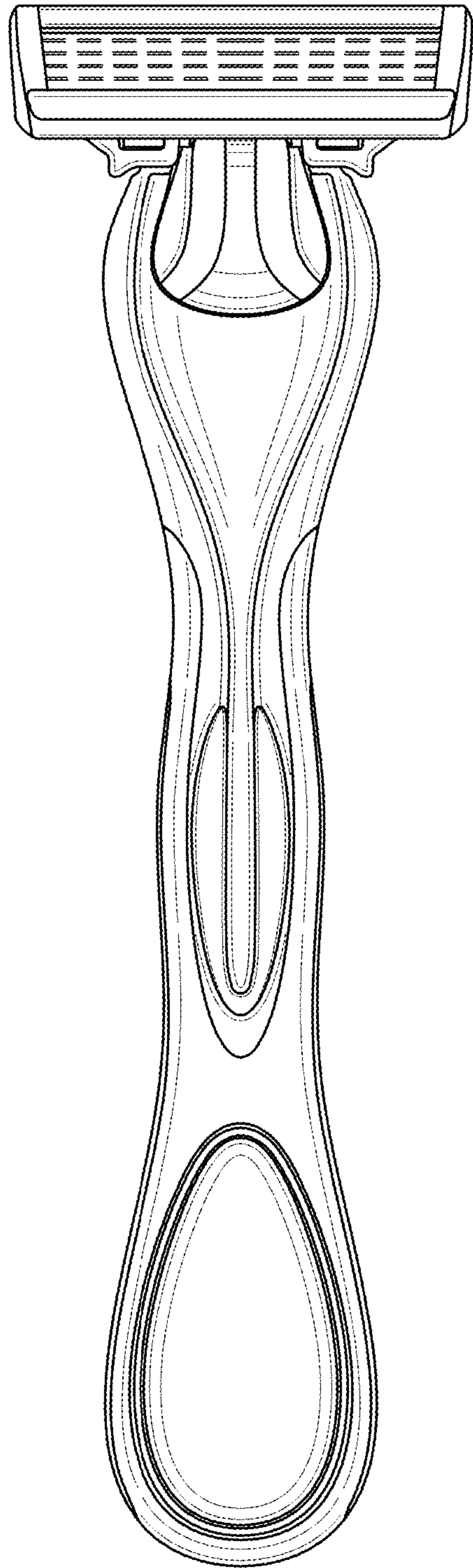

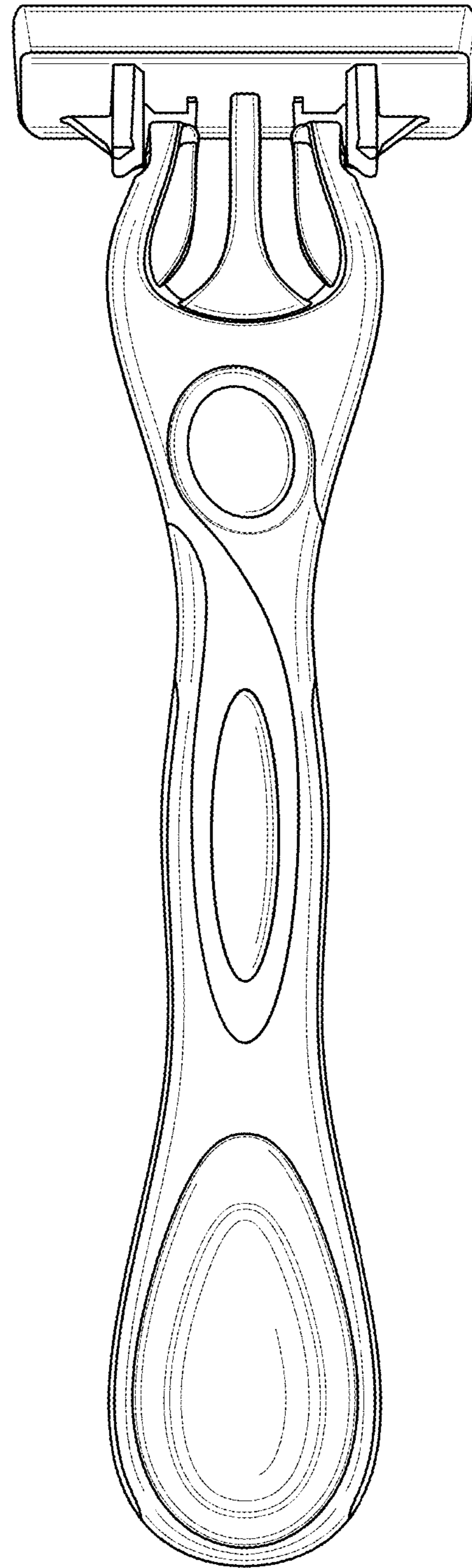

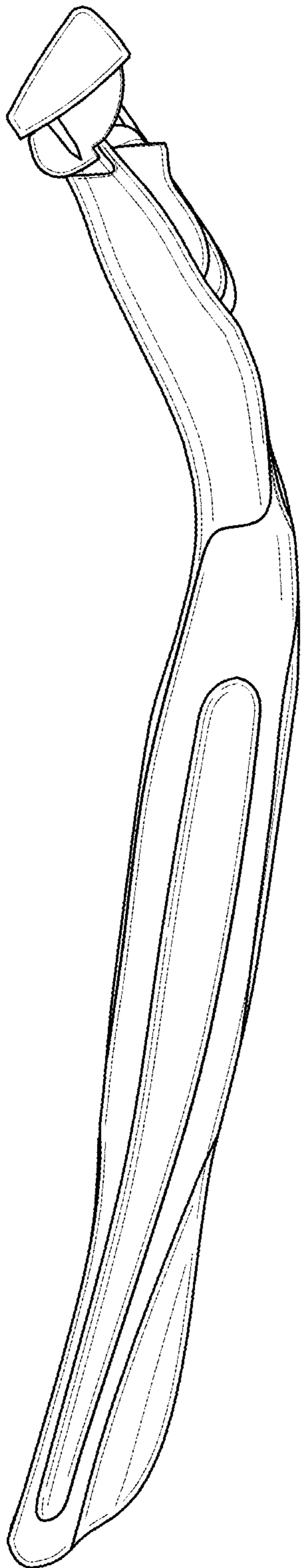

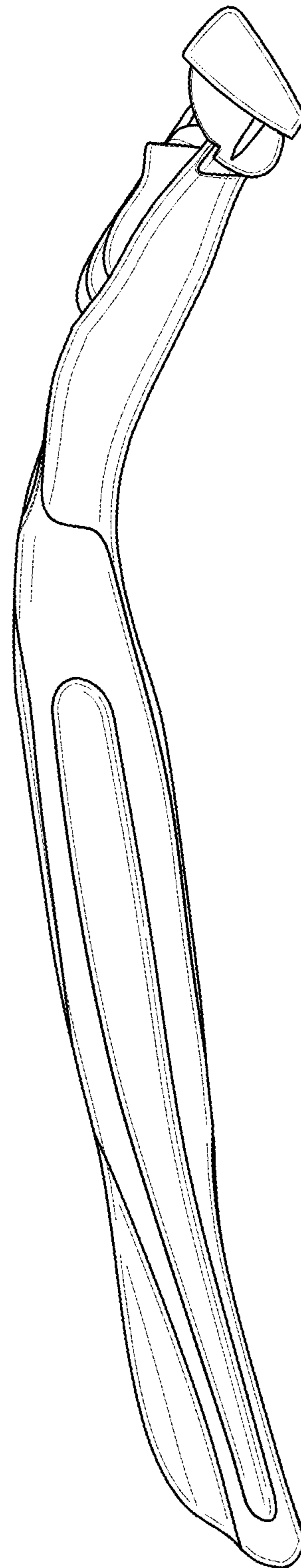

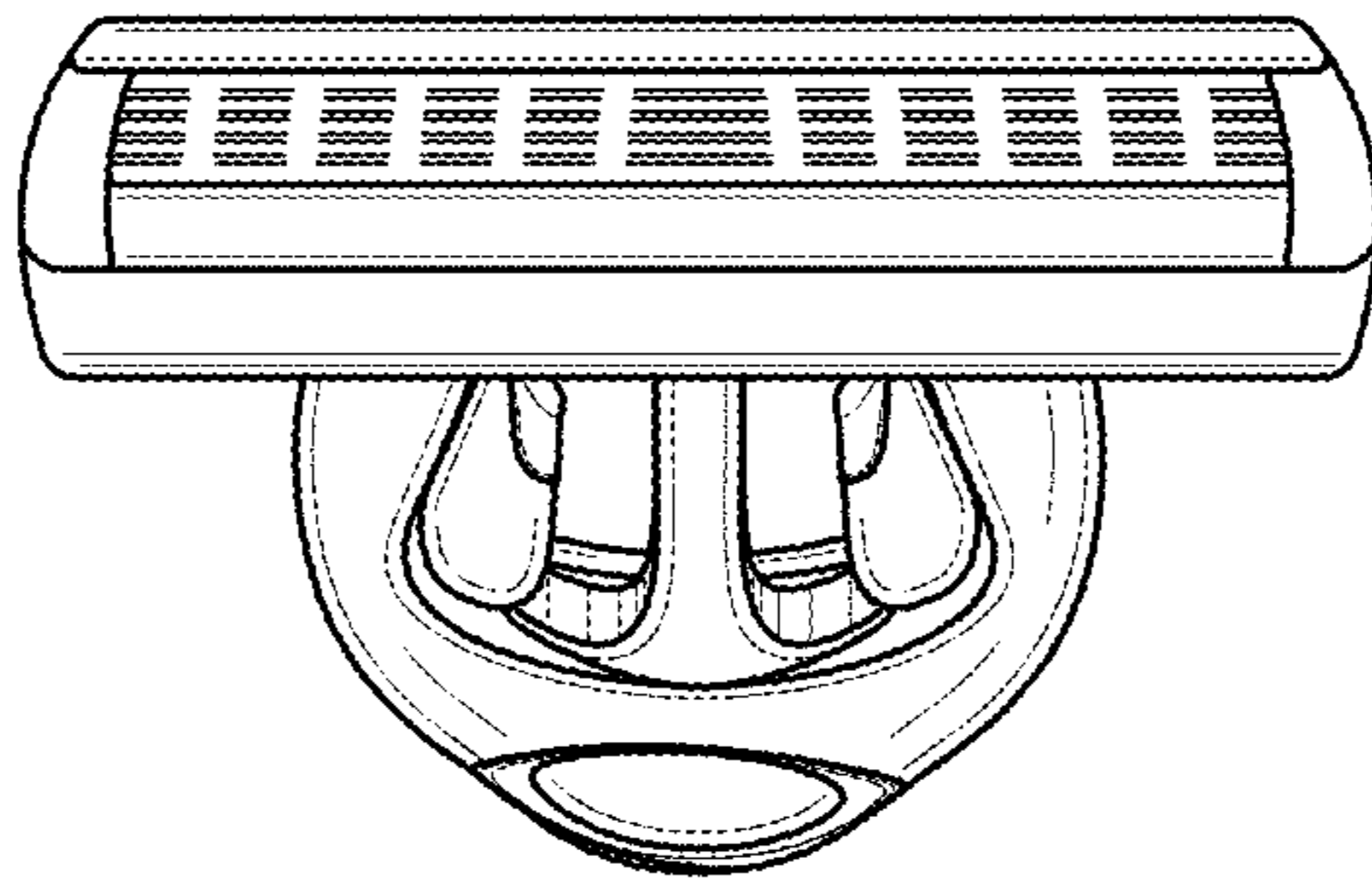

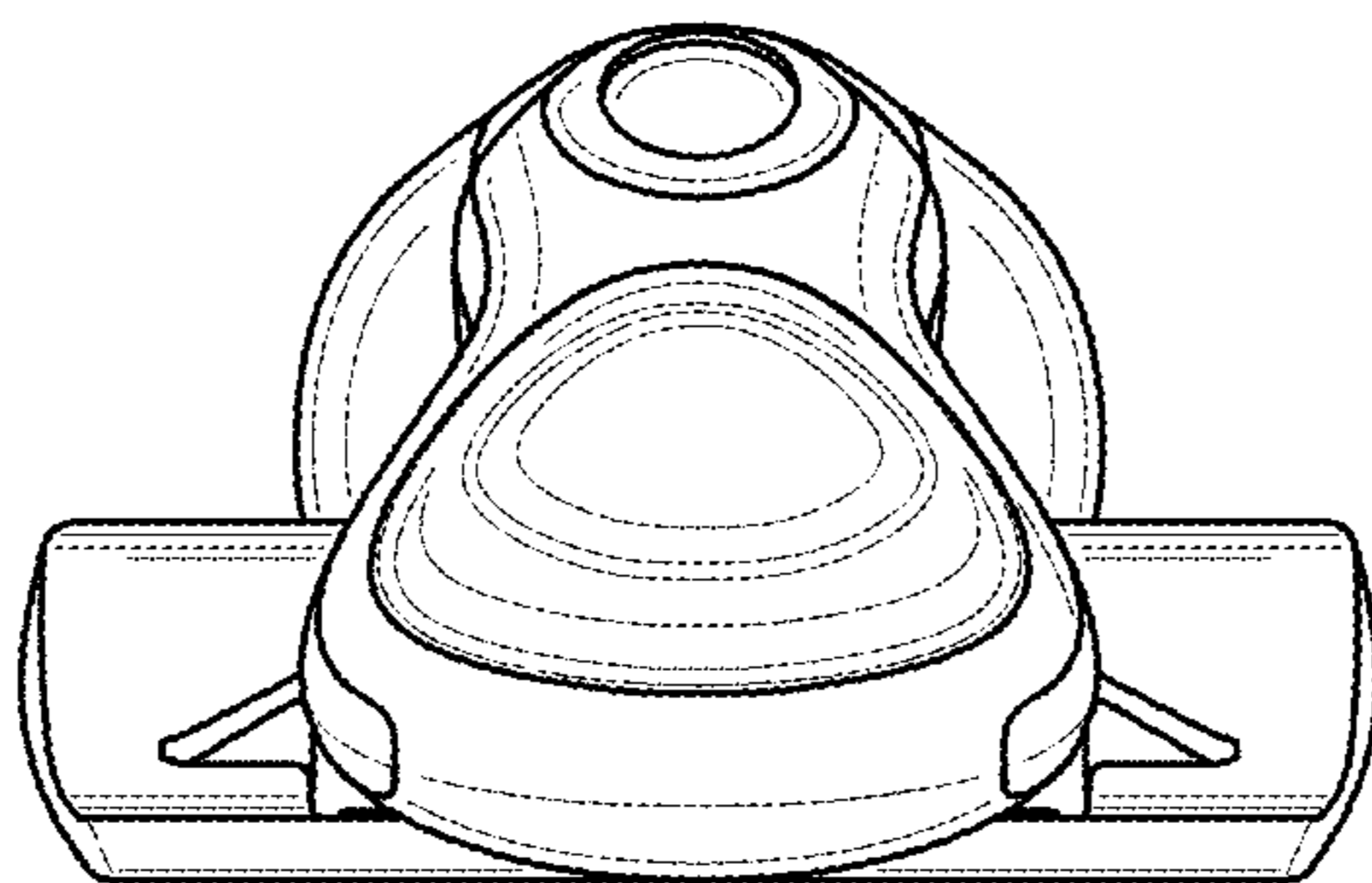
