DESCRIPTION

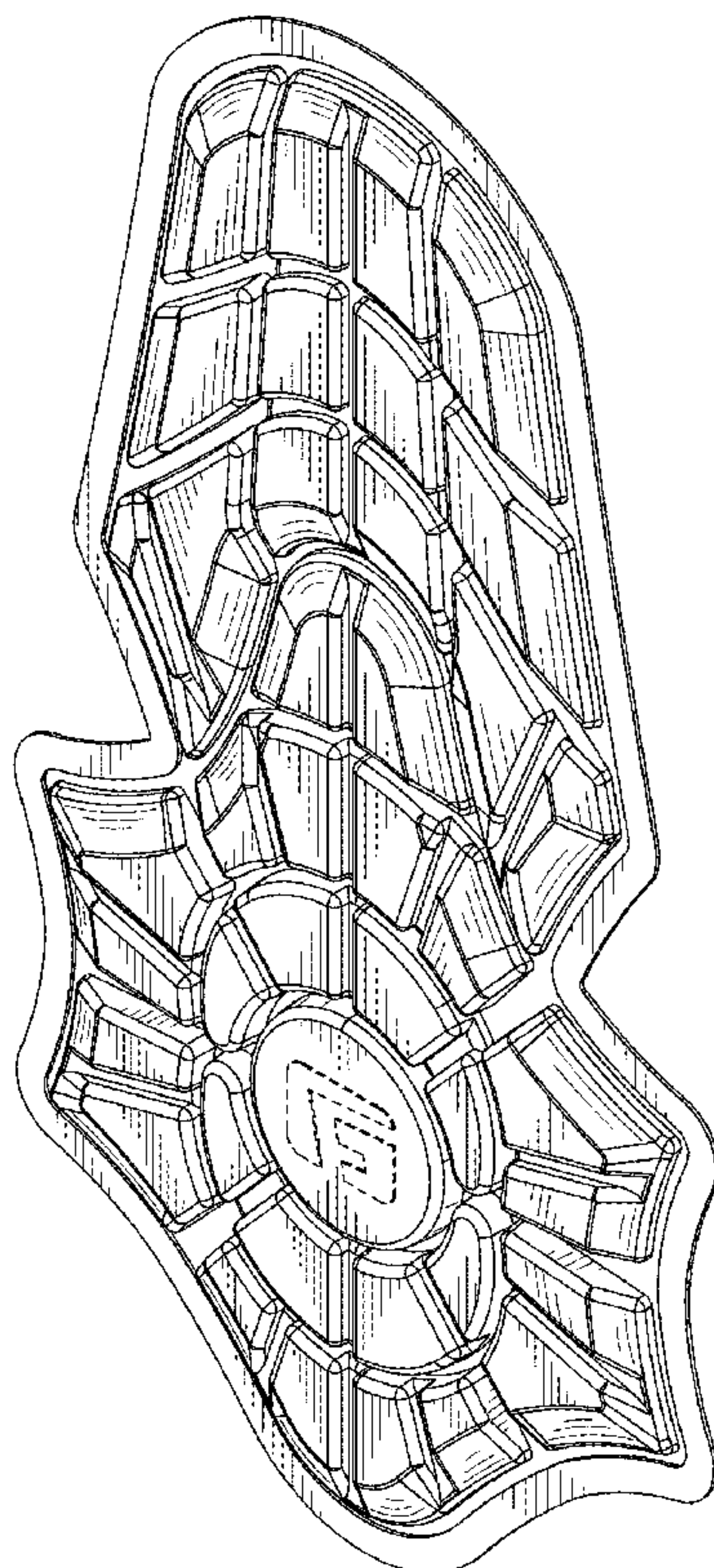
FIG. 1 is a perspective view of a baseball elbow guard showing our new design;

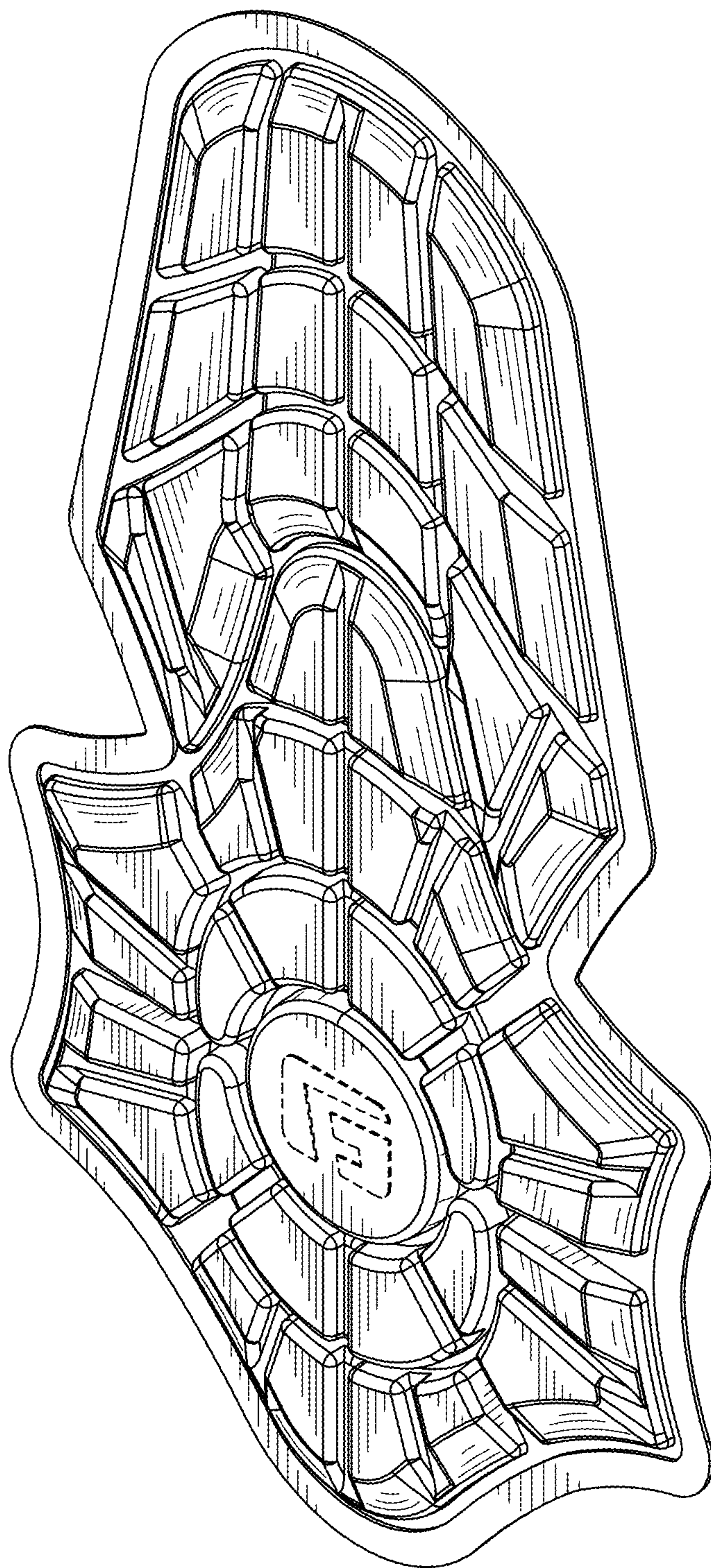

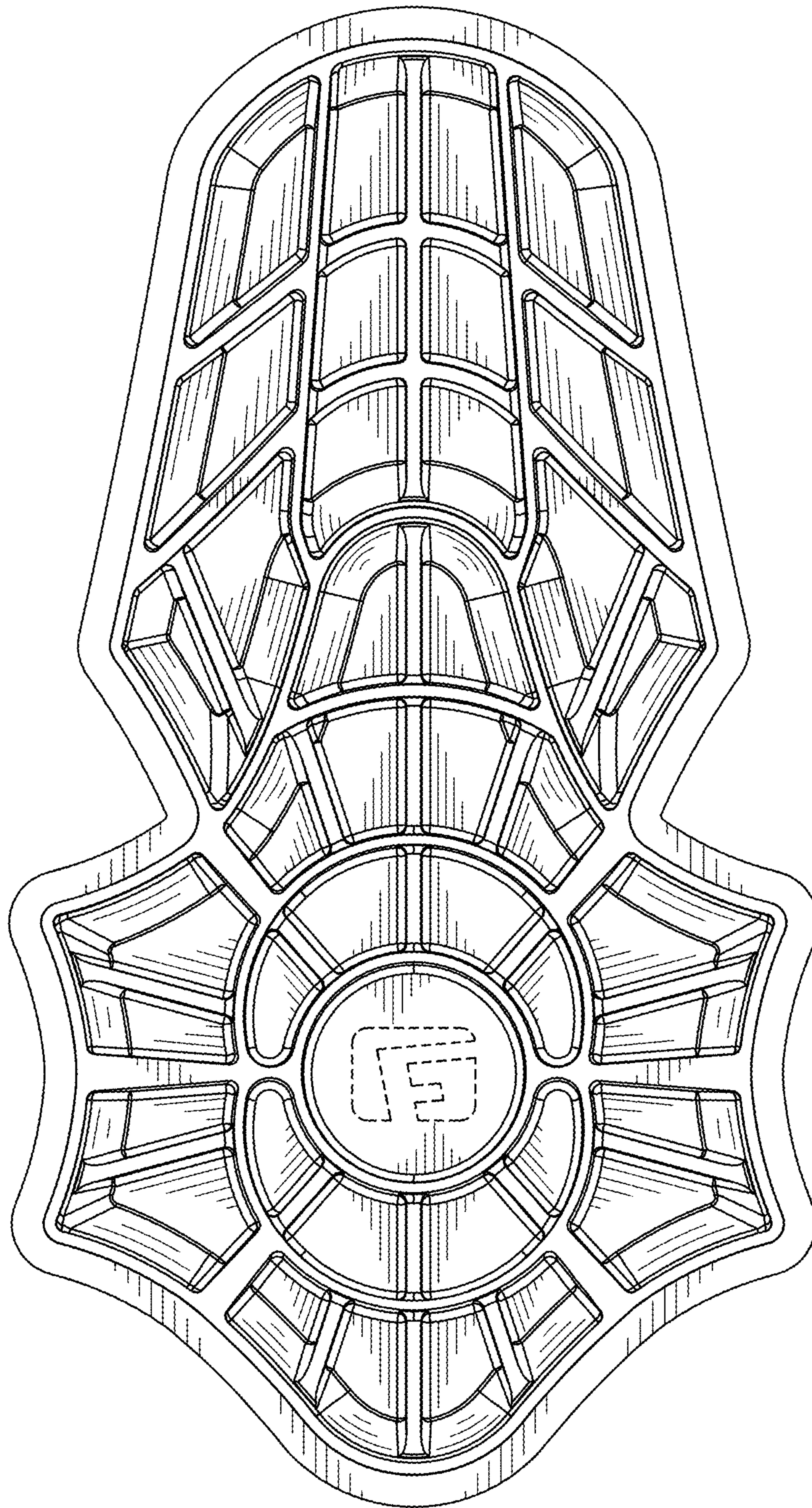

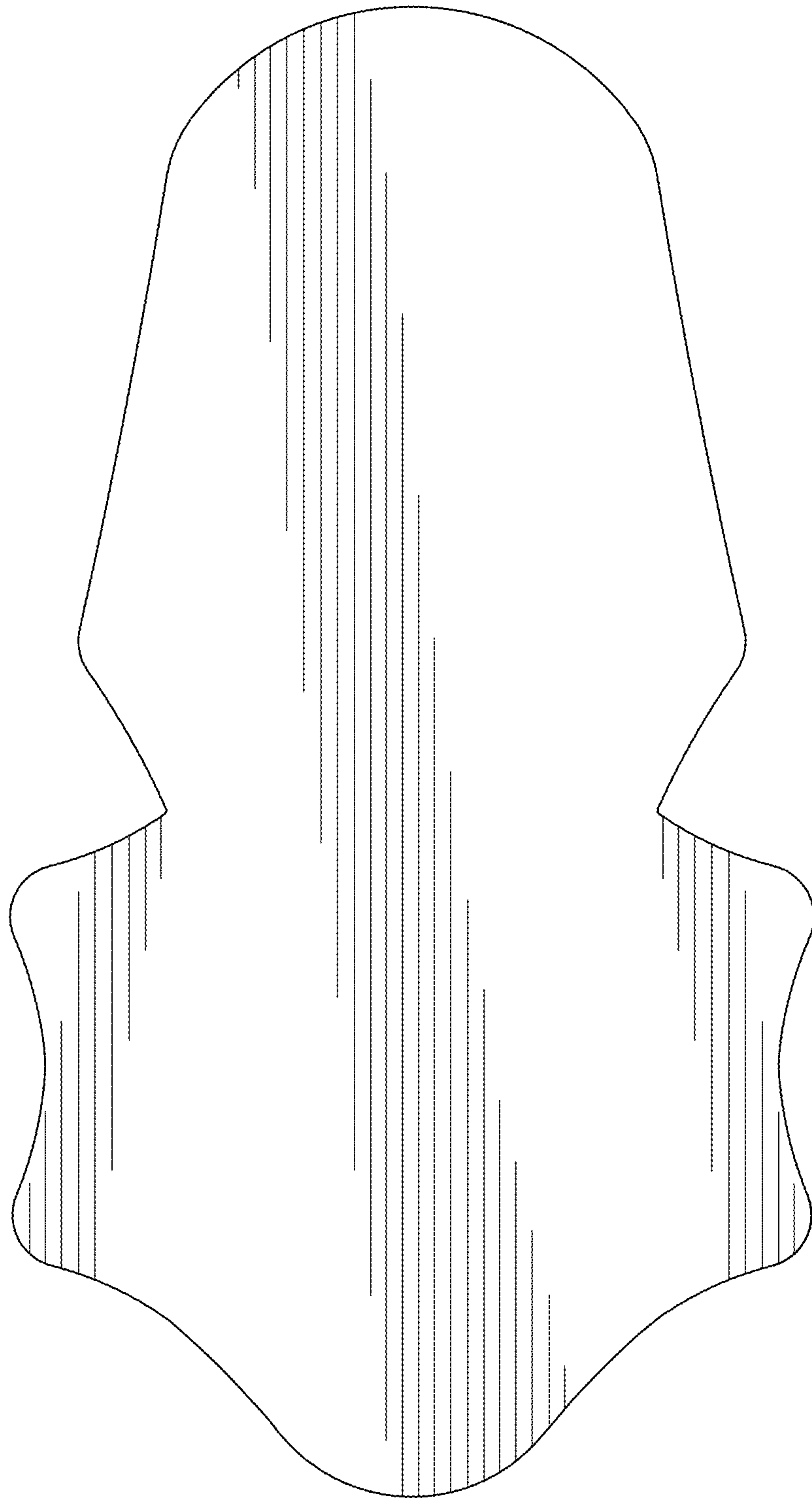
