(57) **CLAIM**

The ornamental design for a combination cleavage-enhancing garment insert and set of insert covers, as shown and described.

**DESCRIPTION**

FIG. 1 is a view of the cleavage-enhancing garment insert inside of a bra;

FIG. 2 is a rear view of the cleavage-enhancing garment insert;

FIG. 3 is a front view of the cleavage-enhancing garment insert;

FIG. 4 is a left view of the cleavage-enhancing garment insert;

FIG. 5 is a right view of the cleavage-enhancing garment insert;

FIG. 6 is a top view of the cleavage-enhancing garment insert;

FIG. 7 is a bottom view of the cleavage-enhancing garment insert;

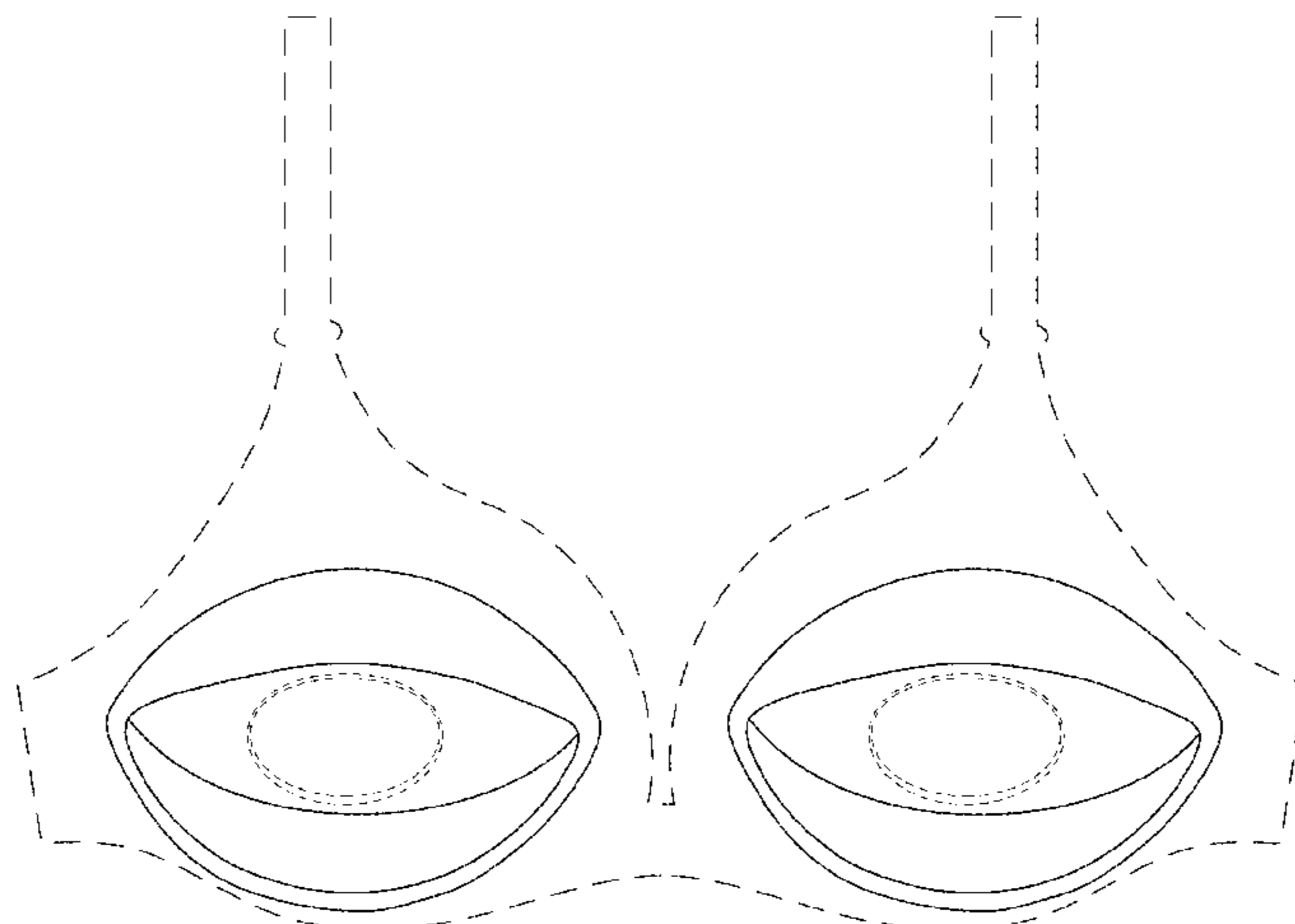
FIG. 8B is a lace print cover for the cleavage-enhancing insert, which is shown separate of the insert for clarity of illustration;

FIG. 8A is a peach color cover for the cleavage-enhancing insert, which is shown separate of the insert for clarity of illustration;

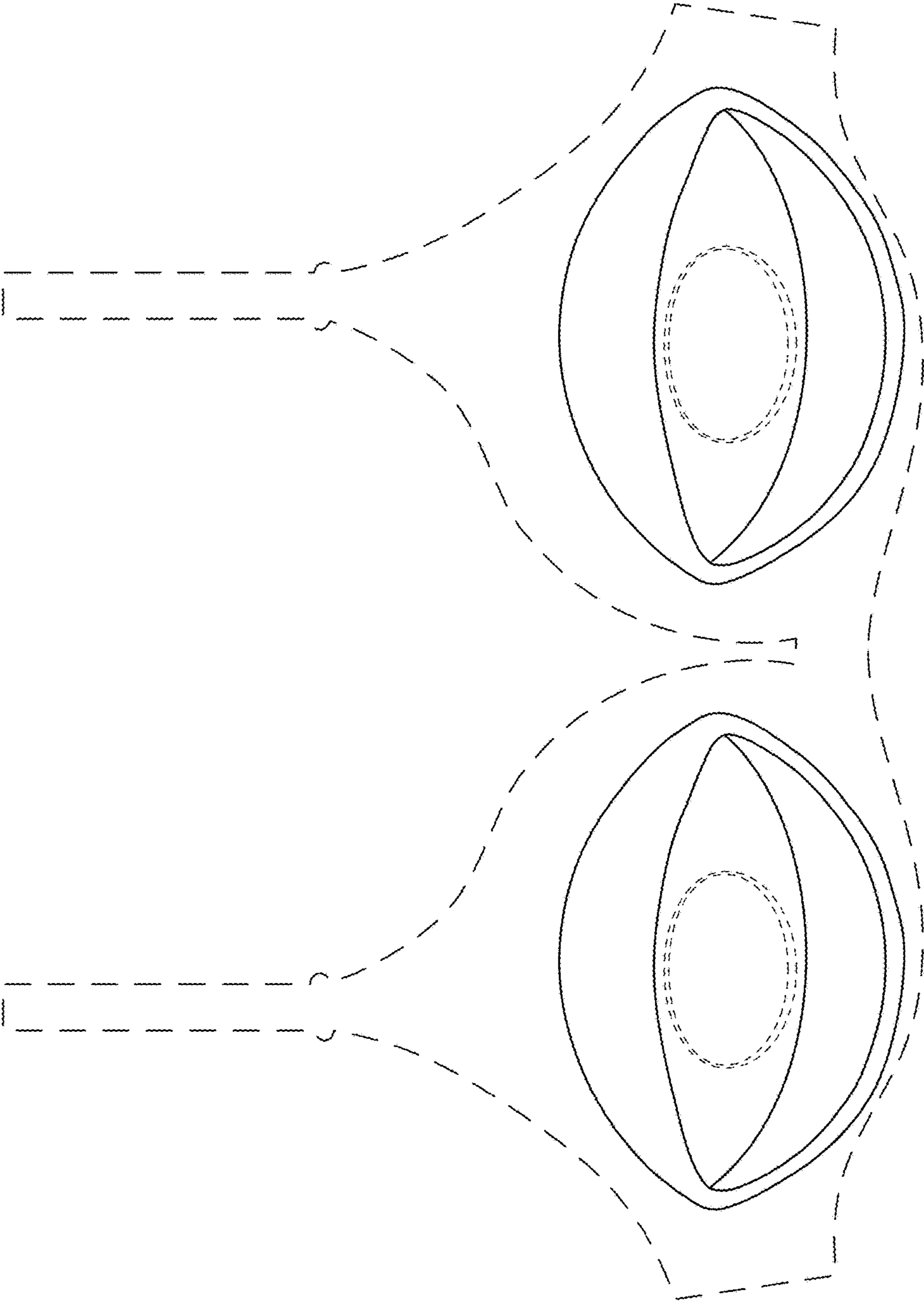

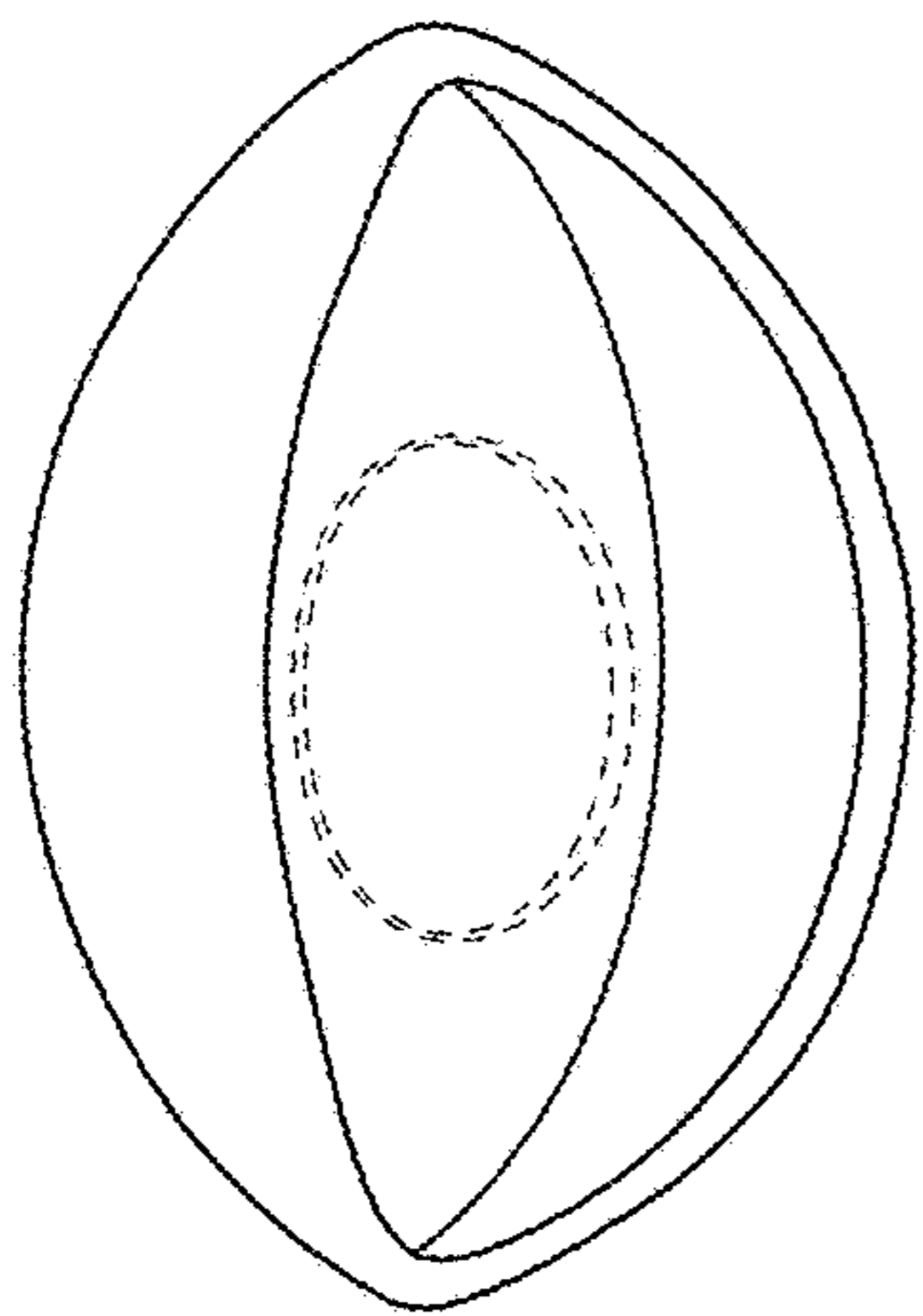

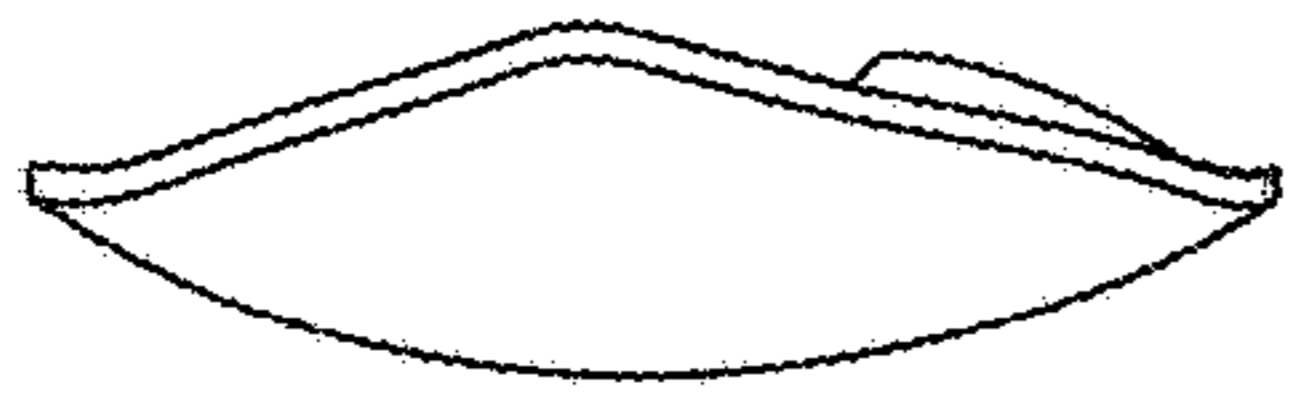

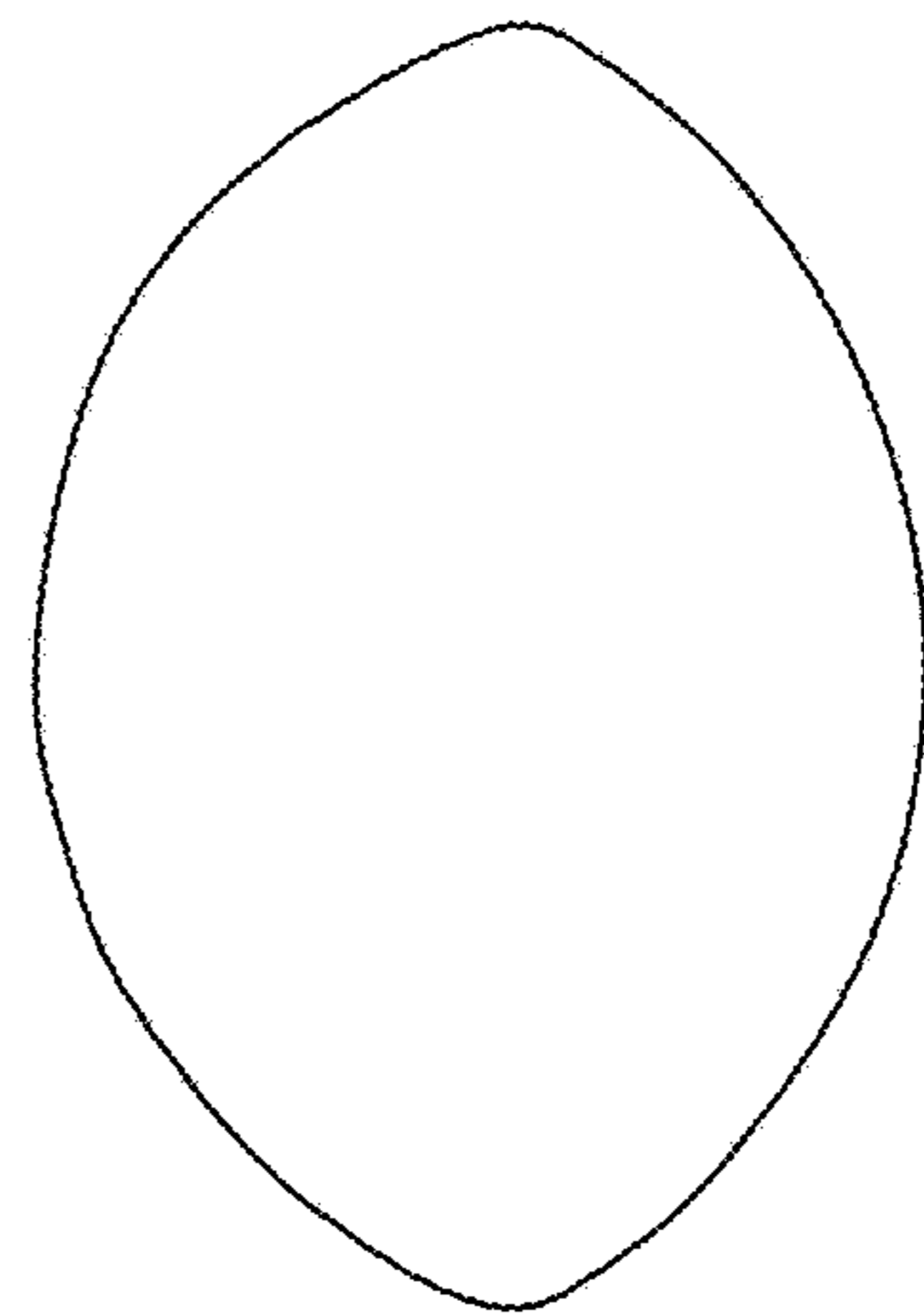

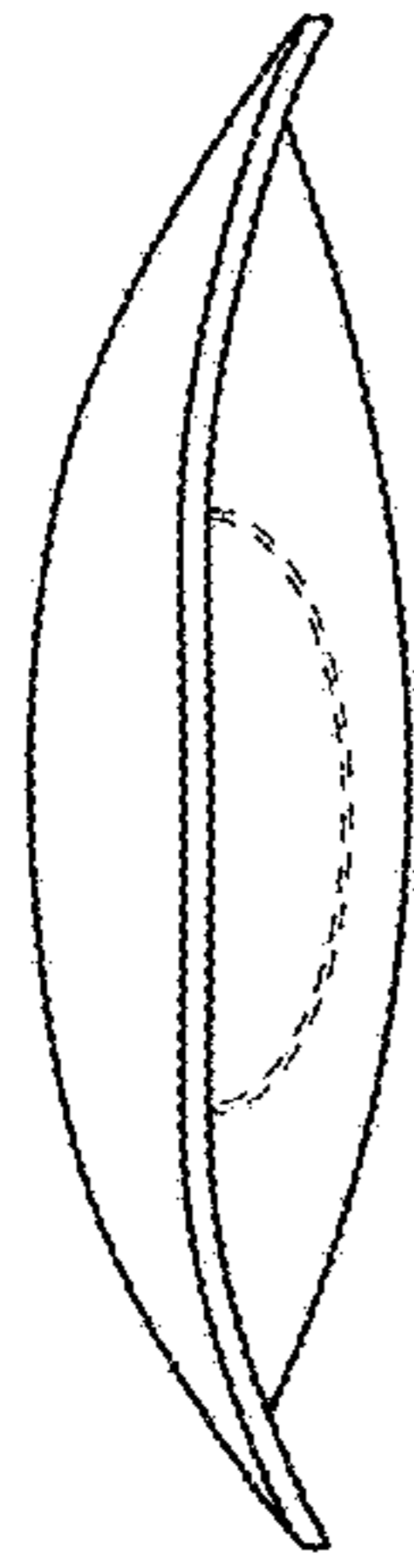

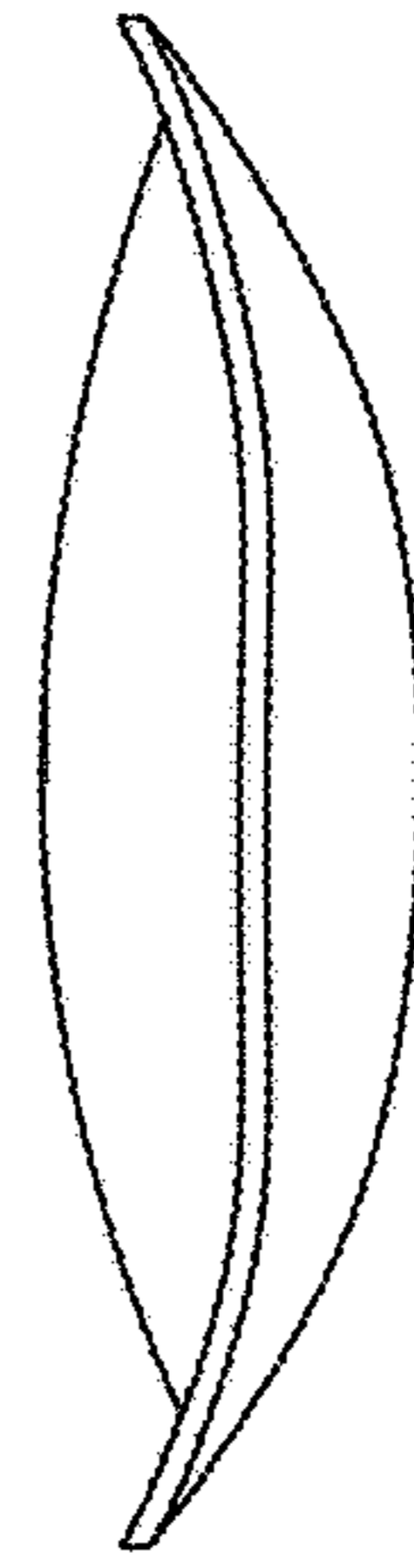

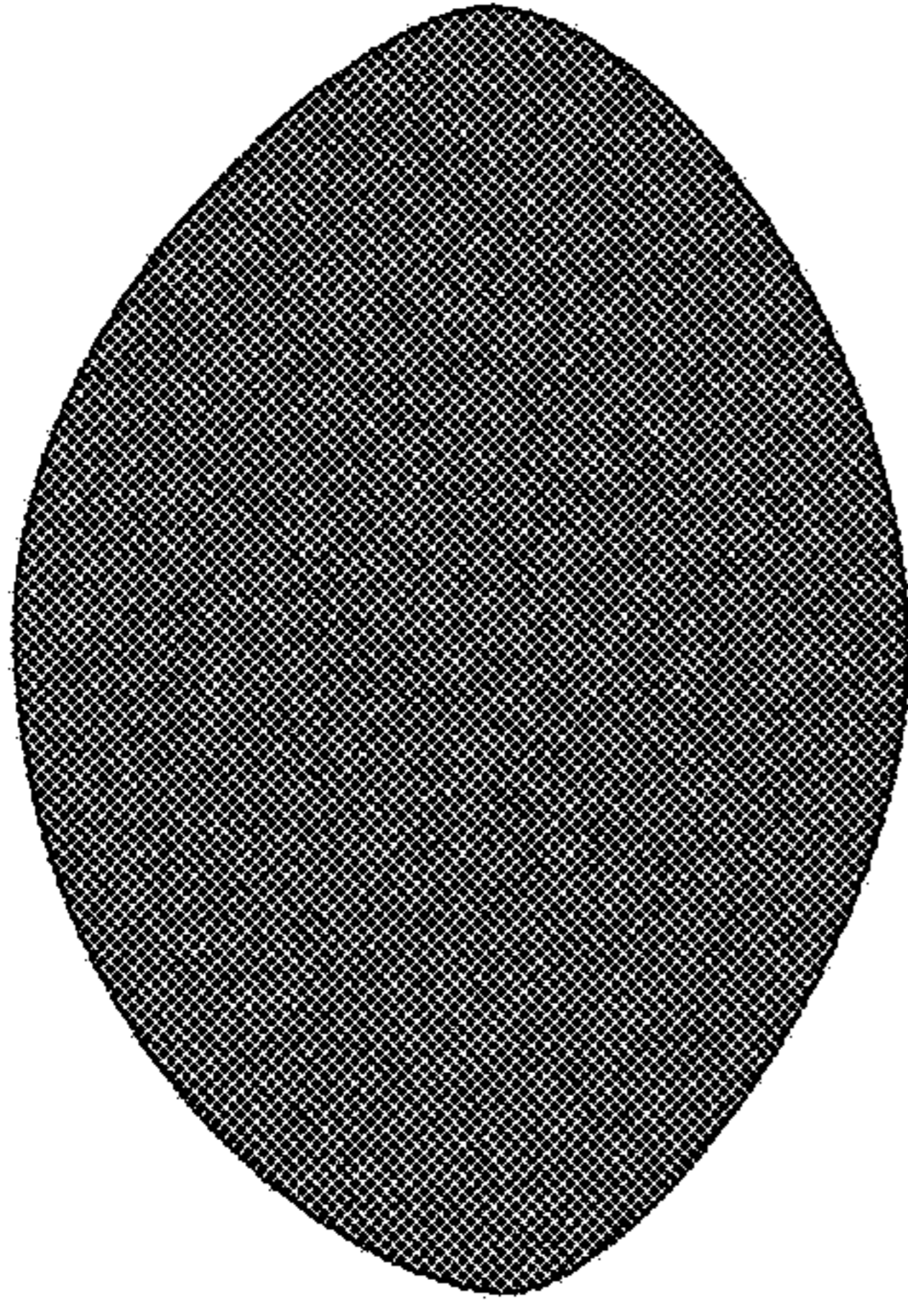

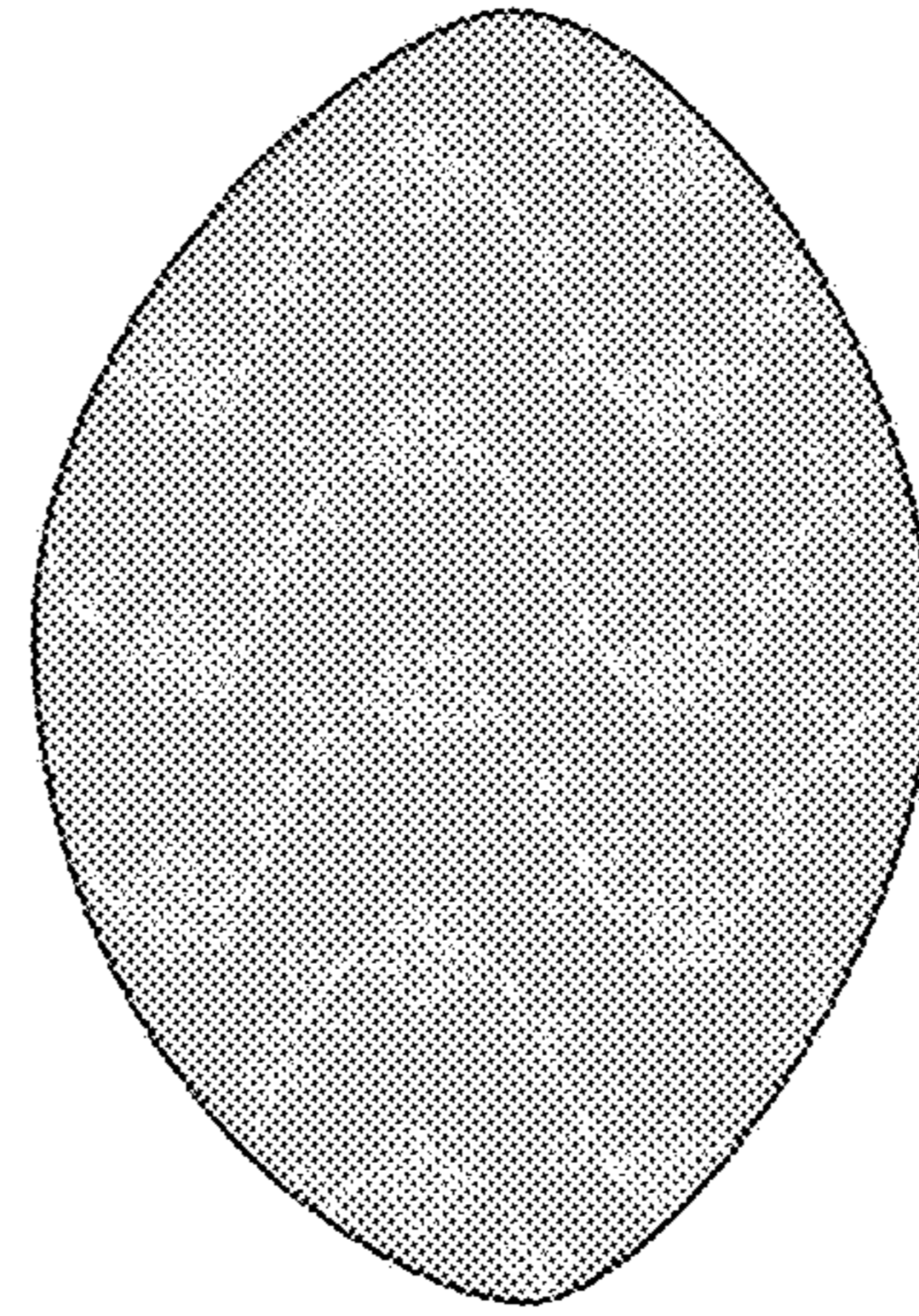

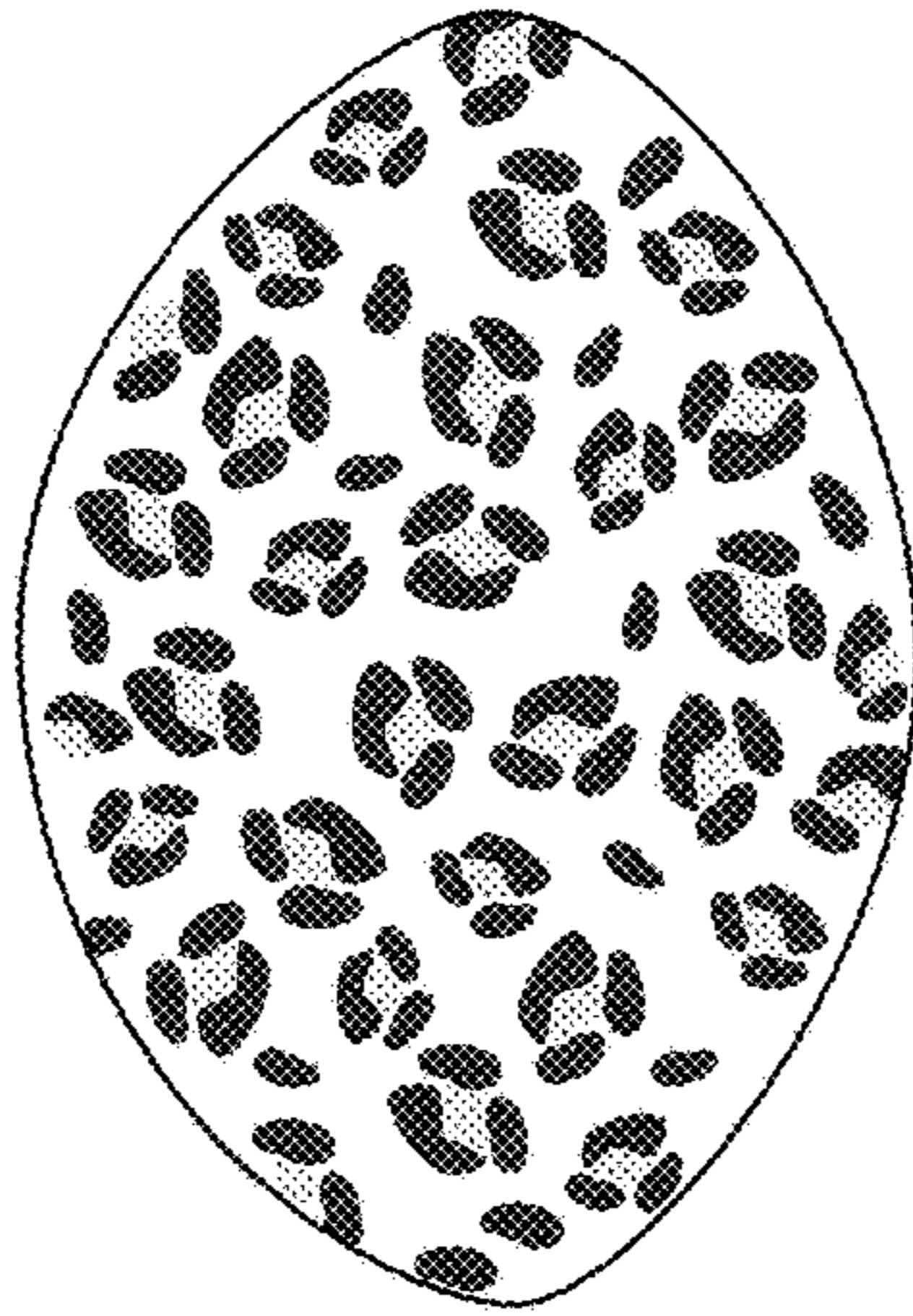

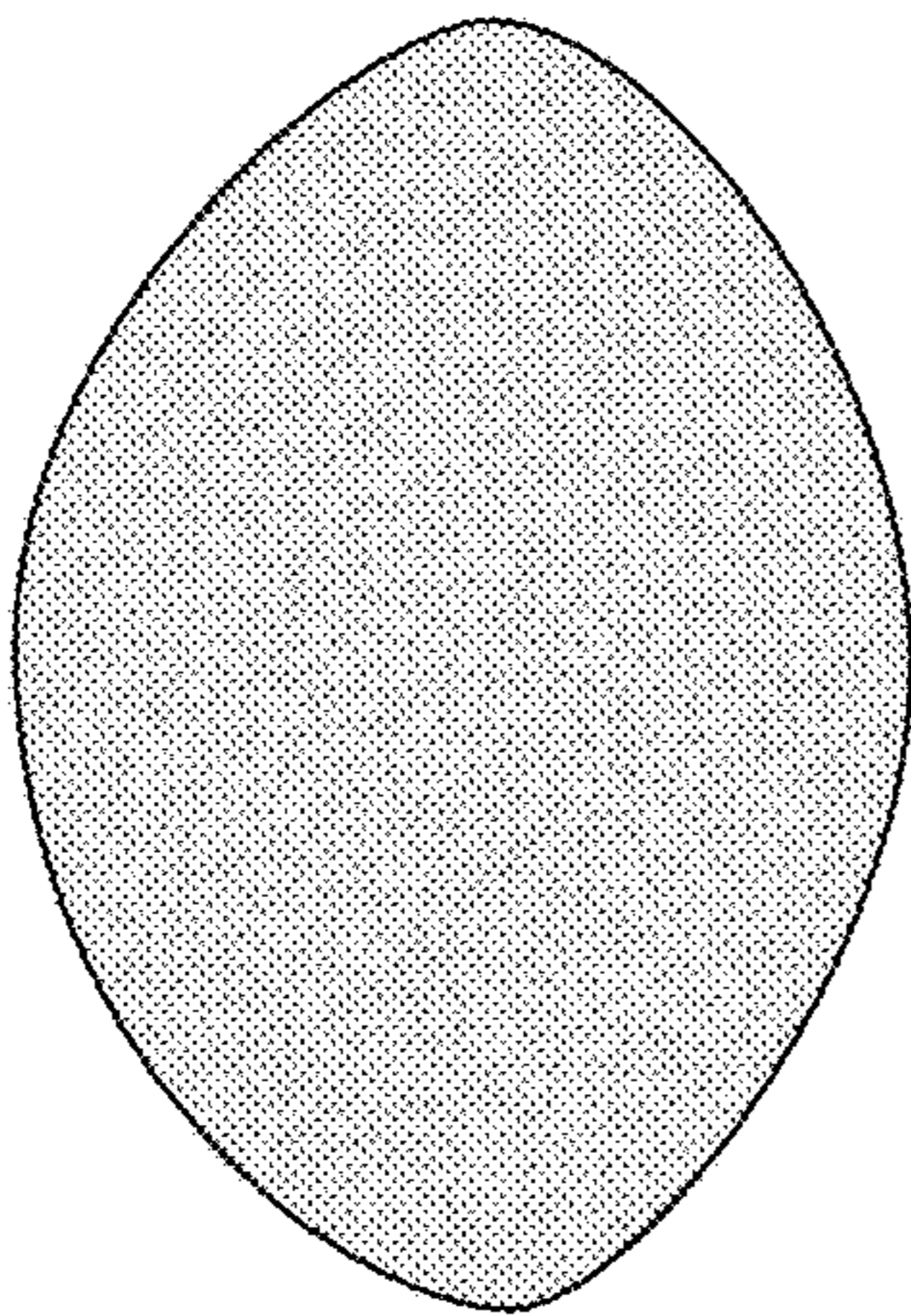

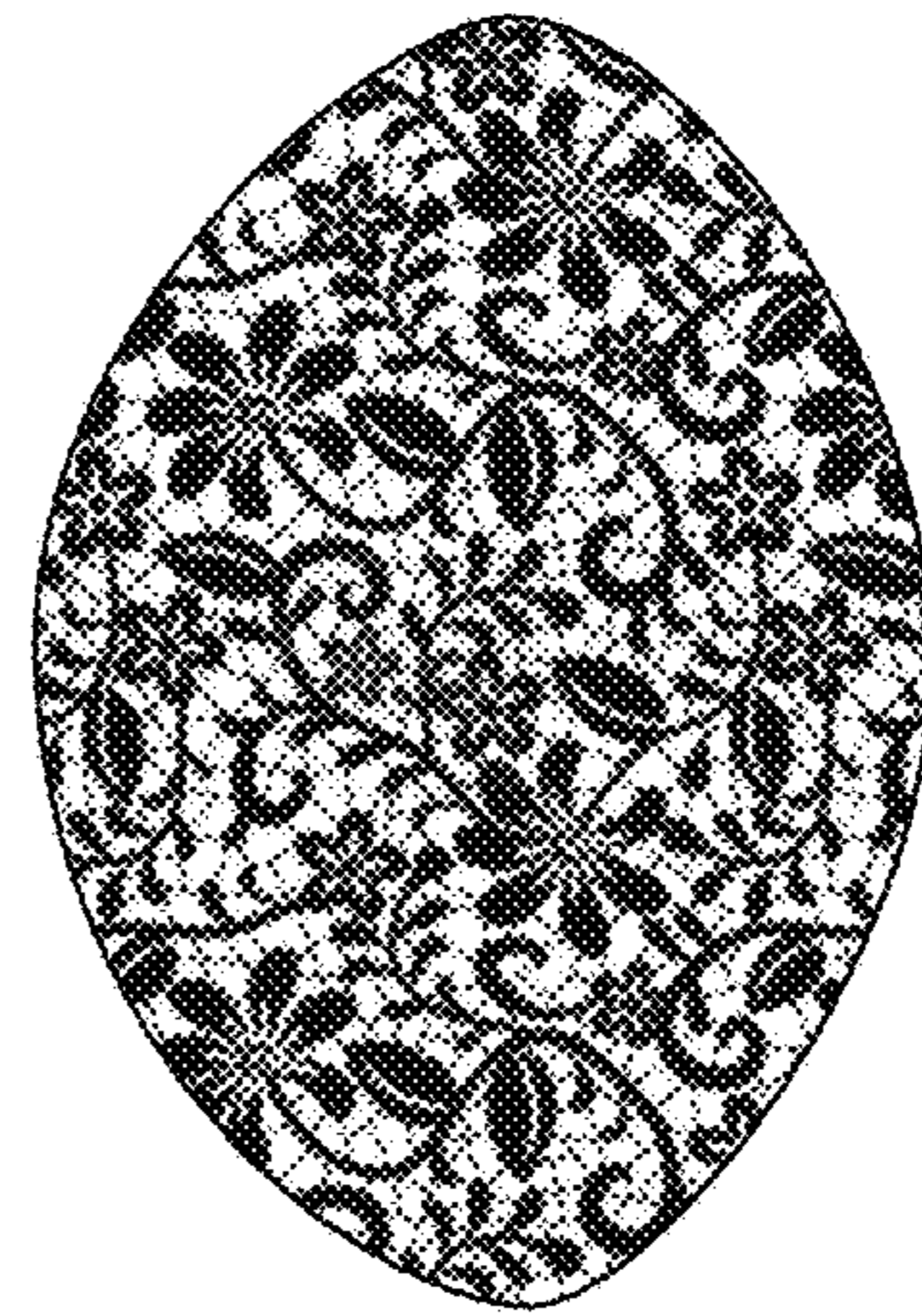
