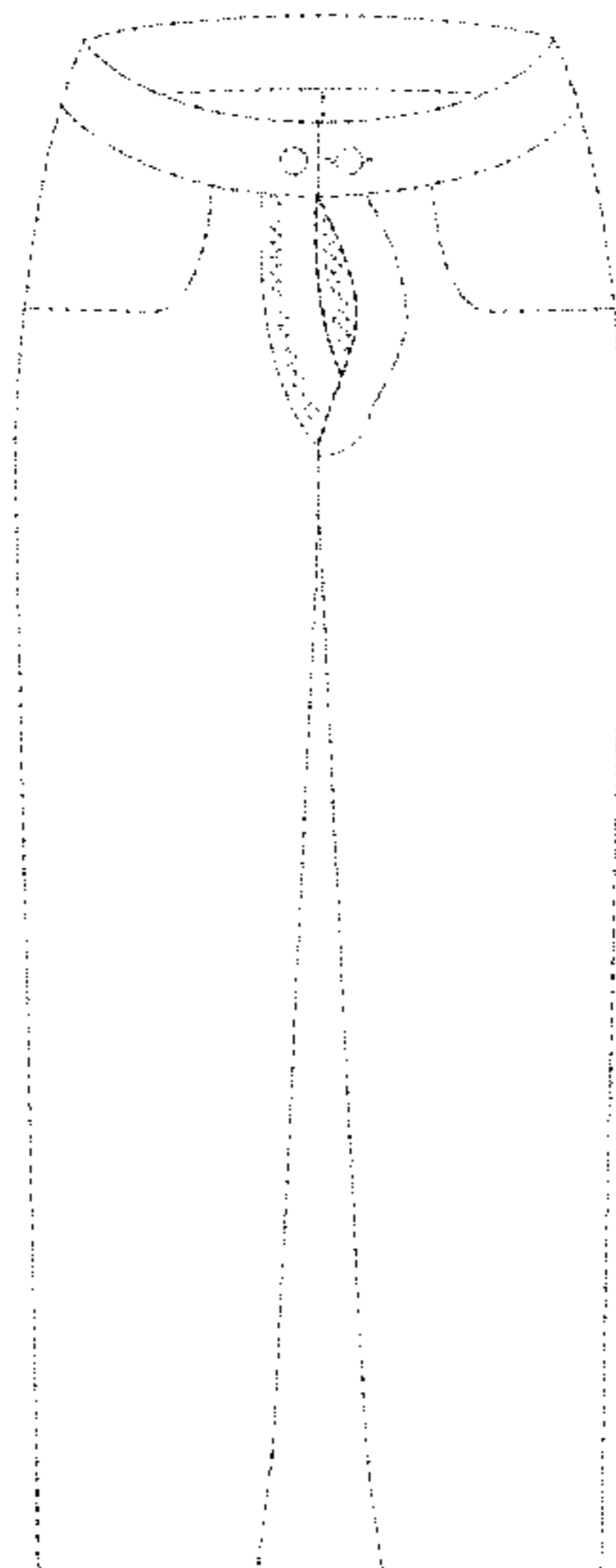
(57) **CLAIM**

The ornamental design for a mock garment closure, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a mock garment closure showing our new design;
 FIG. 2 is a right side elevational view thereof;

 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a front elevational view of the design in a position with a button opened;

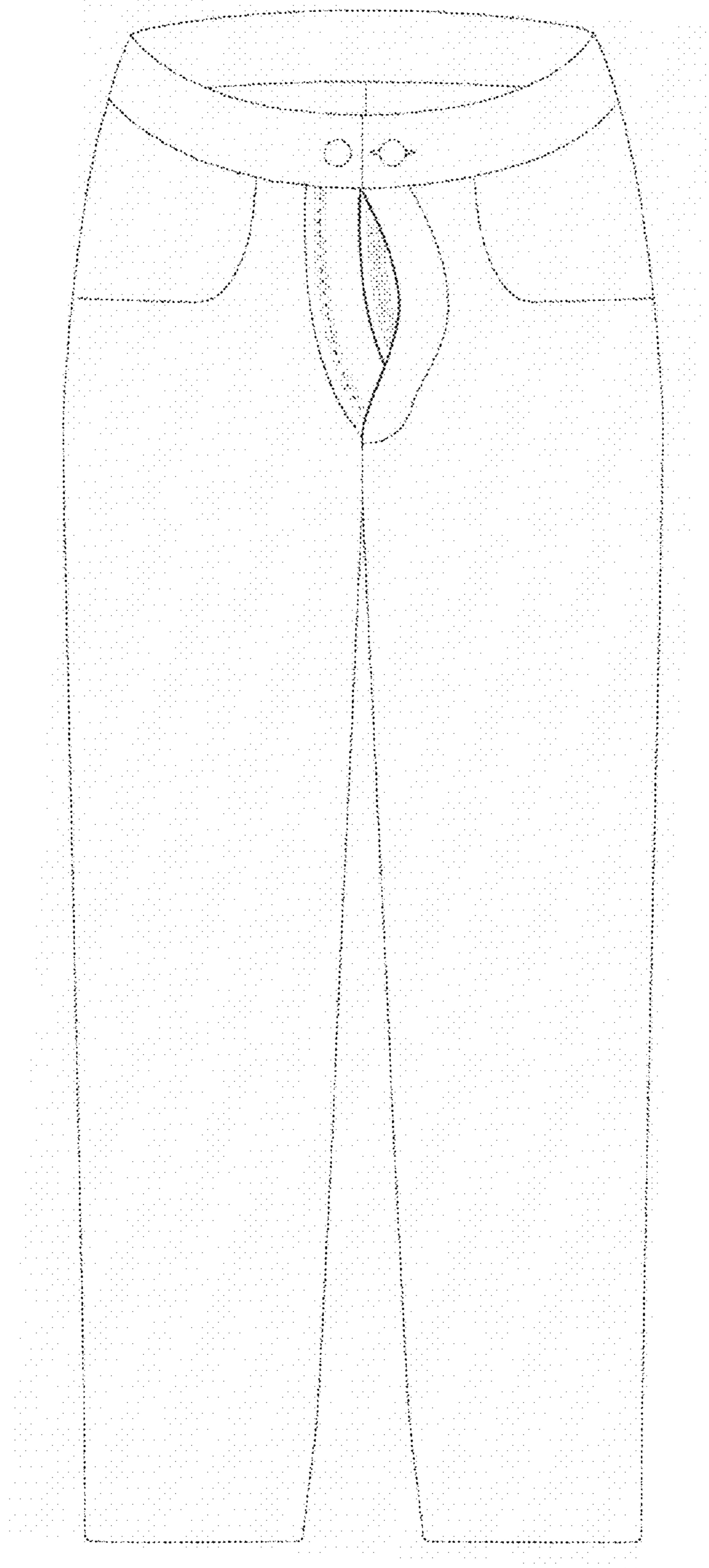

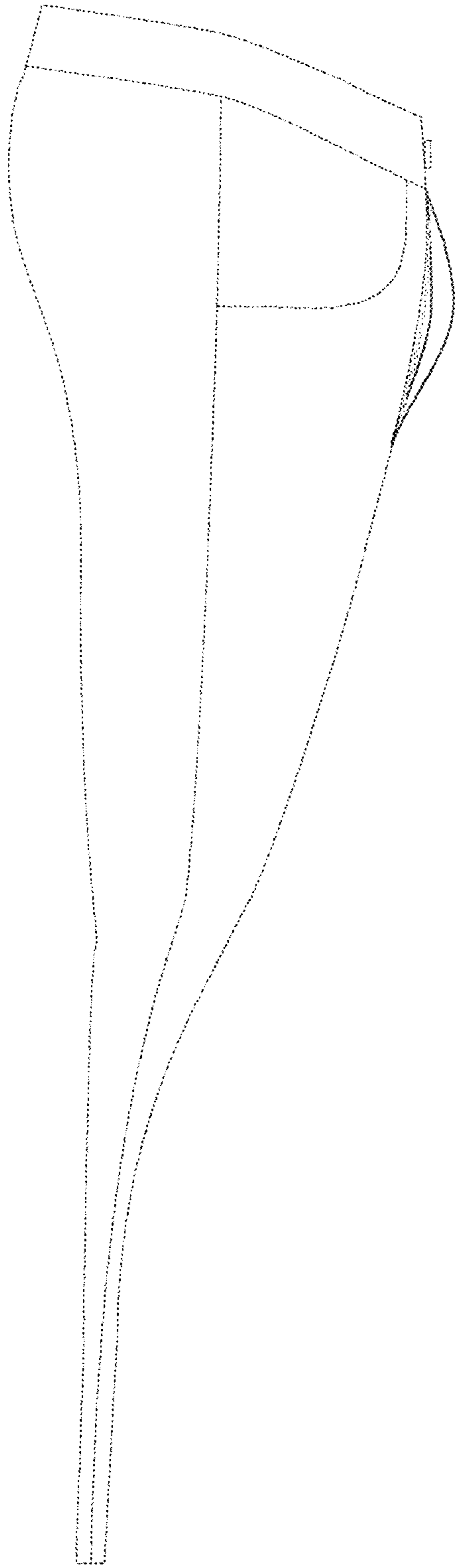

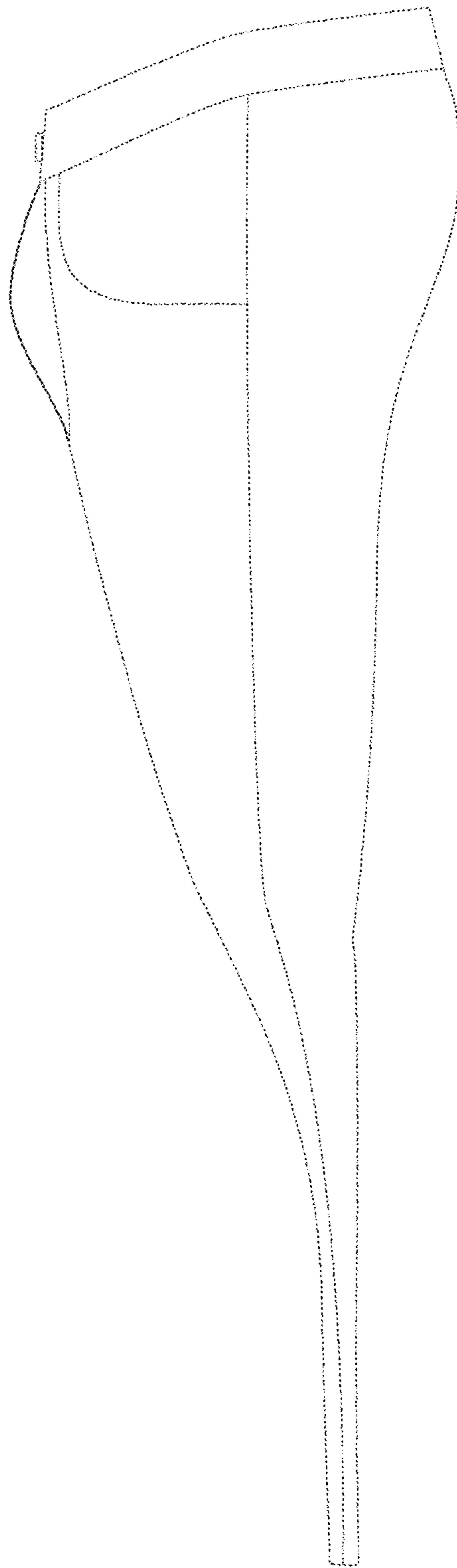

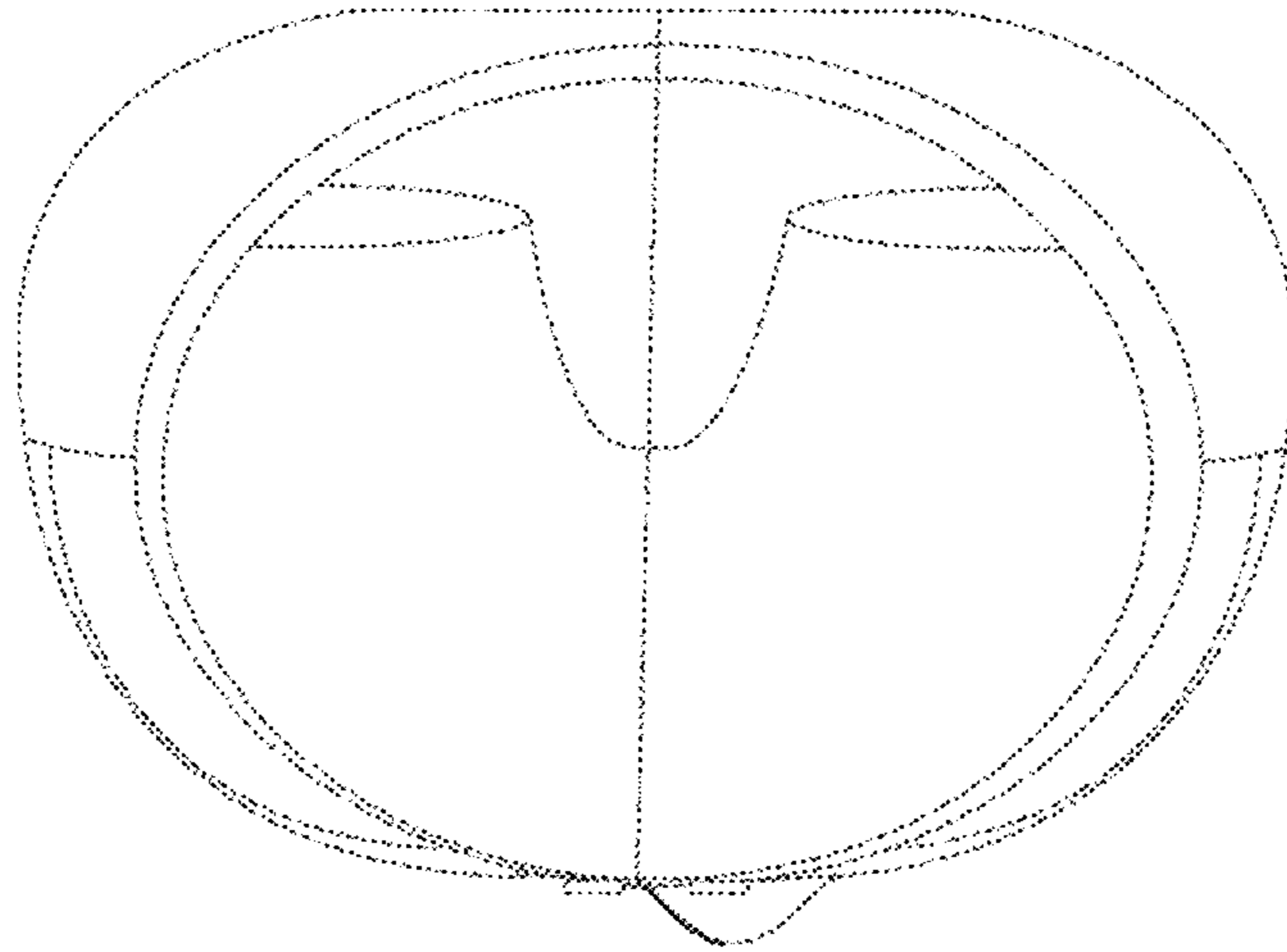

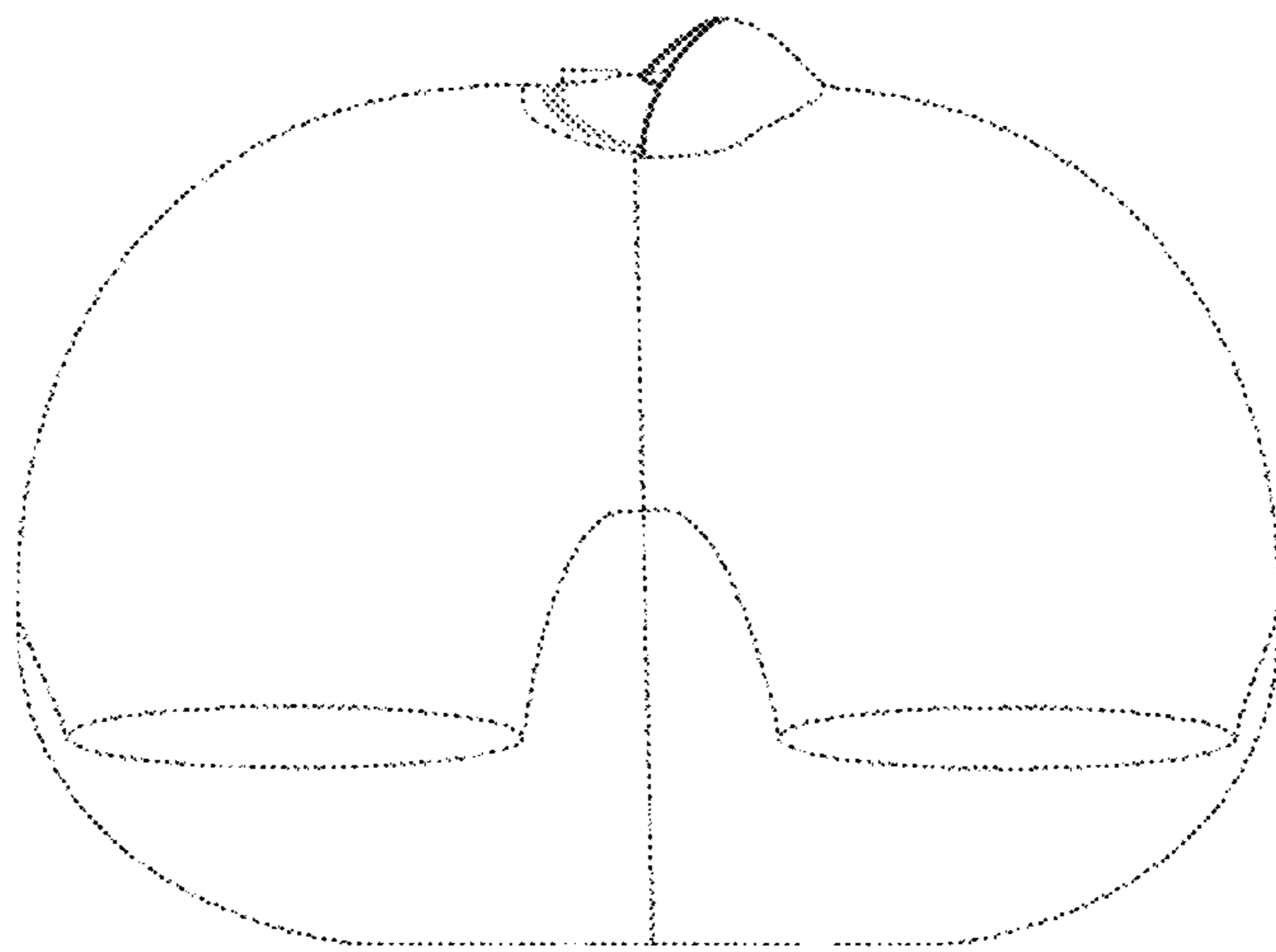

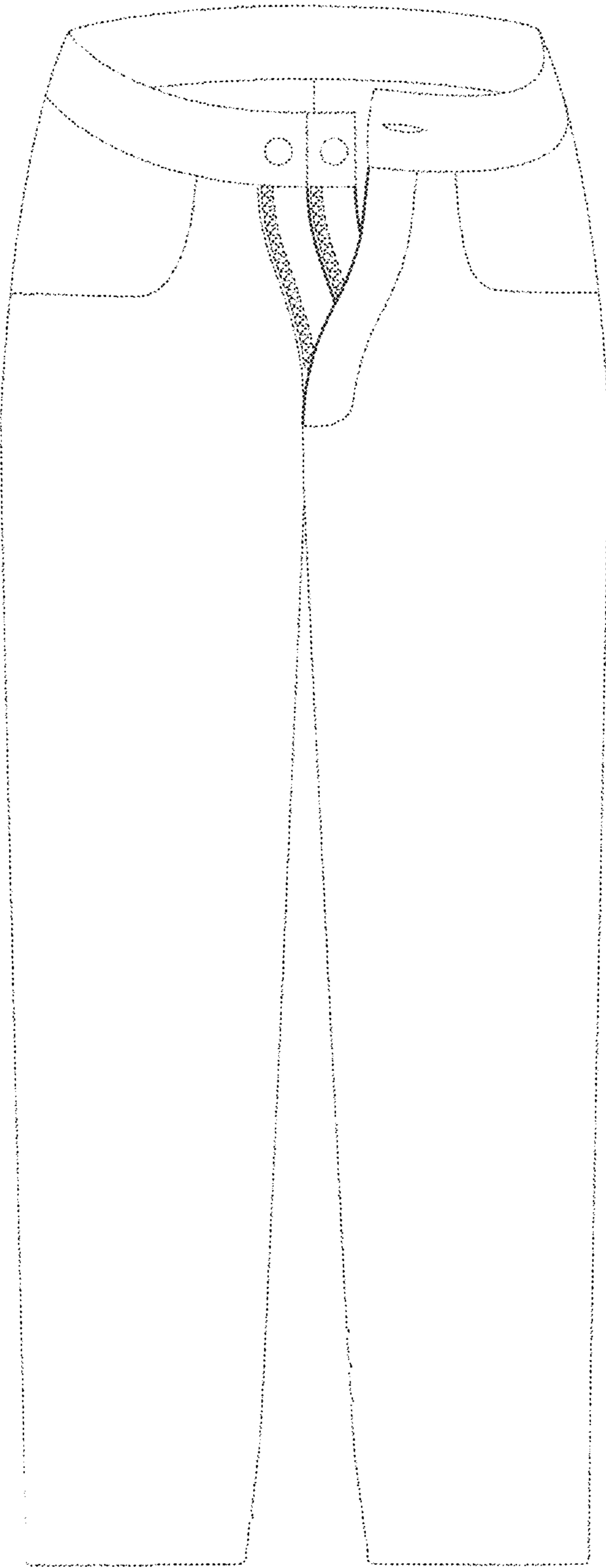

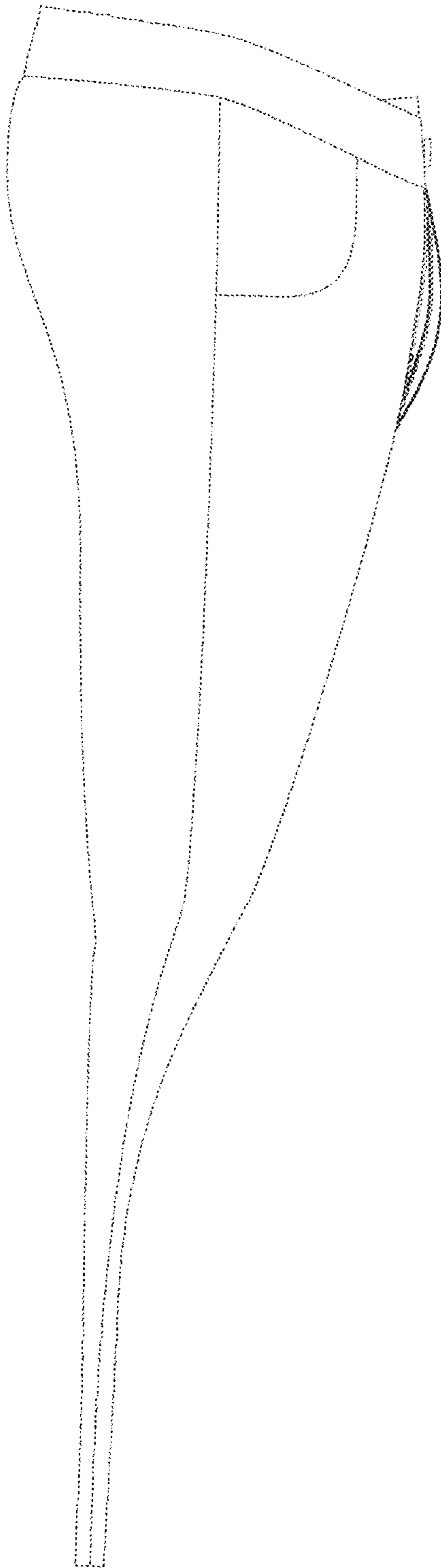

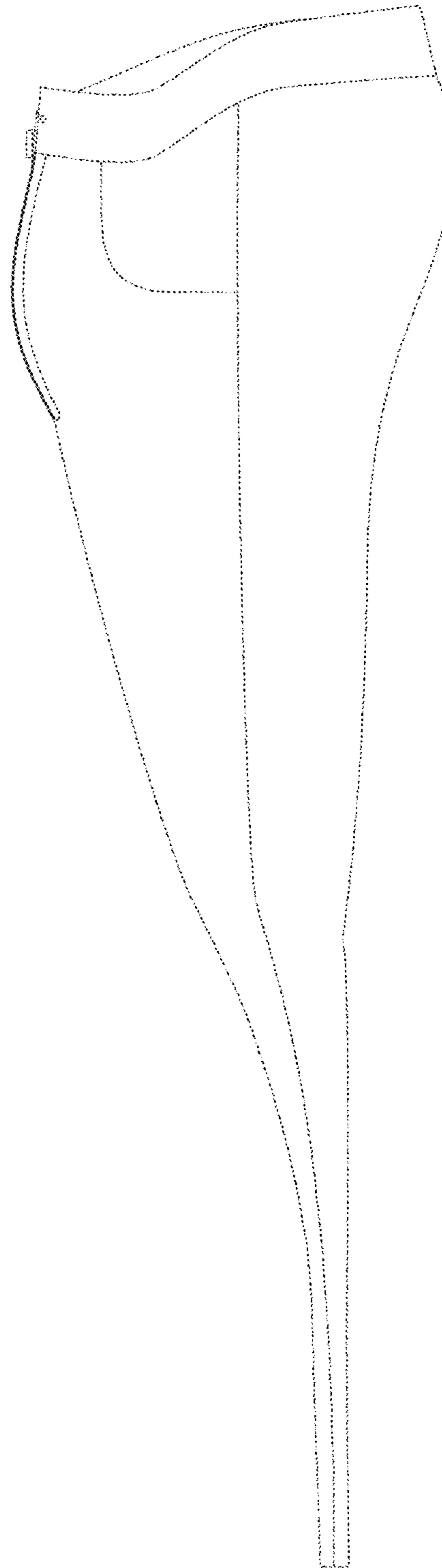

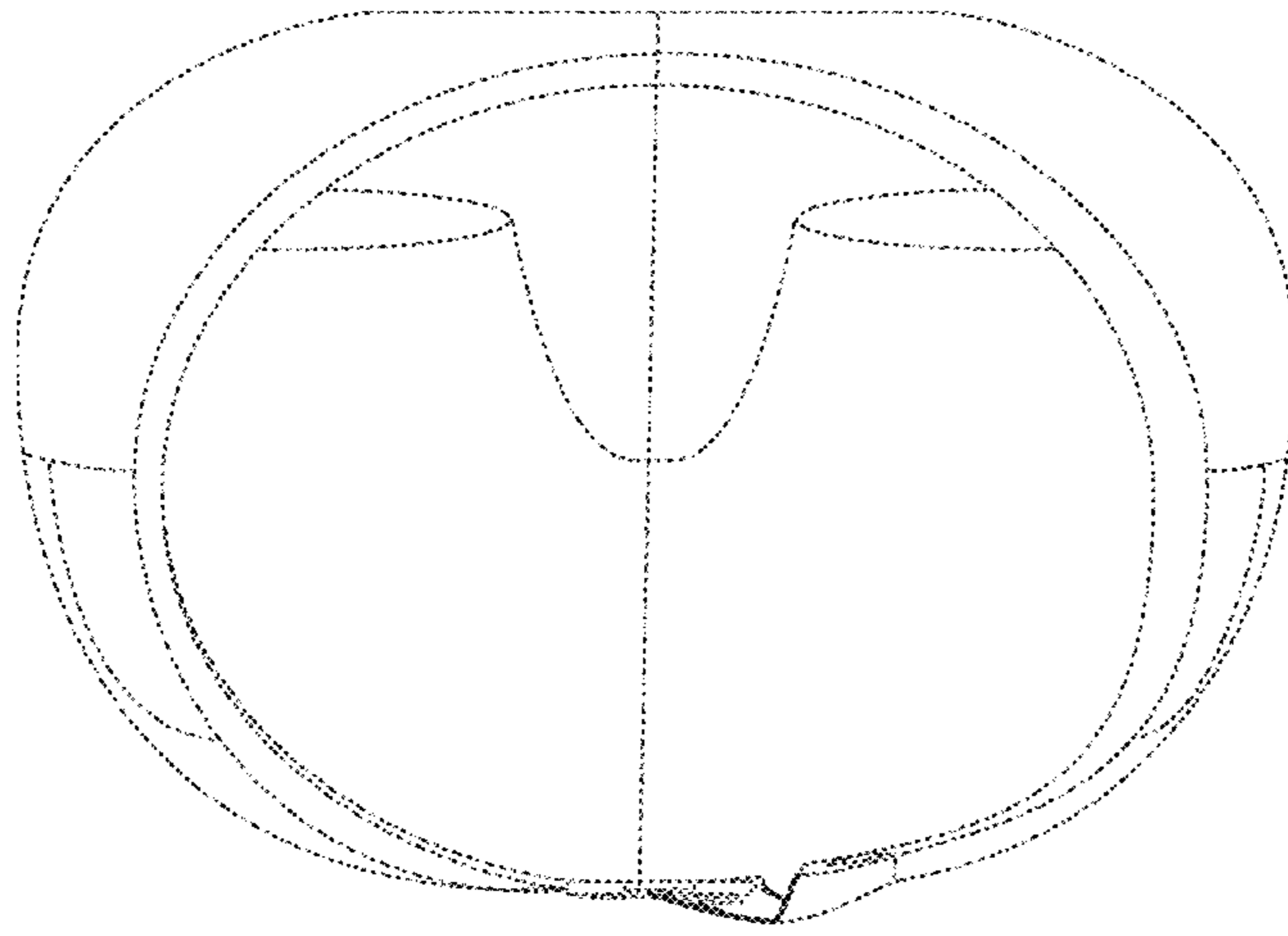

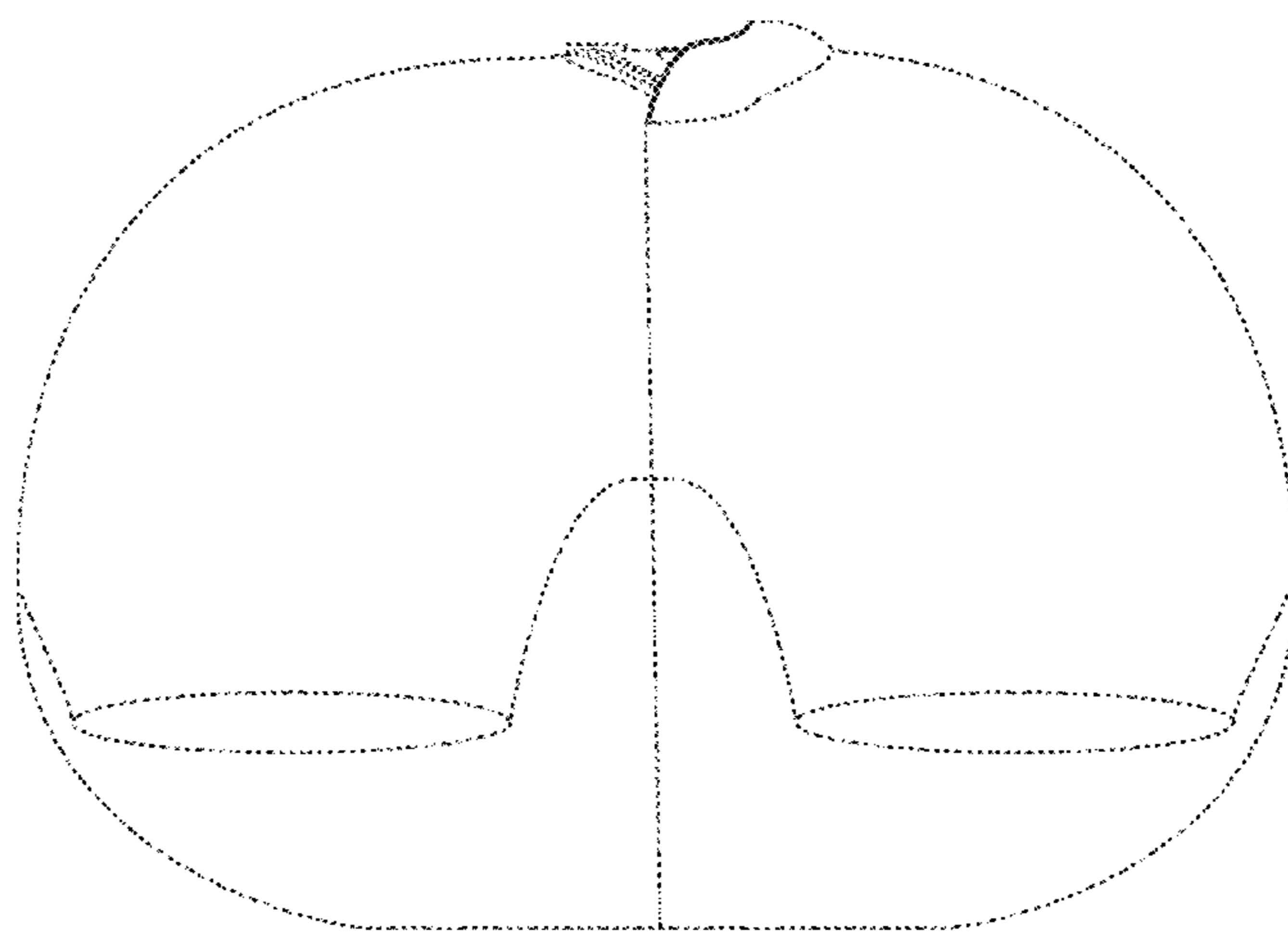

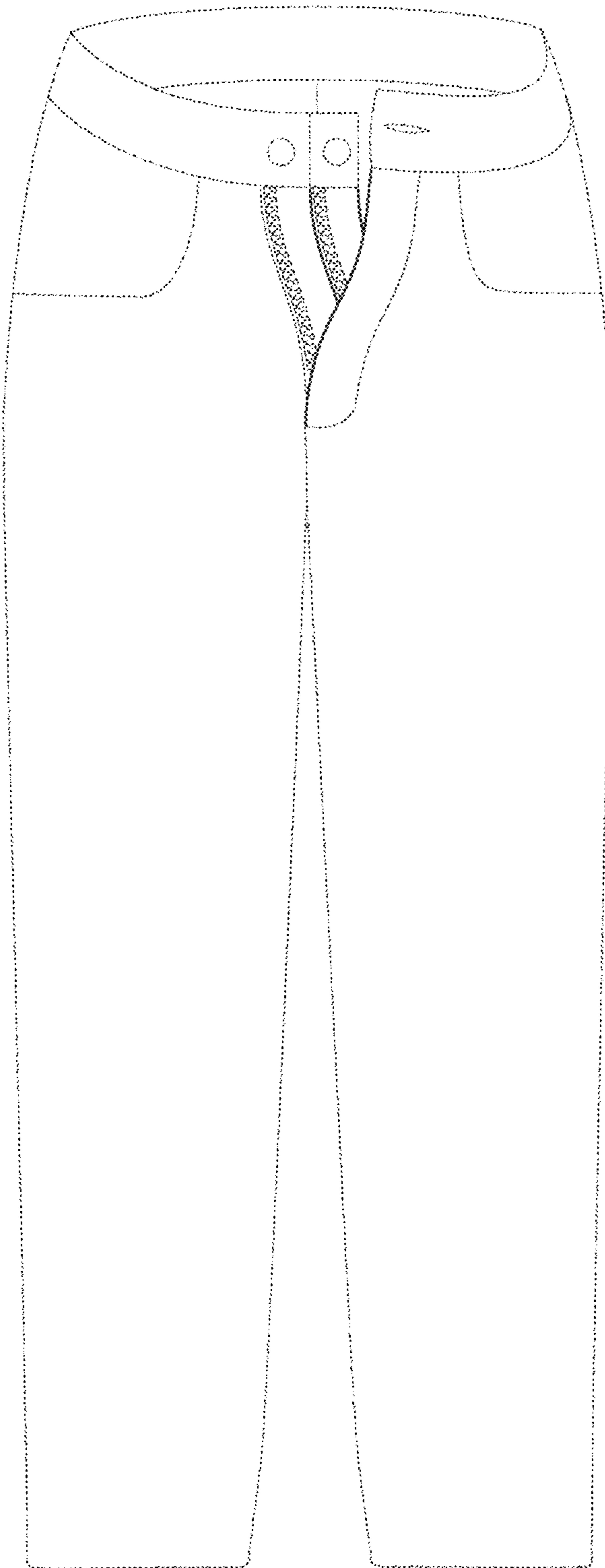

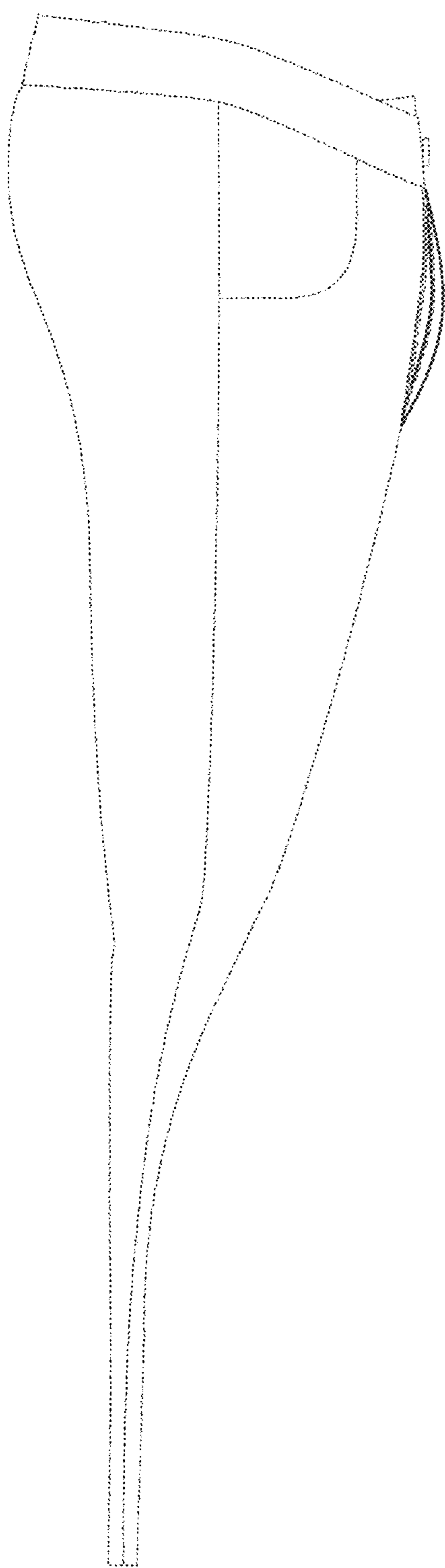

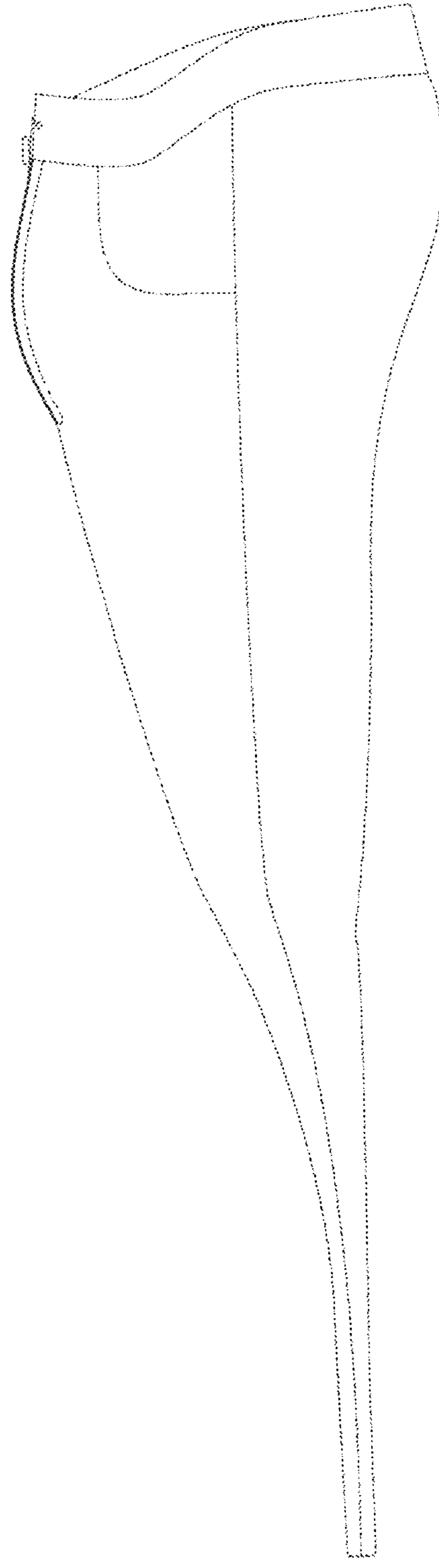

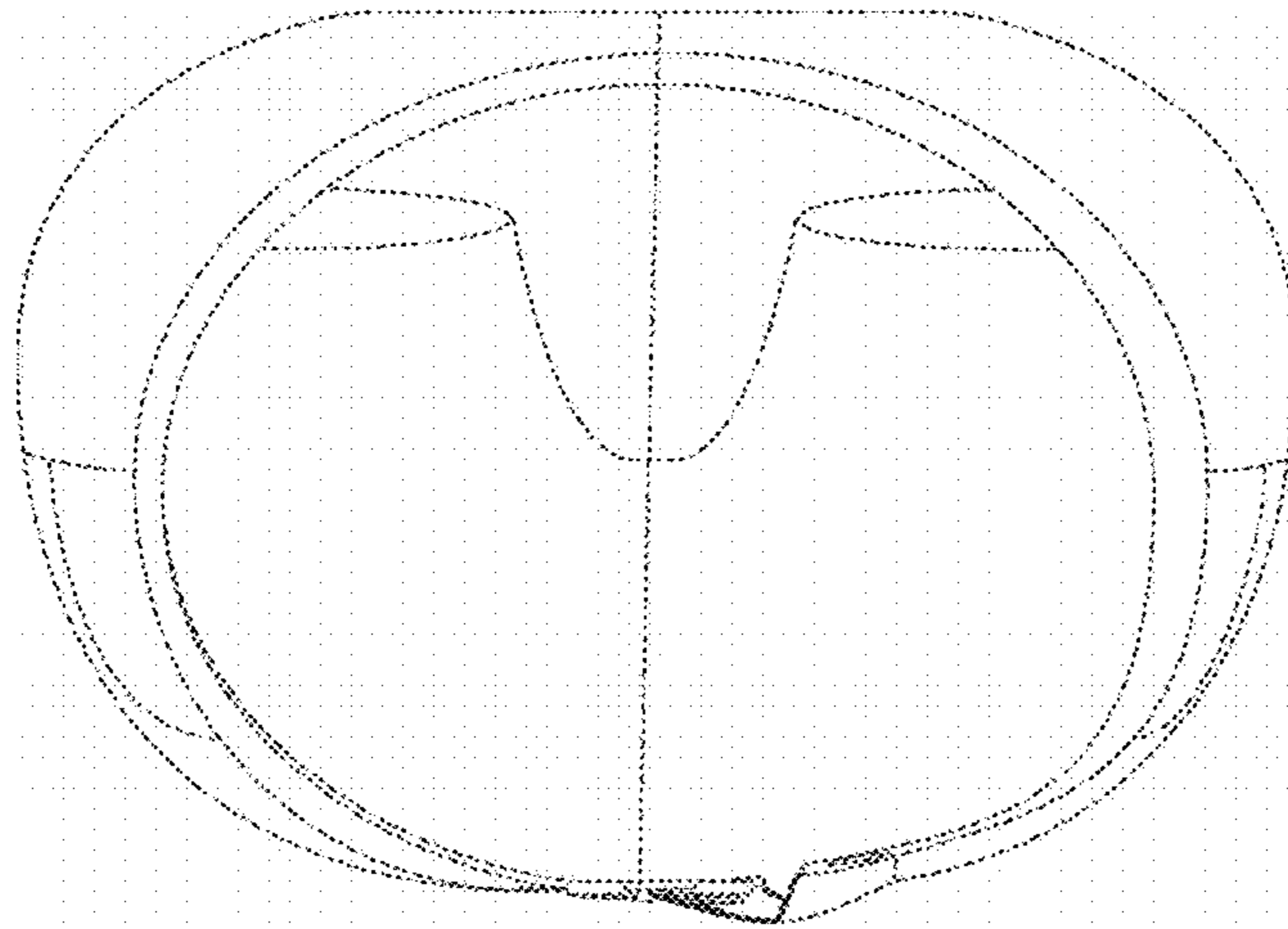

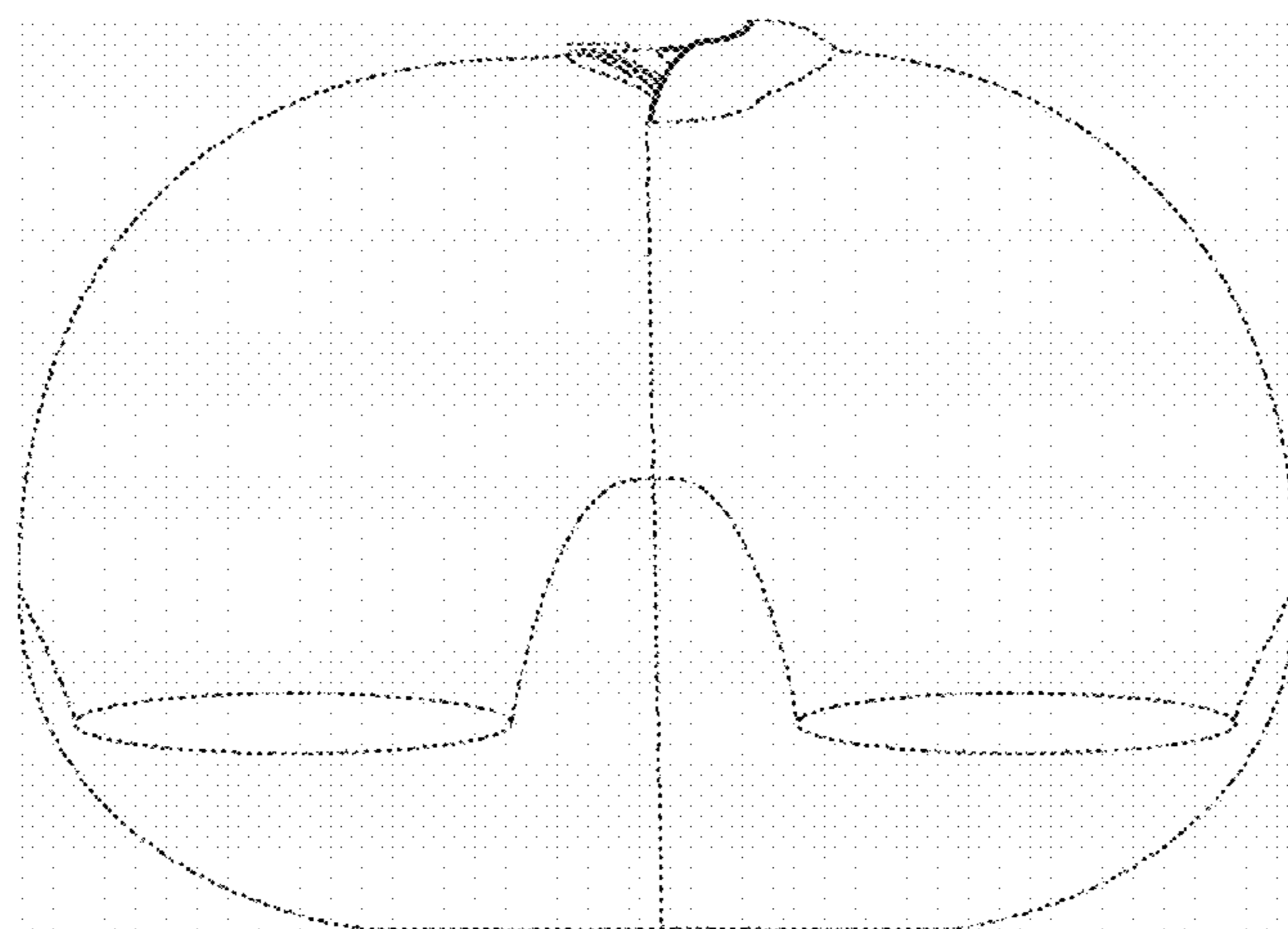

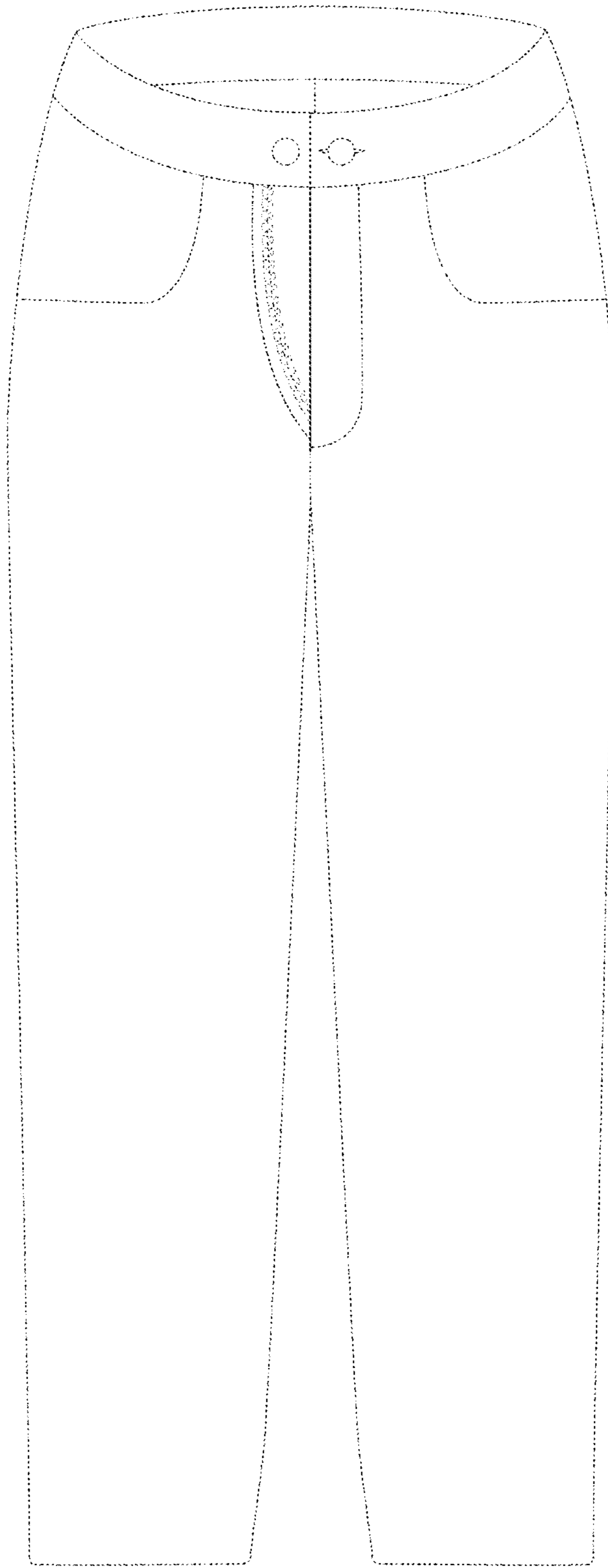

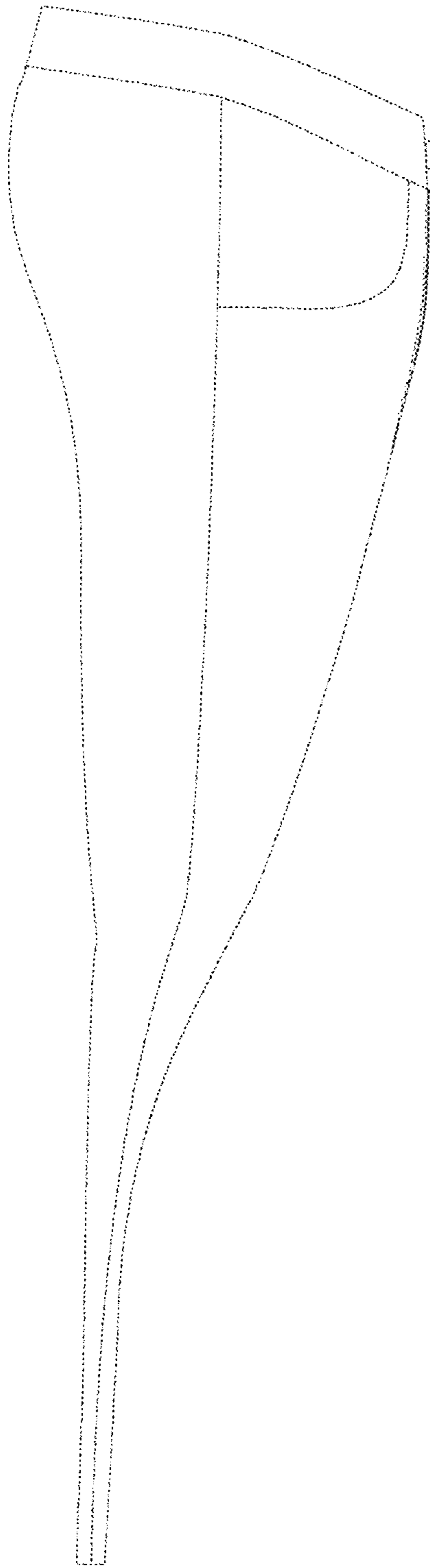

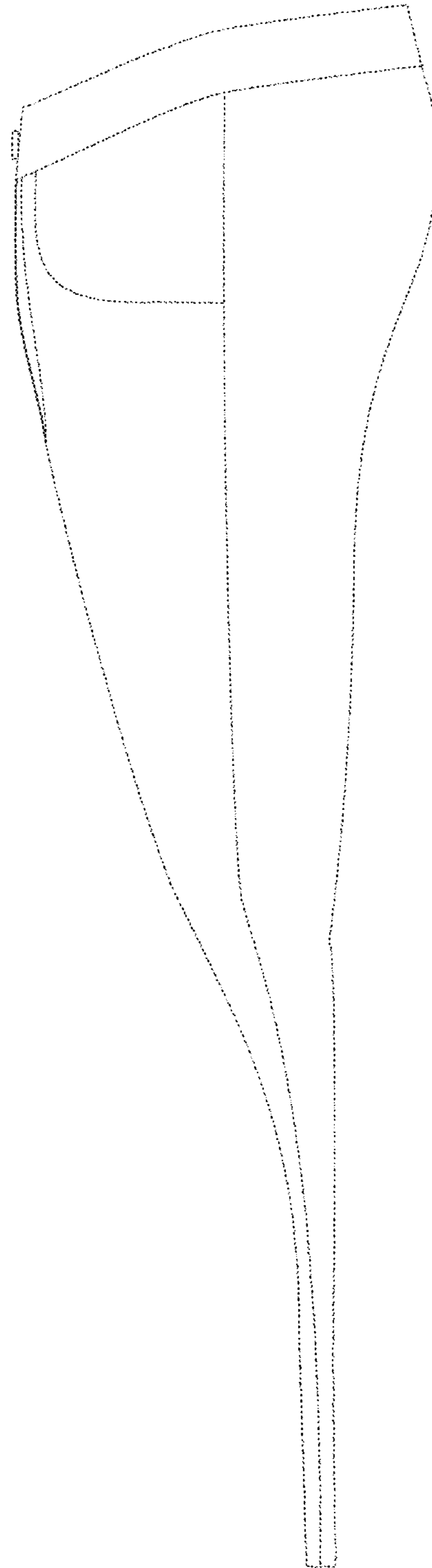

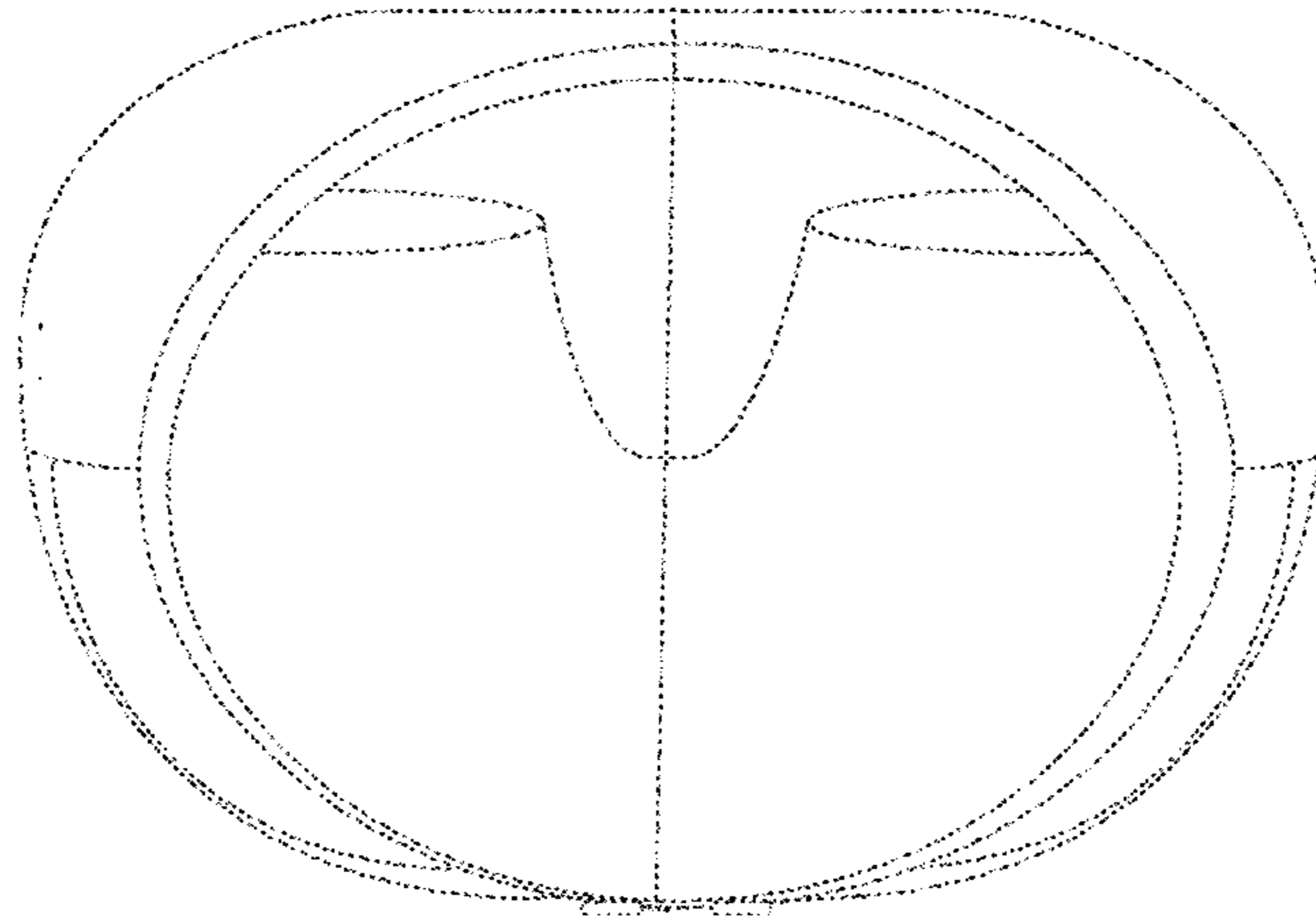

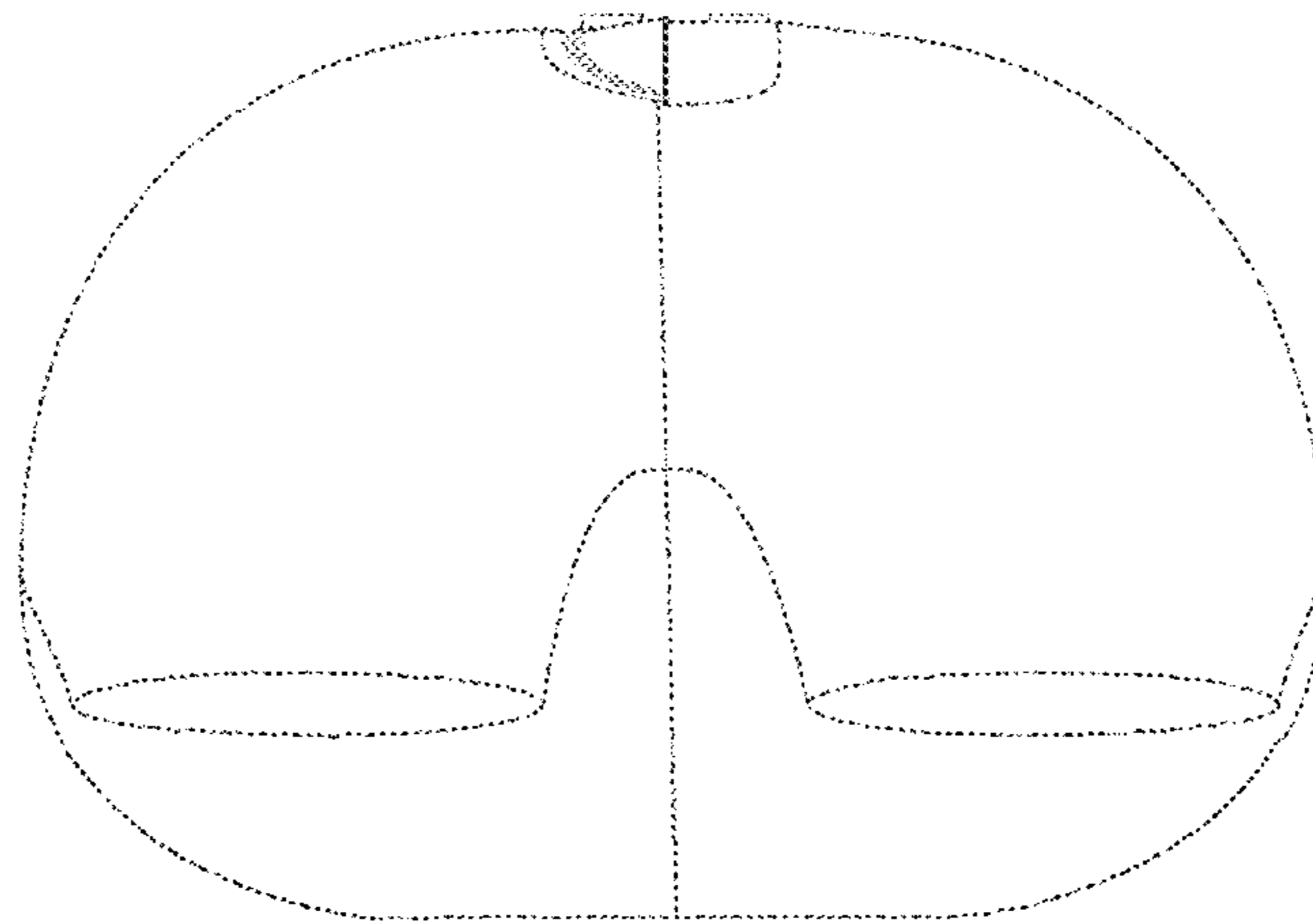
