(57) **CLAIM**

The ornamental design for a storage container and portion of a rack, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a first embodiment of a storage container and portion of a rack;
FIG. 2 is a front elevational view of the storage container and portion of a rack of FIG. 1;
FIG. 3 is a top plan view of the storage container and portion of a rack of FIG. 1;

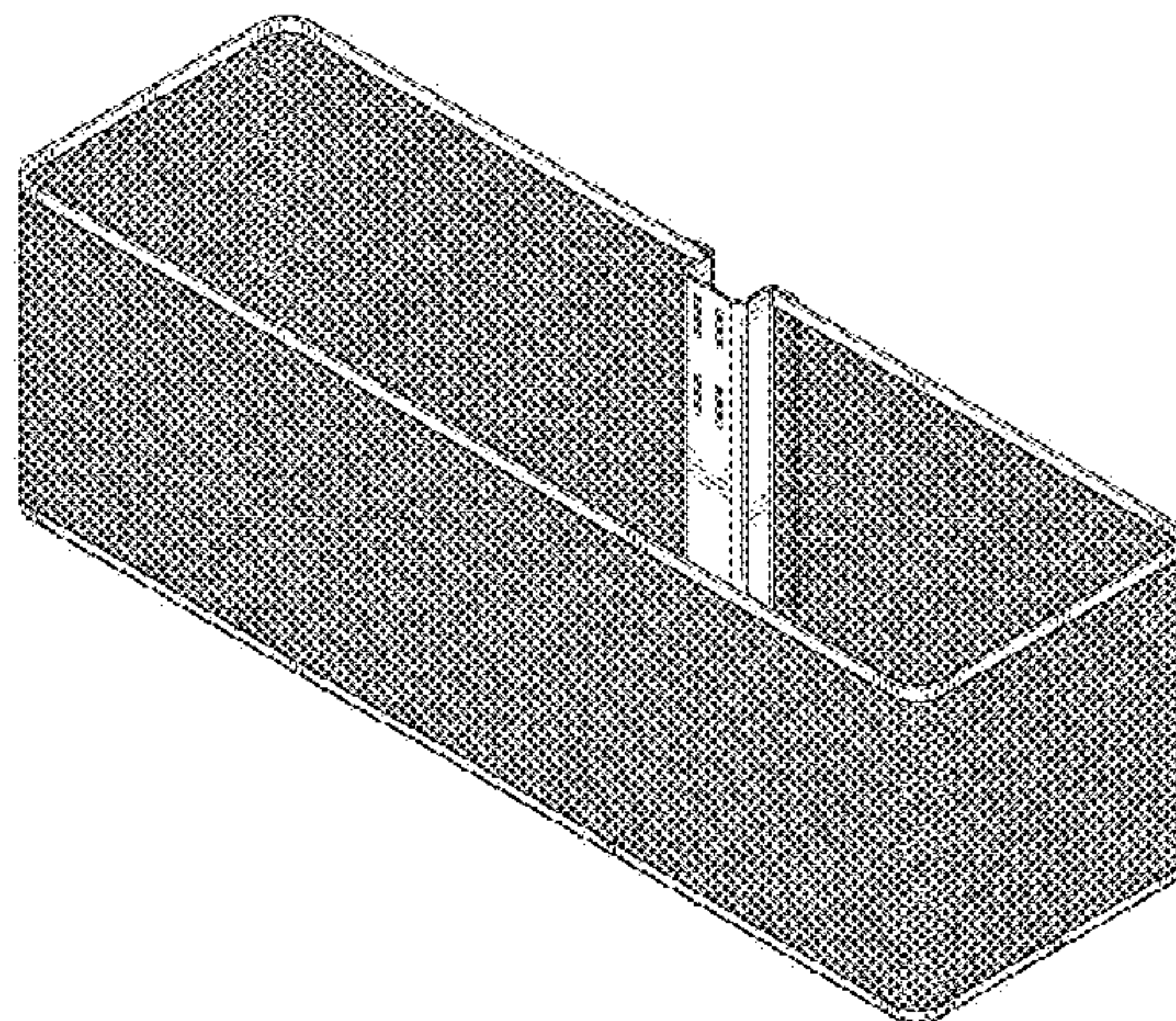

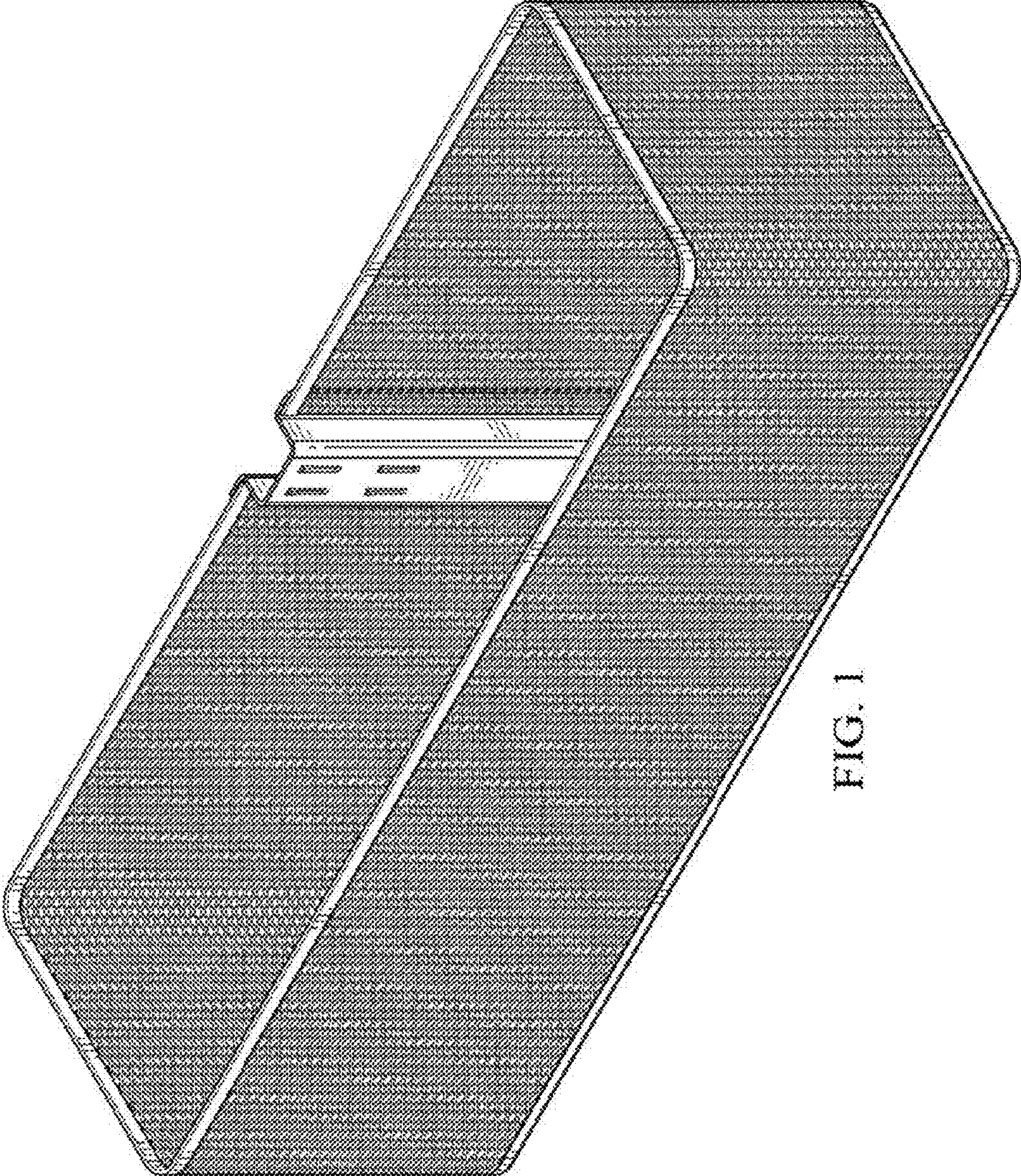

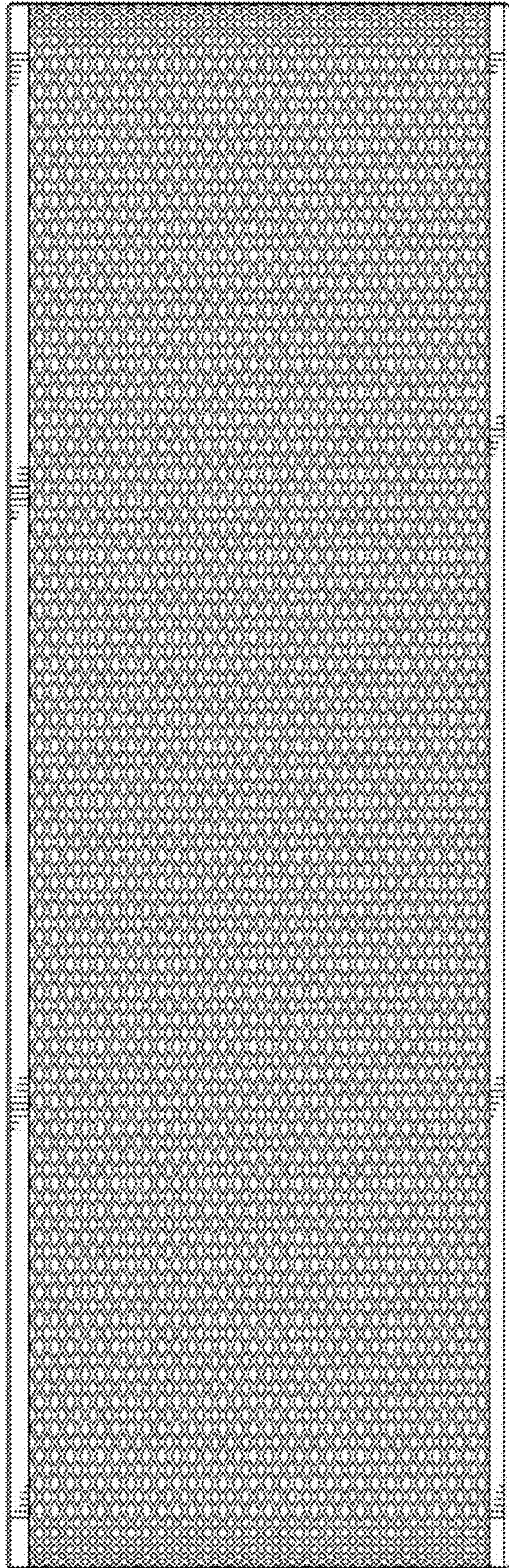

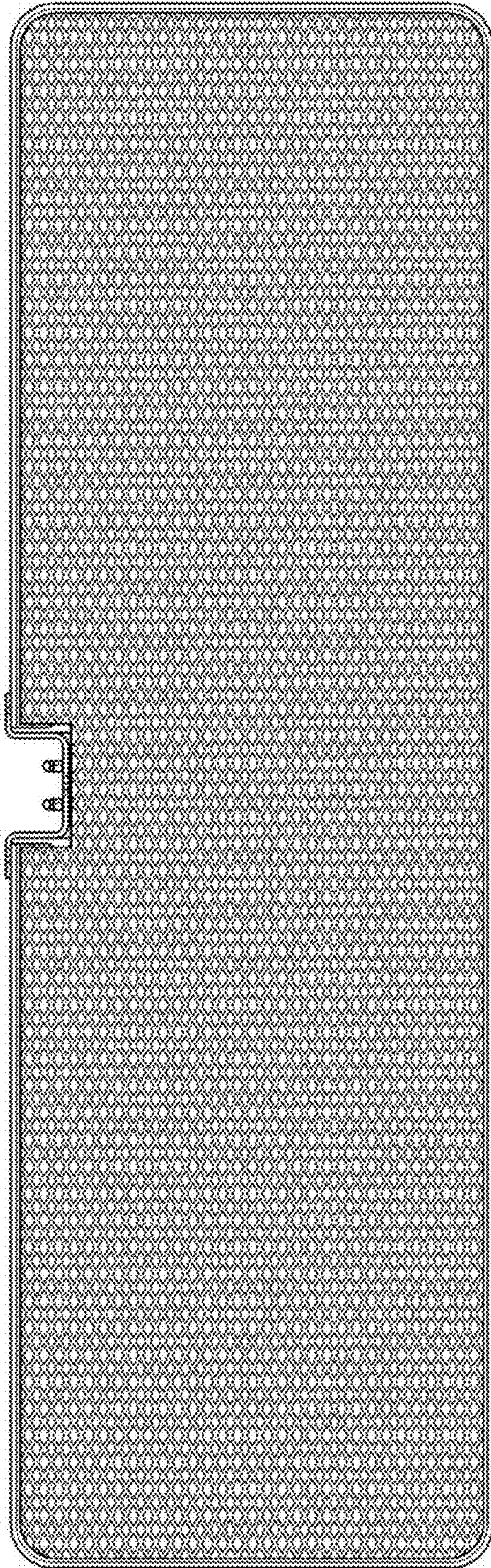

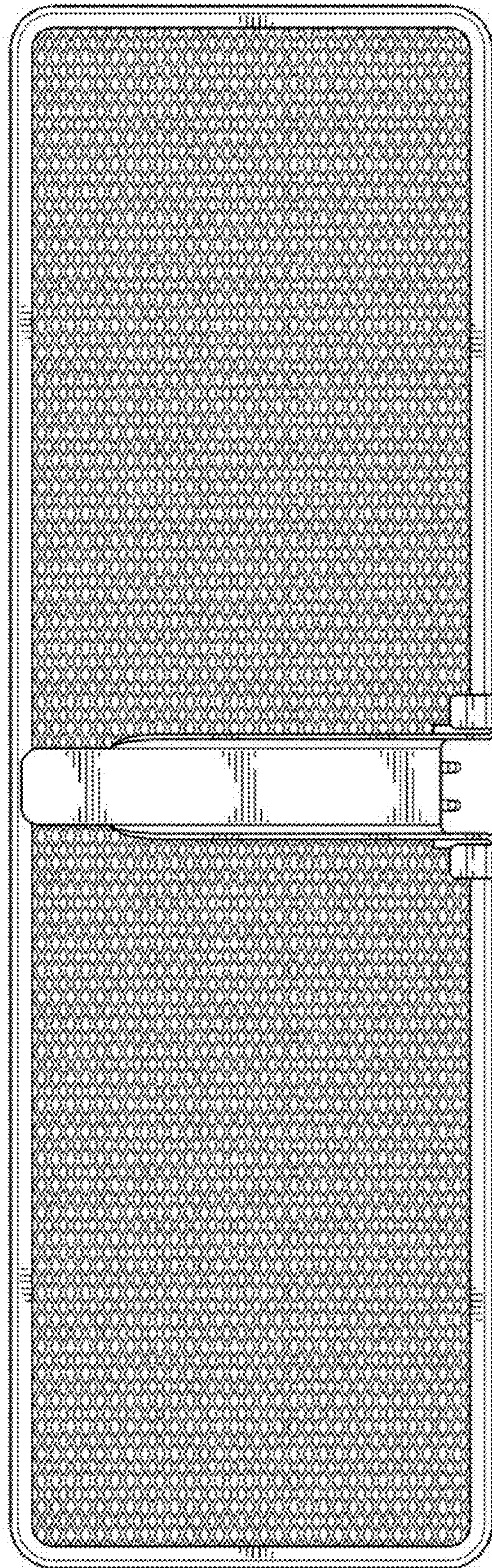

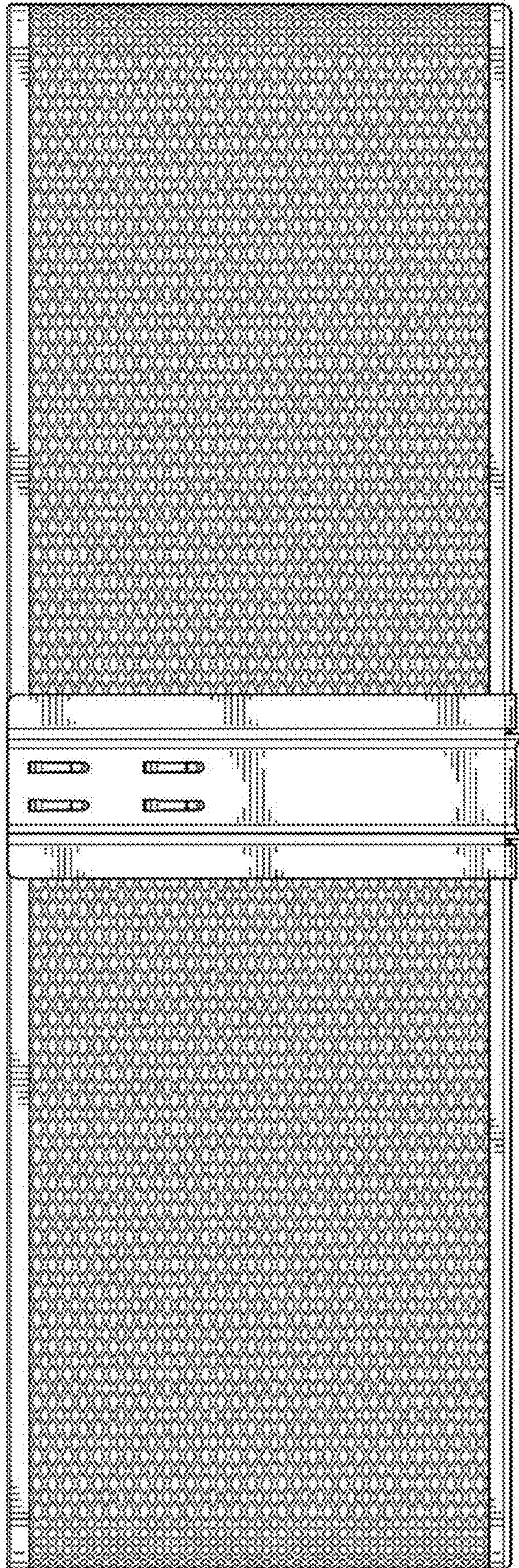

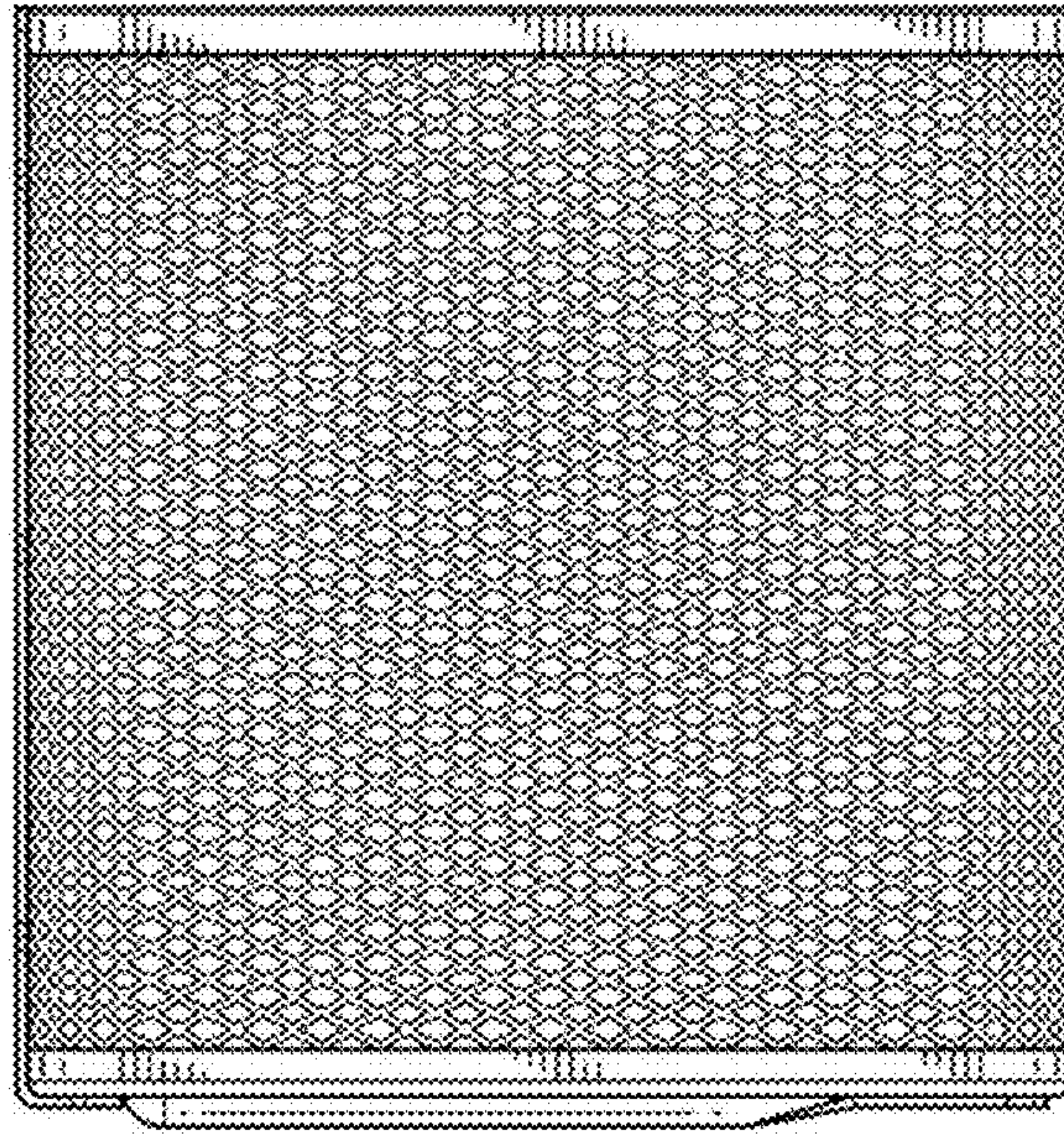

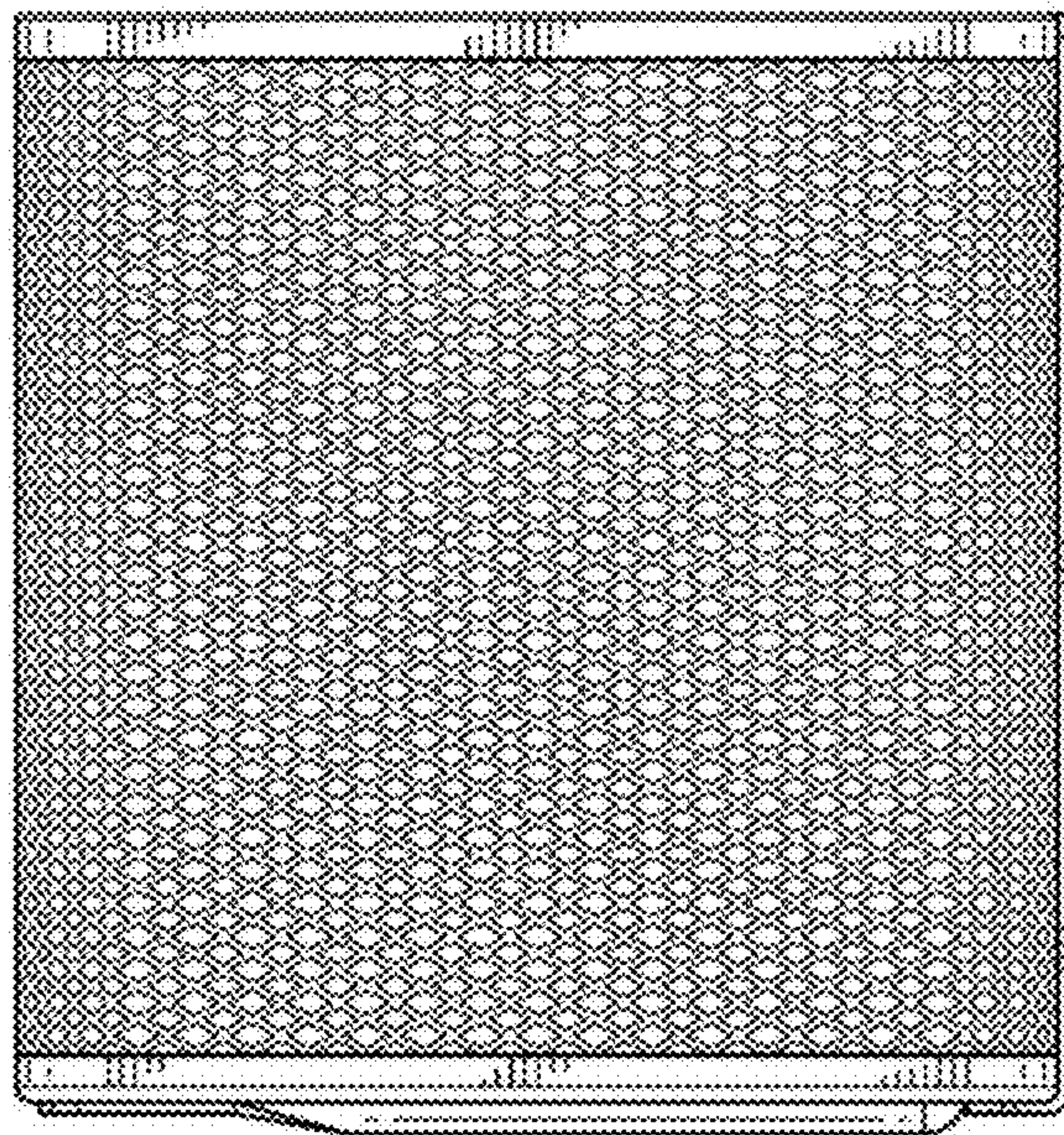

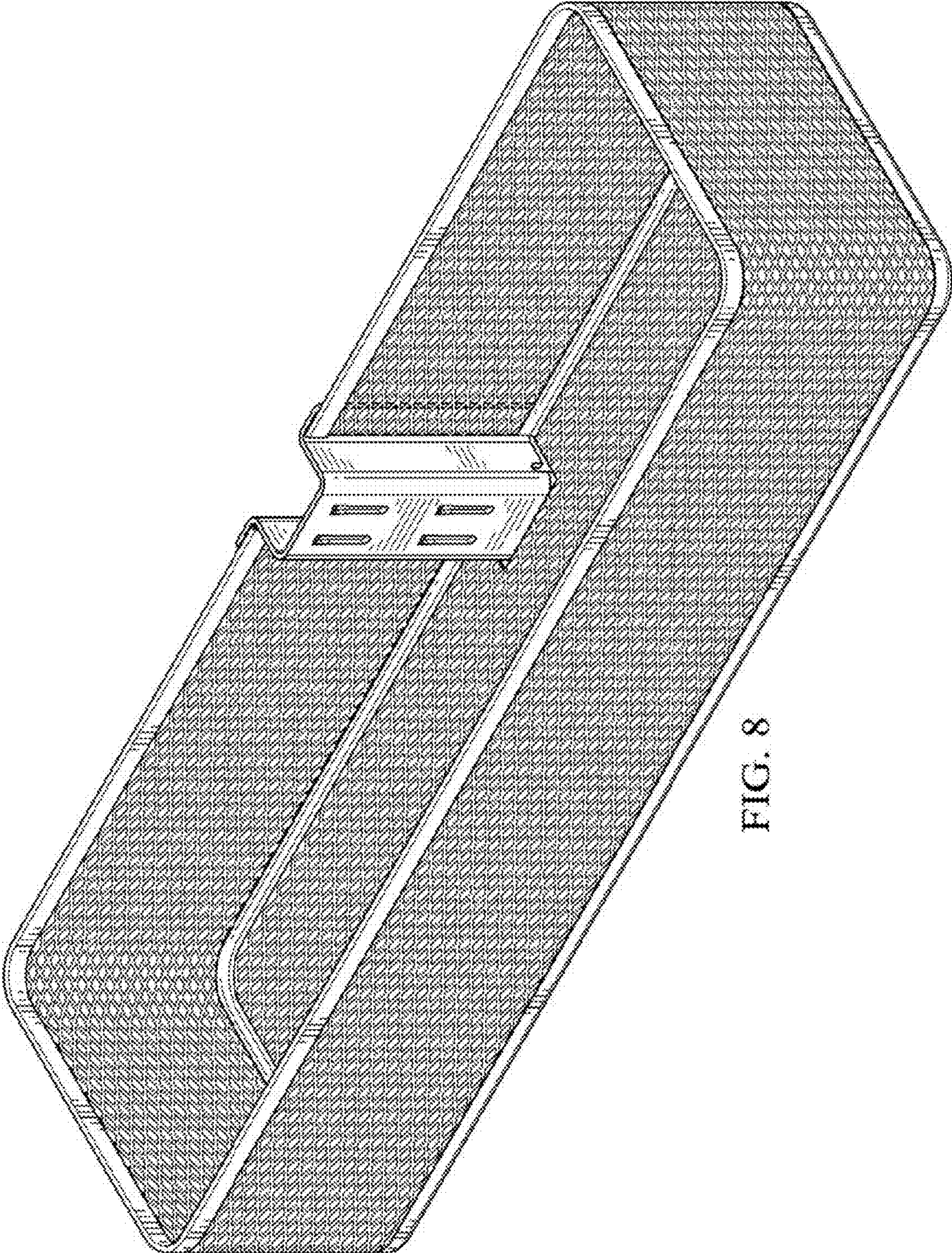

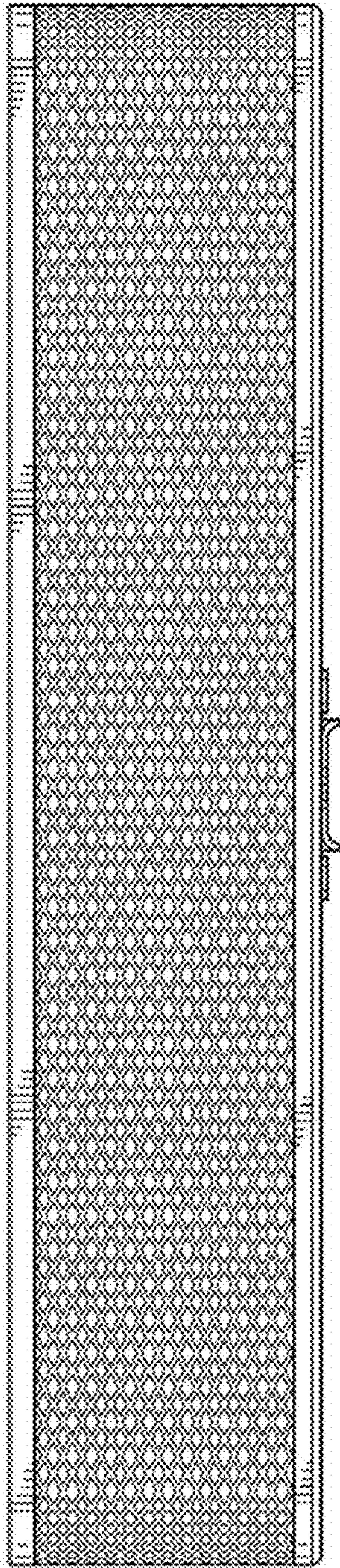

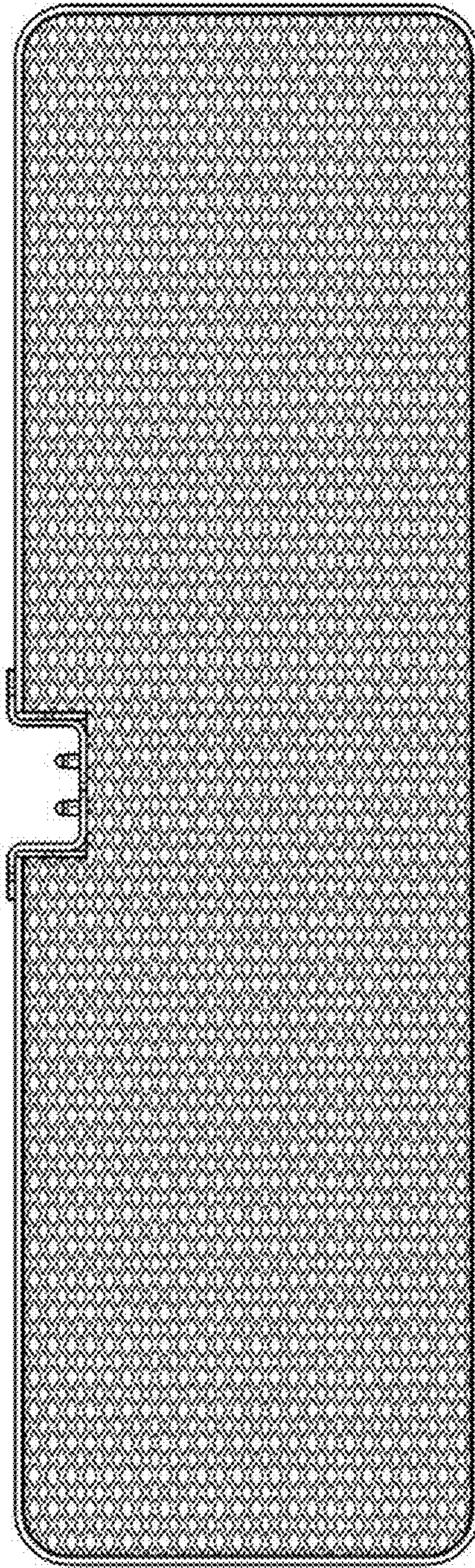

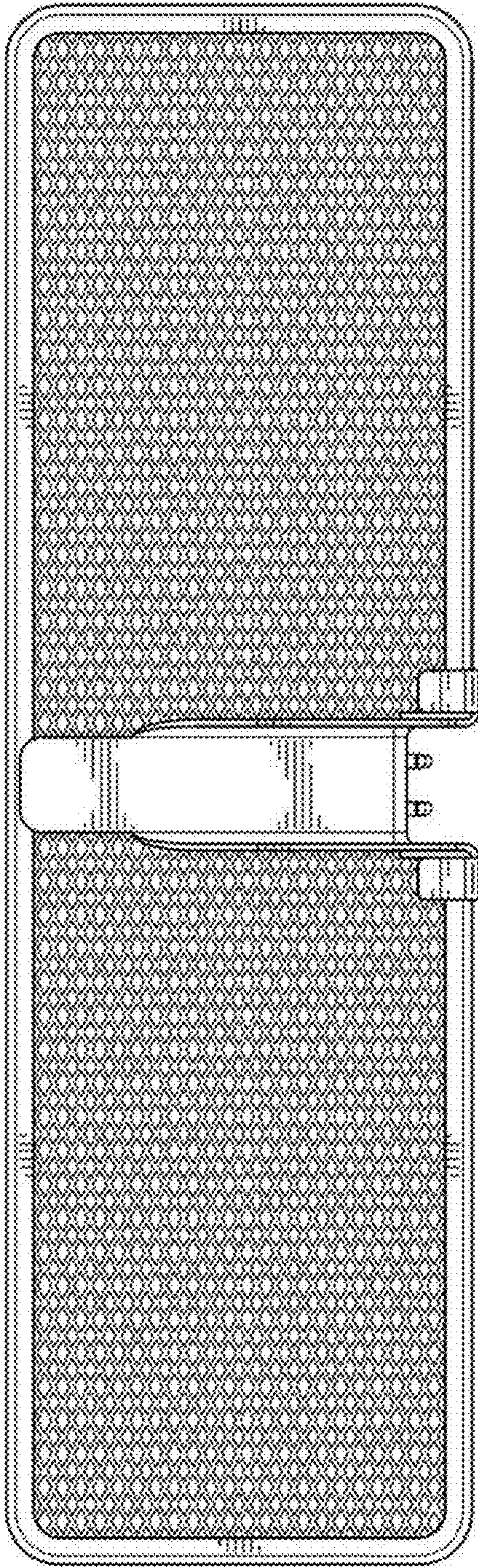

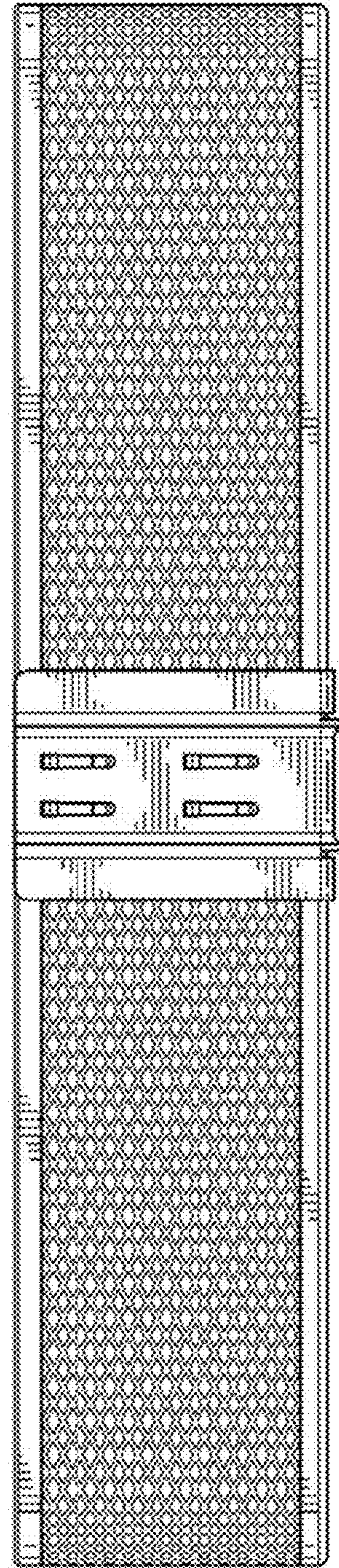

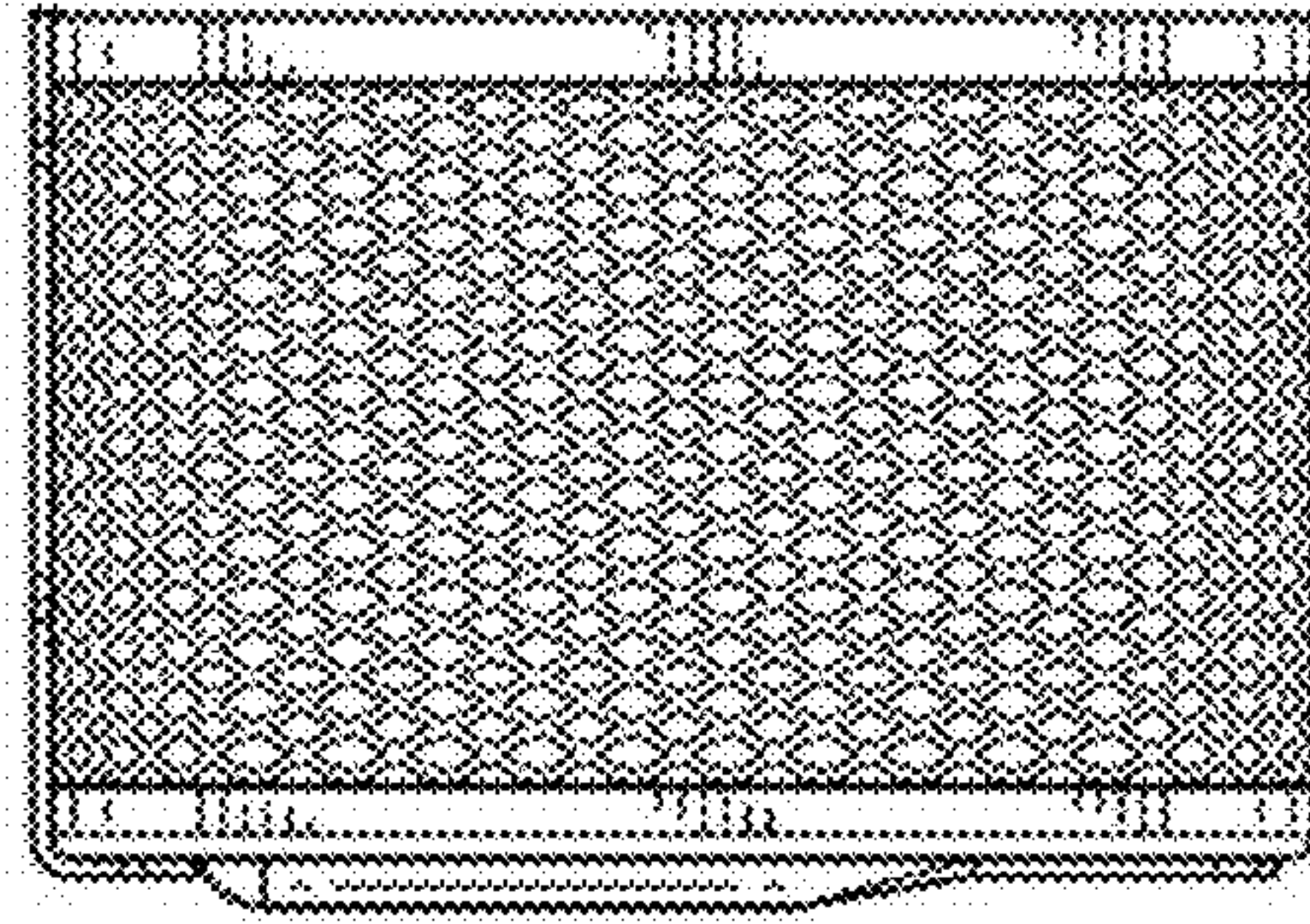

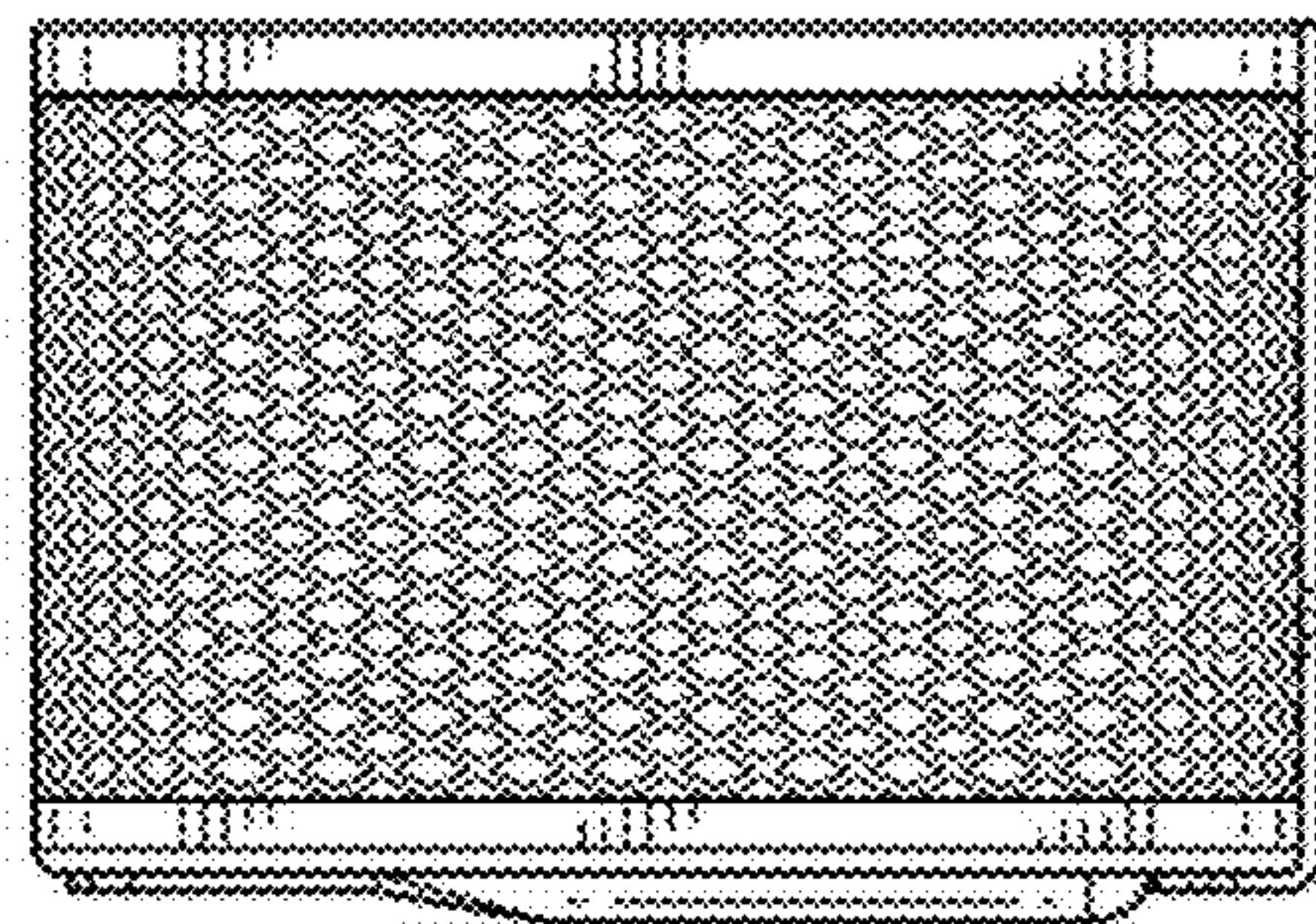

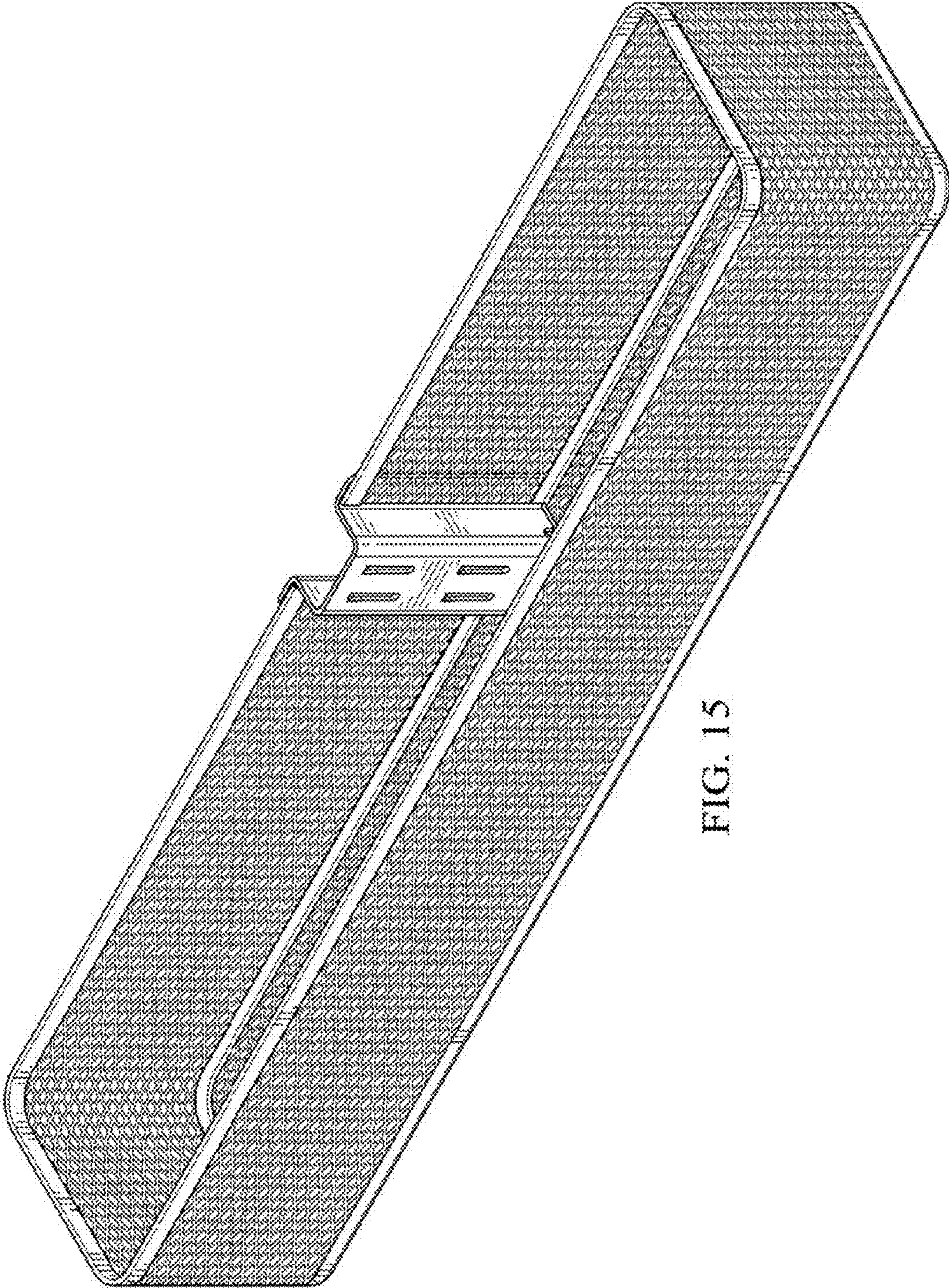

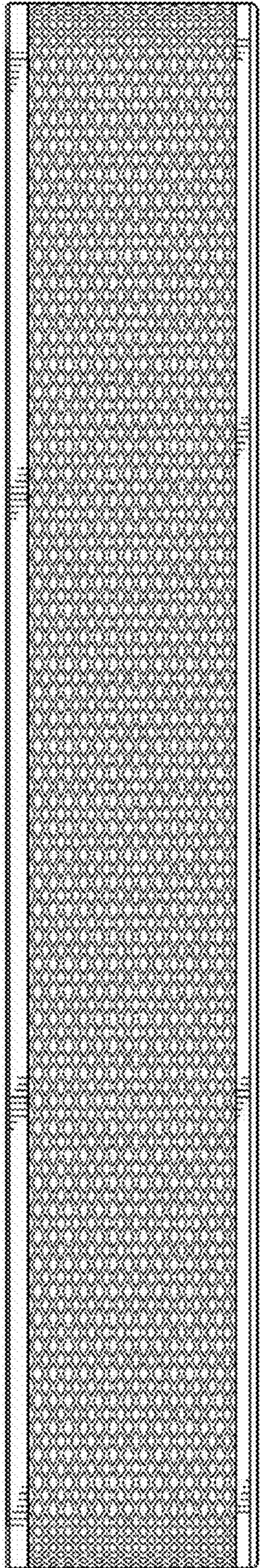

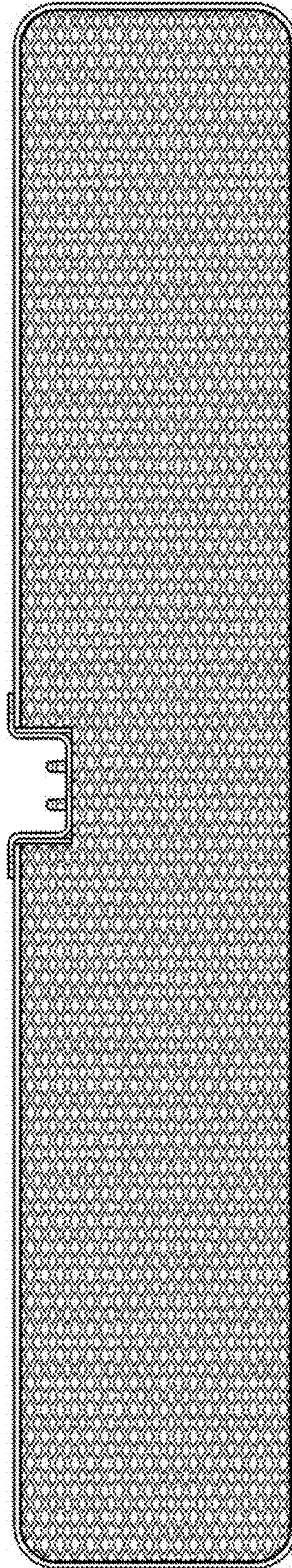

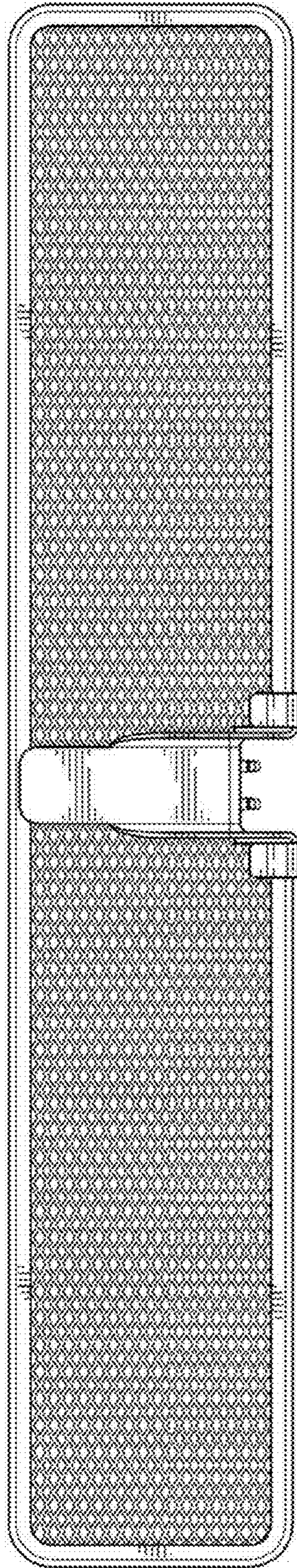

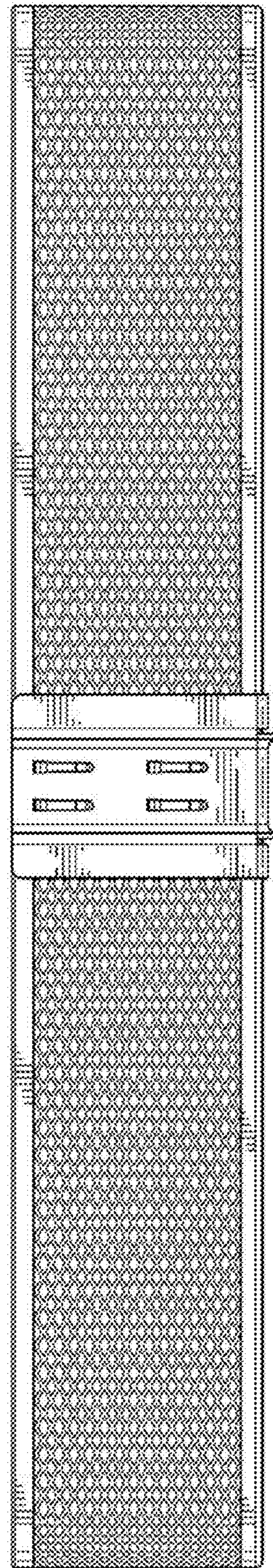

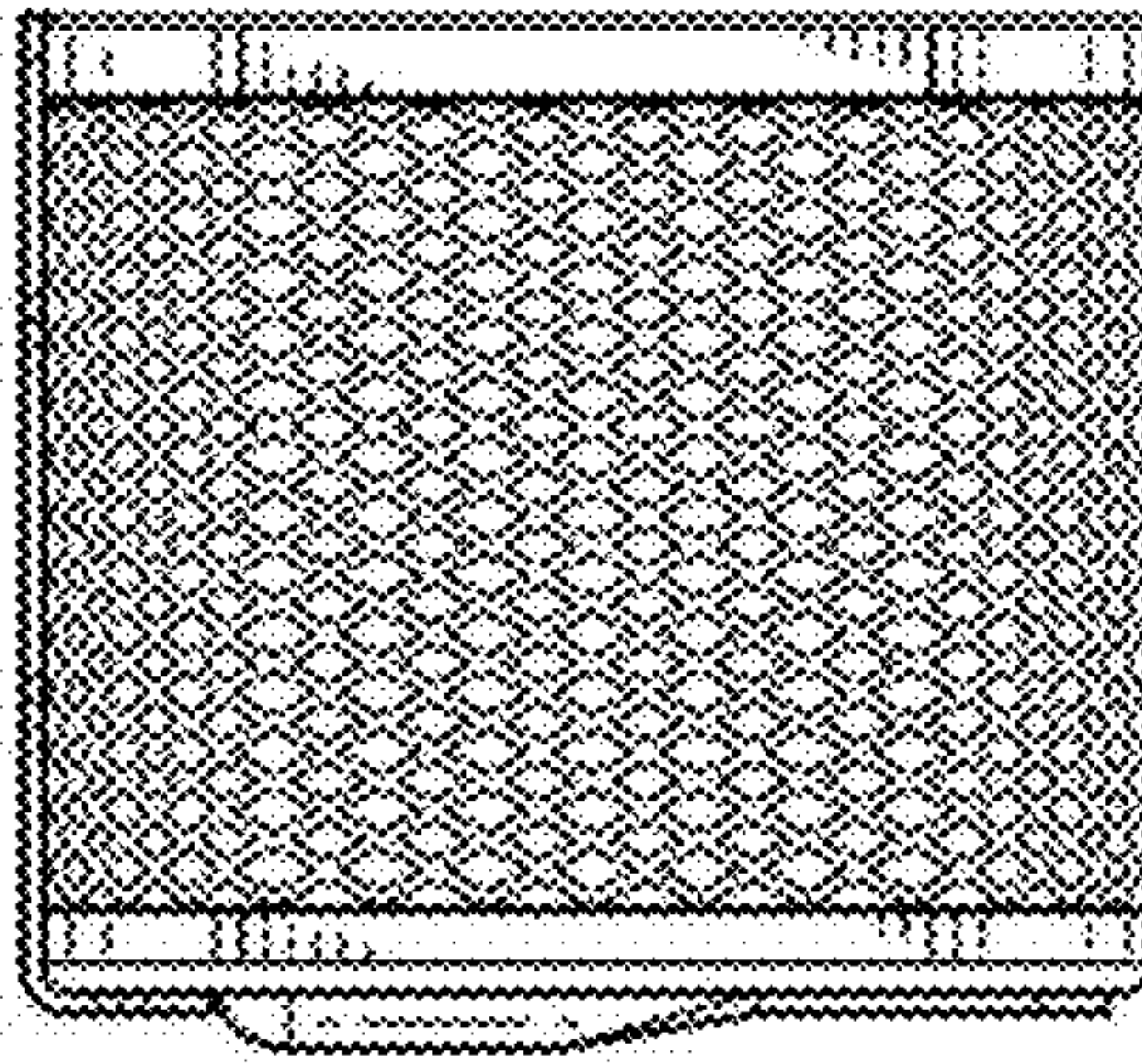

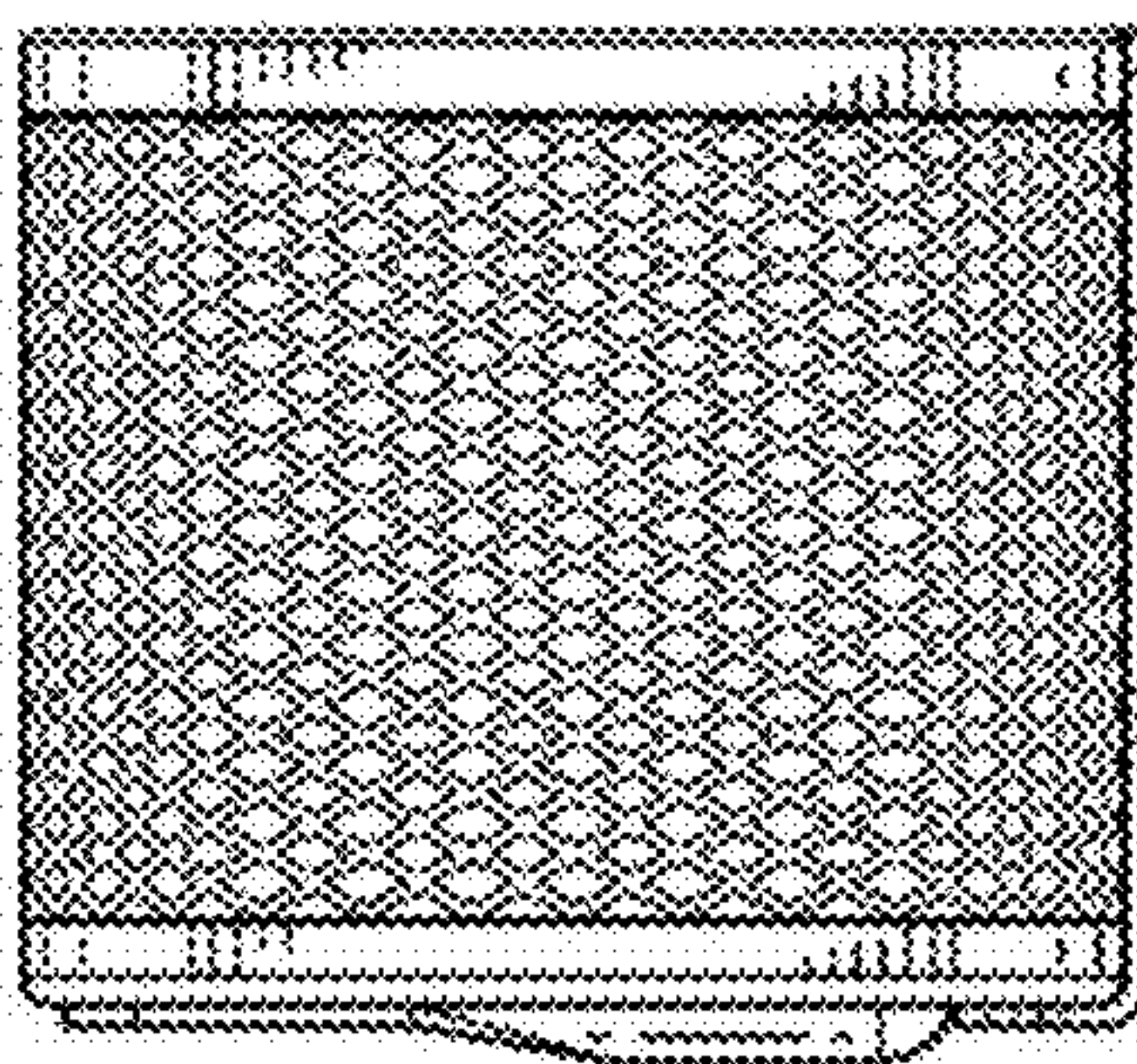
