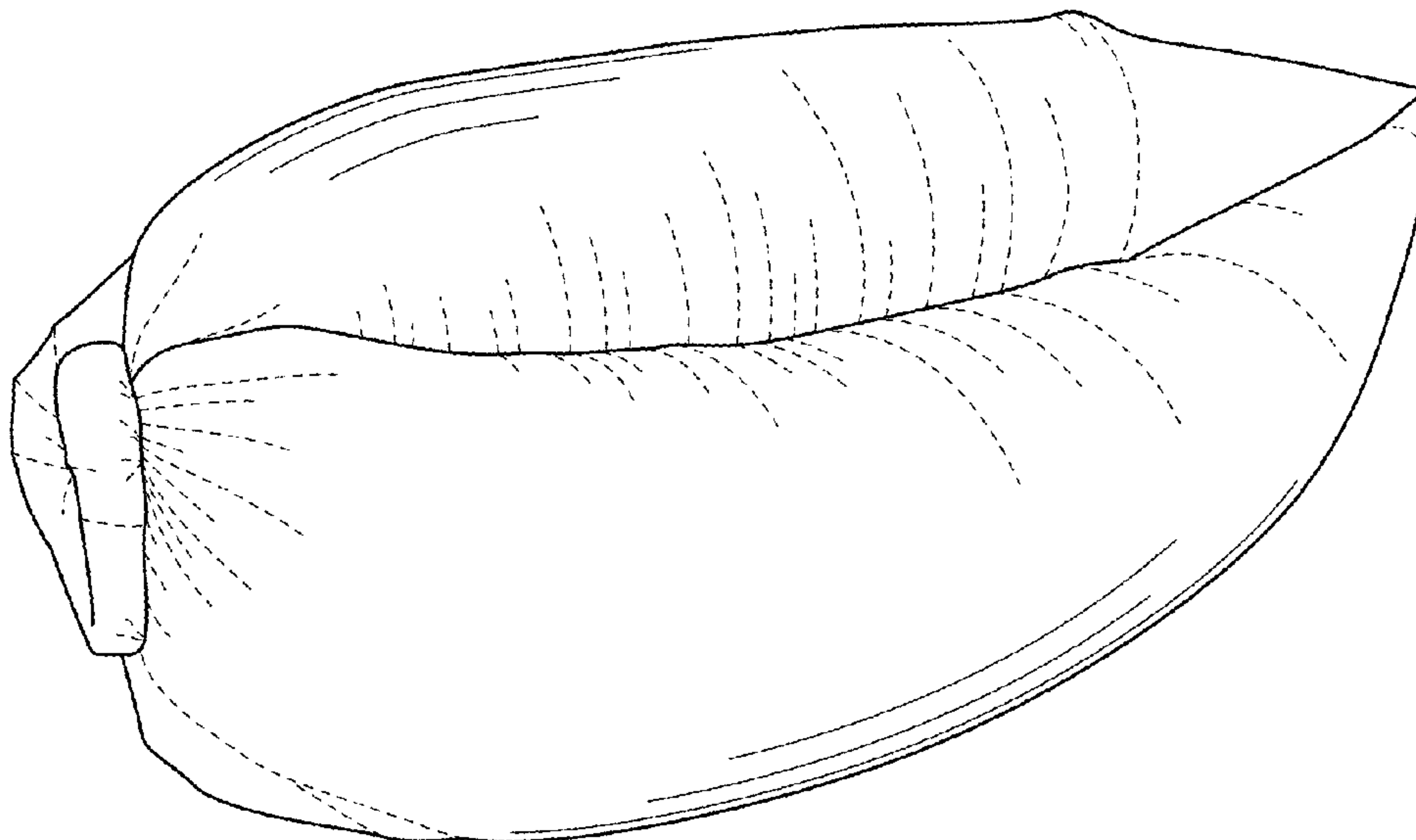
FIG. 1 shows a top view of the chaise lounge;

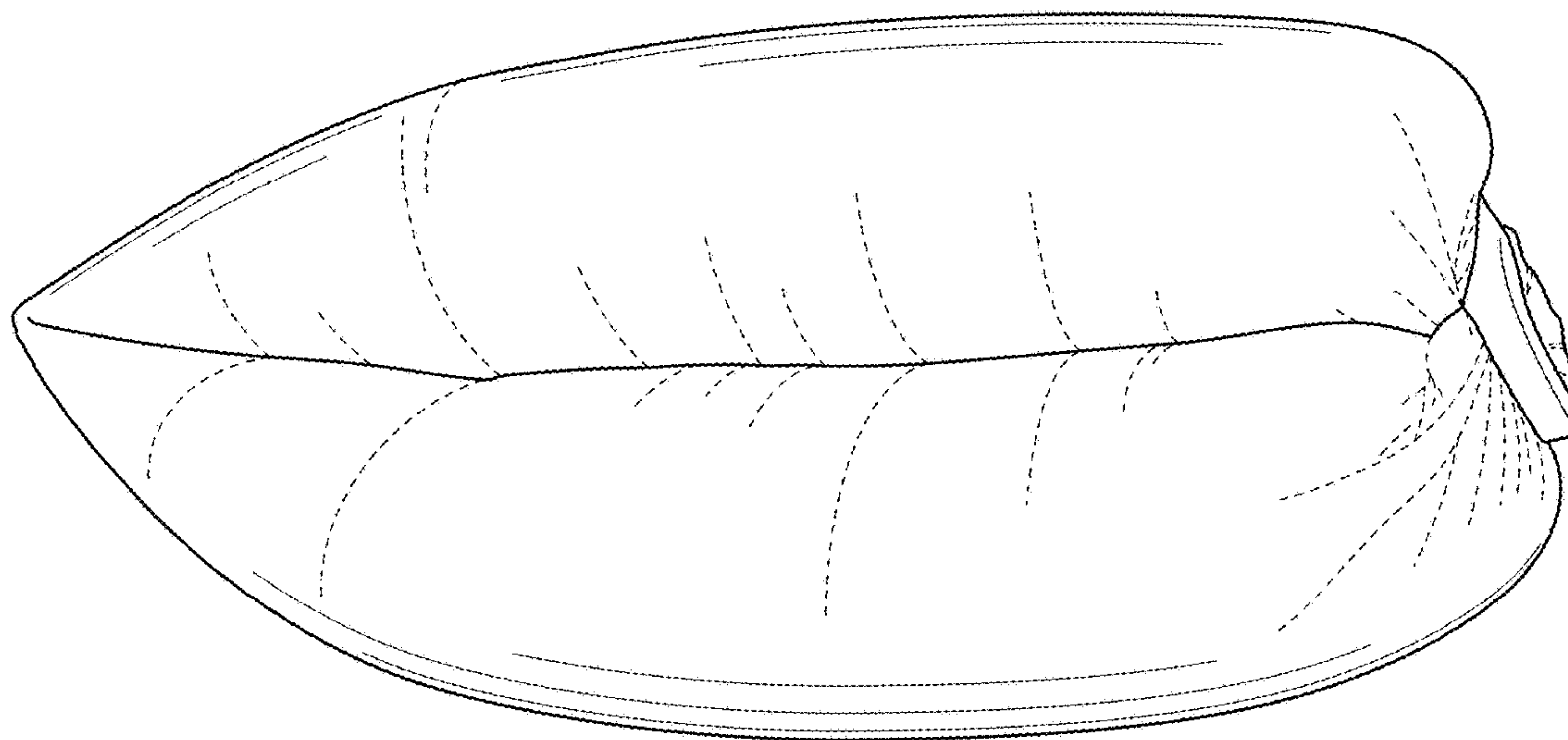

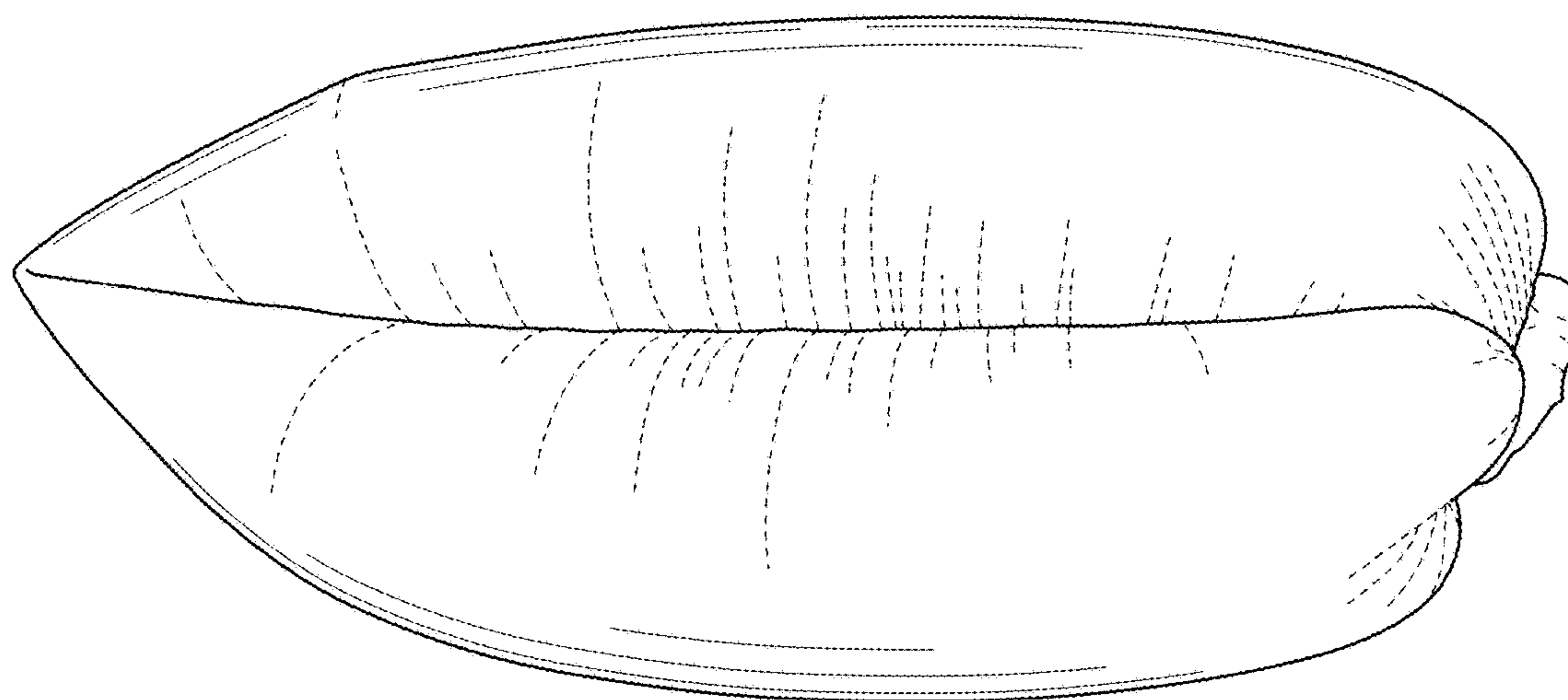

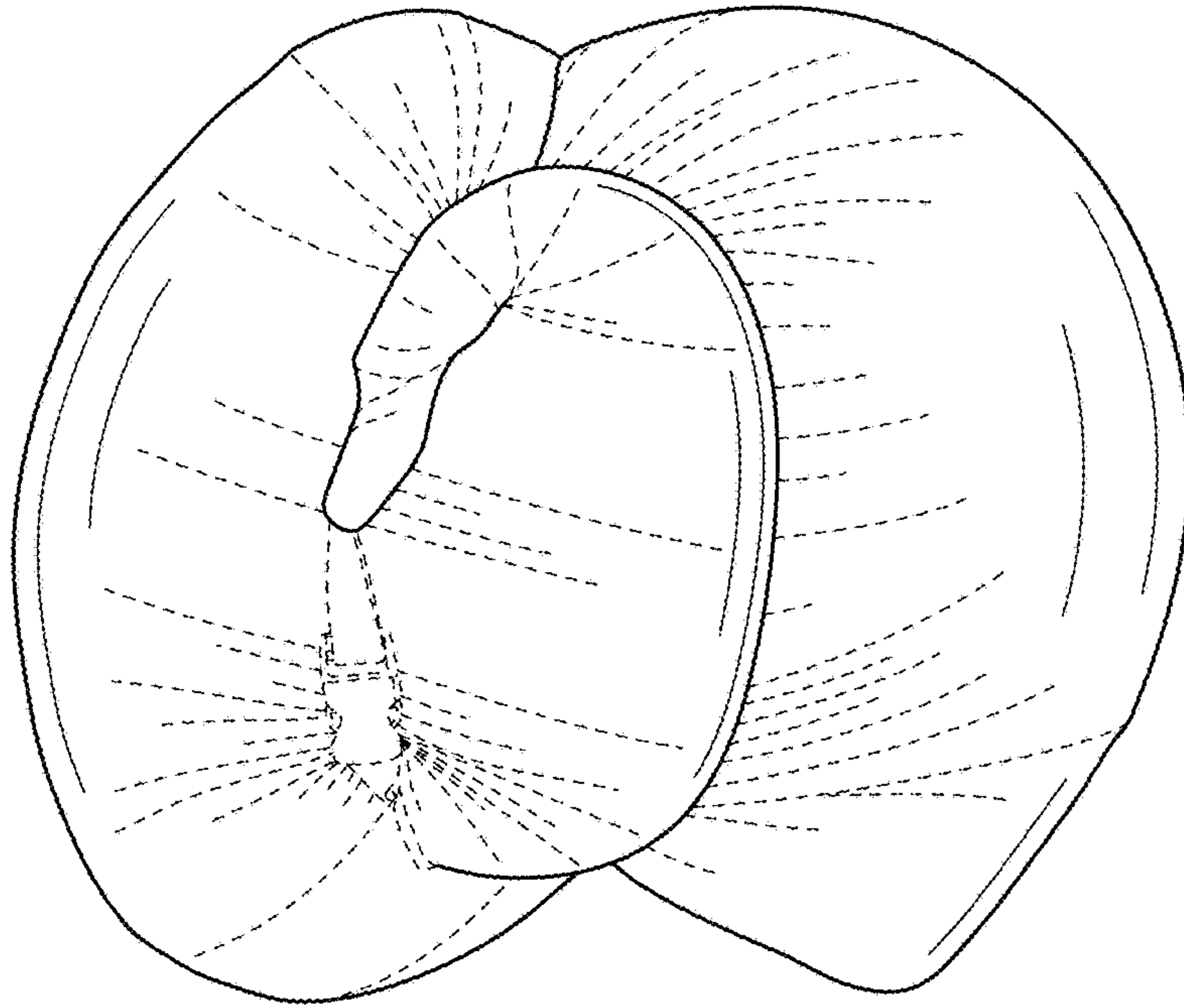

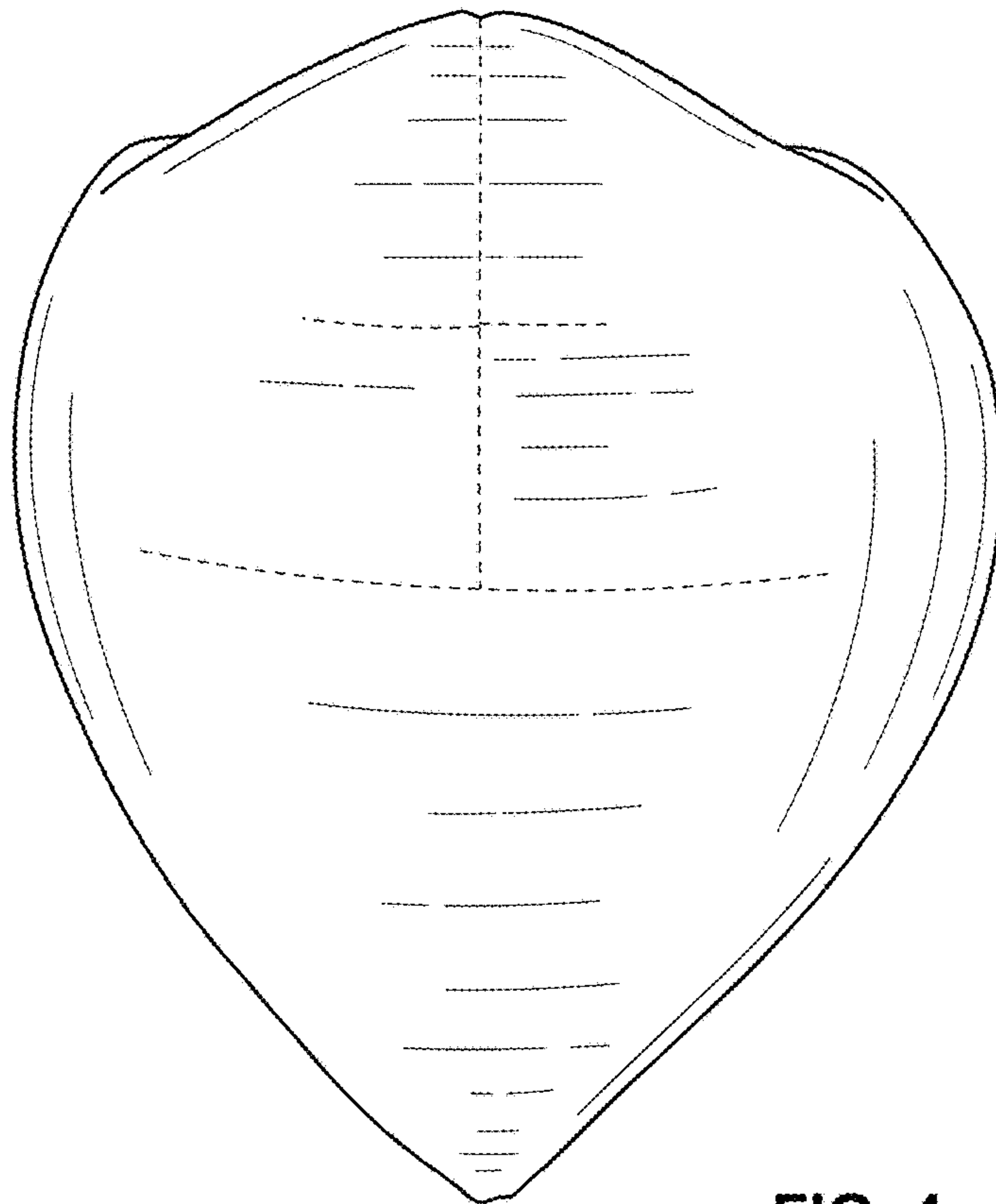

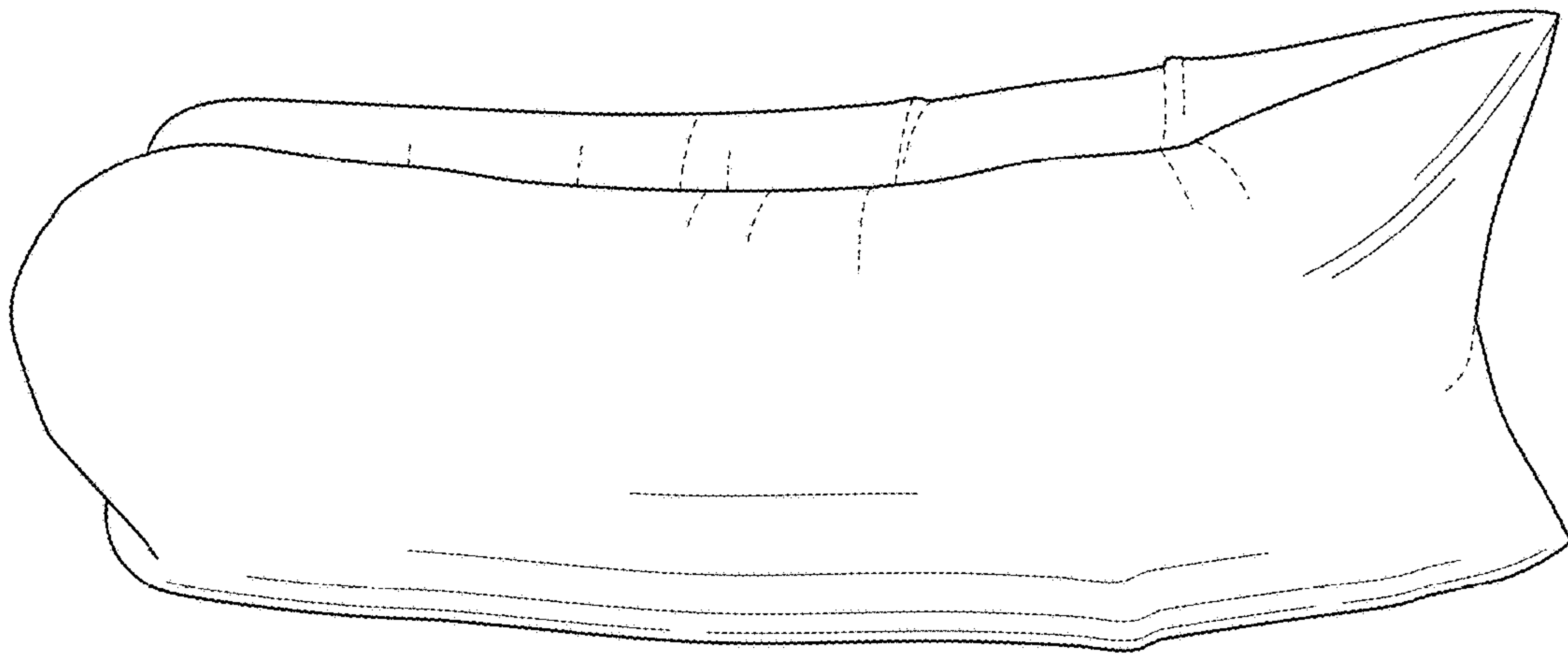

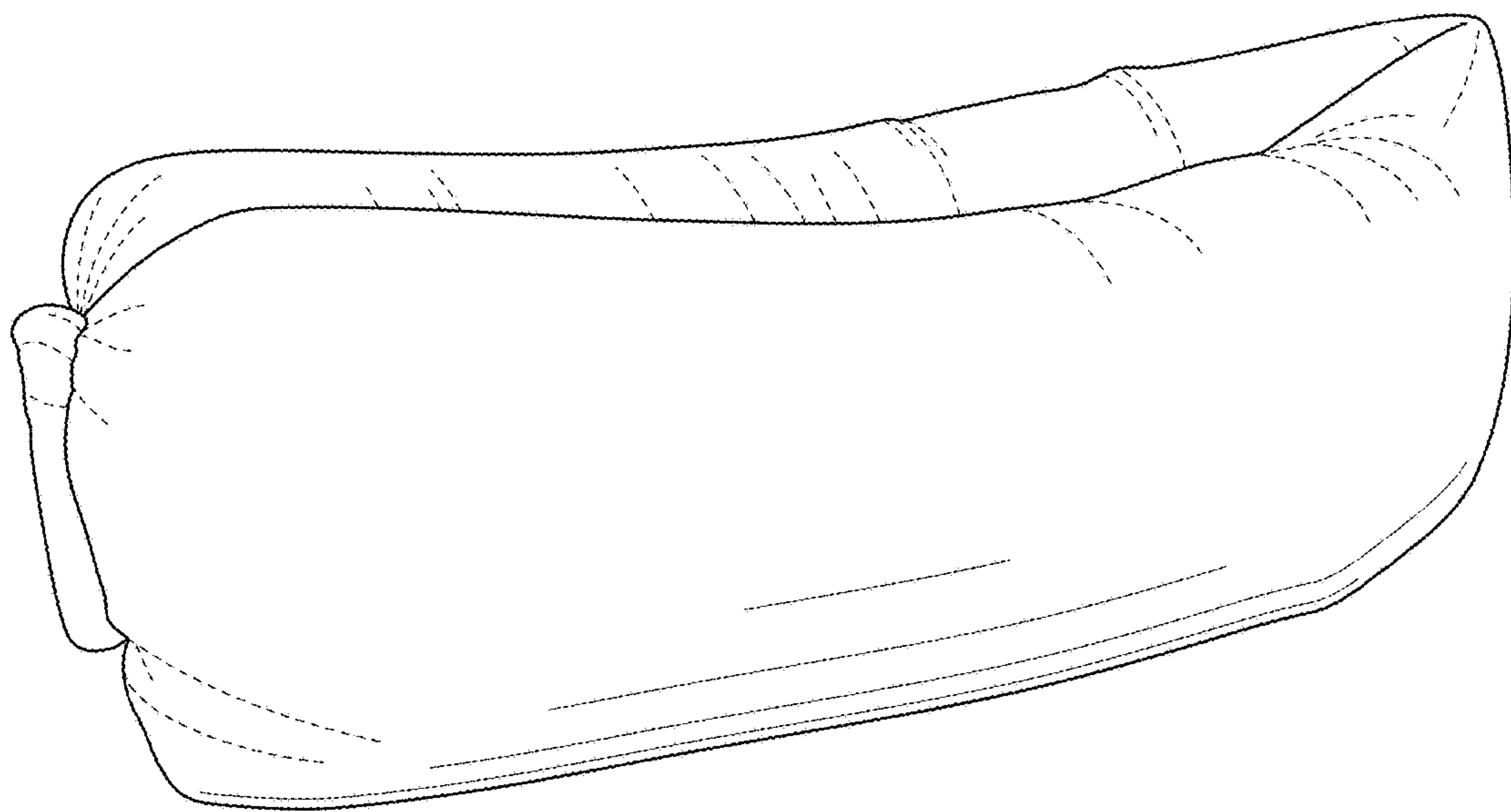

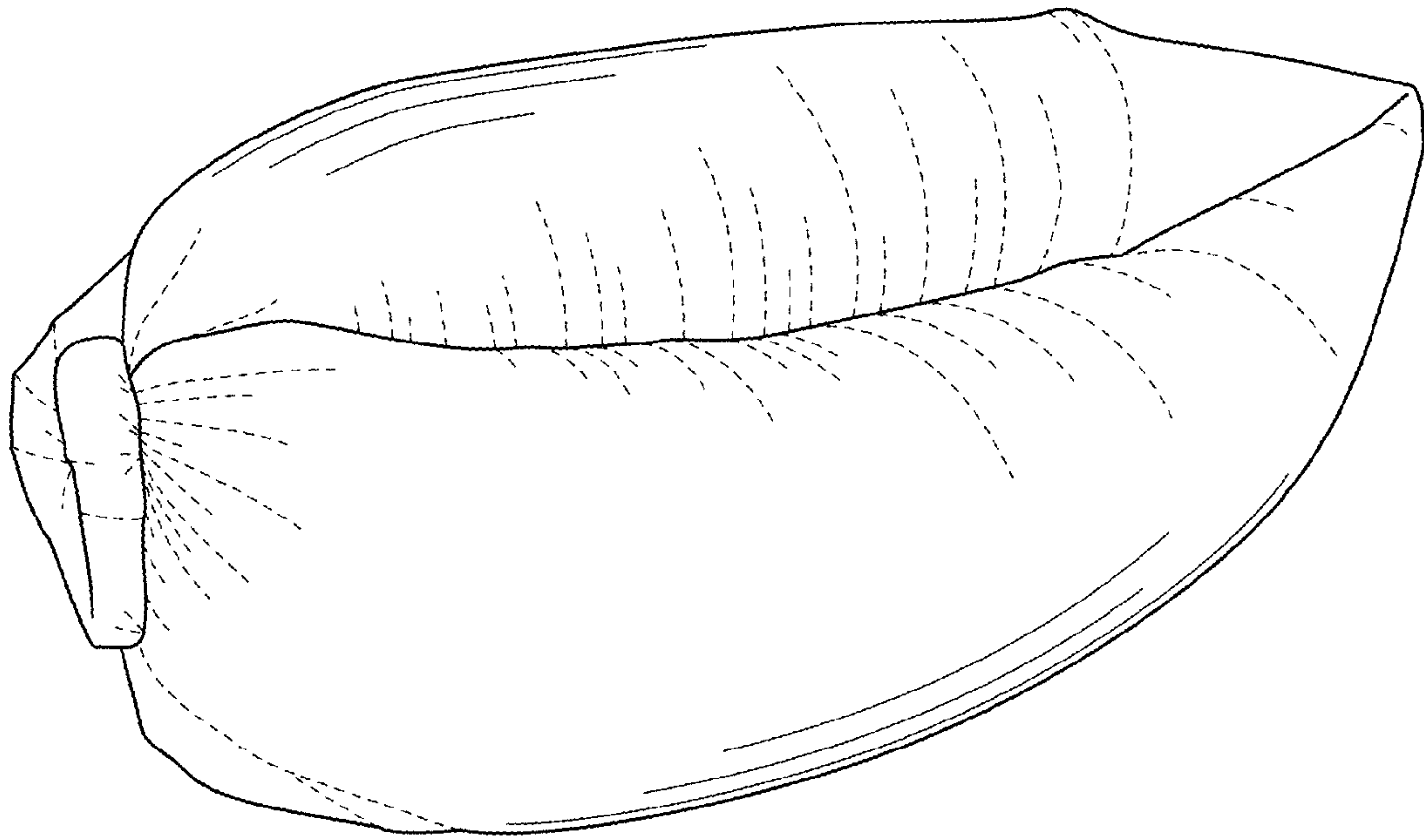

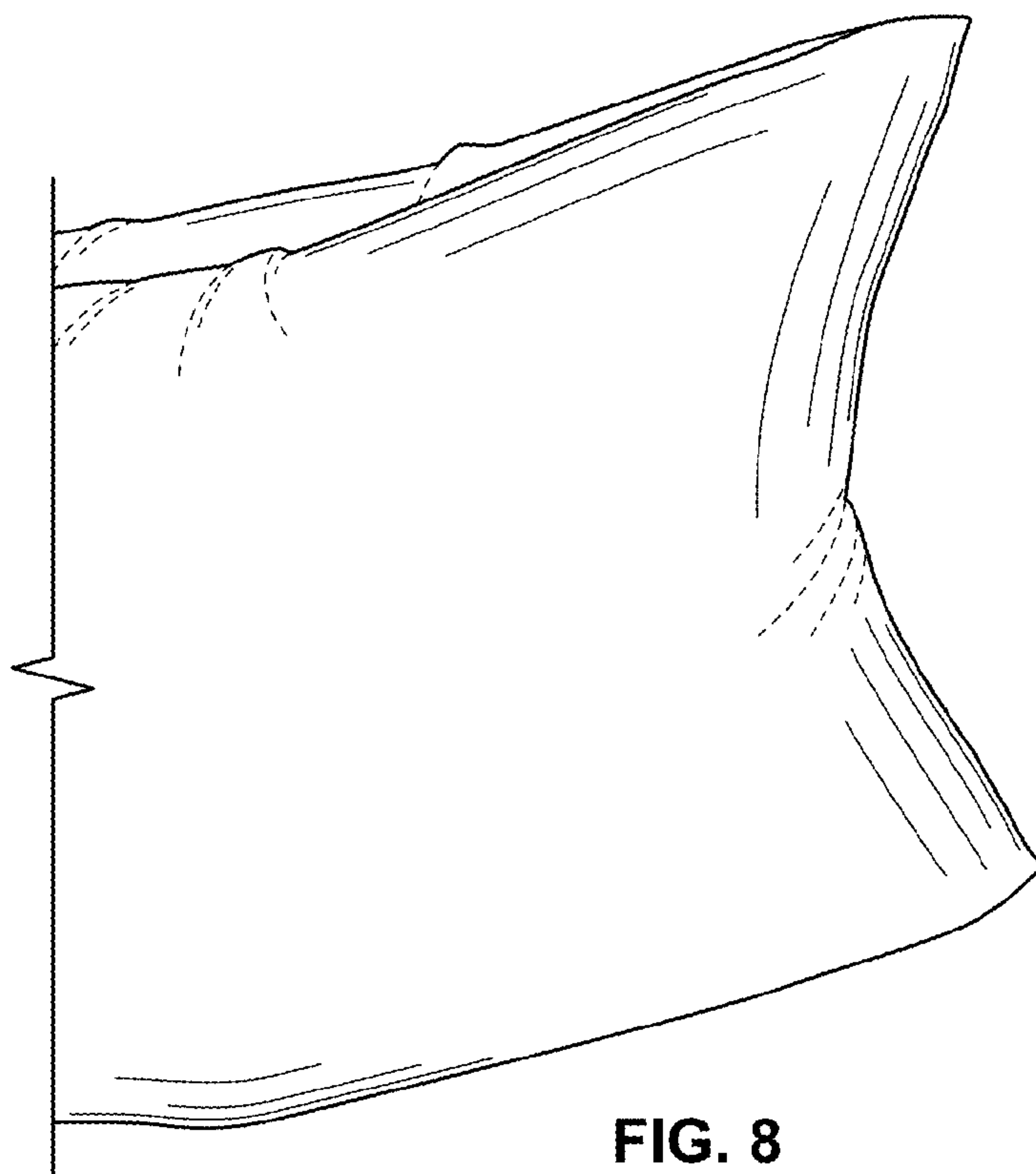
