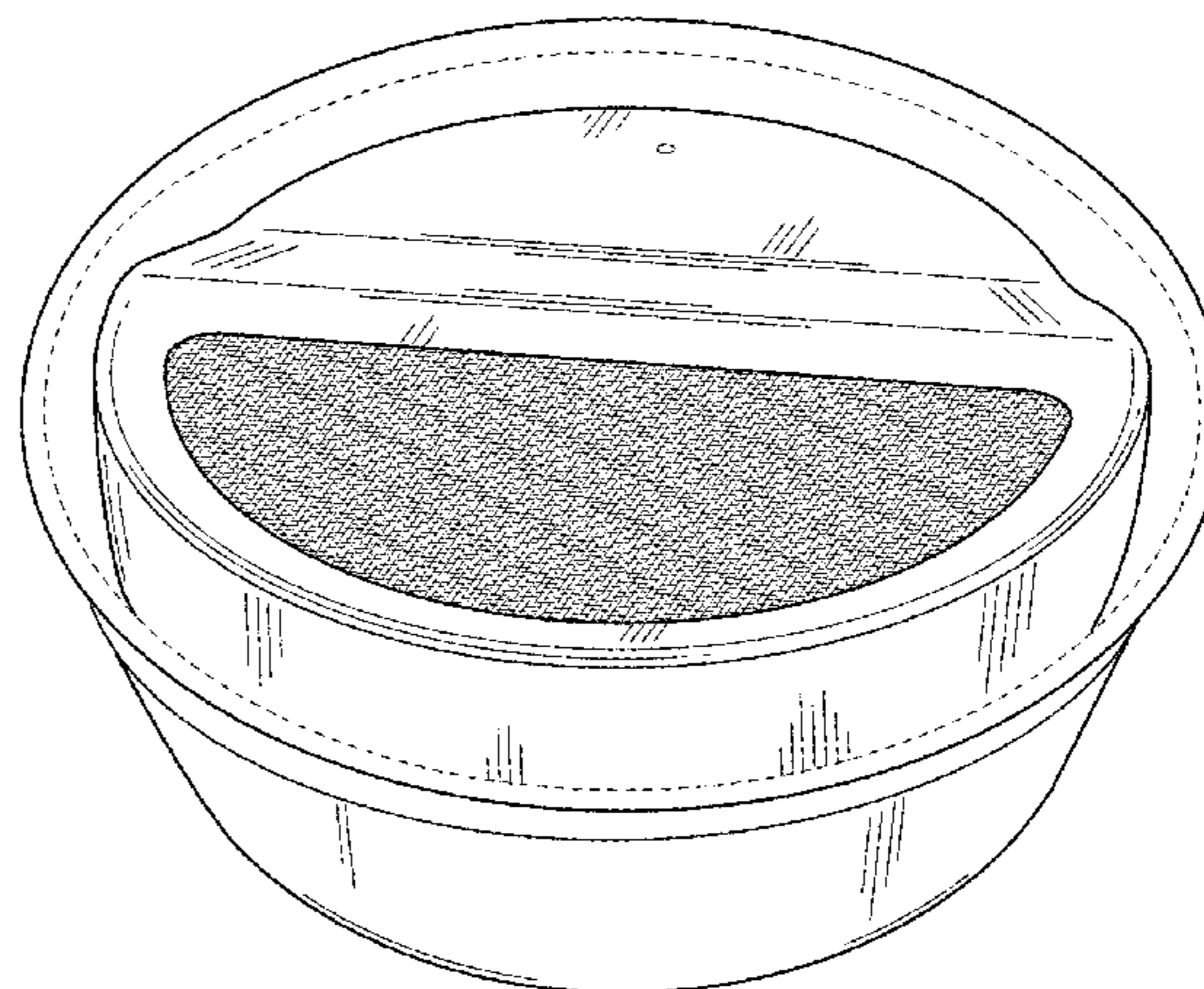
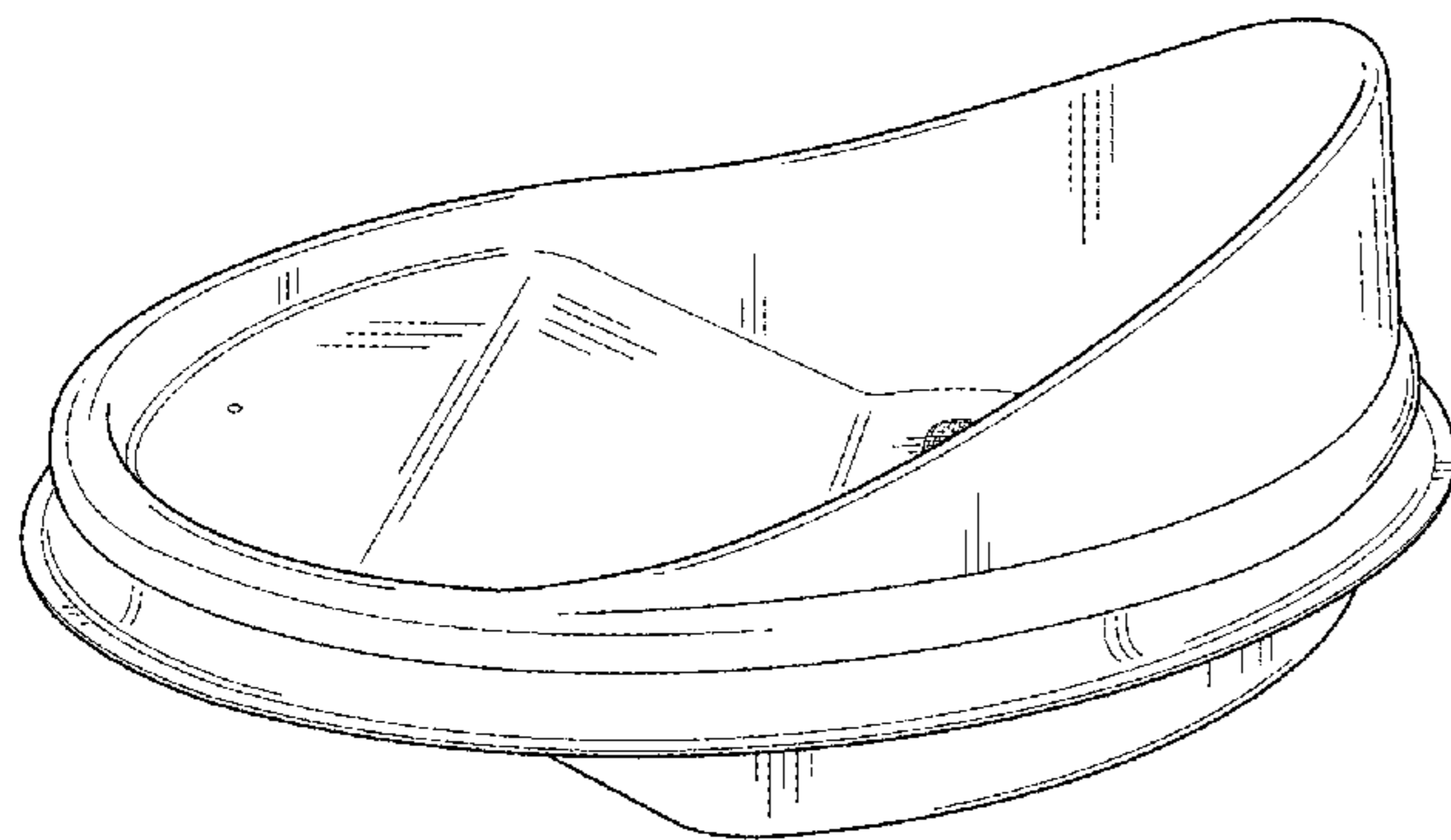
(57) **CLAIM**

The ornamental design for a beverage cup lid, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a beverage cup lid;
FIG. 2 is a bottom perspective view of same;
FIG. 3 is a top view of the beverage cup lid of FIG. 1;
FIG. 4 is a bottom view of same;
FIG. 5 is a right side view of the beverage cup lid of FIG. 1, both sides being mirror images of each other; and,
FIG. 6 is a side perspective view of the beverage cup lid of FIG. 1 shown on a beverage cup.
The structure shown in broken lines is for environment purposes only and does not form part of the claimed invention.

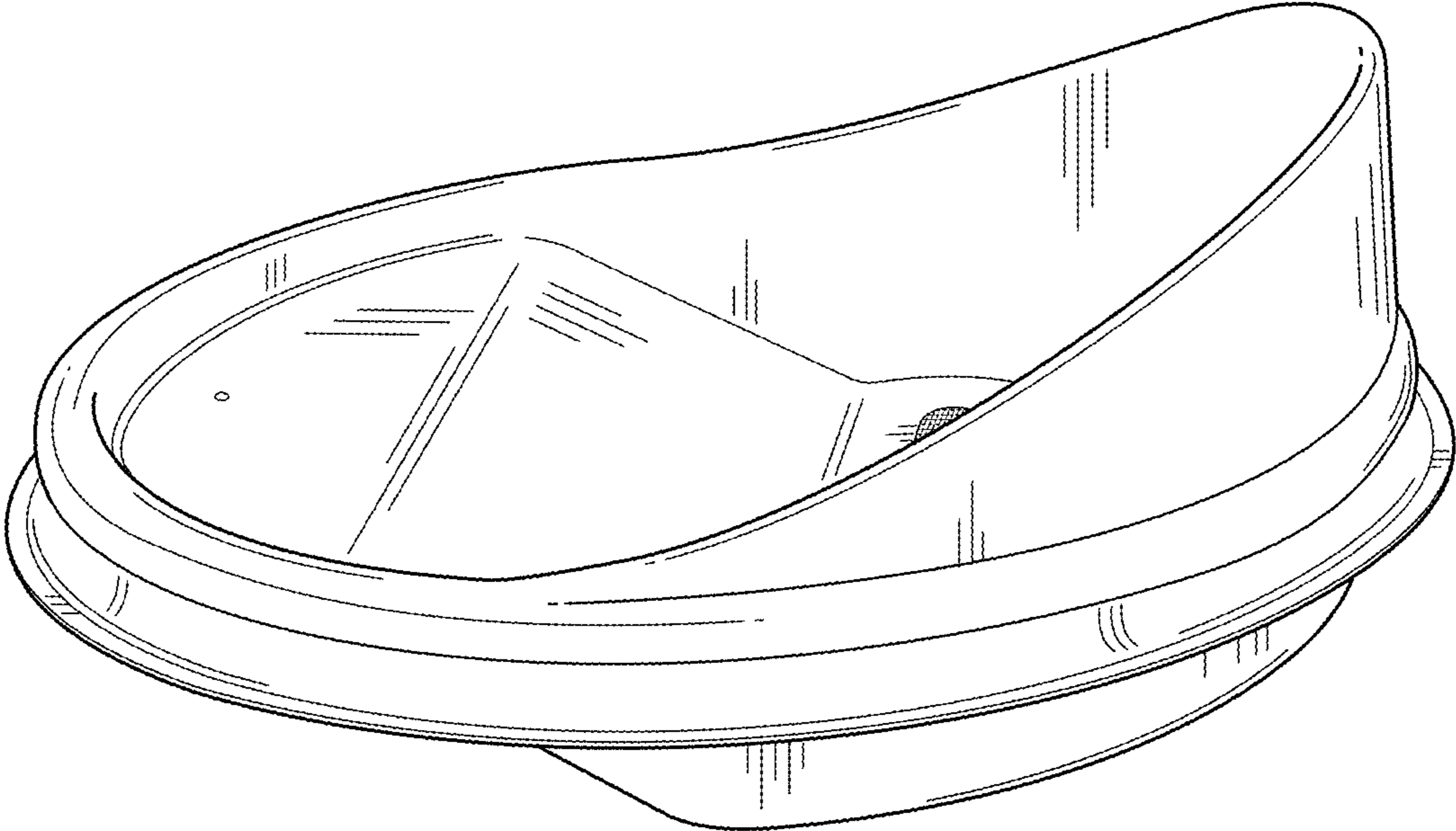

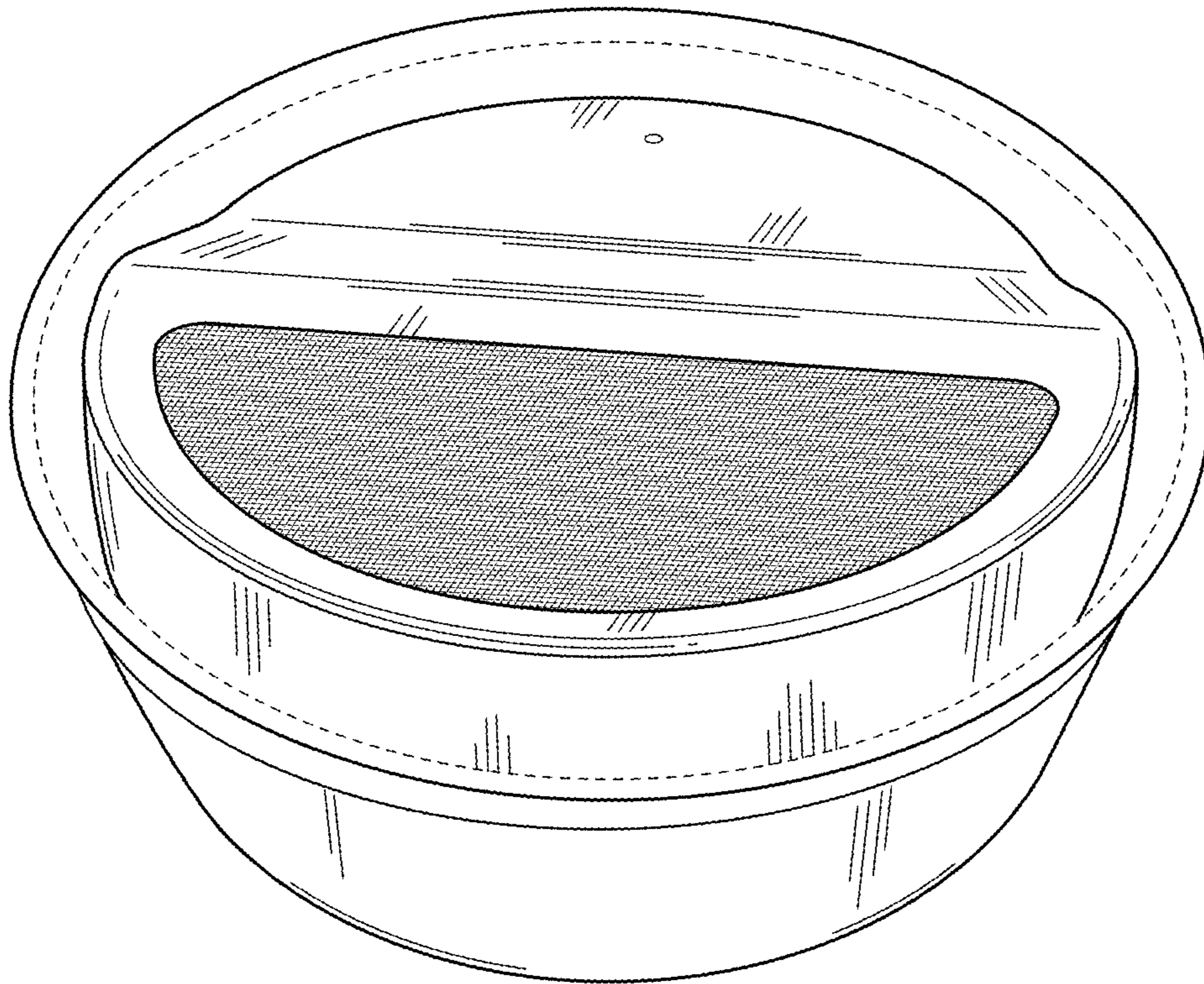

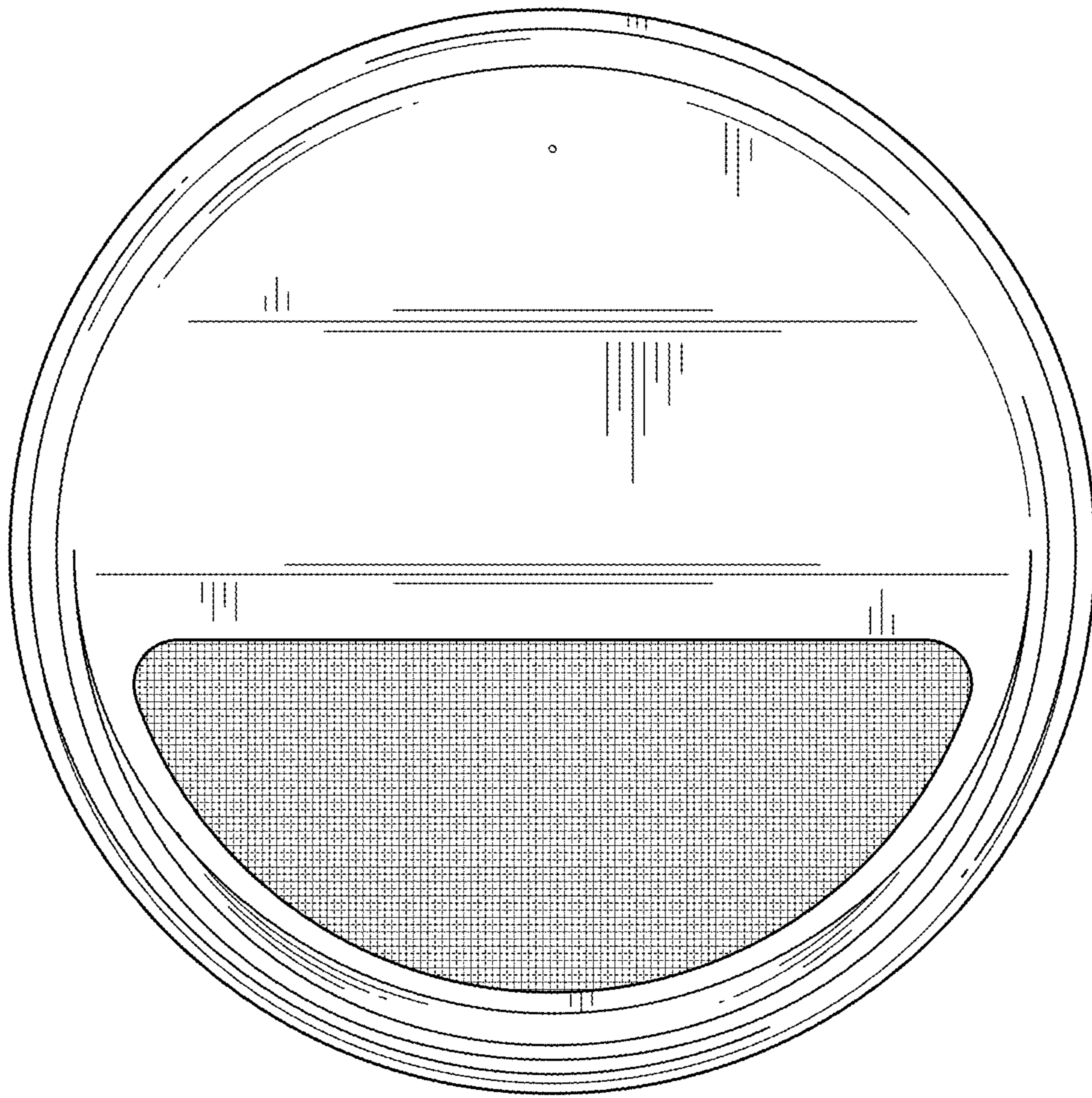

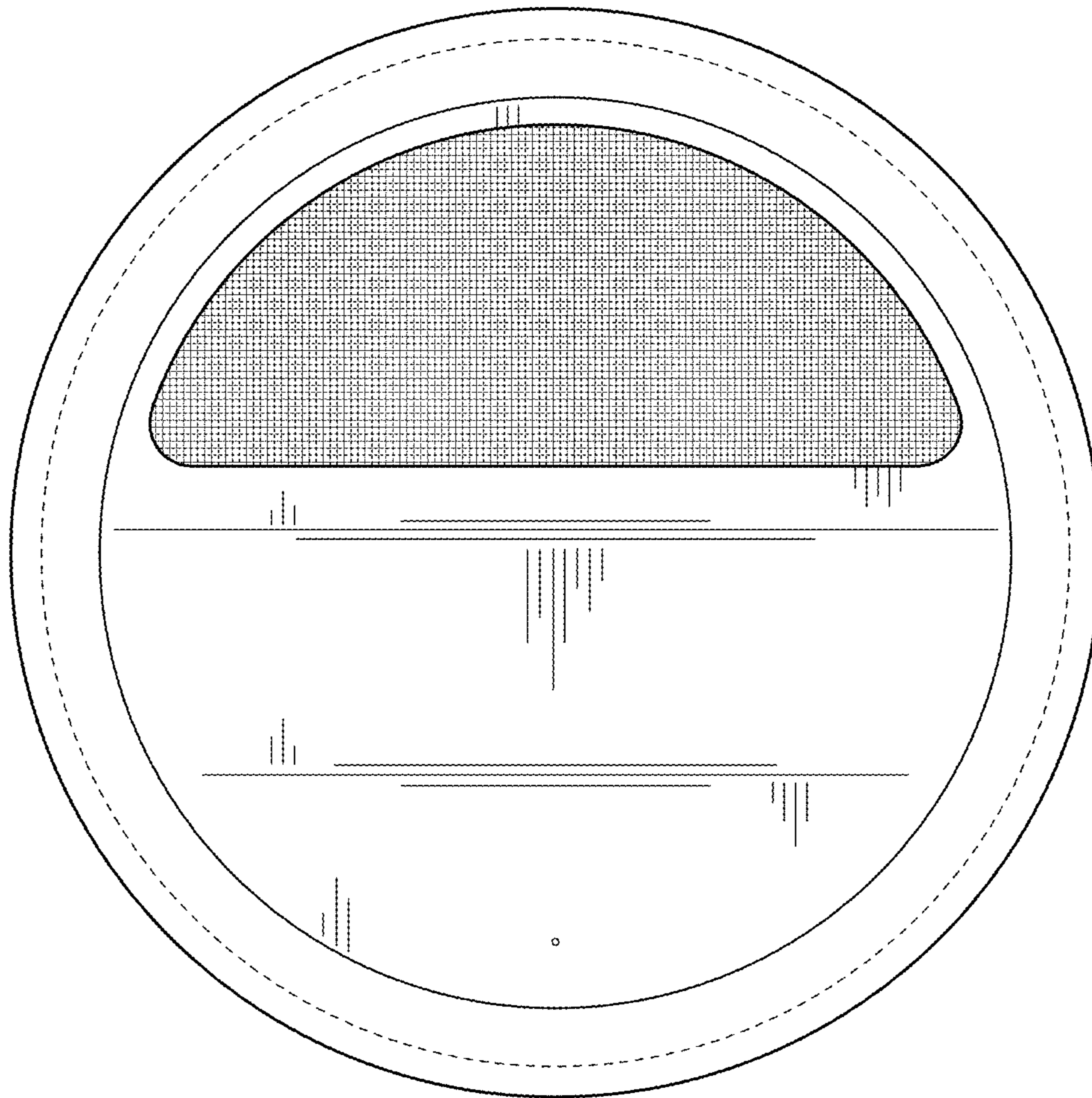

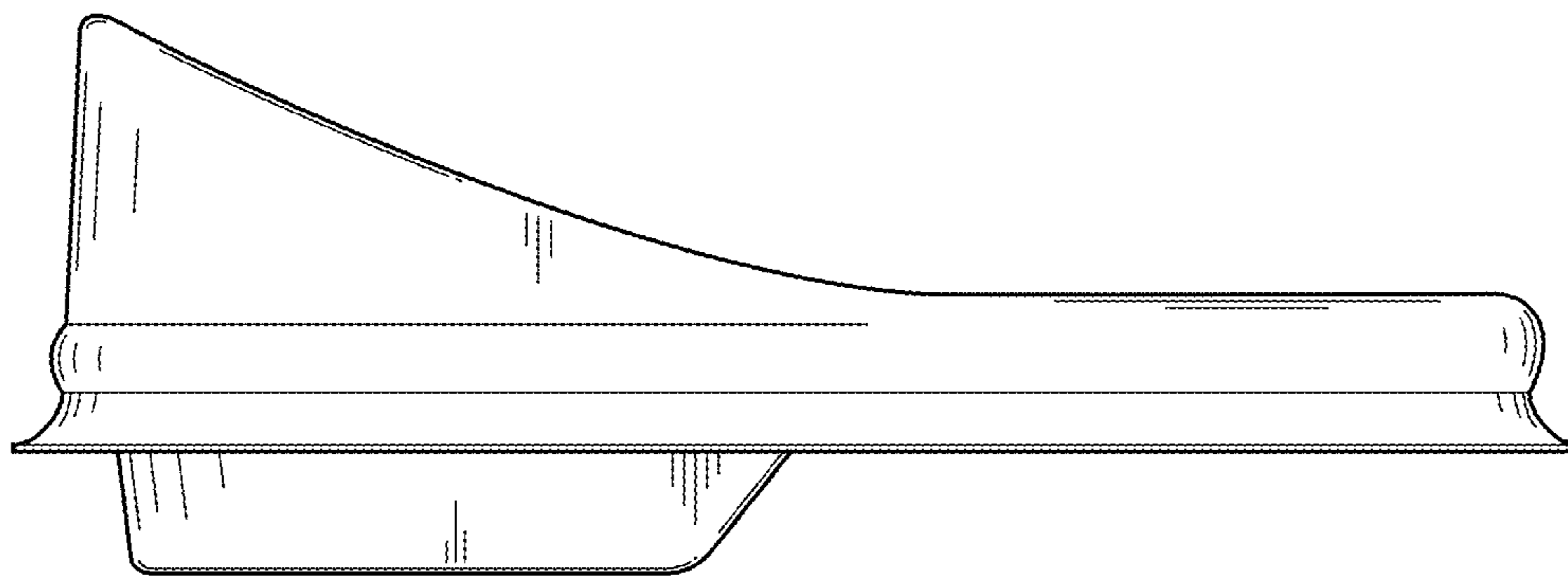

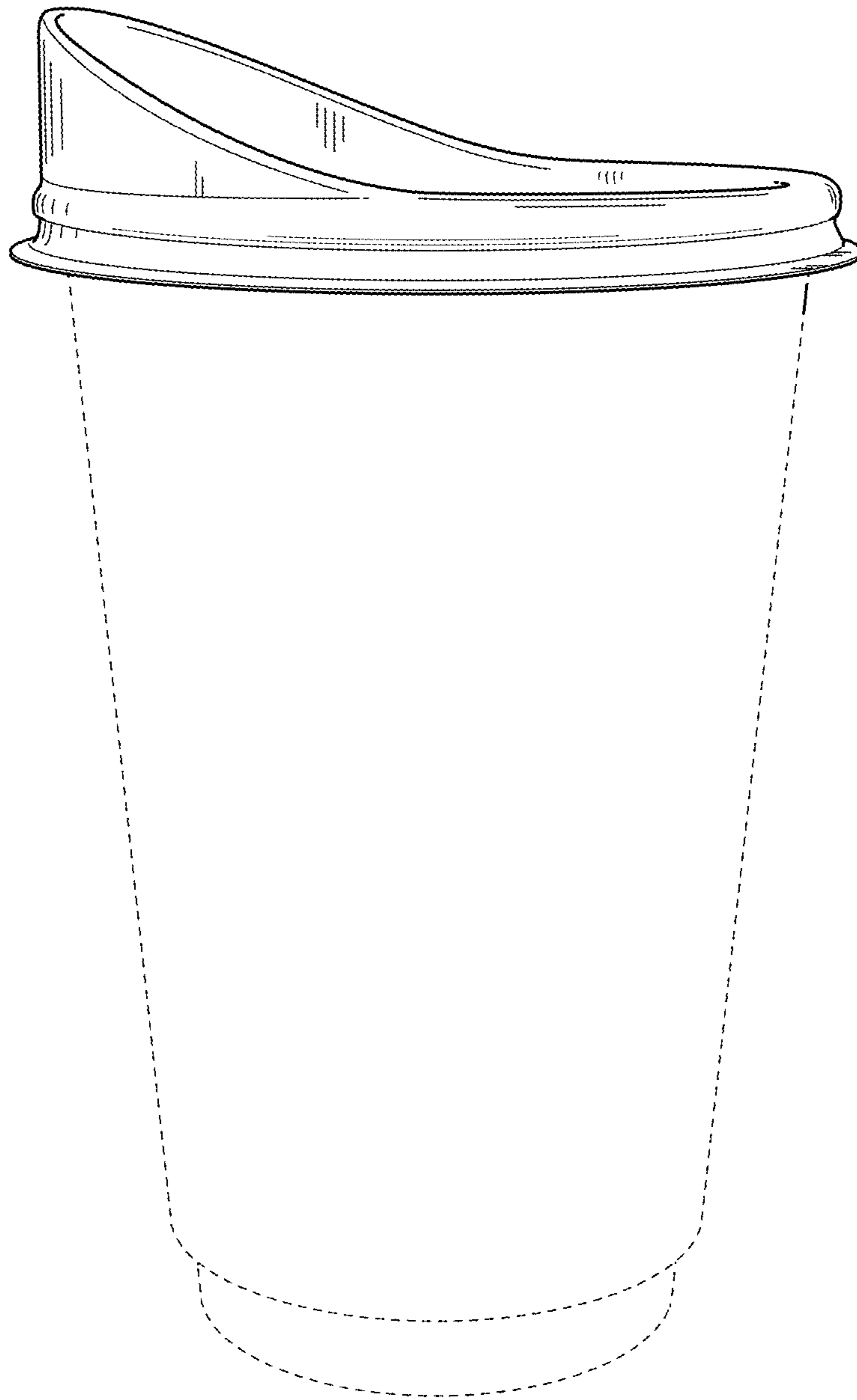
