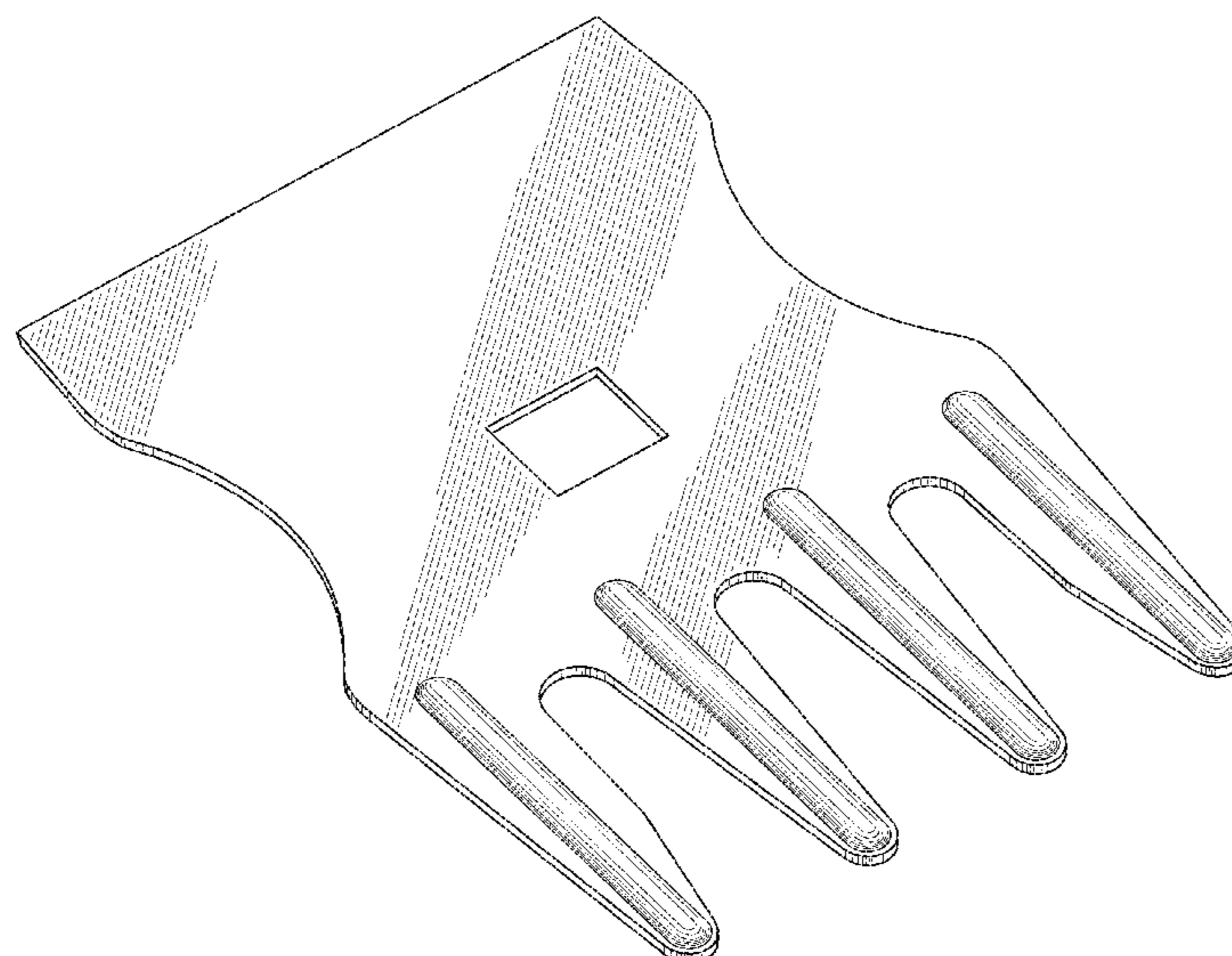
The ornamental design for a McLeod tool head, as shown and described.

DESCRIPTION

FIG. 1 is a front top perspective view of a McLeod tool head of the present disclosure;
FIG. 2 is a rear bottom perspective view of the McLeod tool head shown in FIG. 1;
FIG. 3 is a front elevational view of the McLeod tool head shown in FIG. 1;
FIG. 4 is a rear elevational view of the McLeod tool head shown in FIG. 1;
FIG. 5 is a top plan view of the McLeod tool head shown in FIG. 1;
FIG. 6 is a bottom plan view of the McLeod tool head shown in FIG. 1;
FIG. 7 is a left elevational view of the McLeod tool head shown in FIG. 1;
FIG. 8 is a right elevational view of the McLeod tool head shown in FIG. 1; and,
FIG. 9 is a cross-sectional view of the McLeod tool head taken generally along line 9-9 in FIG. 5.

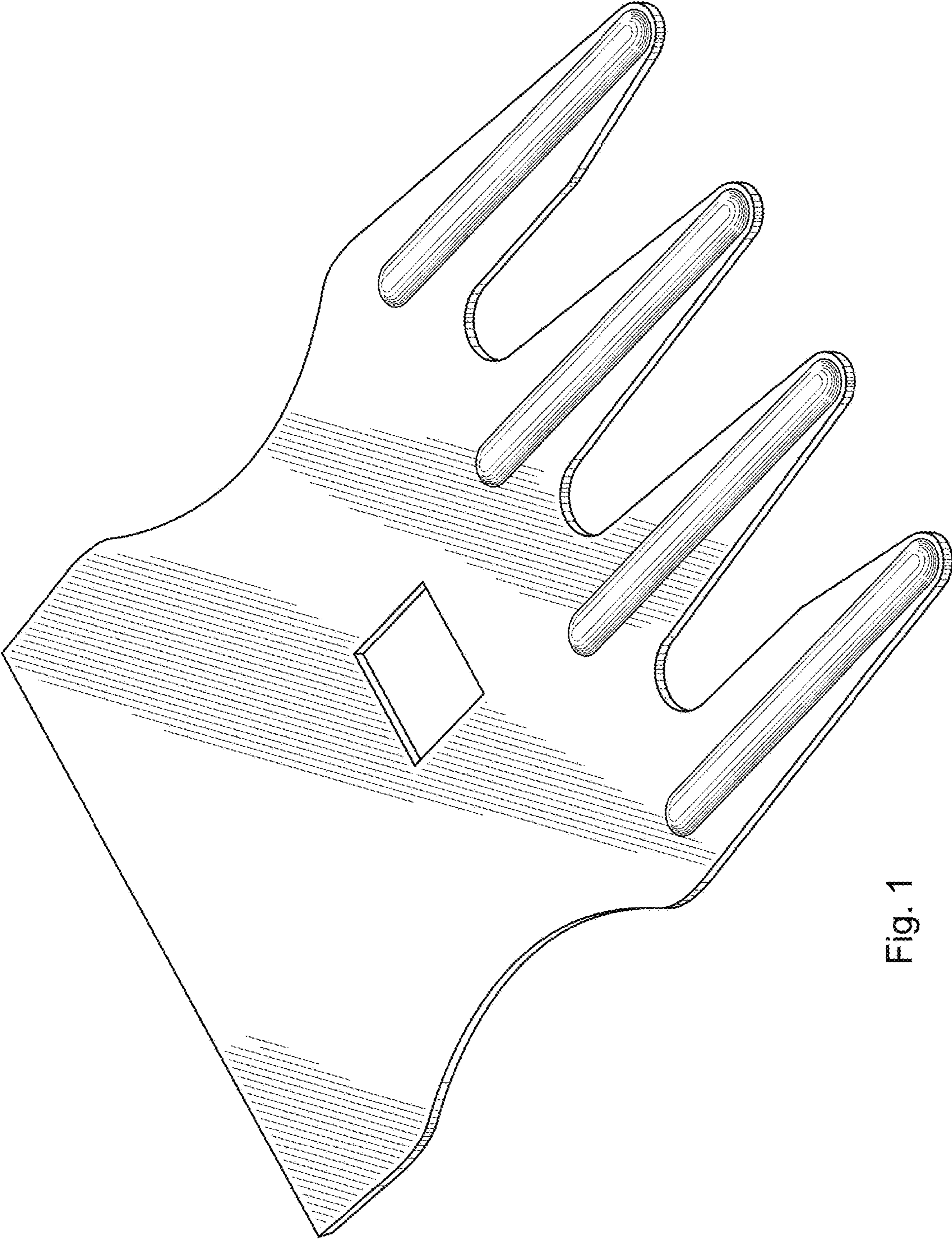

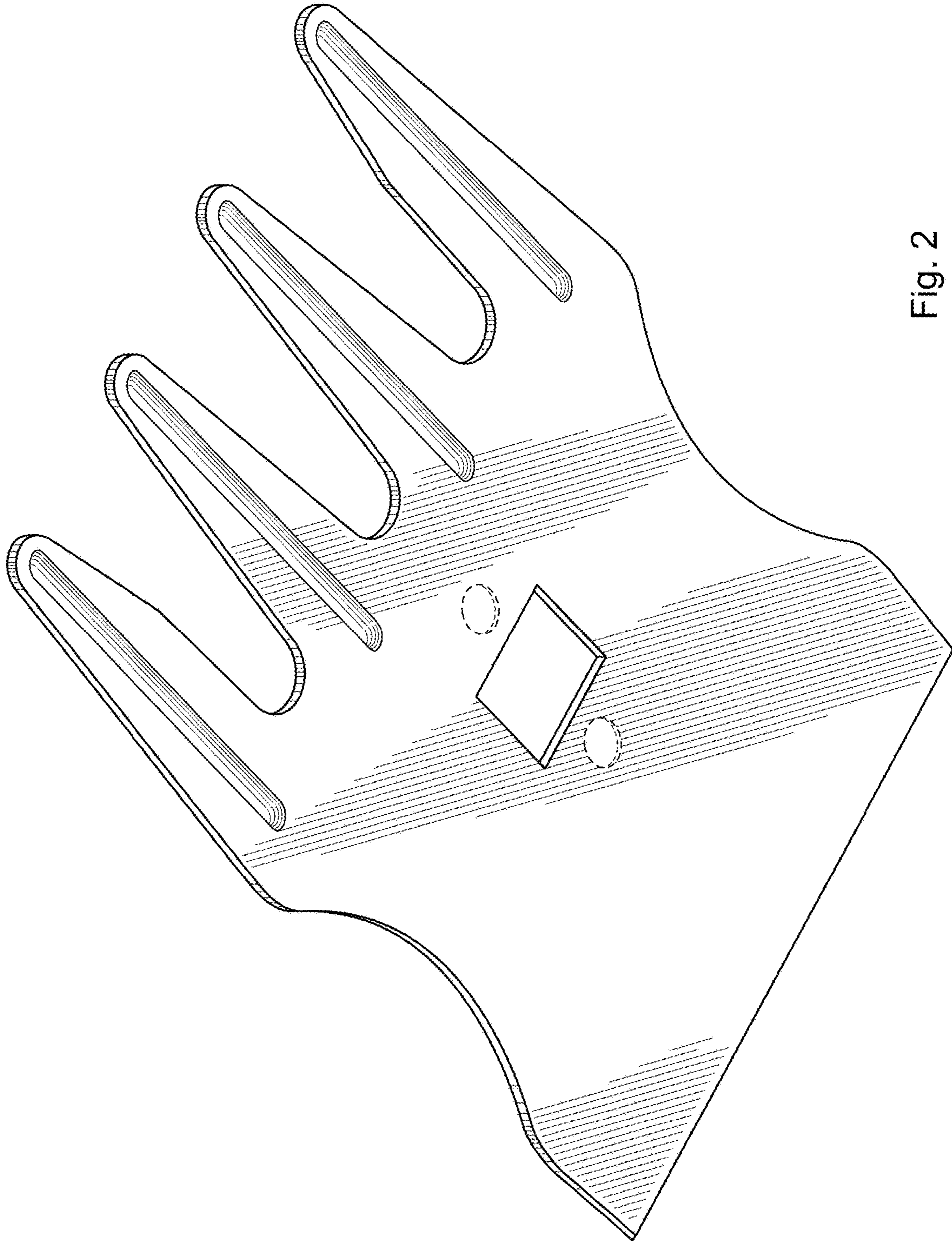

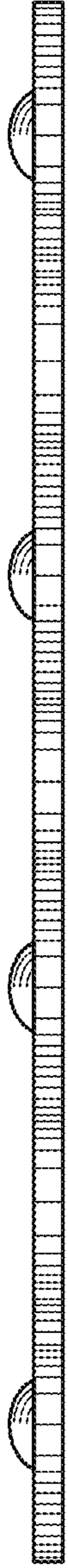

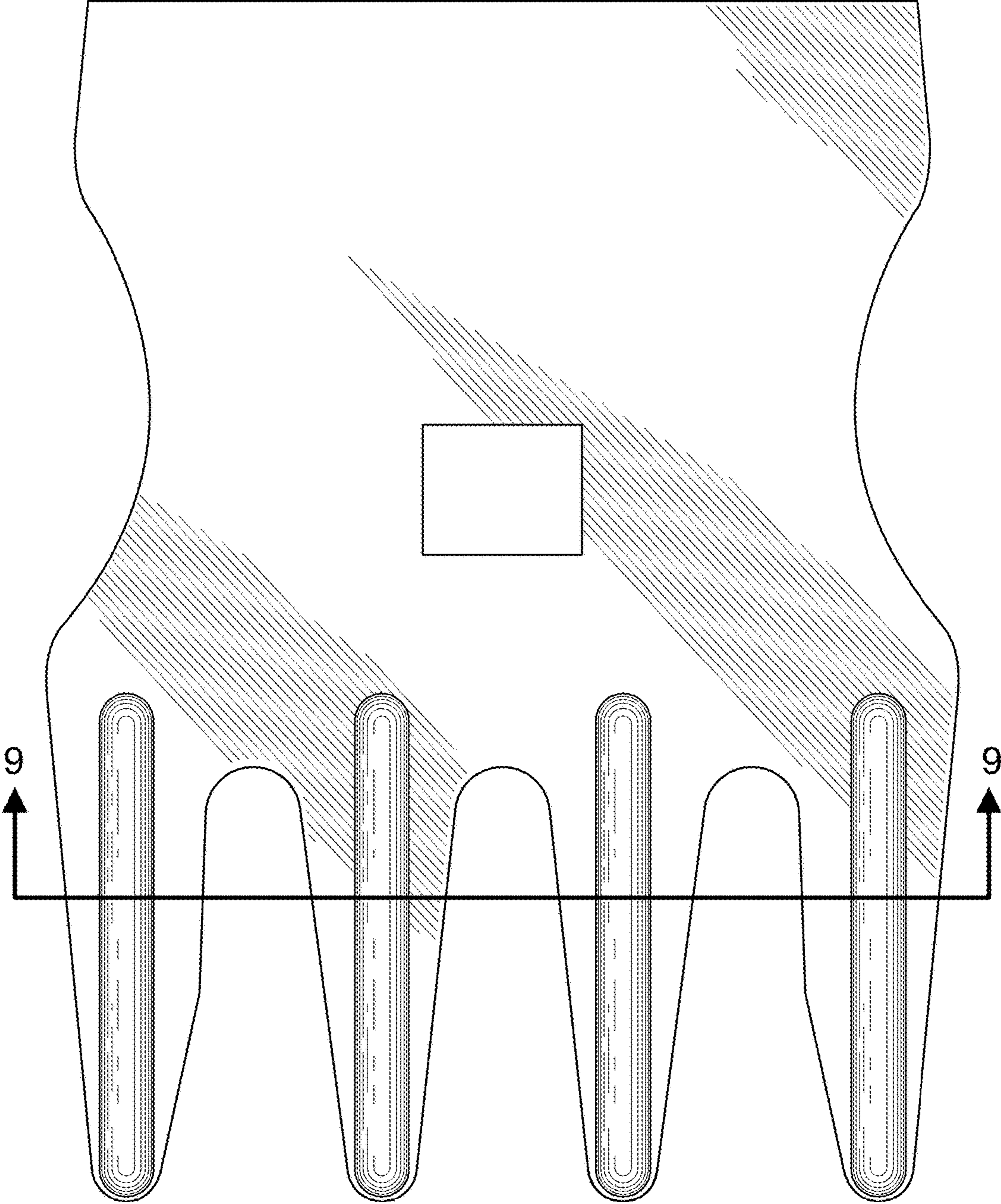

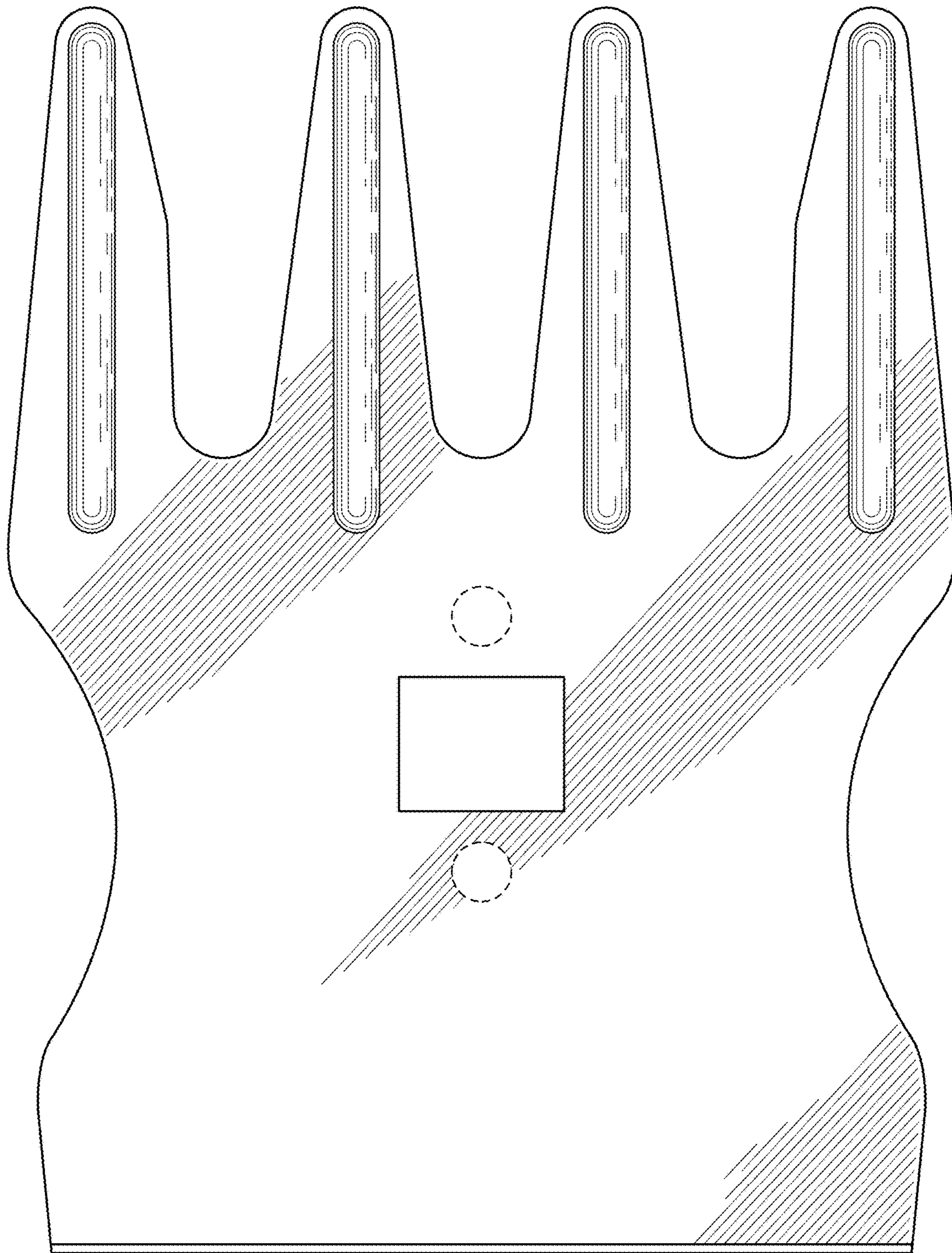

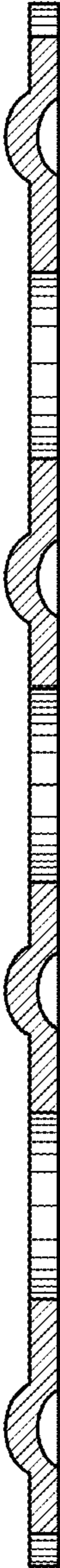
