(57) **CLAIM**

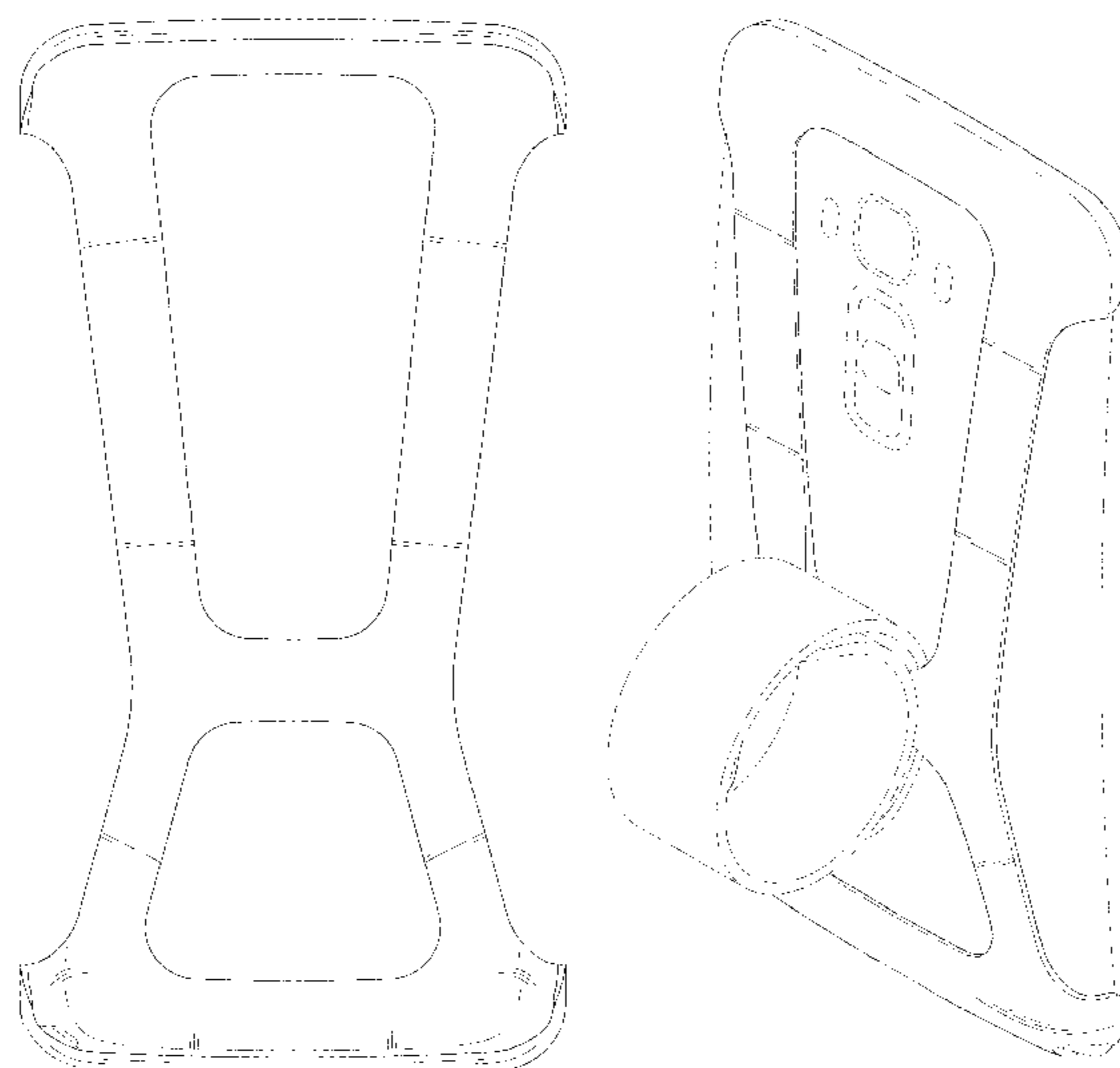
The ornamental design for a mobile phone case, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a mobile phone case showing our new design;
 FIG. 2 is a front view thereof;
 FIG. 3 is a rear view thereof;
 FIG. 4 is a left side view thereof;
 FIG. 5 is a right side view thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a bottom plan view thereof; and,
 FIG. 8 is a rear perspective view thereof shown in a state of use with an environmental mobile phone and rolled stylus pen.

The dot-dash broken lines in FIG. 8 depict an environmental mobile phone and rolled stylus pen that form no part of the claimed design. The dash-dash broken lines throughout the drawing figures depict portions of the mobile phone case that form no part of the claimed design.

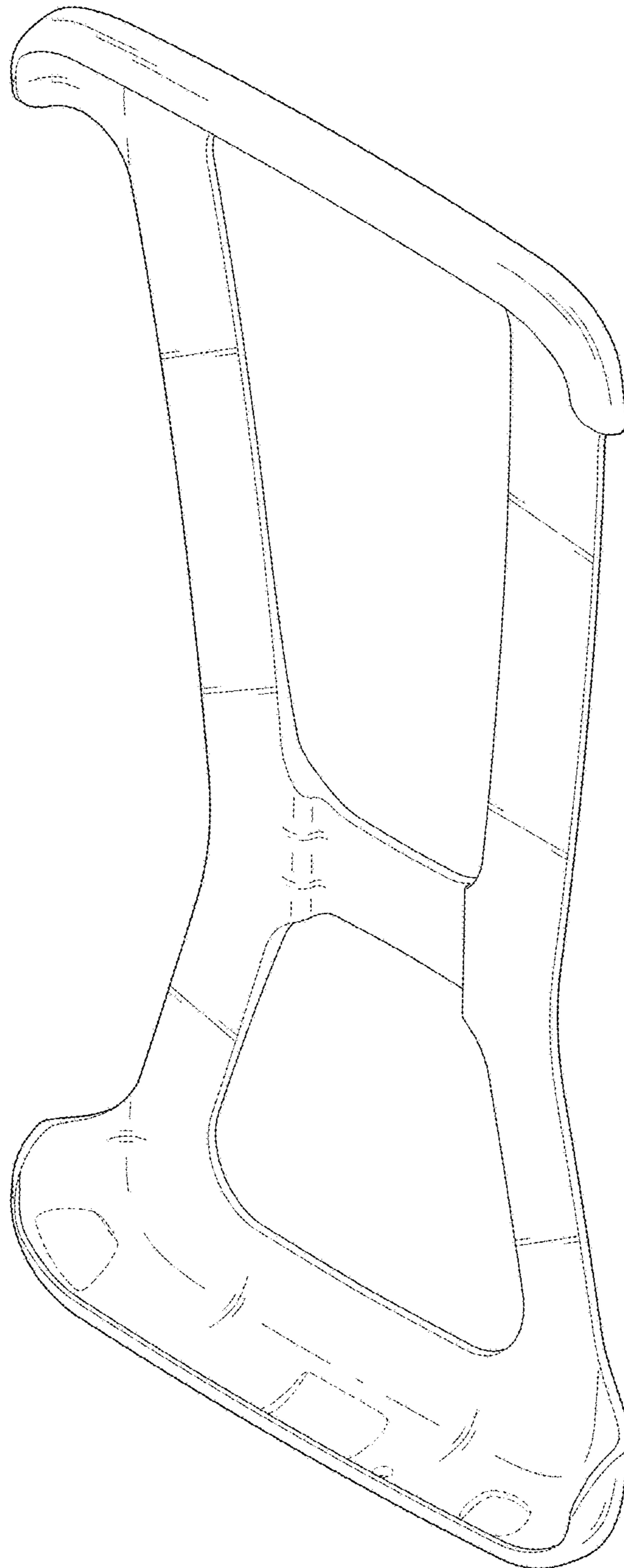

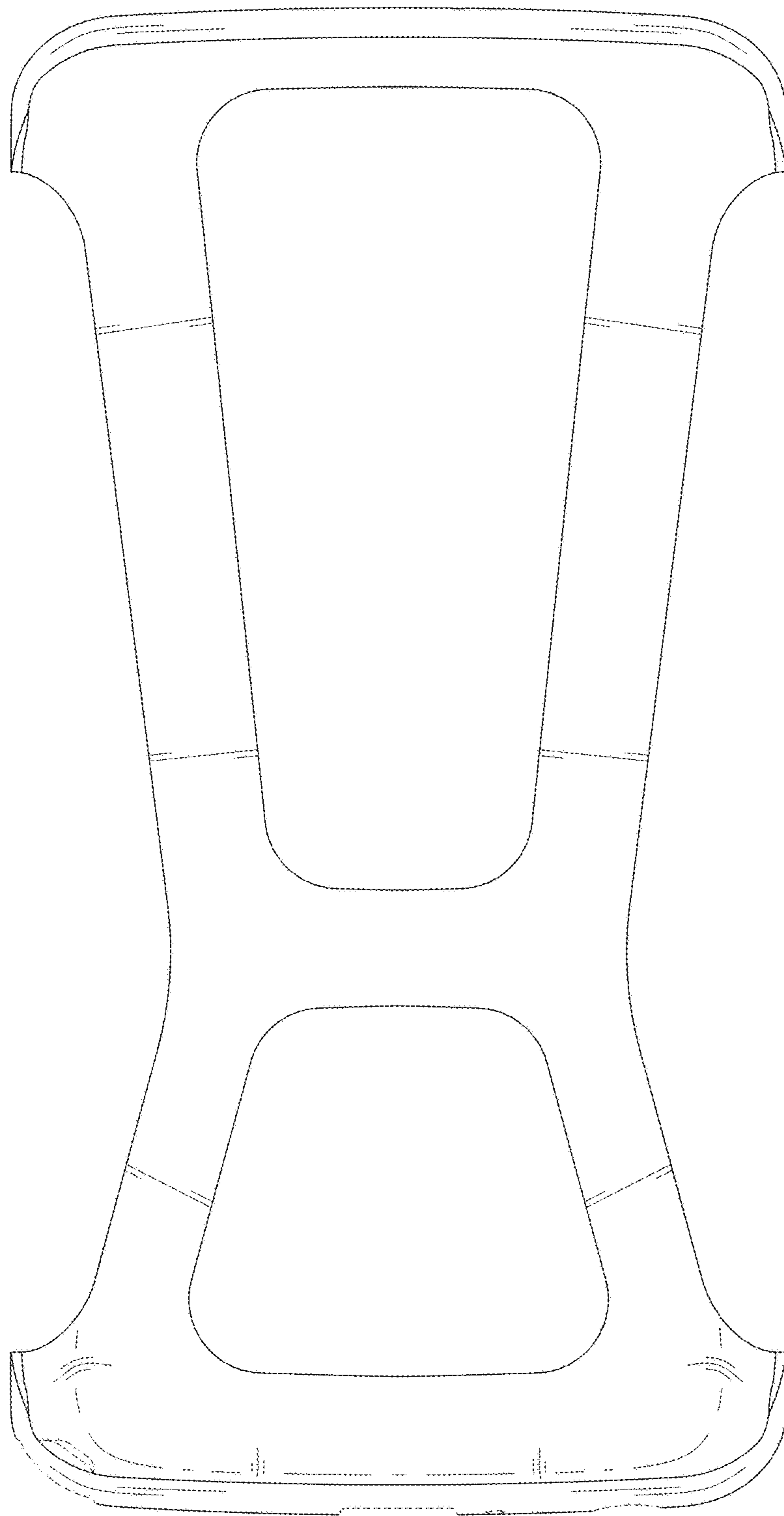

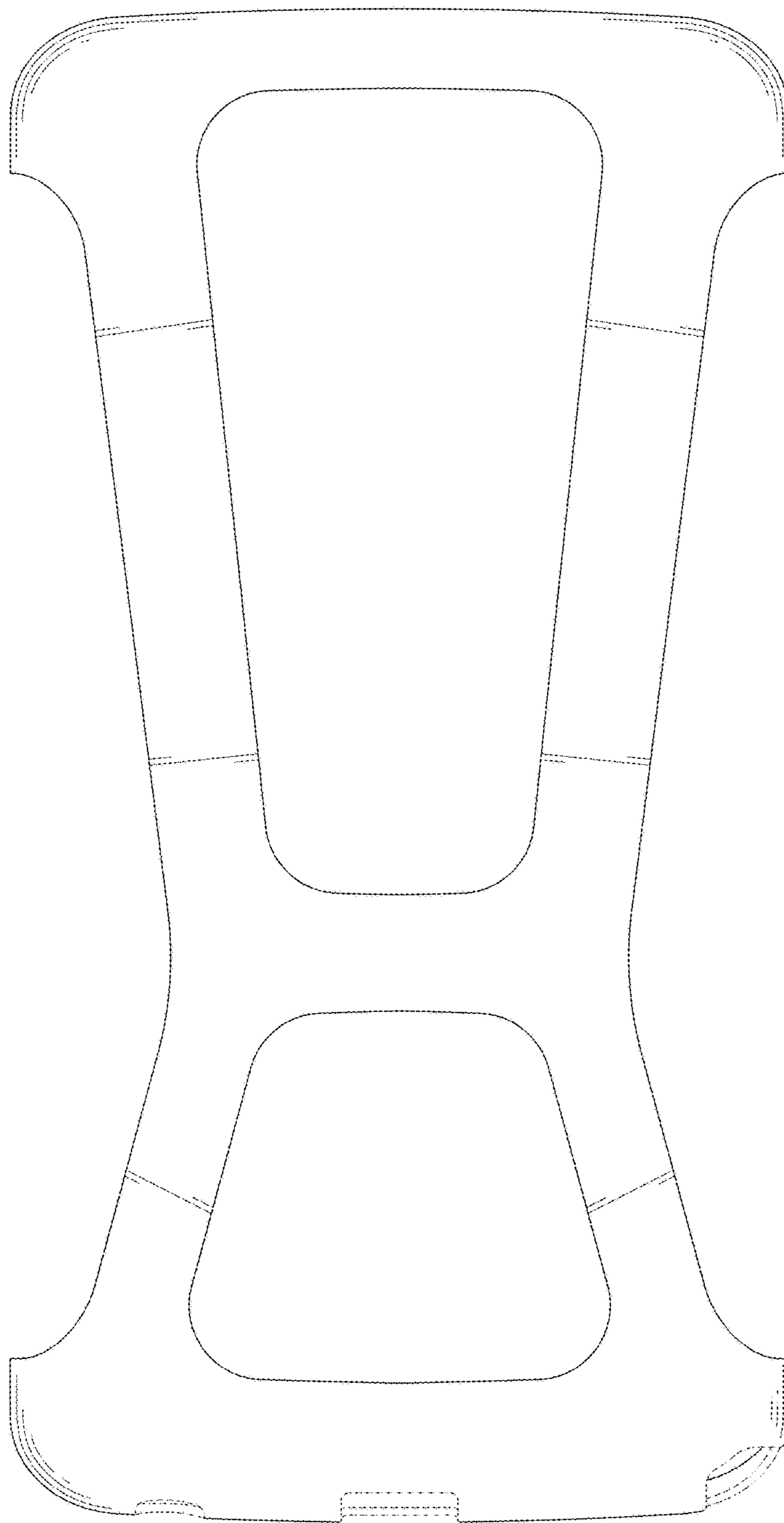

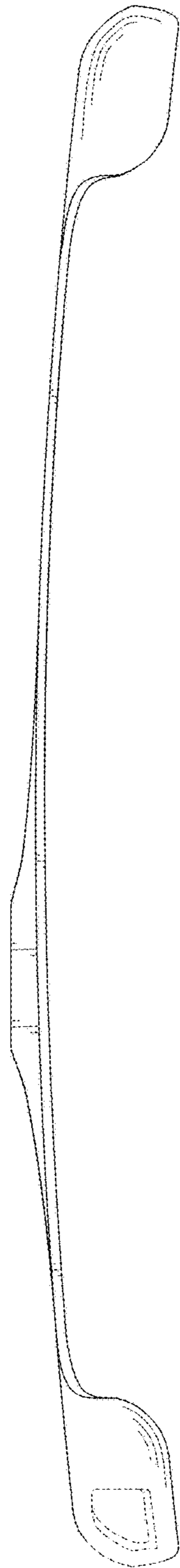

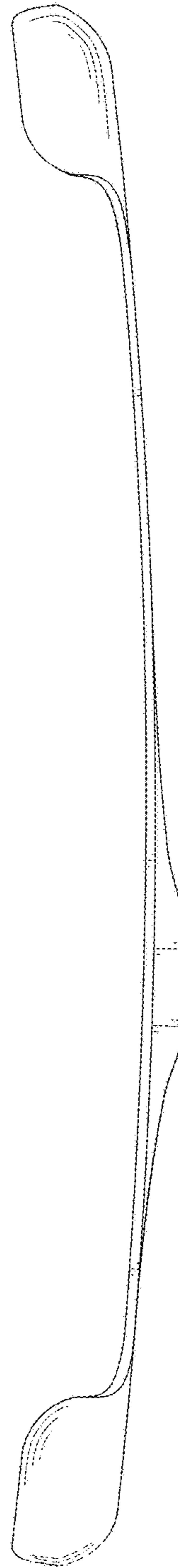

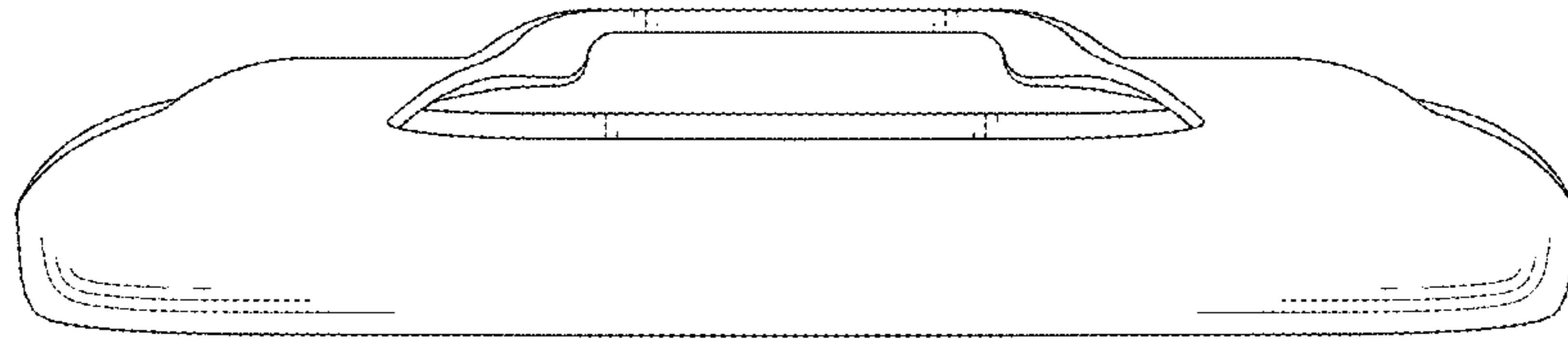

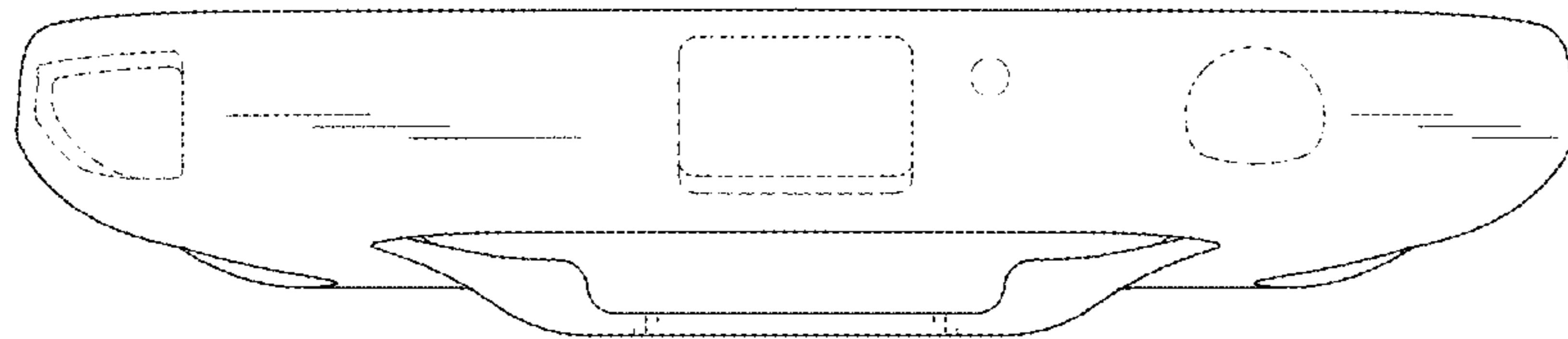
