(57) **CLAIM**

We claim the ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first image of a display panel or screen with an animated graphical user interface of our design;

FIG. 2 is a front elevational view of a second image thereof;

FIG. 3 is a front elevational view of a third image thereof;

FIG. 4 is a front elevational view of a fourth image thereof;

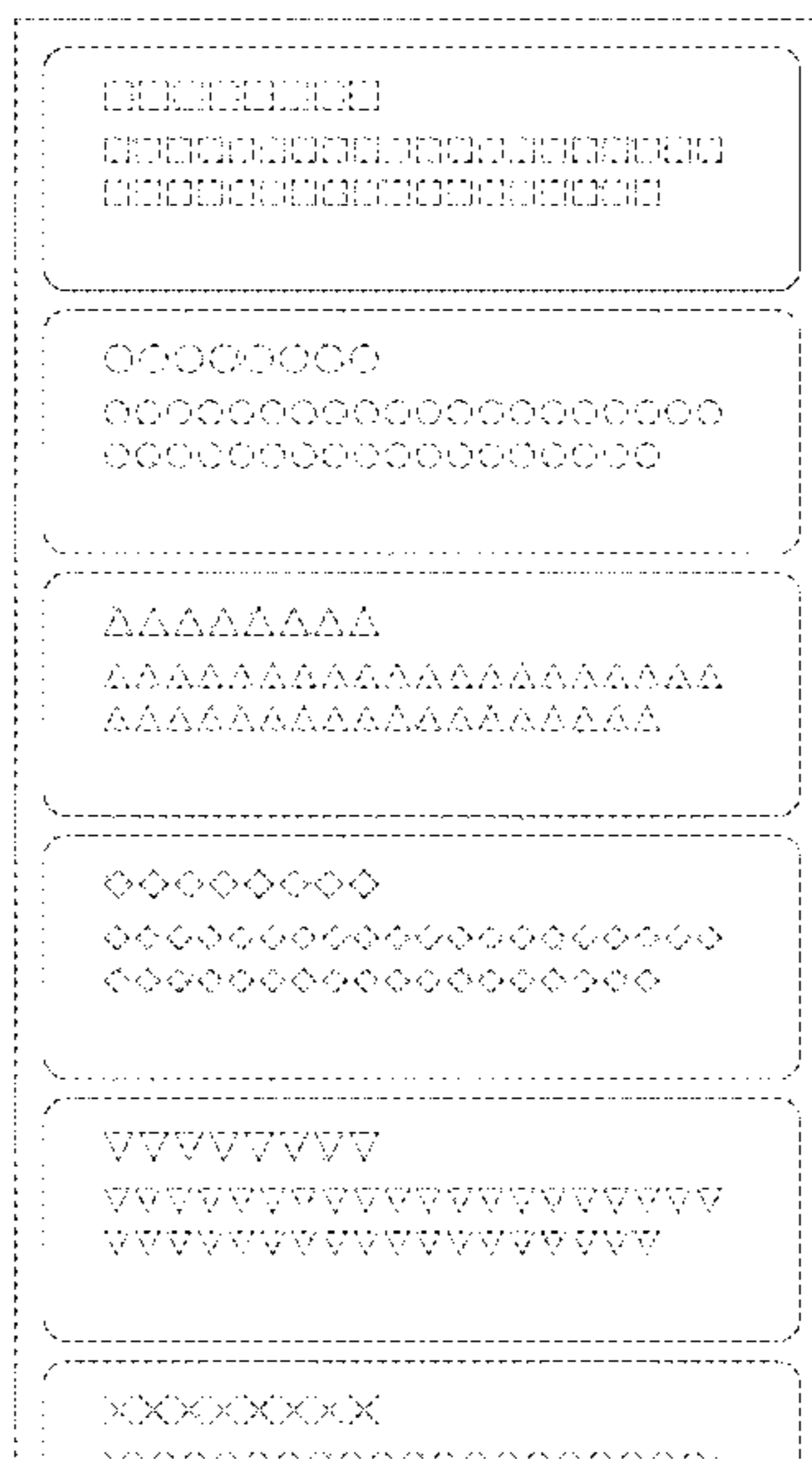
FIG. 5 is a front elevational view of a fifth image thereof; and,

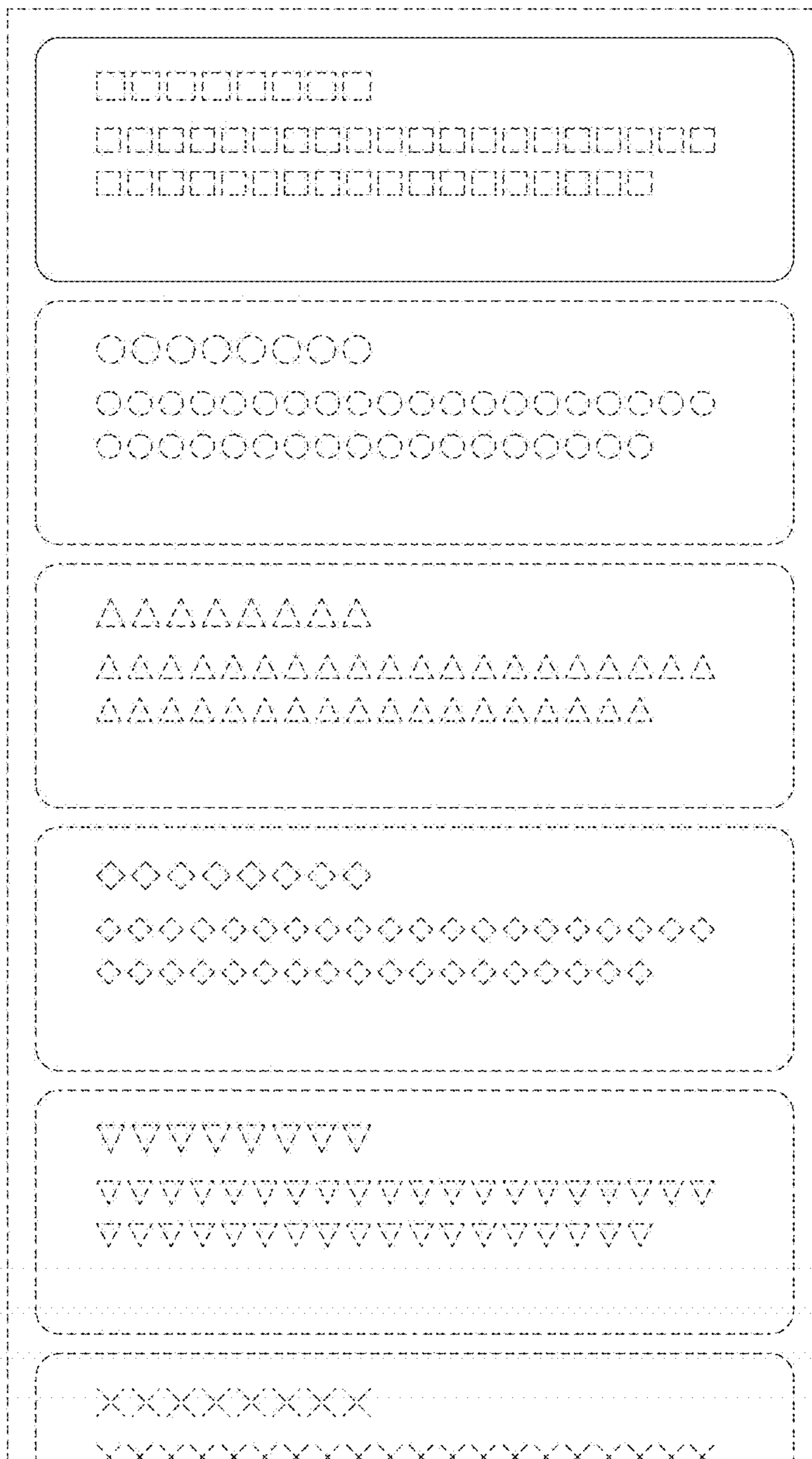

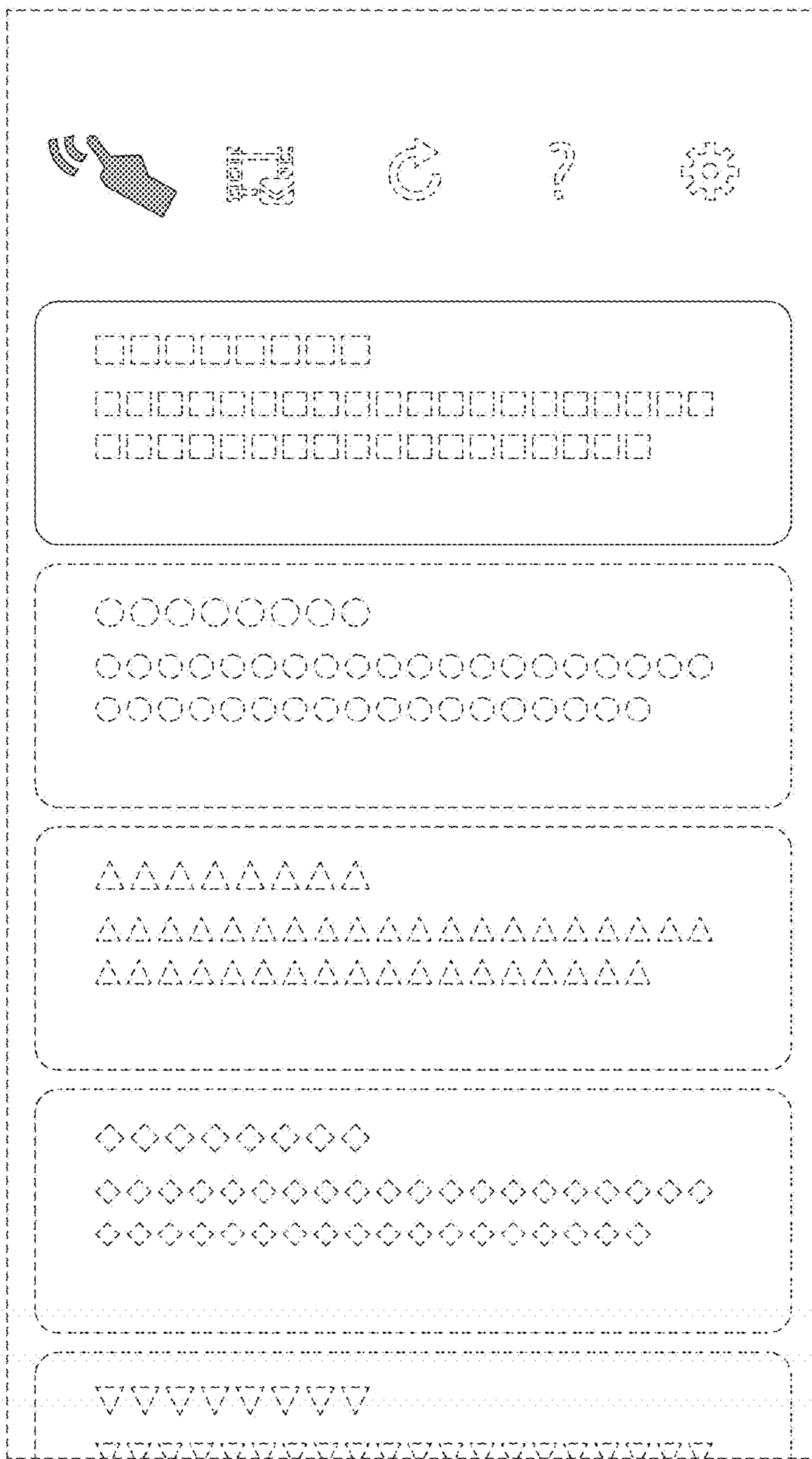

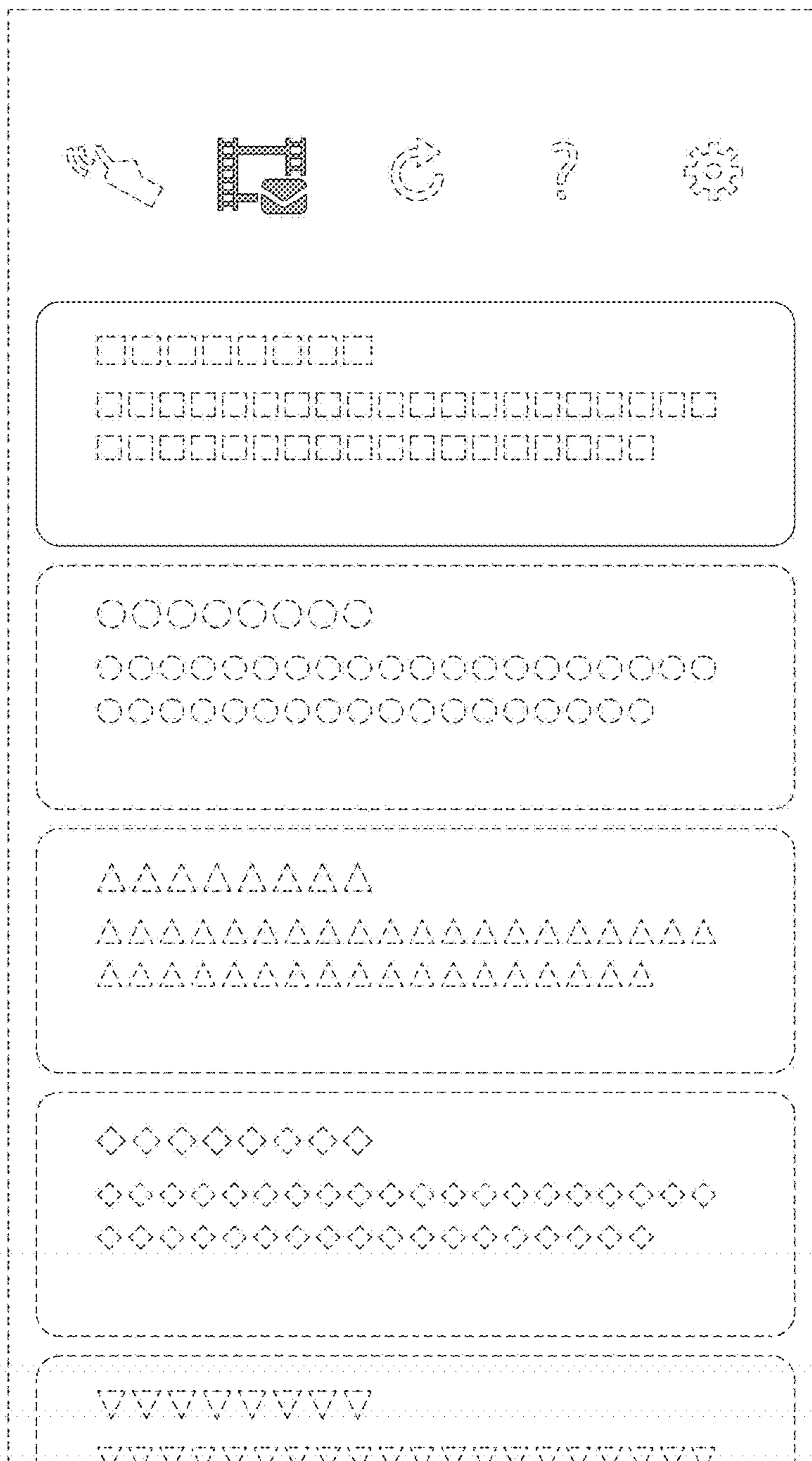

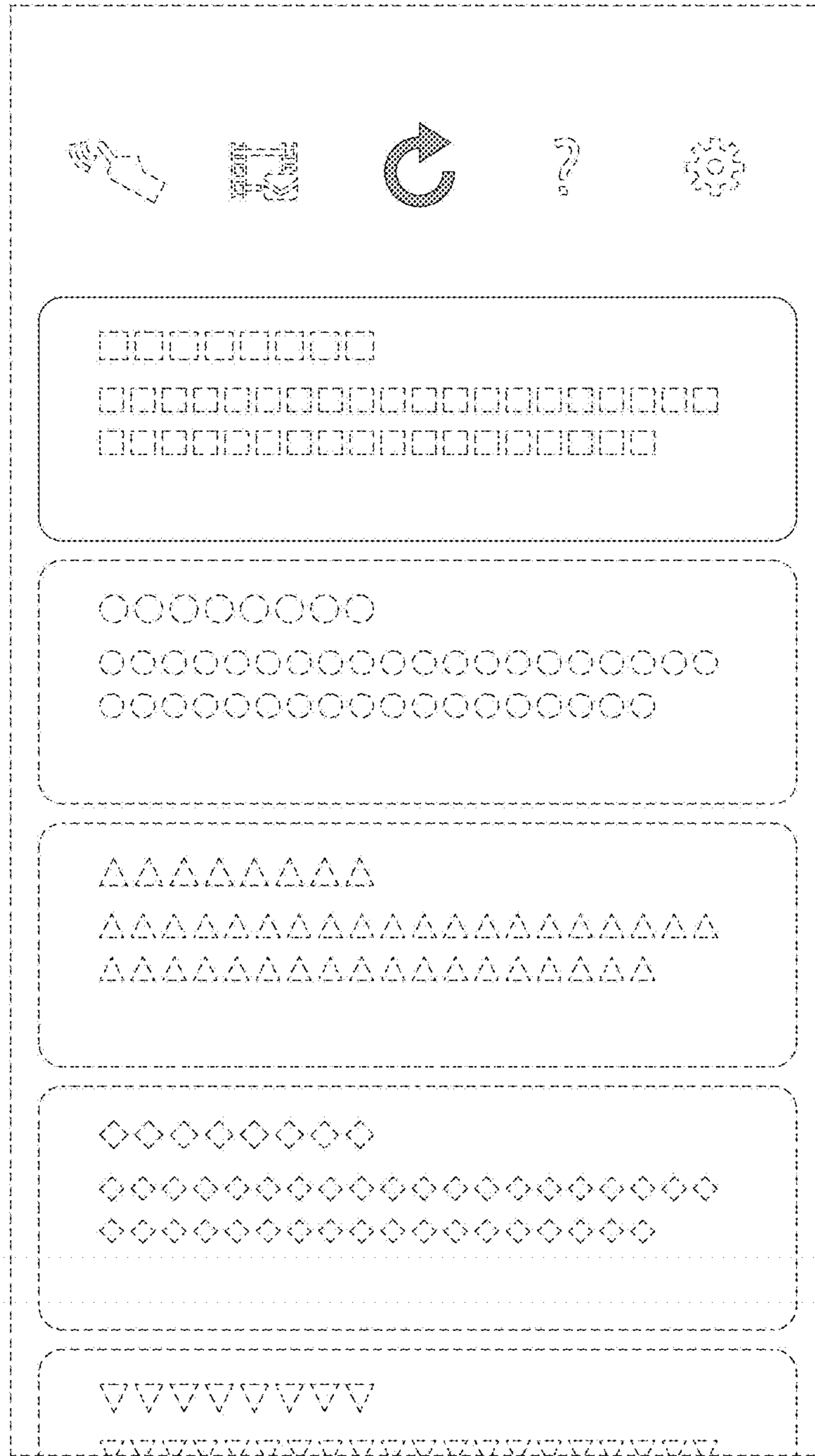

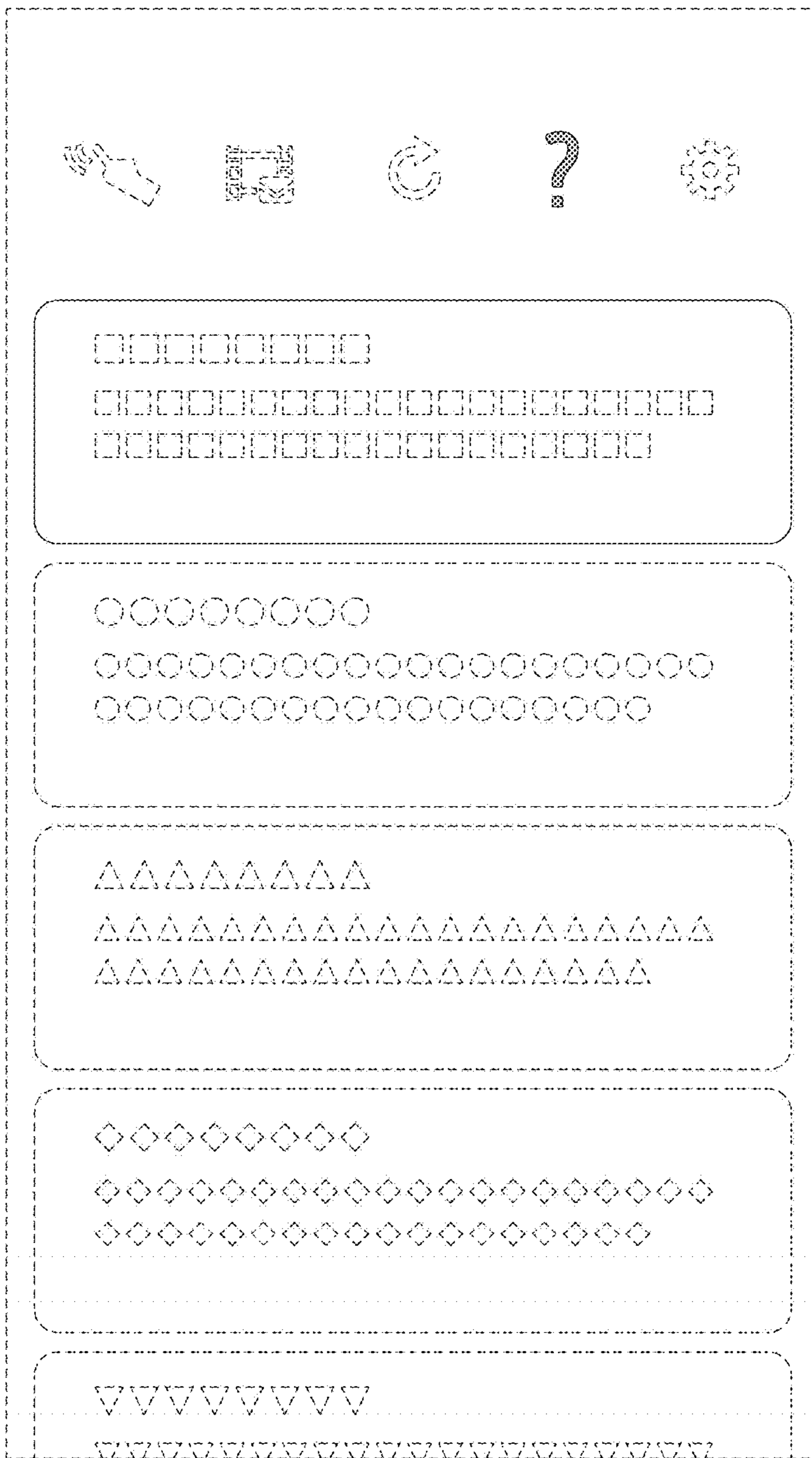
