(57) **CLAIM**

The ornamental design for a display screen or a portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a first image of a first embodiment of a display screen or a portion thereof with an animated graphical user interface;

FIG. 2 is a second image of the first embodiment of a display screen or a portion thereof with an animated graphical user interface;

FIG. 3 is a first image of a second embodiment of a display screen or a portion thereof with an animated graphical user interface;

FIG. 4 is a second image of the second embodiment of a display screen or a portion thereof with an animated graphical user interface;

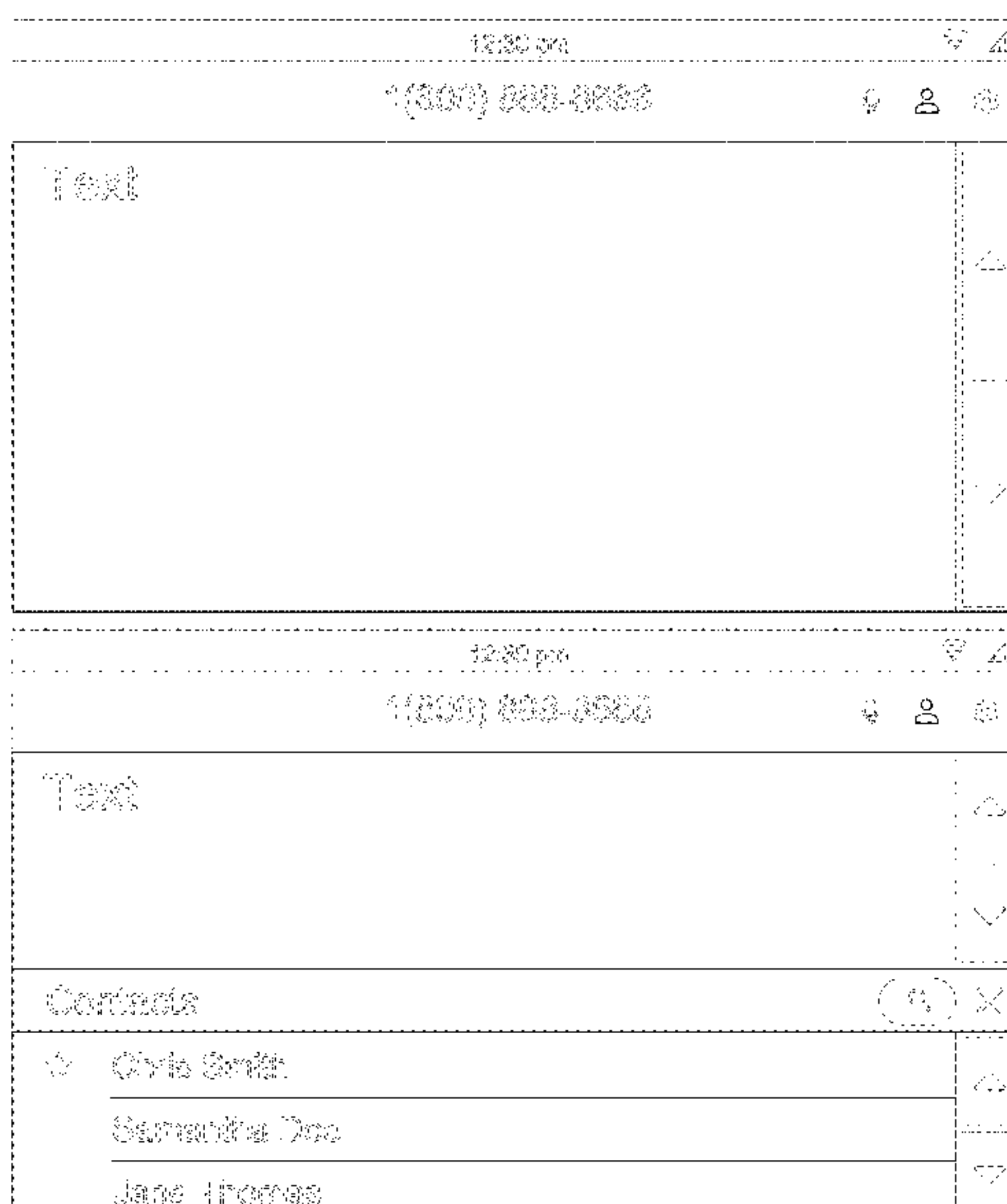
FIG. 5 is a first image of a third embodiment of a display screen or a portion thereof with an animated graphical user interface; and,

FIG. 6 is a second image of the third embodiment of a display screen or a portion thereof with an animated graphical user interface.

The broken line showing a display screen or a portion thereof, as well as the text, symbols, and portions of the graphical user interface are included for the purpose of illustrating portions of the article and form no part of the claimed design.

The appearance of the animated graphical user interface sequentially transitions between FIGS. 1 and 2 in embodiment 1, FIGS. 3 and 4 in embodiment 2, and FIGS. 5 and 6 in embodiment 3. The process or period in which one image transitions to another forms no part of the claimed design.

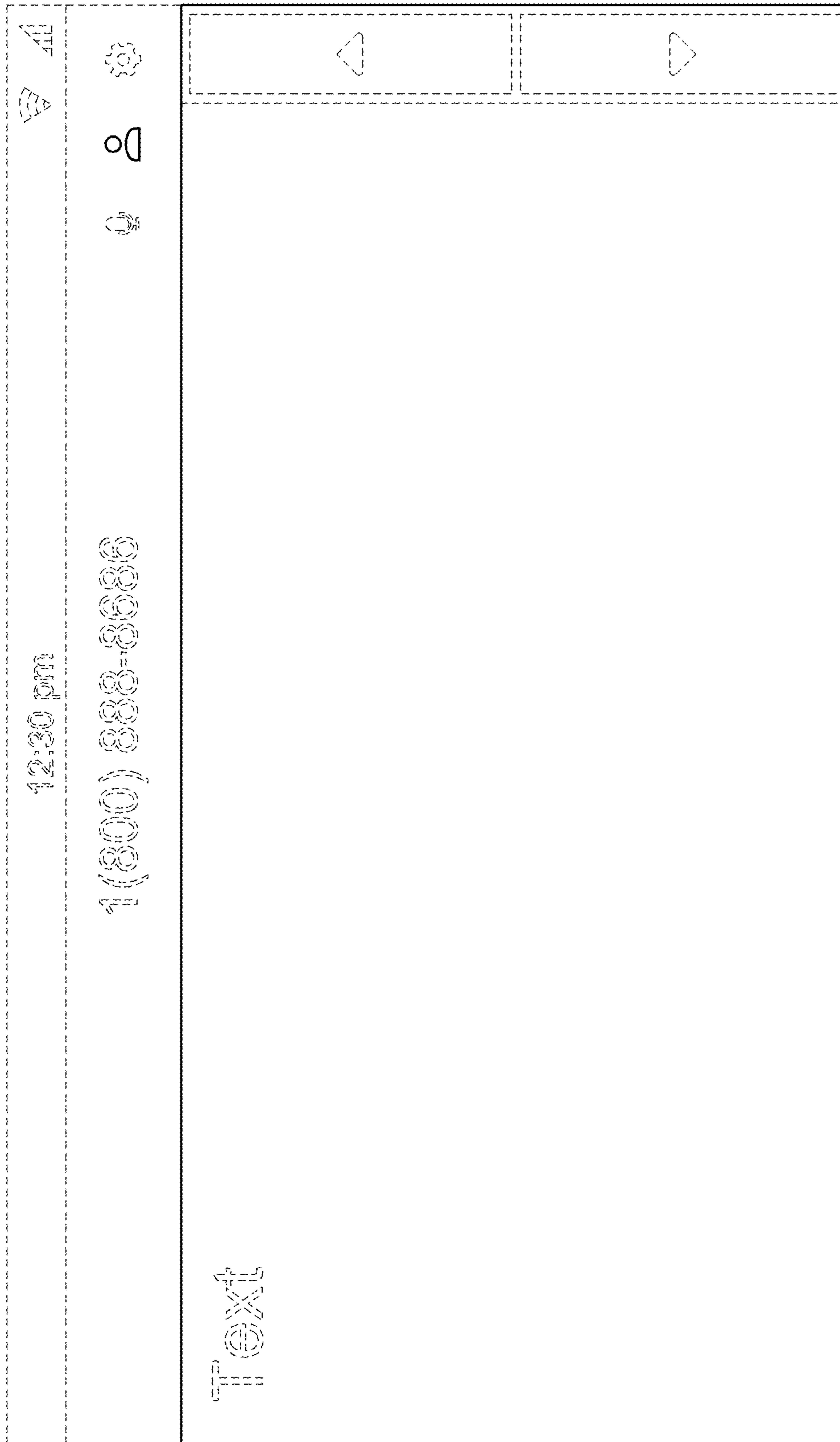

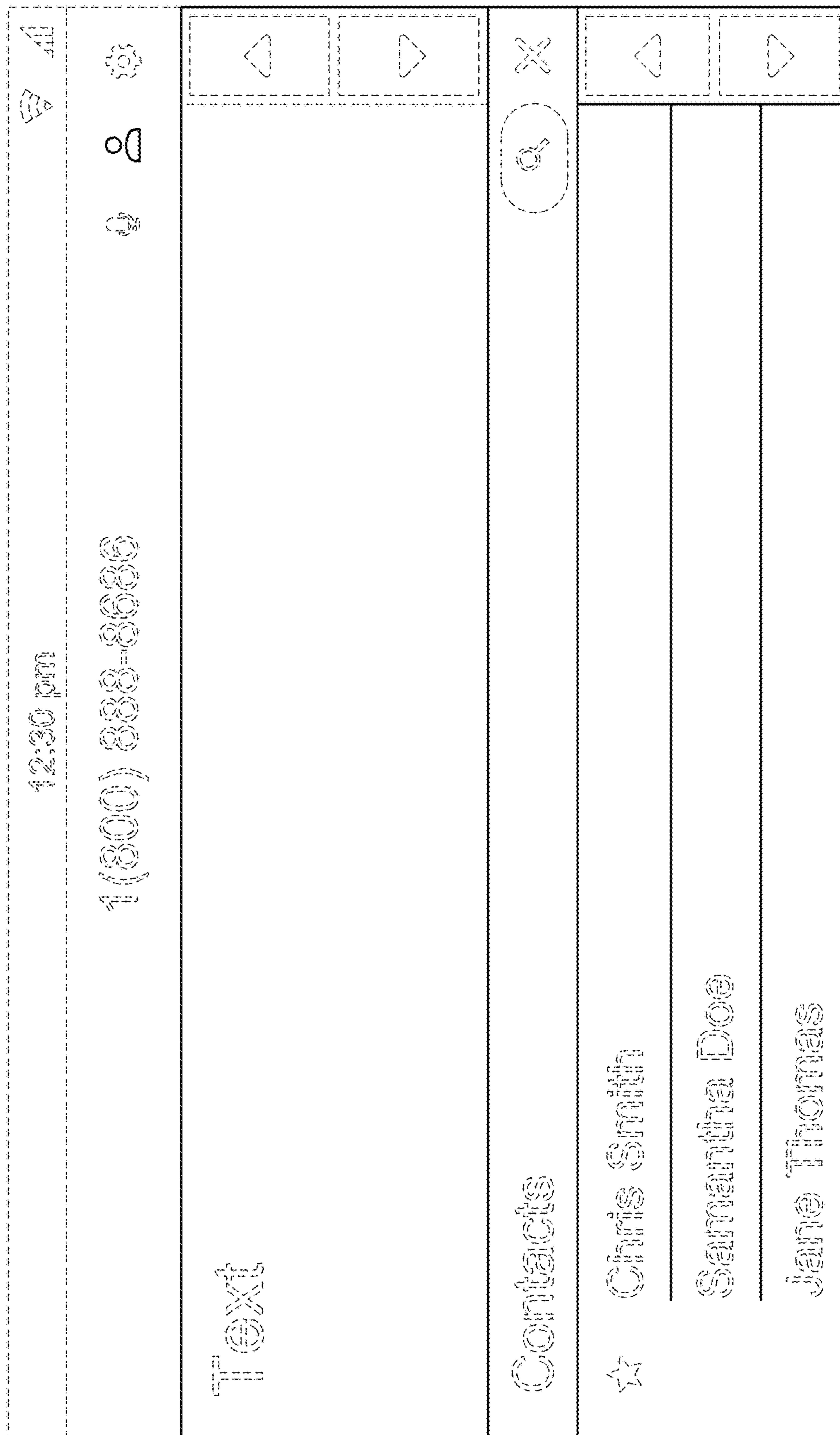

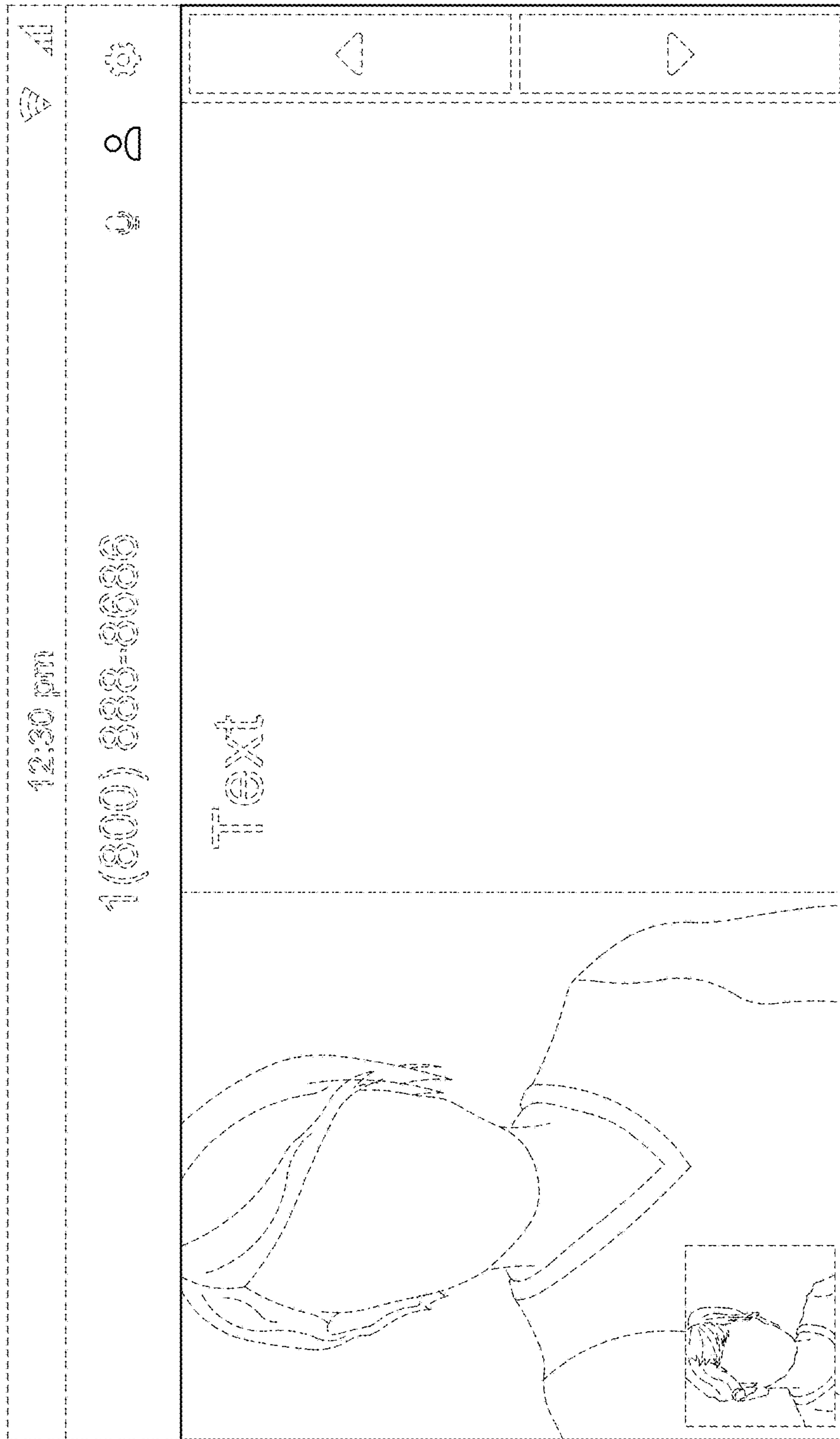

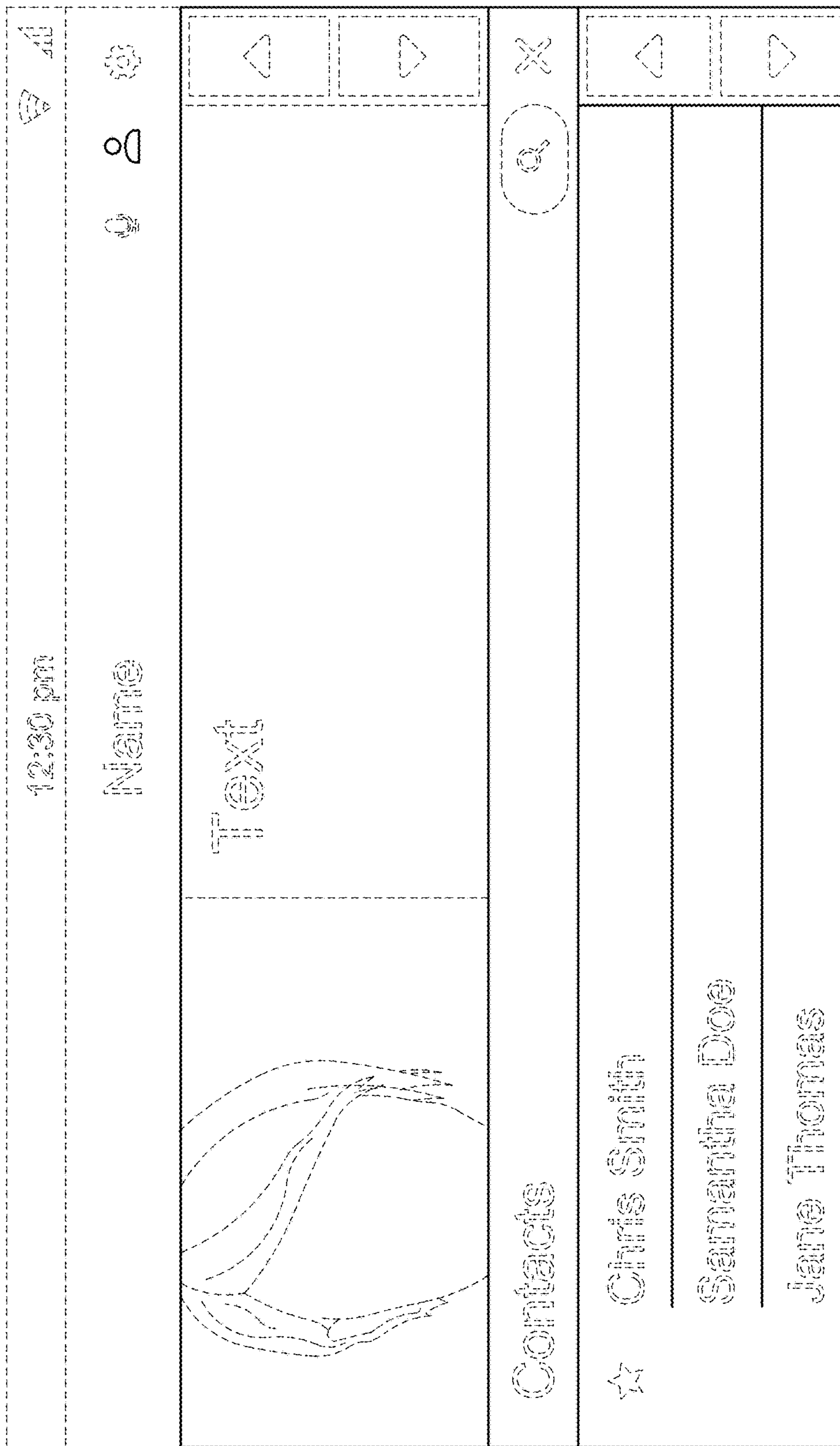

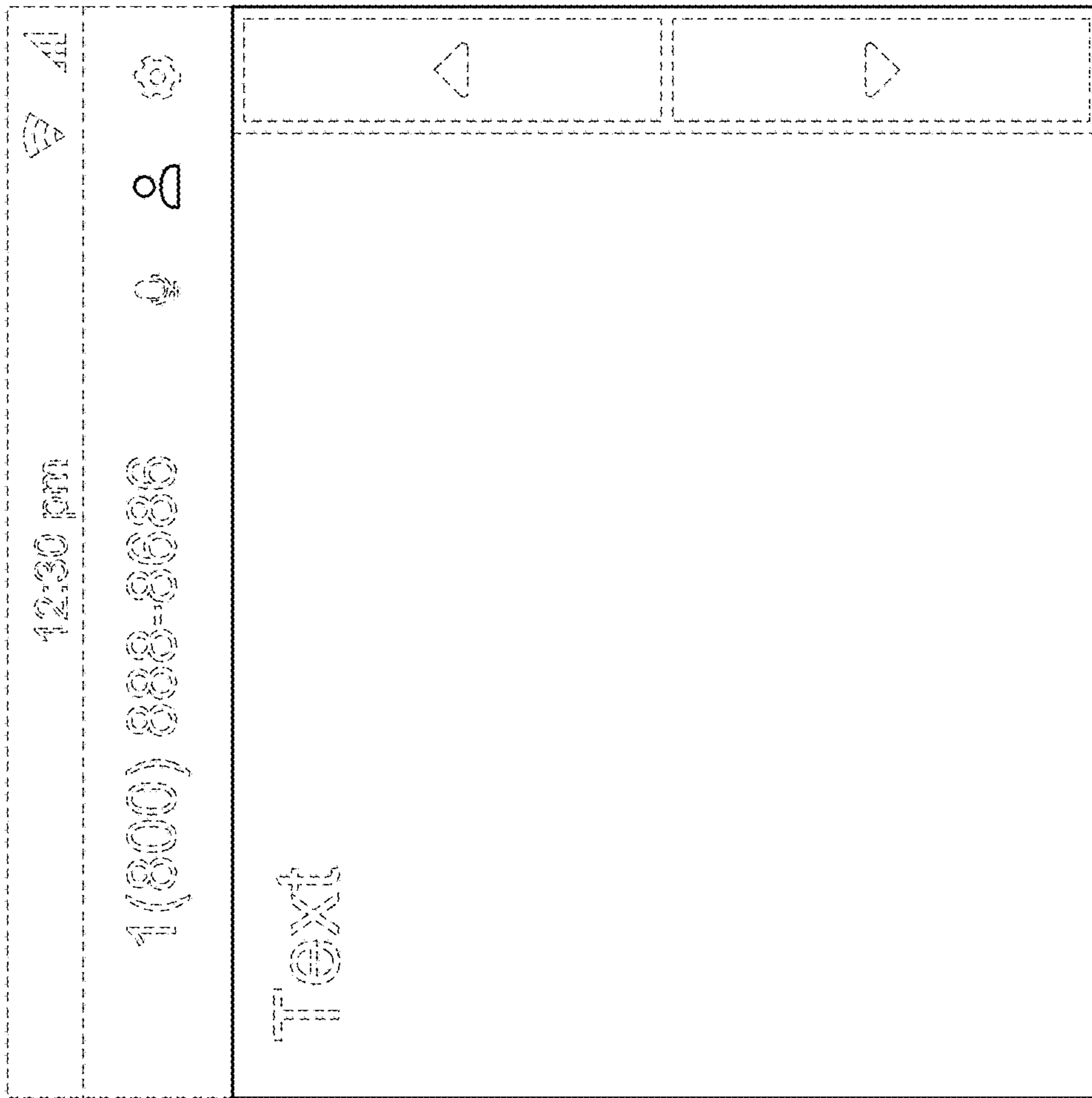

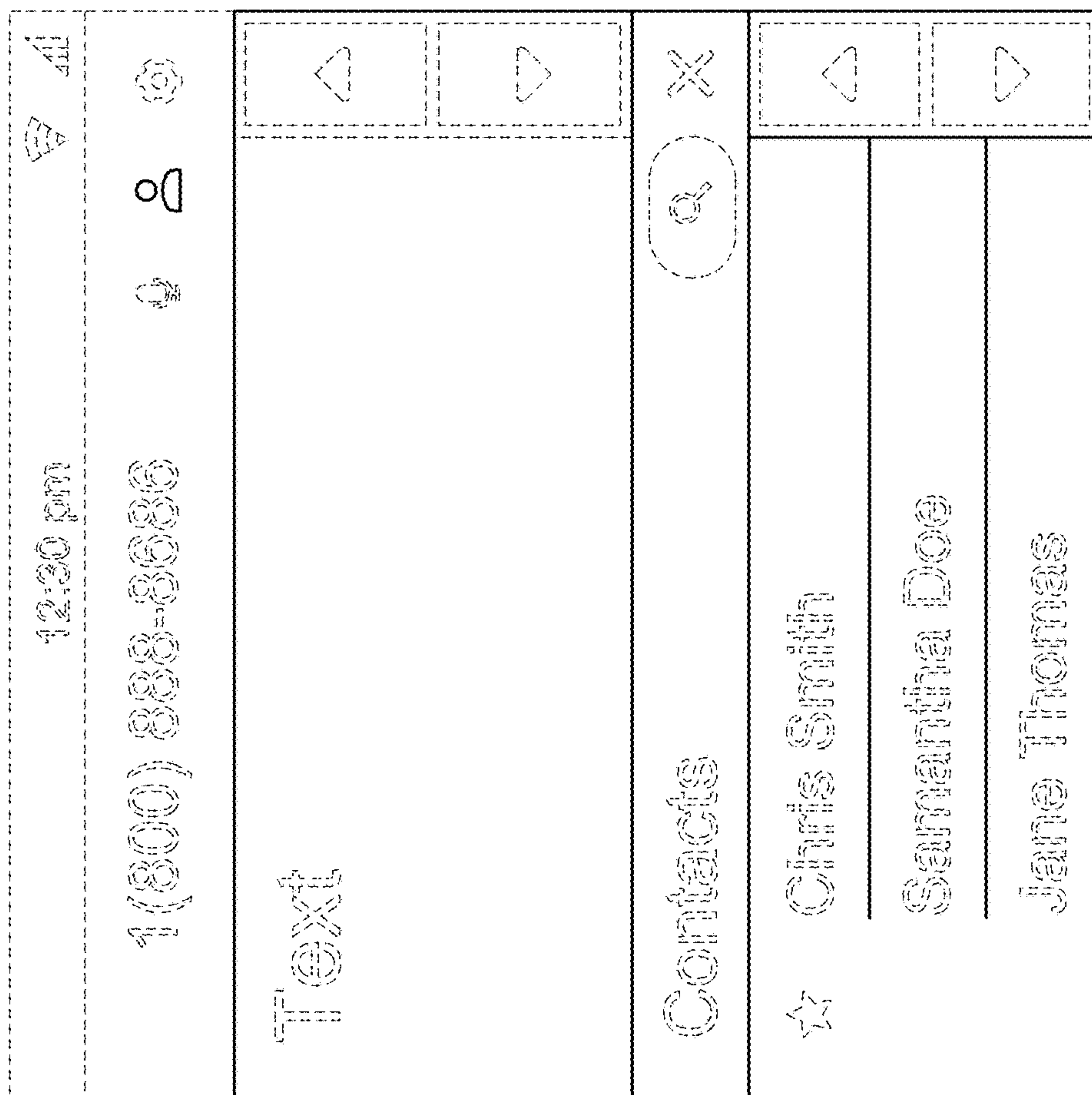
