FIG. 11 is a front view of a fourth image thereof;

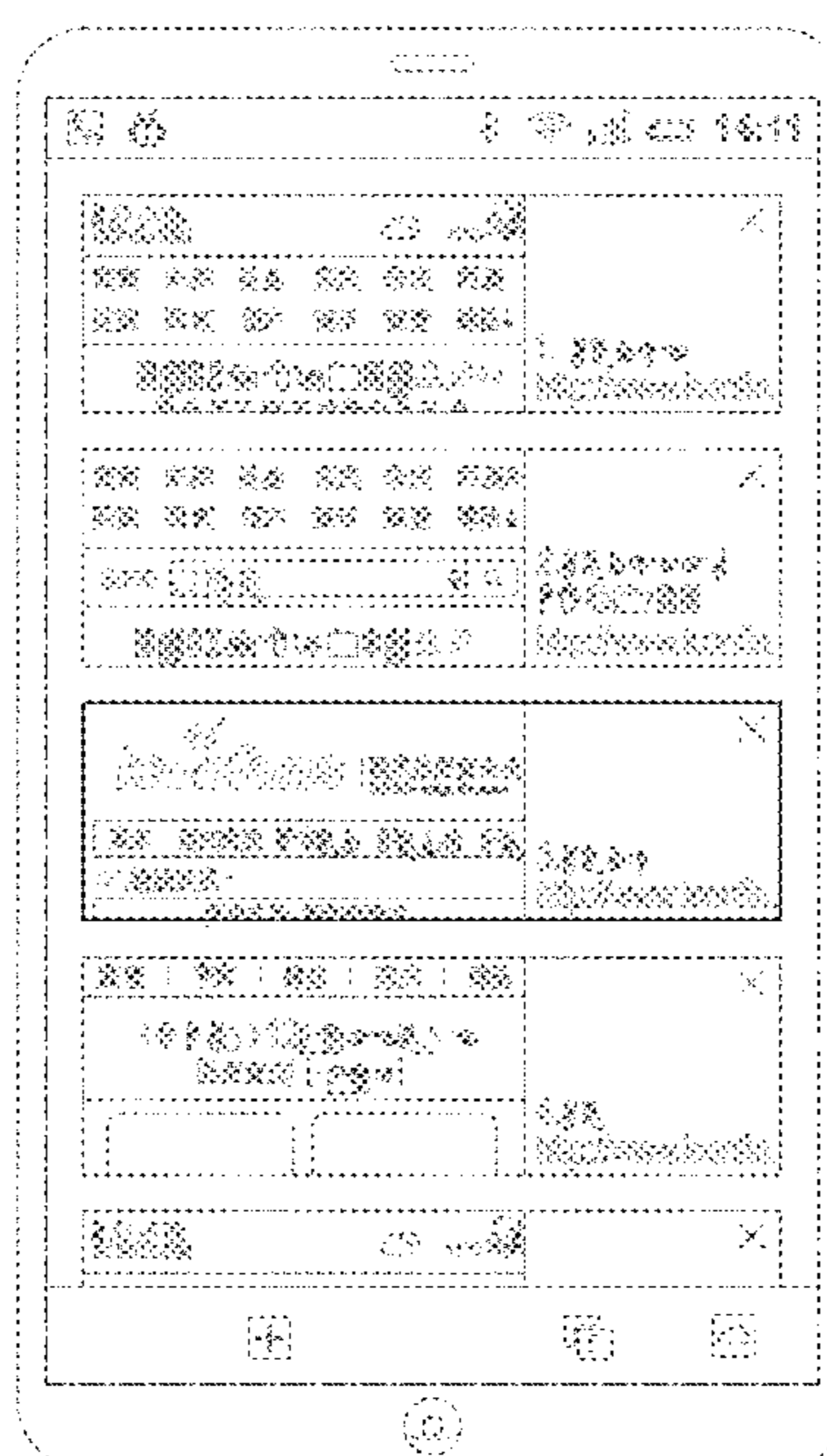
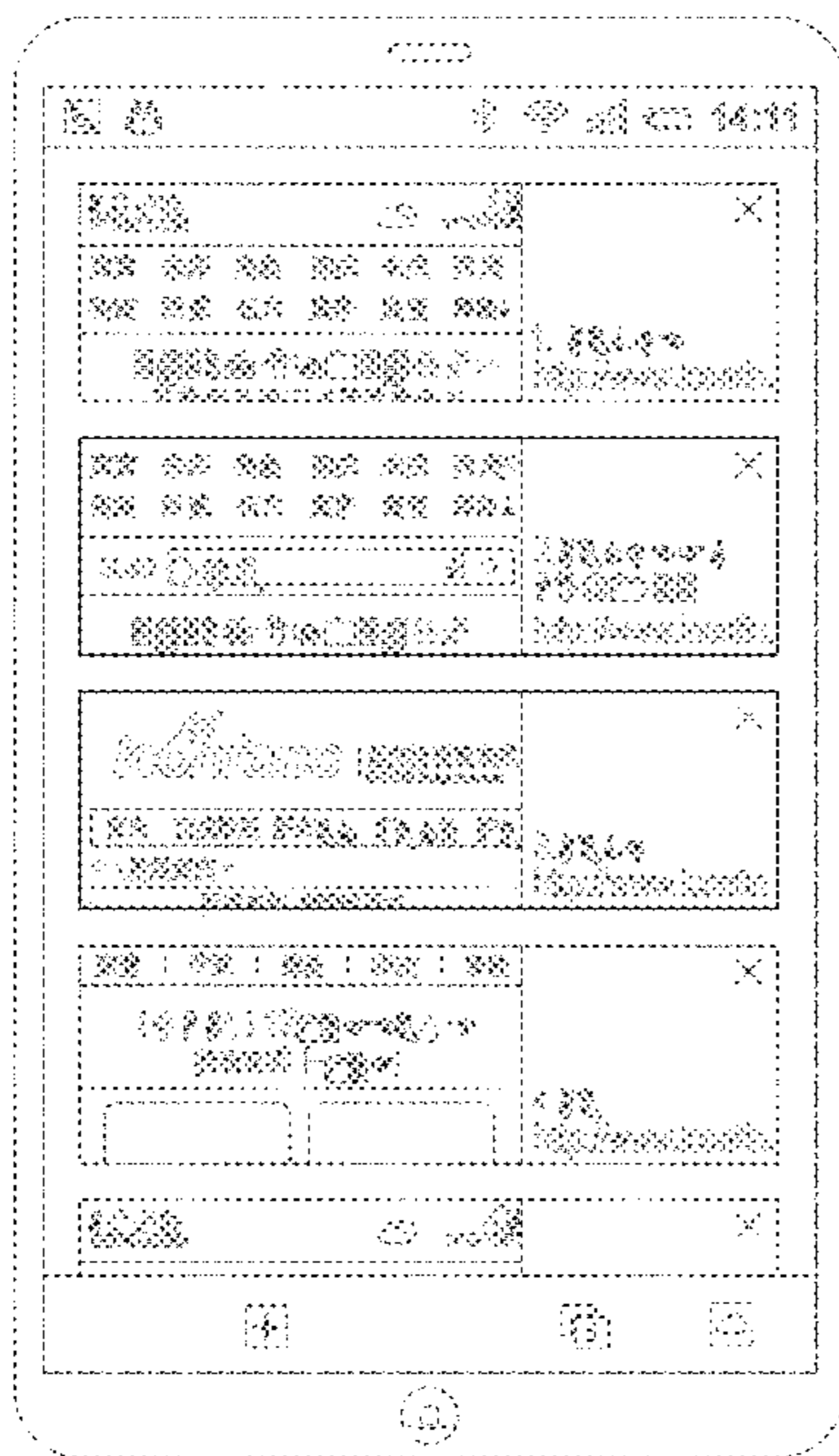
FIG. 12 is a front view of a fifth image thereof;

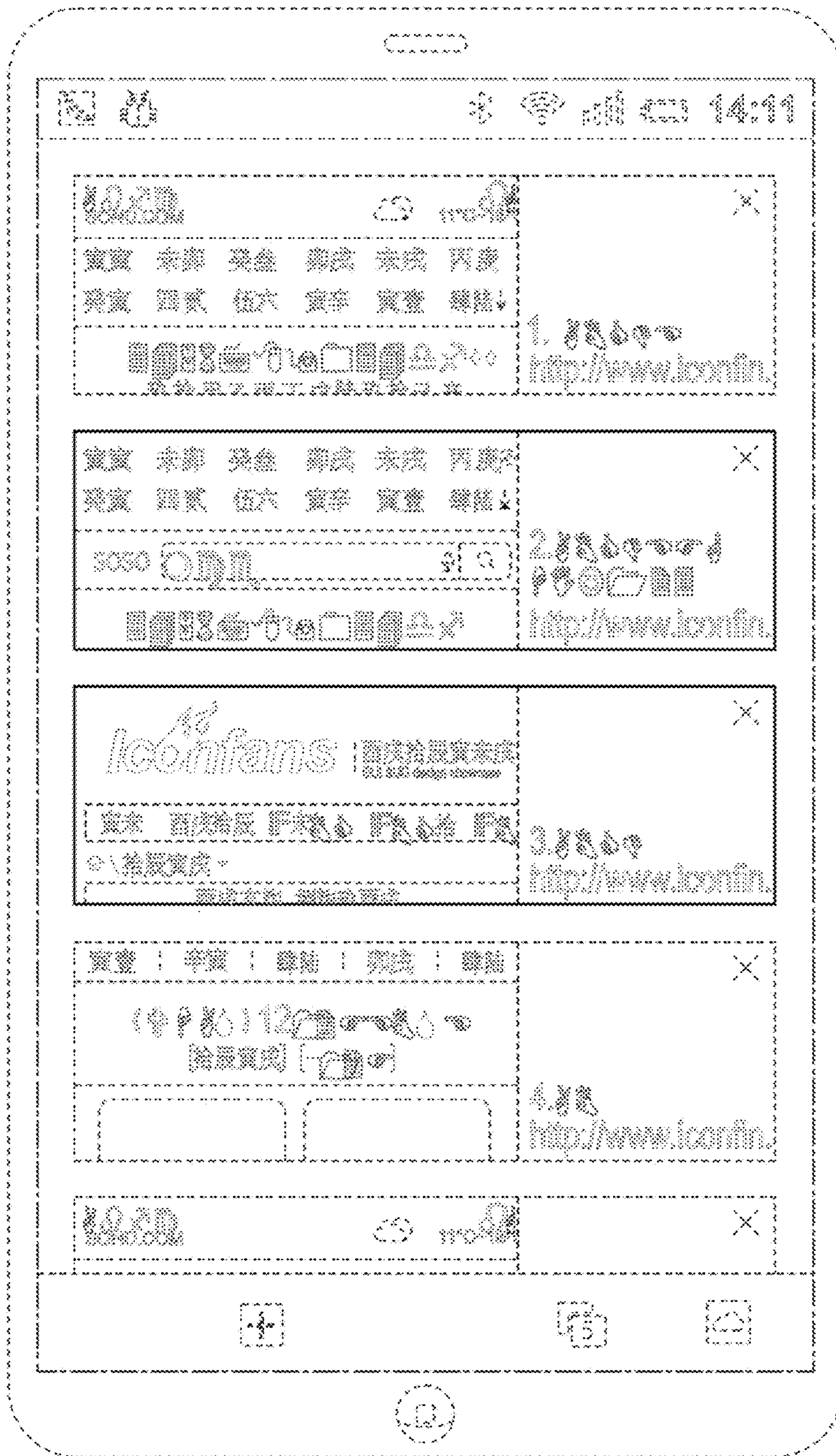

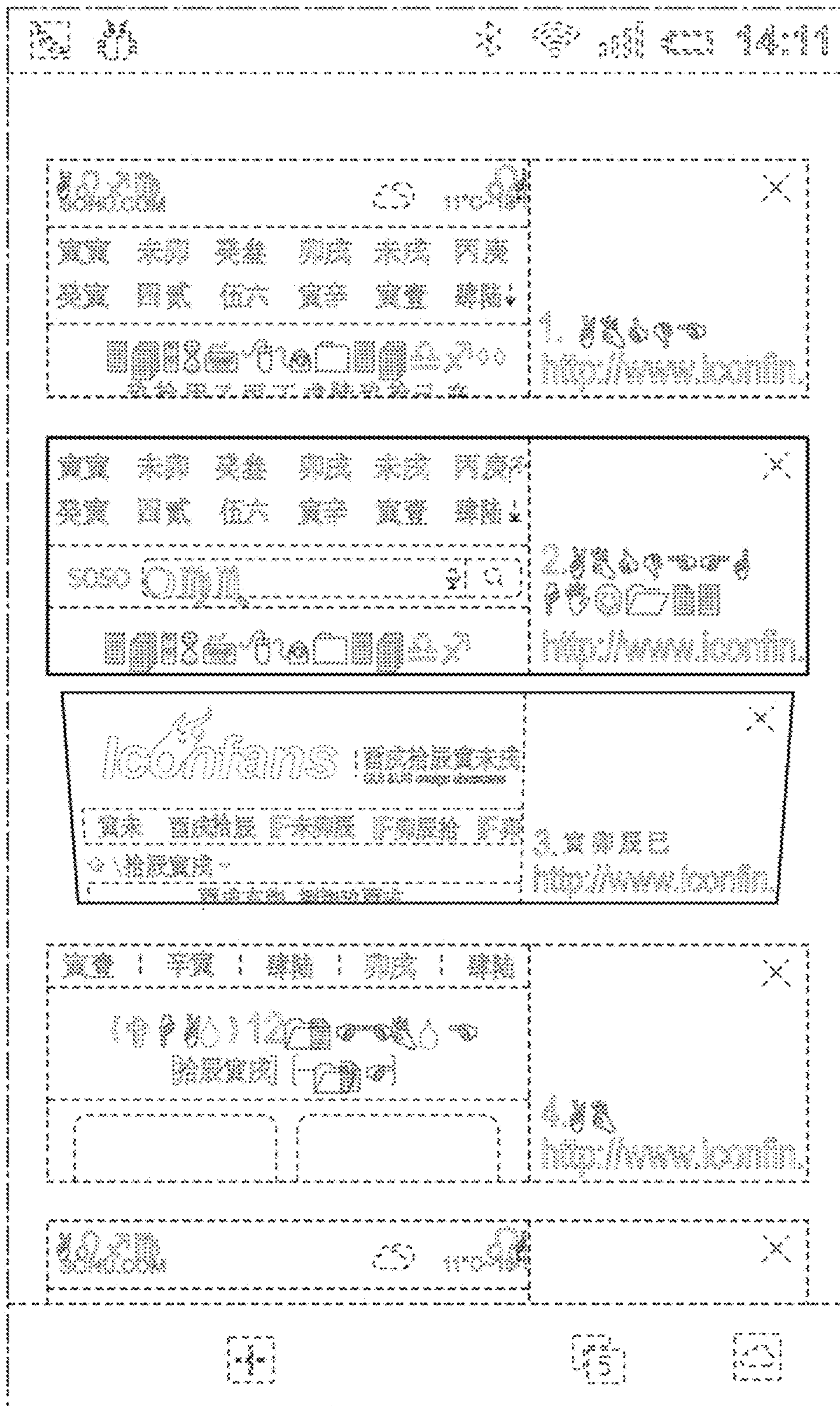

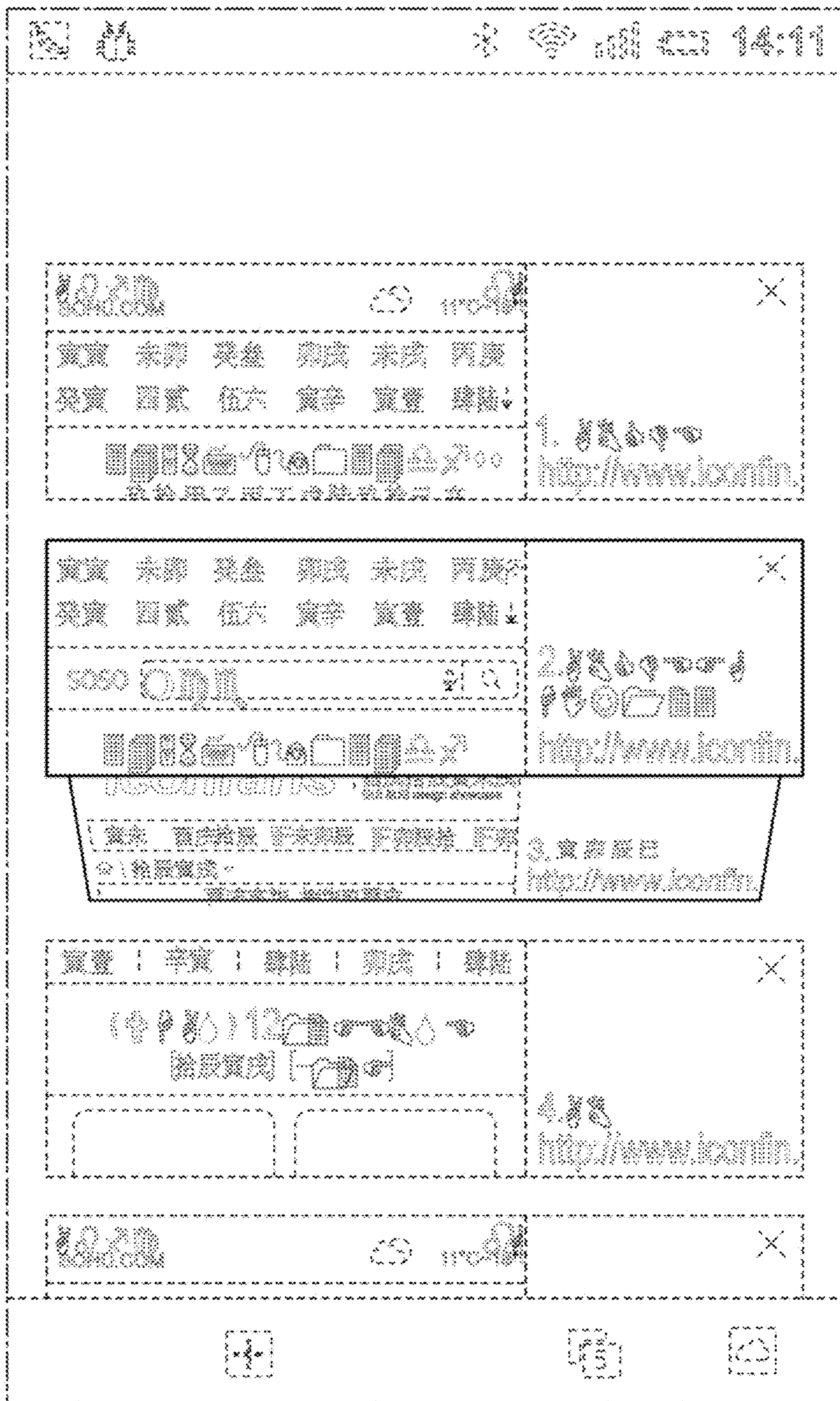

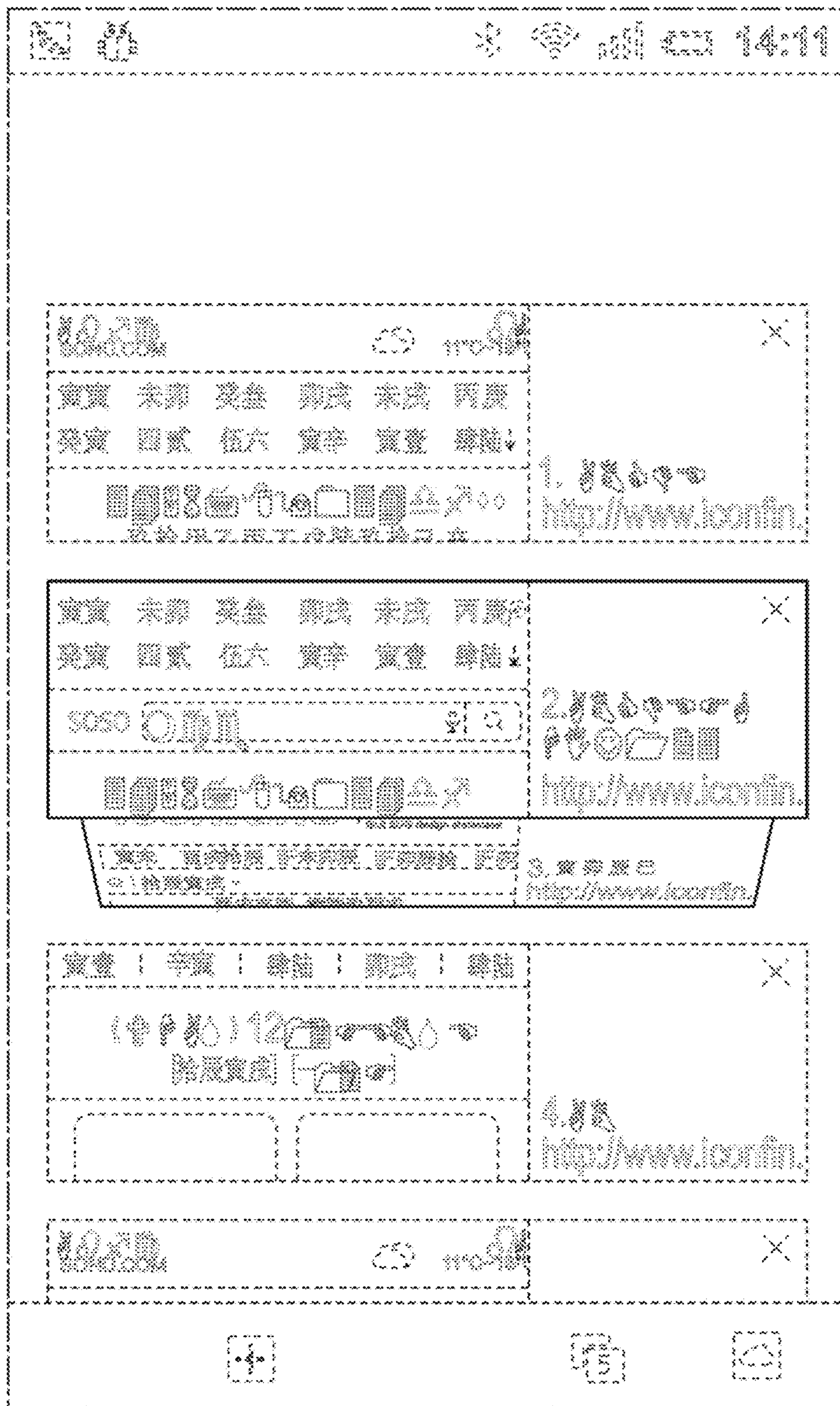

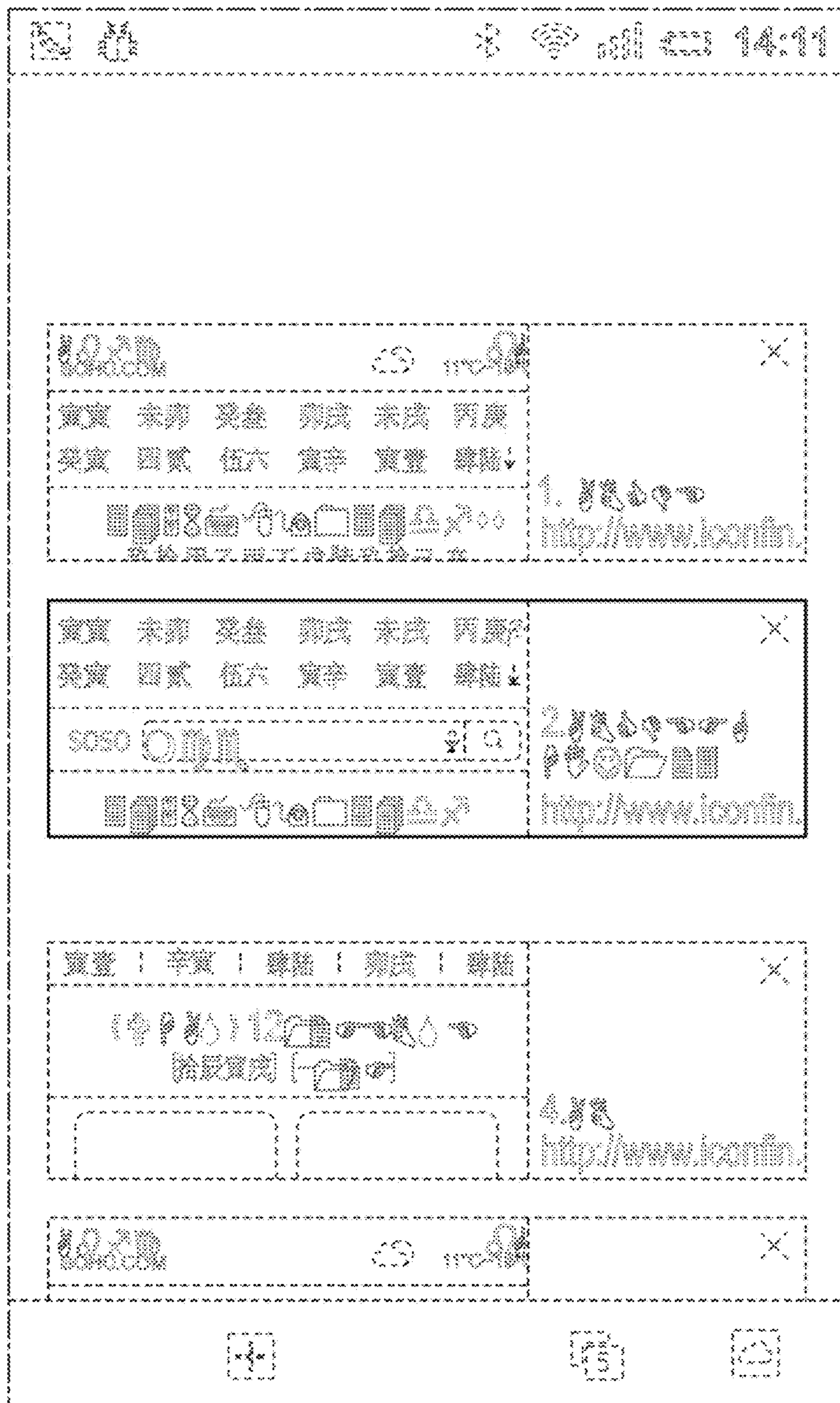

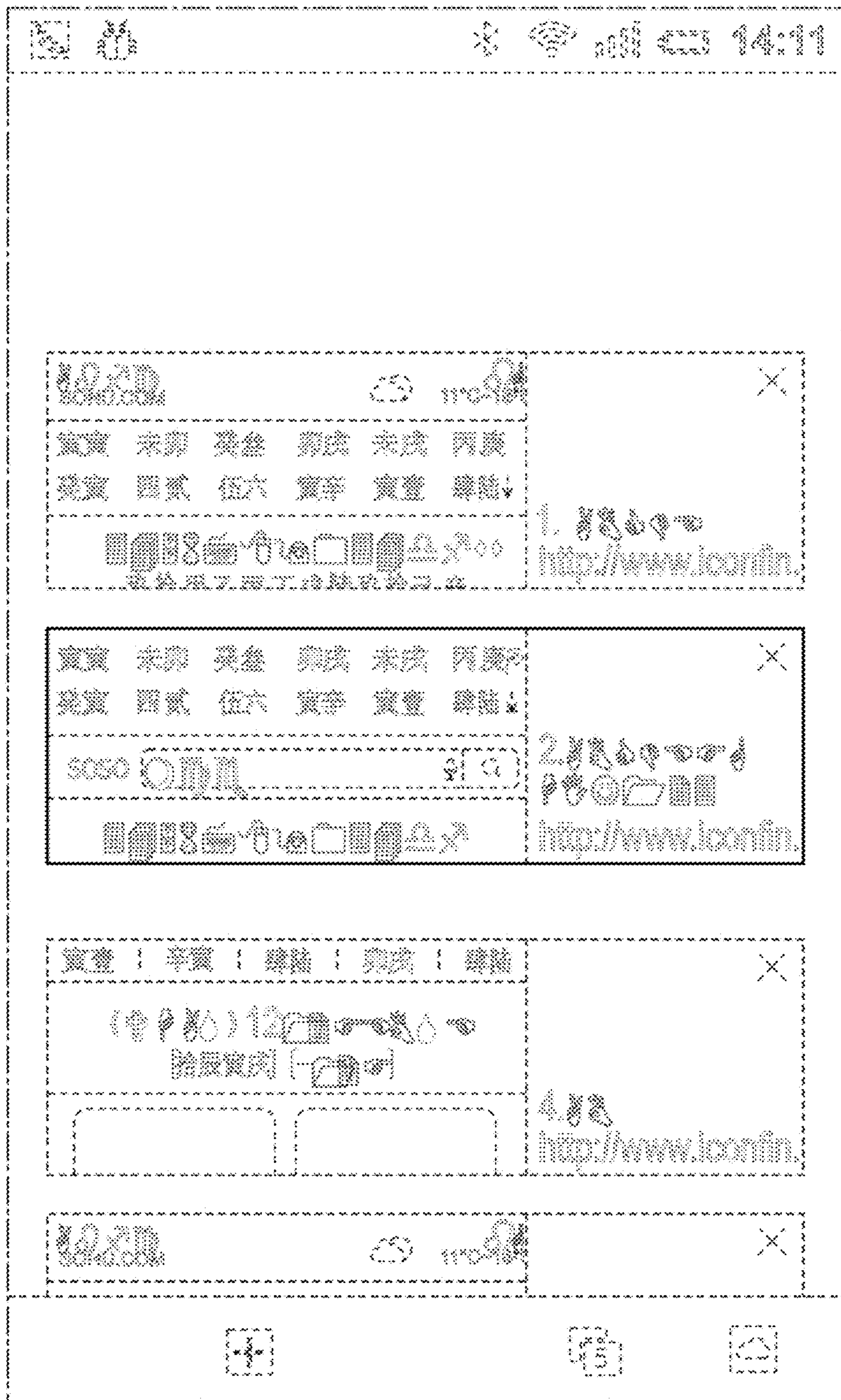

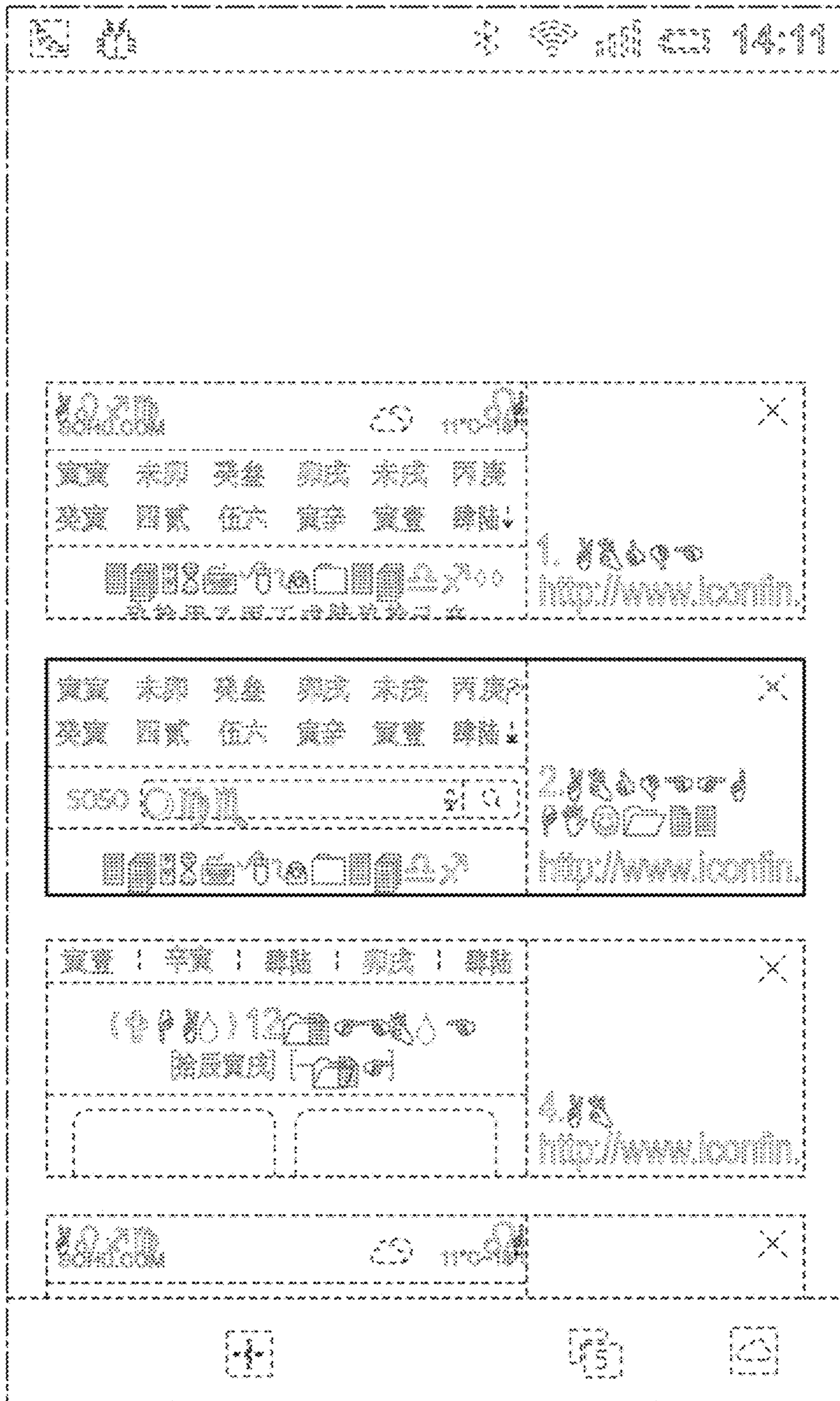

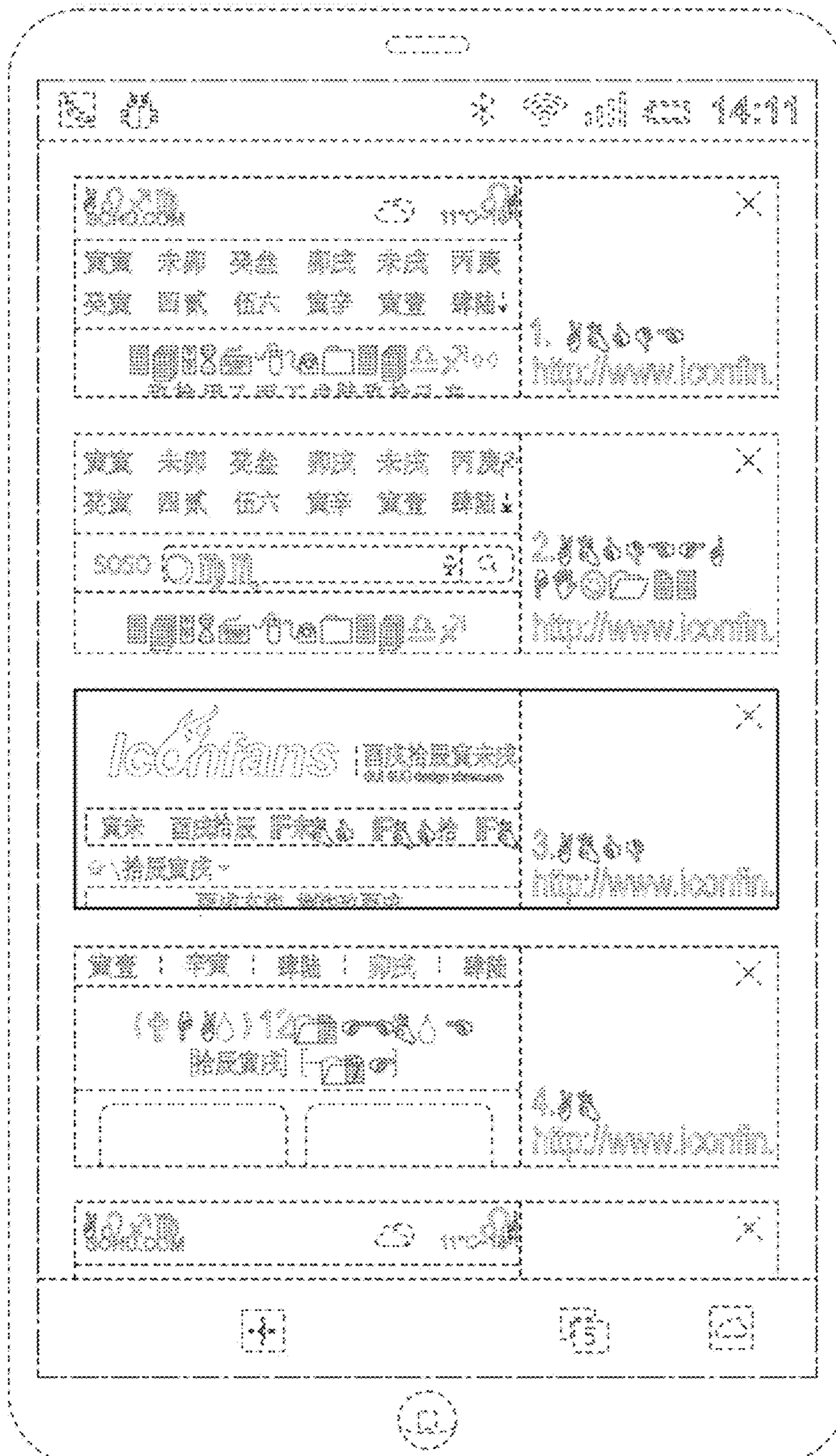

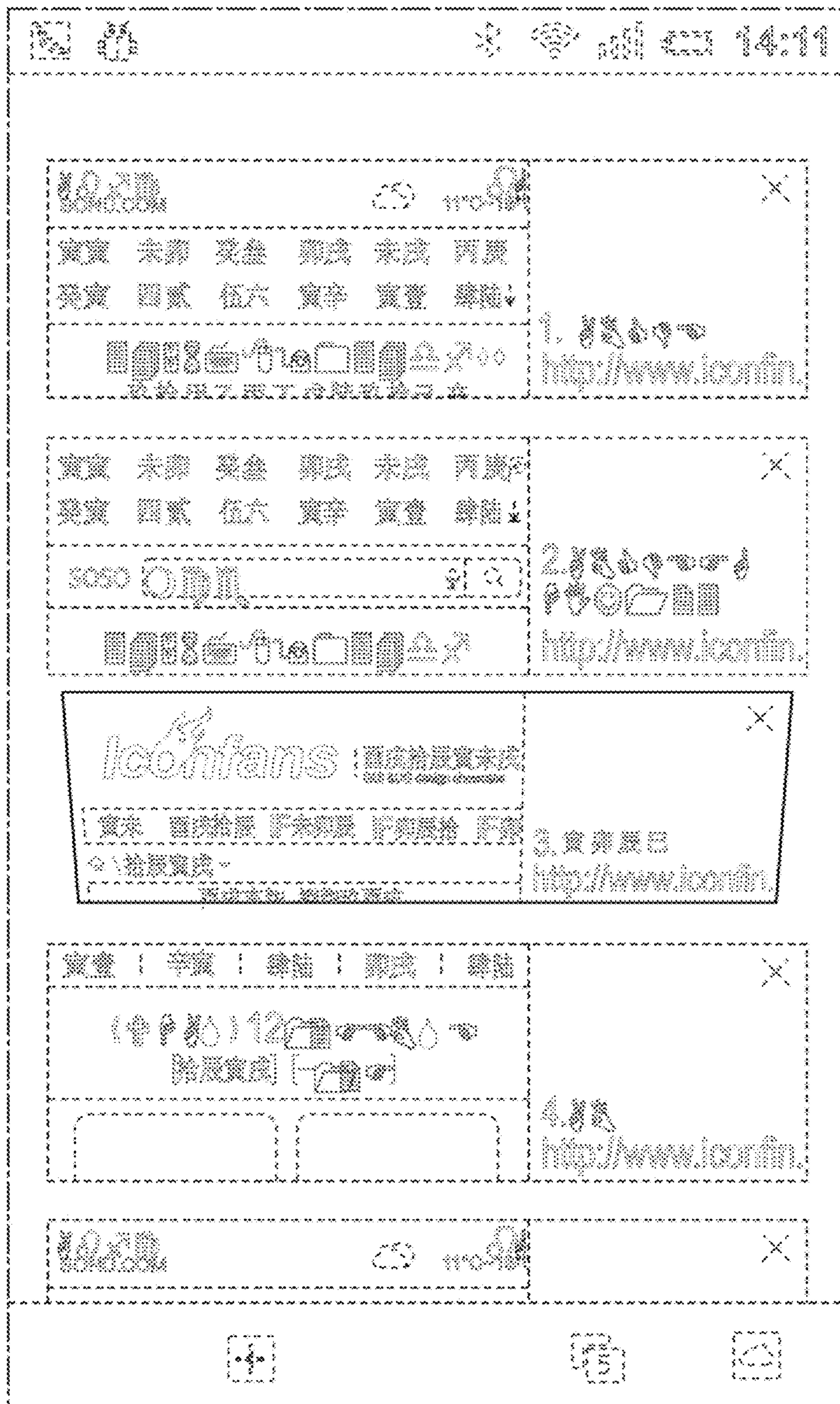

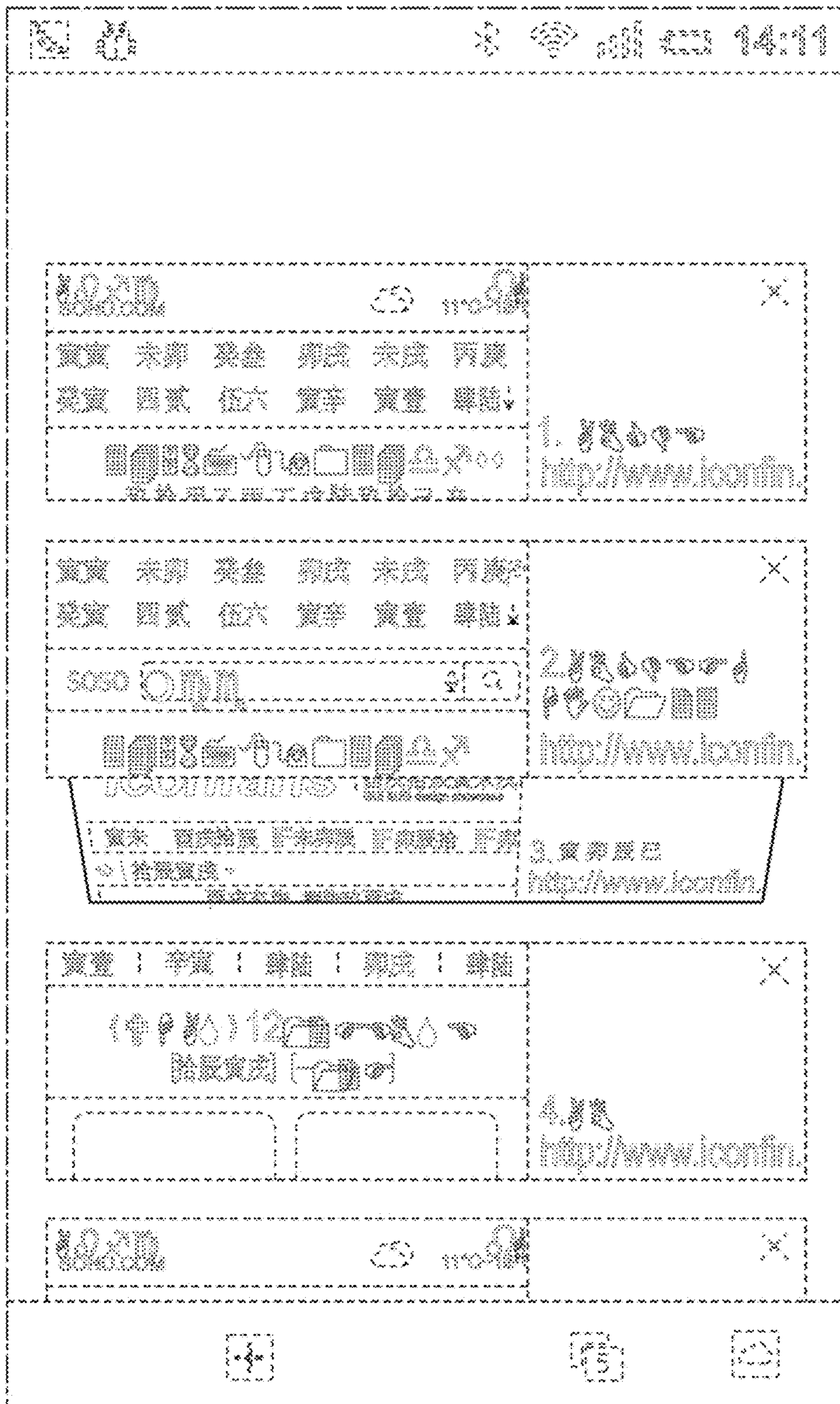

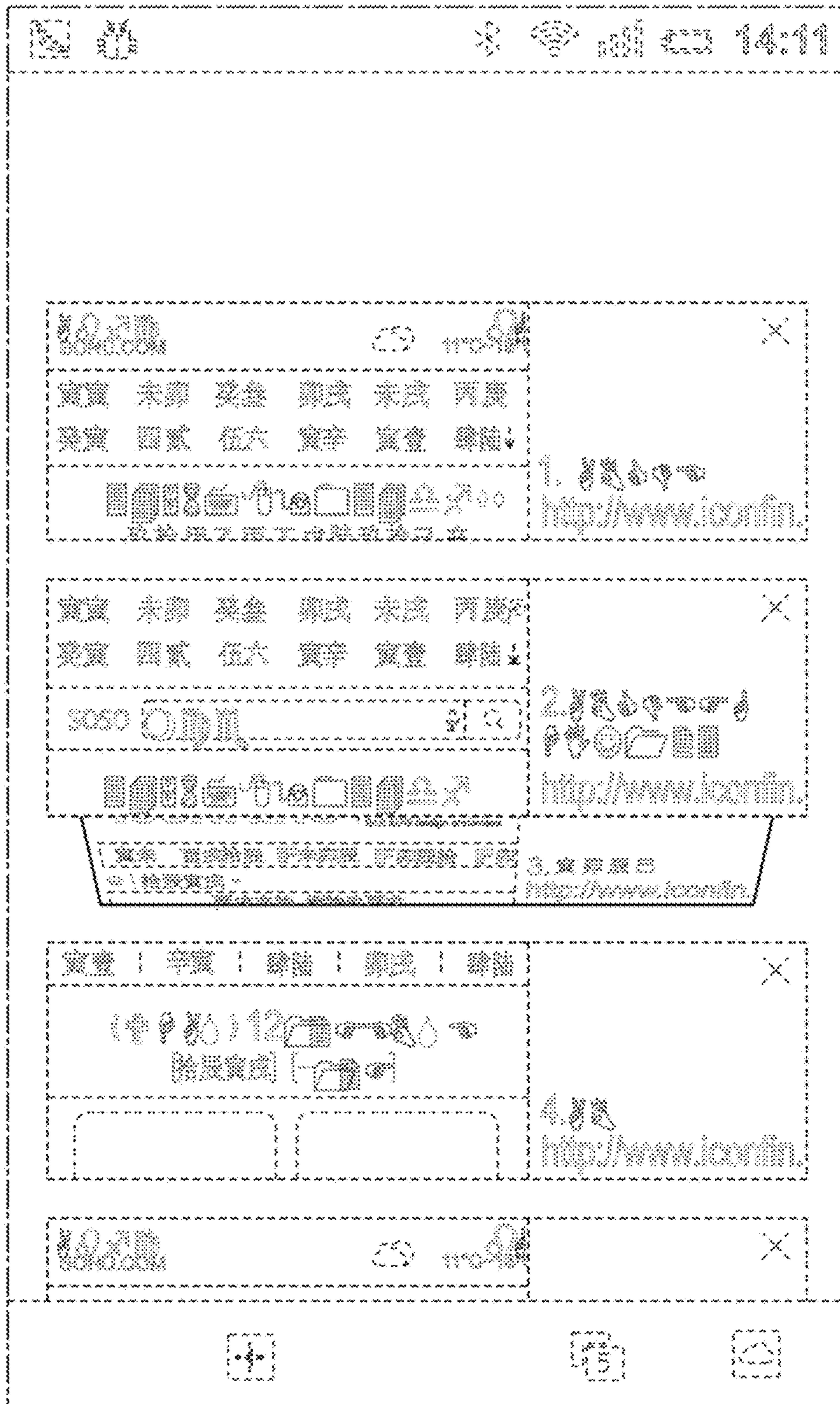

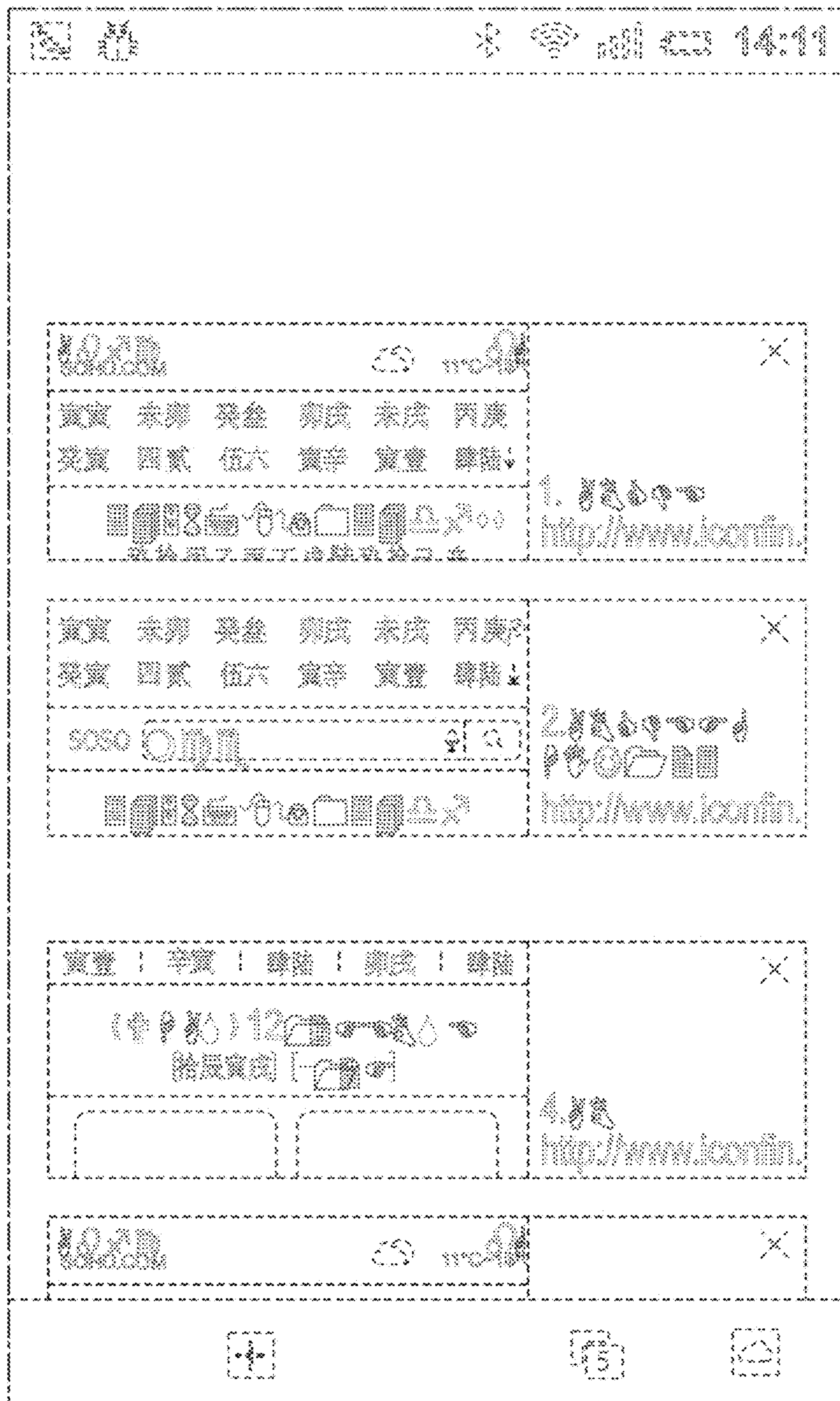

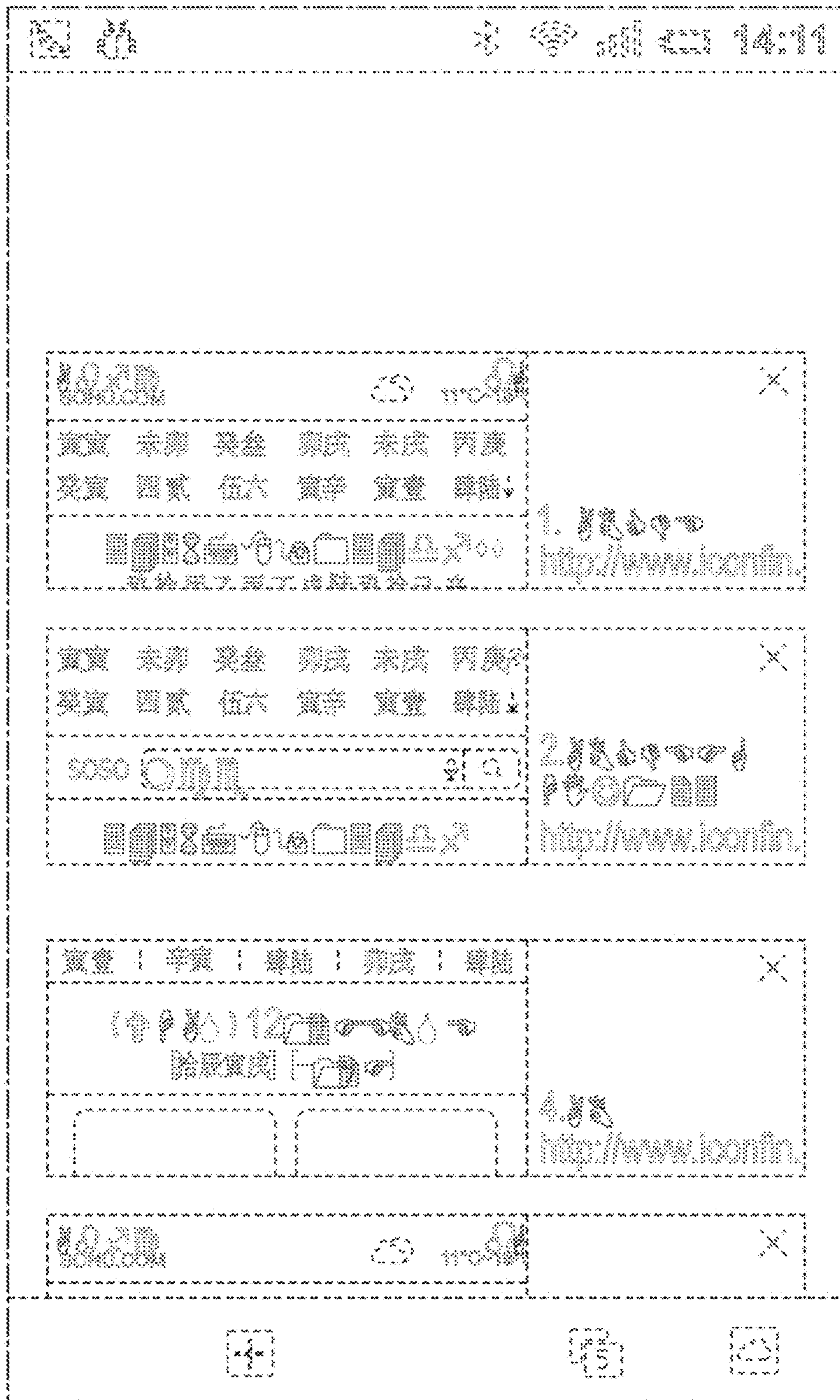

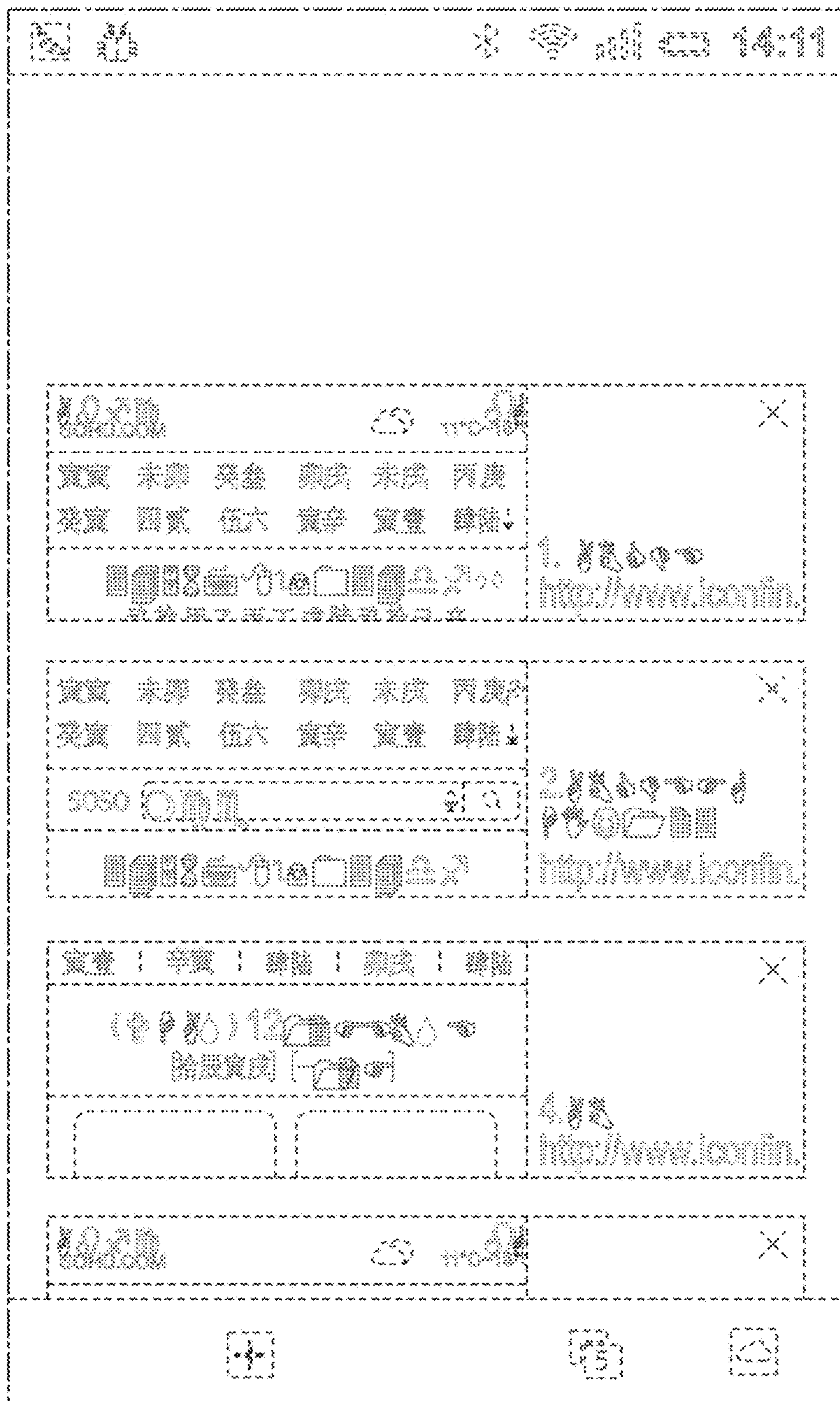
