FIG. 17 is a bottom plan view thereof; and,

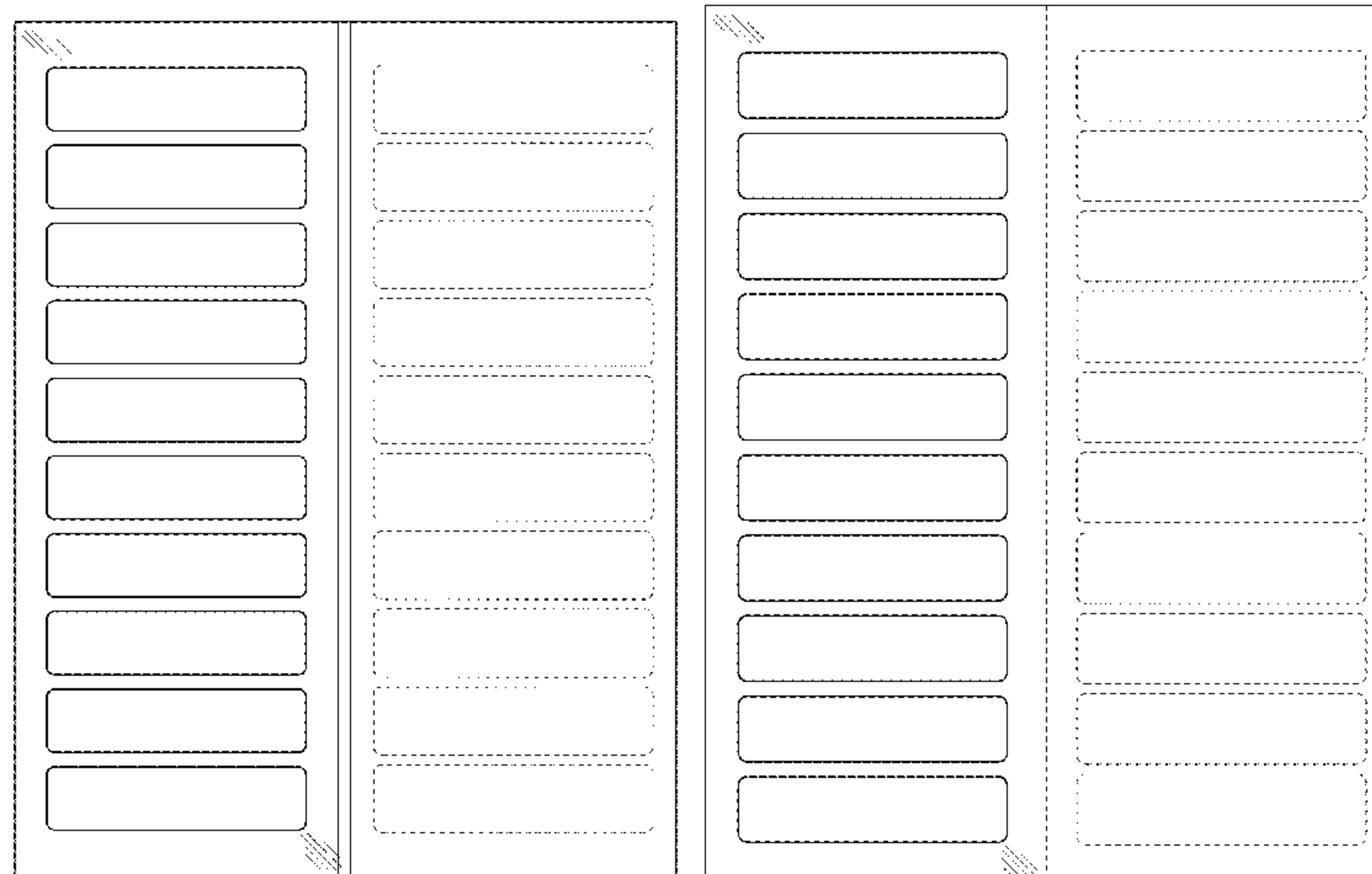

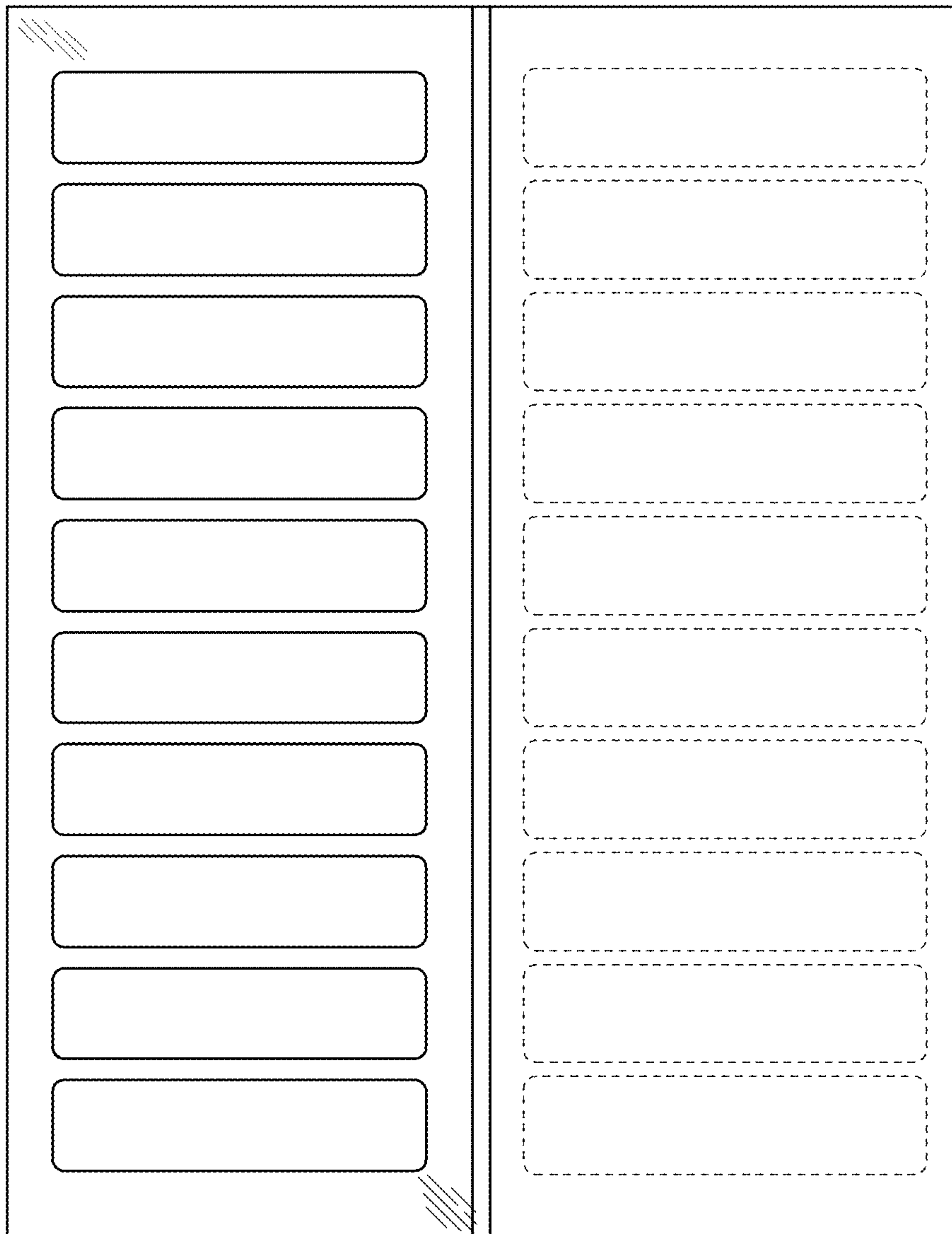

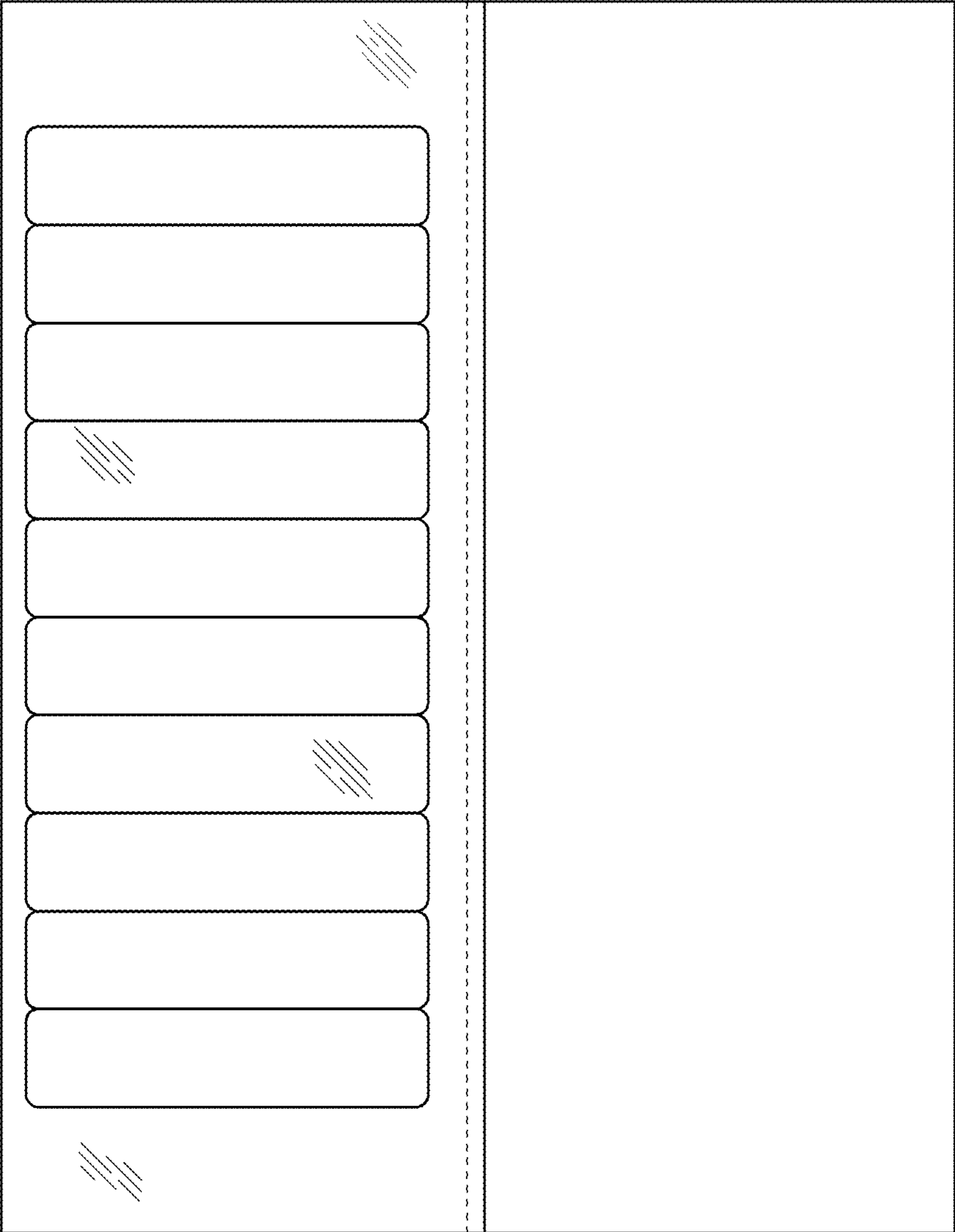

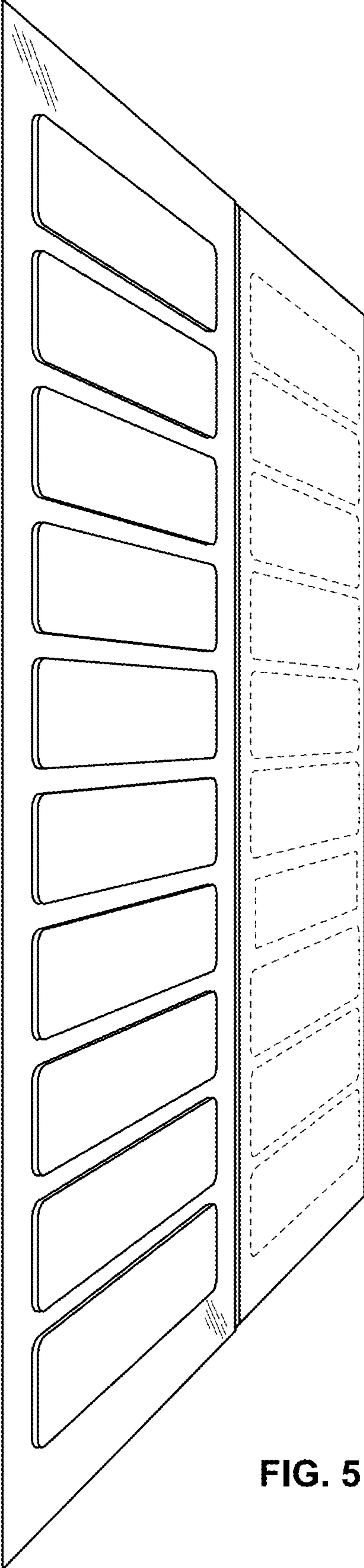

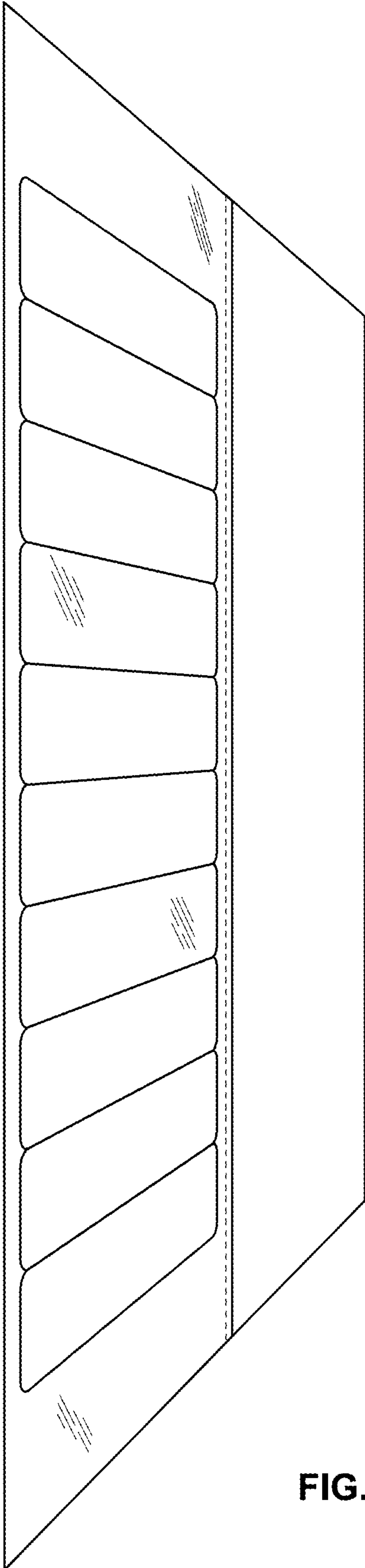

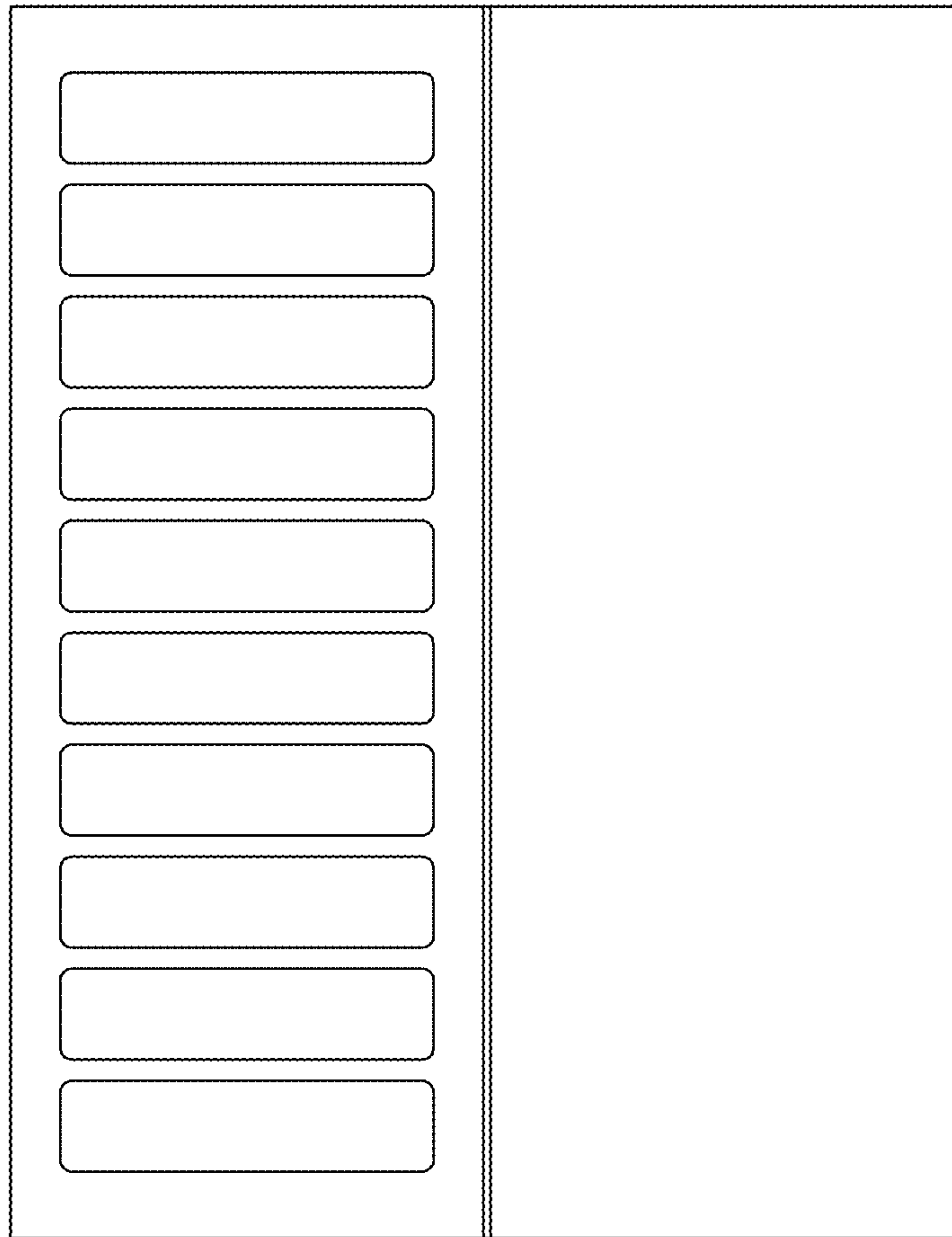

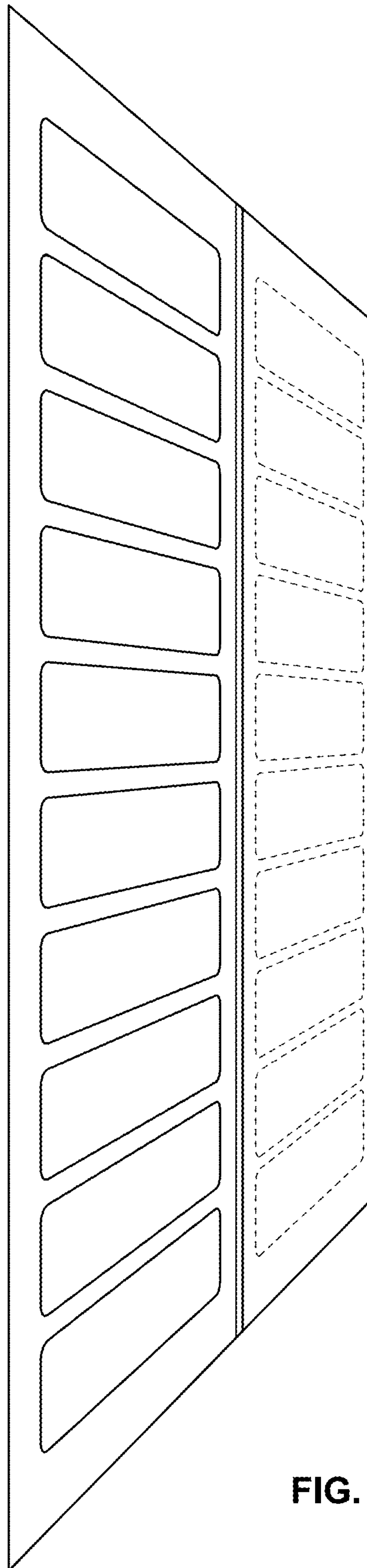

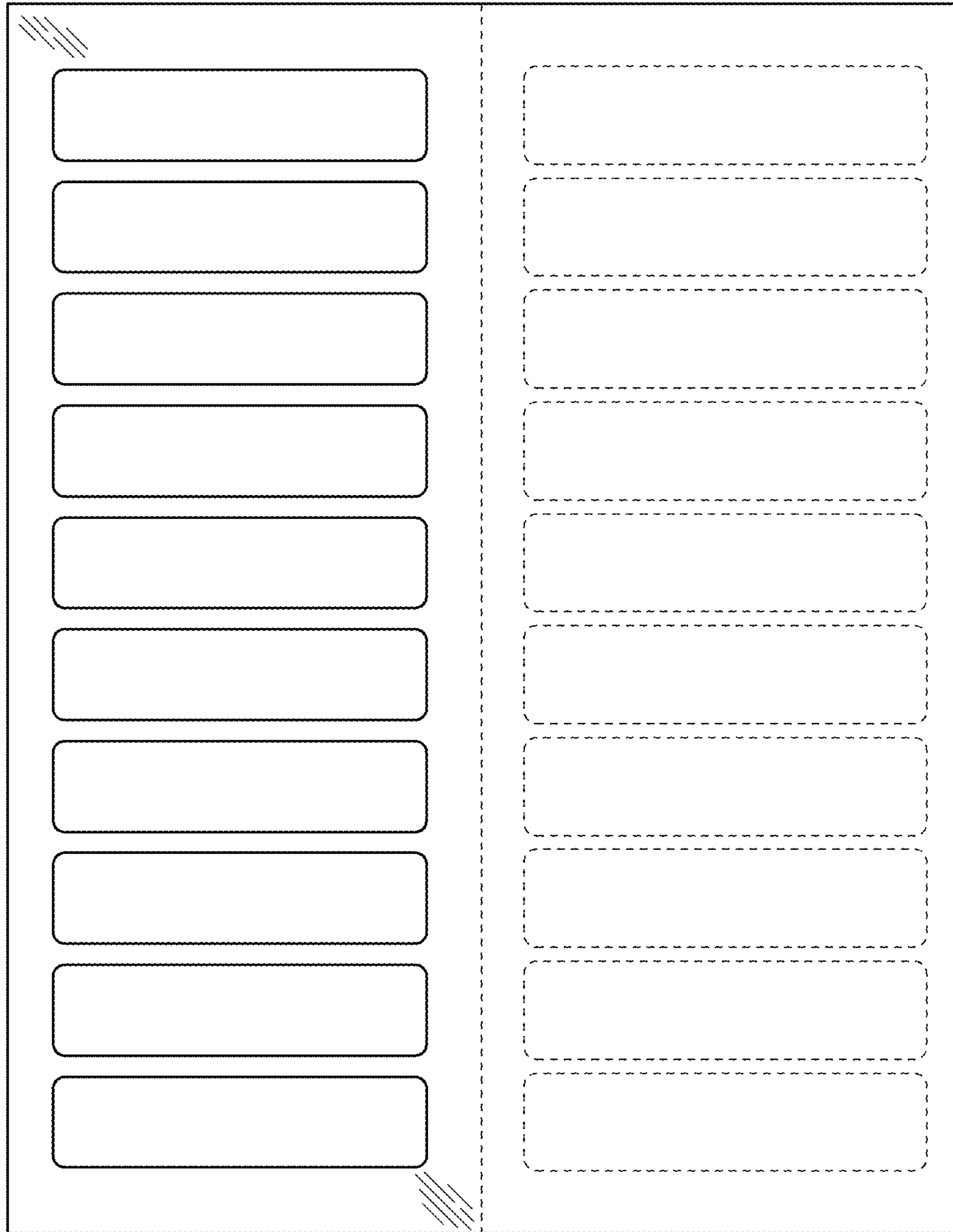

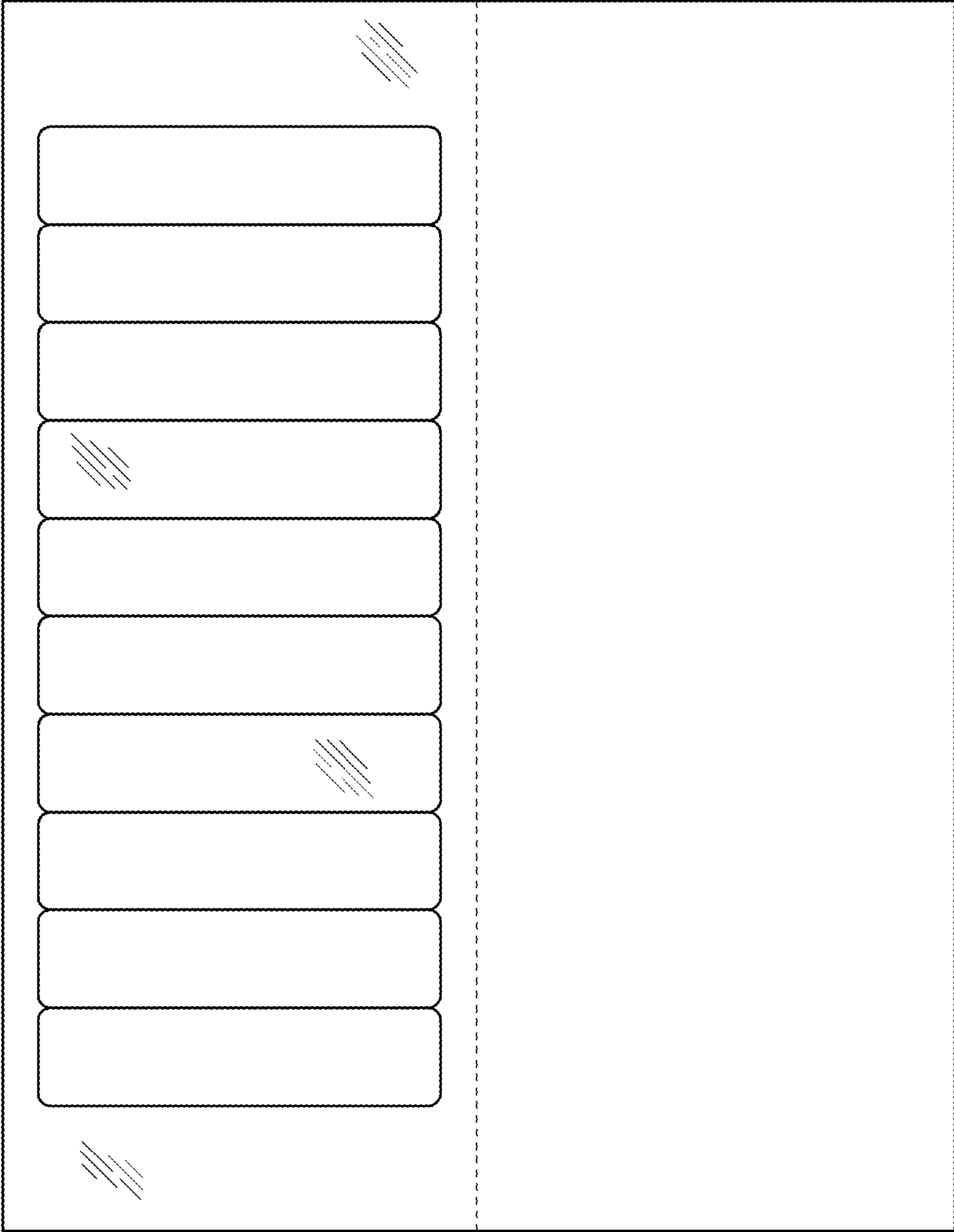

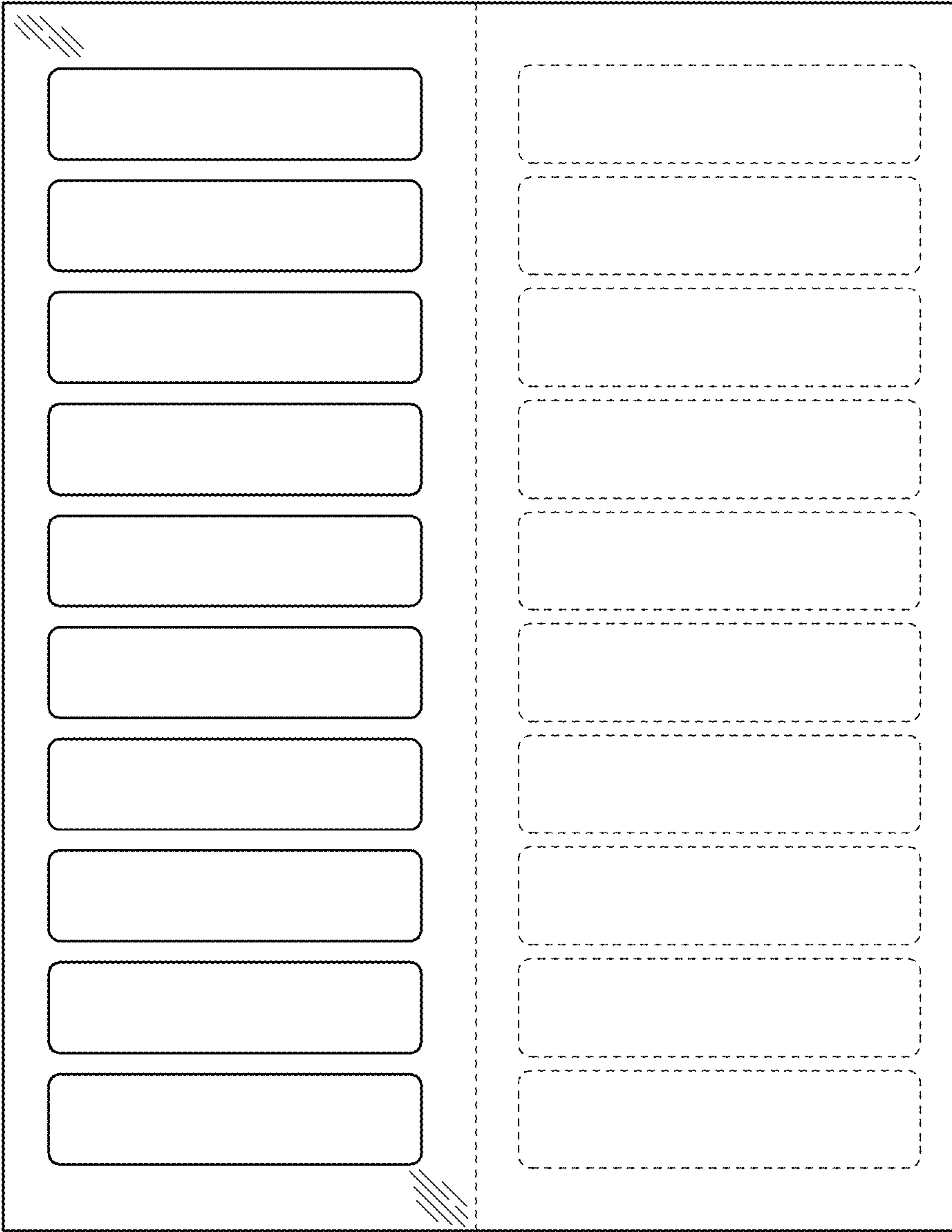

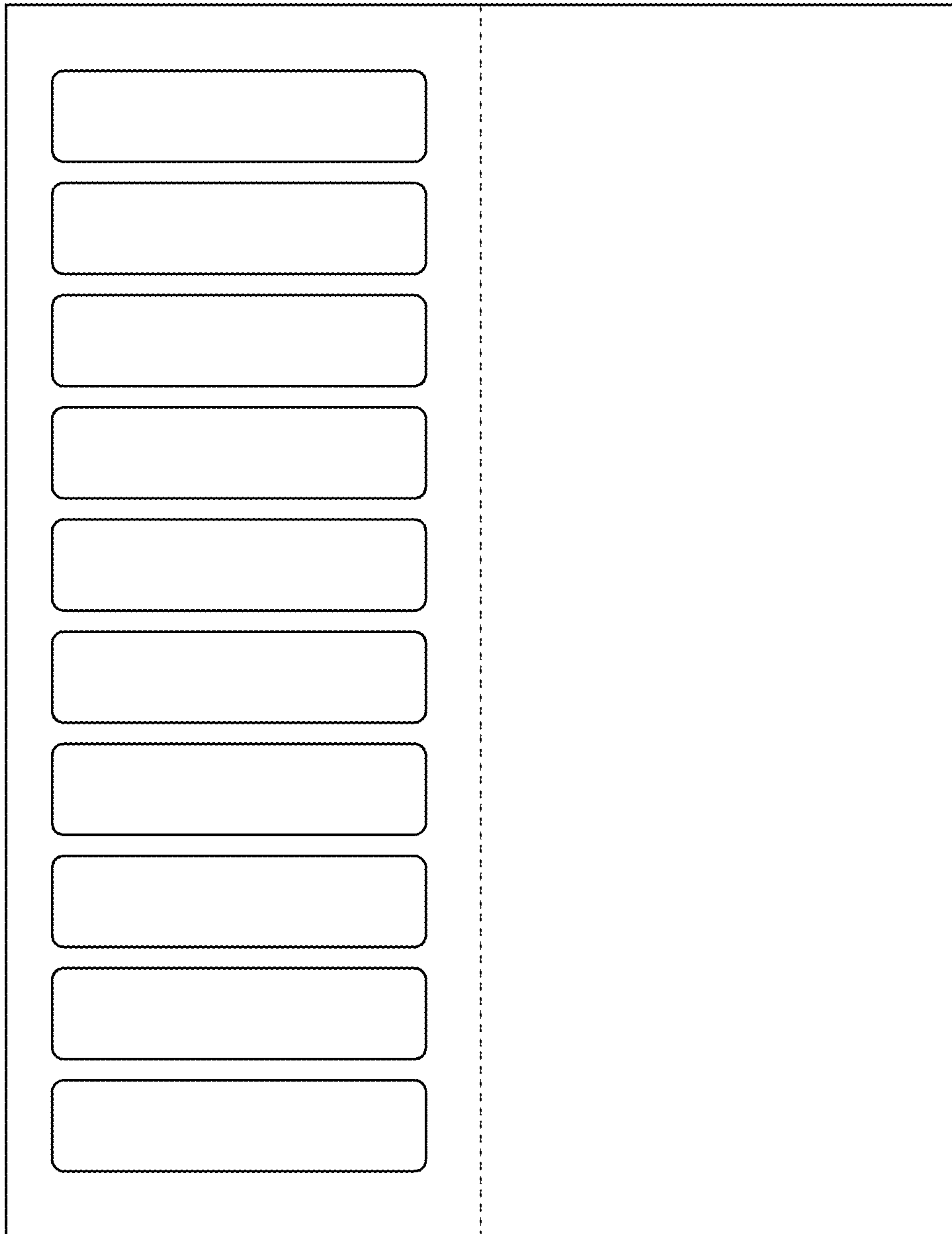
