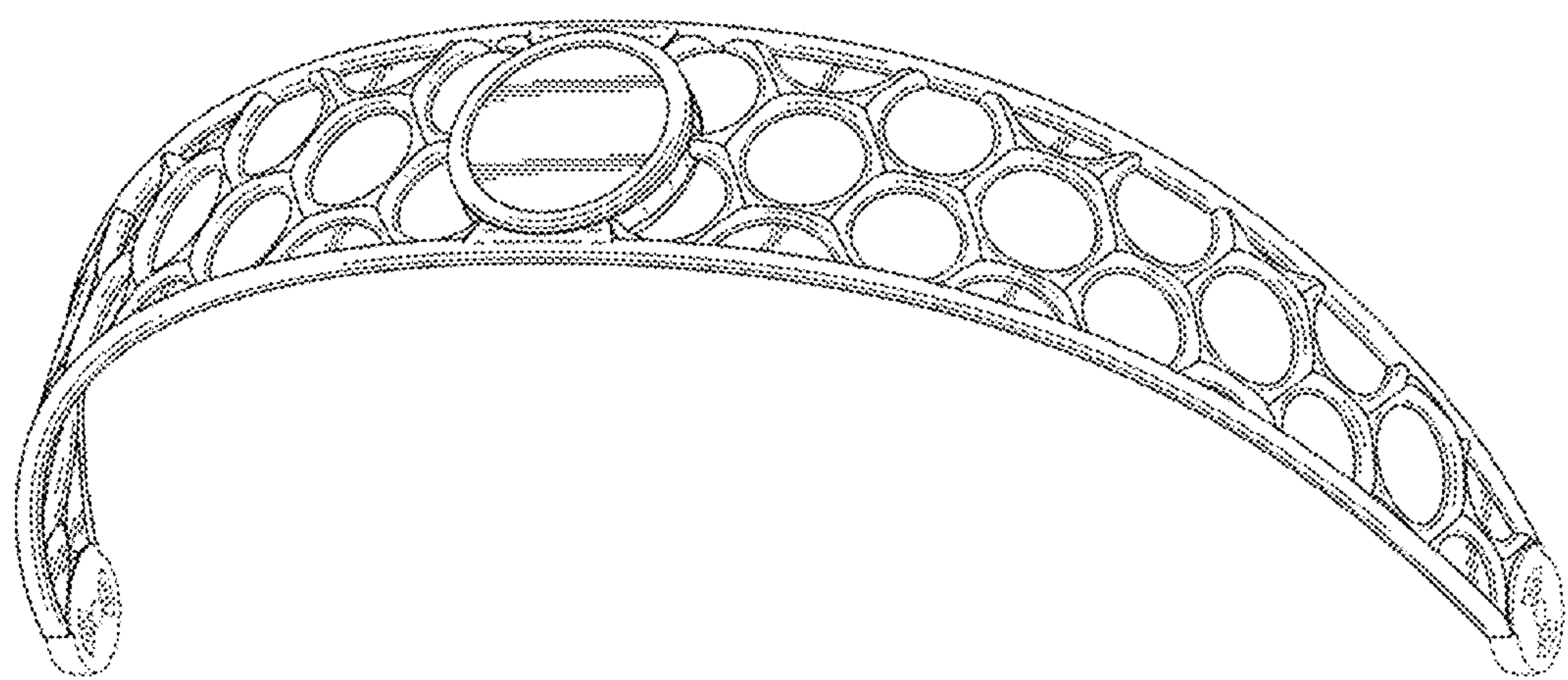

(57) **CLAIM**
The ornamental design for a children's toy bar, substantially as shown and described.

DESCRIPTION
FIG. 1 is a perspective view of a children's toy bar, embodying my new design.
FIG. 2 is a top view of the toy bar of FIG. 1;
FIG. 3 is a front view of the toy bar of FIG. 1;
FIG. 4 is a bottom view of the toy bar of FIG. 1; and,
FIG. 5 is a side view of the toy bar of FIG. 1, the opposite side being substantially a mirror image thereof.

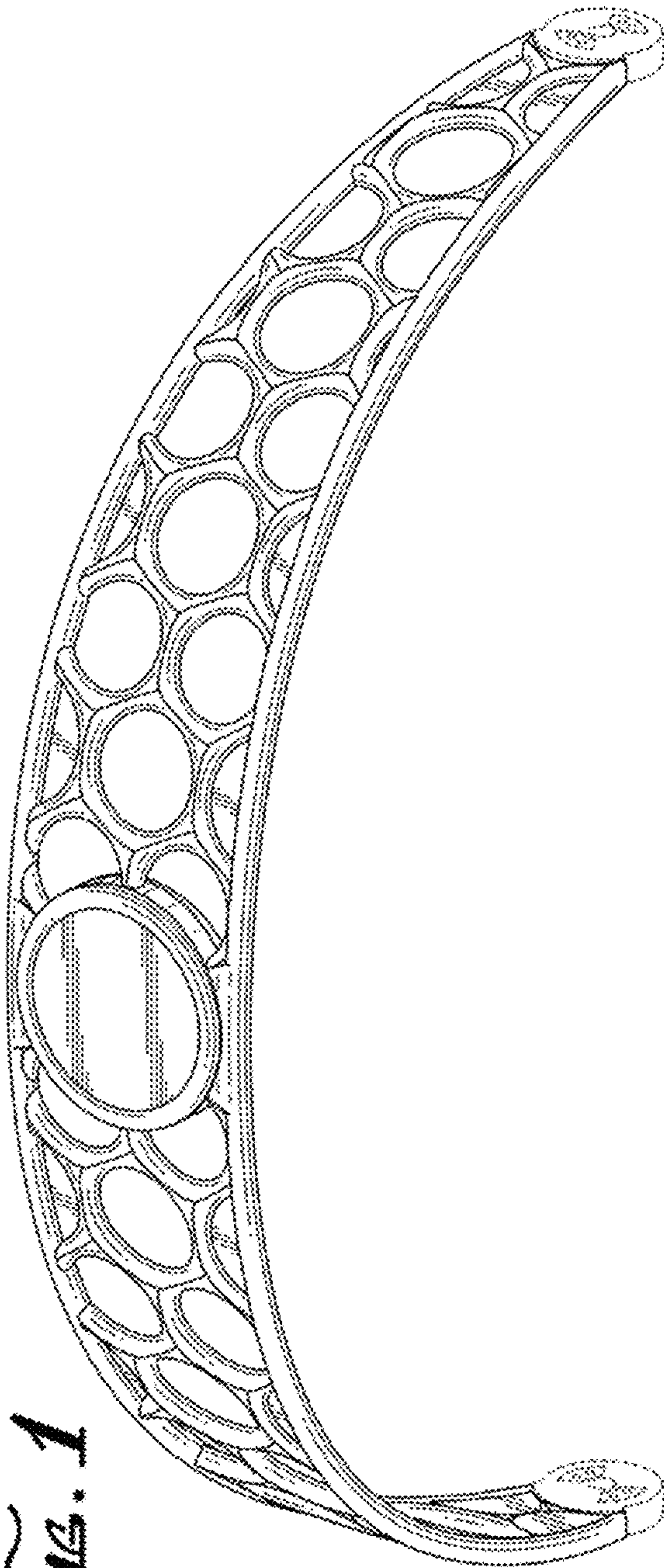

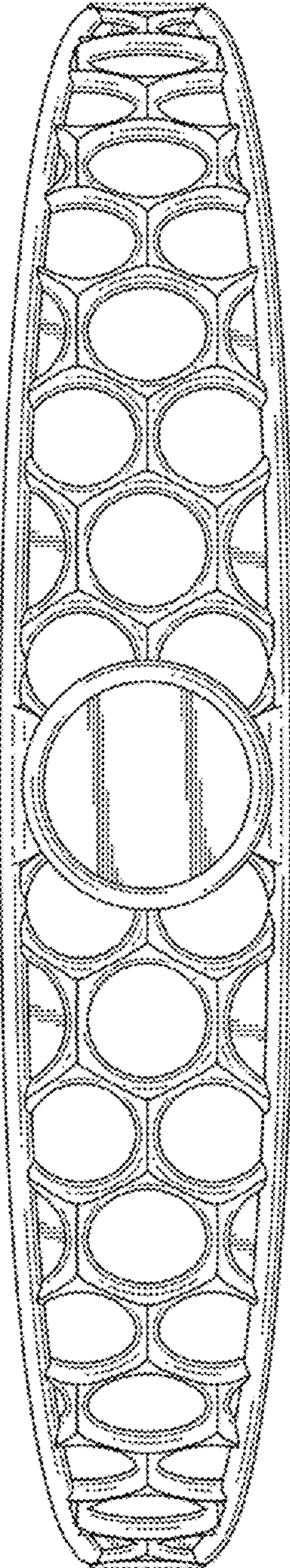
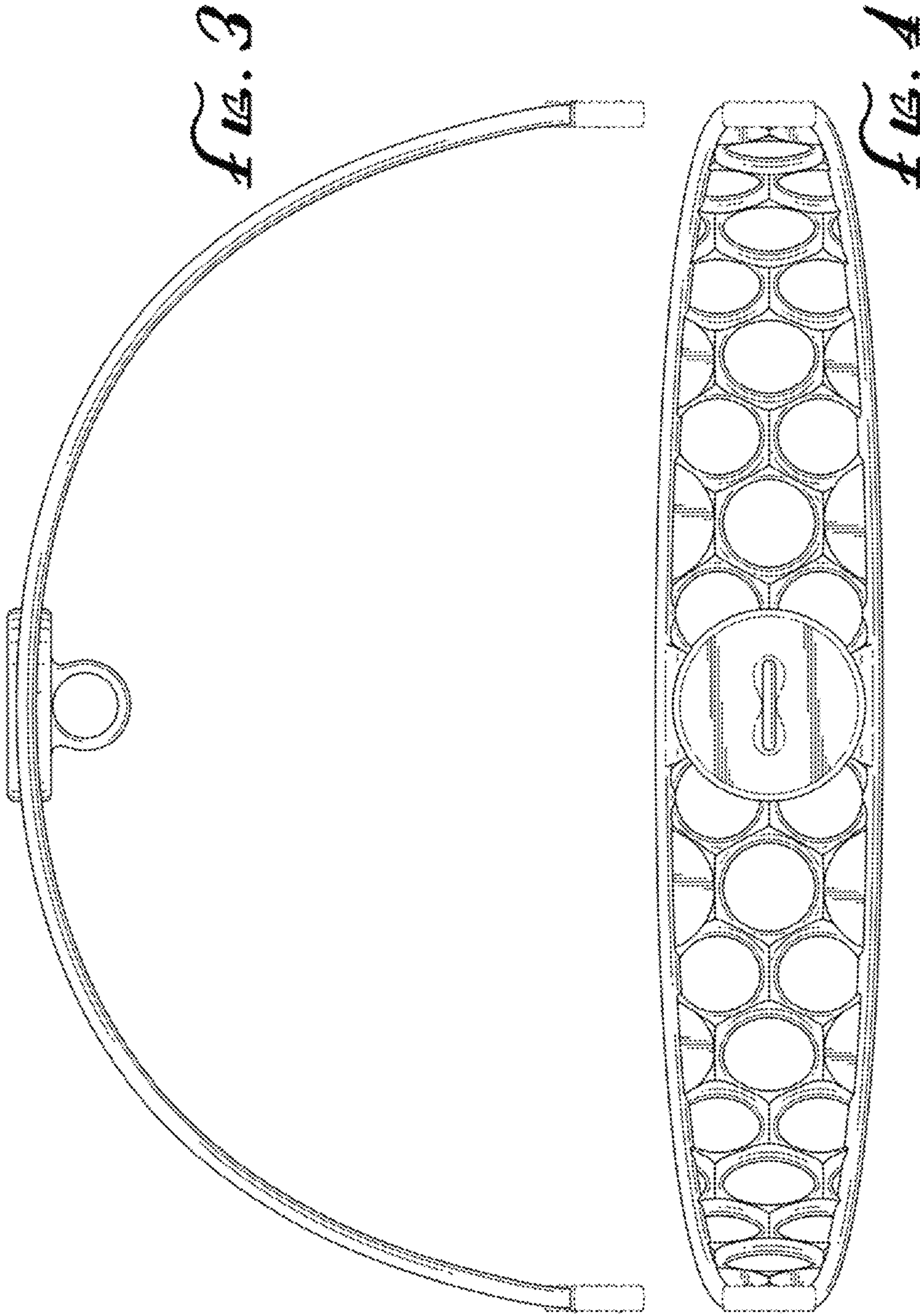

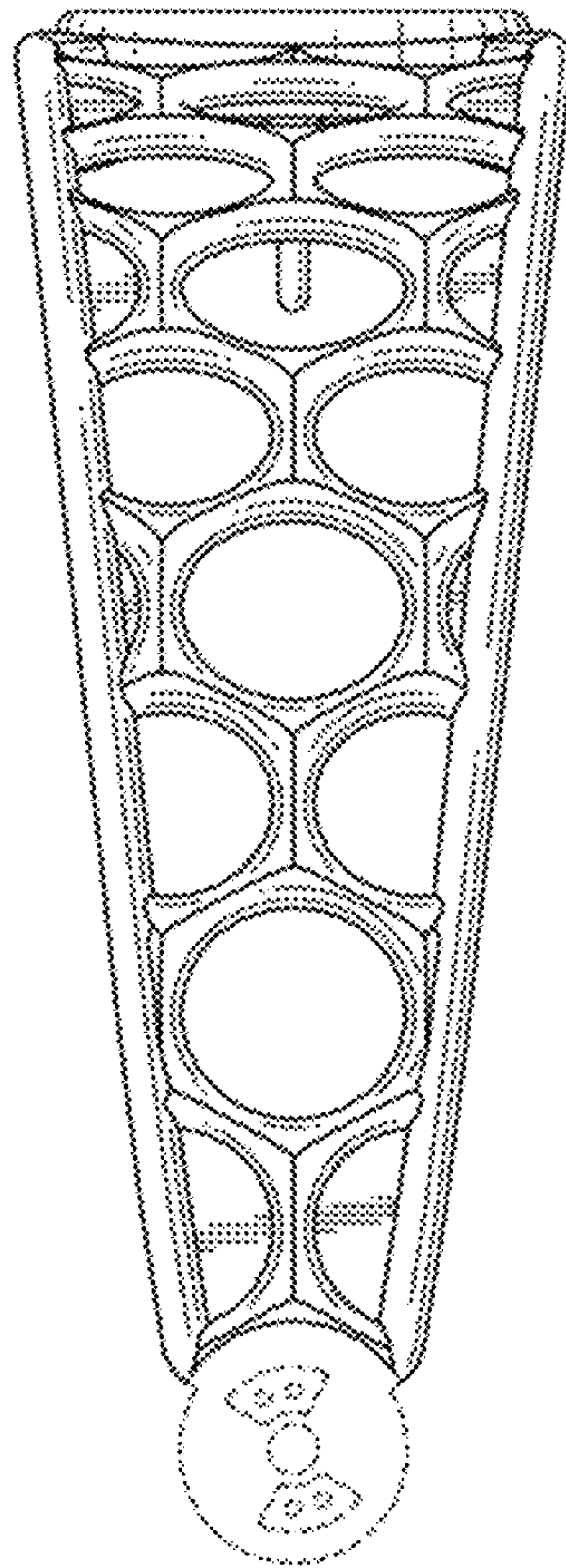
