The ornamental design for a tactile toy for infants, as shown and described.

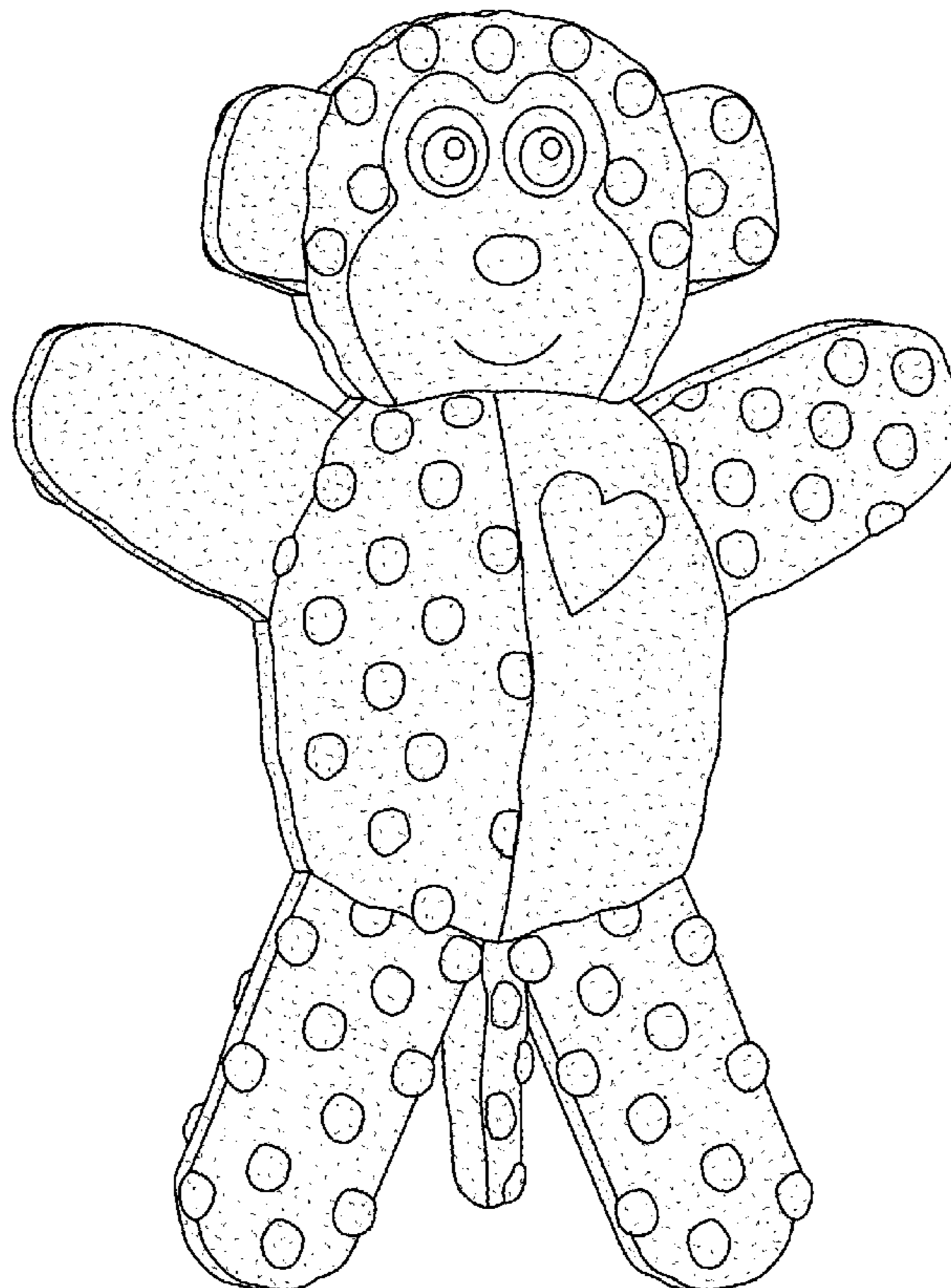
DESCRIPTION

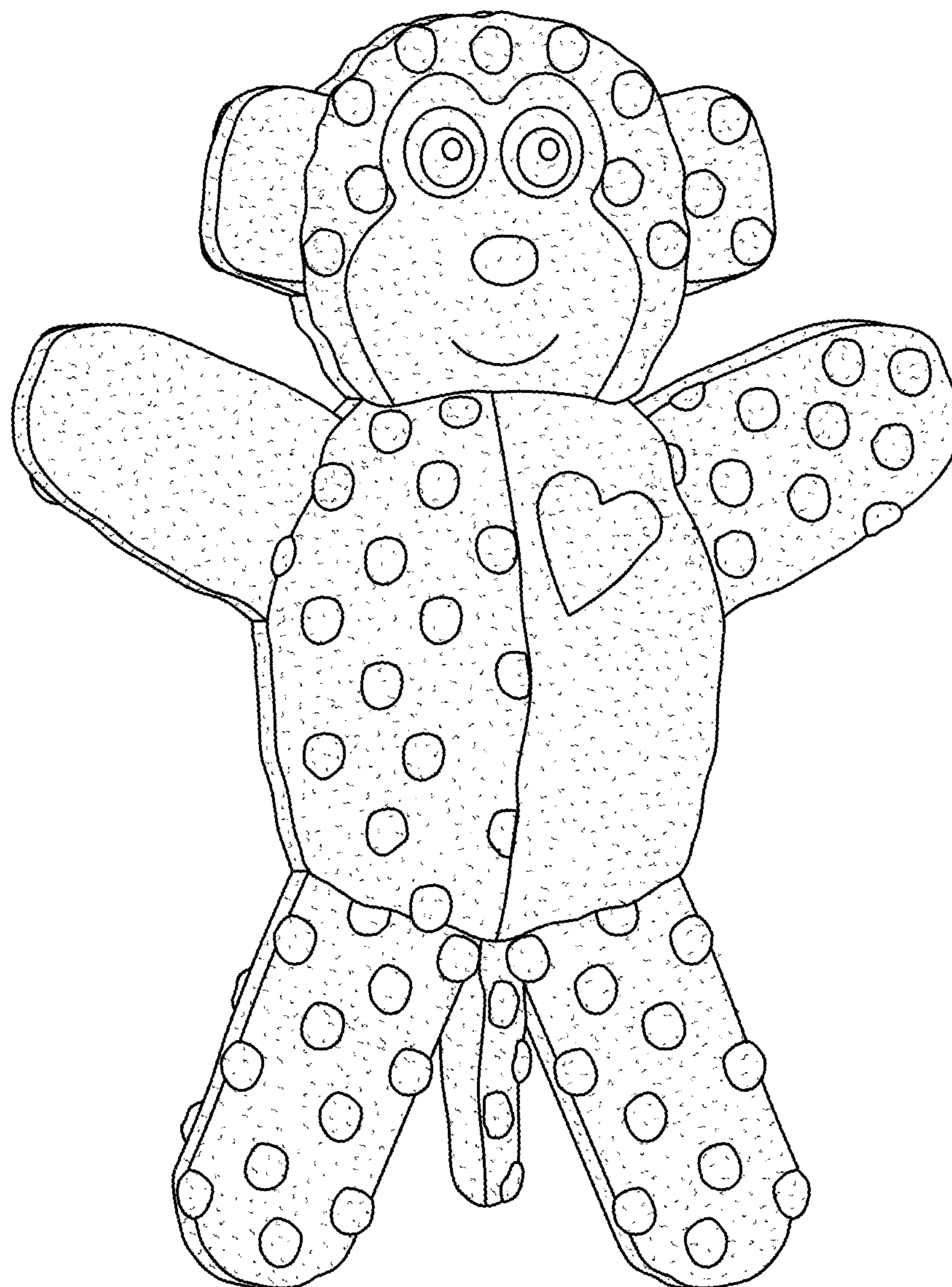

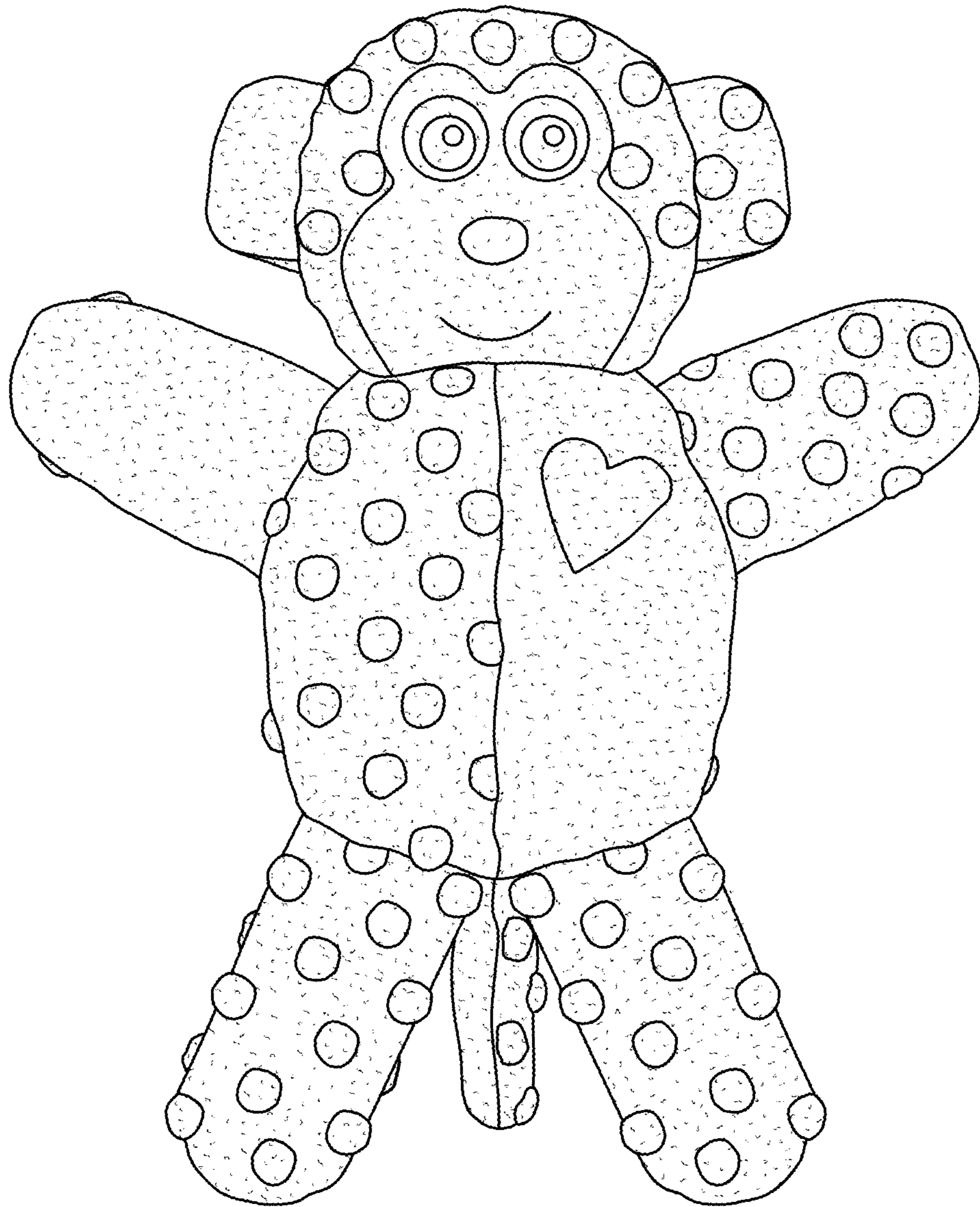

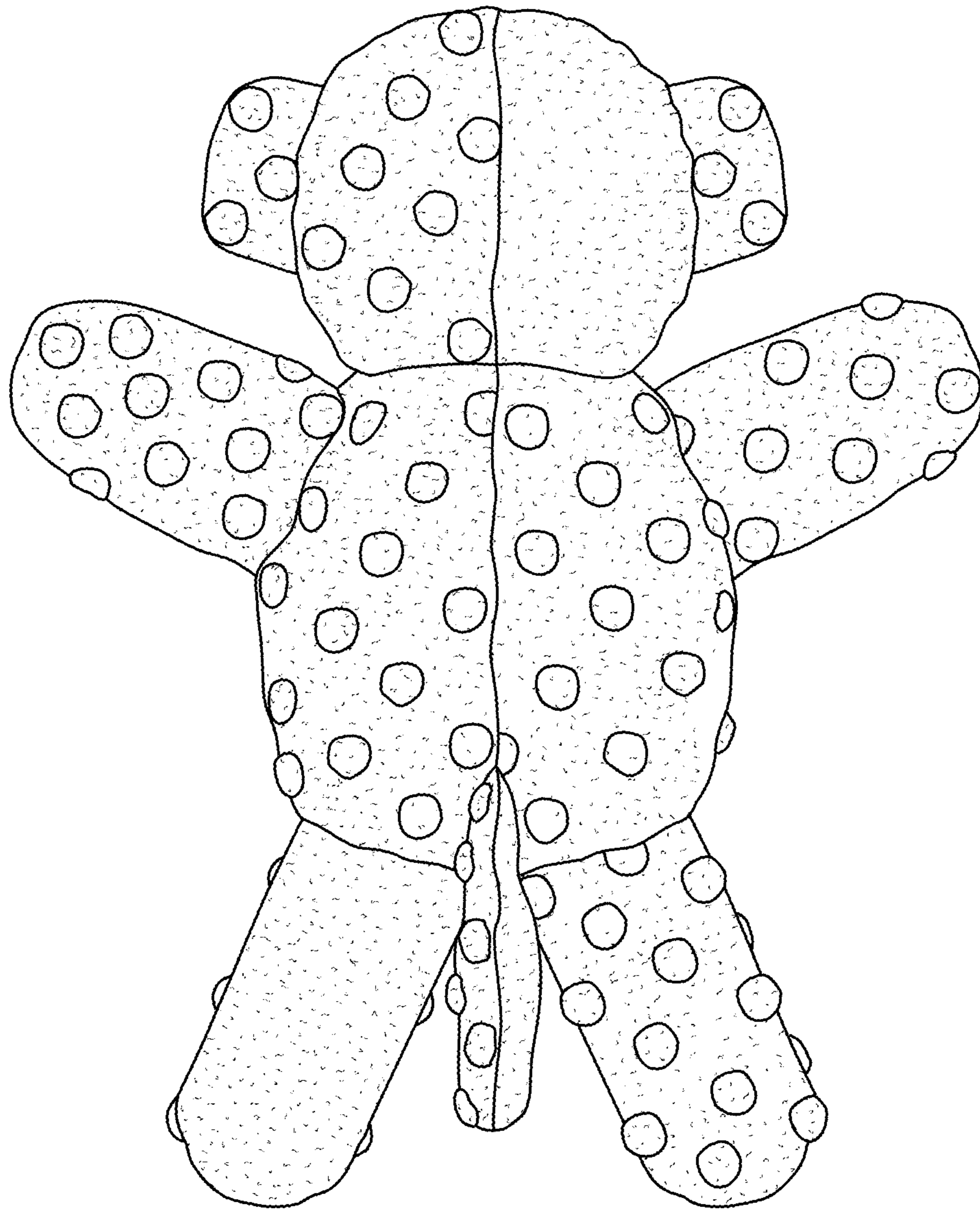

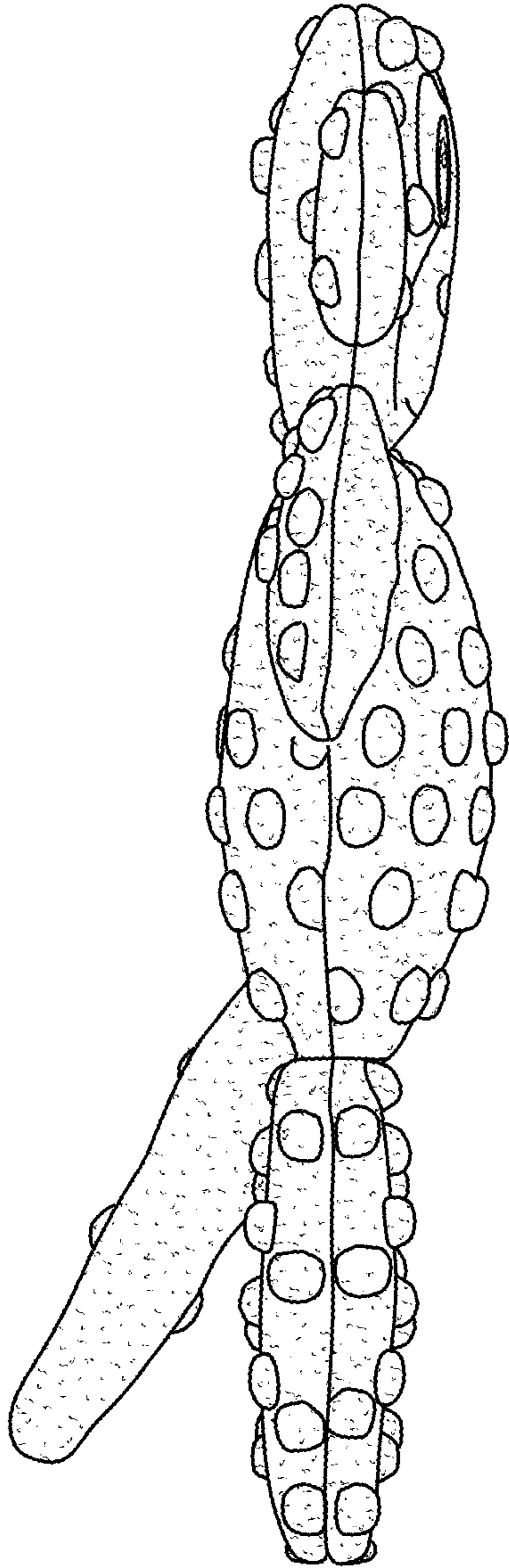

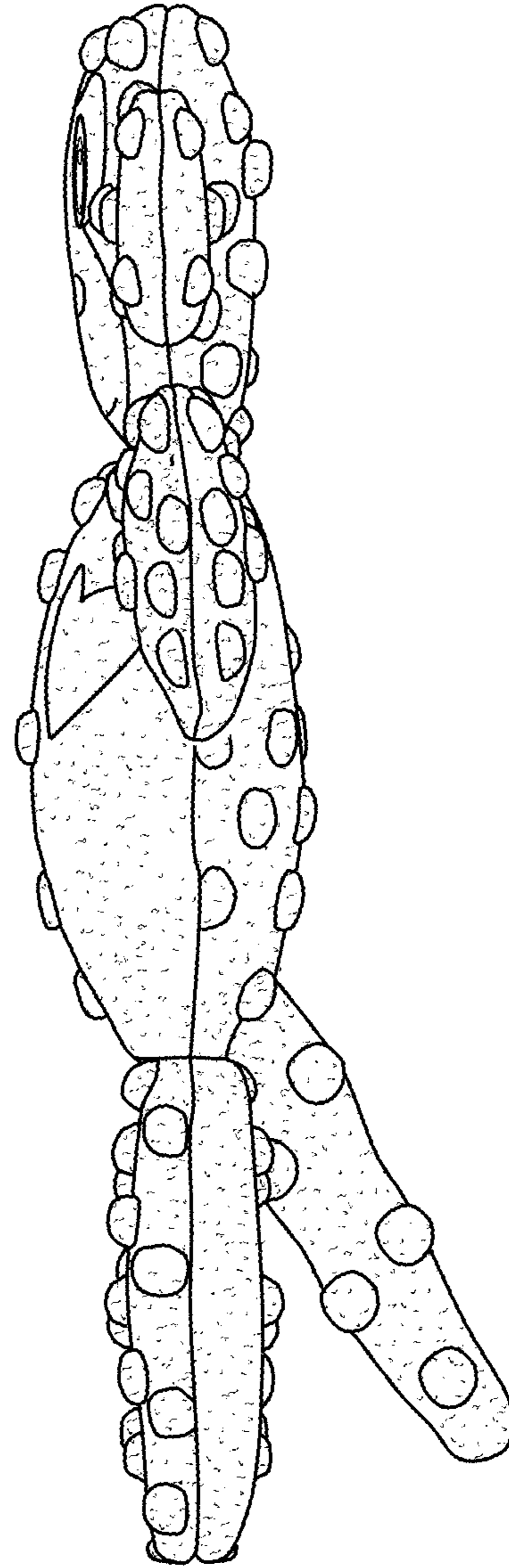

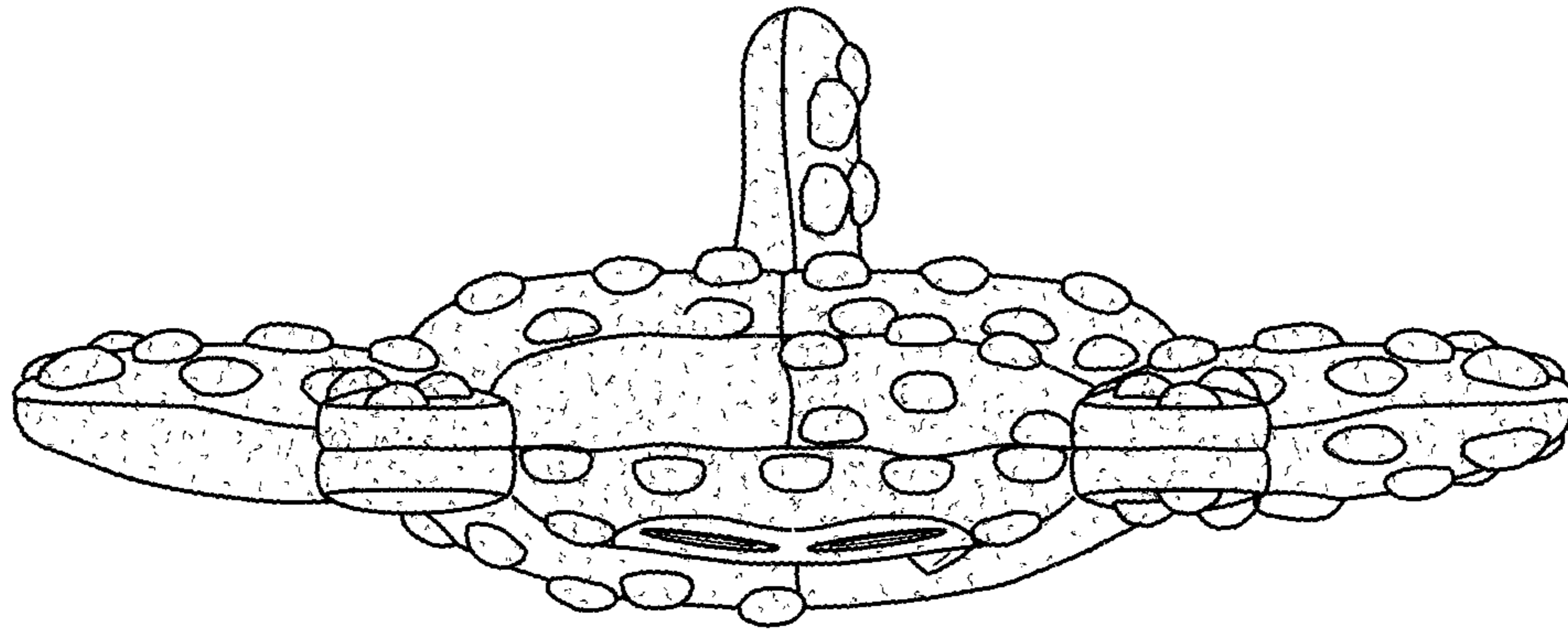

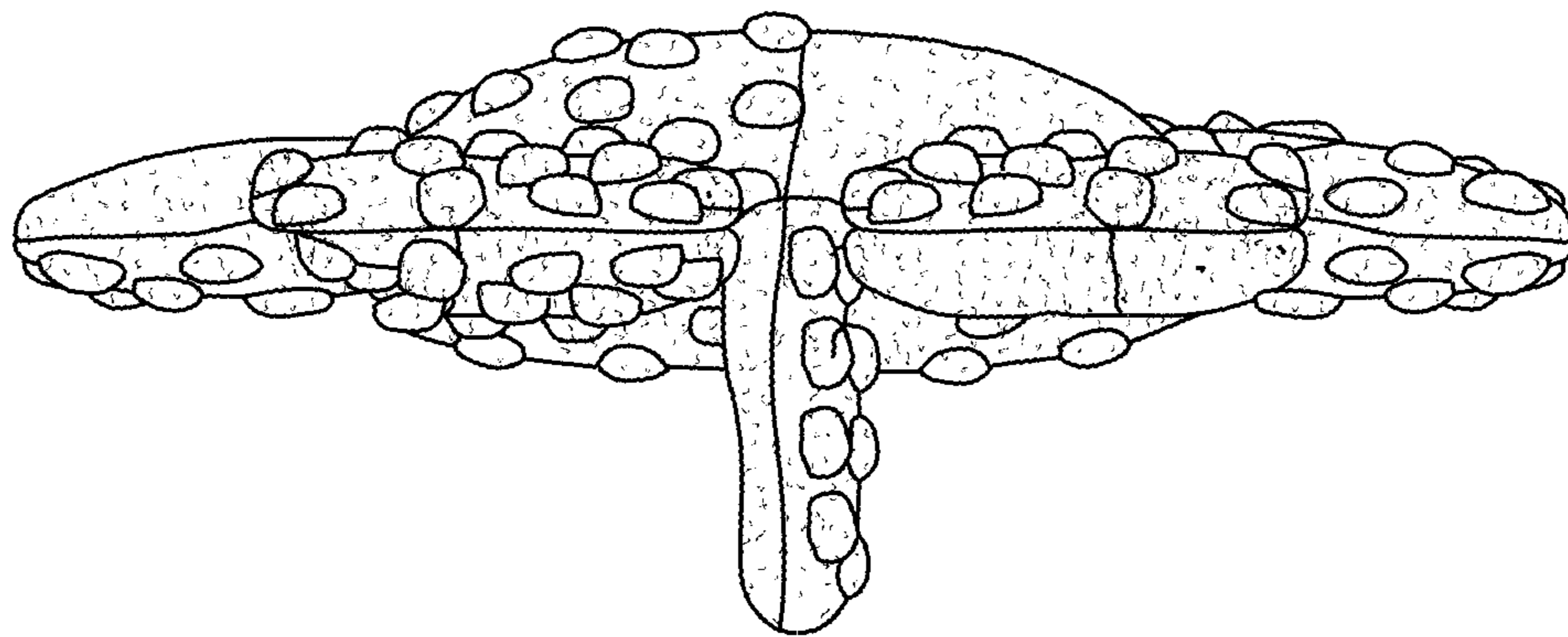
