**DESCRIPTION**

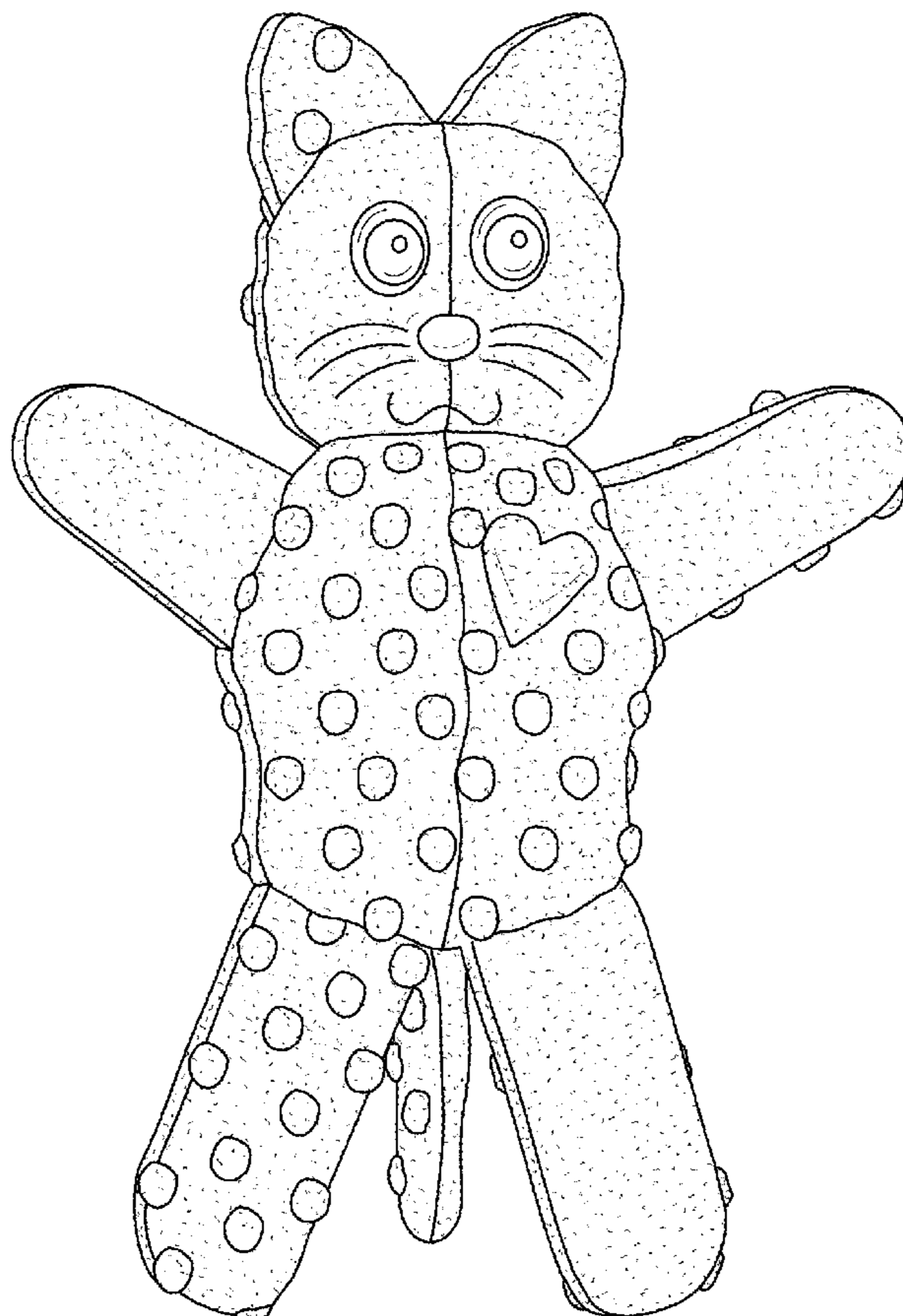
FIG. 1 is a perspective view of the tactile toy for infants, showing my new design.

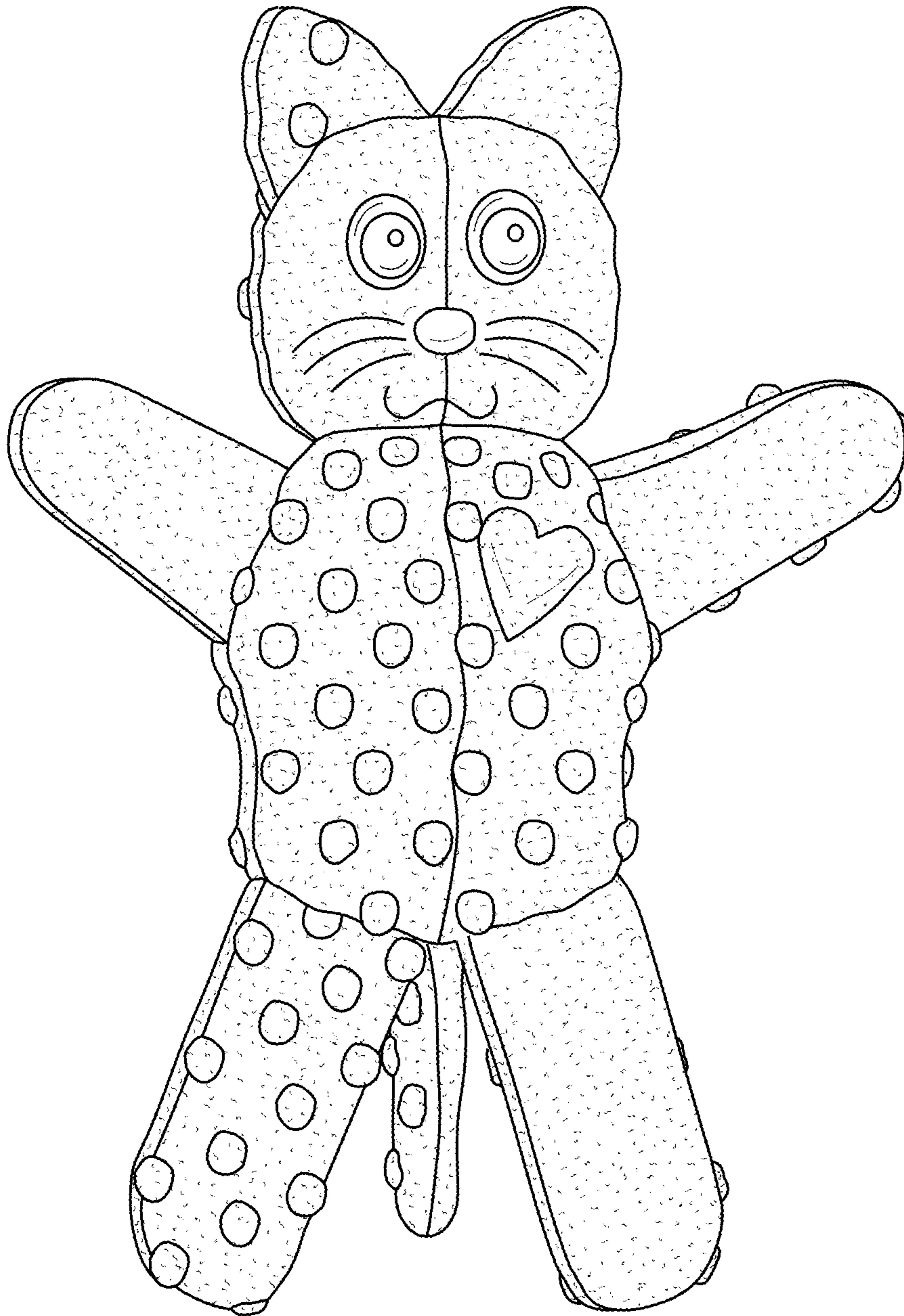

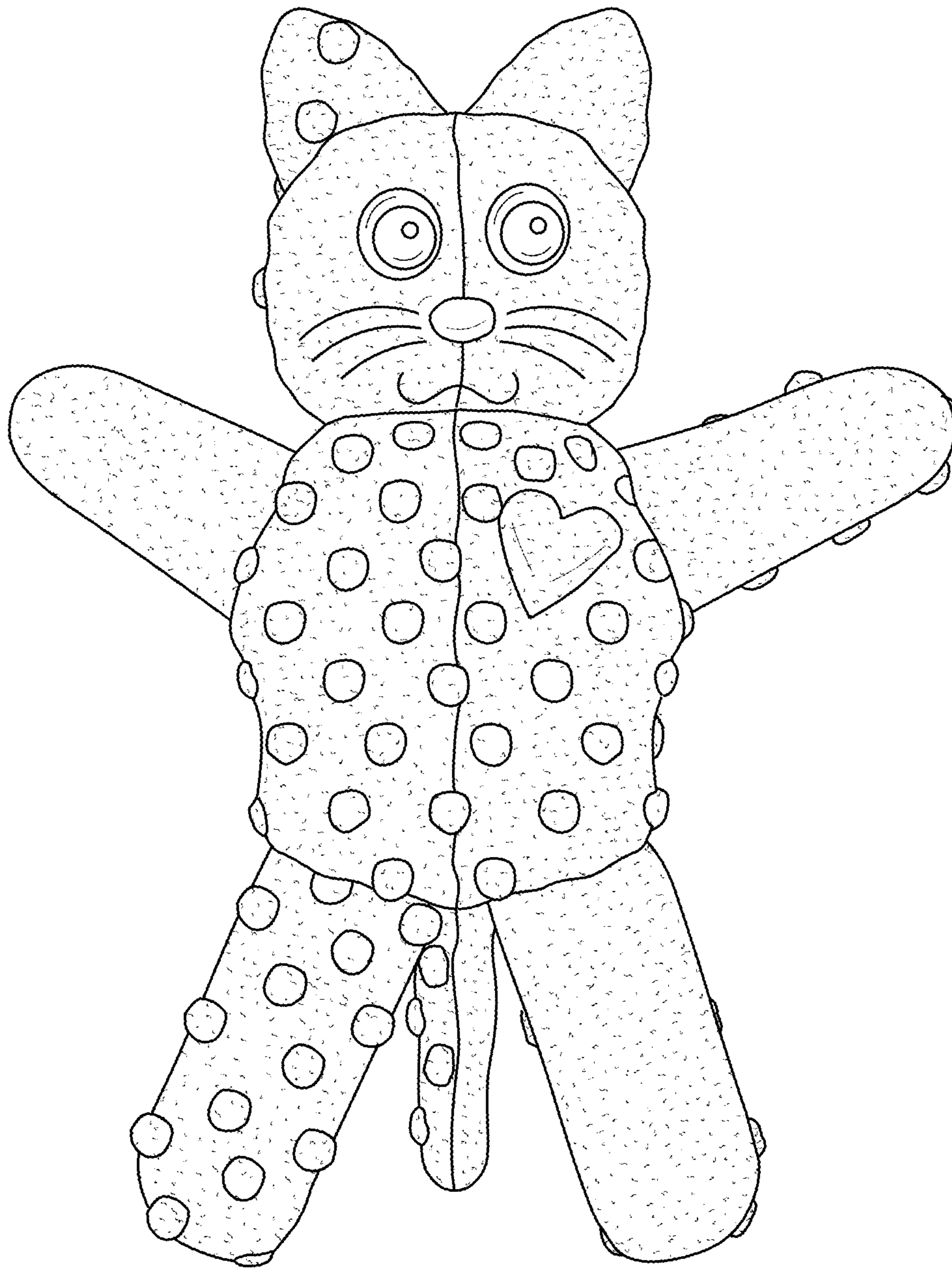

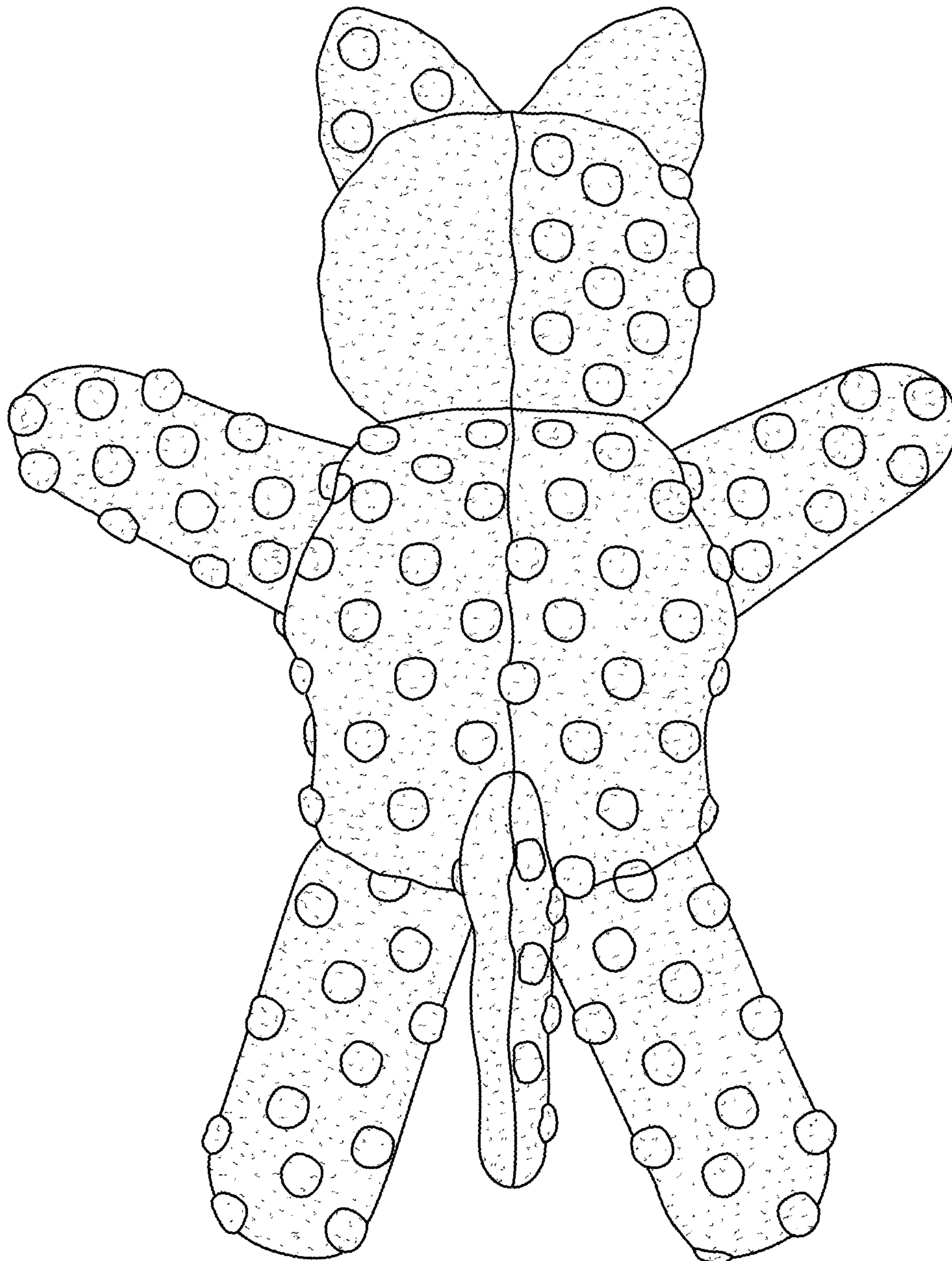

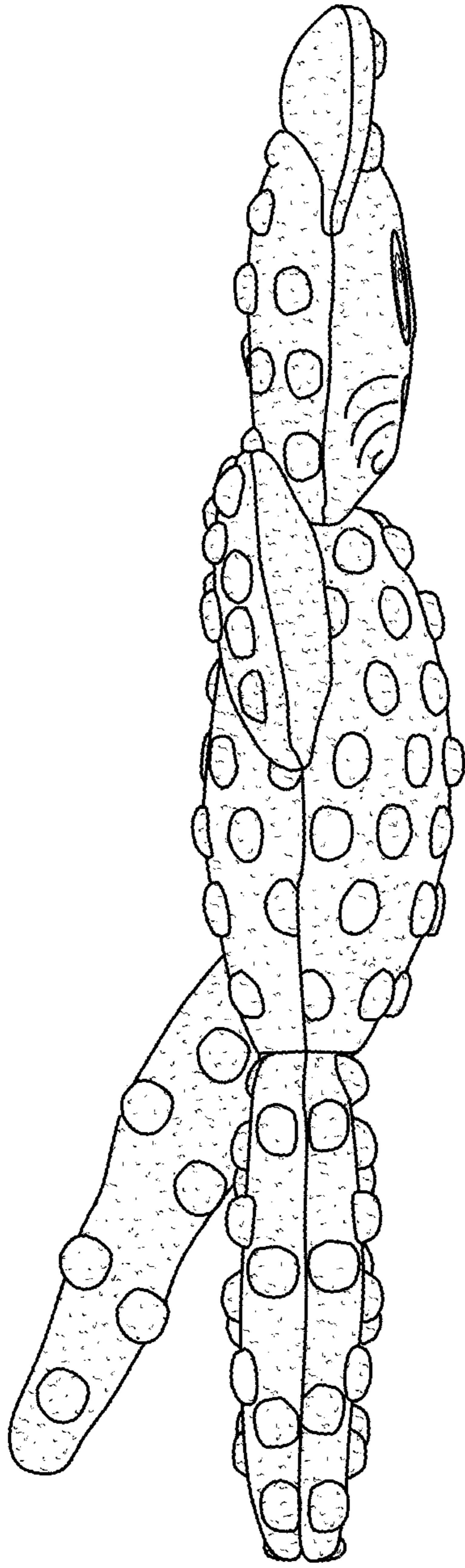

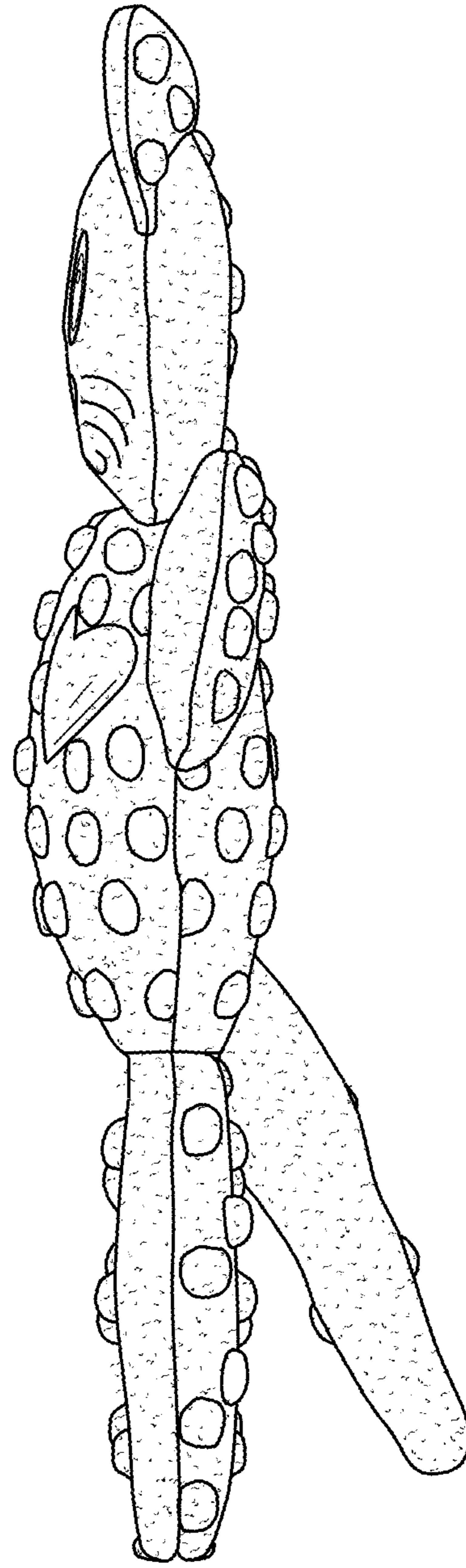

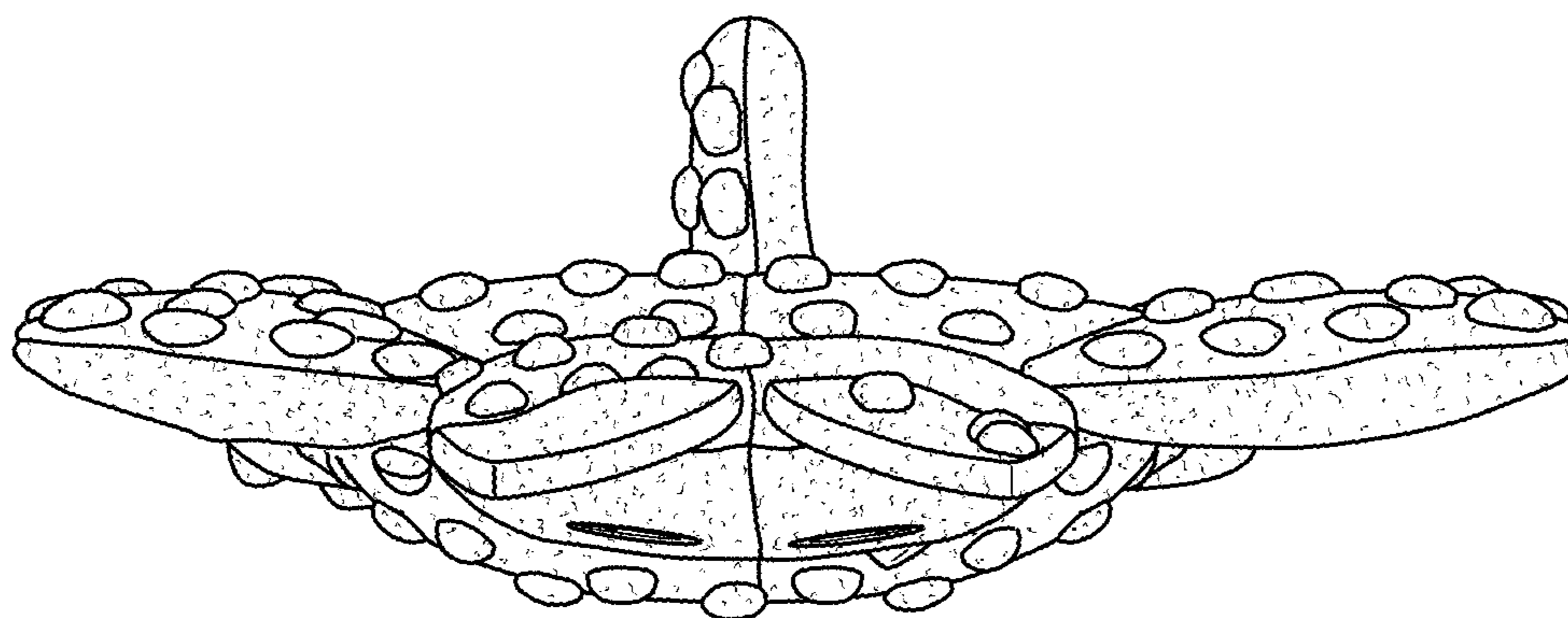

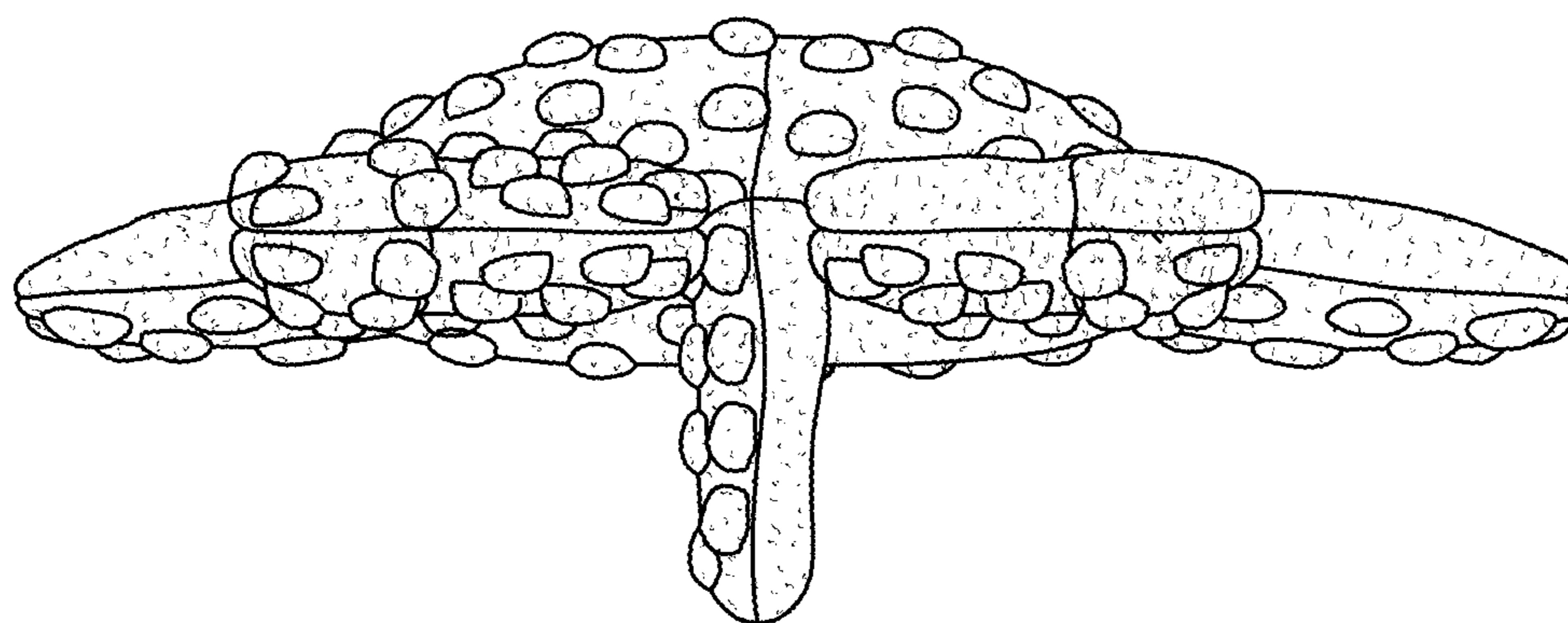
