(57) **CLAIM**

I claim the ornamental design for a work-vest, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view from the right side of a first embodiment of a work-vest of my new design
 FIG. 2 is a rear right perspective view thereof;
 FIG. 3 is a right side view thereof;
 FIG. 4 is a top view thereof;
 FIG. 5 is a front view of a second embodiment of my design wherein a back strap has been added to the design of the first embodiment;
 FIG. 6 is a rear perspective view thereof from the right side; and,
 FIG. 7 front left perspective view of a third embodiment of my design wherein a back piece has been added to the second embodiment.

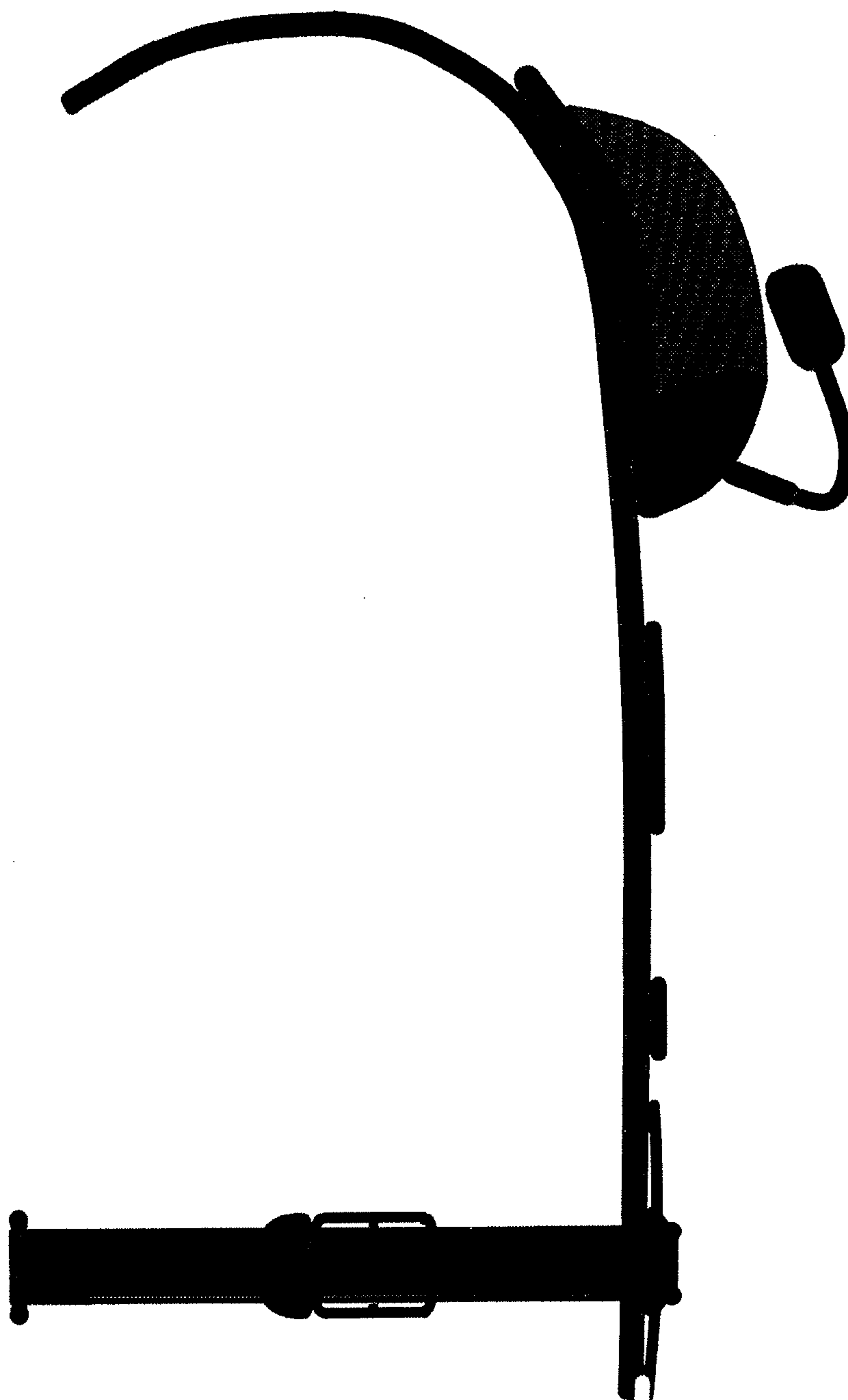

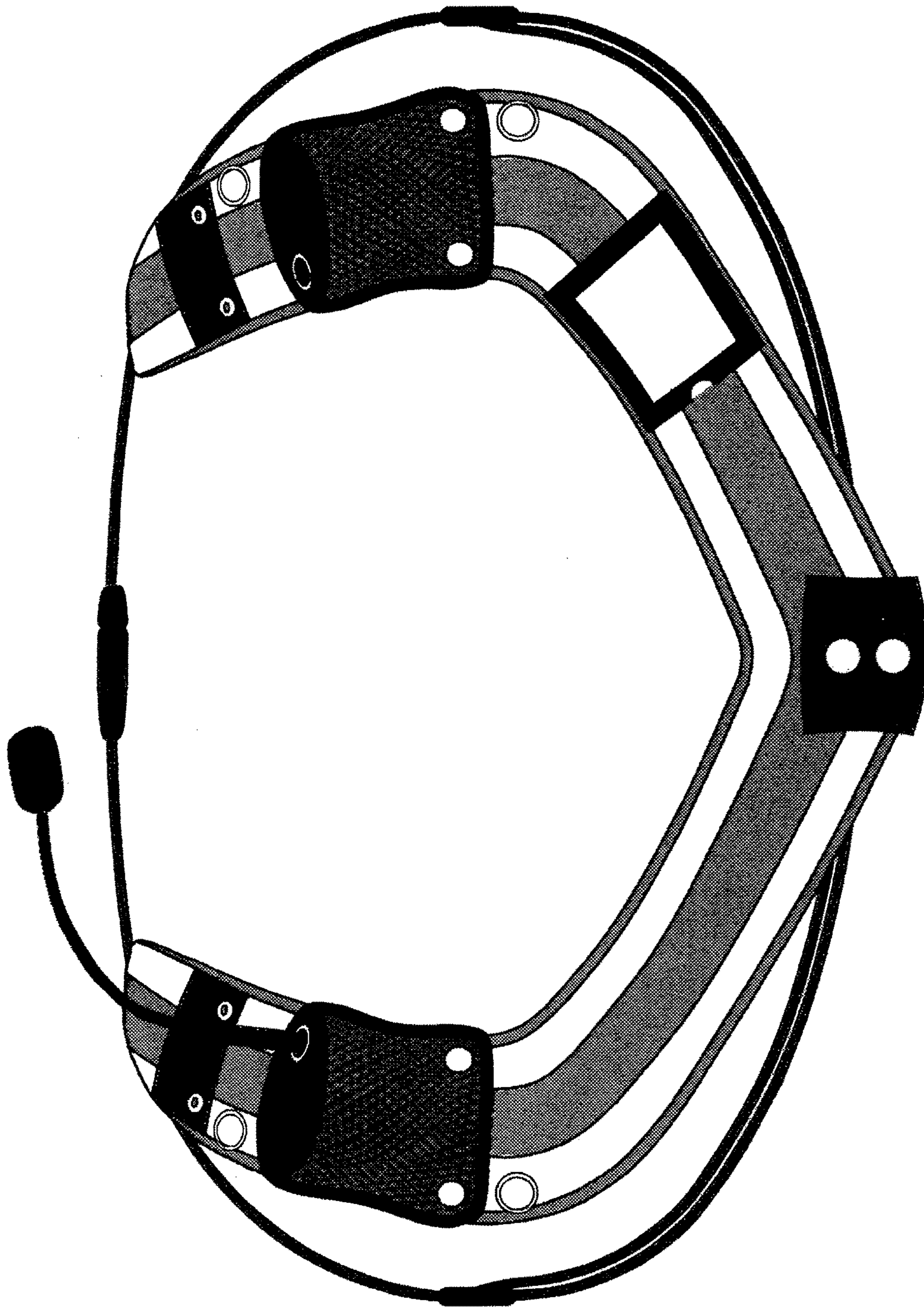

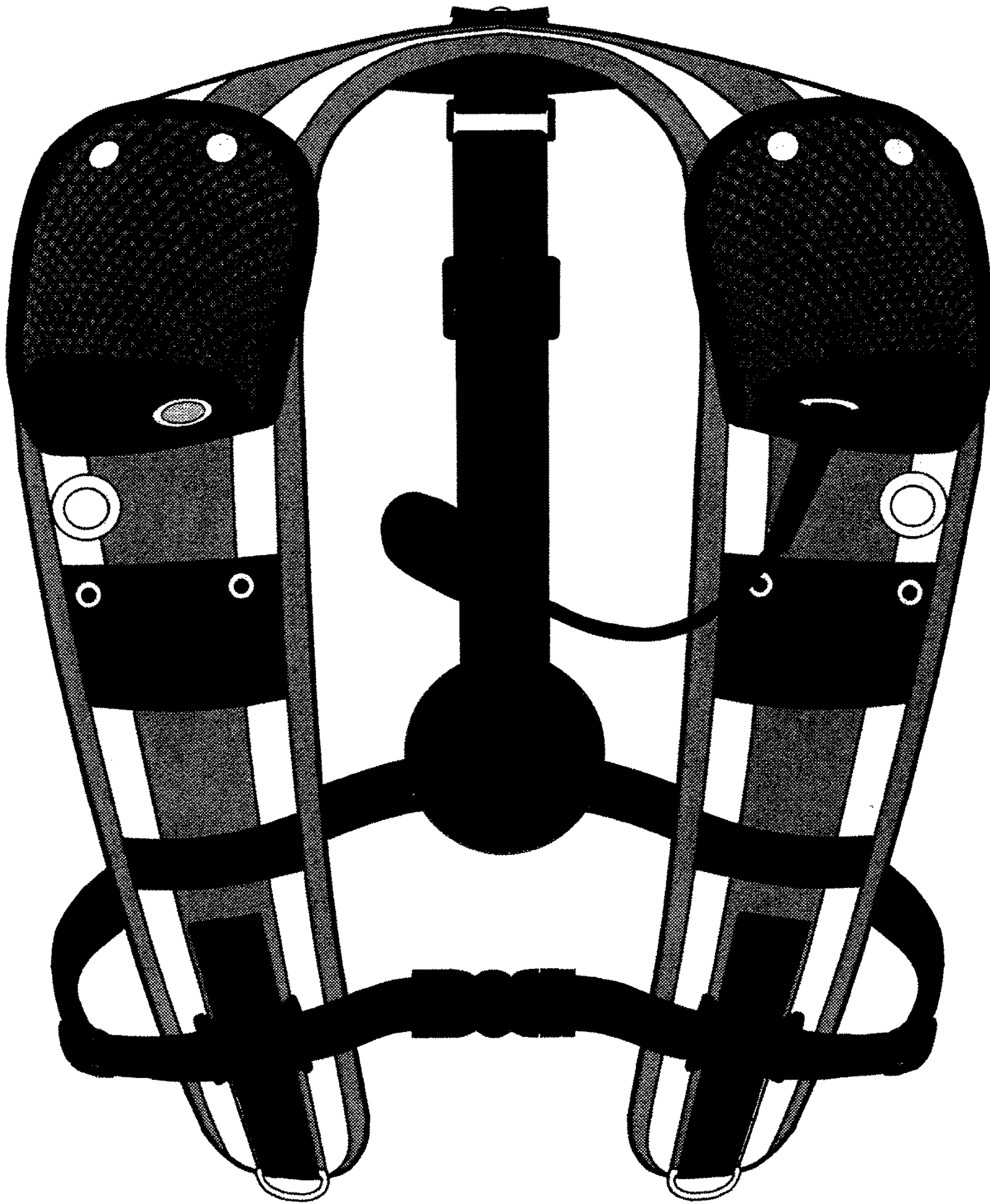

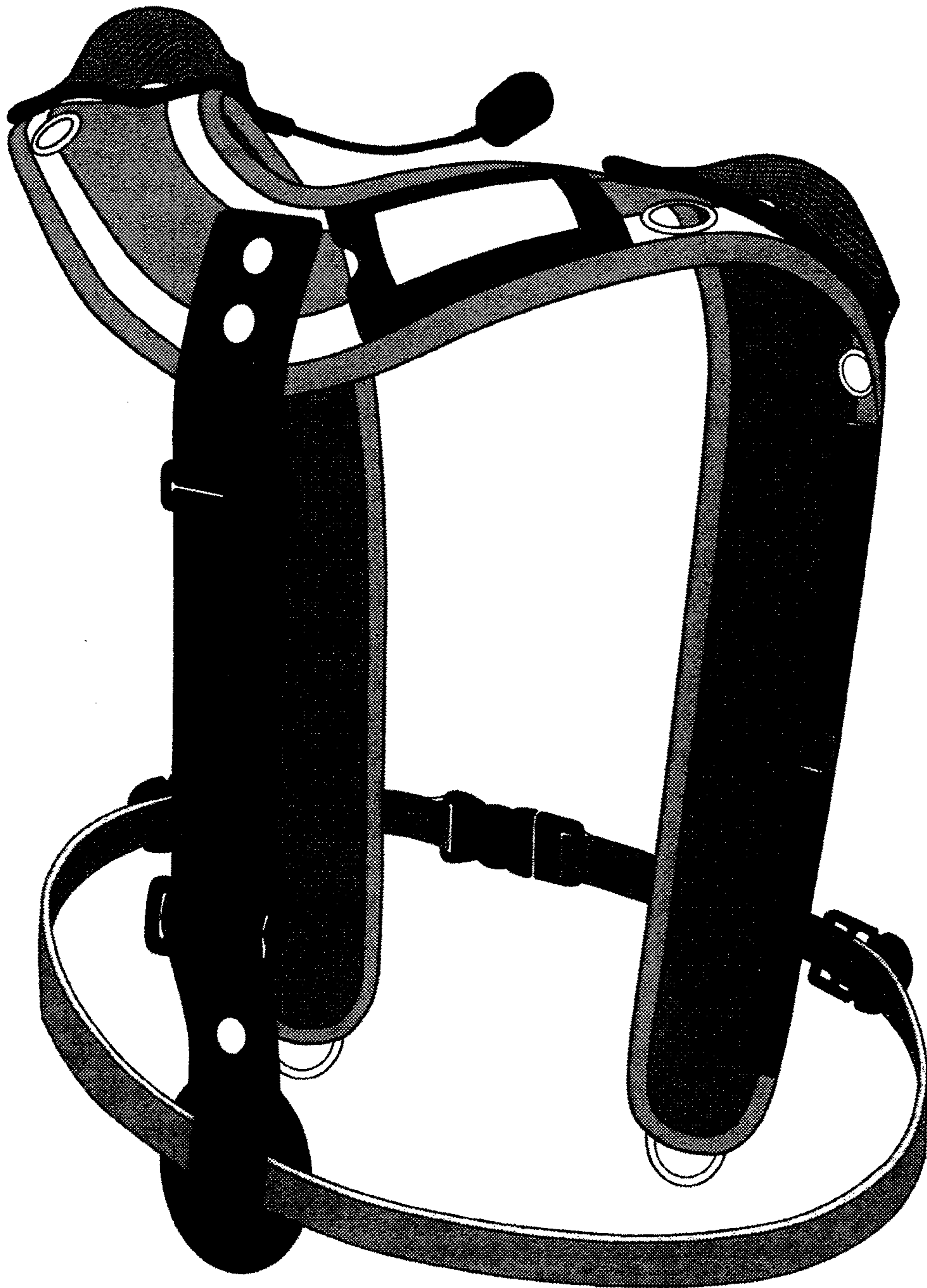
