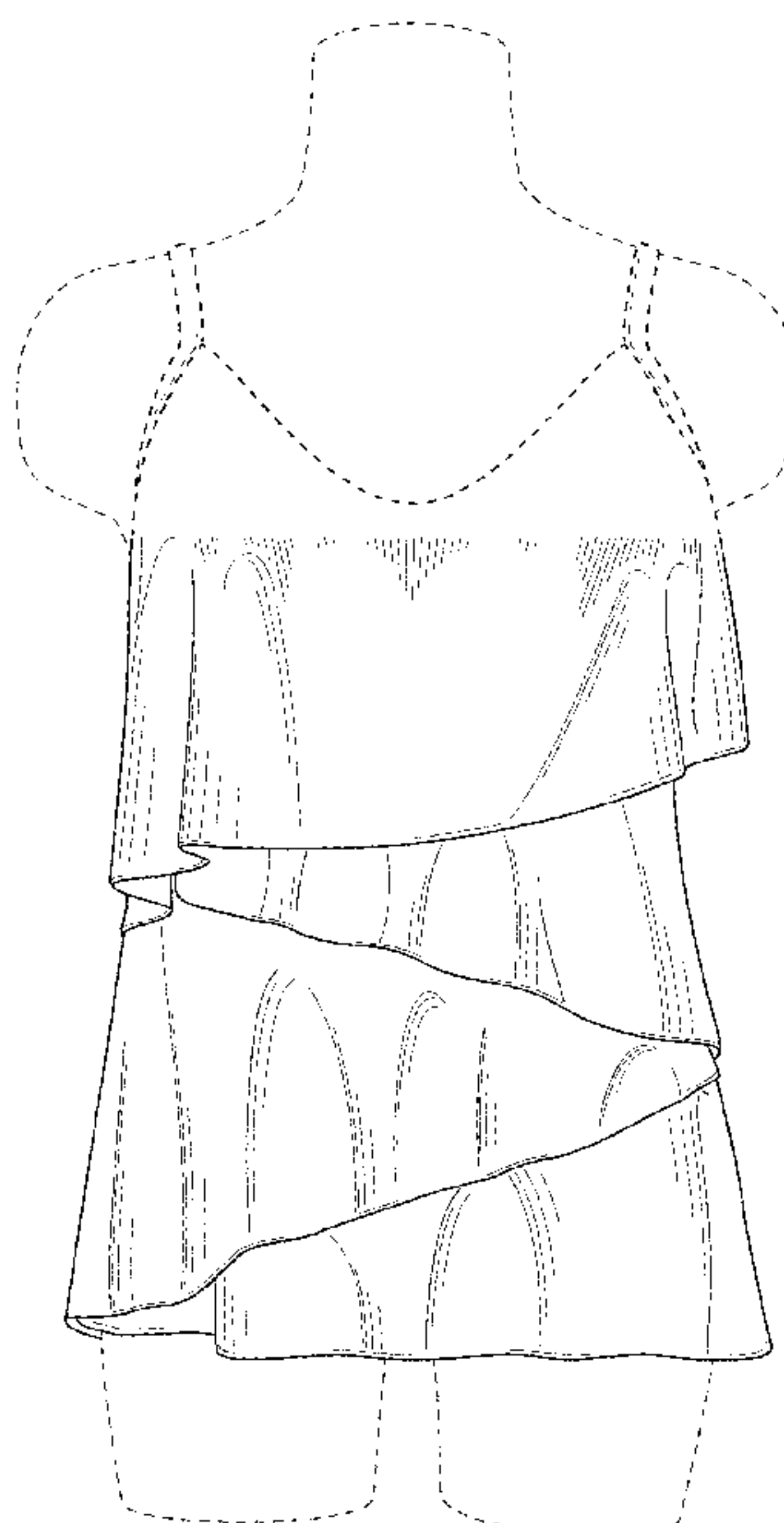

DESCRIPTION

FIG. 1 is a front view of a portion of a swimsuit on a model showing my new design according to the present invention. FIG. 2 is a rear view of the portion of the swimsuit of FIG. 1.
FIG. 3 is a right-side view of the portion of the swimsuit of FIG. 1; and,
FIG. 4 is a left-side view of the portion of the swimsuit of FIG. 1.
The broken lines formed by linear segments of equal length in FIGS. 1-4 are provided for environment only and form no part of the claimed design.

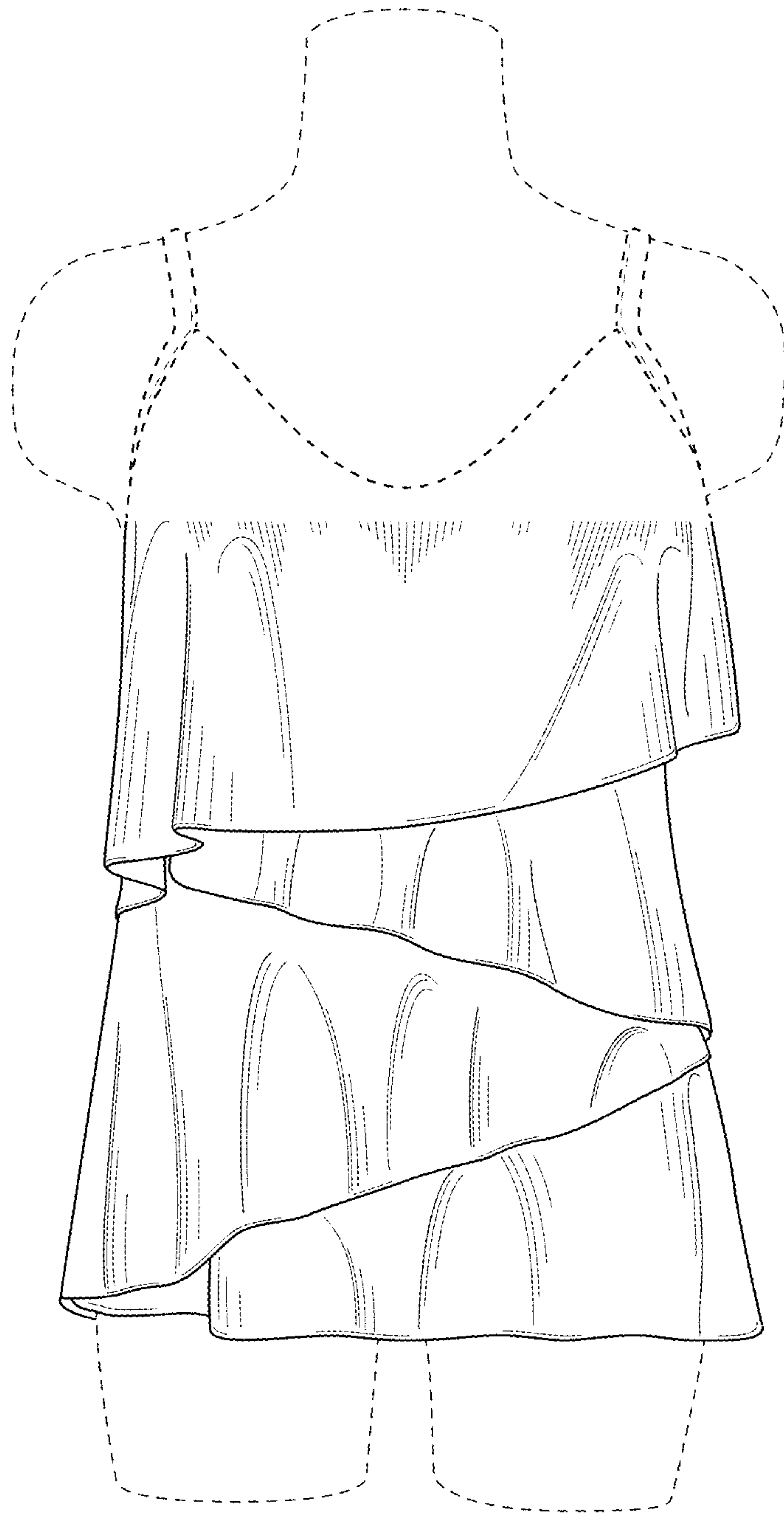

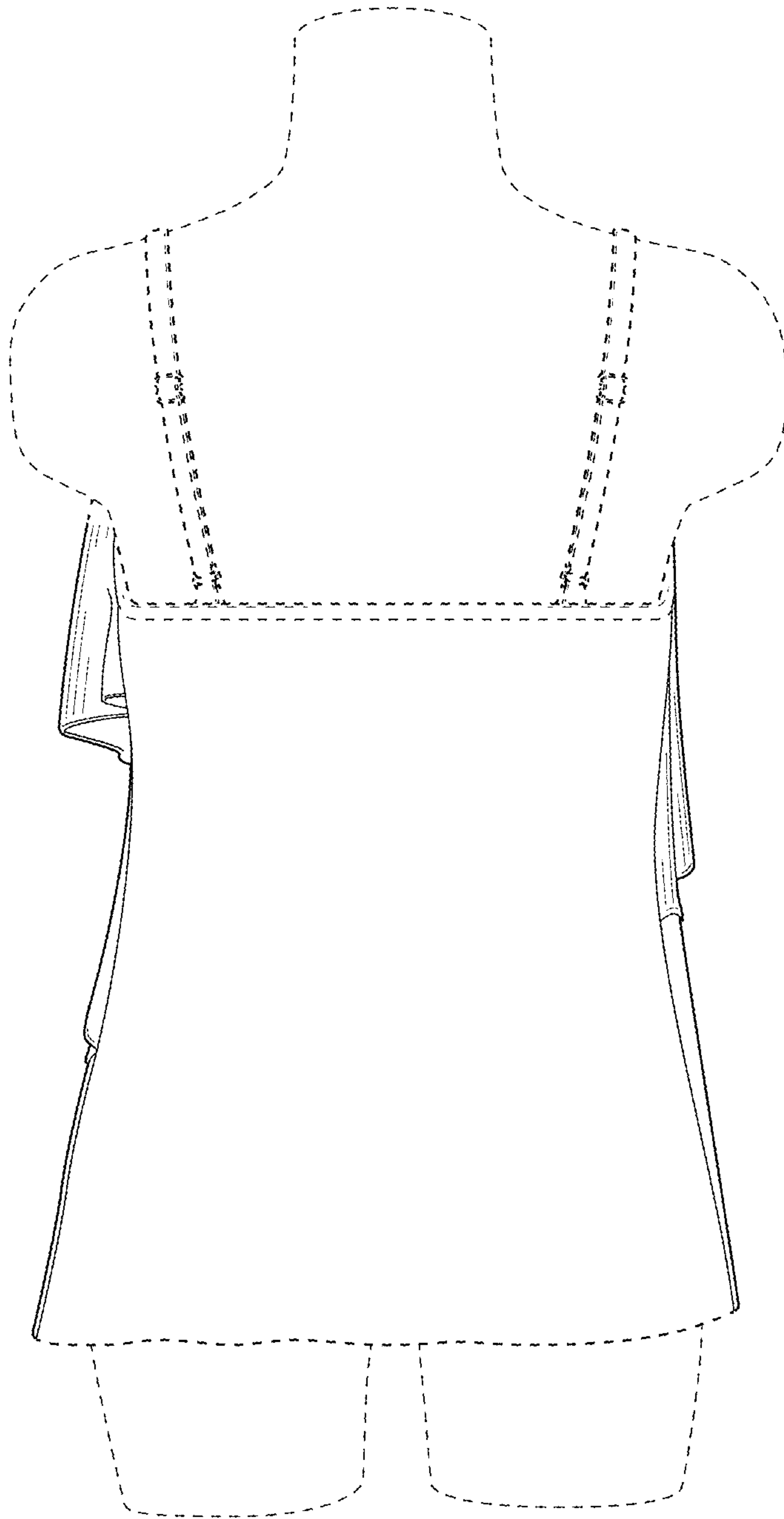

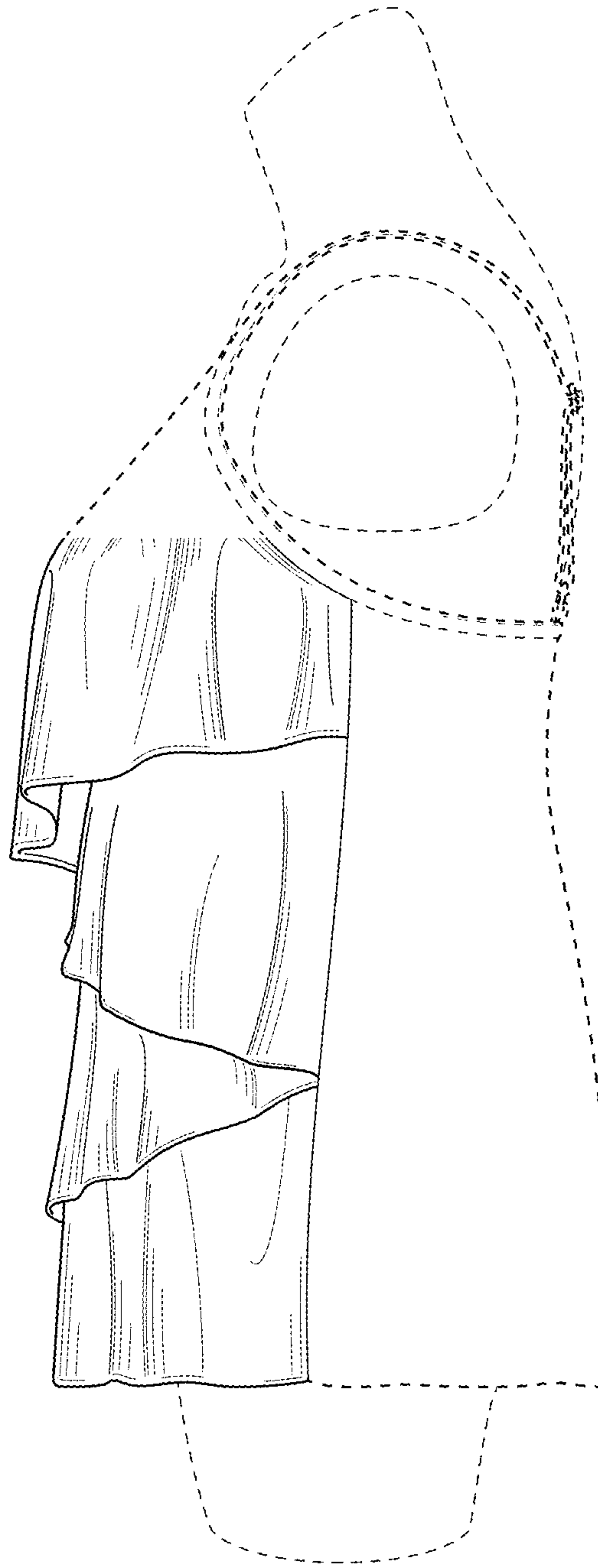

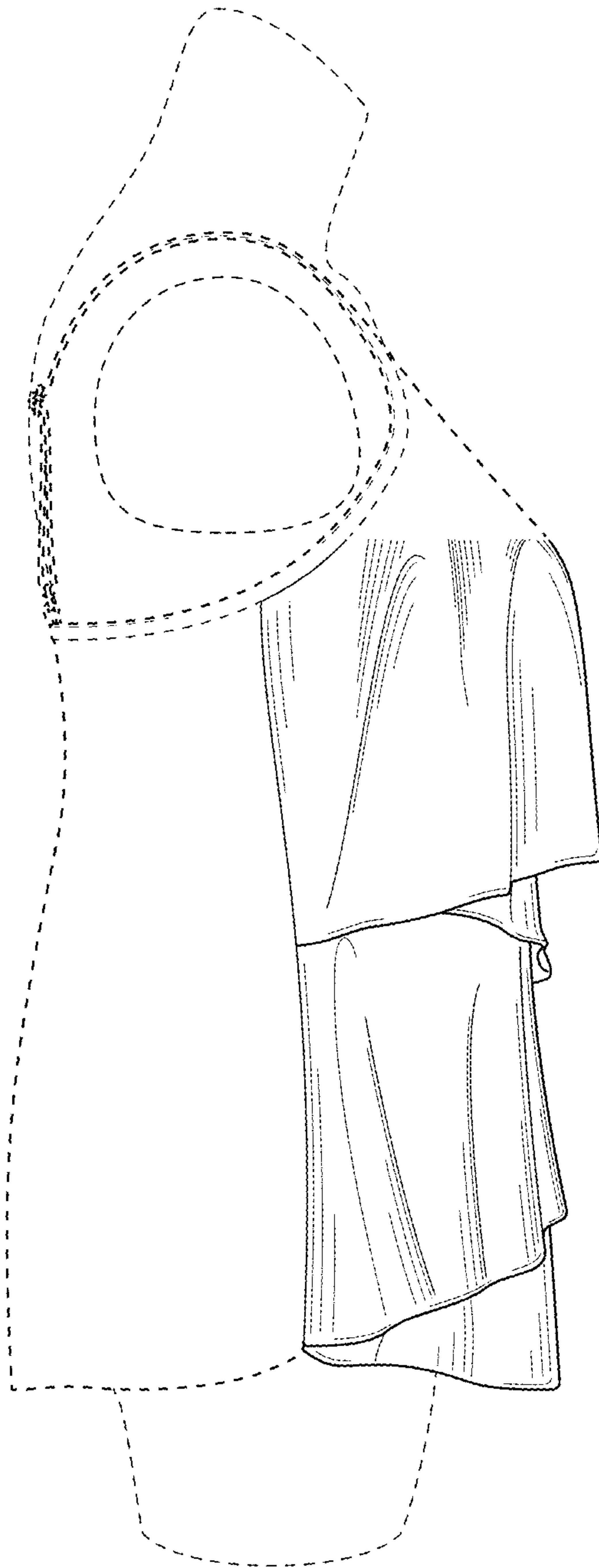
