FIG. 4 is lateral side view thereof.

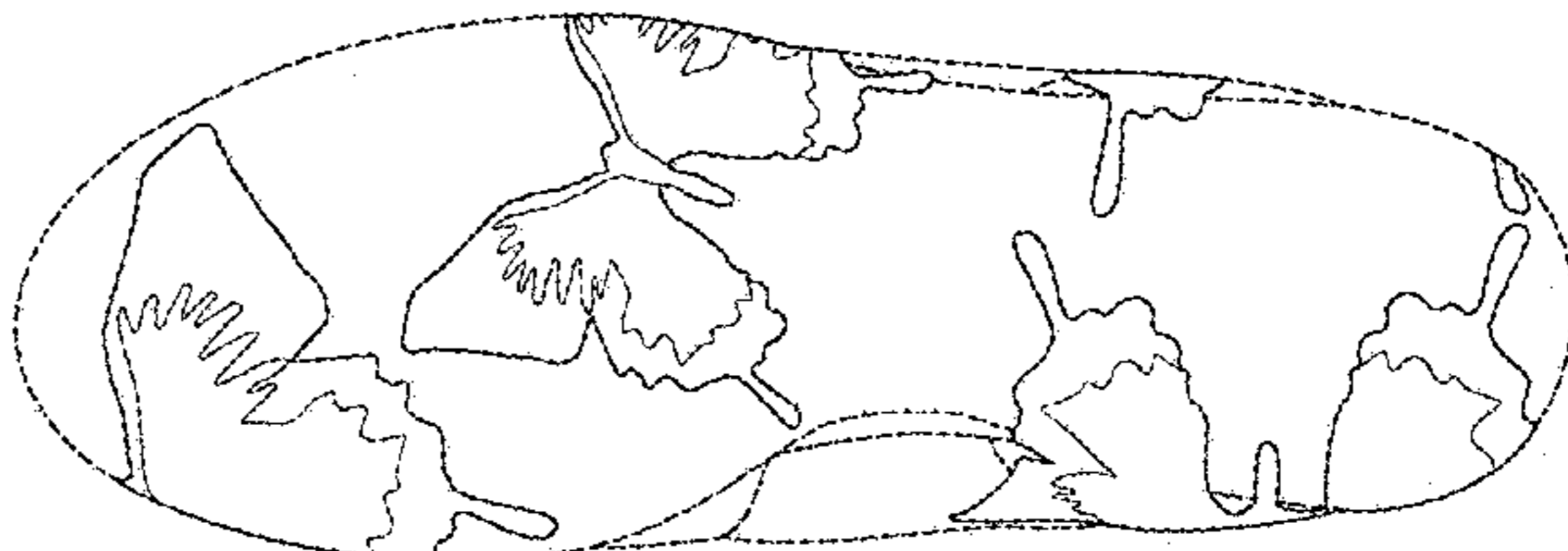
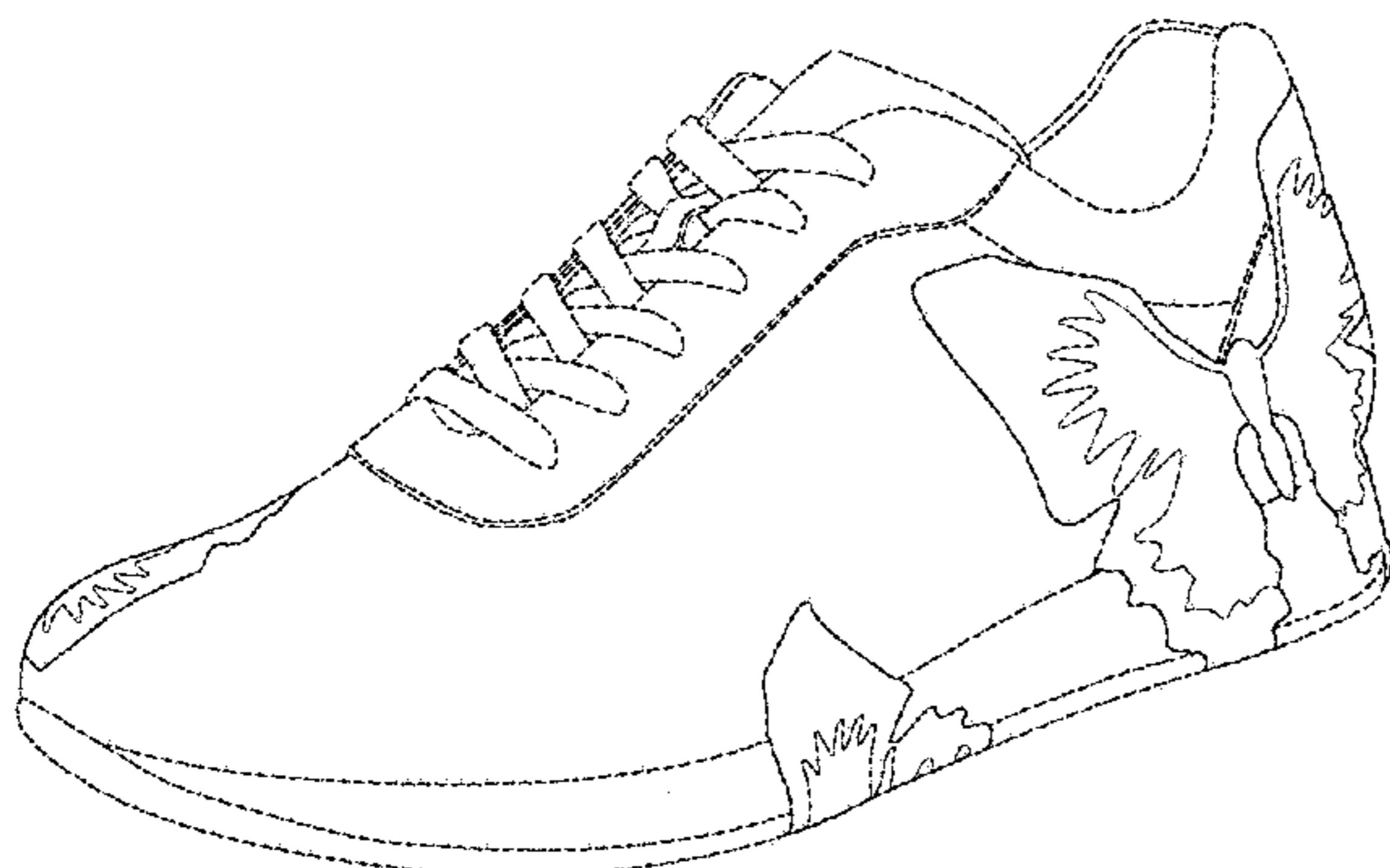
FIG. 5 is a medial side view thereof.

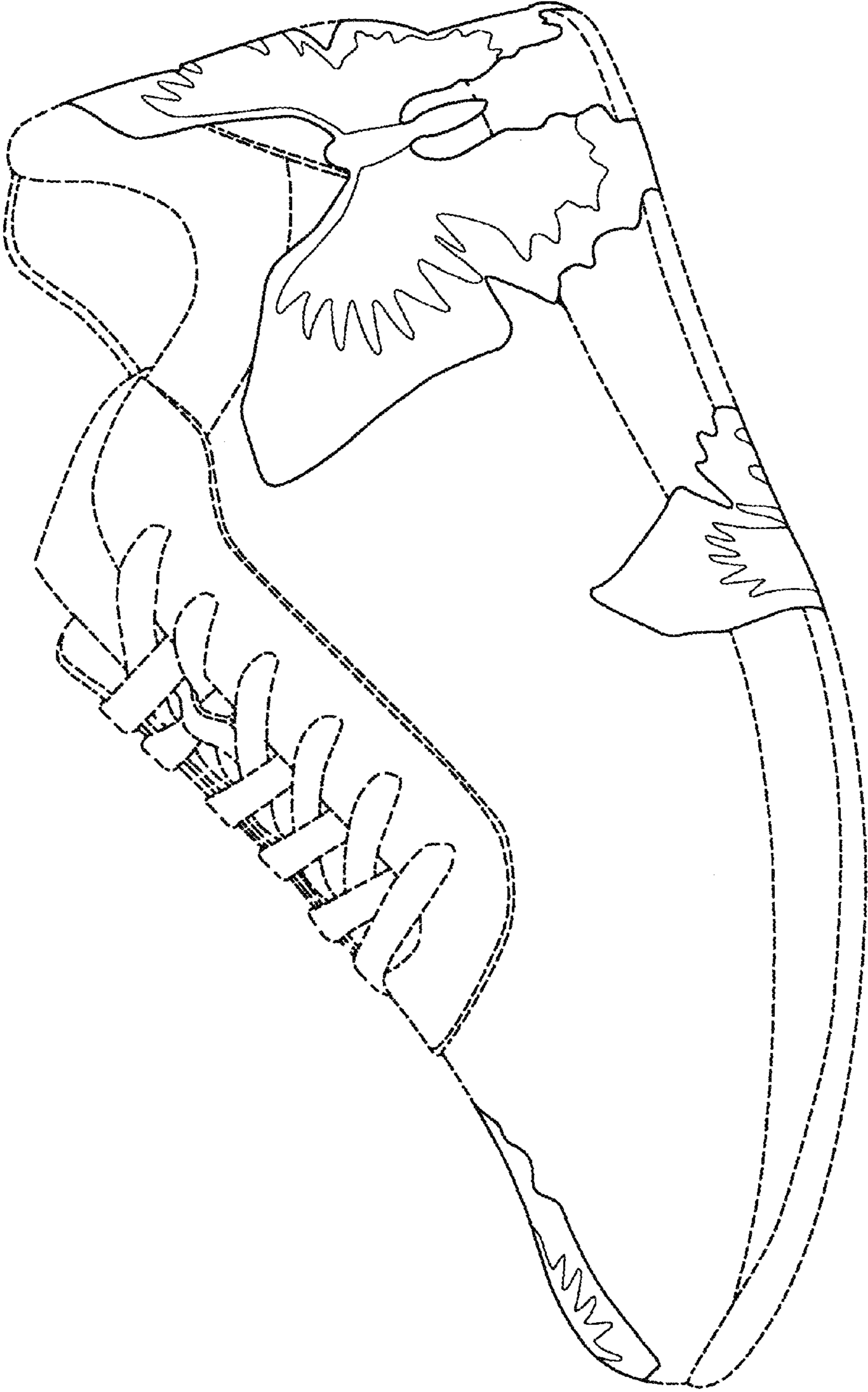

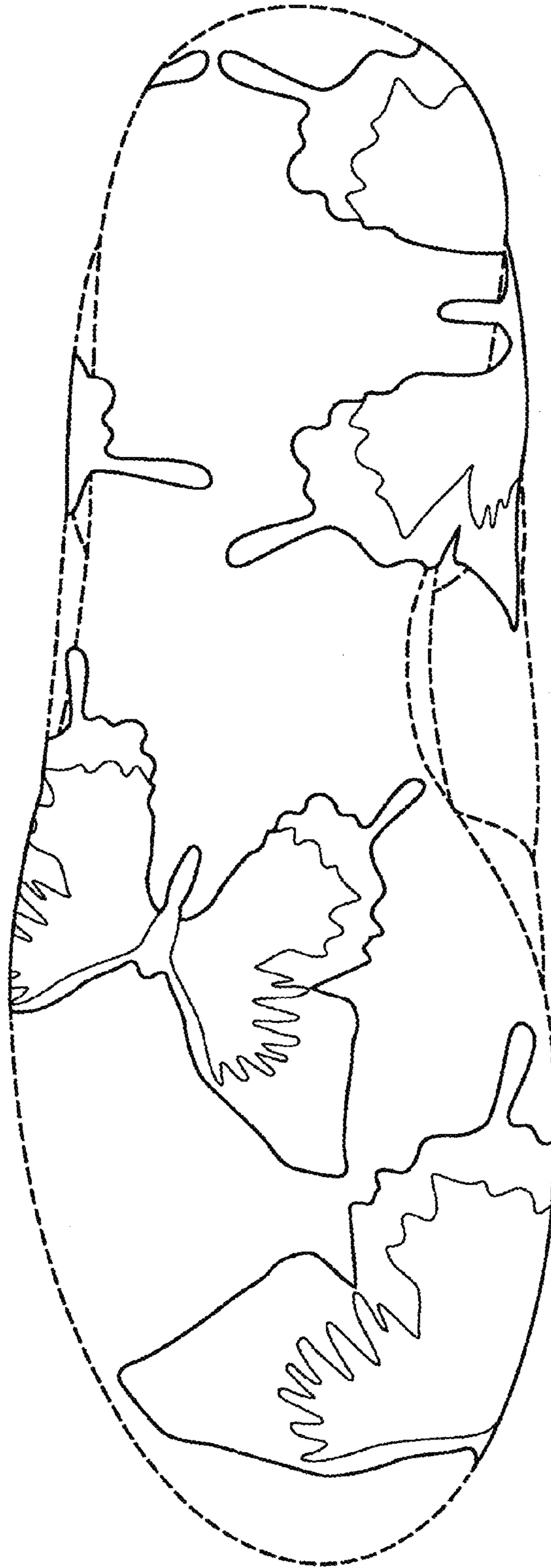

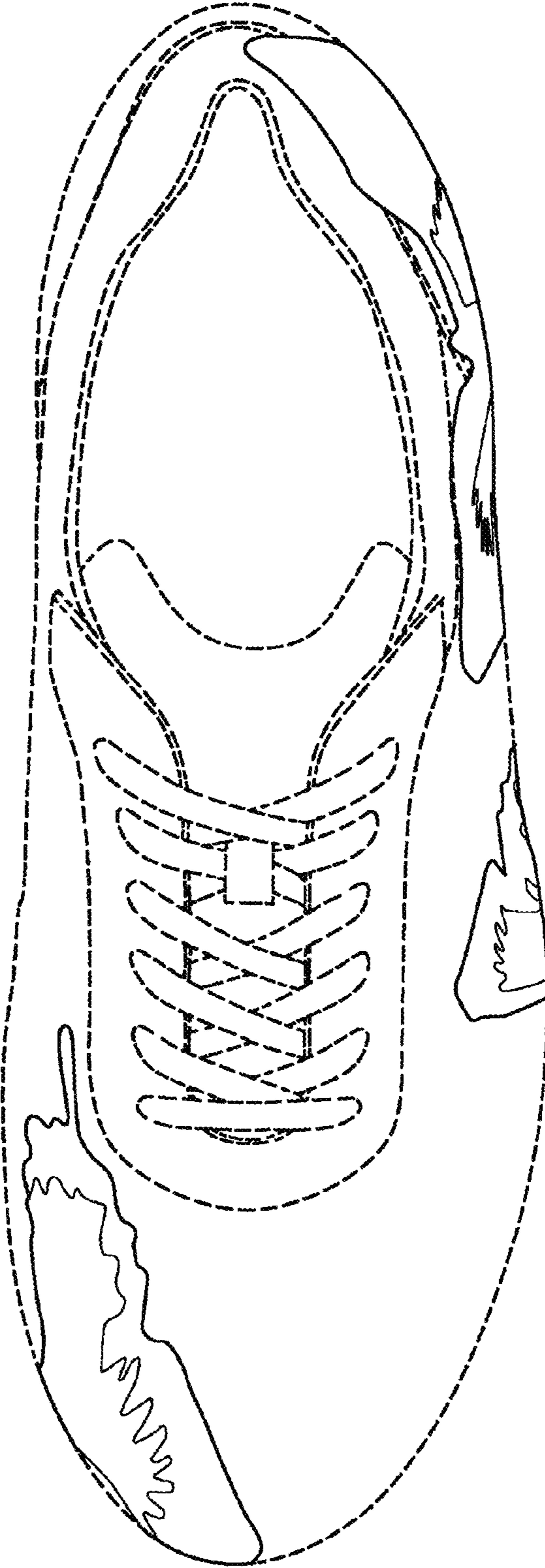

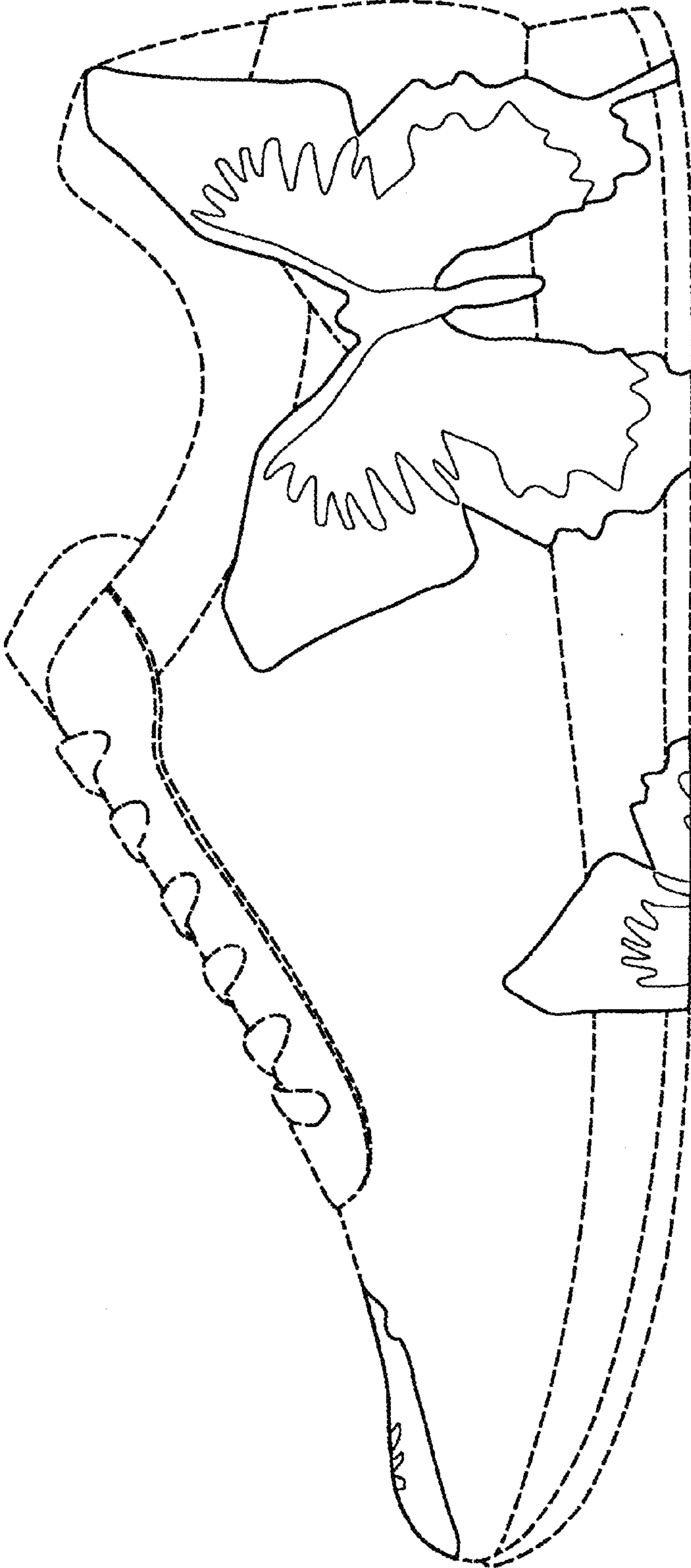

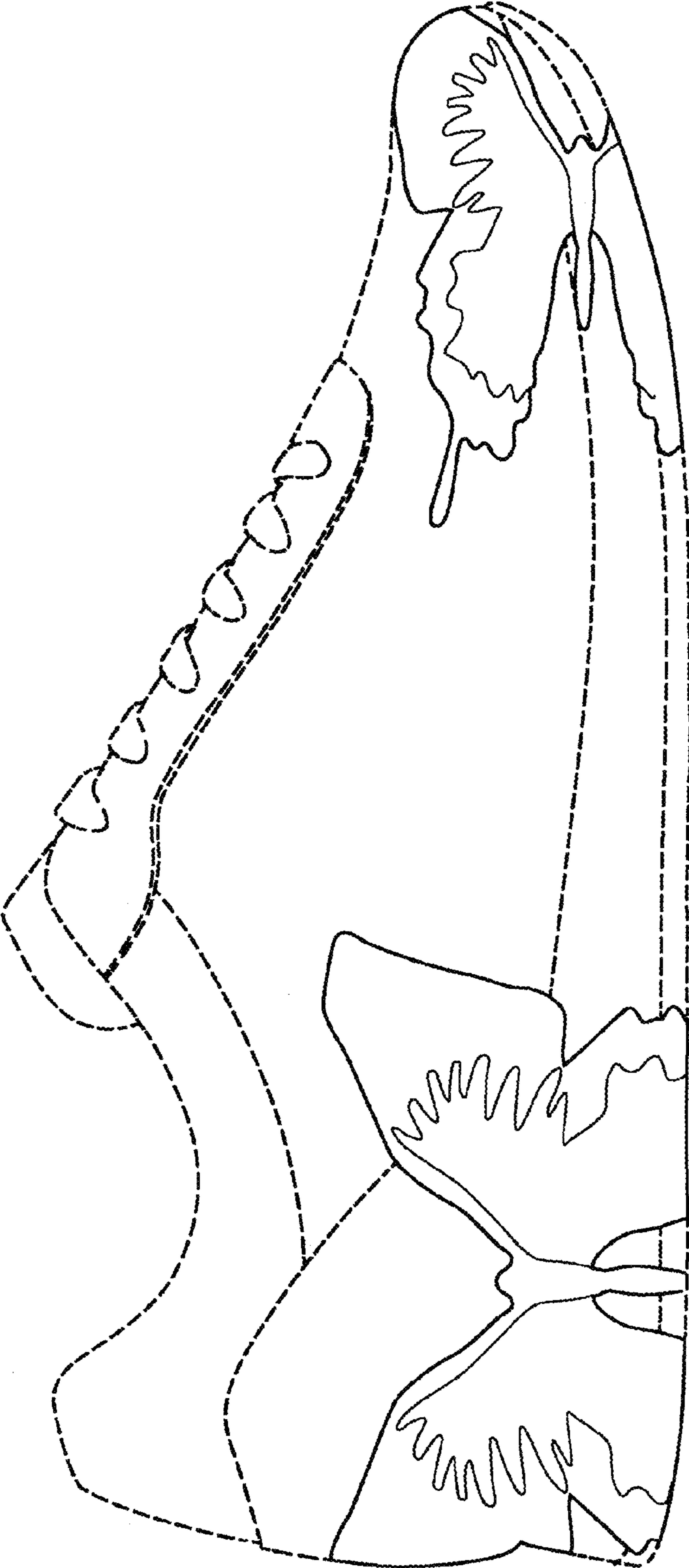

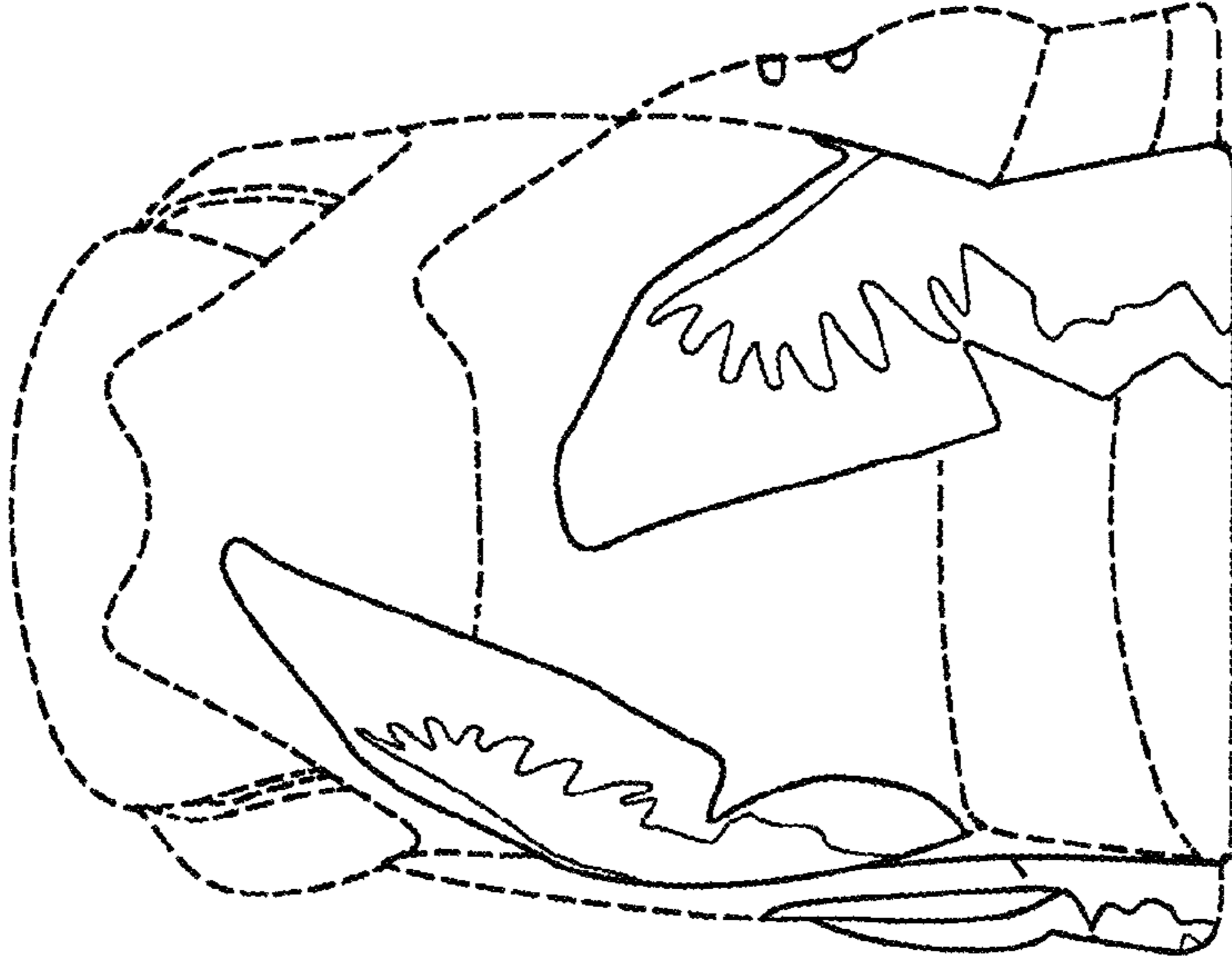

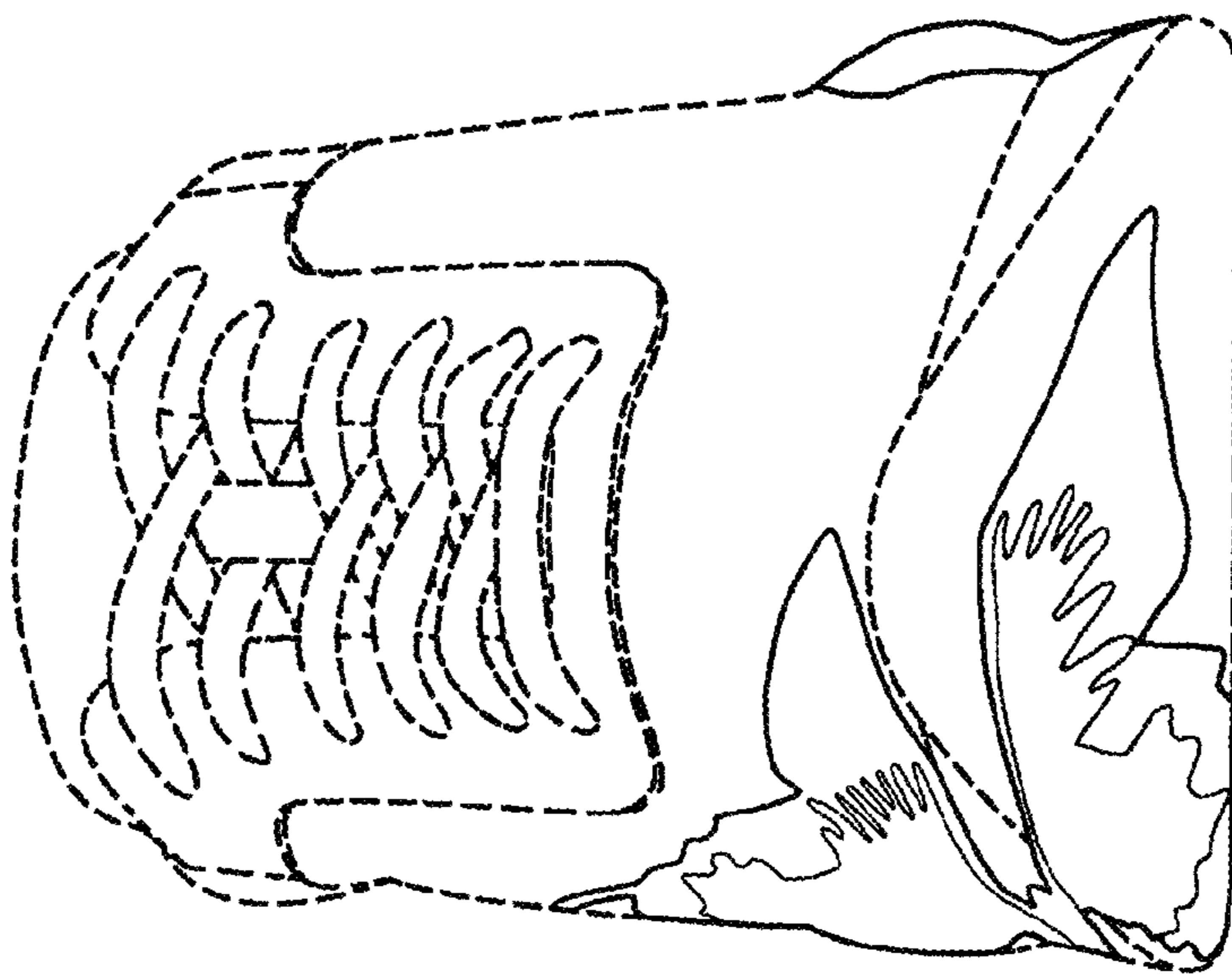
