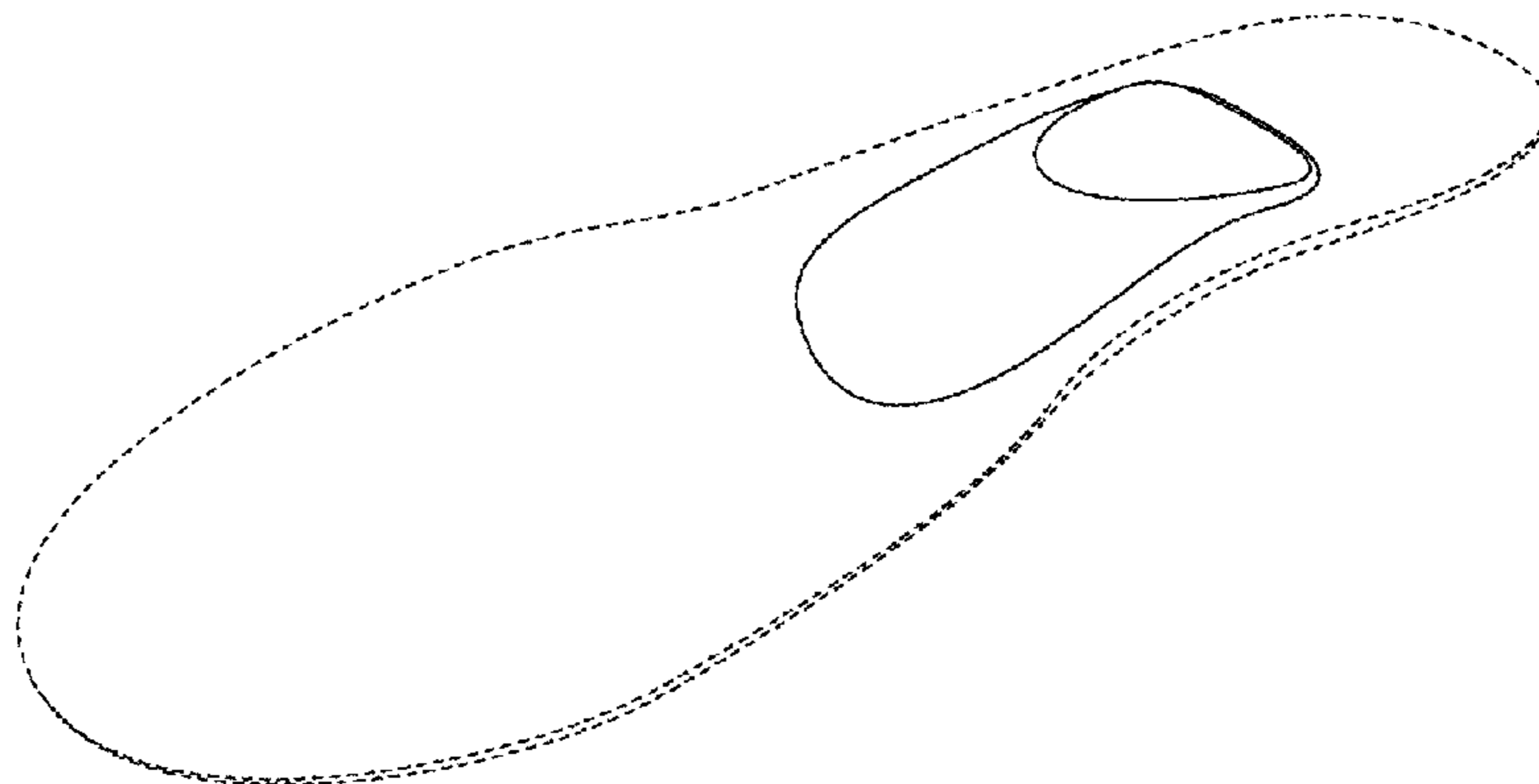
(57) **CLAIM**

The ornamental design for a footwear insole, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a footwear insole for a right foot, showing my new design;  
FIG. 2 is a back view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a left side view thereof;  
FIG. 7 is a cross sectional view thereof, taken along line VII-VII in FIG. 3;  
FIG. 8 is a cross sectional view thereof, taken along line VIII-VIII in FIG. 3;  
FIG. 9 is a perspective view thereof; and,  
FIG. 10 is a cross sectional view thereof, taken along line X-X in FIG. 3, shown in a used condition with a human foot shown in broken lines.  
The footwear insole for the left foot is a mirror image of the footwear insole for the right foot.  
The broken line showing is included for the purpose of illustrating and forms no part of the claimed design.

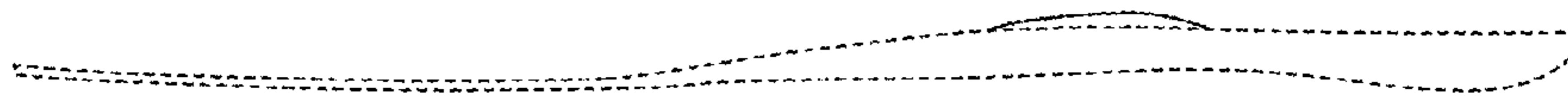

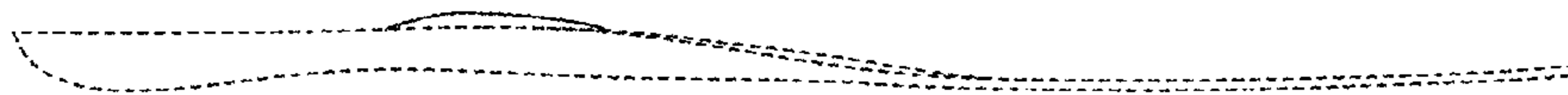

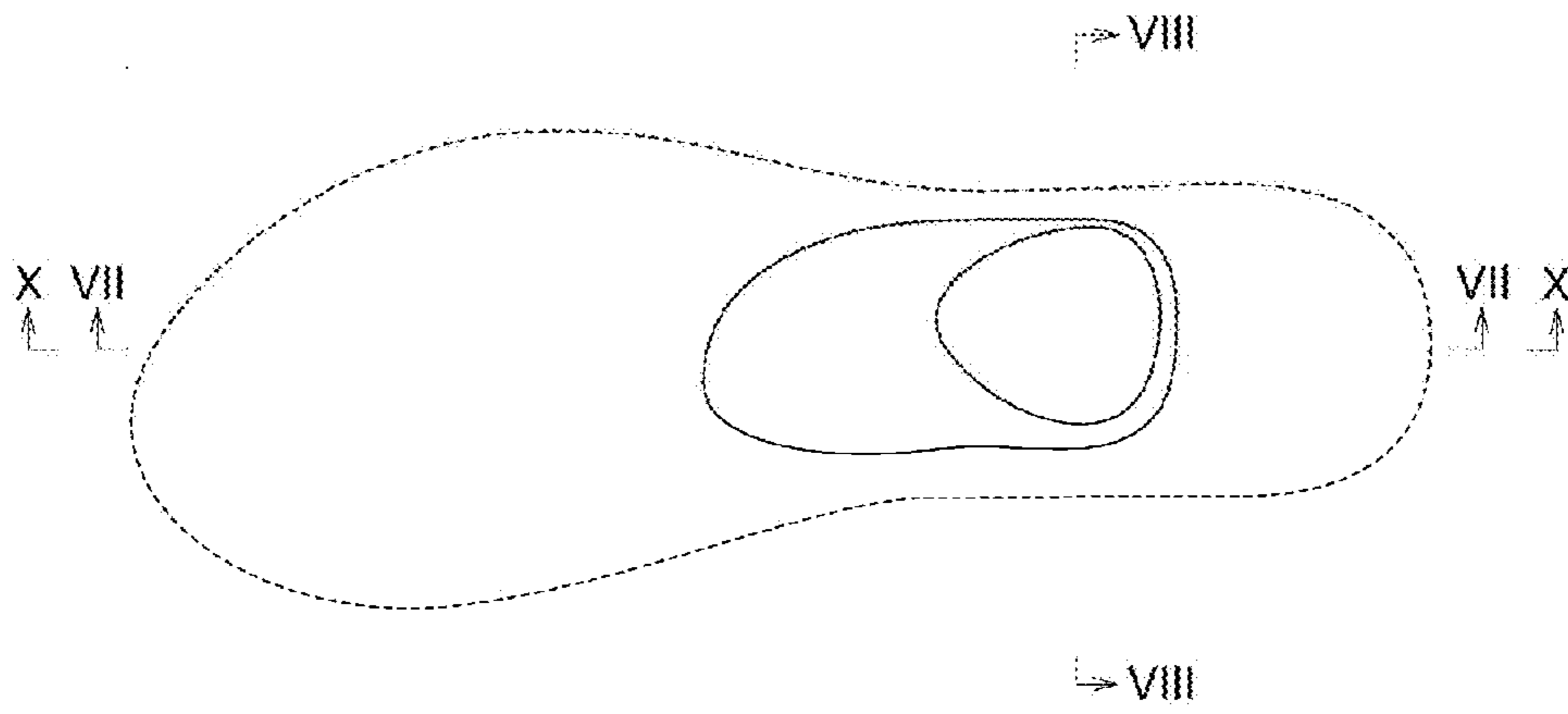

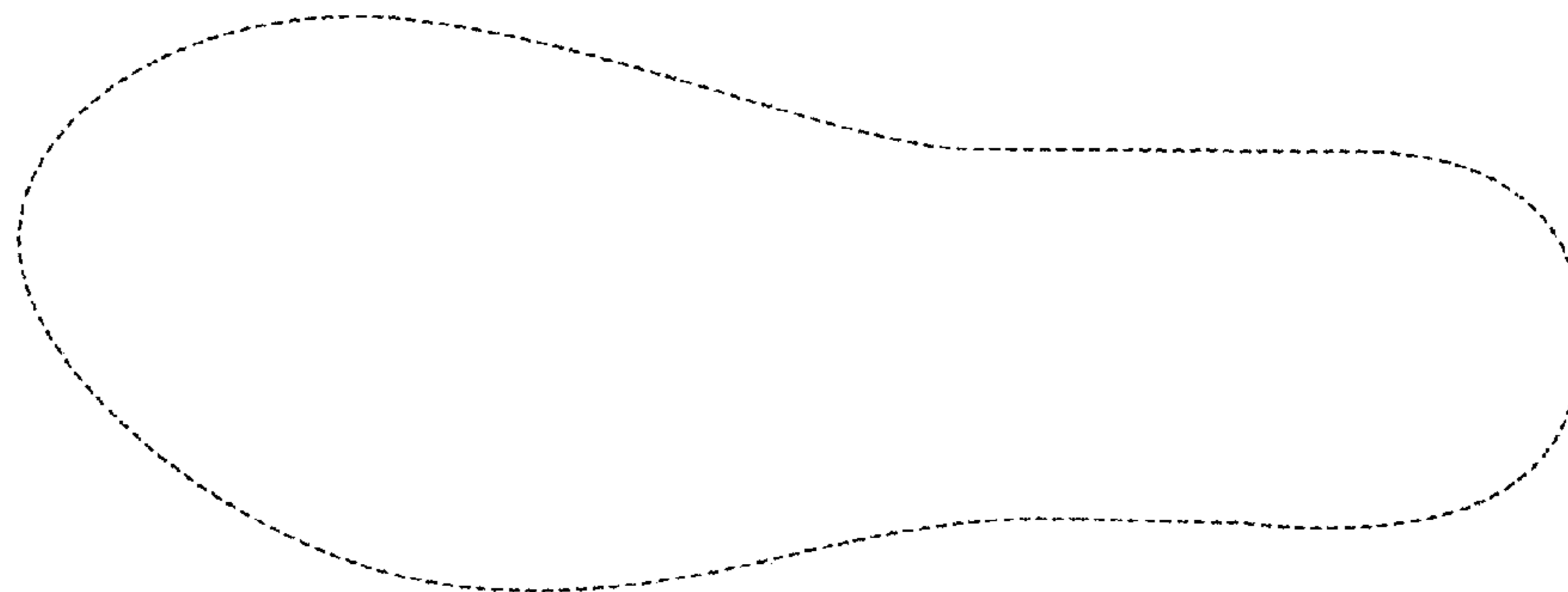

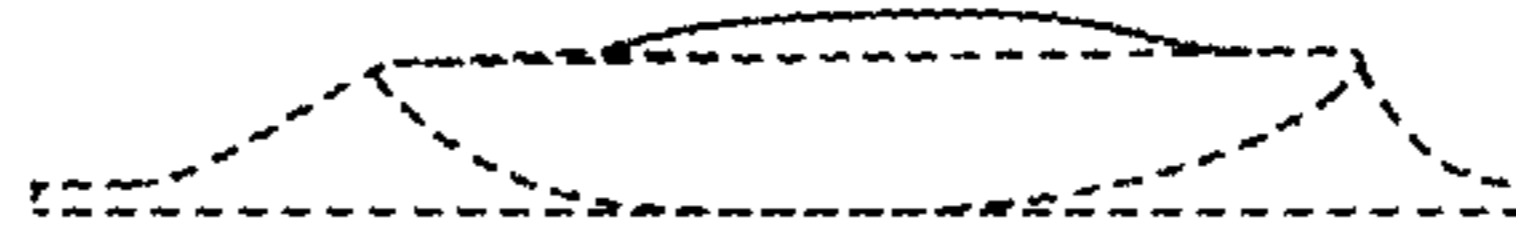

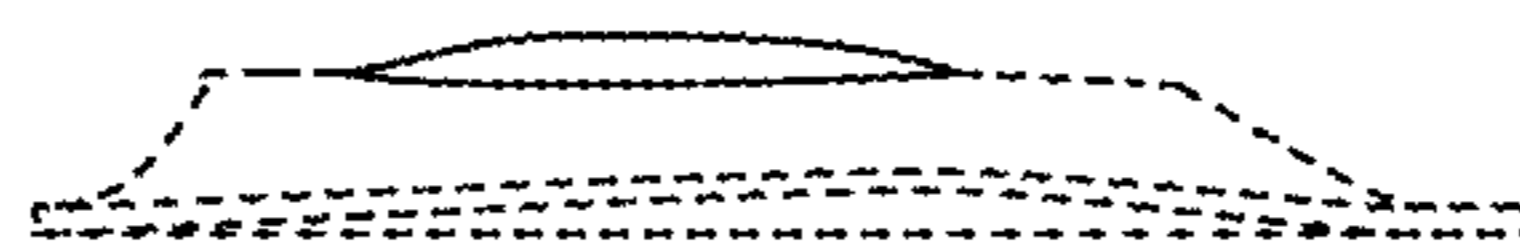

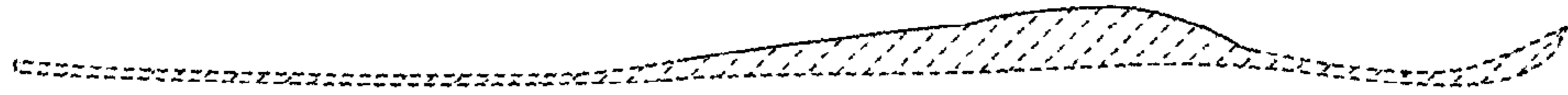

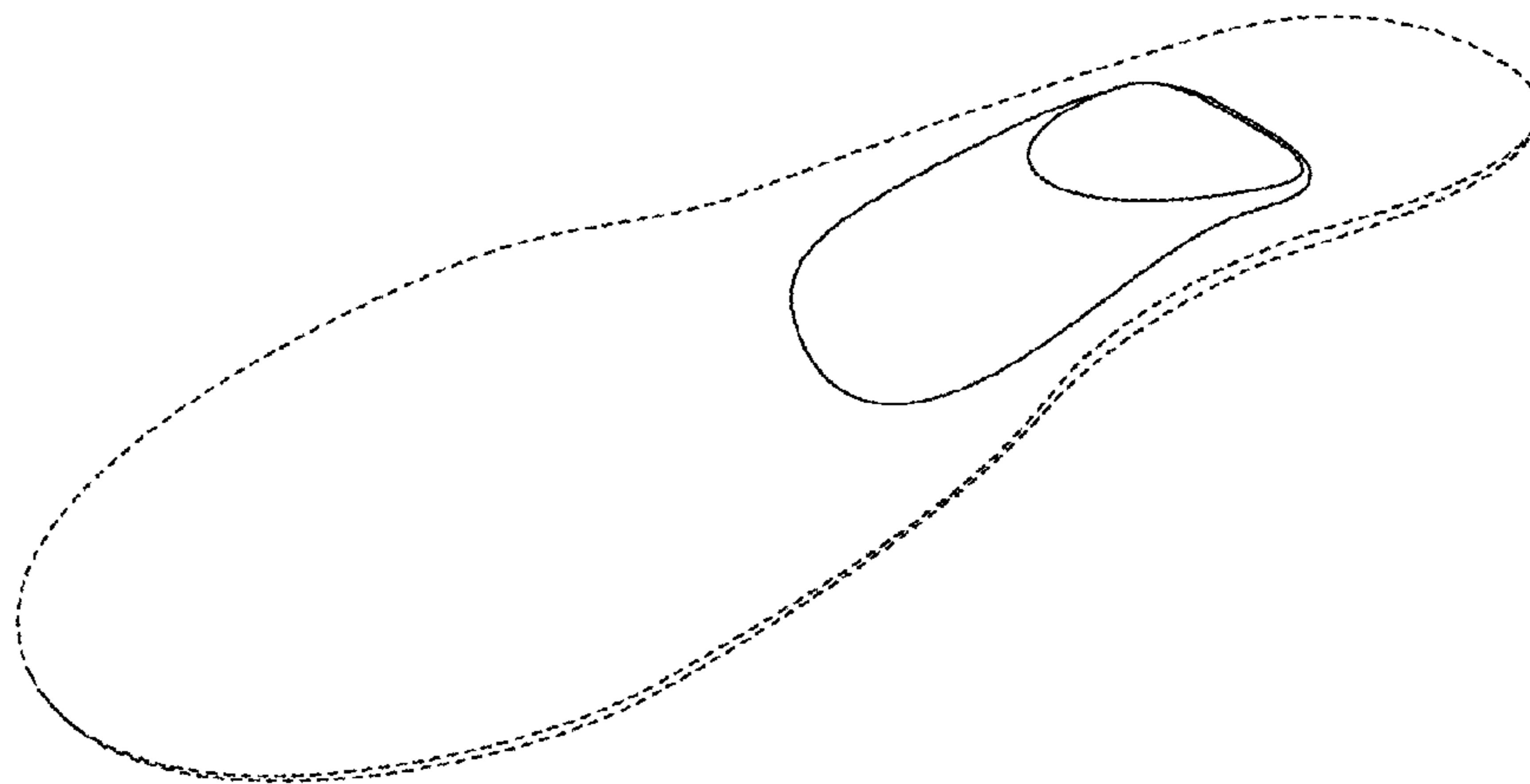
