(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front lateral perspective view of an embodiment of a shoe, it being understood that there is no claim being made to the sole.

FIG. 2 is a lateral side view of the shoe of FIG. 1.

FIG. 3 is a medial side view of the shoe of FIG. 1.

FIG. 4 is a front view of the shoe of FIG. 1.

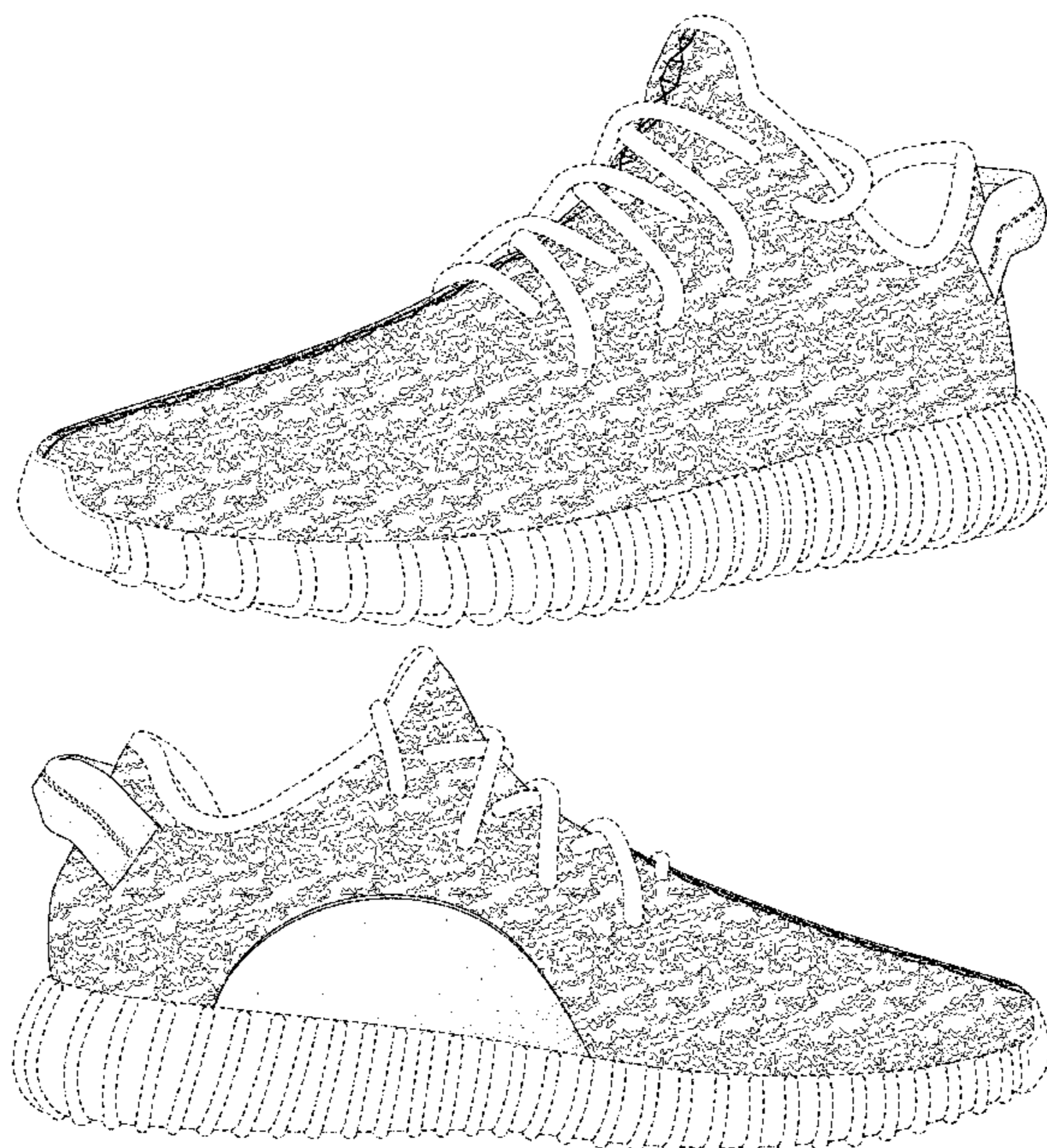
FIG. 5 is a rear view of the shoe of FIG. 1; and,

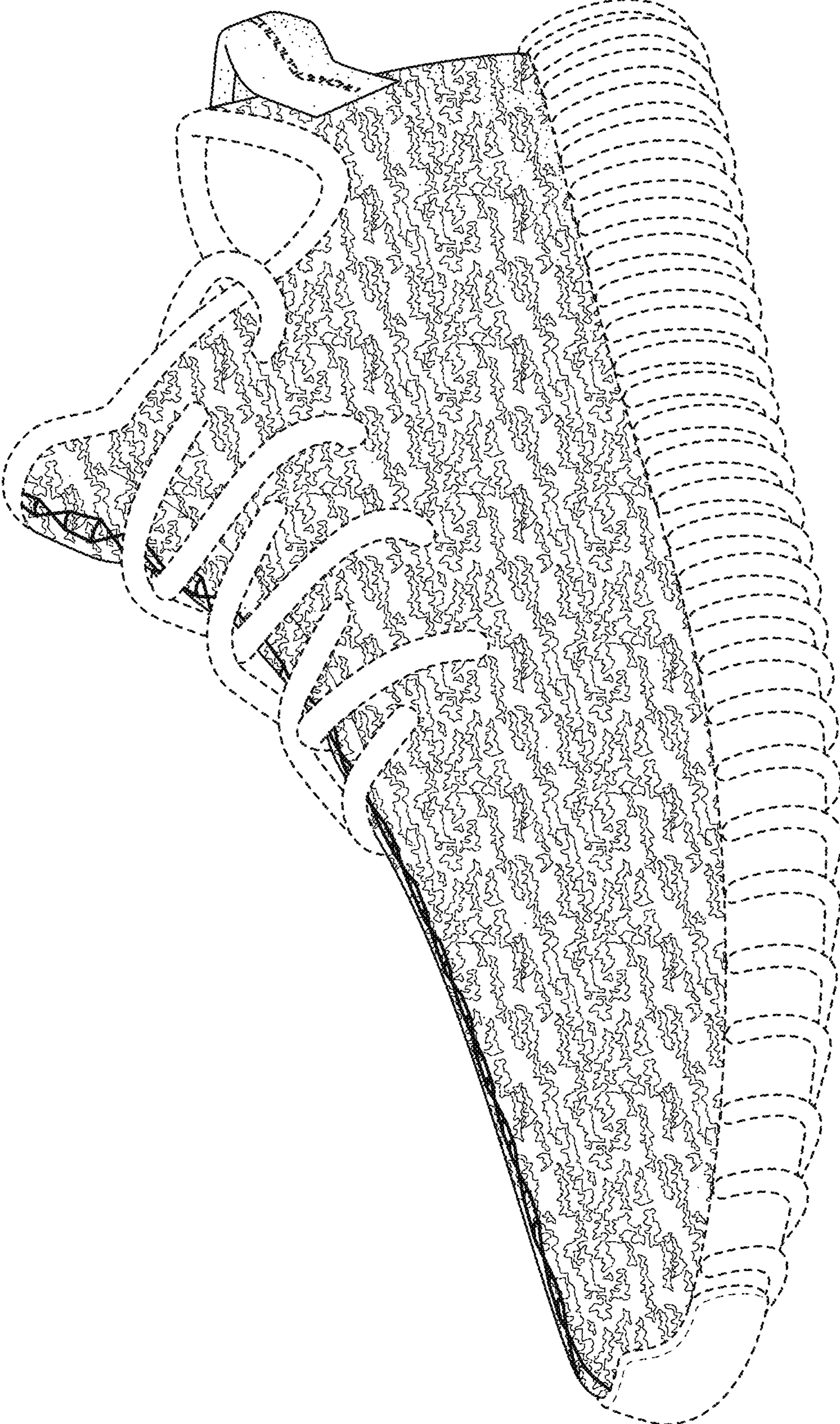

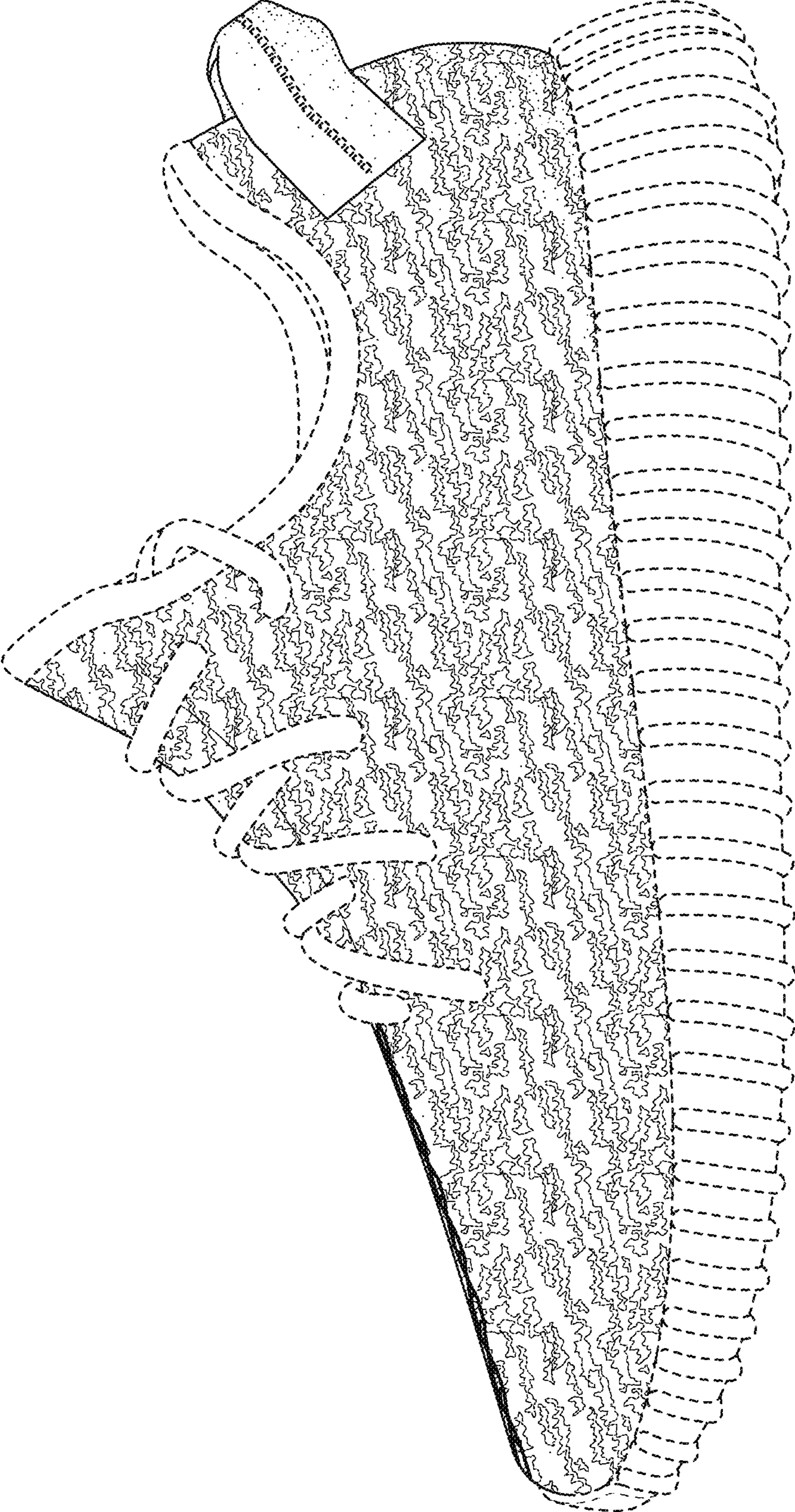

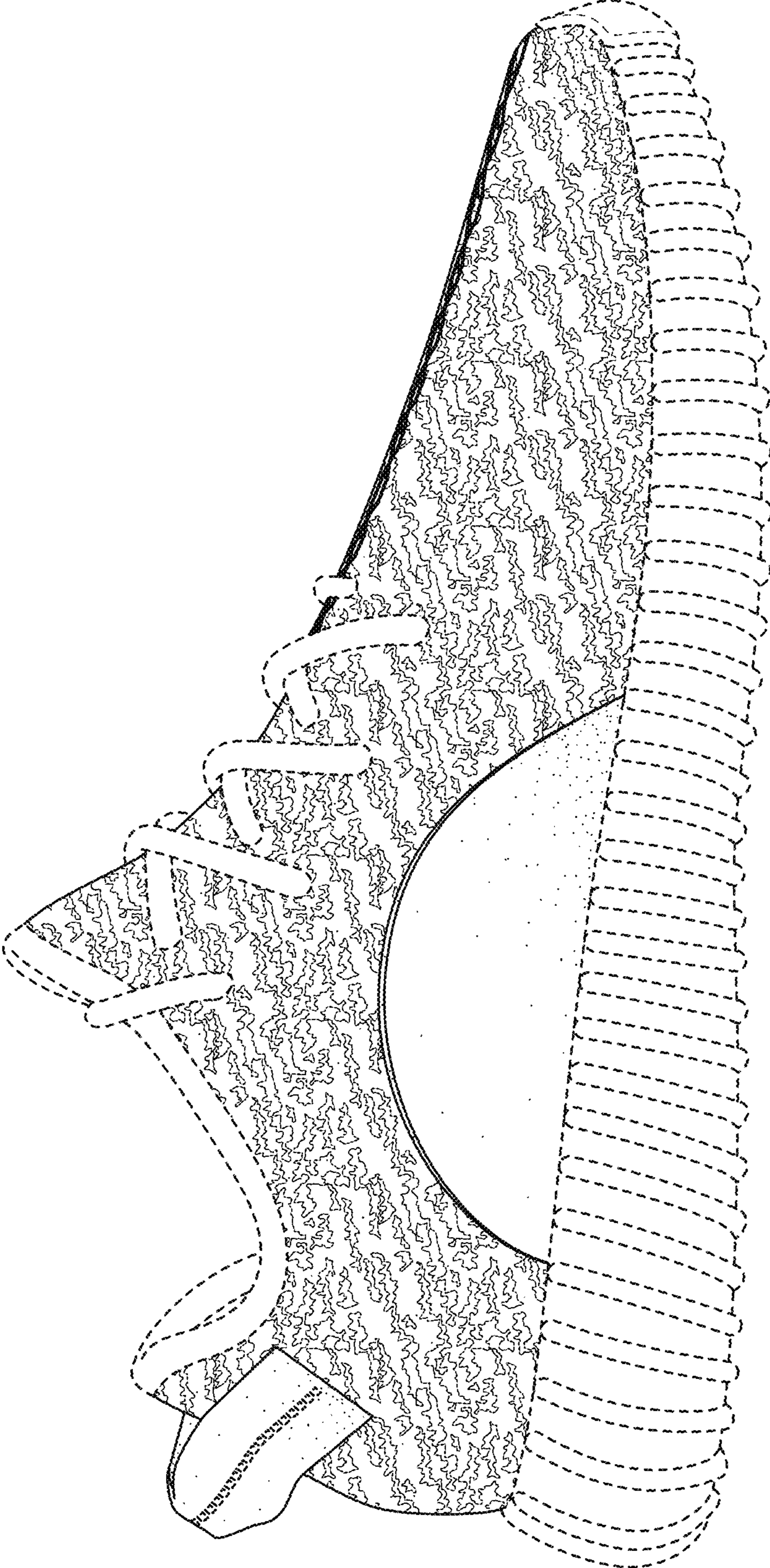

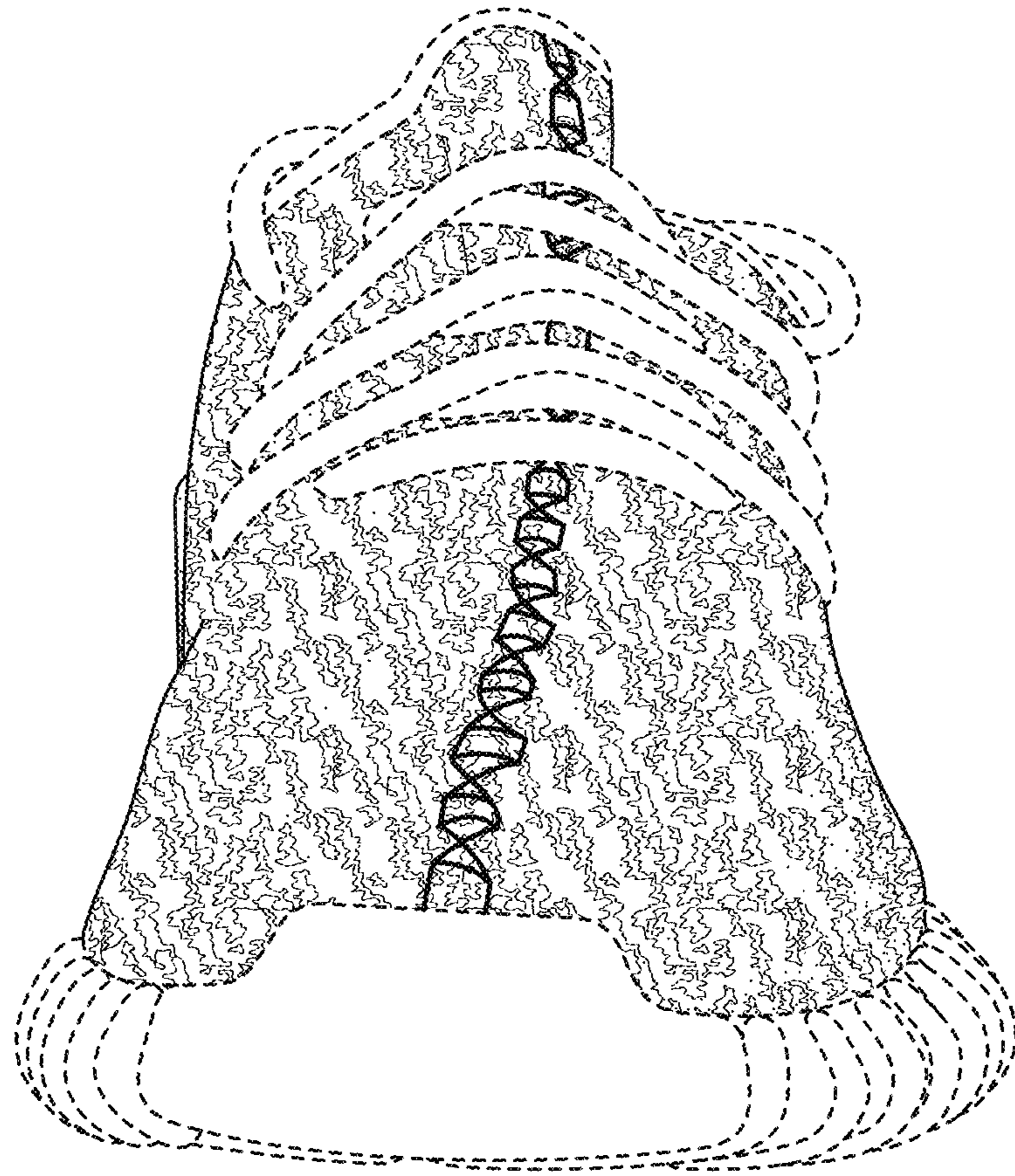

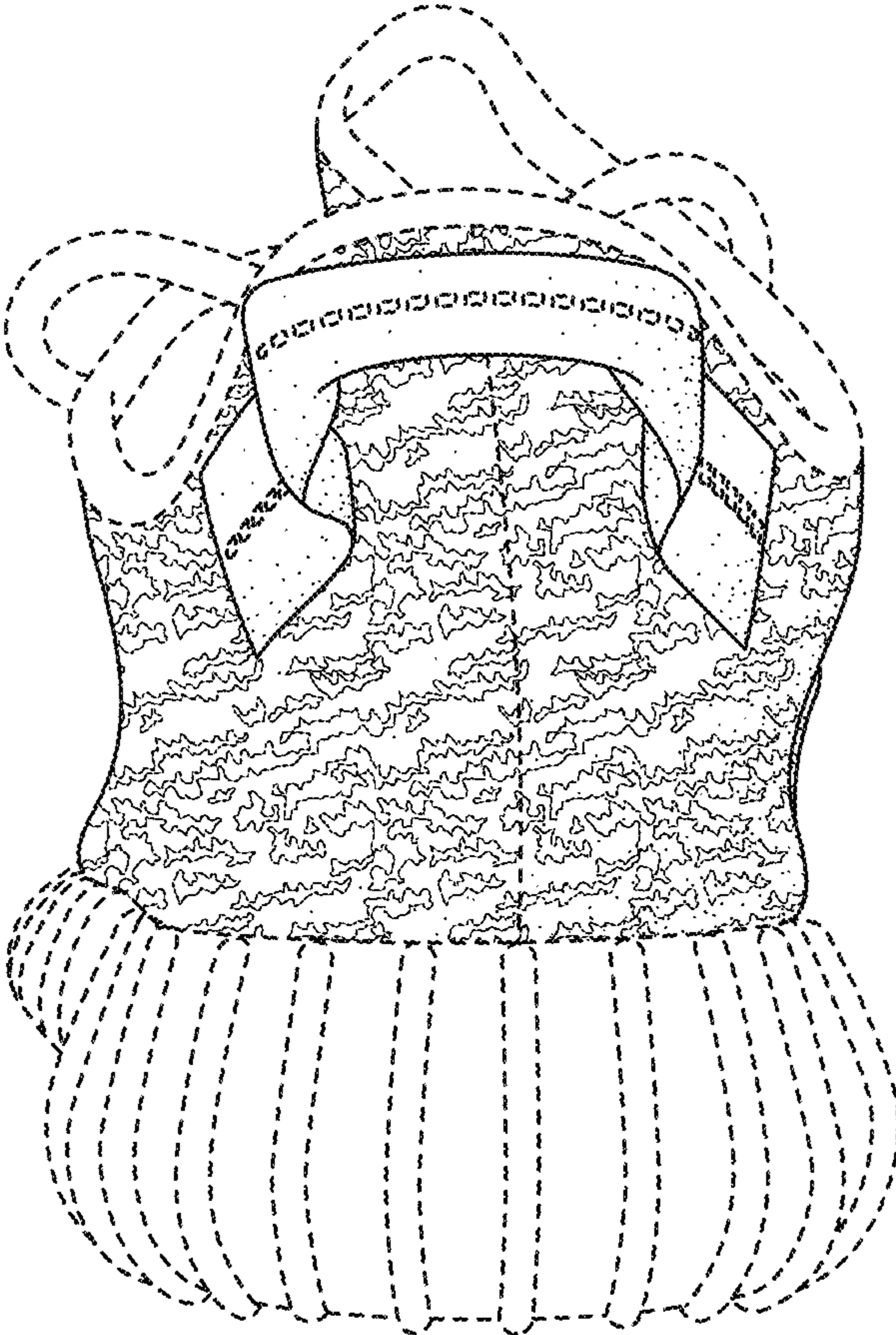

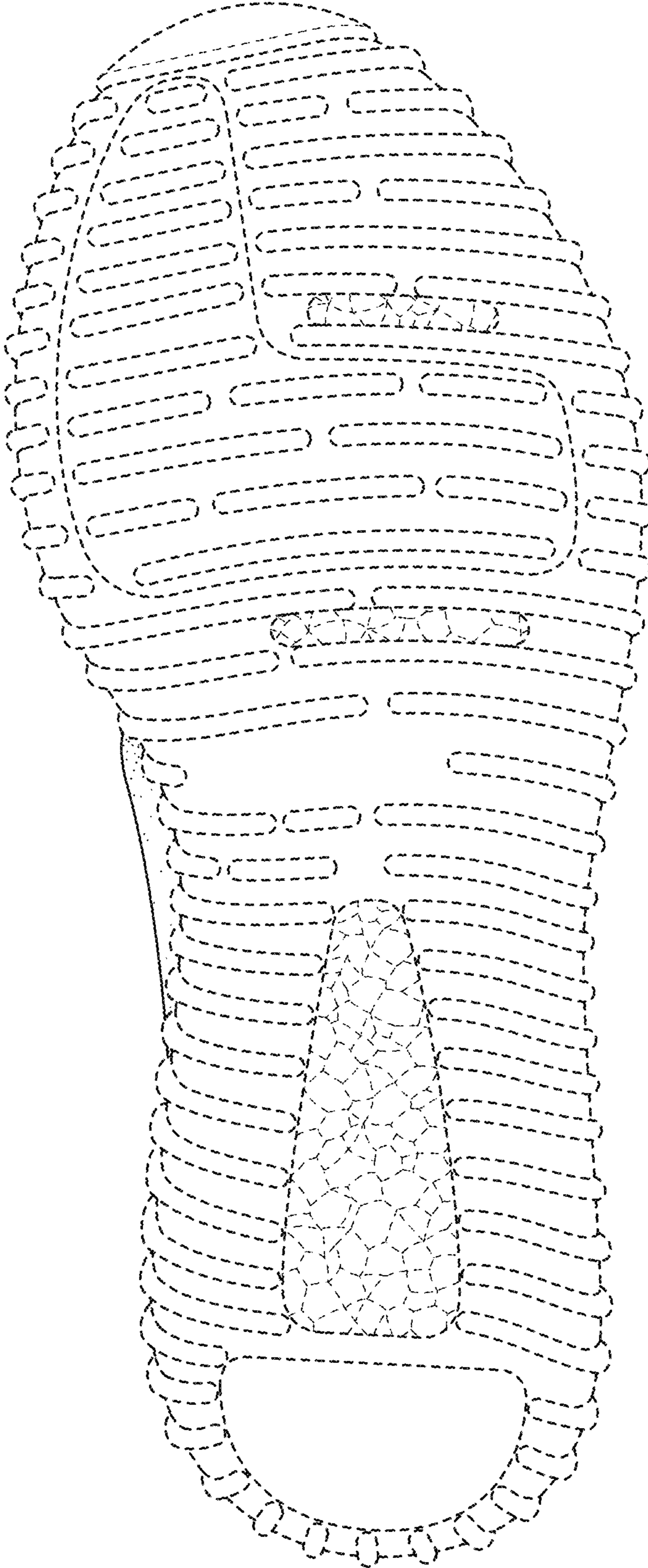
