FIG. 5 is a top plan view thereof, shown in a closed position;

FIG. 6 is a left side elevational view thereof, shown in a closed position;

FIG. 7 is a front view thereof, shown in an open position;

FIG. 8 is a rear view thereof, shown in an open position;

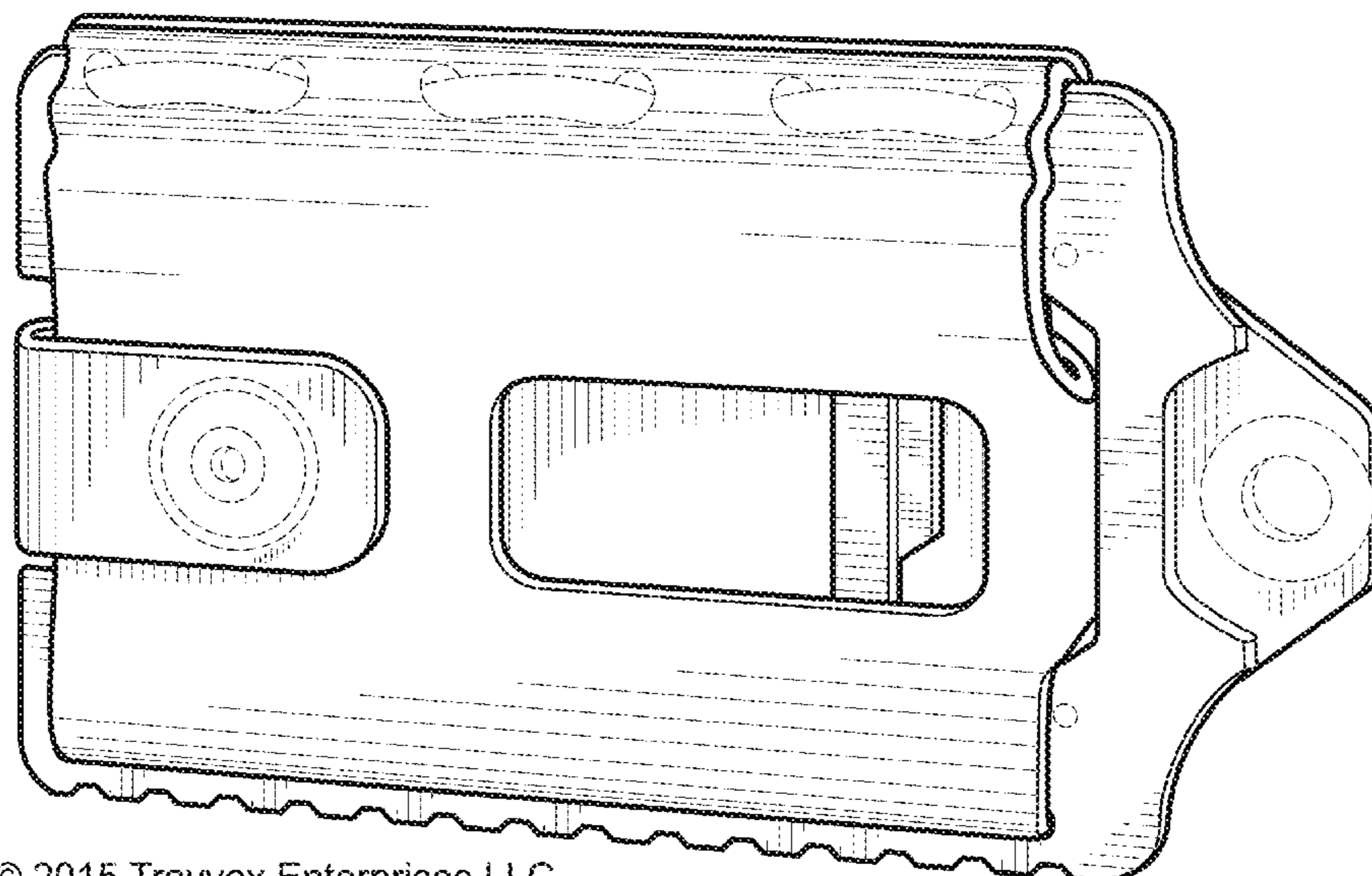
FIG. 9 is a front view of a second embodiment of a wallet, shown in a closed position, the rear, top, and left side views being identical to the first embodiment;

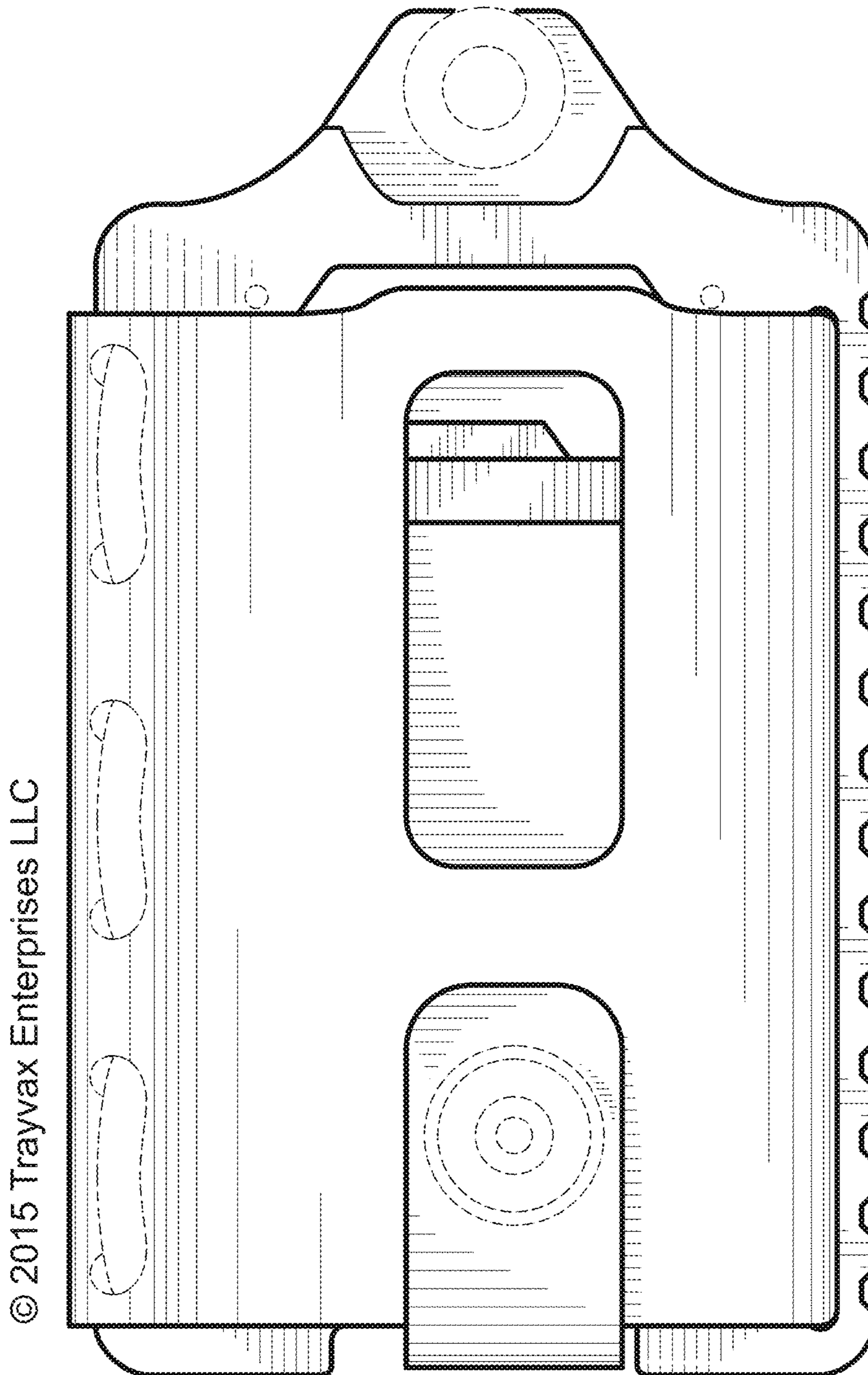
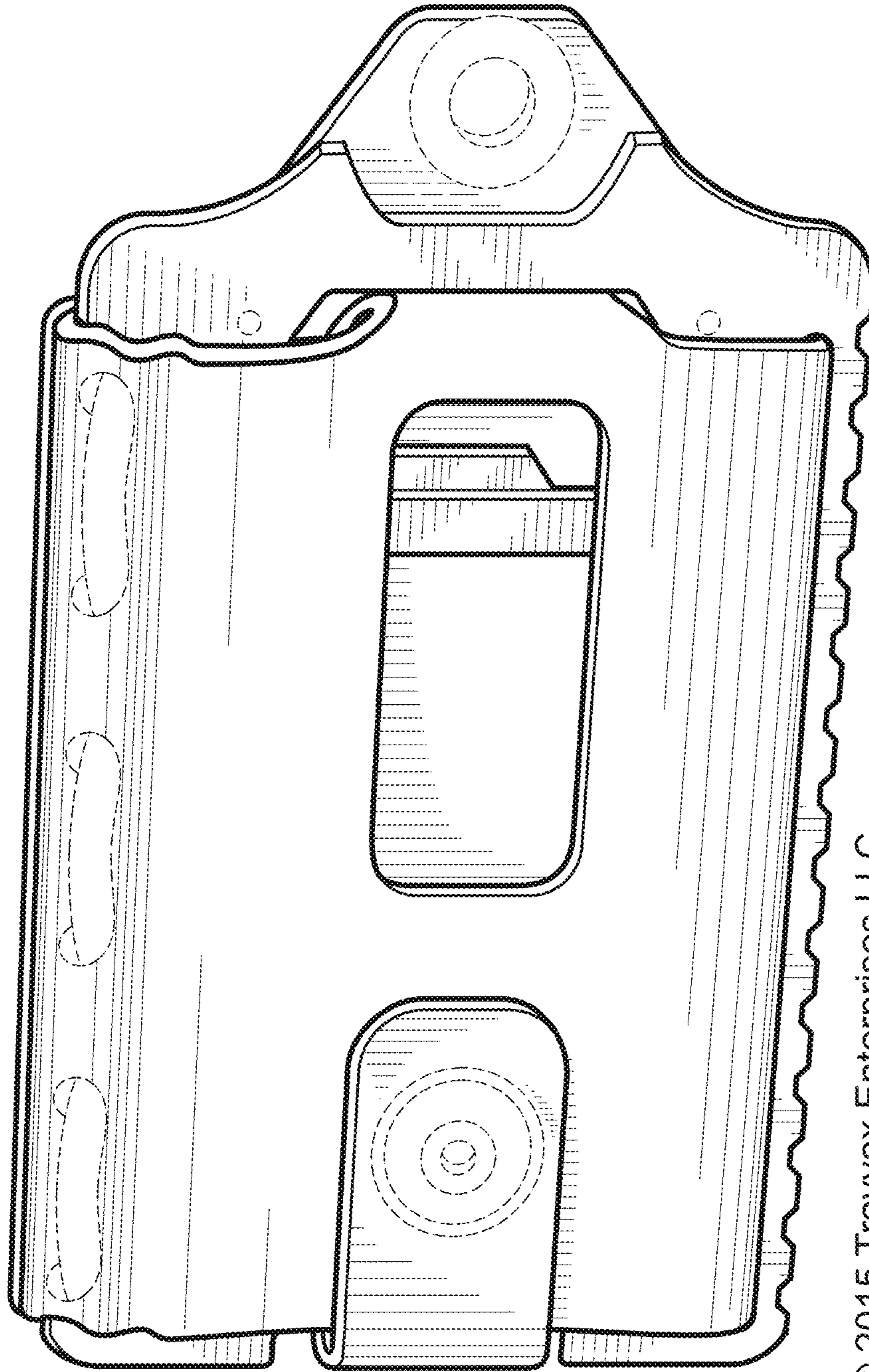
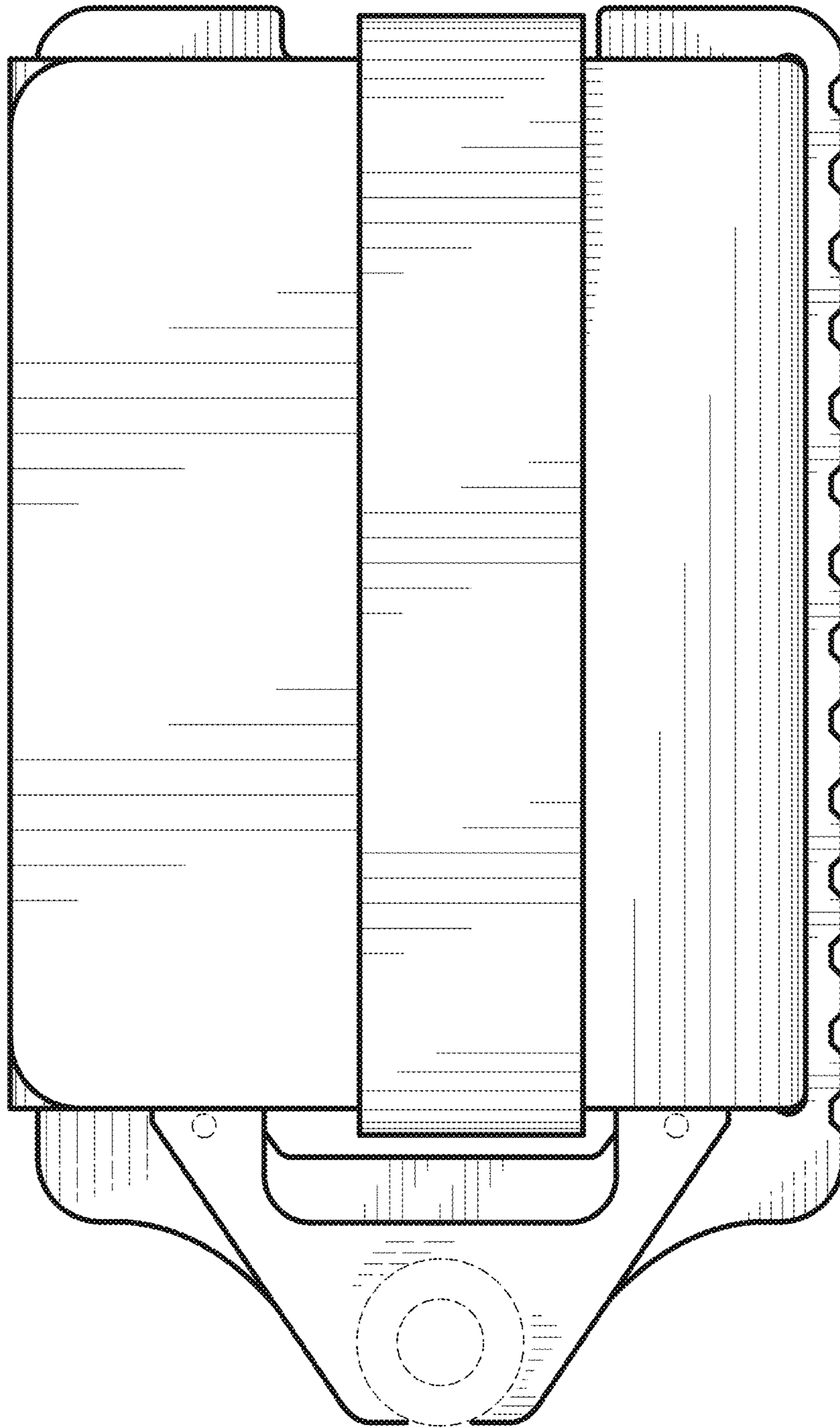

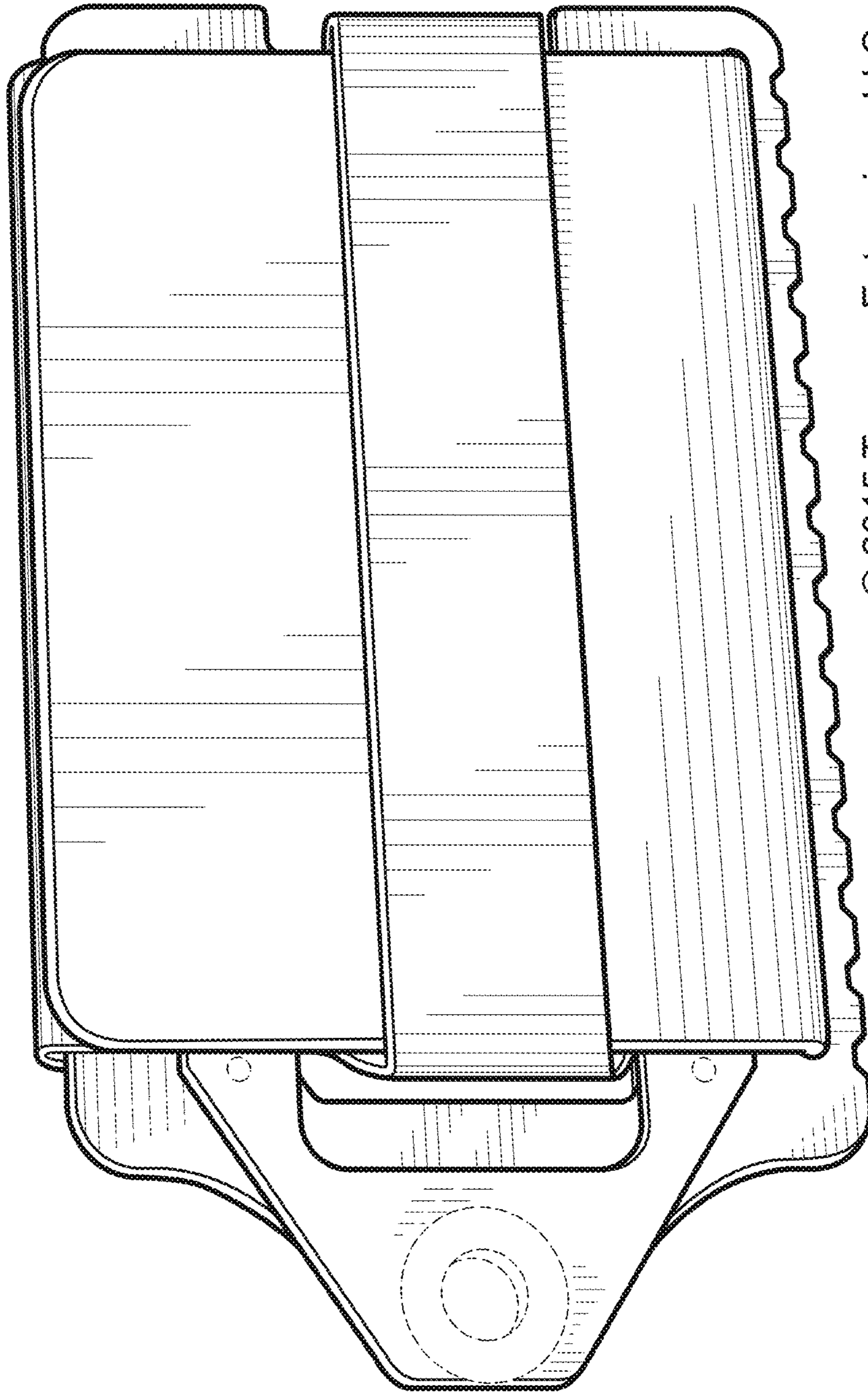

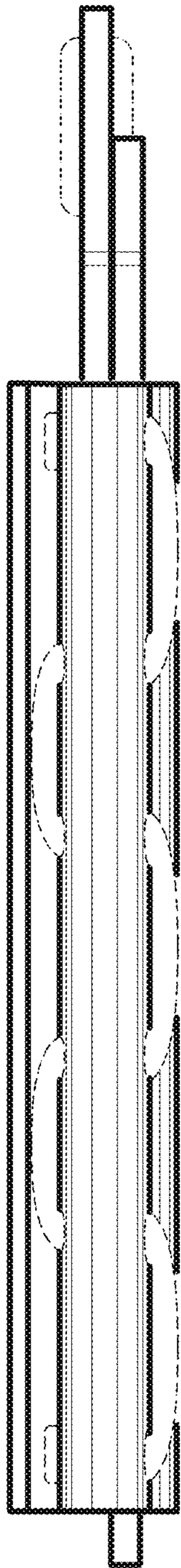

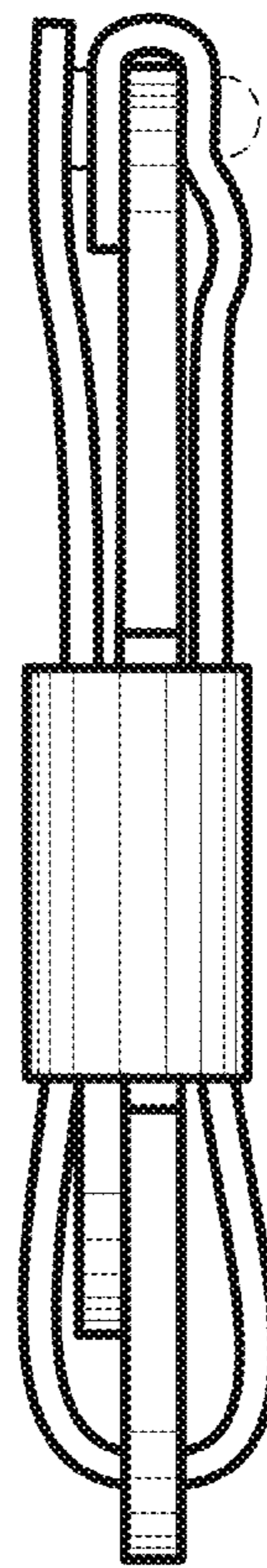

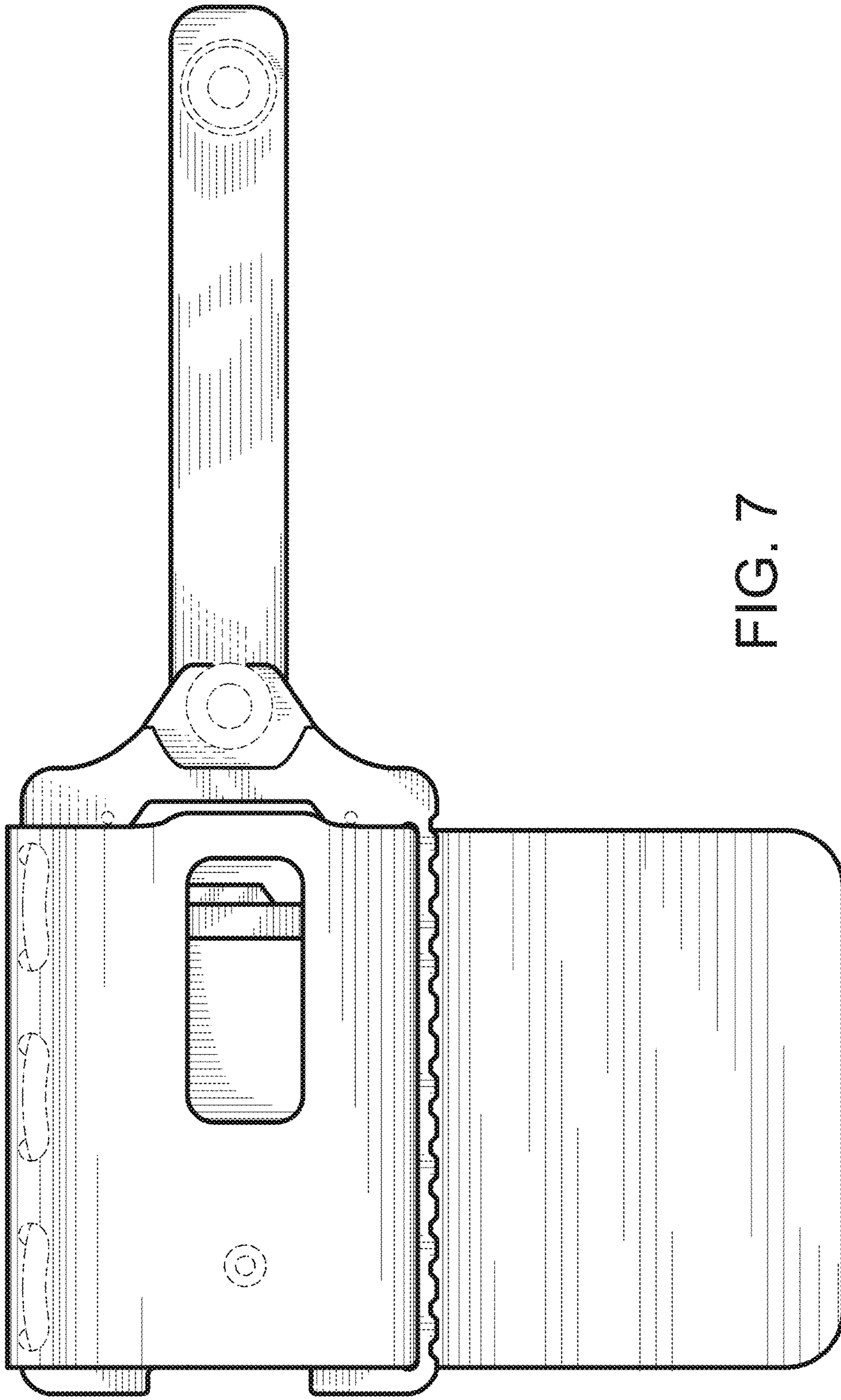

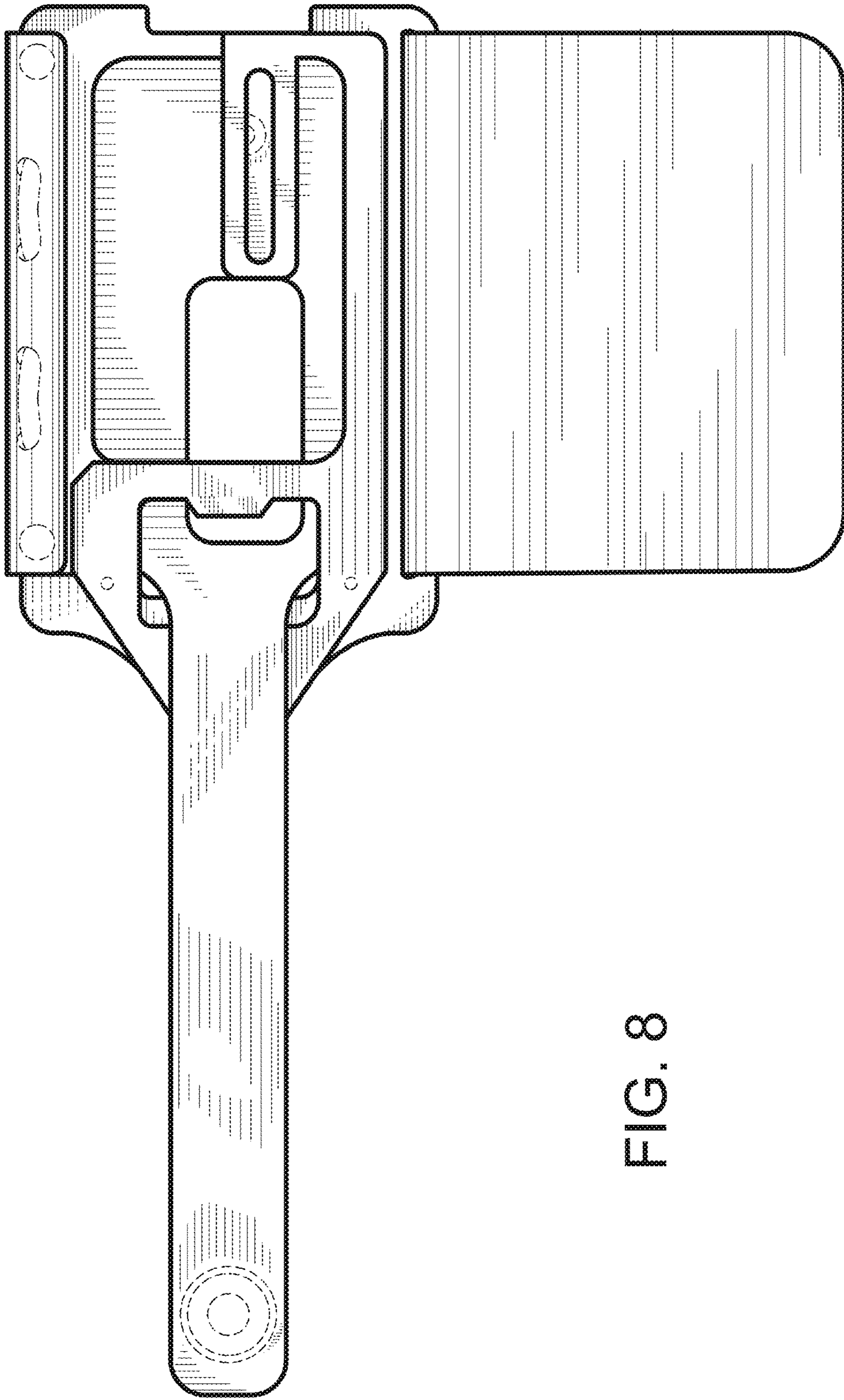

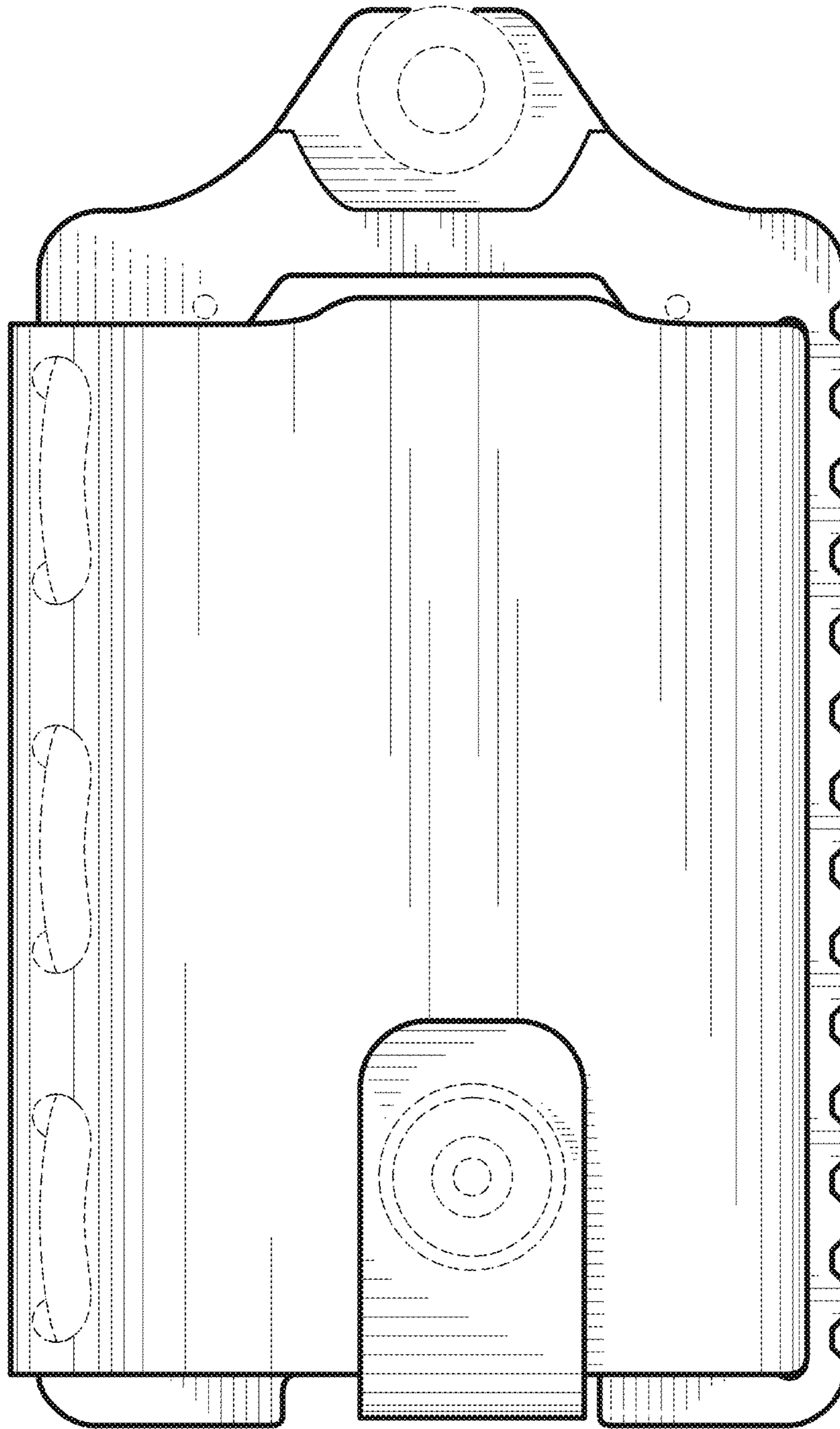

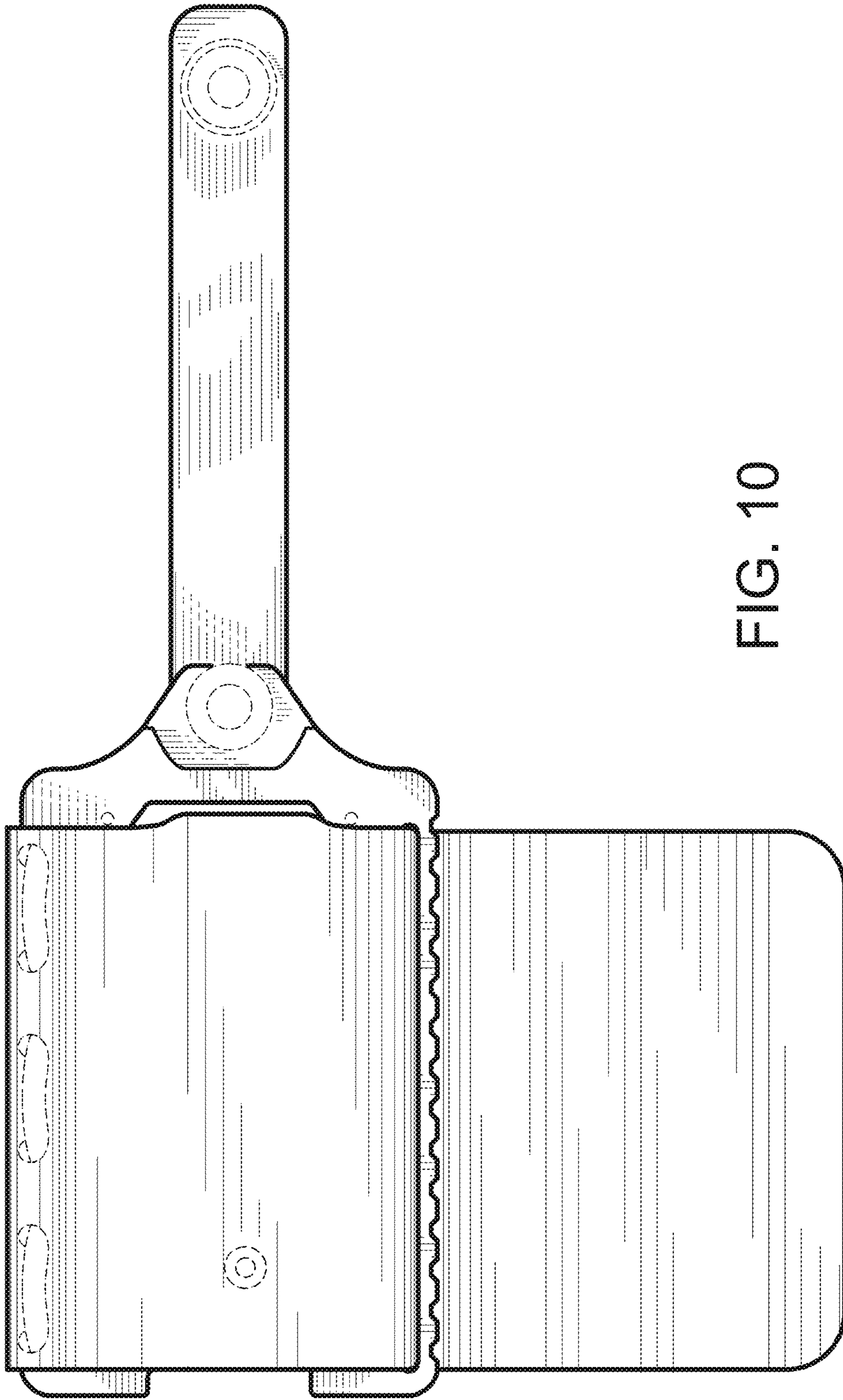
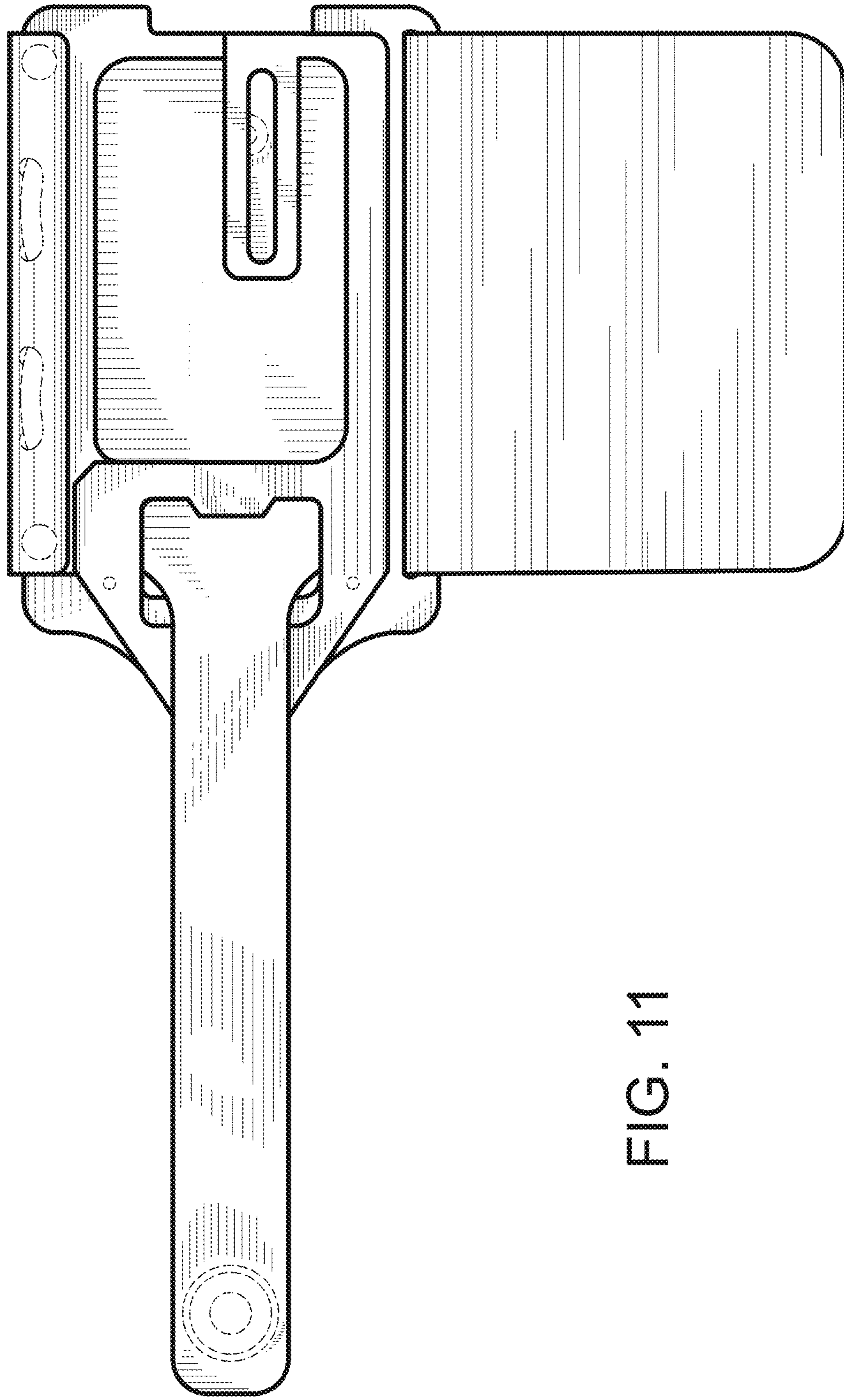
