(57) **CLAIM**

The ornamental design for a vehicle seat, as shown and described.

DESCRIPTION

FIG. 1 is a left perspective view of a vehicle seat;
FIG. 2 is a front perspective view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left perspective view of a vehicle seat with a left-side supporting leg of the vehicle seat;
FIG. 5 is right perspective view of a seat with a right-side supporting leg of the vehicle seat;
FIG. 6 is a rear view of the seat of FIG. 3 with the table removed;
FIG. 7 is another front view of a seat with supporting leg; and,
FIG. 8 is a back perspective view of the seat of FIG. 7.
While the FIGS. 1A-1C show the invention with a supporting leg and table, it will be appreciated that any additional views of the embodiments without the supporting leg and table can be readily ascertained, as is depicted in some of the submitted figures.

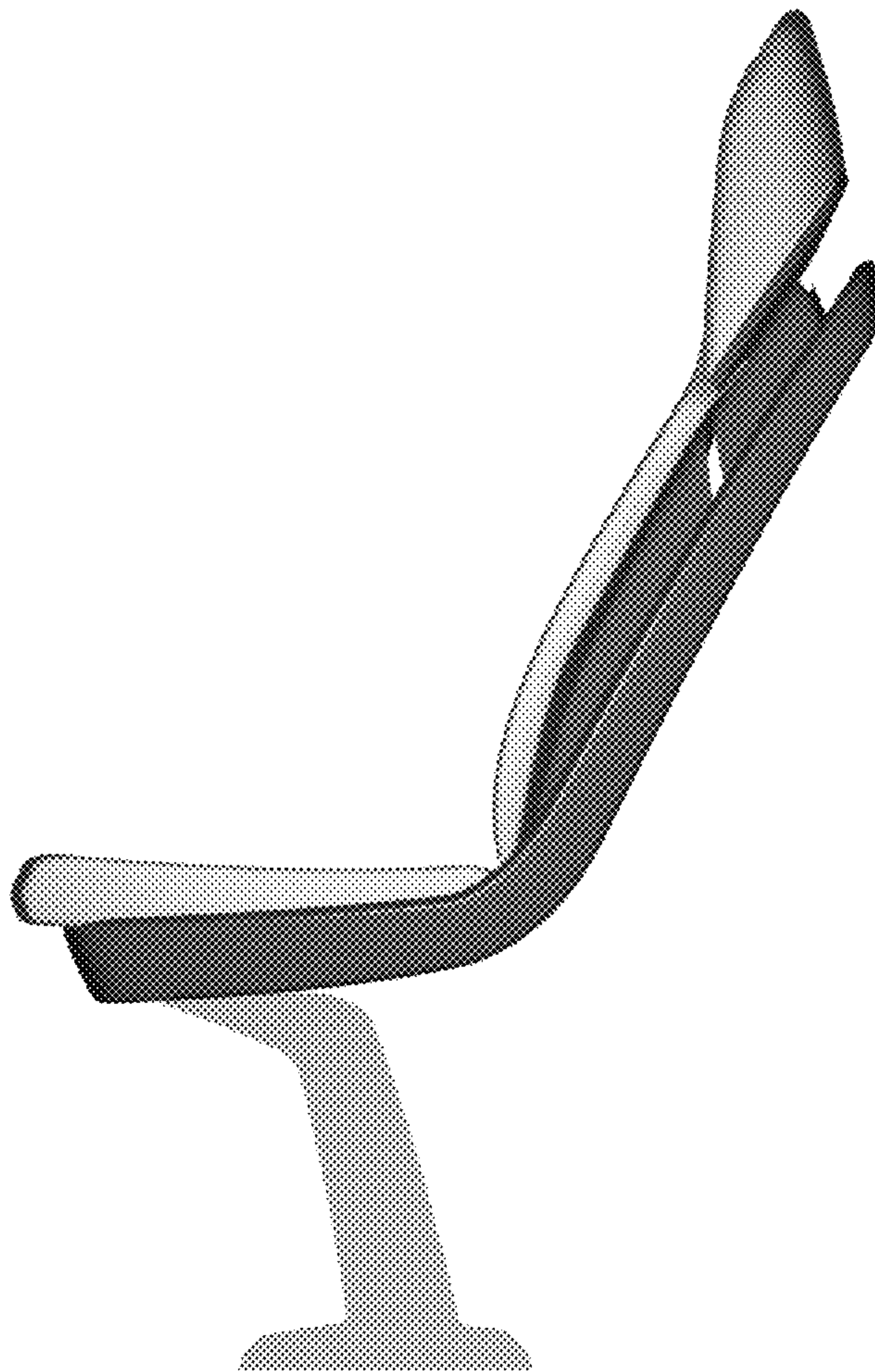

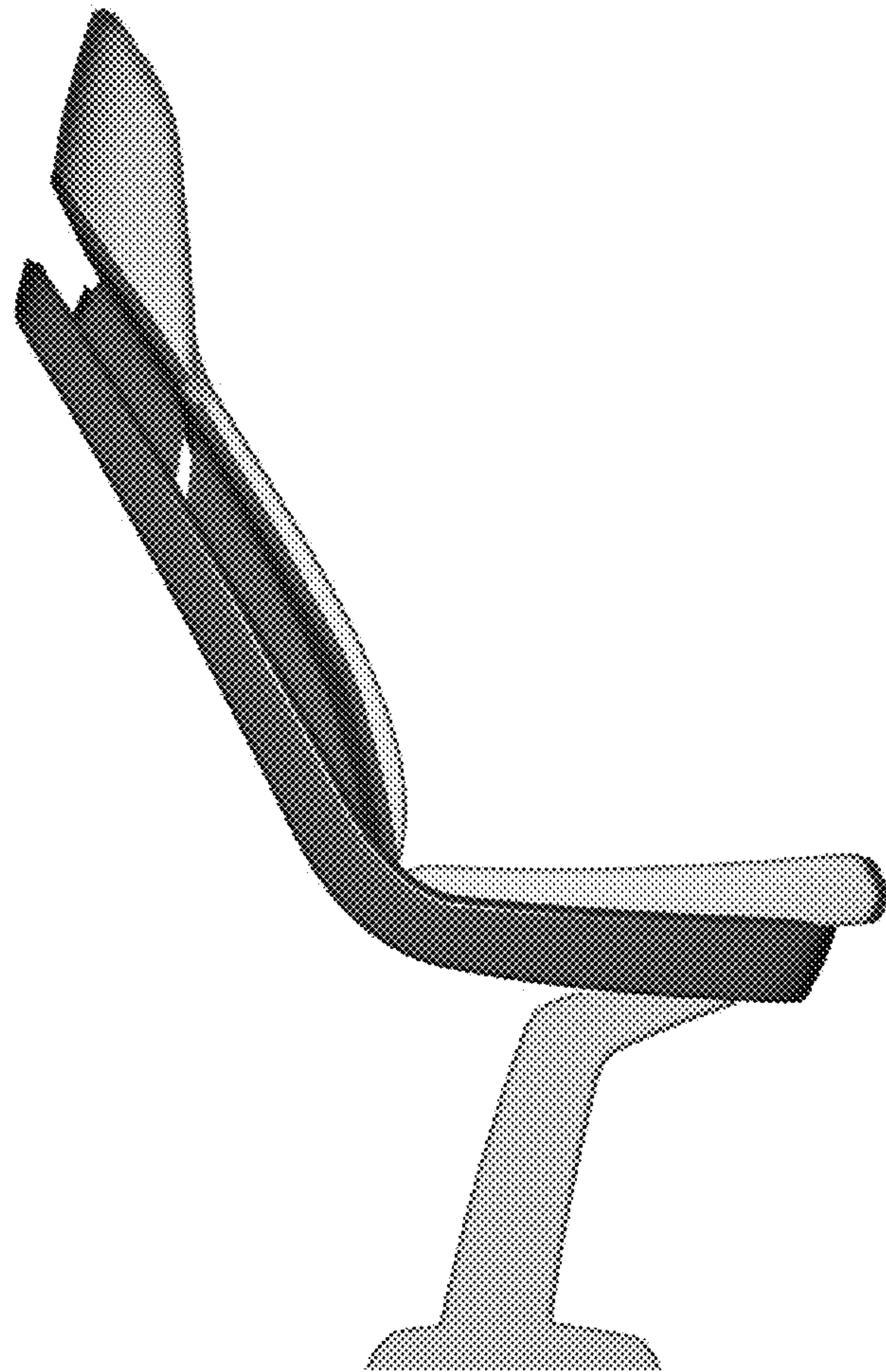

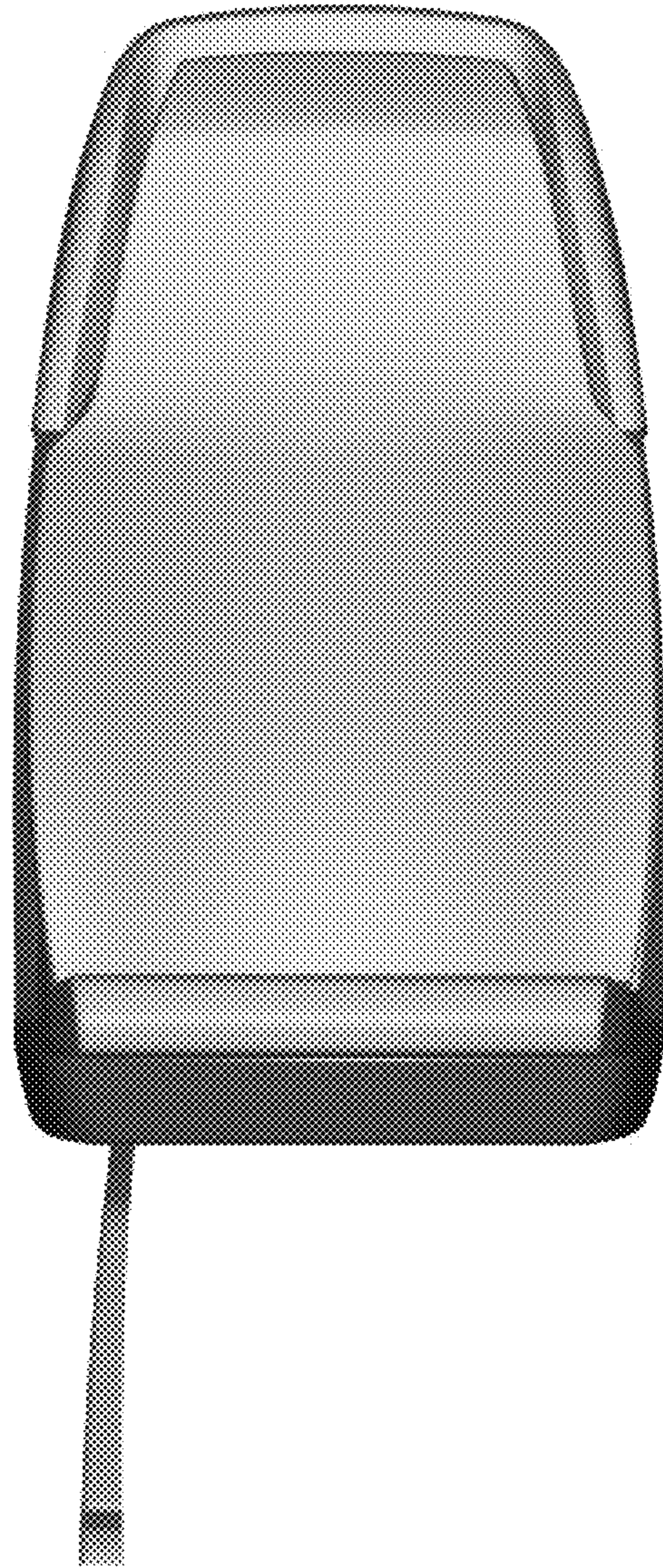

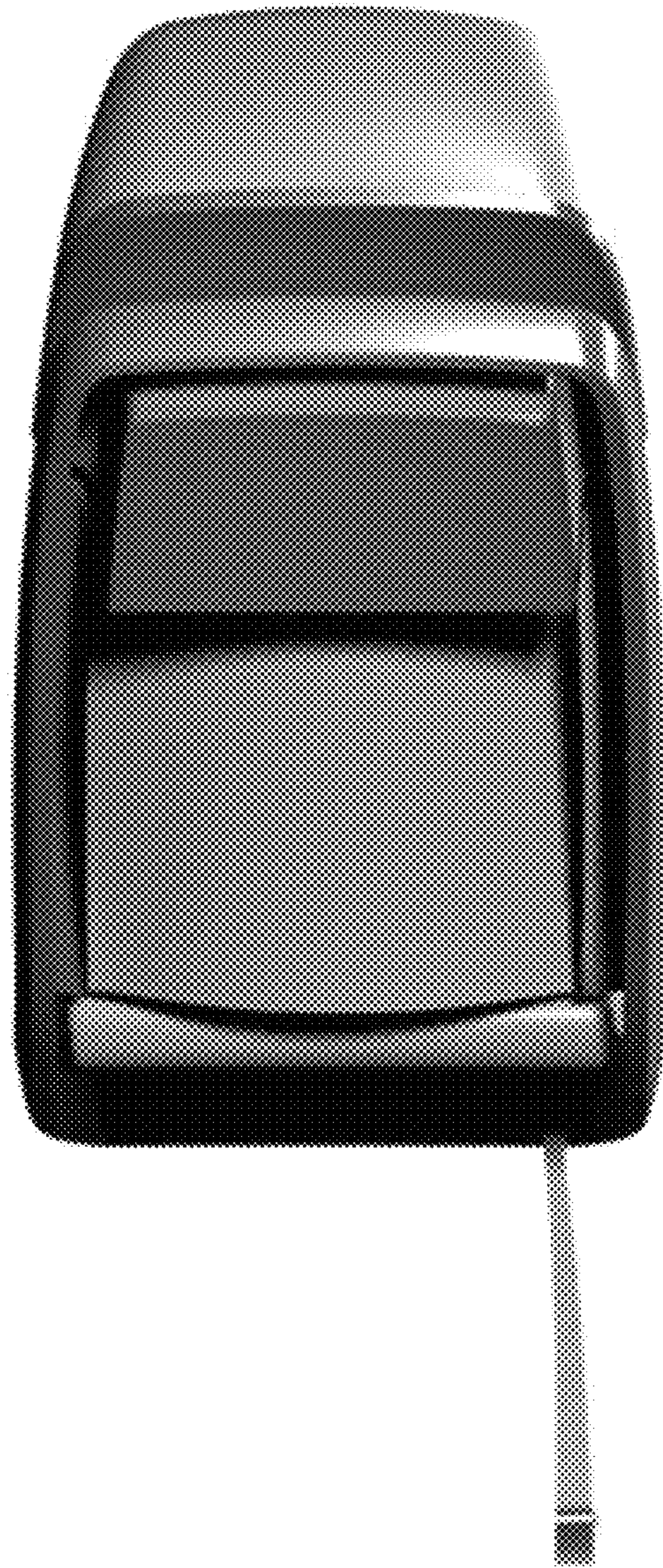
