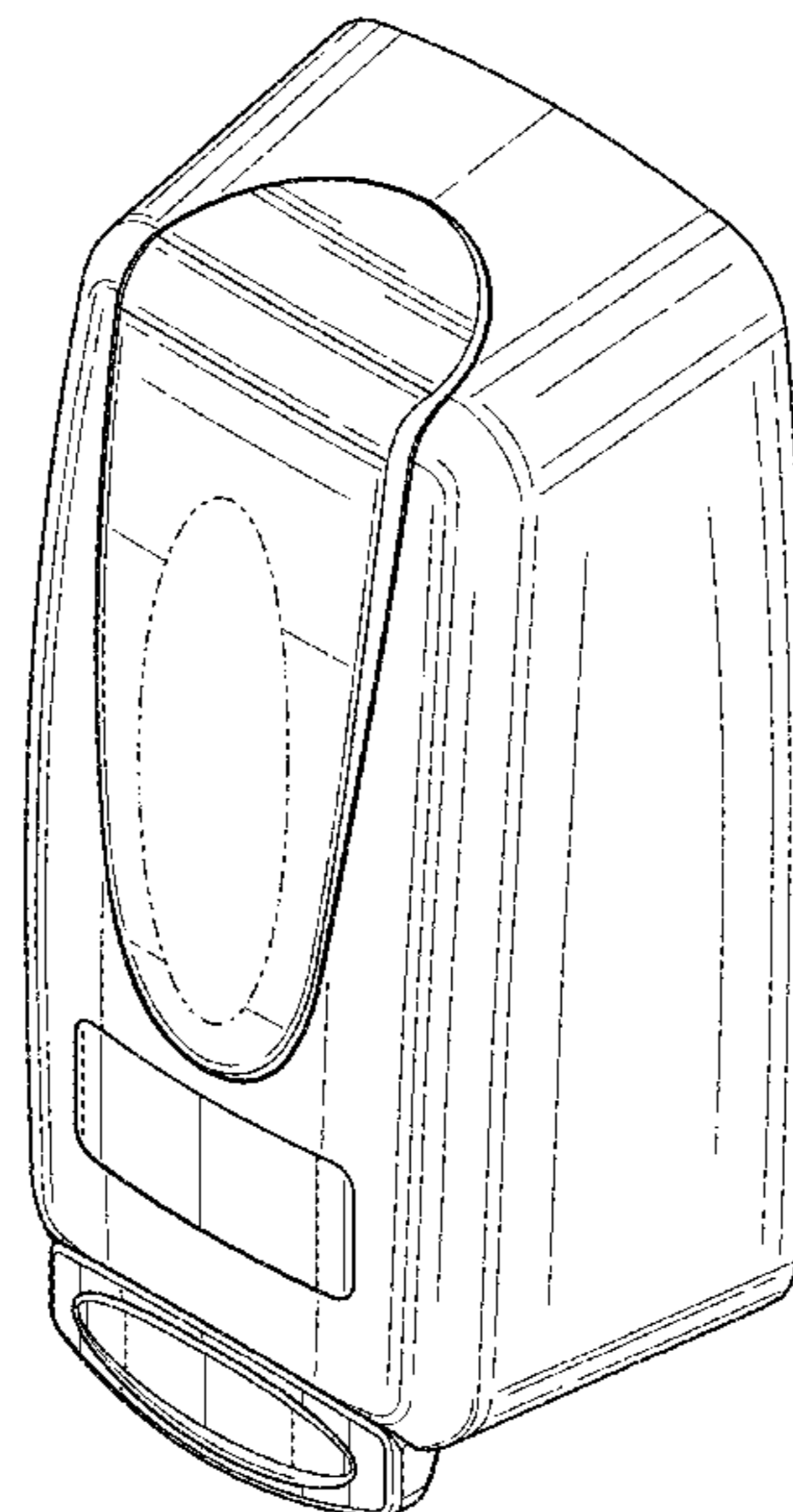

DESCRIPTION

FIG. 1 is an isometric view of a dispenser showing my new design taken generally from the front, top, and right side; FIG. 2 is an isometric view thereof taken generally from the rear, bottom, and left side; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a right side elevation view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. The broken lines depict portions of the article that form no part of the claimed design.

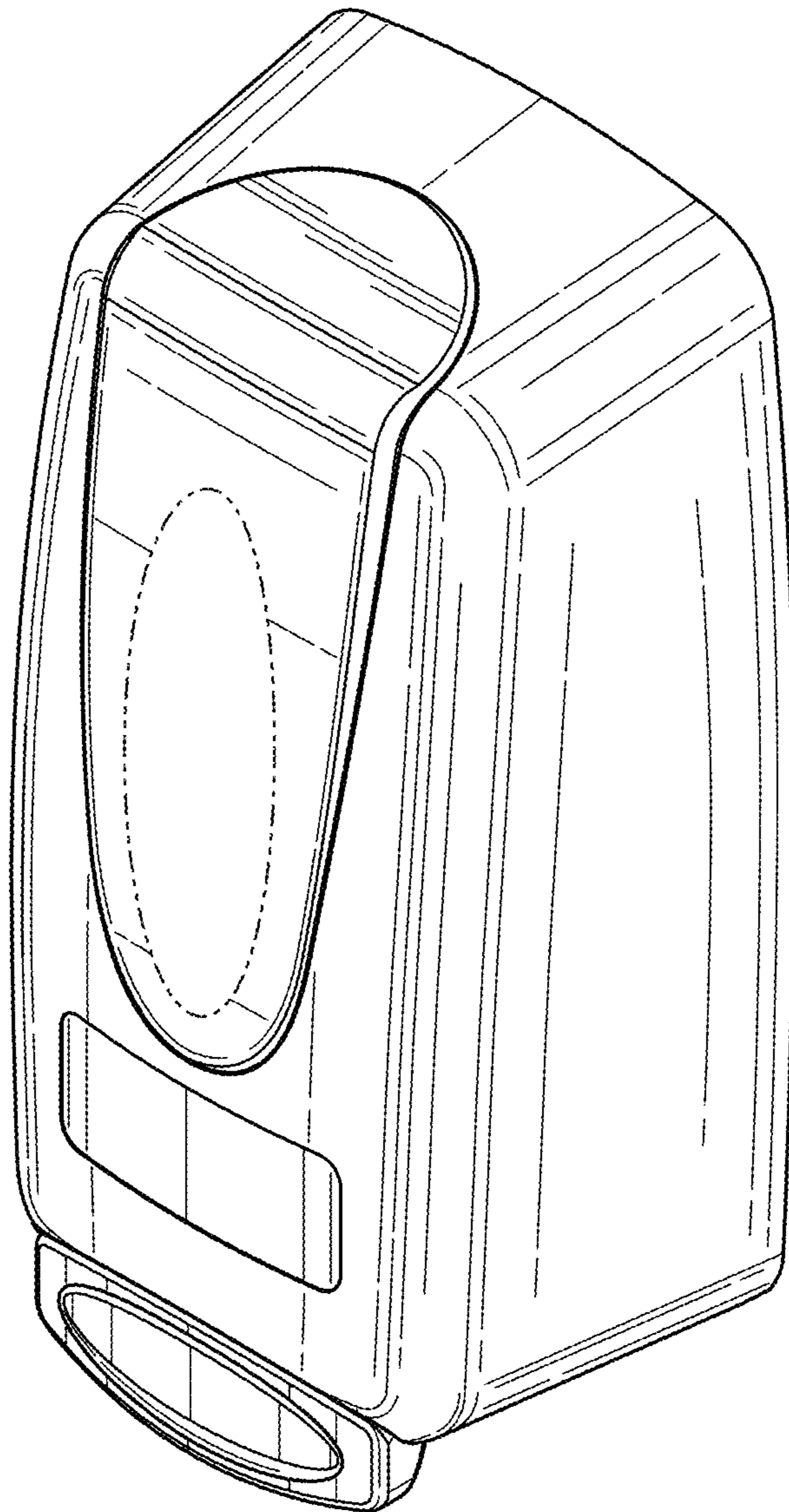

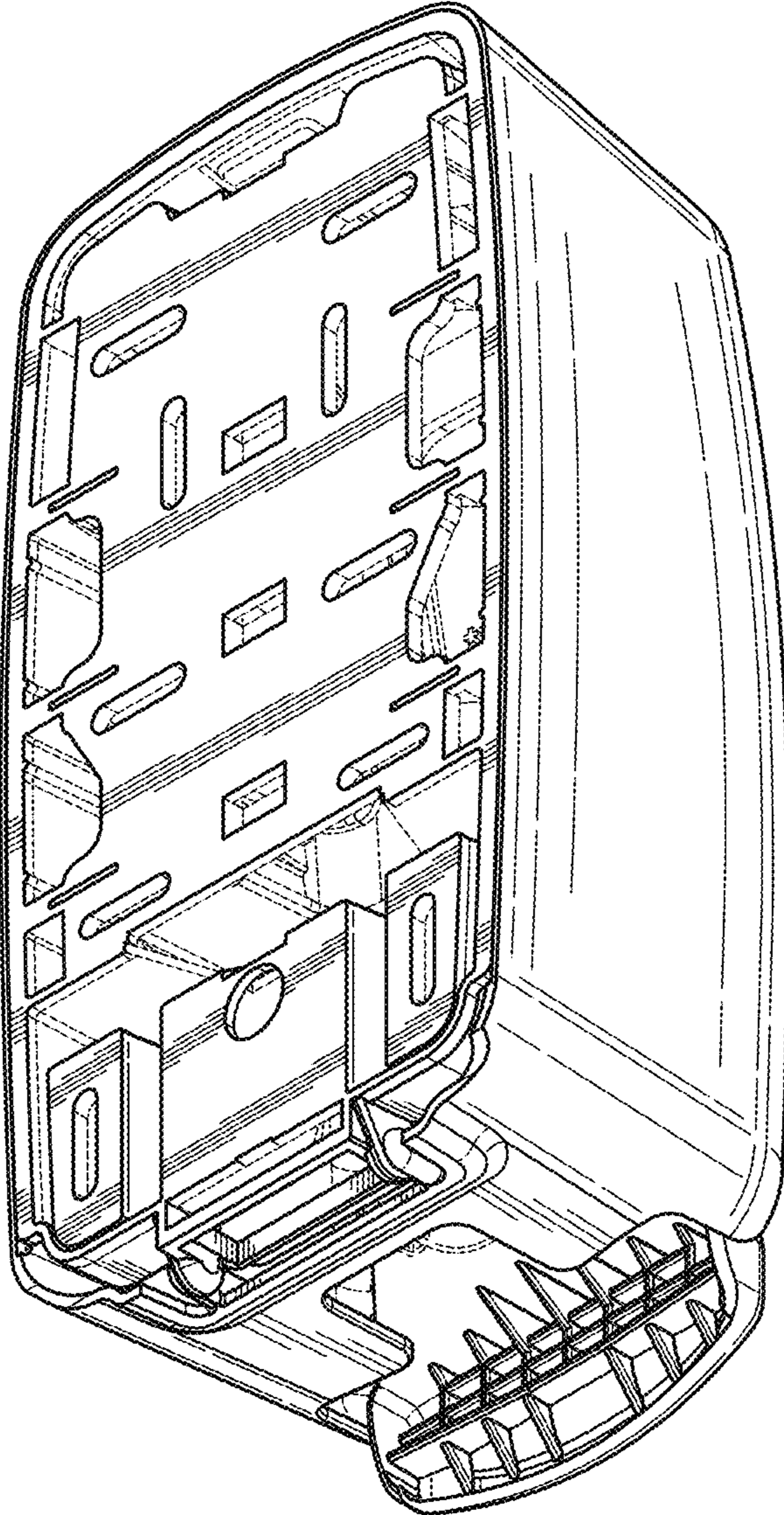

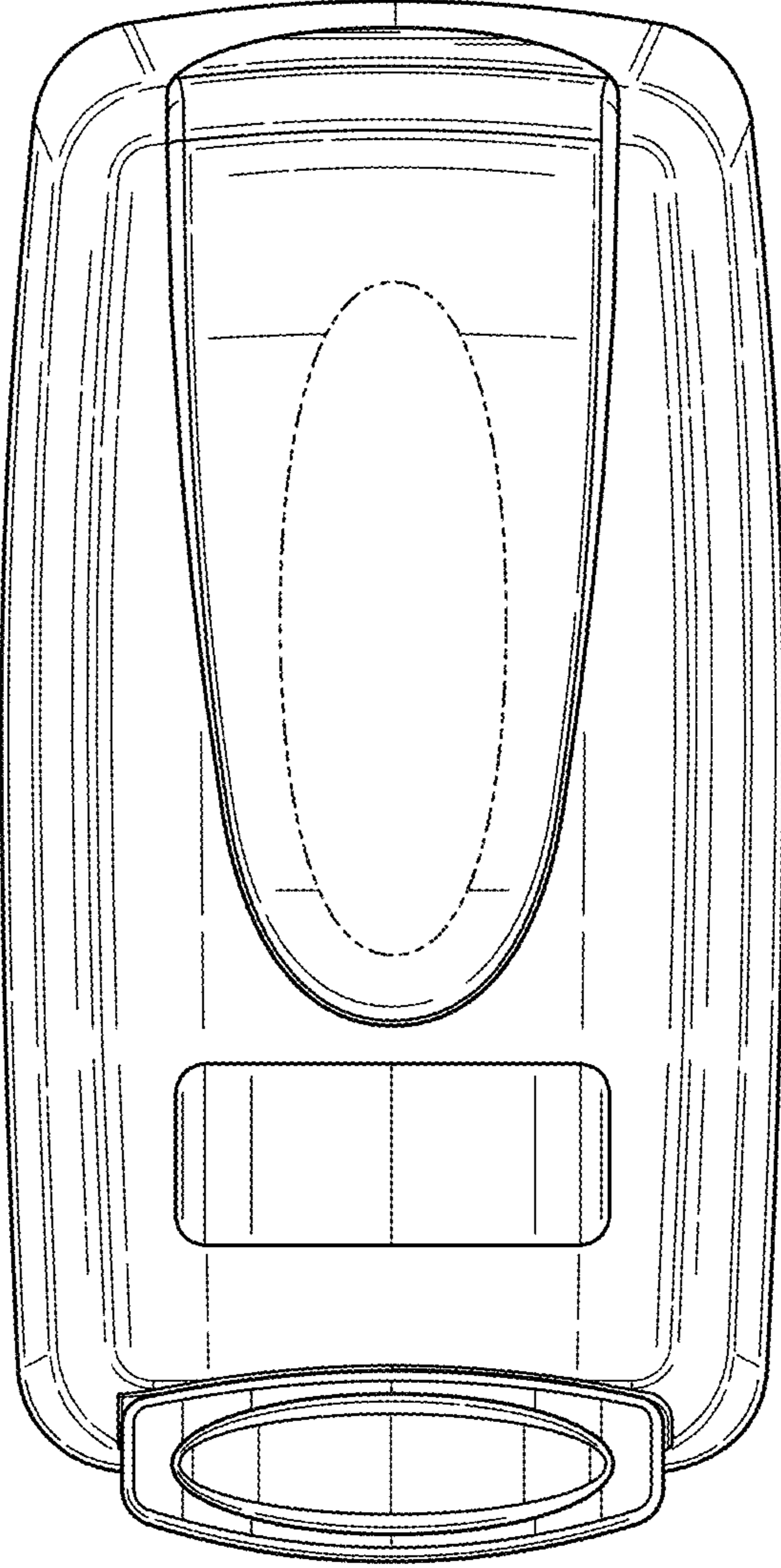

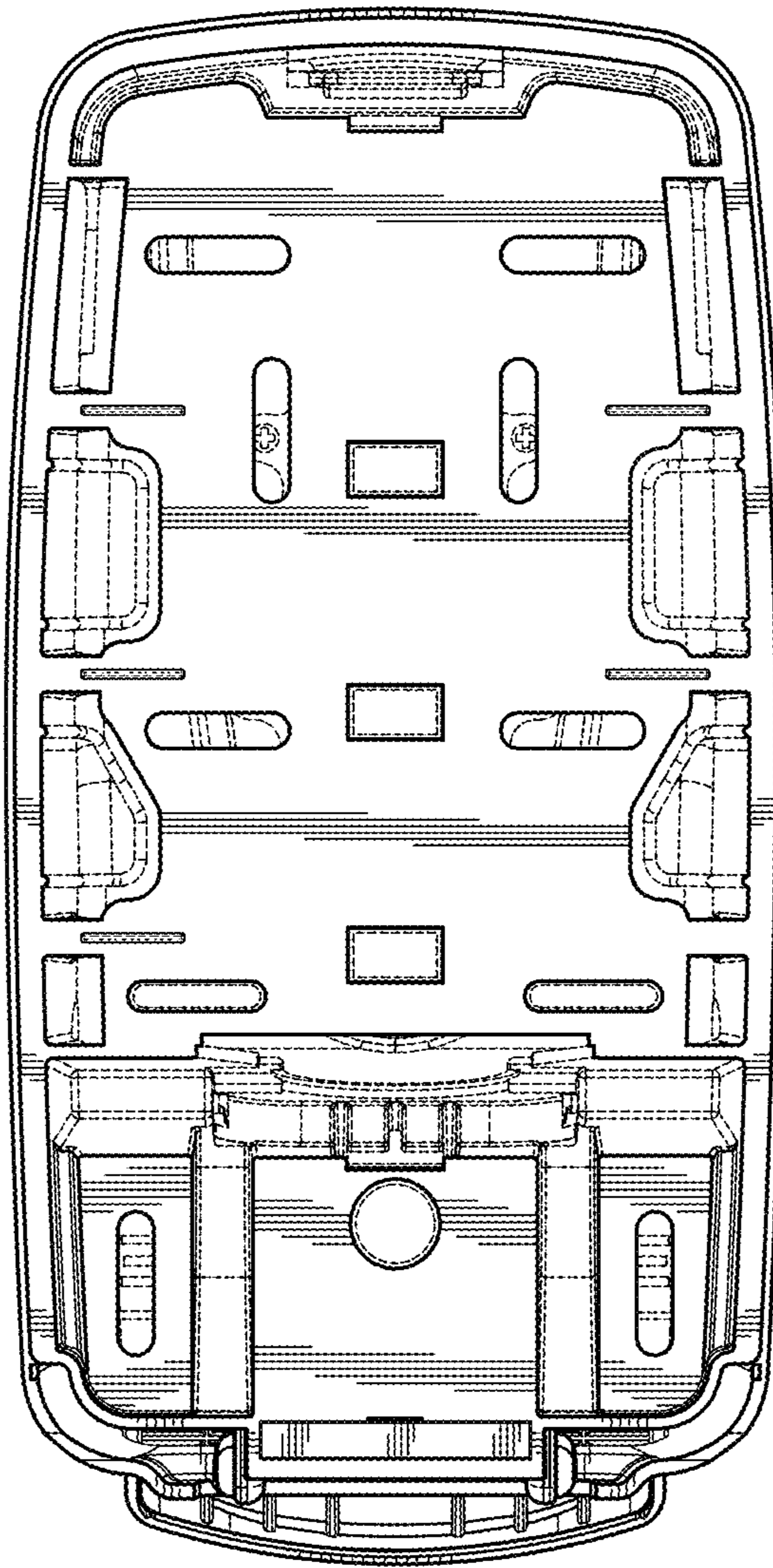

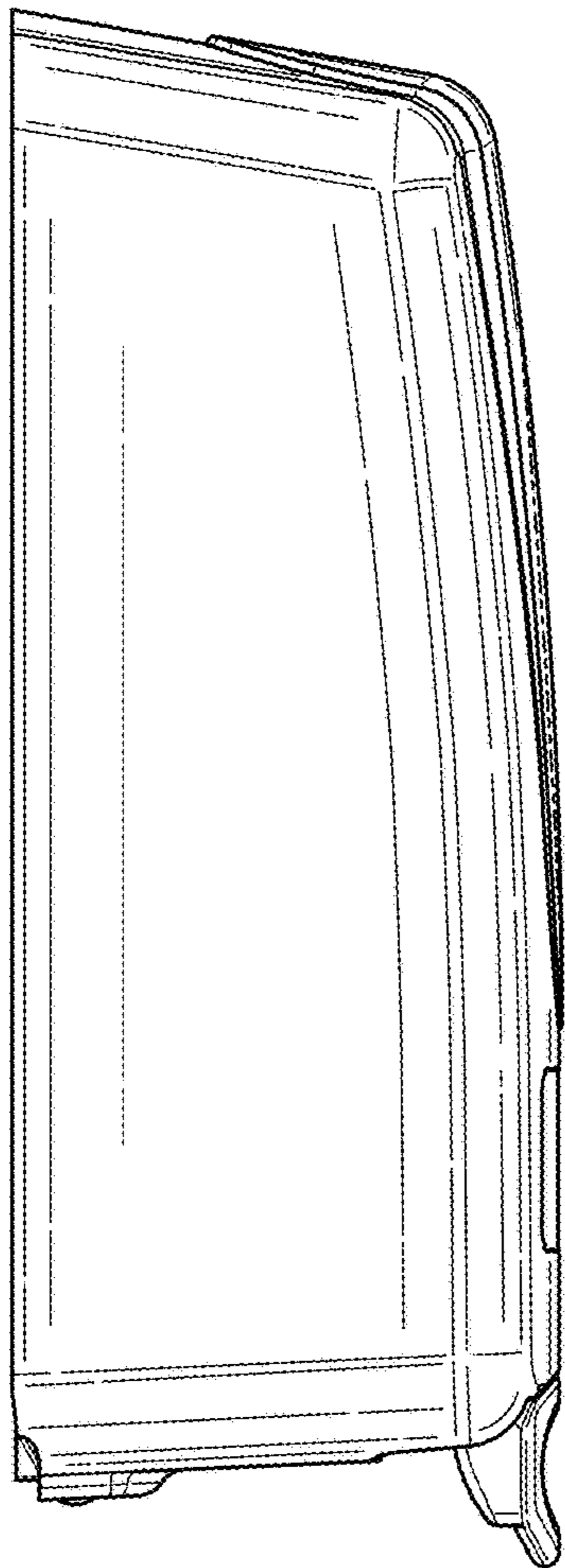

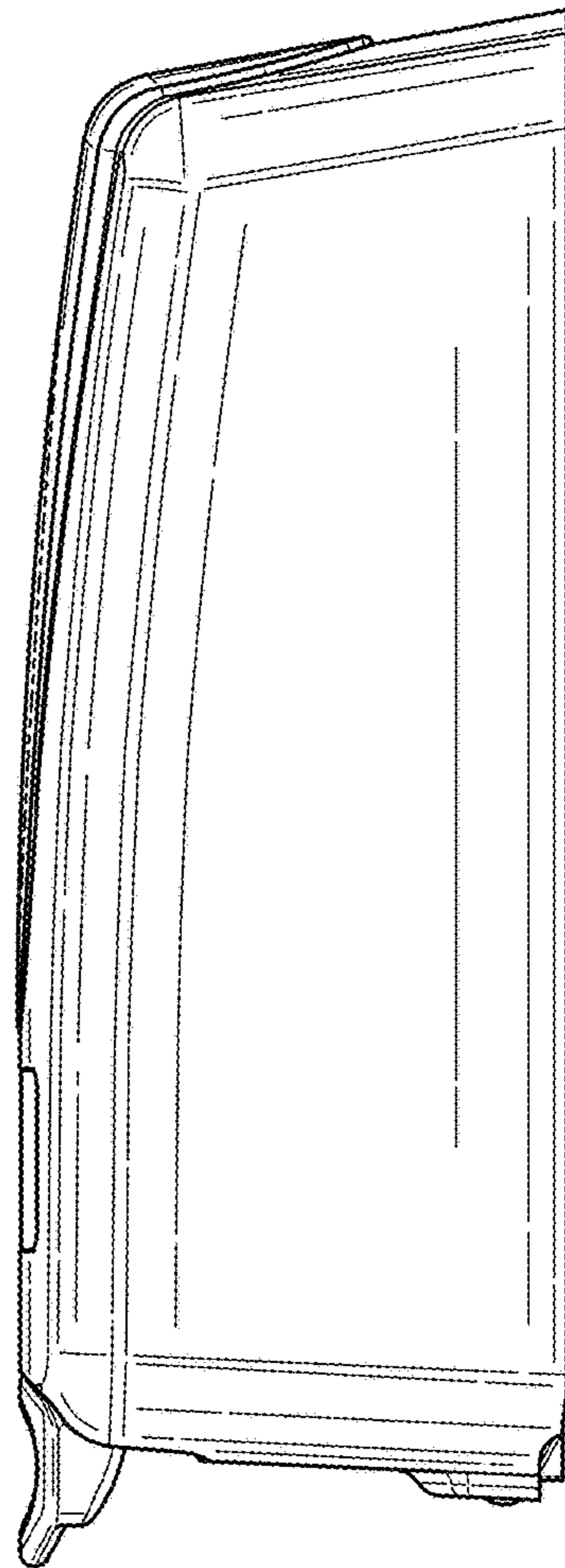

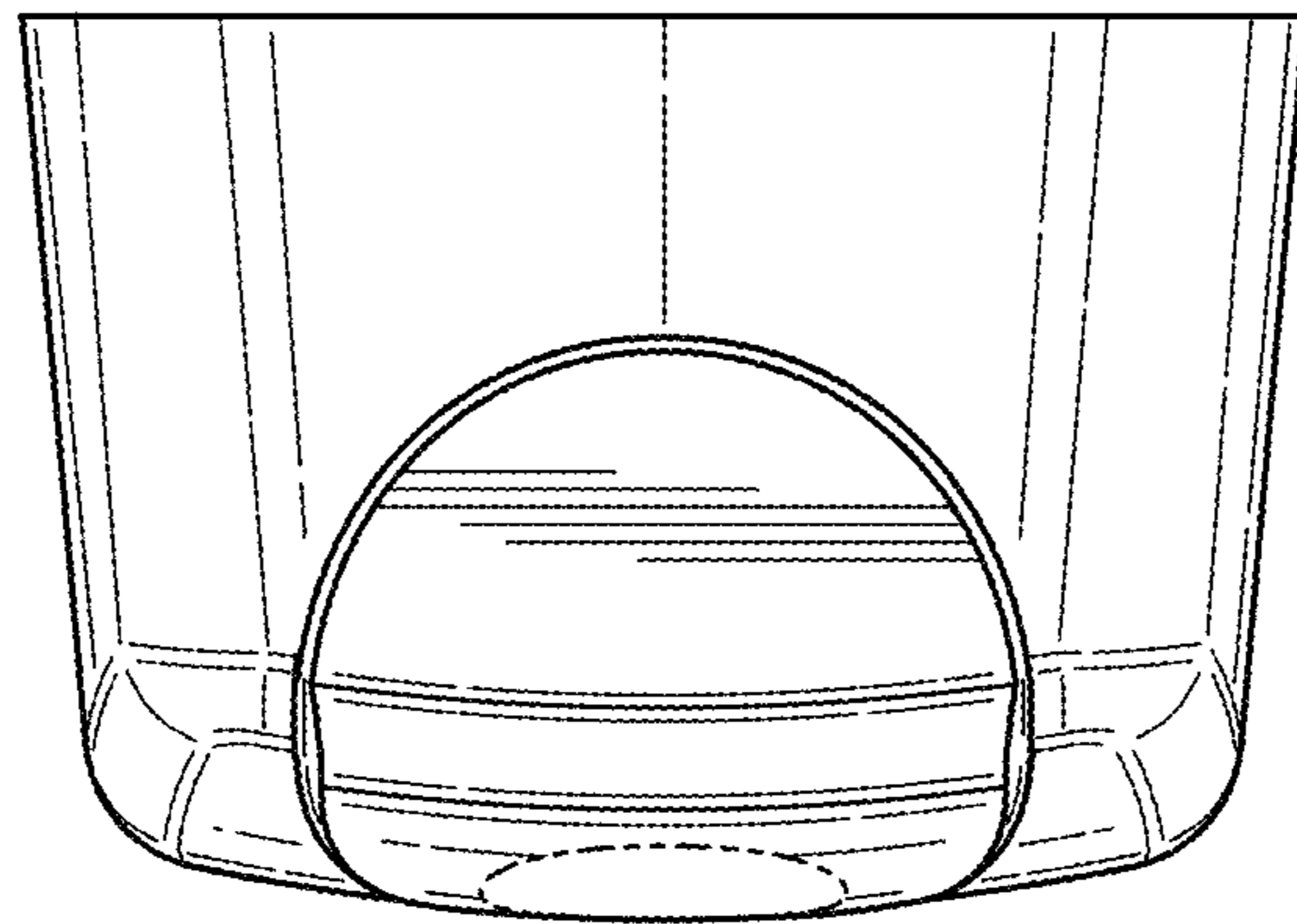

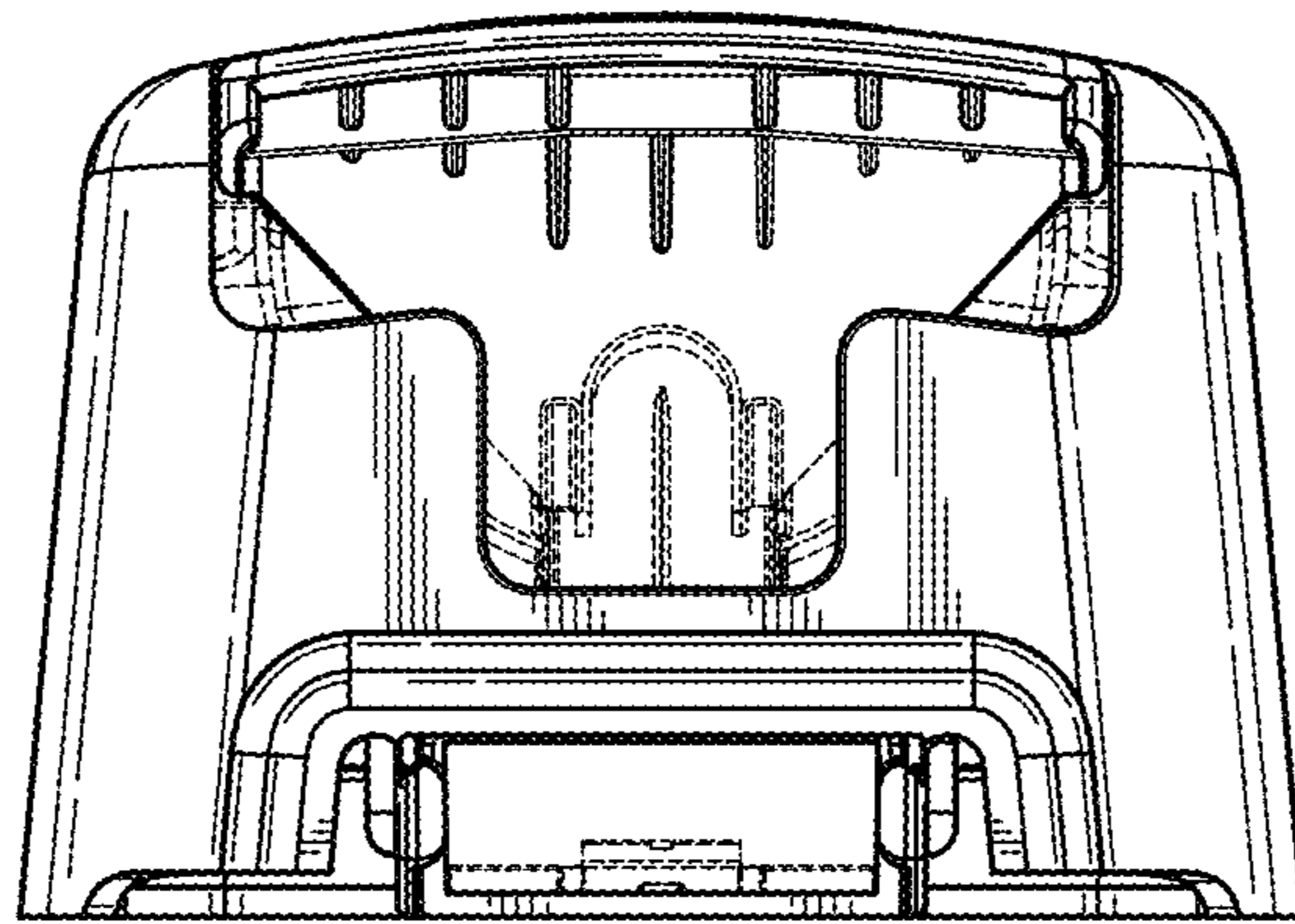
