(57) **CLAIM**

What is claimed is the ornamental design for a football helmet-shaped container, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the football helmet-shaped container. The circular broken line is shown to define a boundary around an aperture that defines an interior bowl of the football helmet-shaped container. The area within the circular broken line boundary is not part of the claimed design.

FIG. 2 is a bottom perspective view of the football helmet-shaped container of FIG. 1. The areas within the broken lines are not part of the claimed design.

FIG. 3 is a front elevation view of the football helmet-shaped container of FIG. 1. The area within the broken lines is not part of the claimed design.

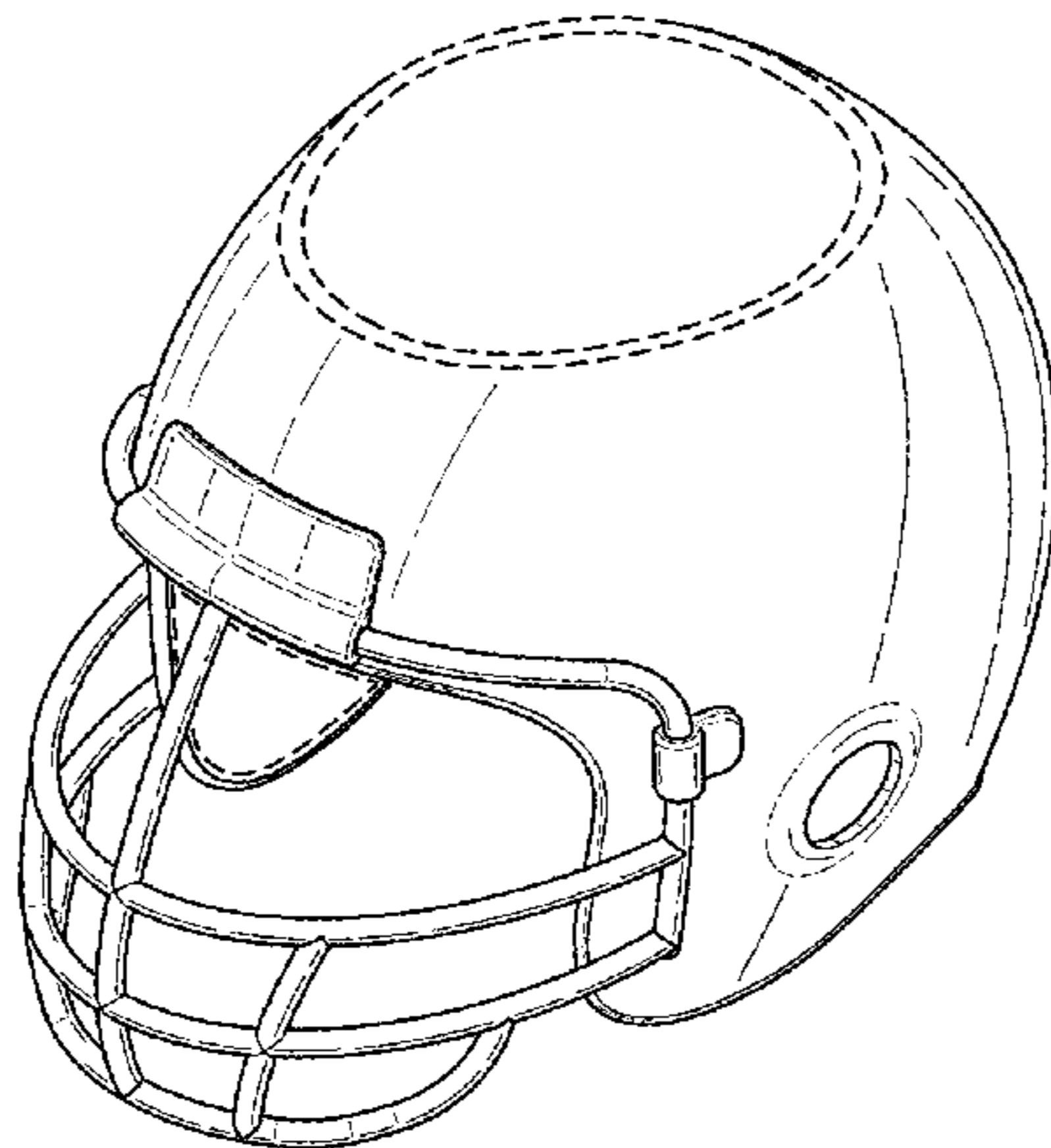
FIG. 4 is rear elevation view of the football helmet-shaped container of FIG. 1.

FIG. 5 is a left side view of the football helmet-shaped container of FIG. 1. The right side view (not shown) is a mirror image of FIG. 5.

FIG. 6 is a top plan view of the football helmet-shaped container of FIG. 1. The area within the circular broken lines is not part of the claimed design; and,

FIG. 7 is a bottom plan view of the football helmet-shaped container of FIG. 1. The area within the broken lines is not part of the claimed design.

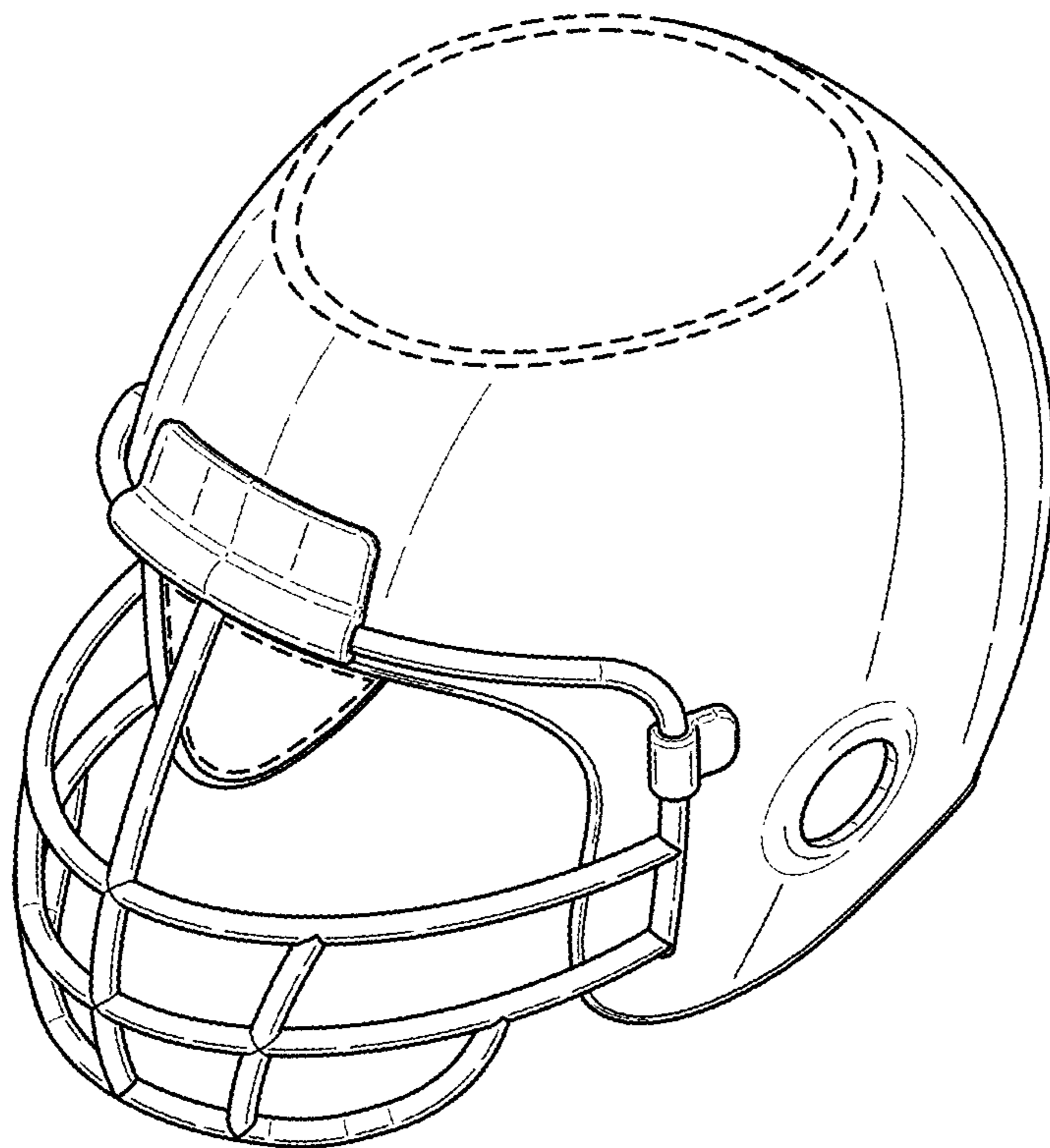

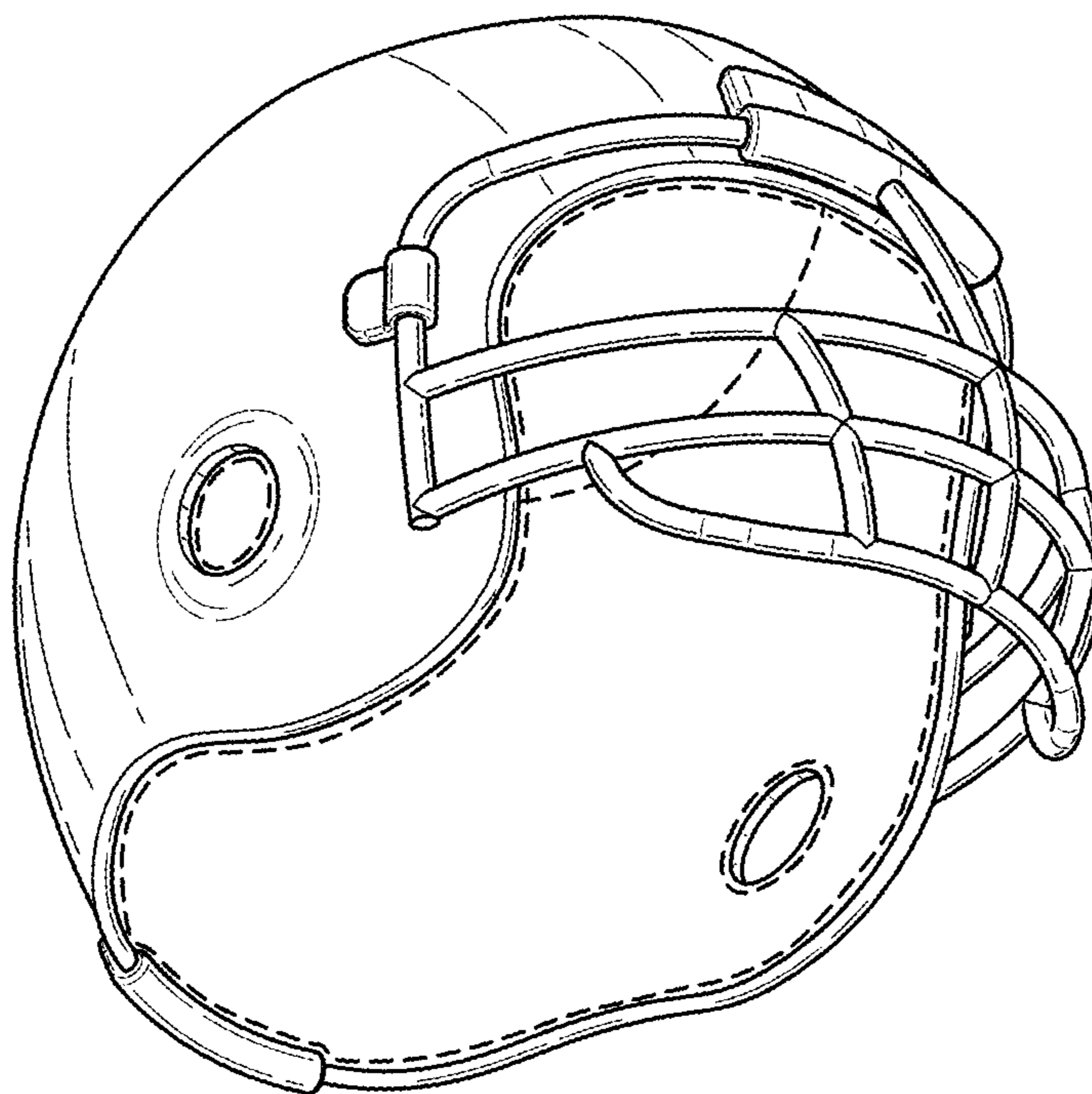

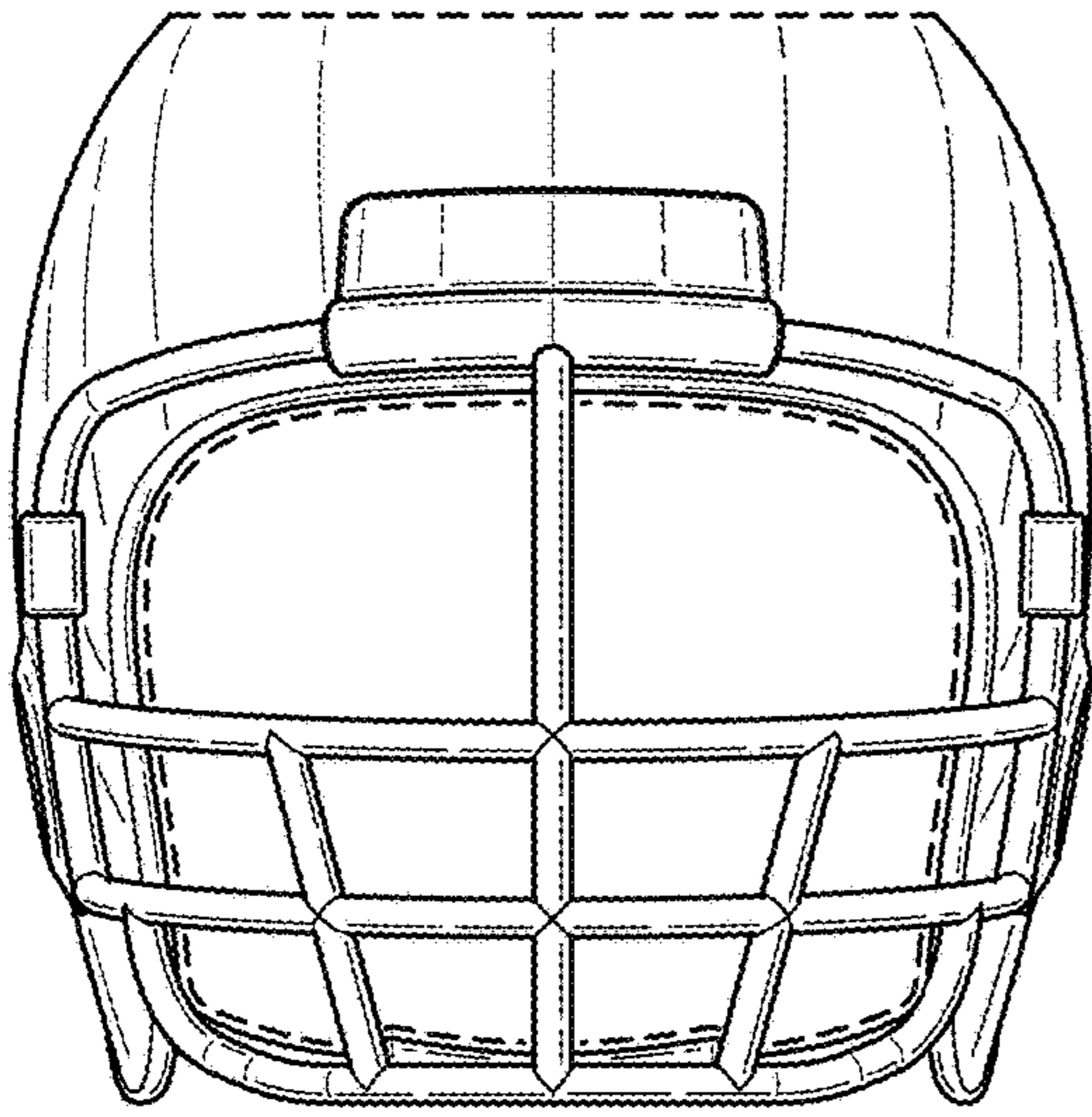

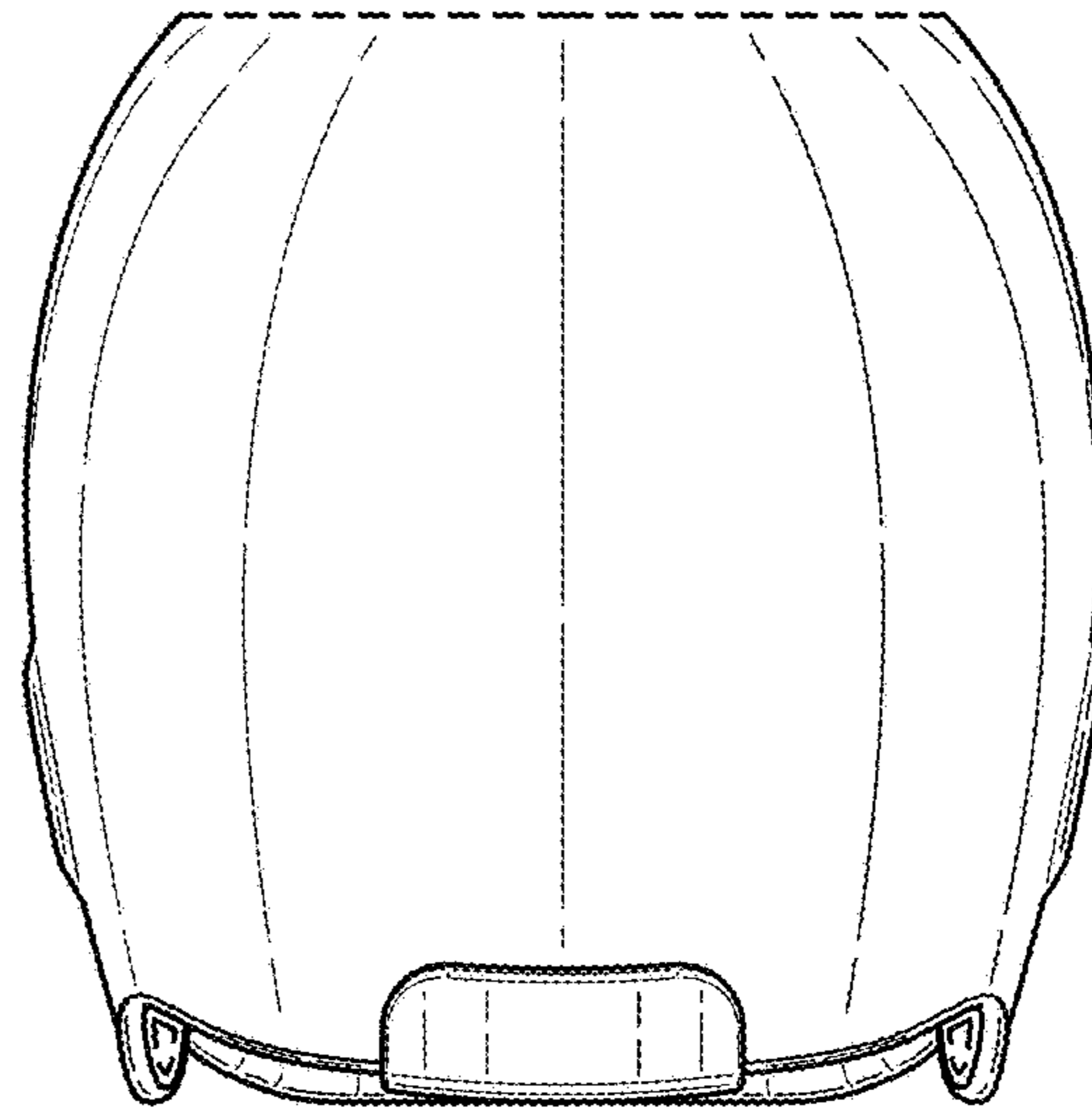

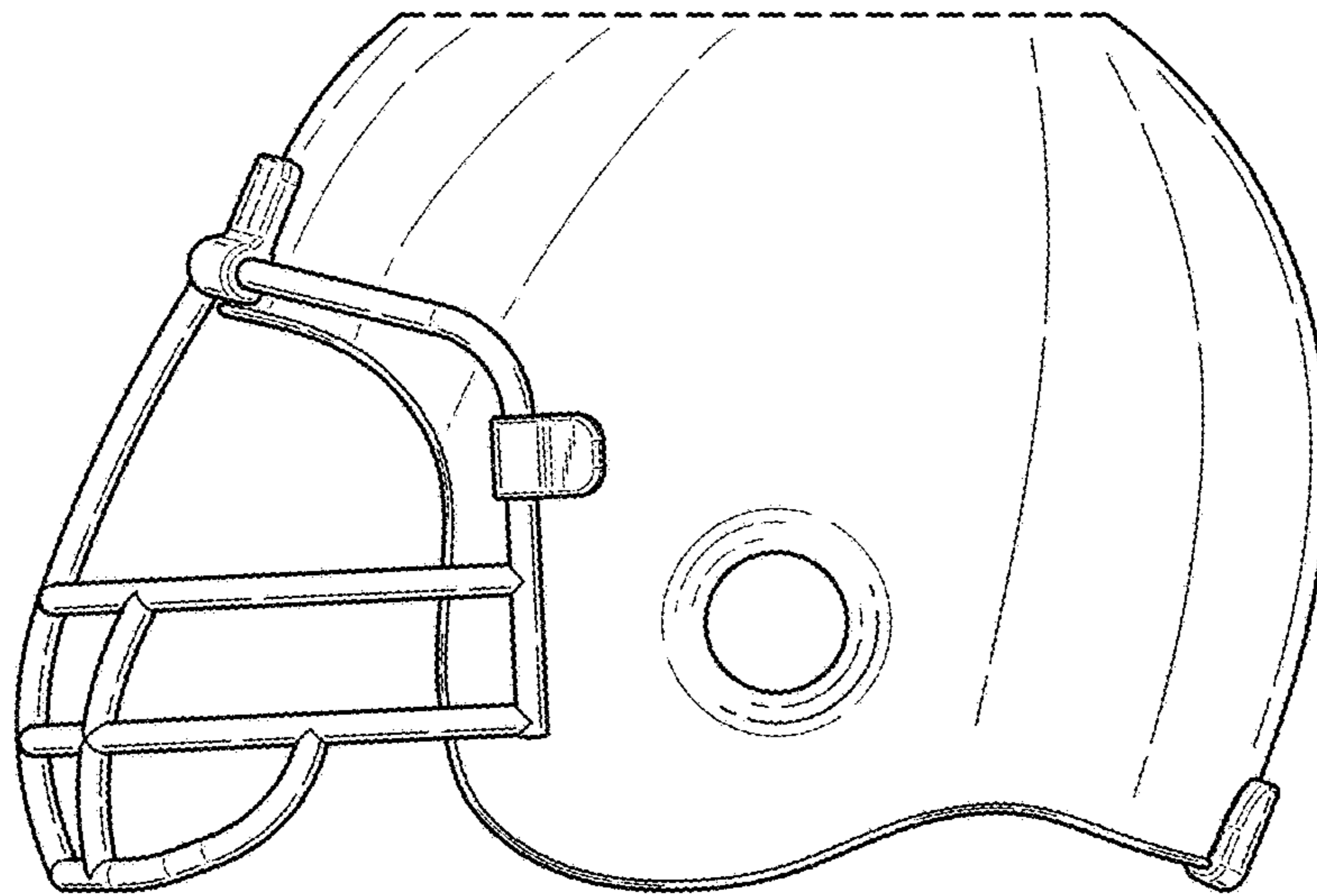

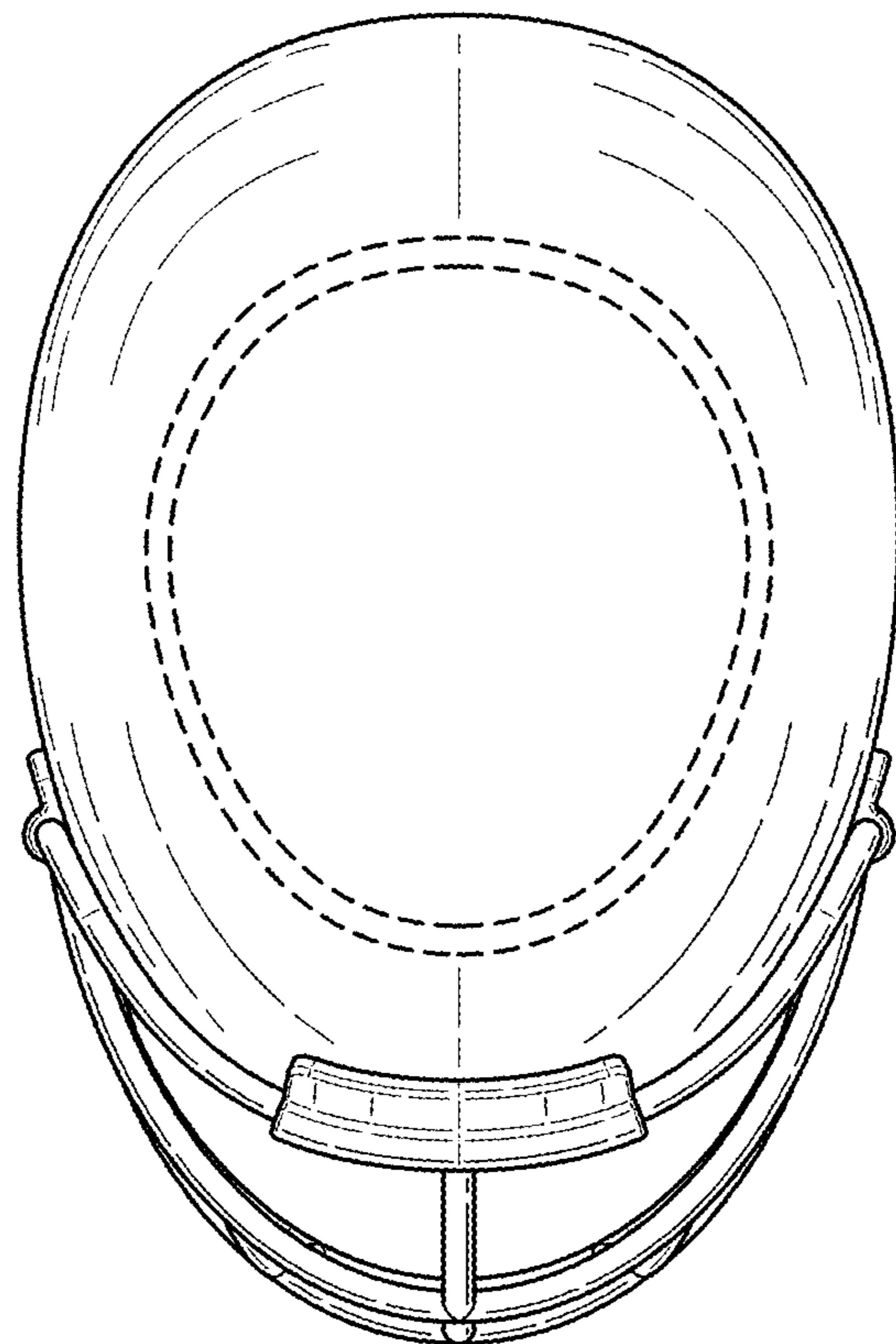

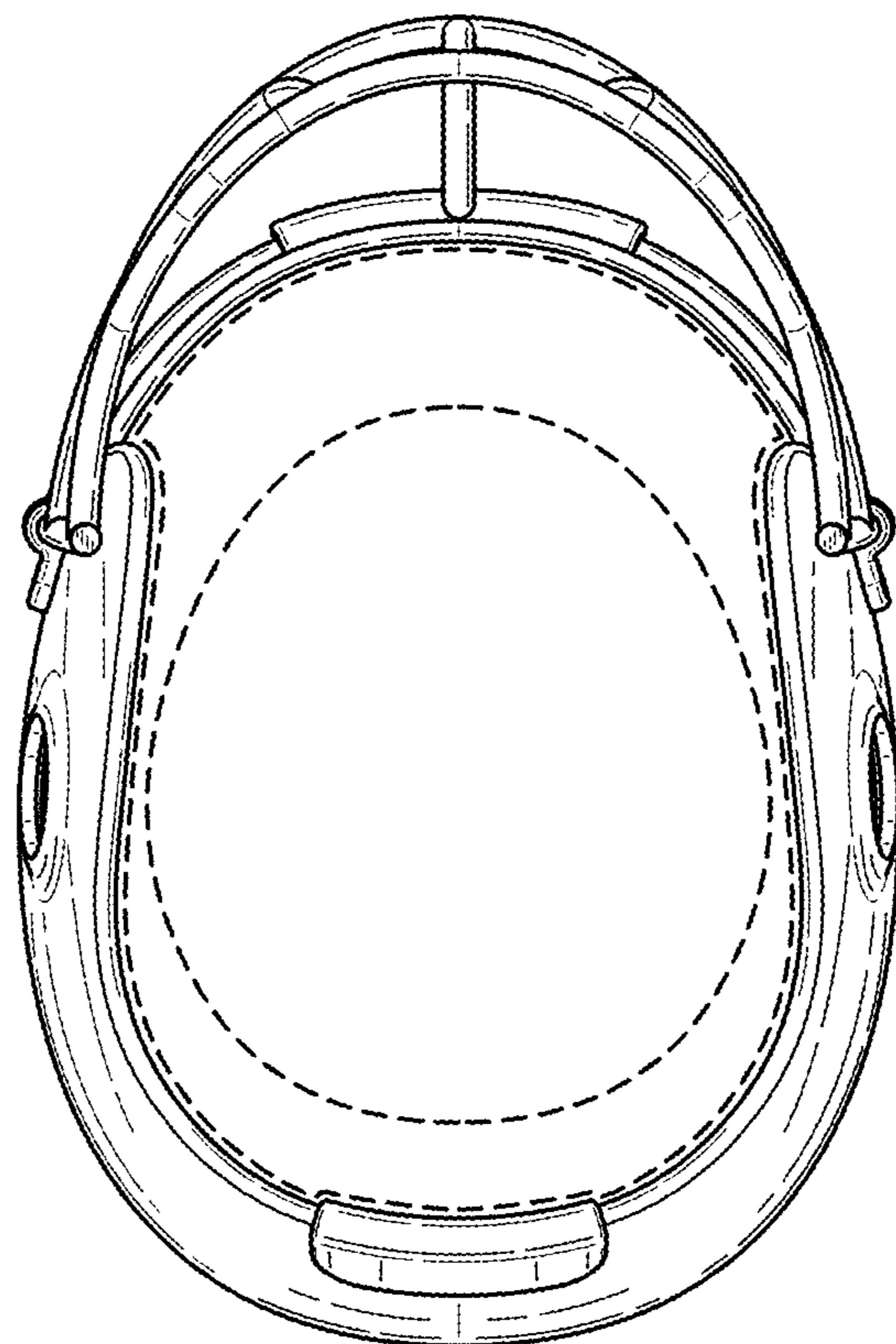
