DESCRIPTION

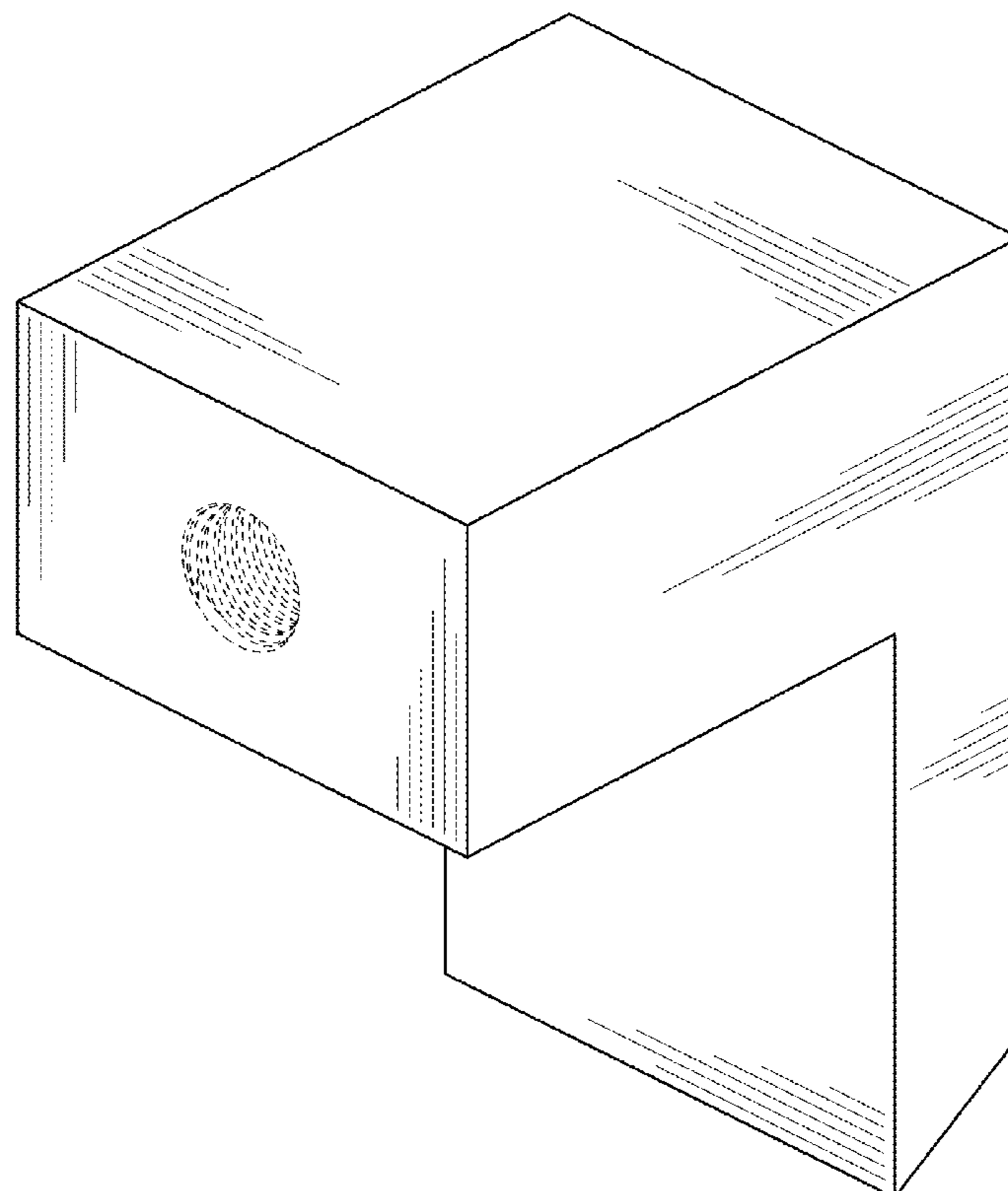
FIG. 1 is an isometric view of the head component for a push-pull tool;

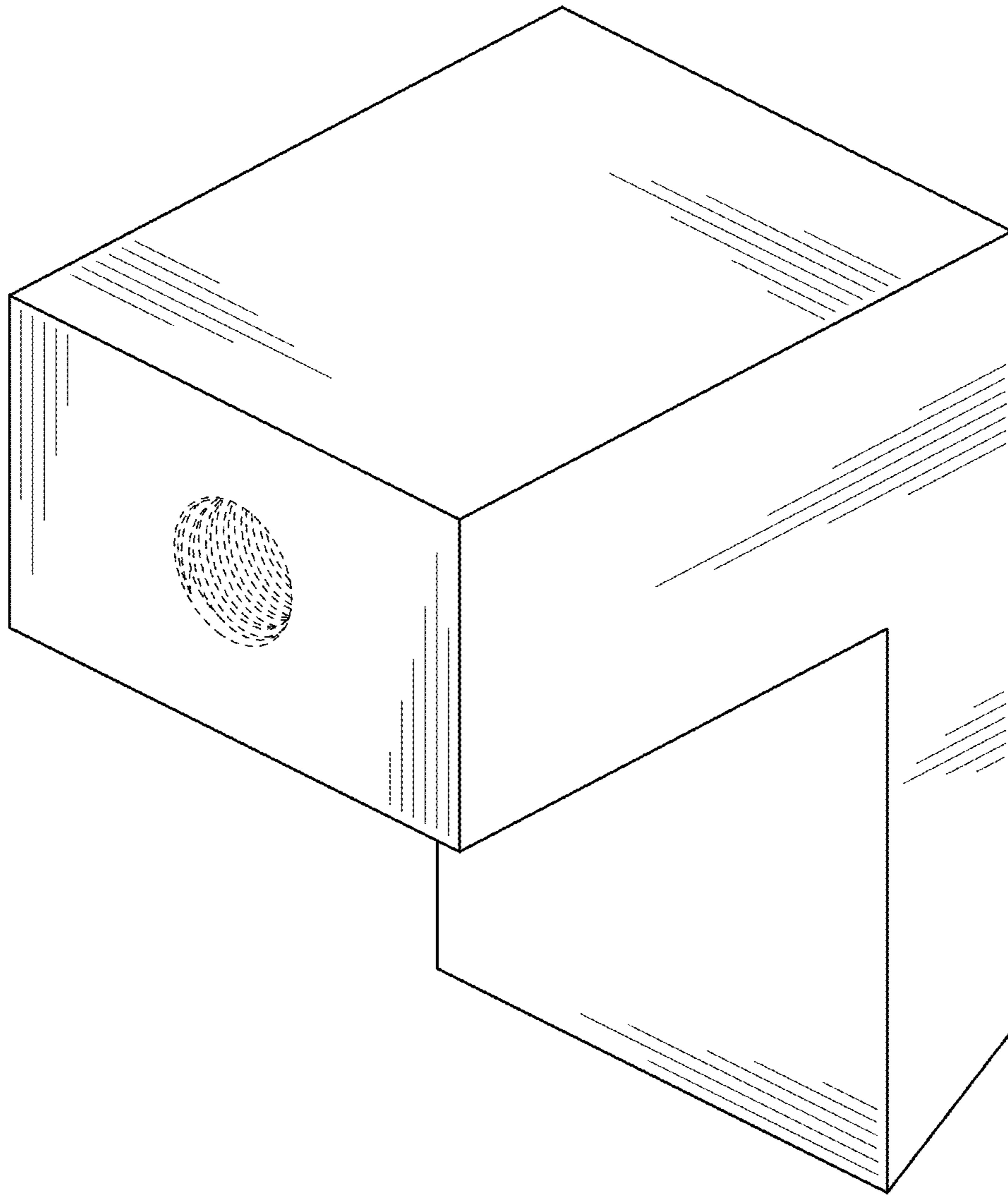

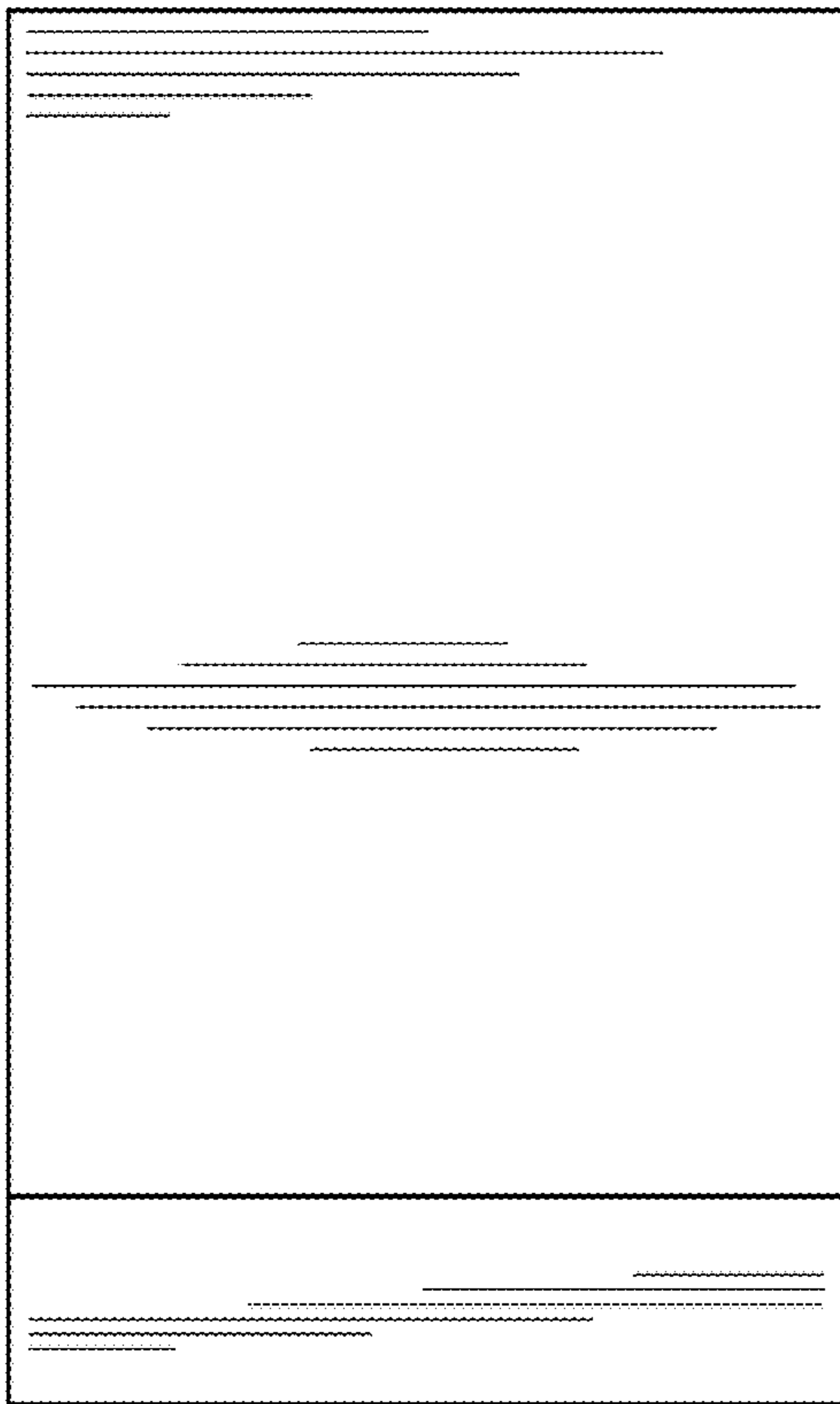

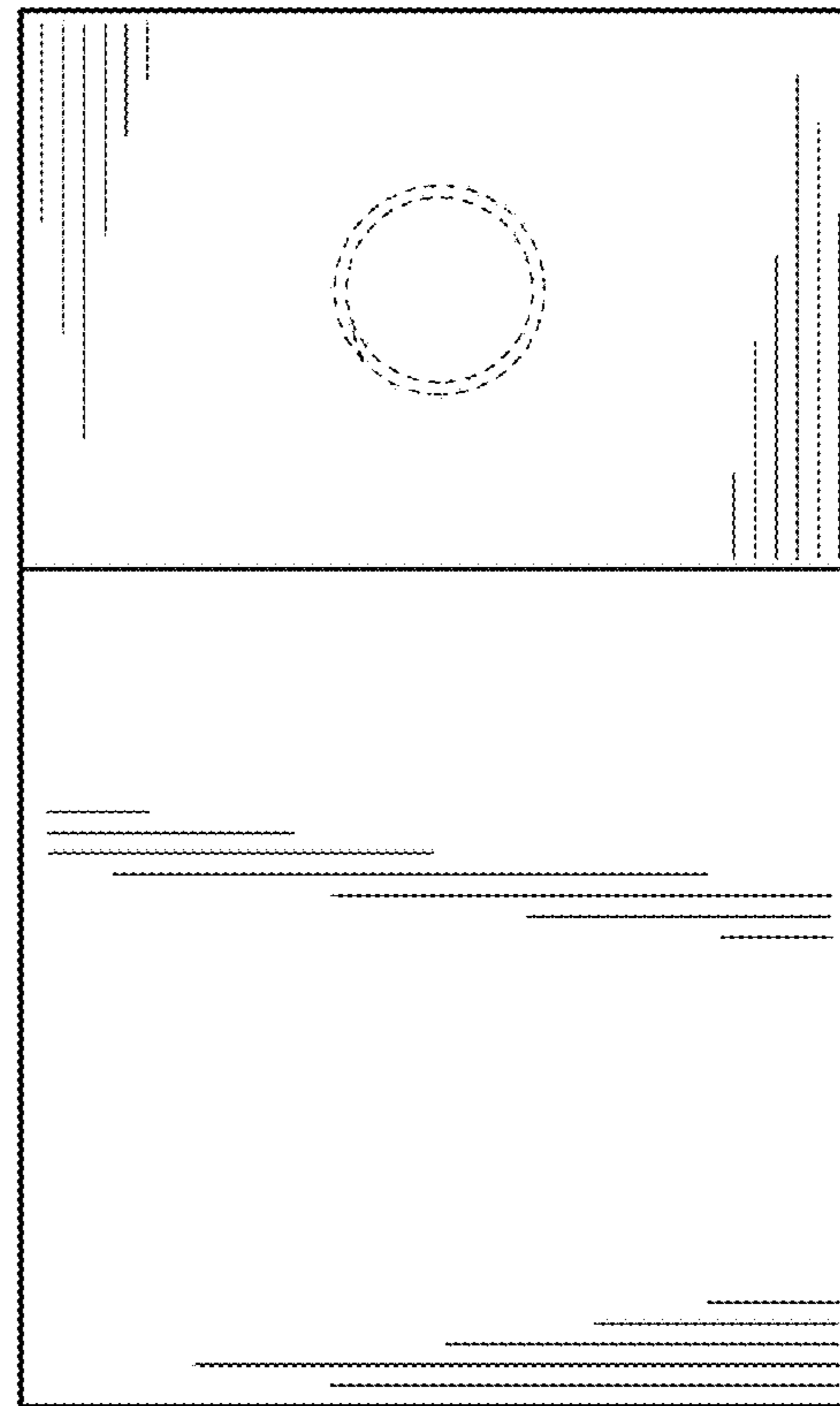

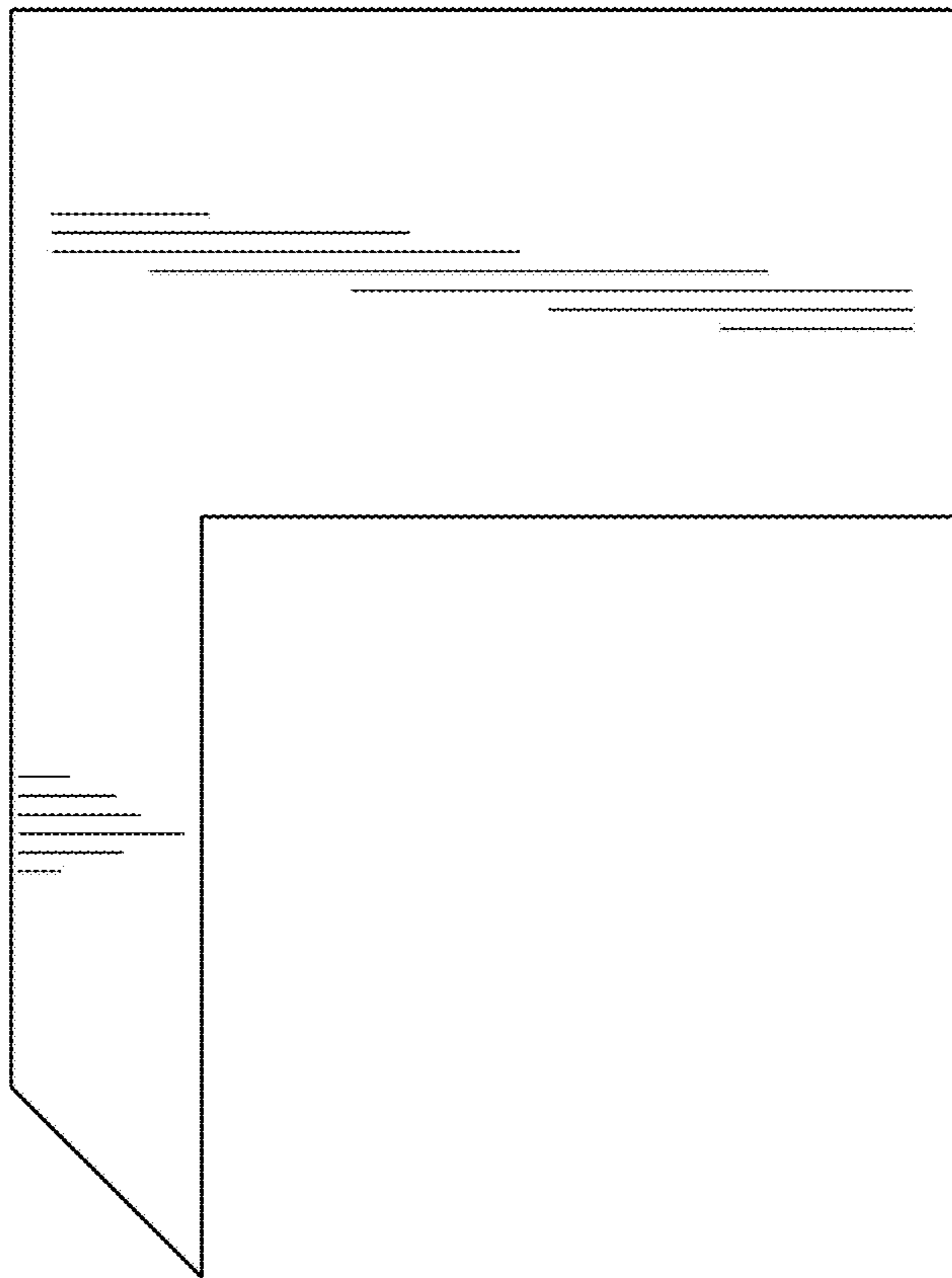

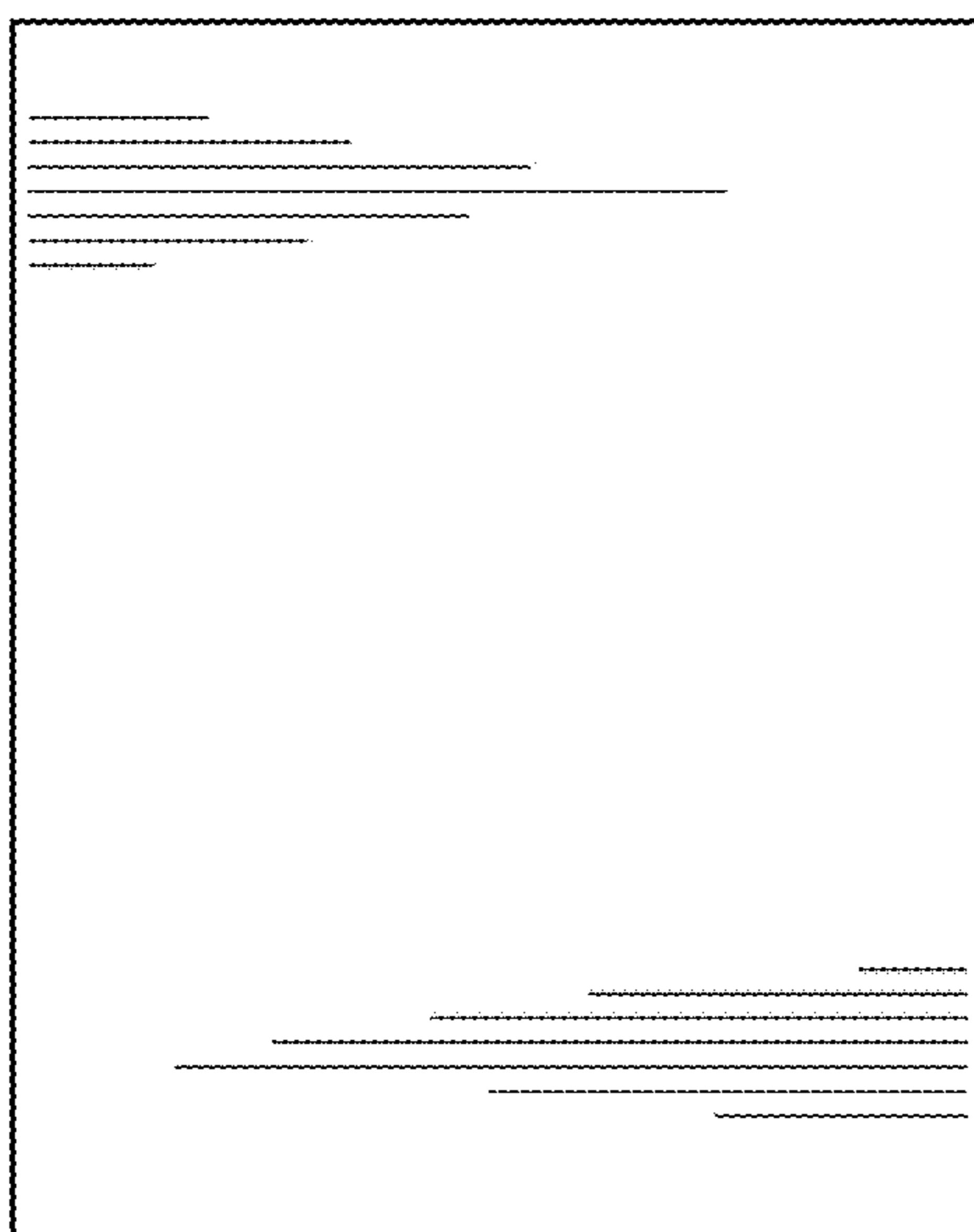

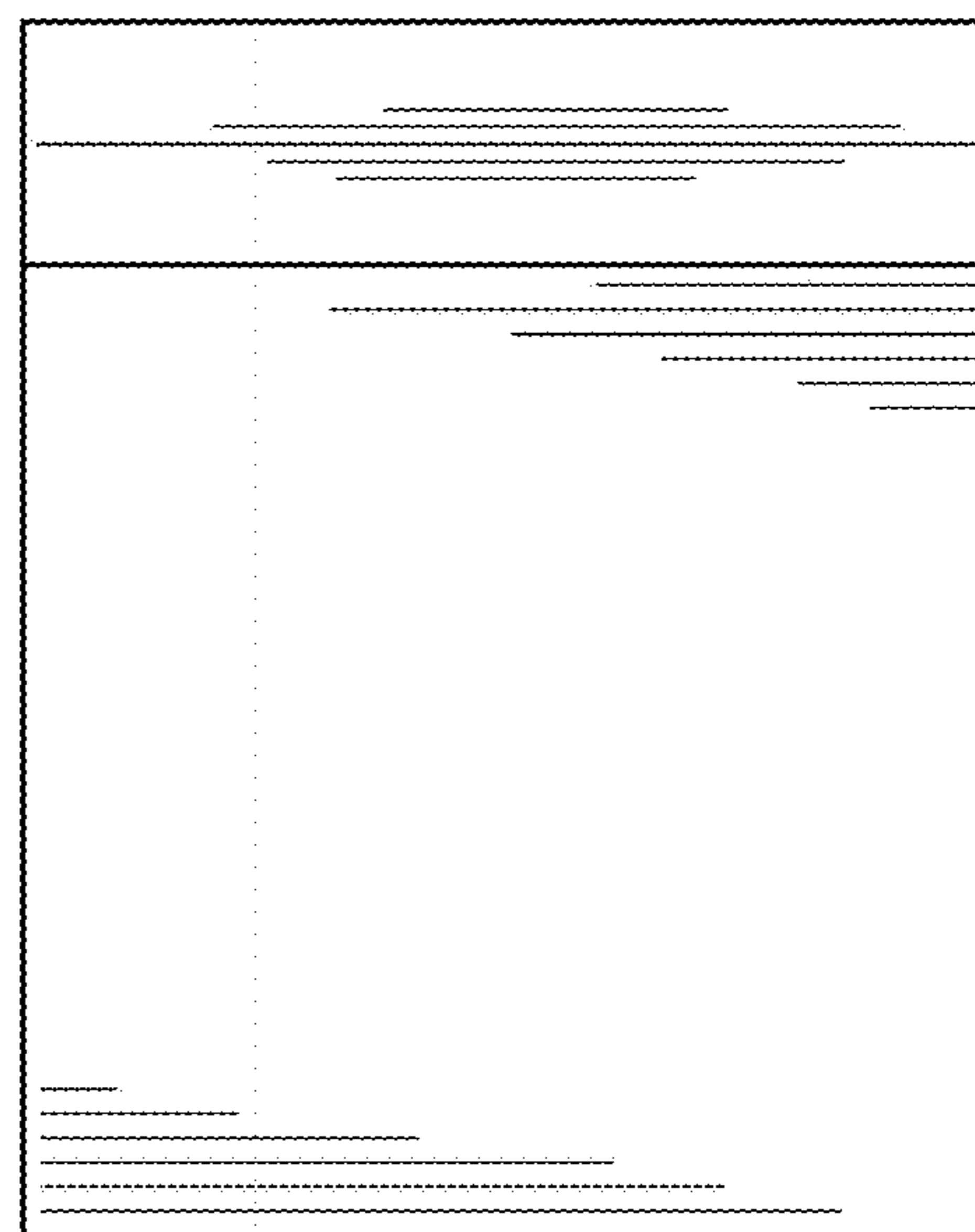
