**DESCRIPTION**

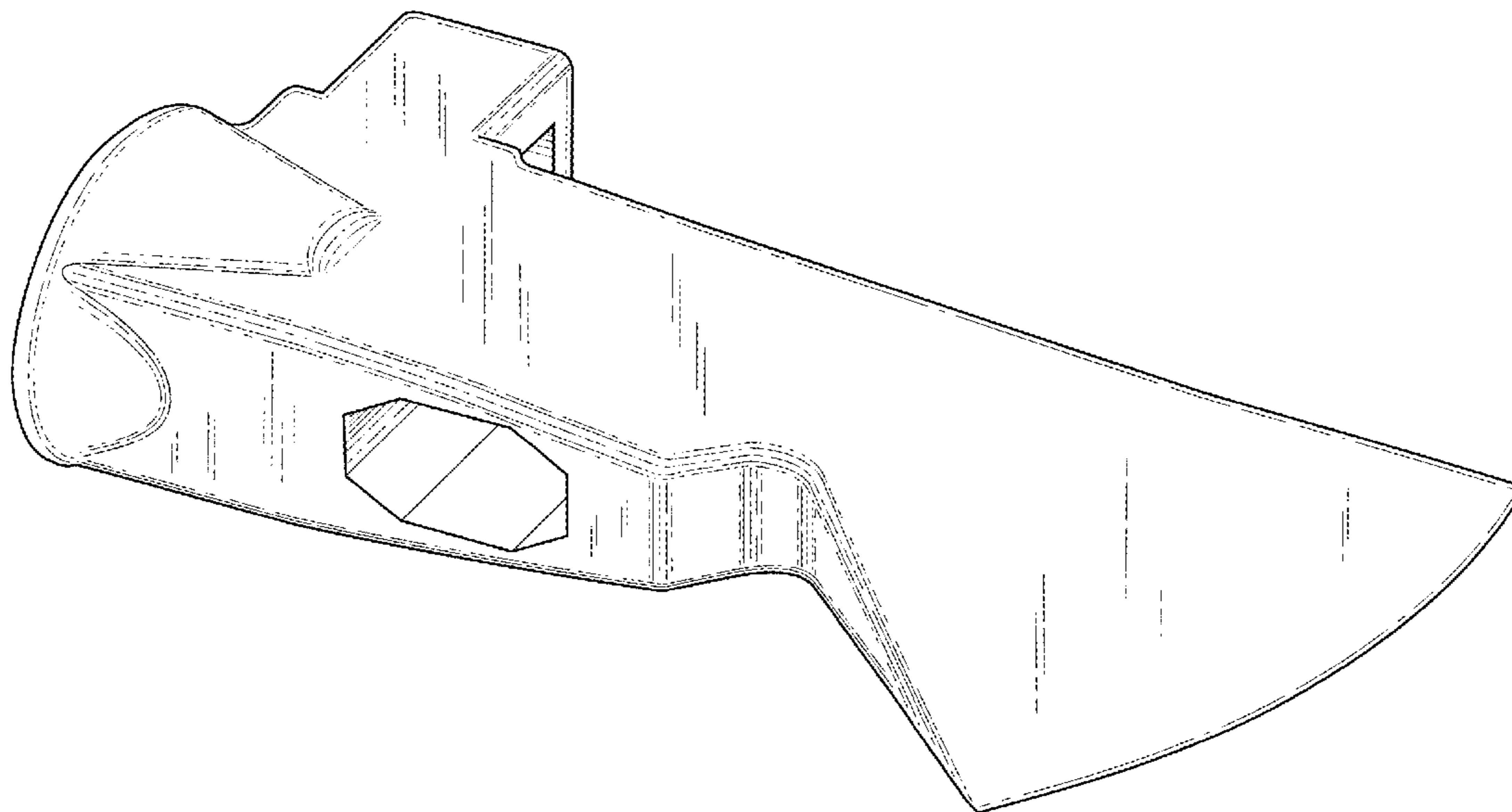
FIG. 1 is a perspective view of a multi-purpose ax head with striking surface showing my new design;  
FIG. 2 is a front elevation view of the multi-purpose ax head with striking surface of FIG. 1;  
FIG. 3 is a rear view of the multi-purpose ax head with striking surface of FIG. 1, rotated 180 degrees from FIG. 2;  
FIG. 4 is a top plan view of the multi-purpose ax head with striking surface of FIG. 1;

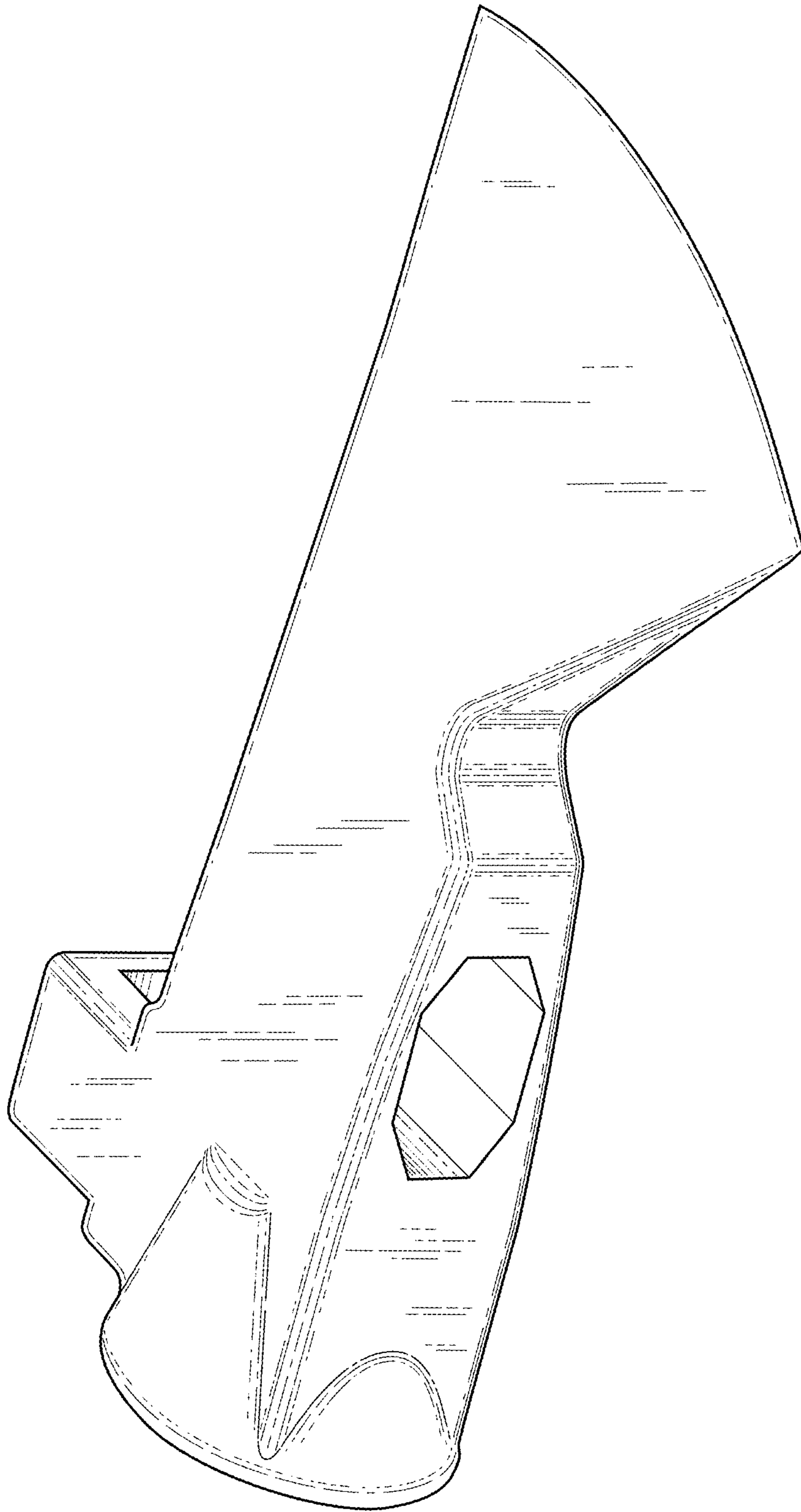

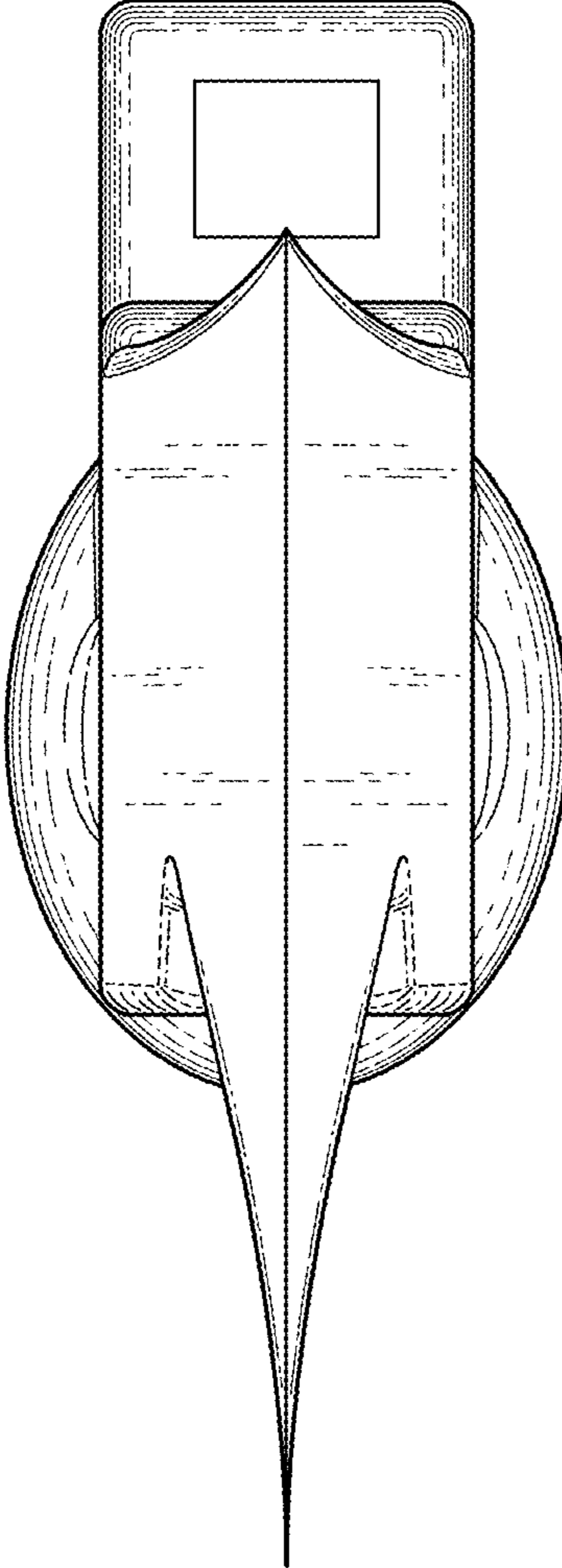

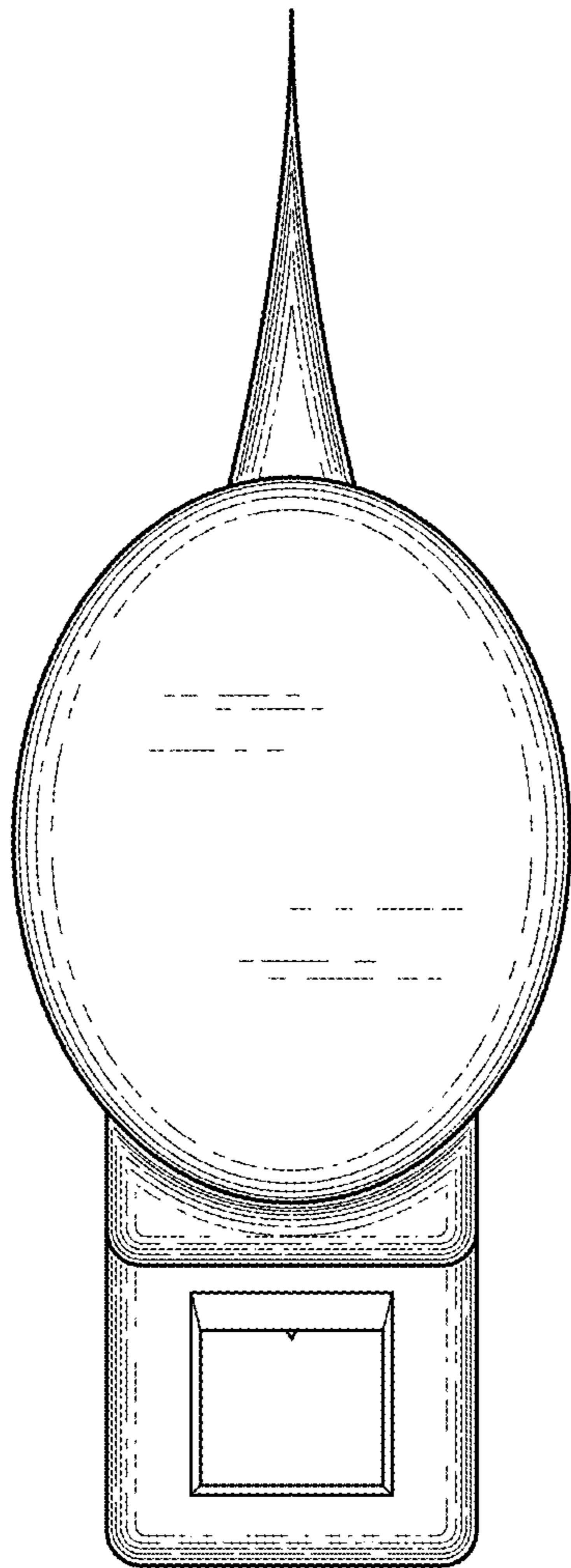

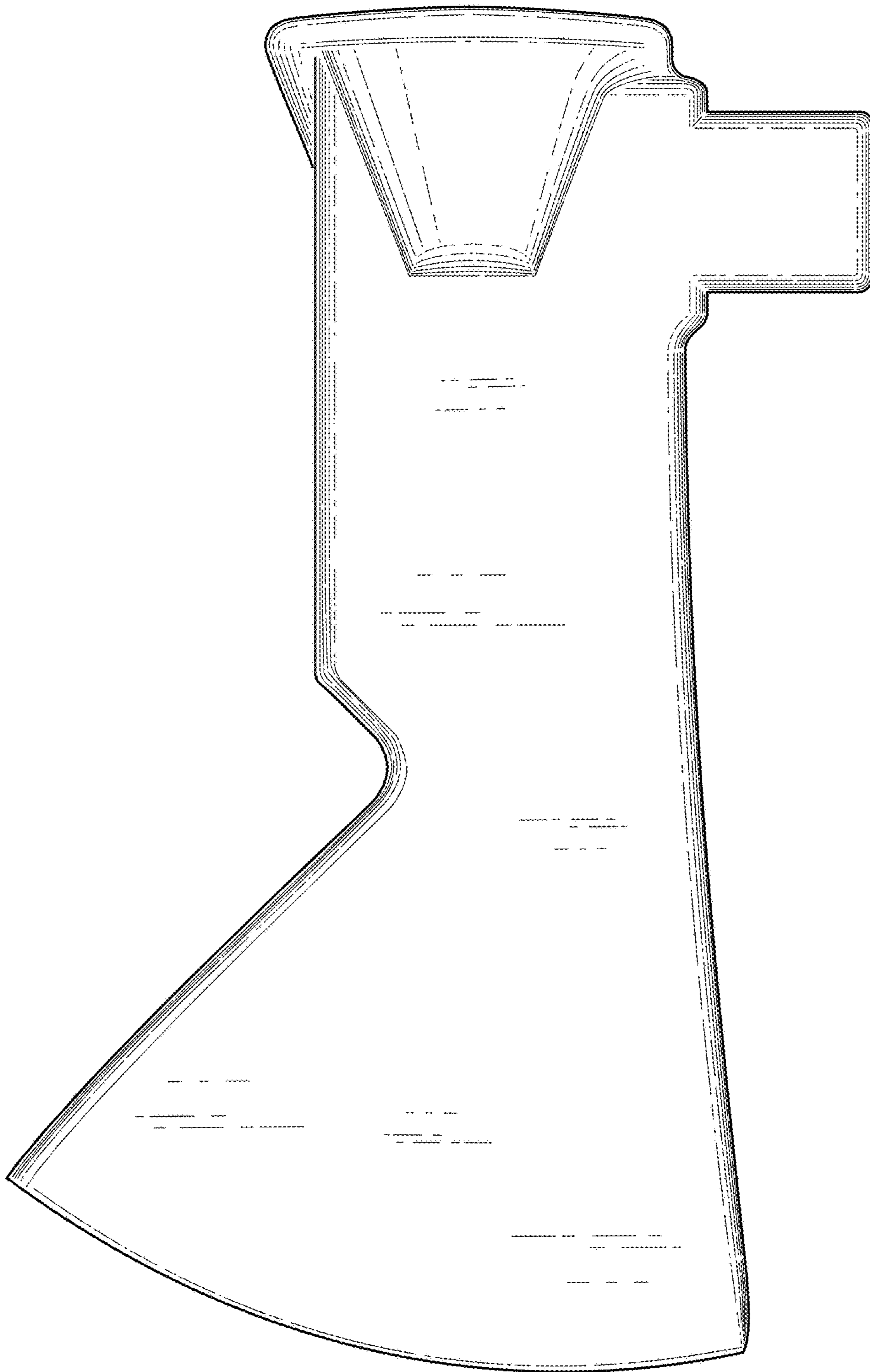

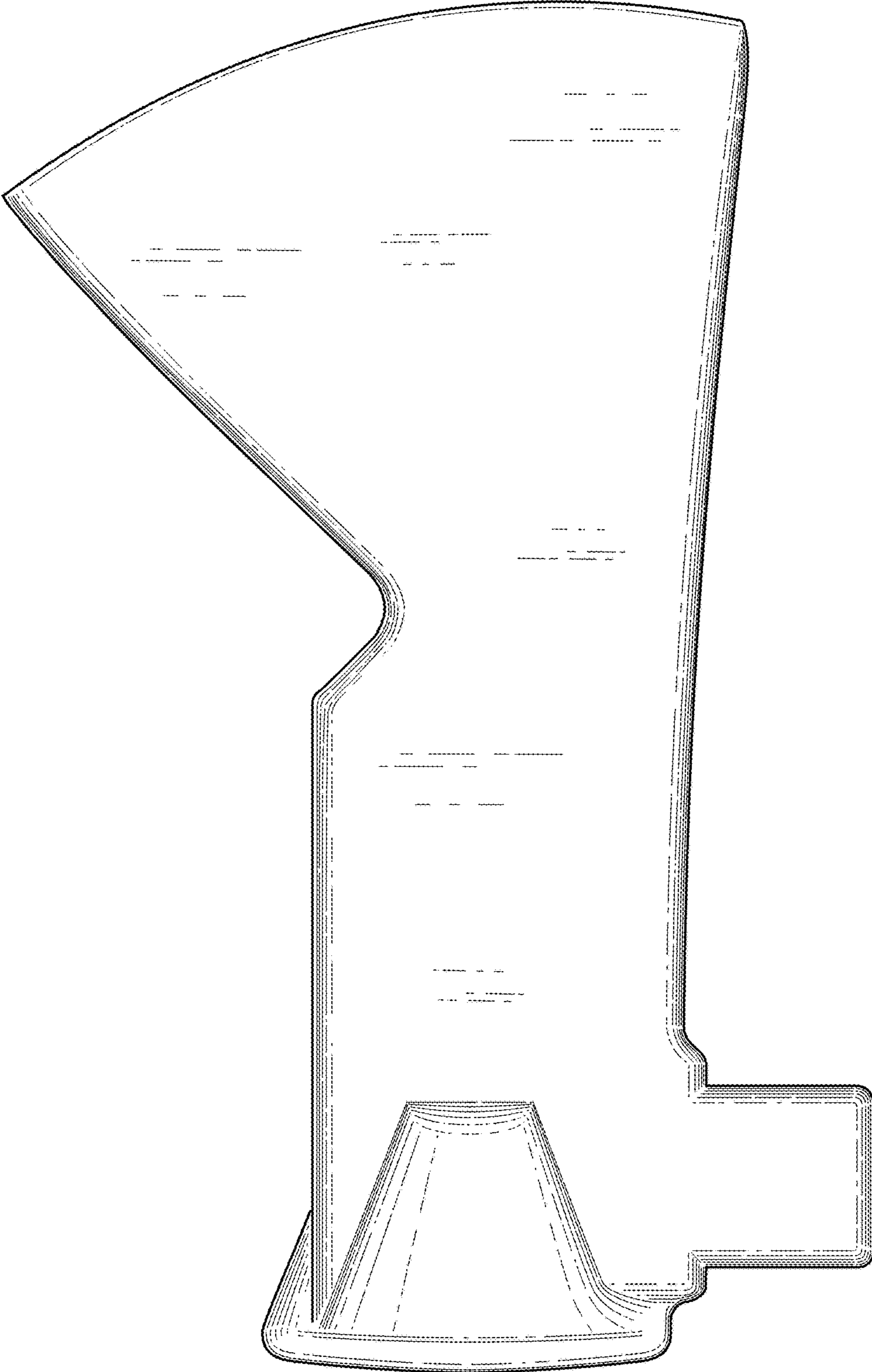

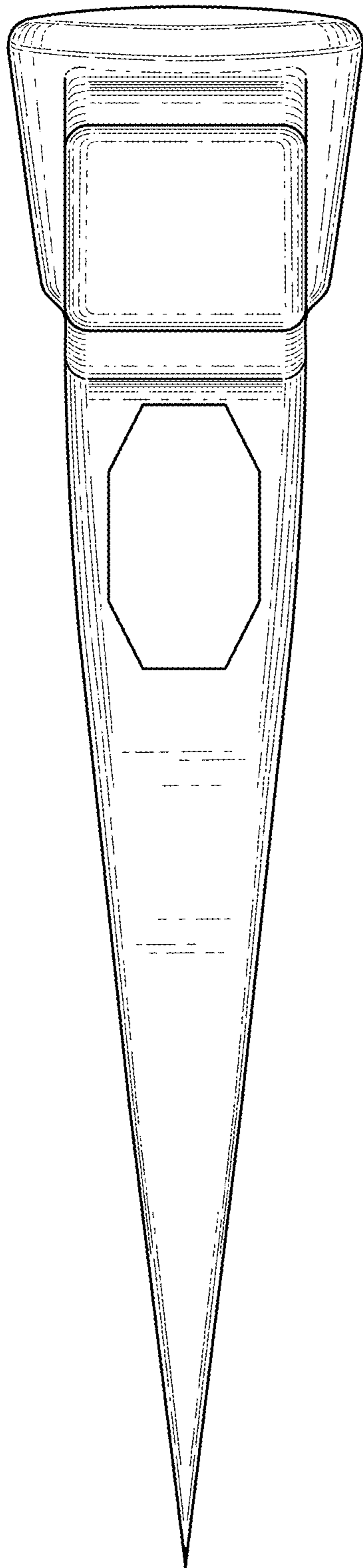

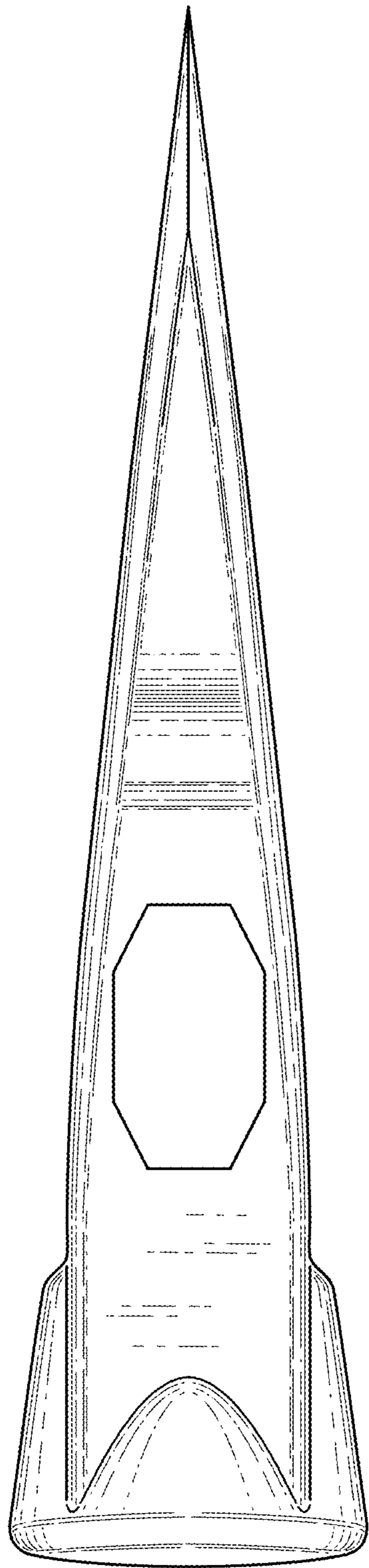
