(57) **CLAIM**

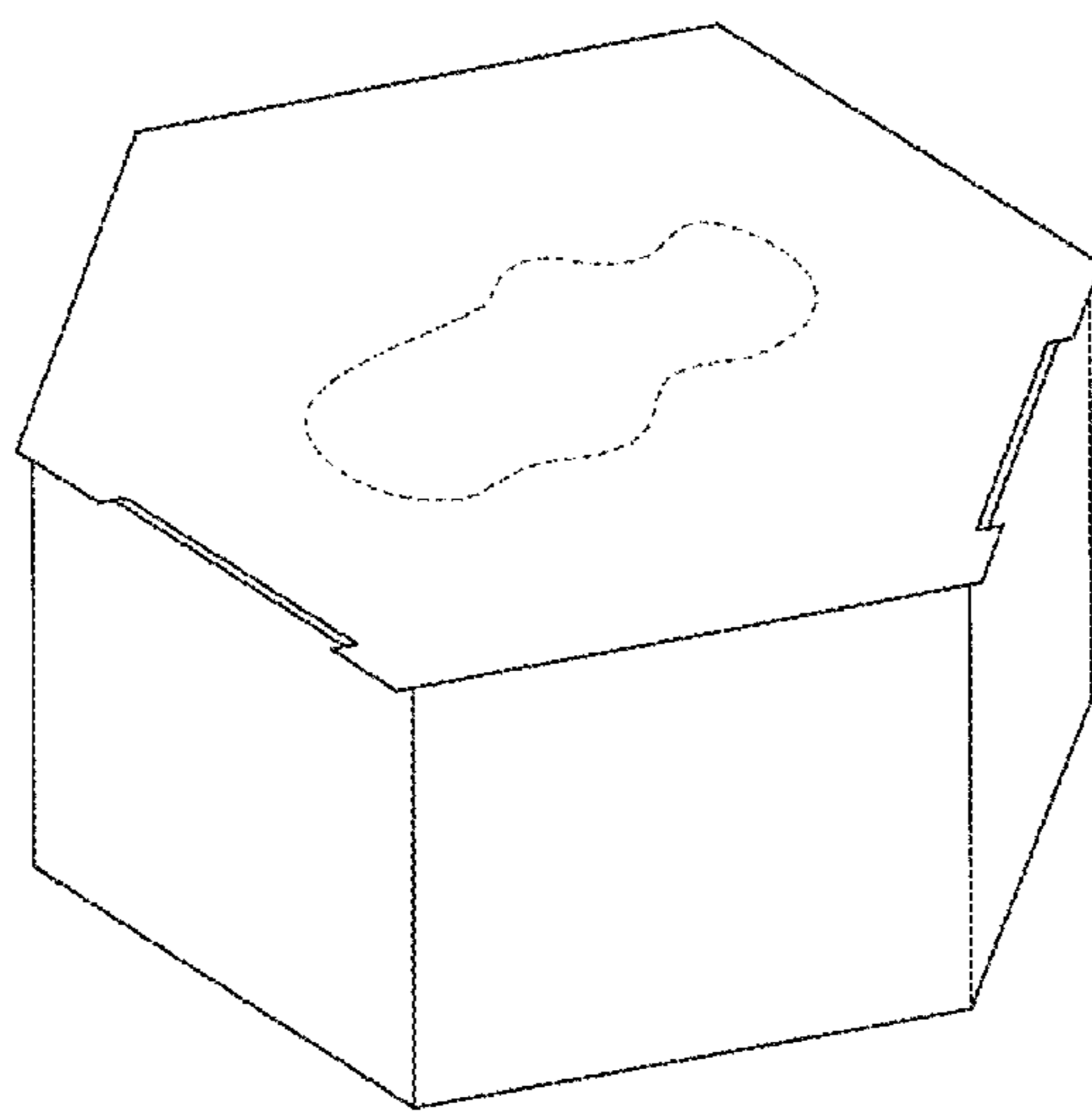
The ornamental design of the package for treats, as shown and described.

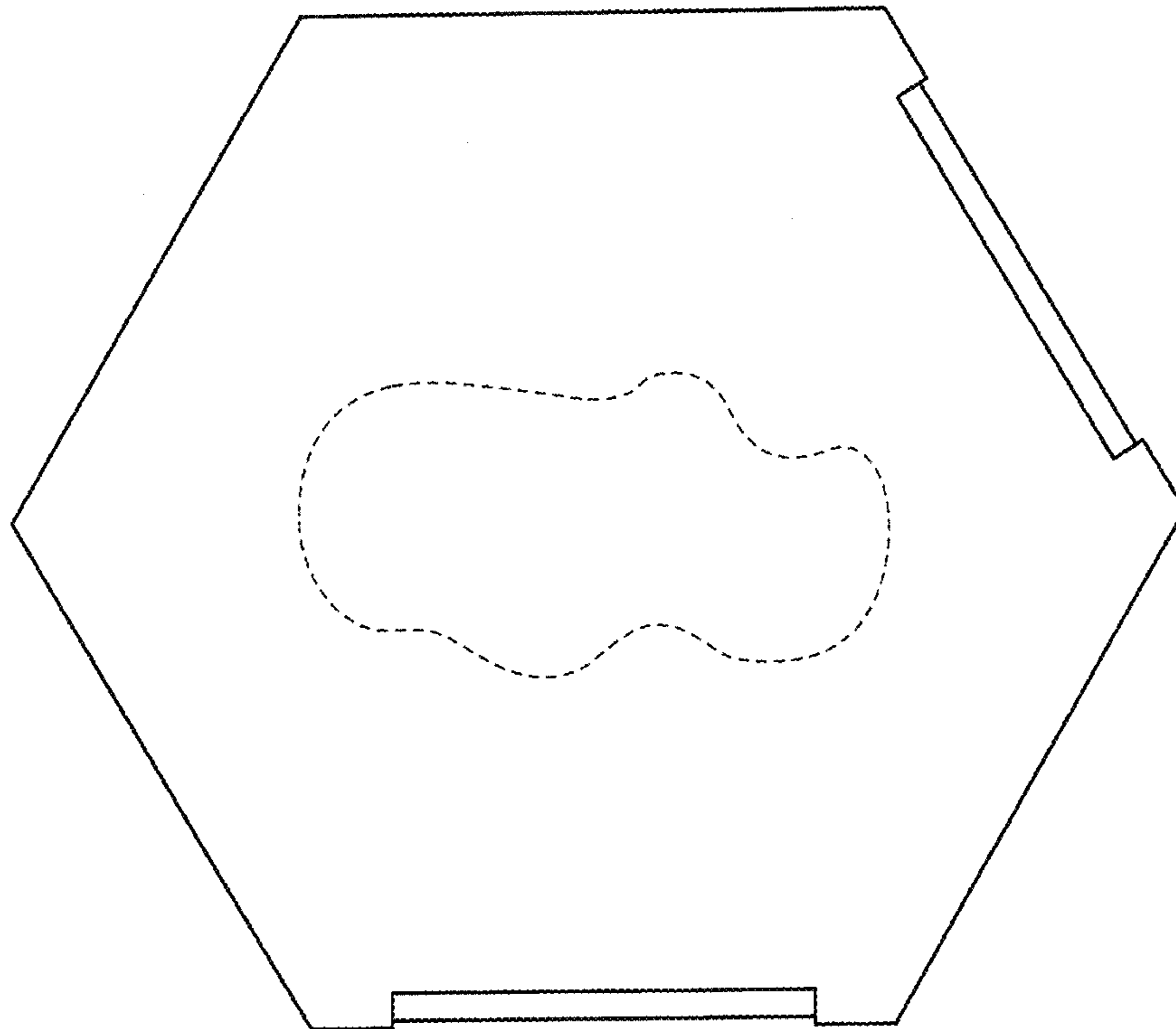

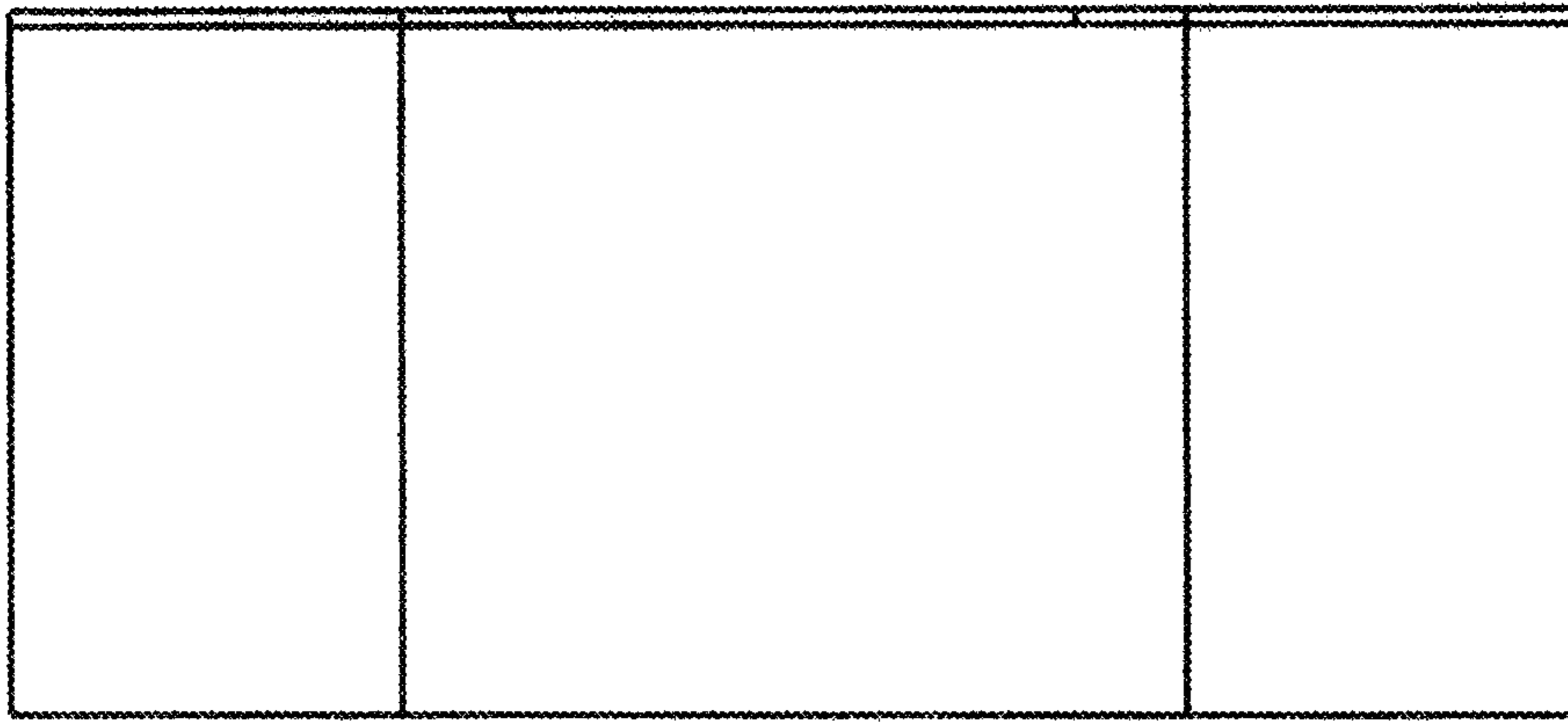

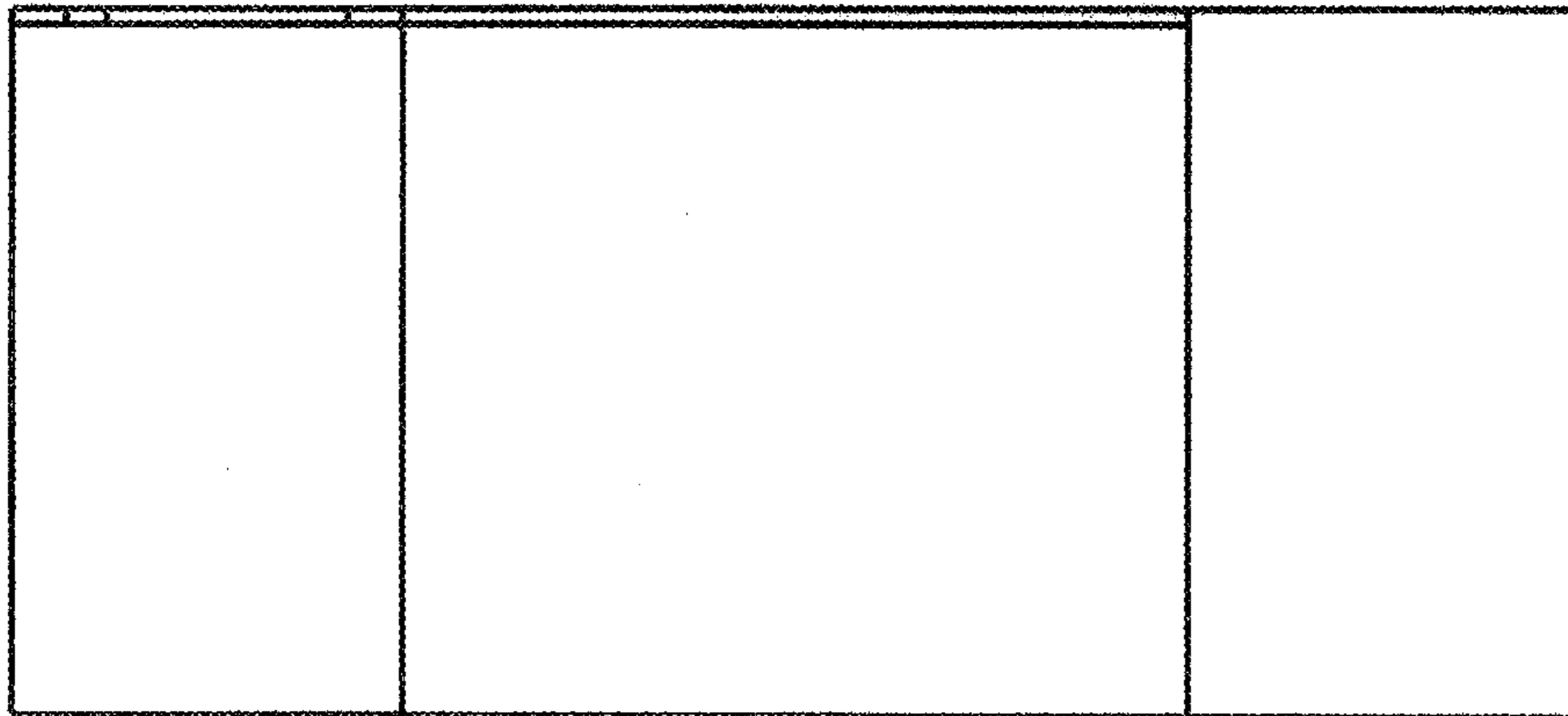

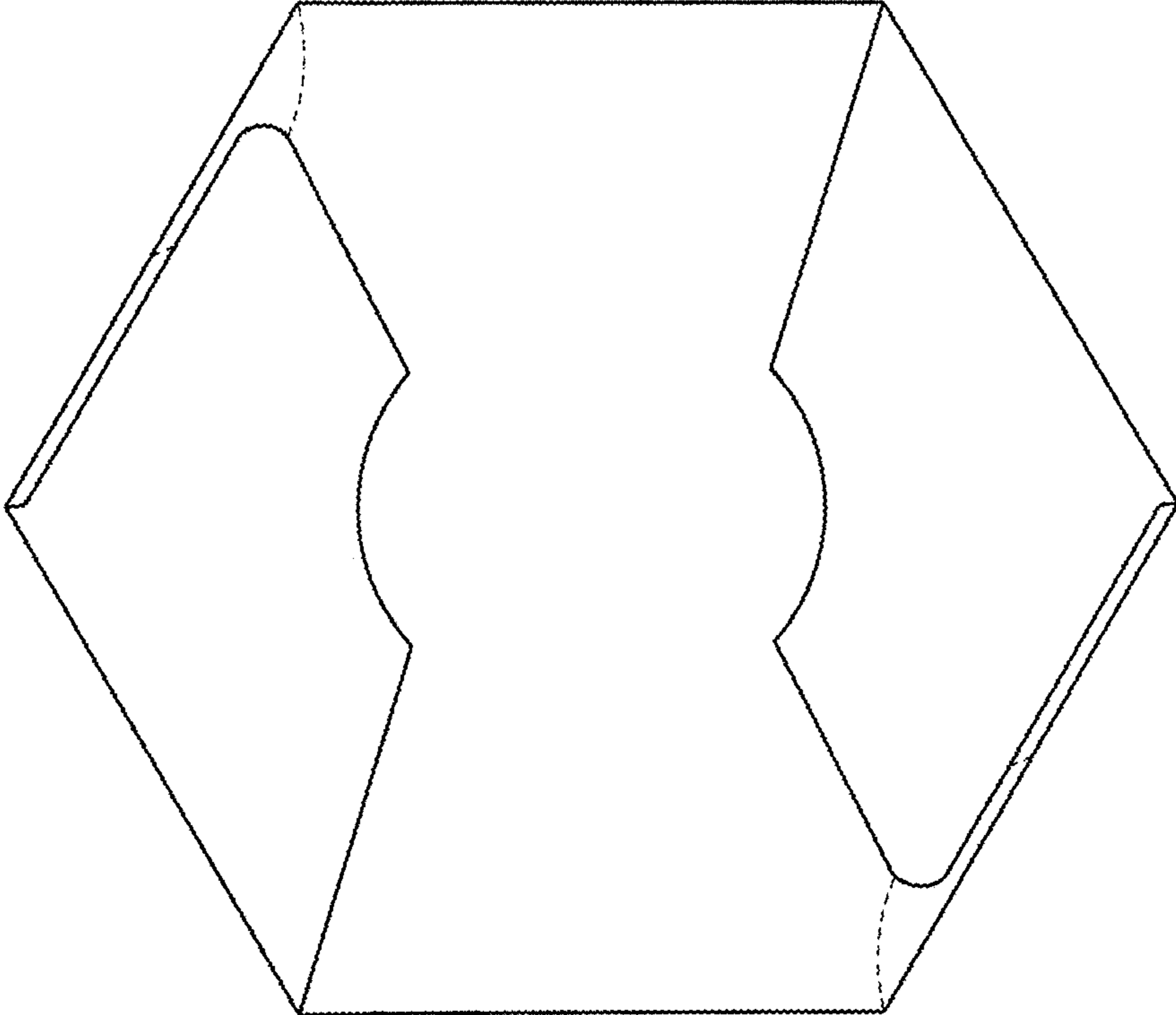

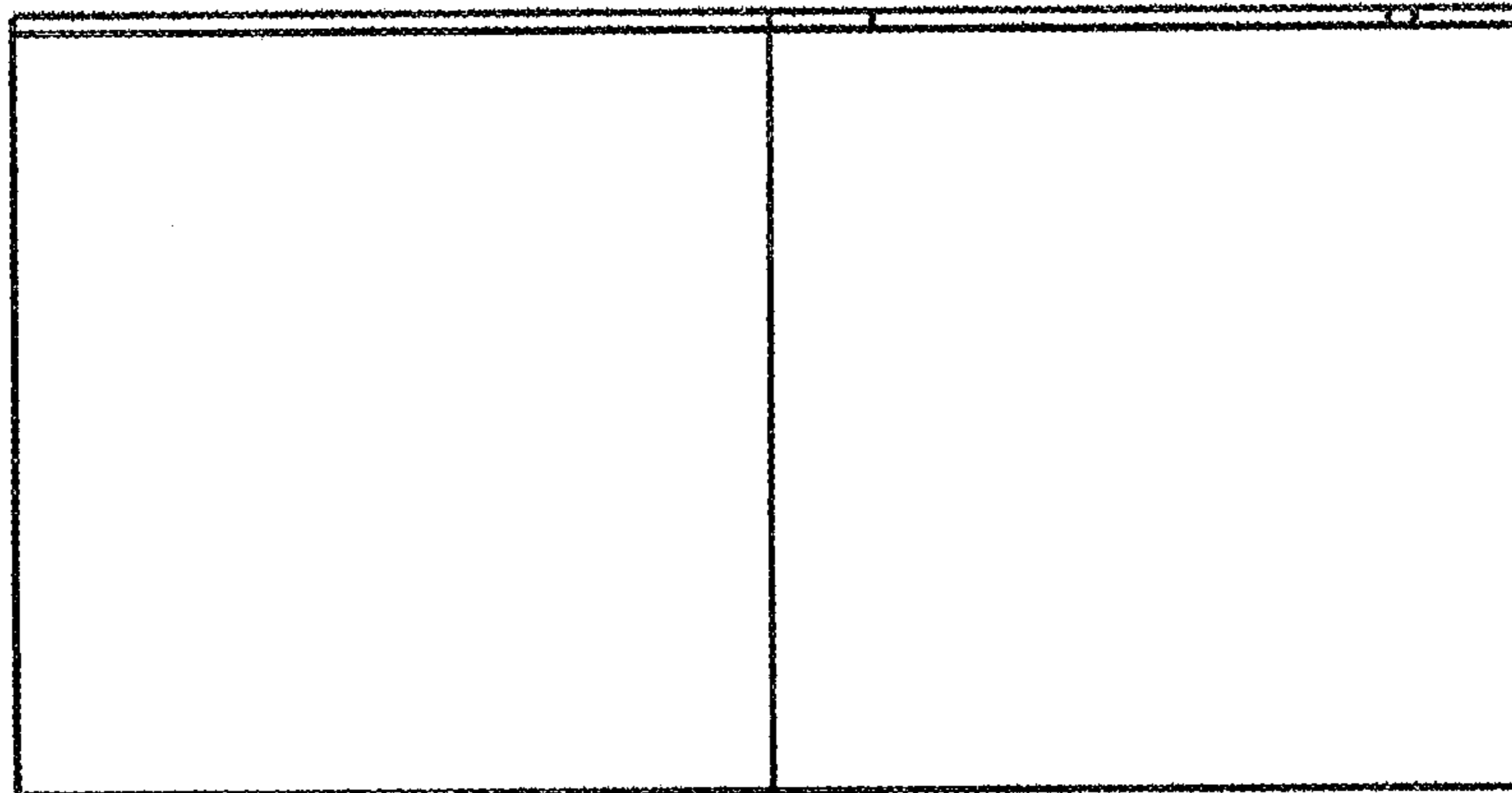

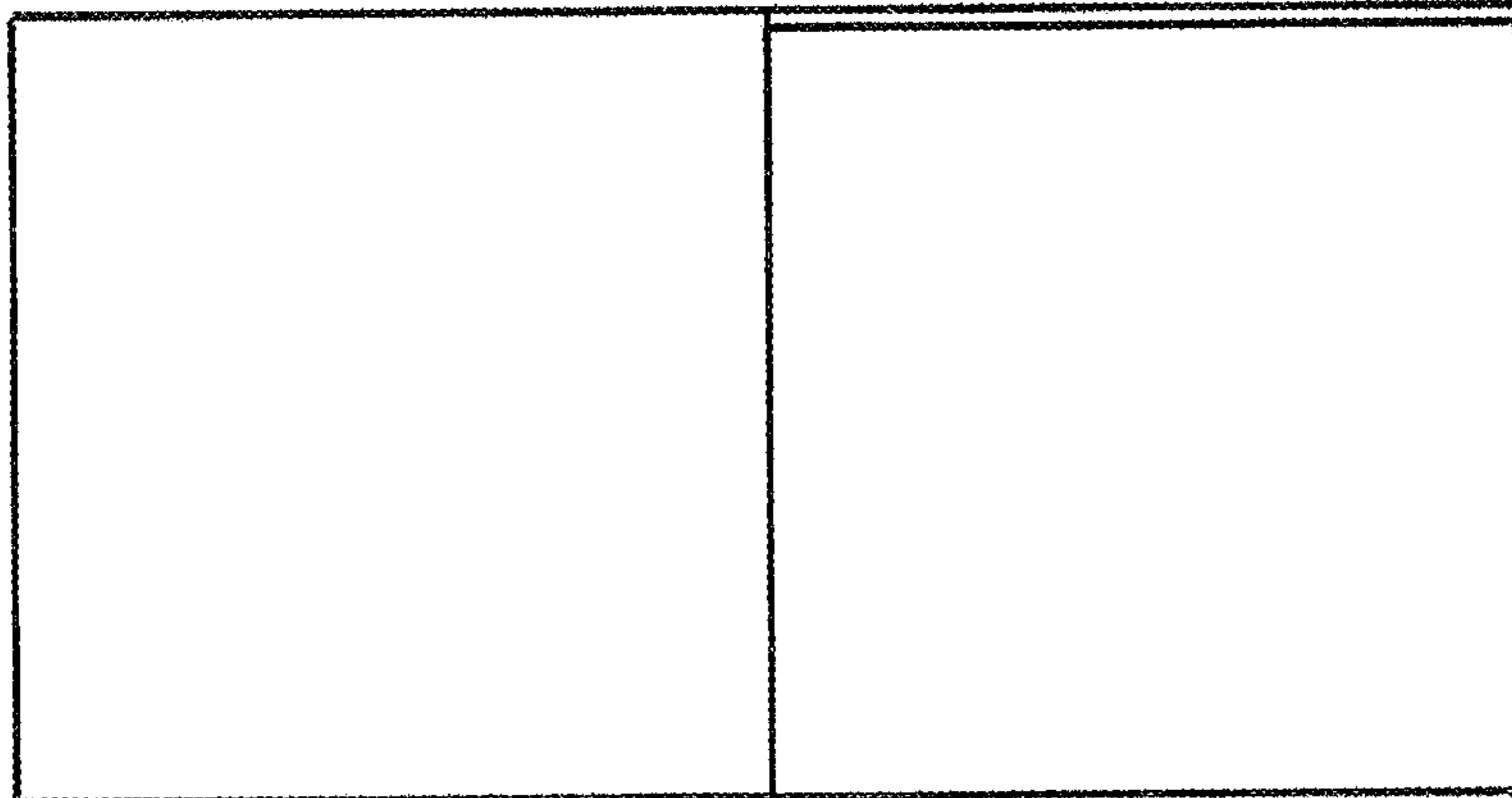

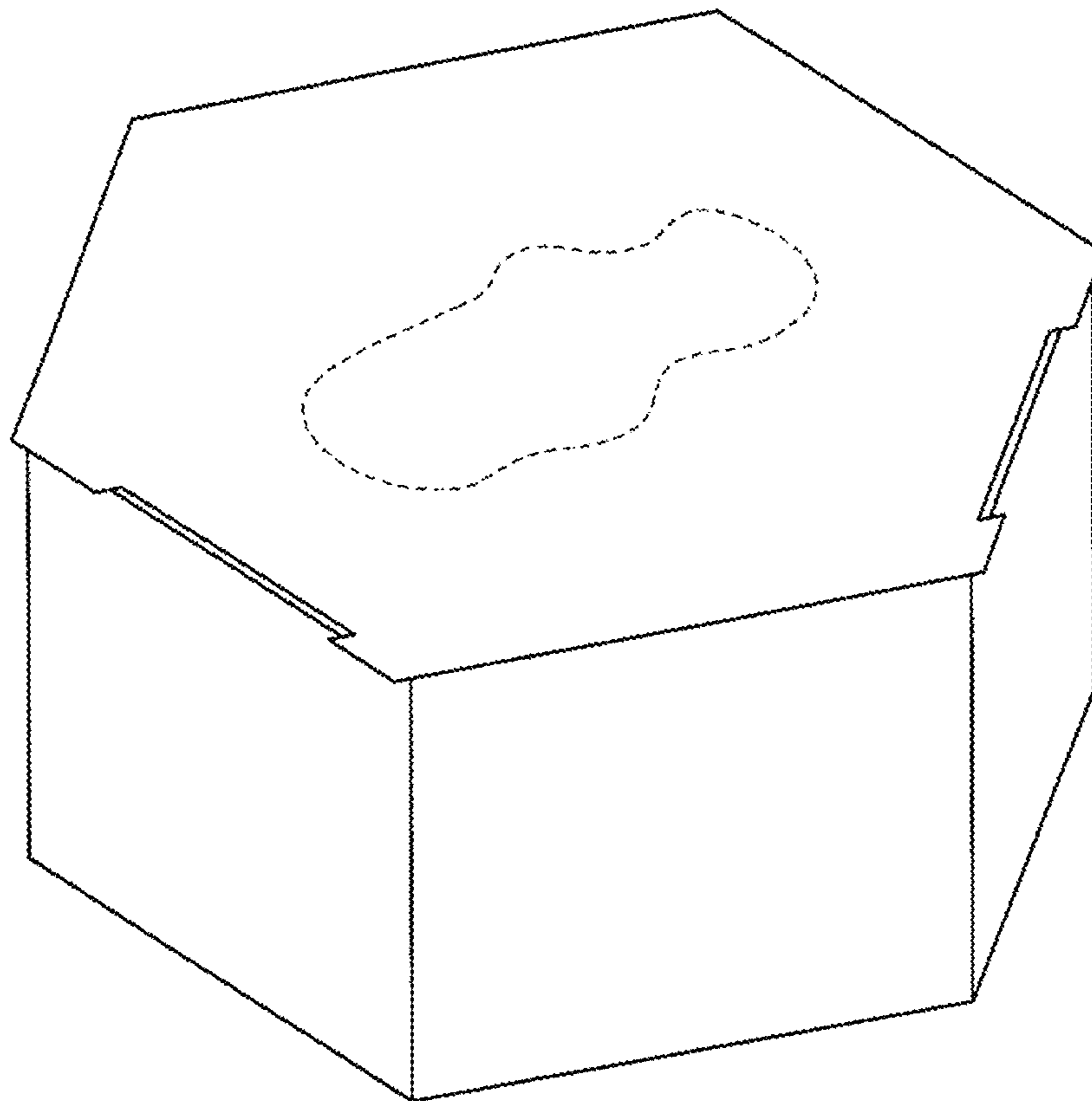
