FIG. 1.

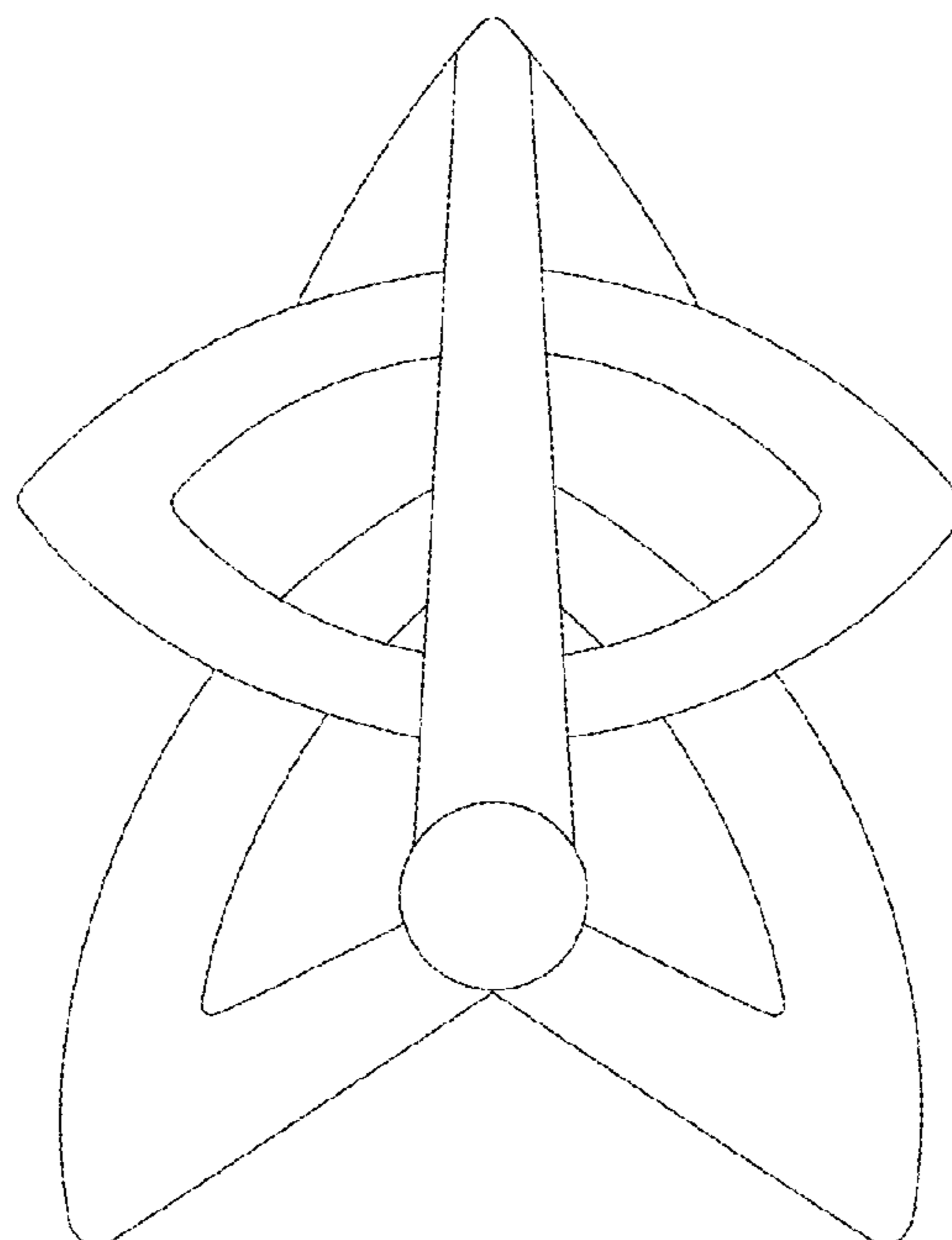
FIG. 4 is a bottom view of the decorative element for jewelry

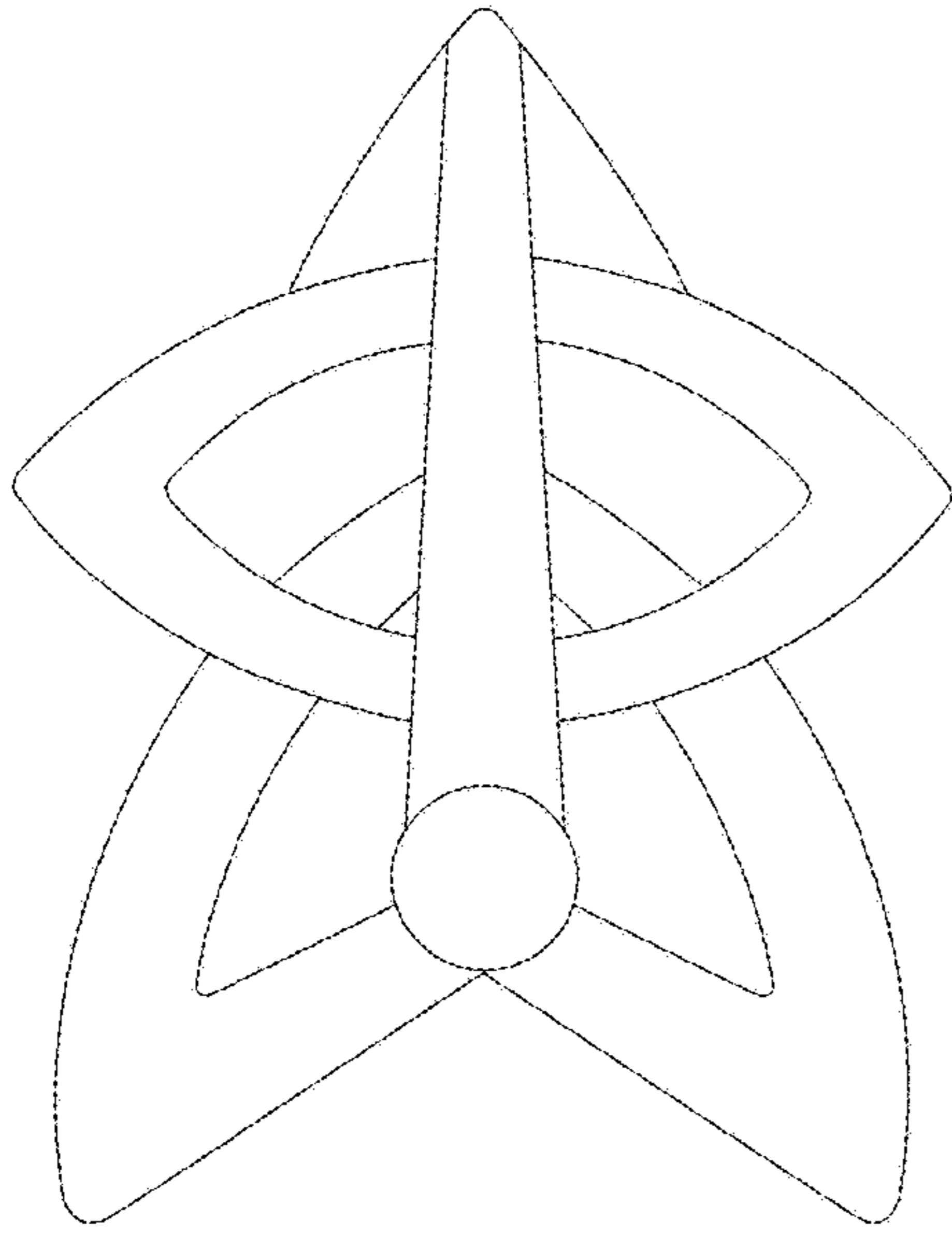

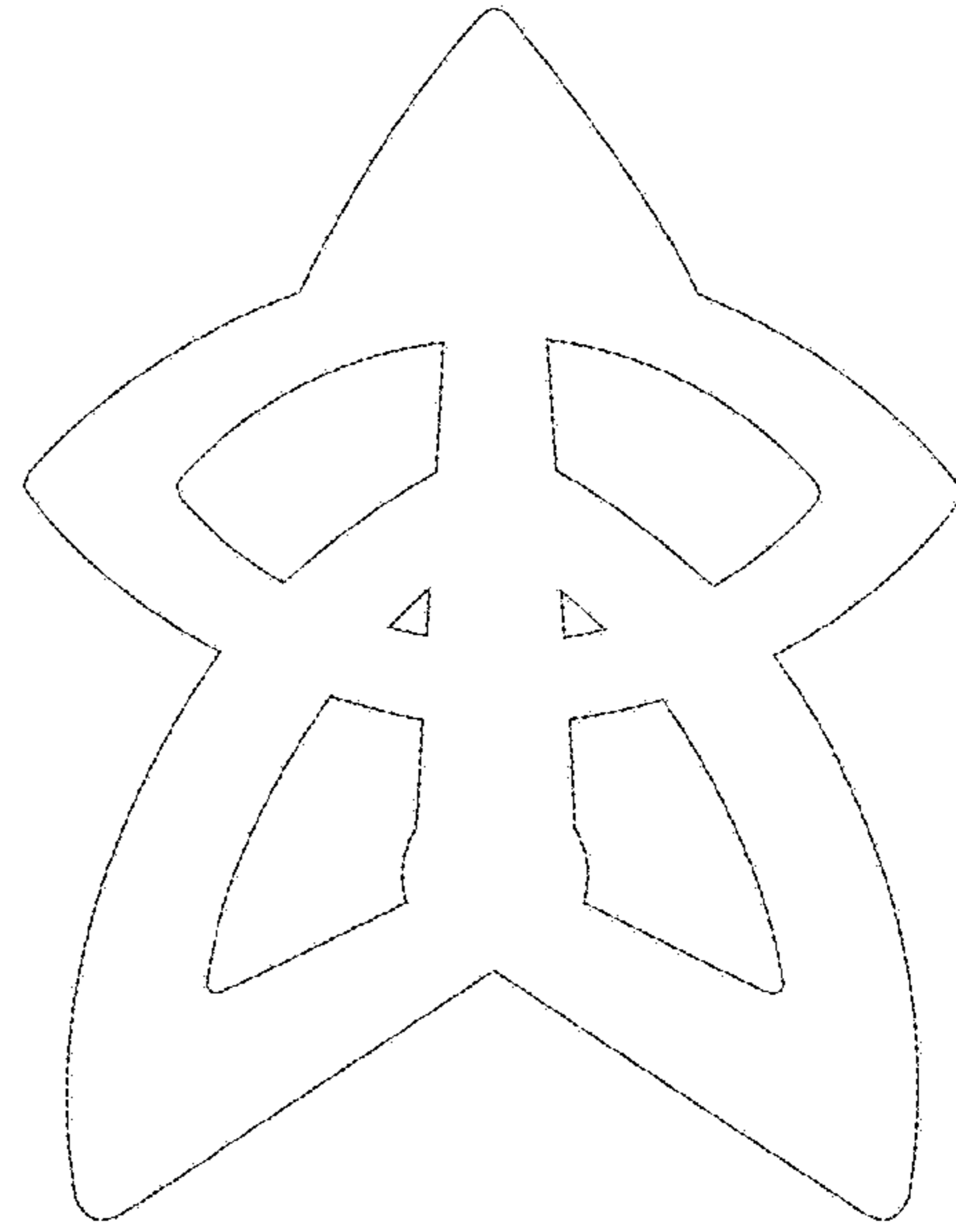

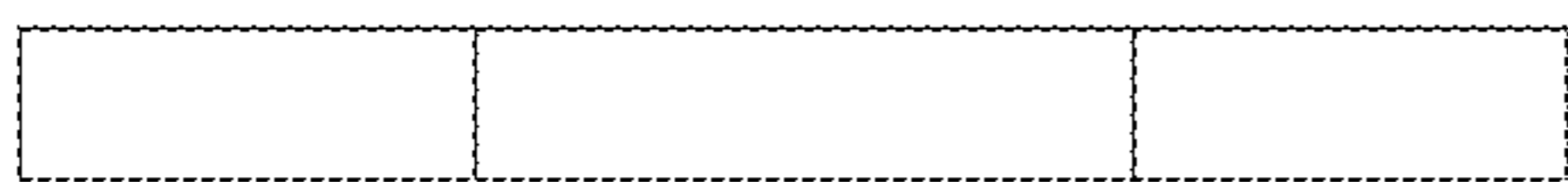

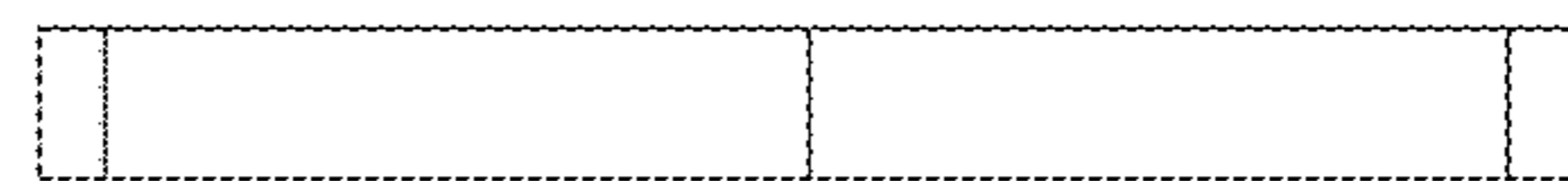

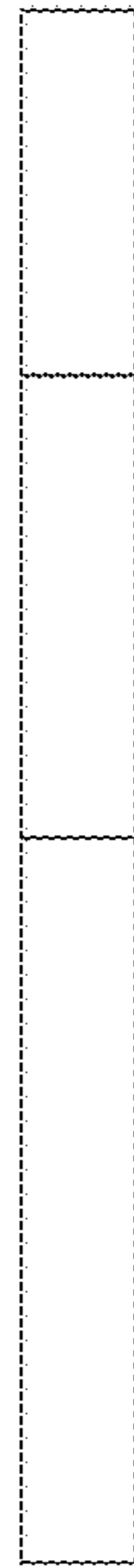

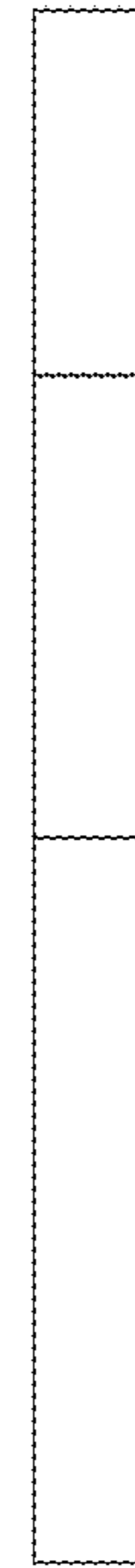

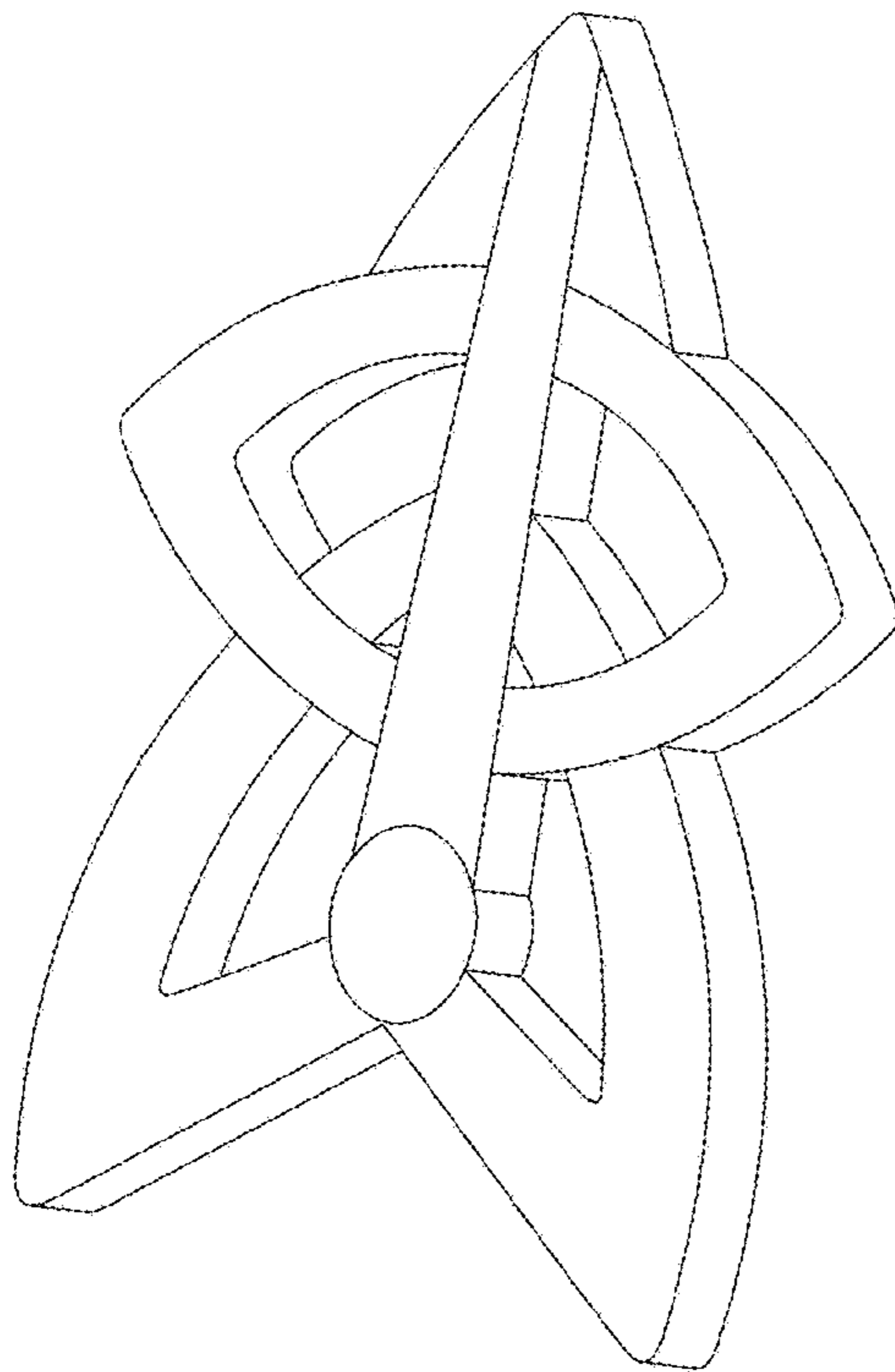
