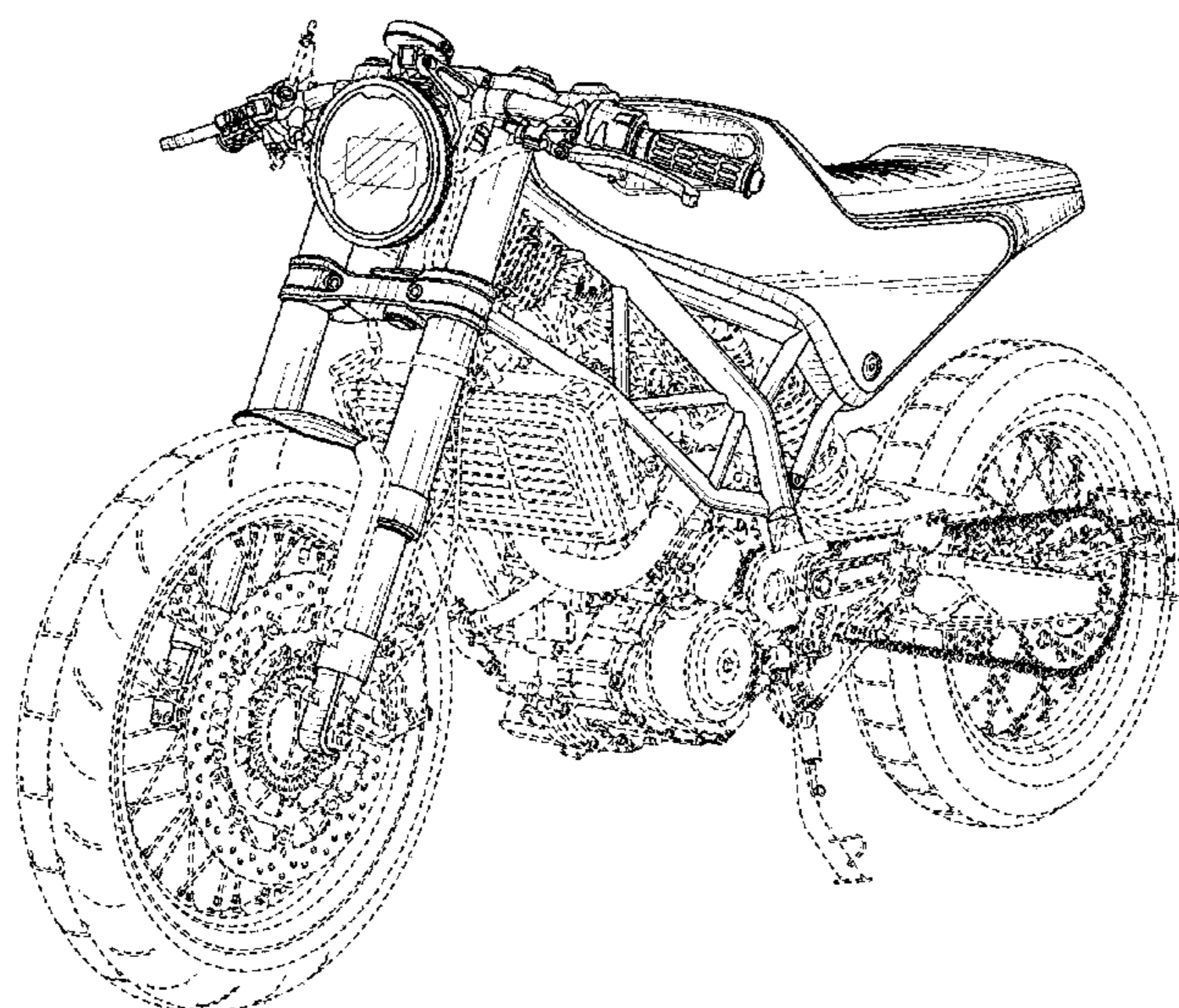
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front and right side perspective view of a motorcycle showing my new design;

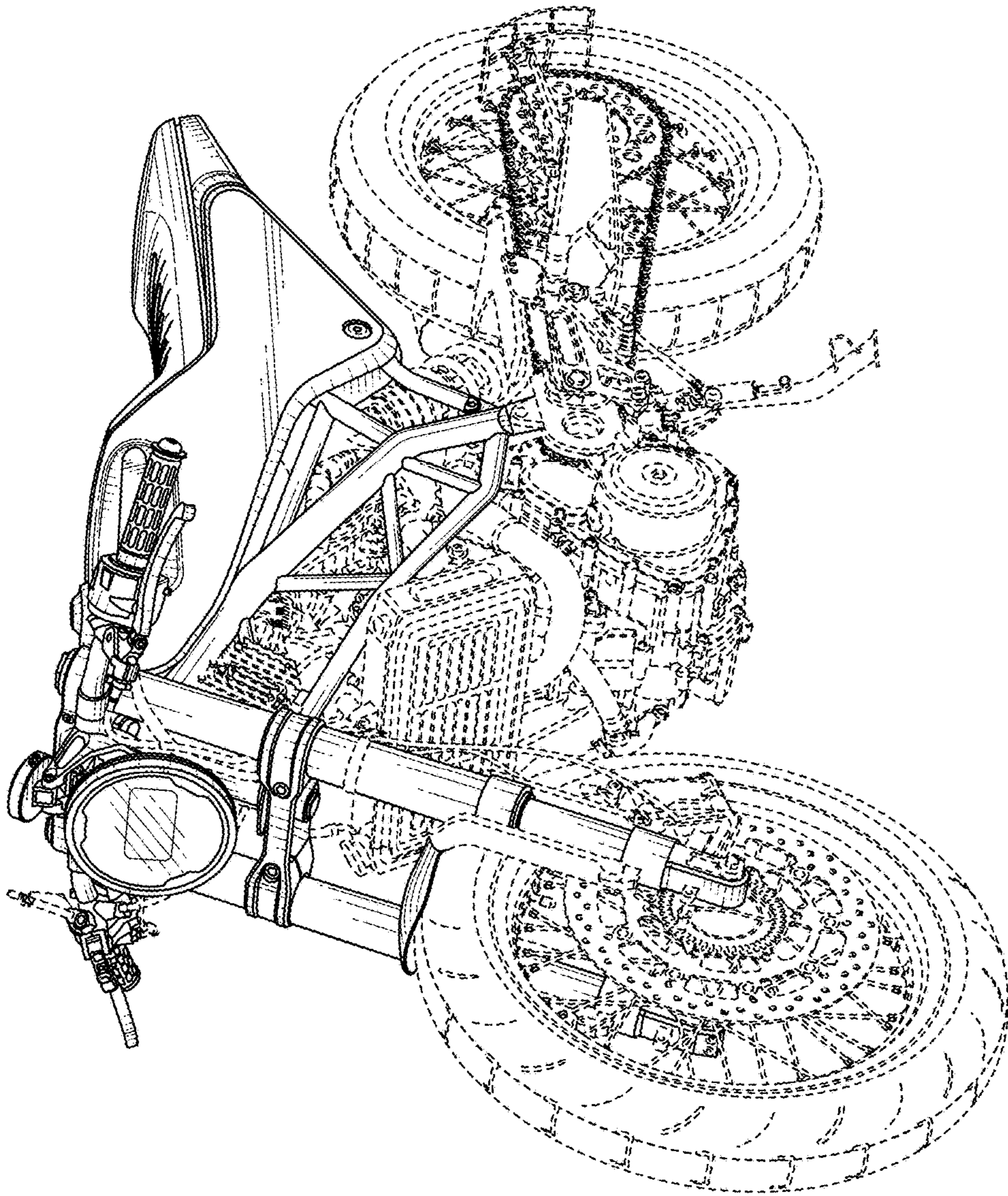

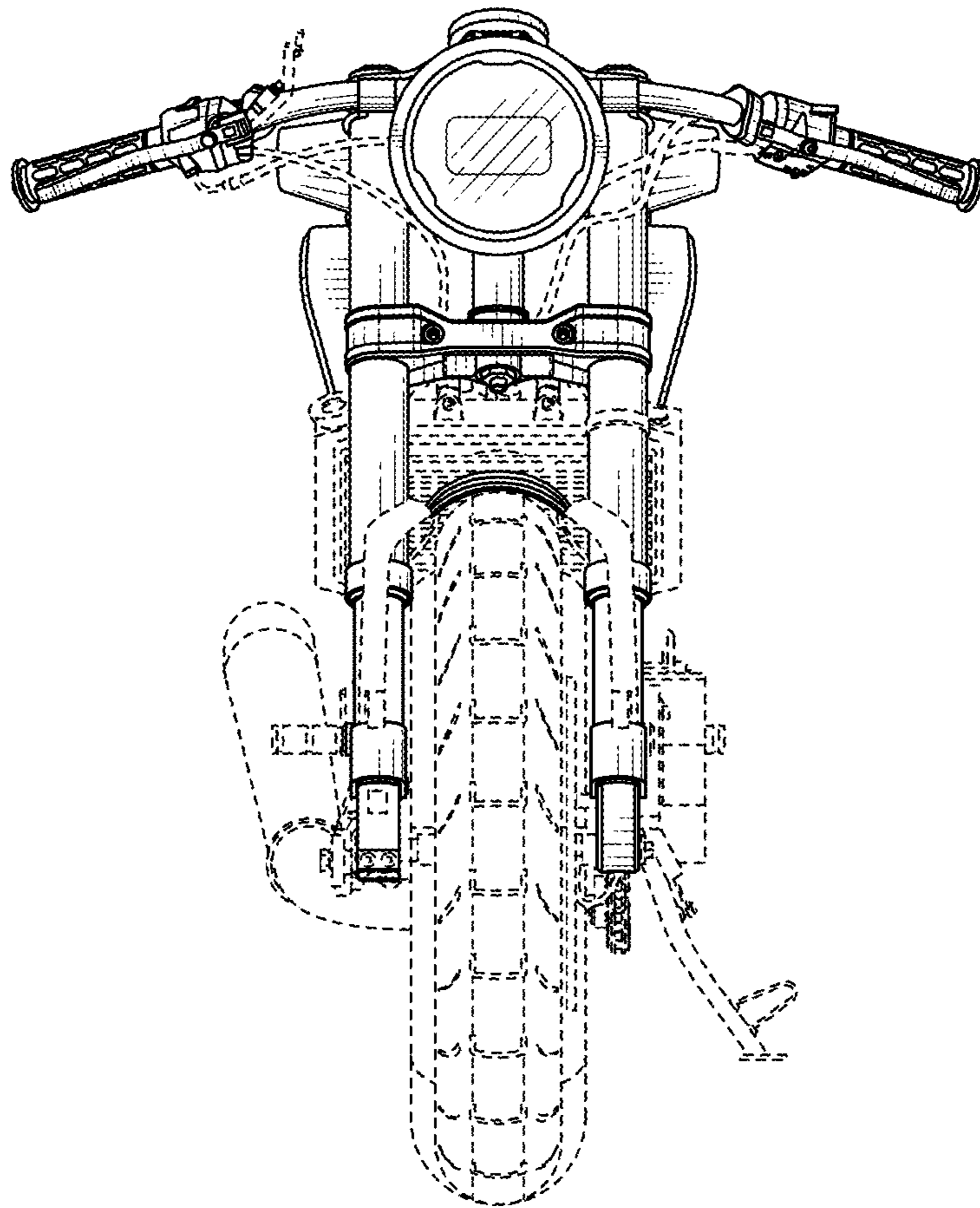

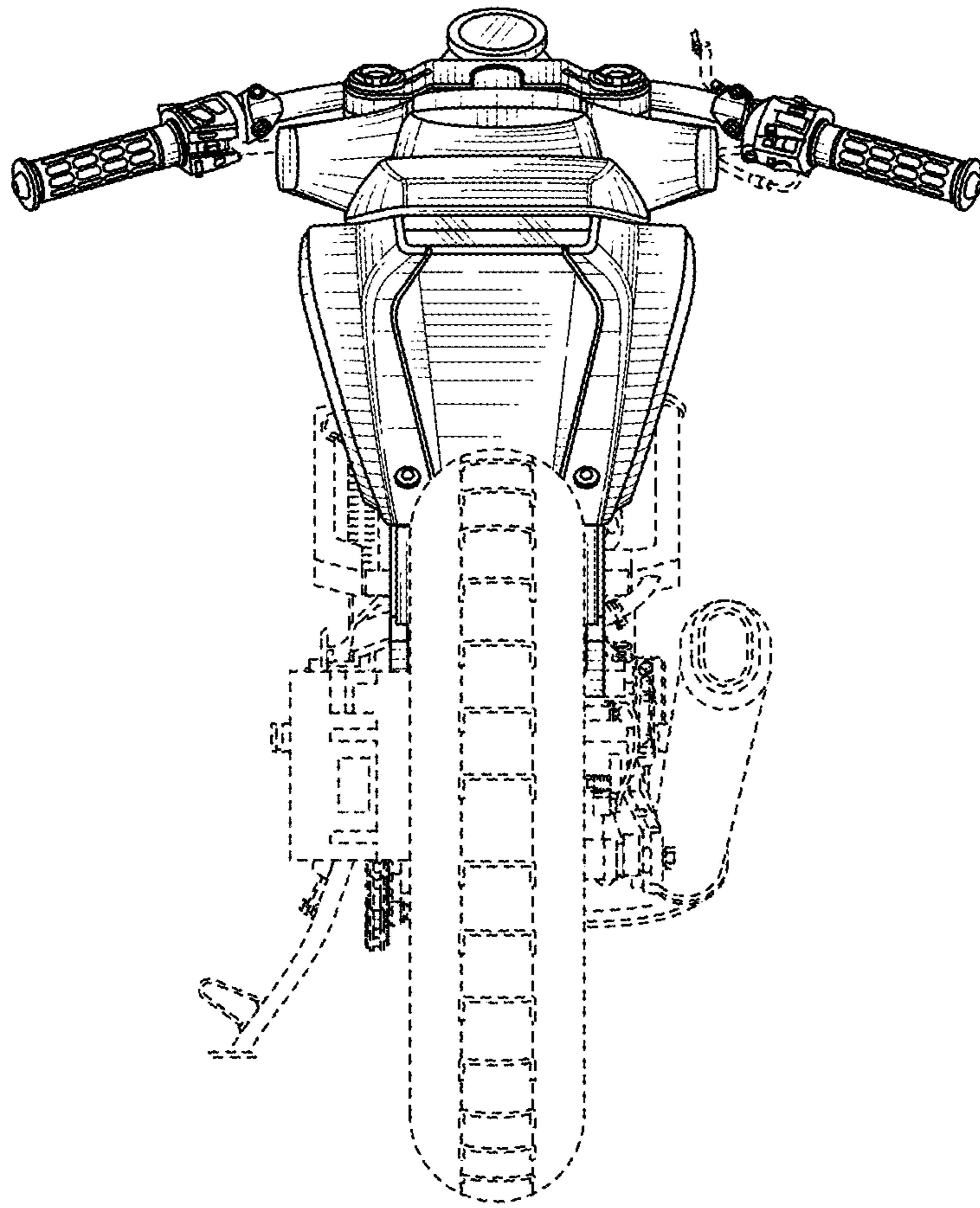

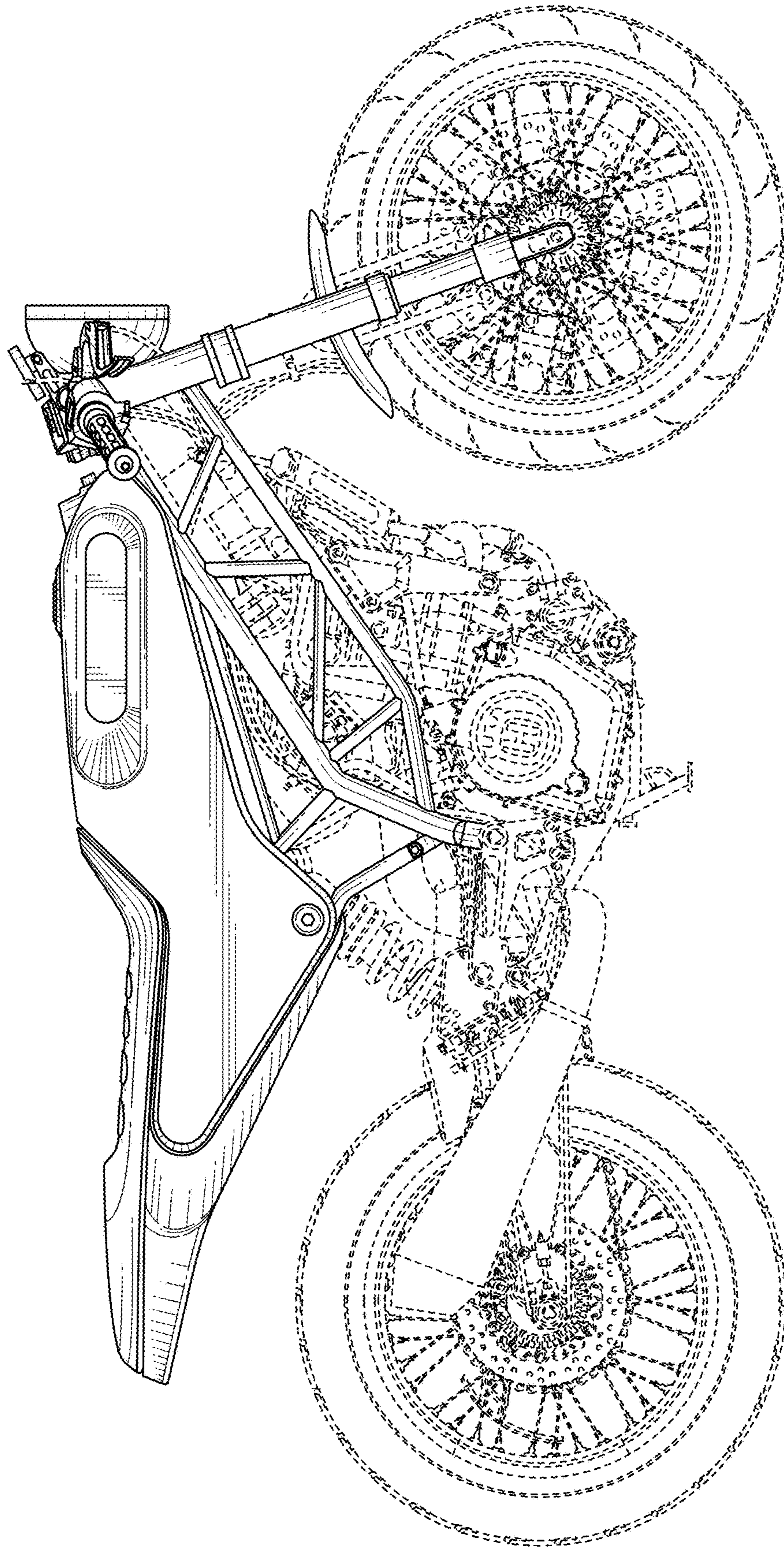

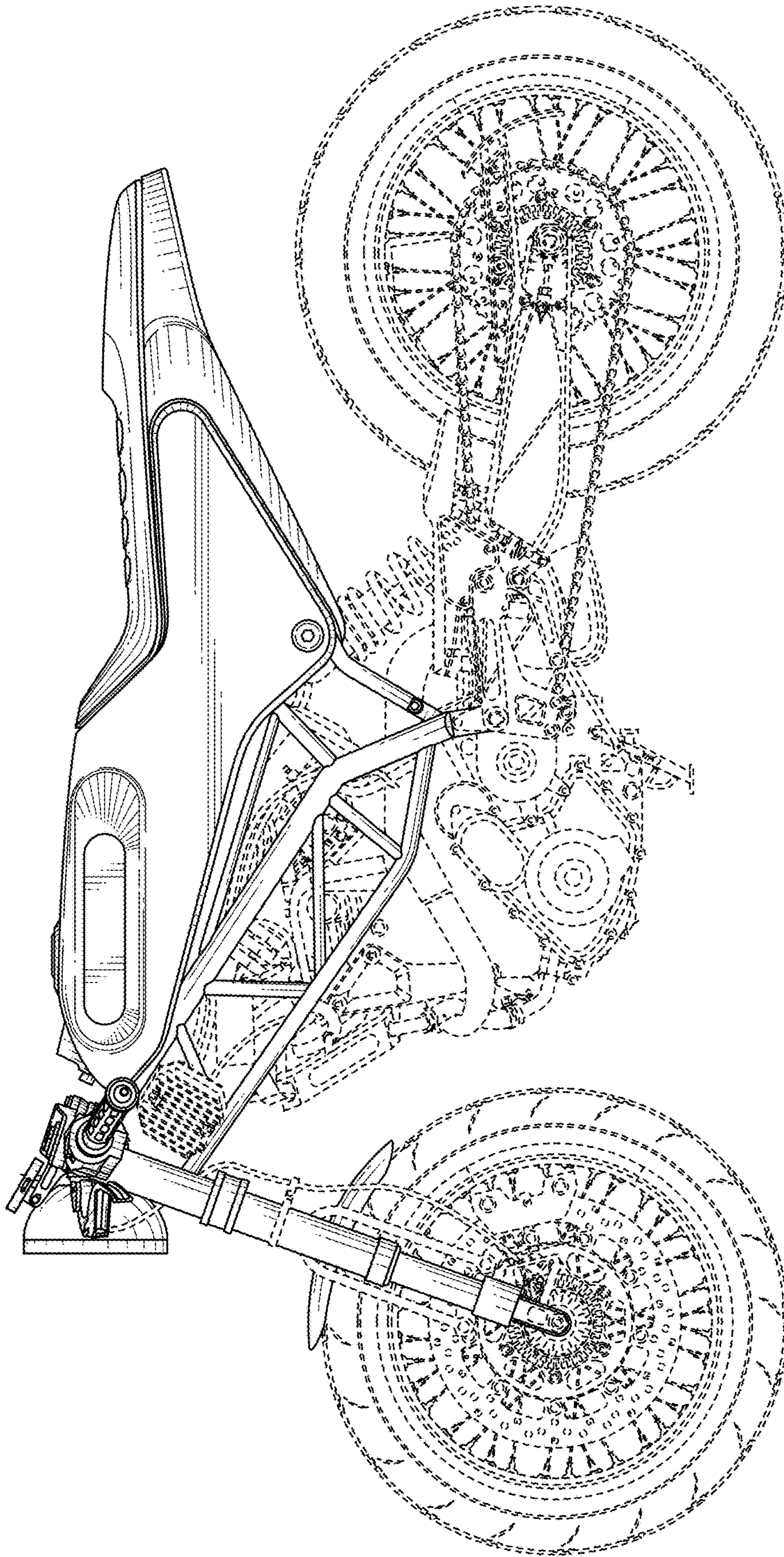

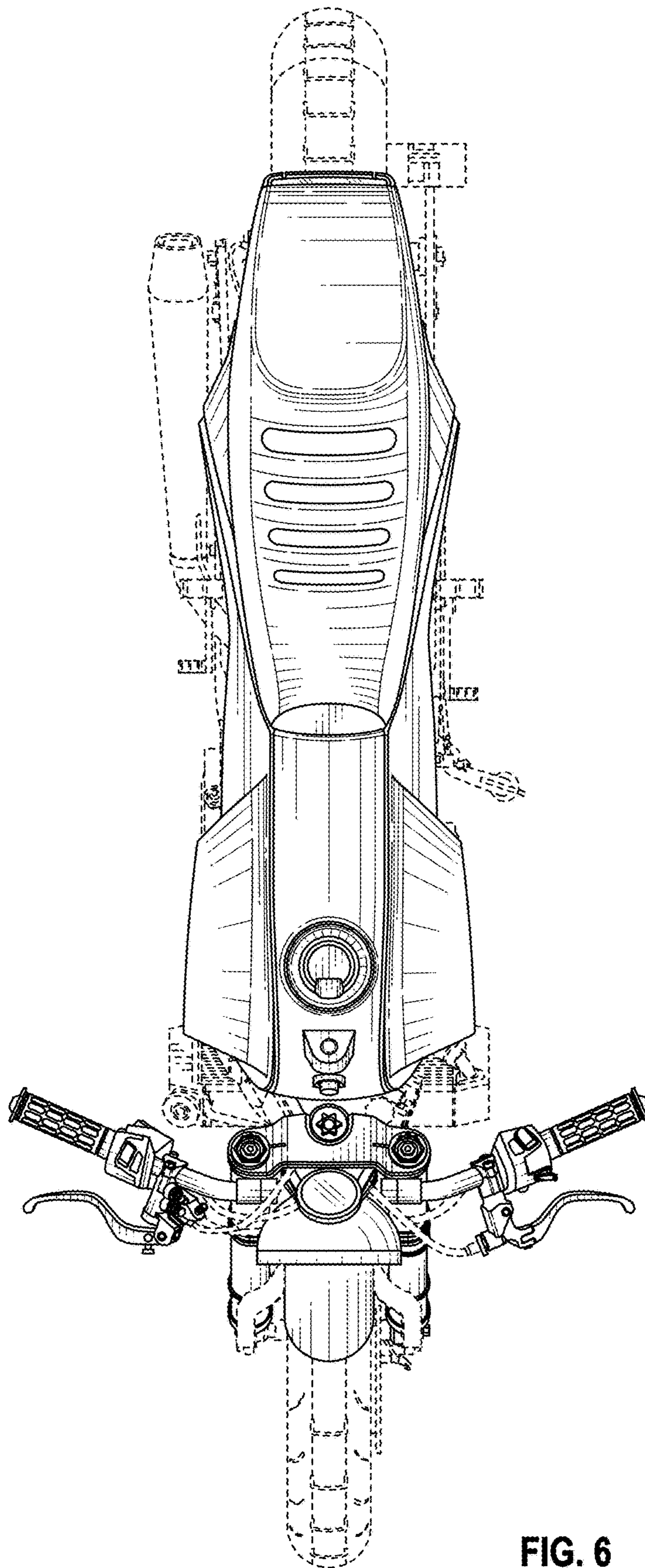

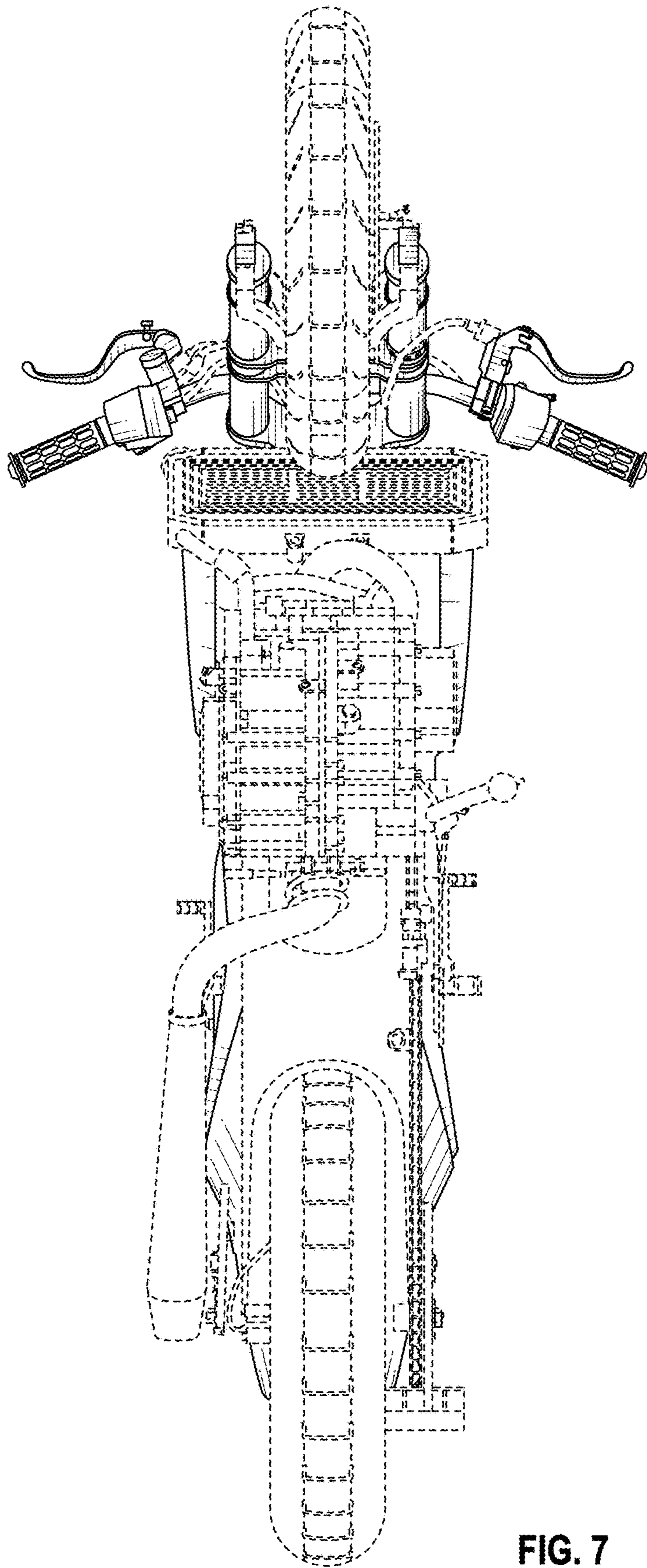

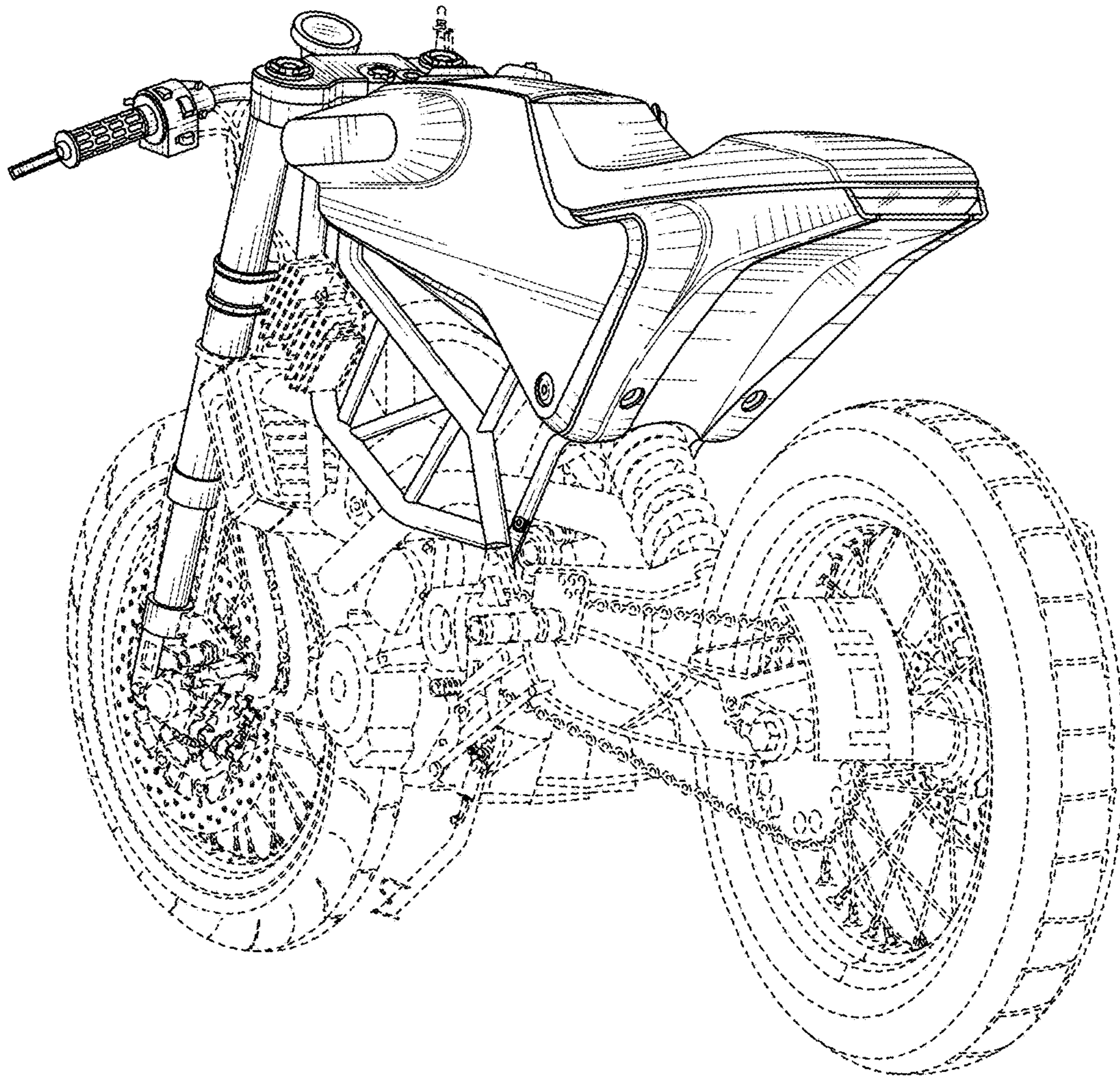

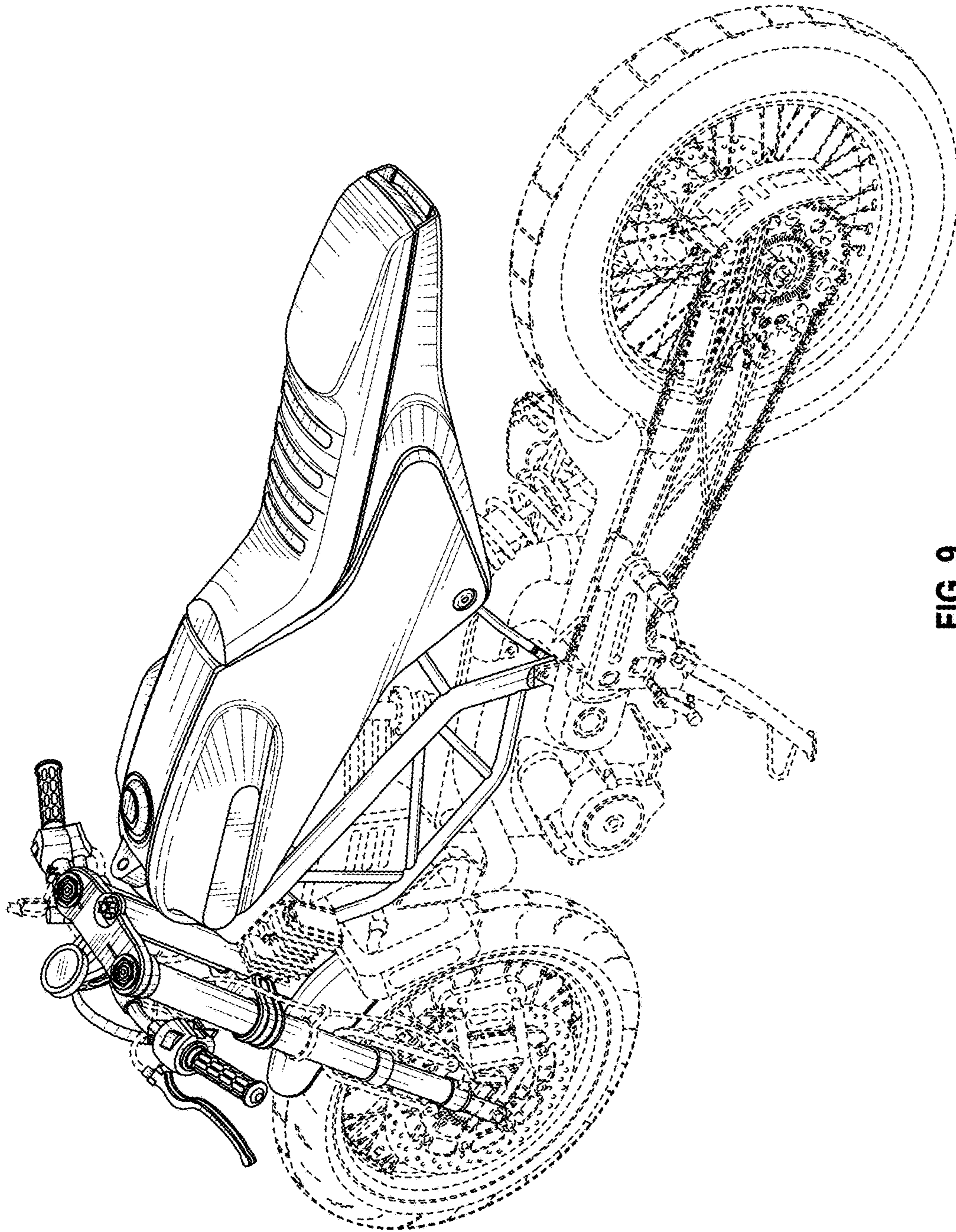
