FIG. 6 is a first perspective view thereof;

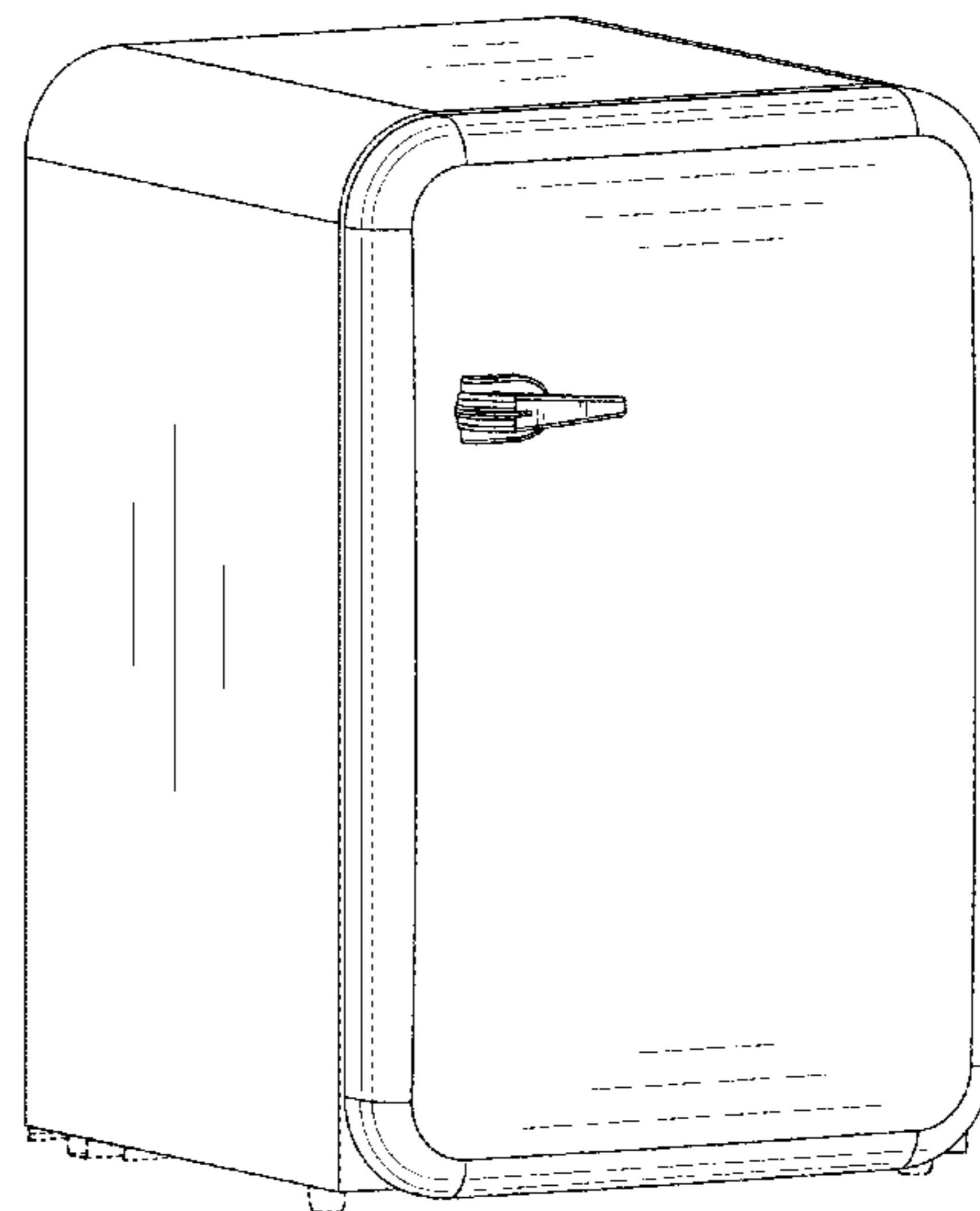
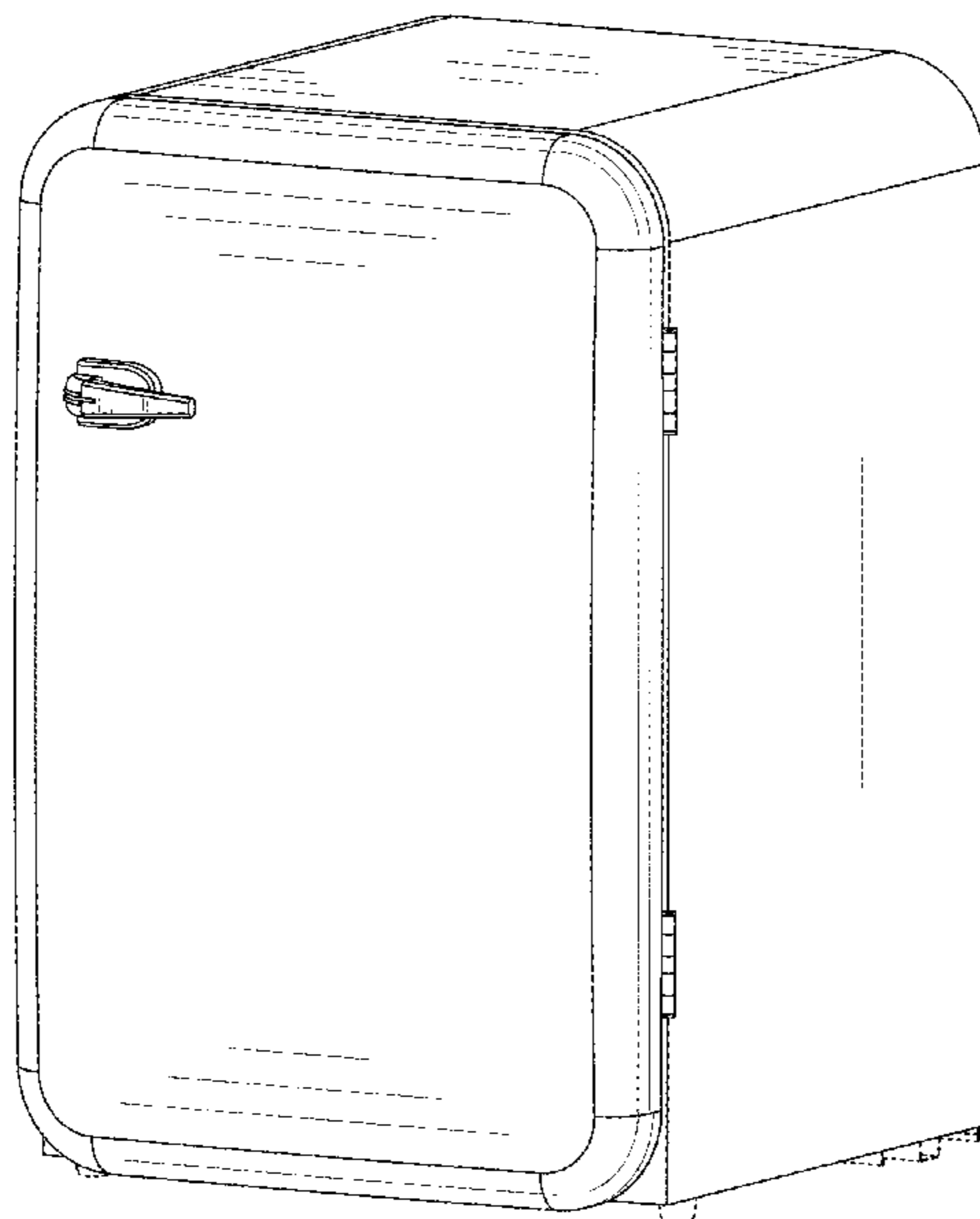
FIG. 7 is a second perspective view thereof;

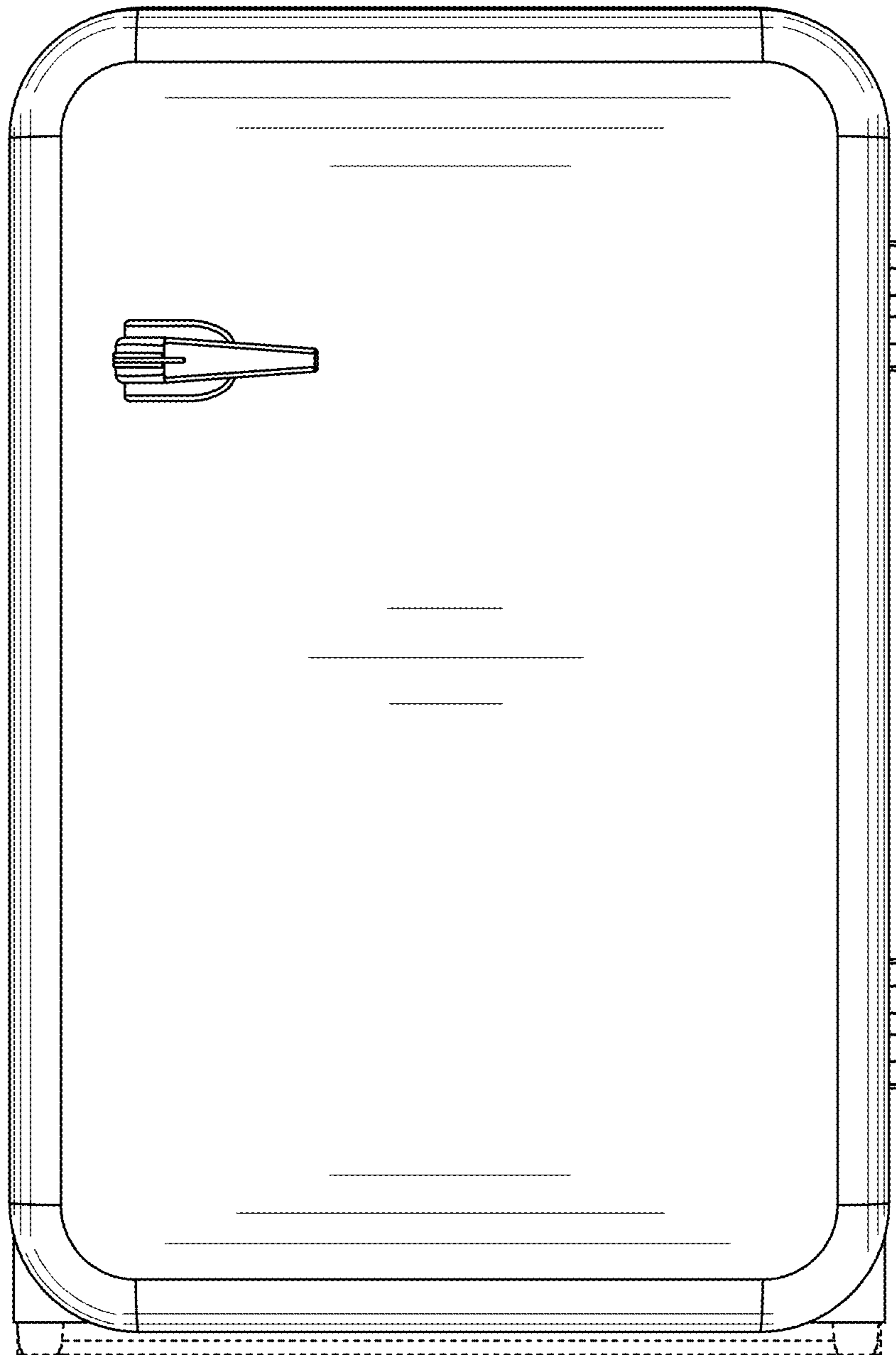

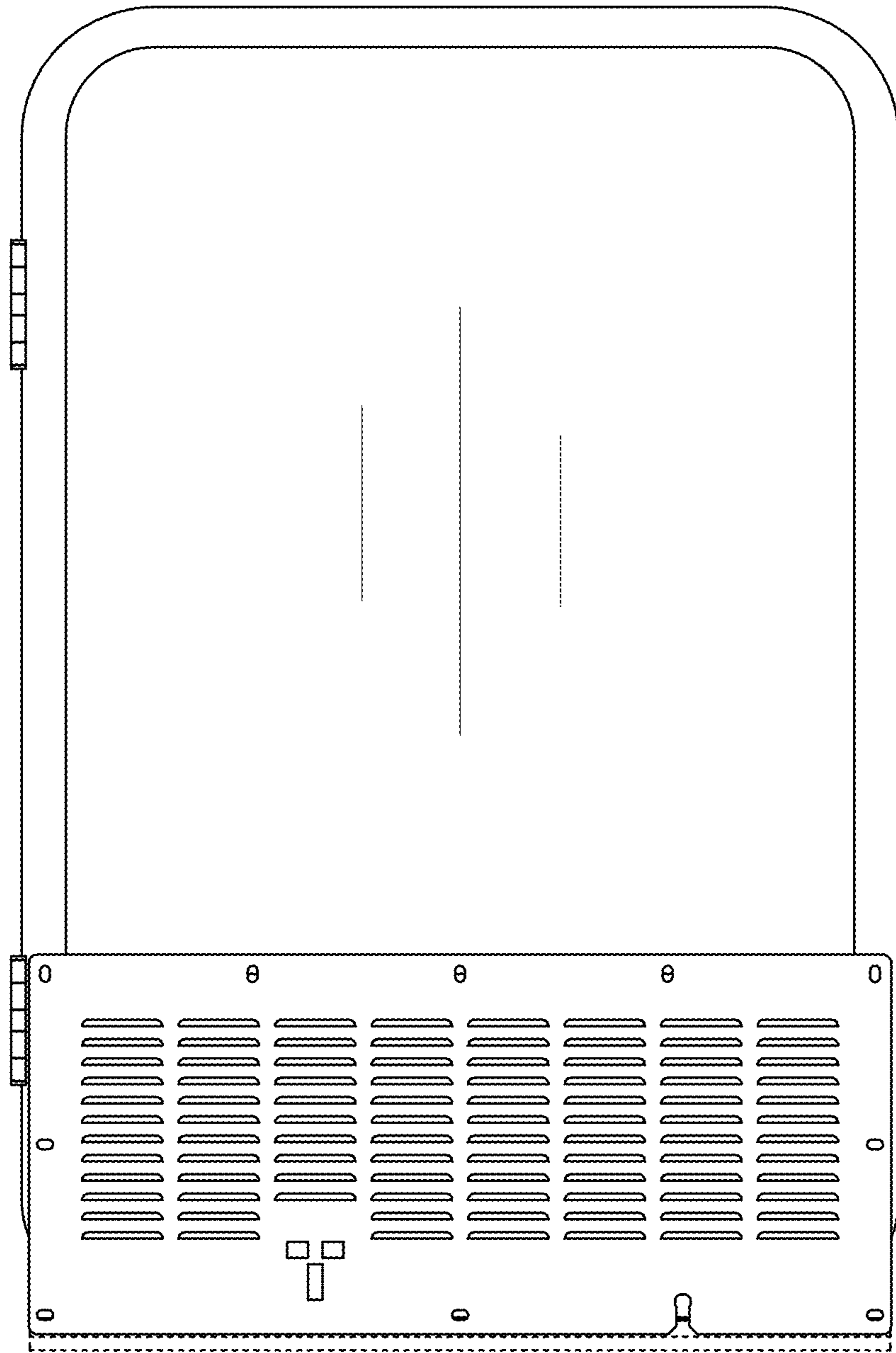

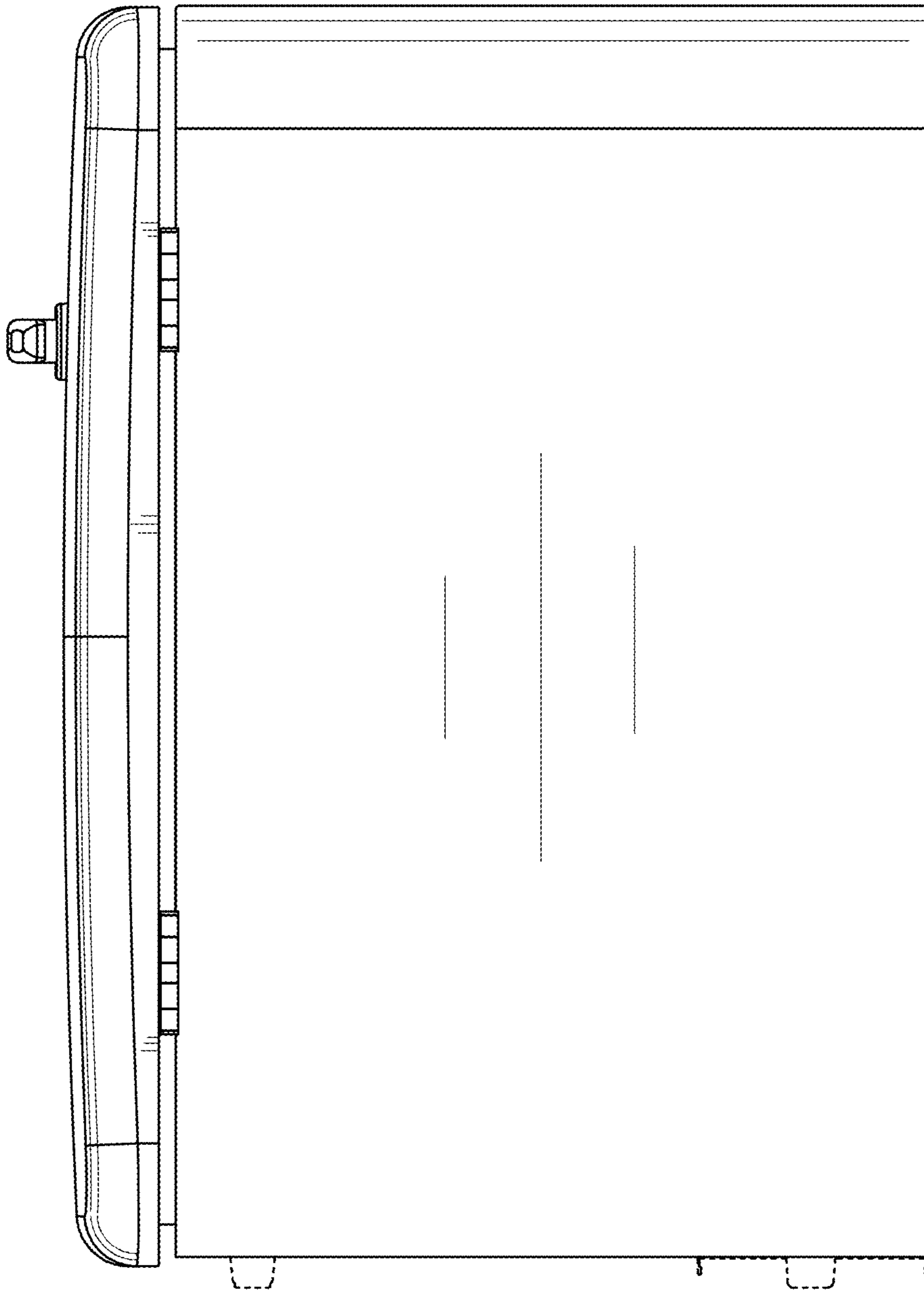

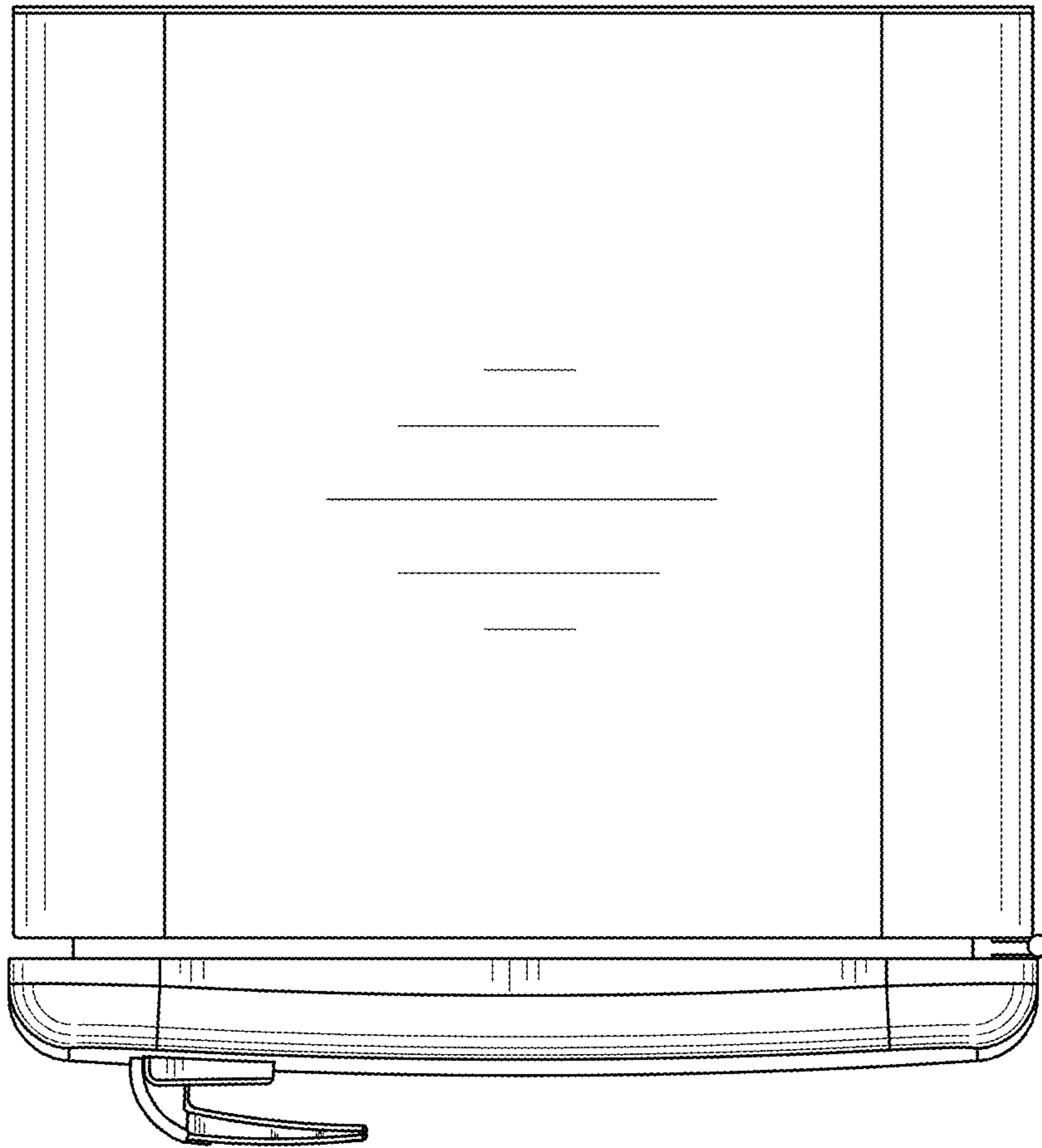

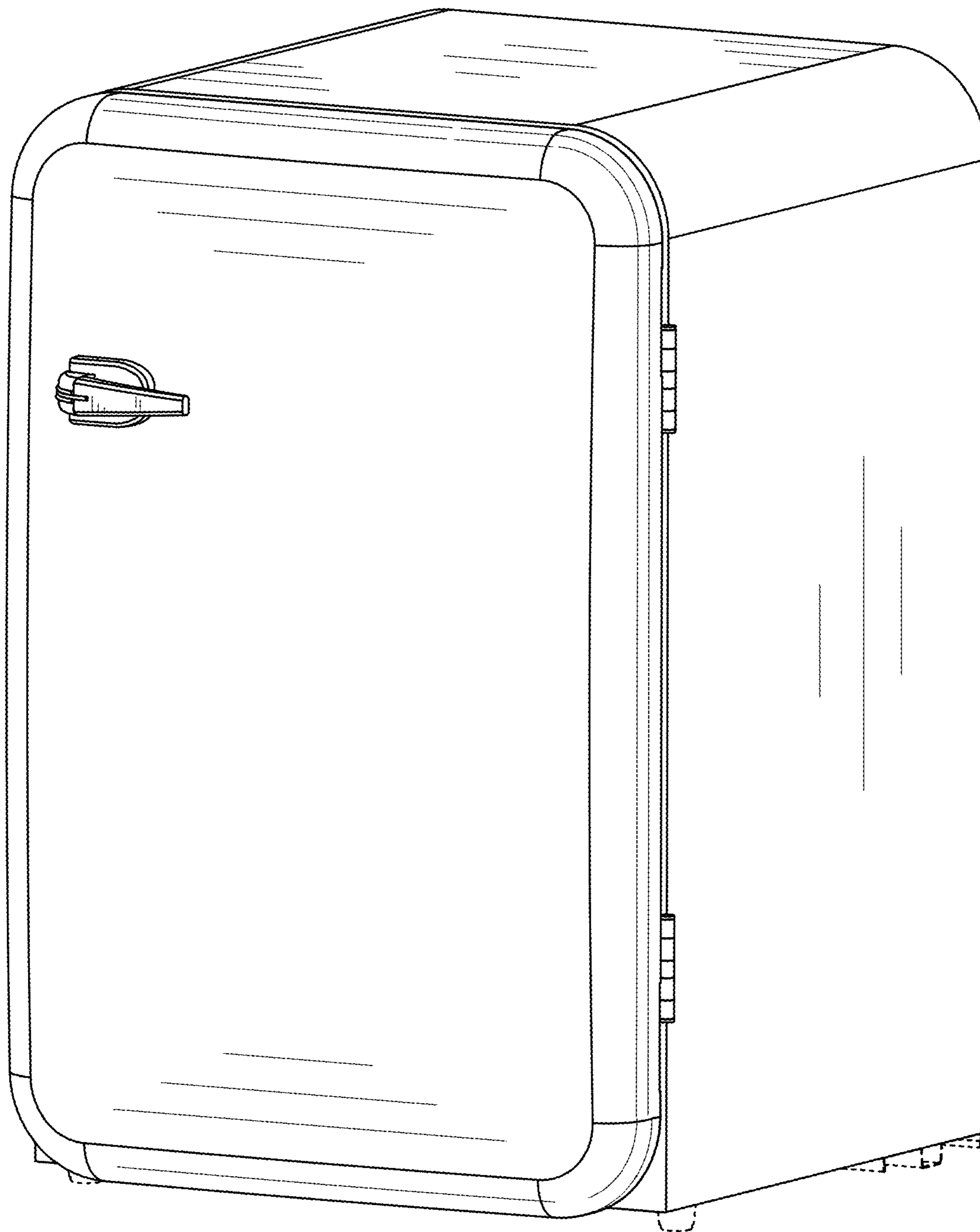

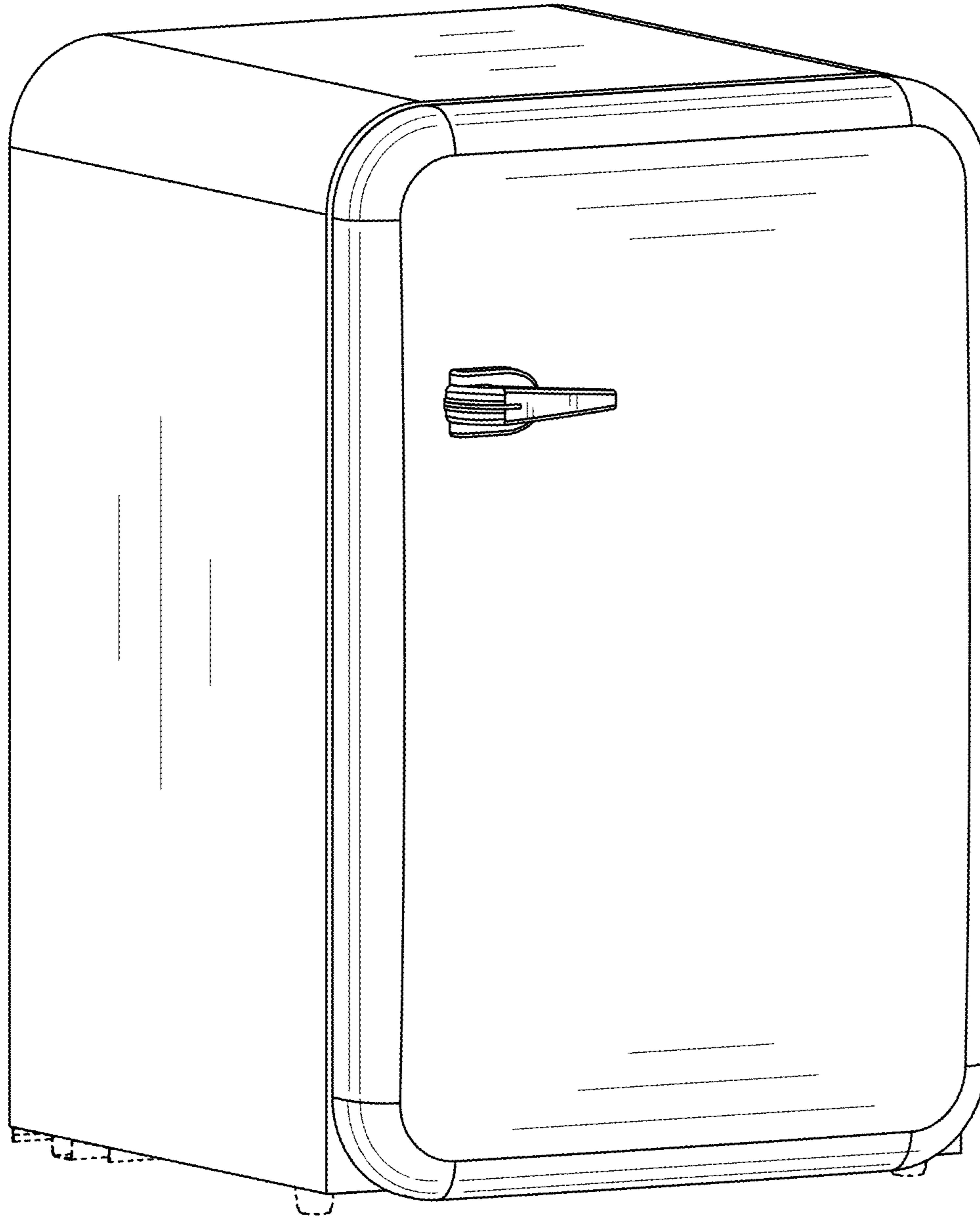

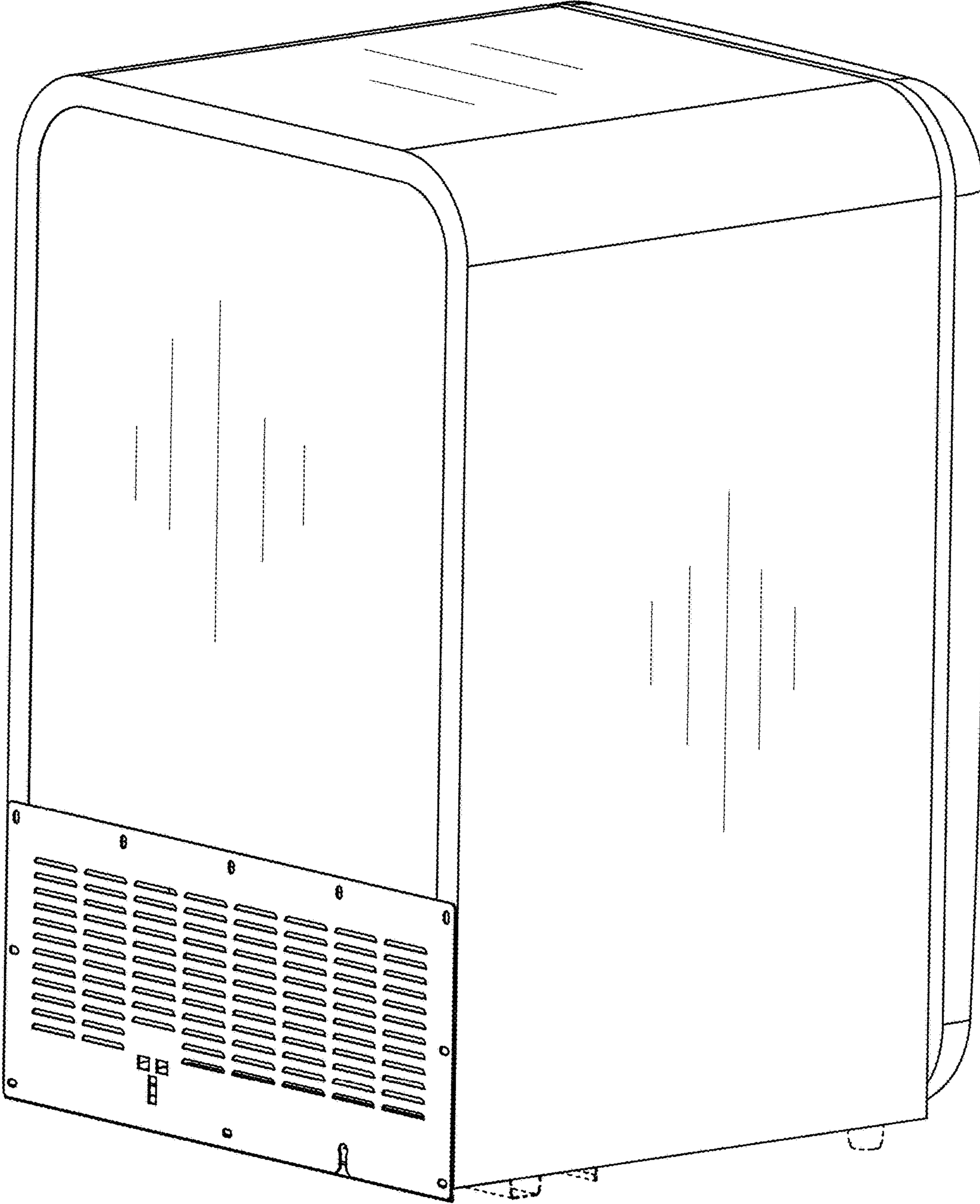

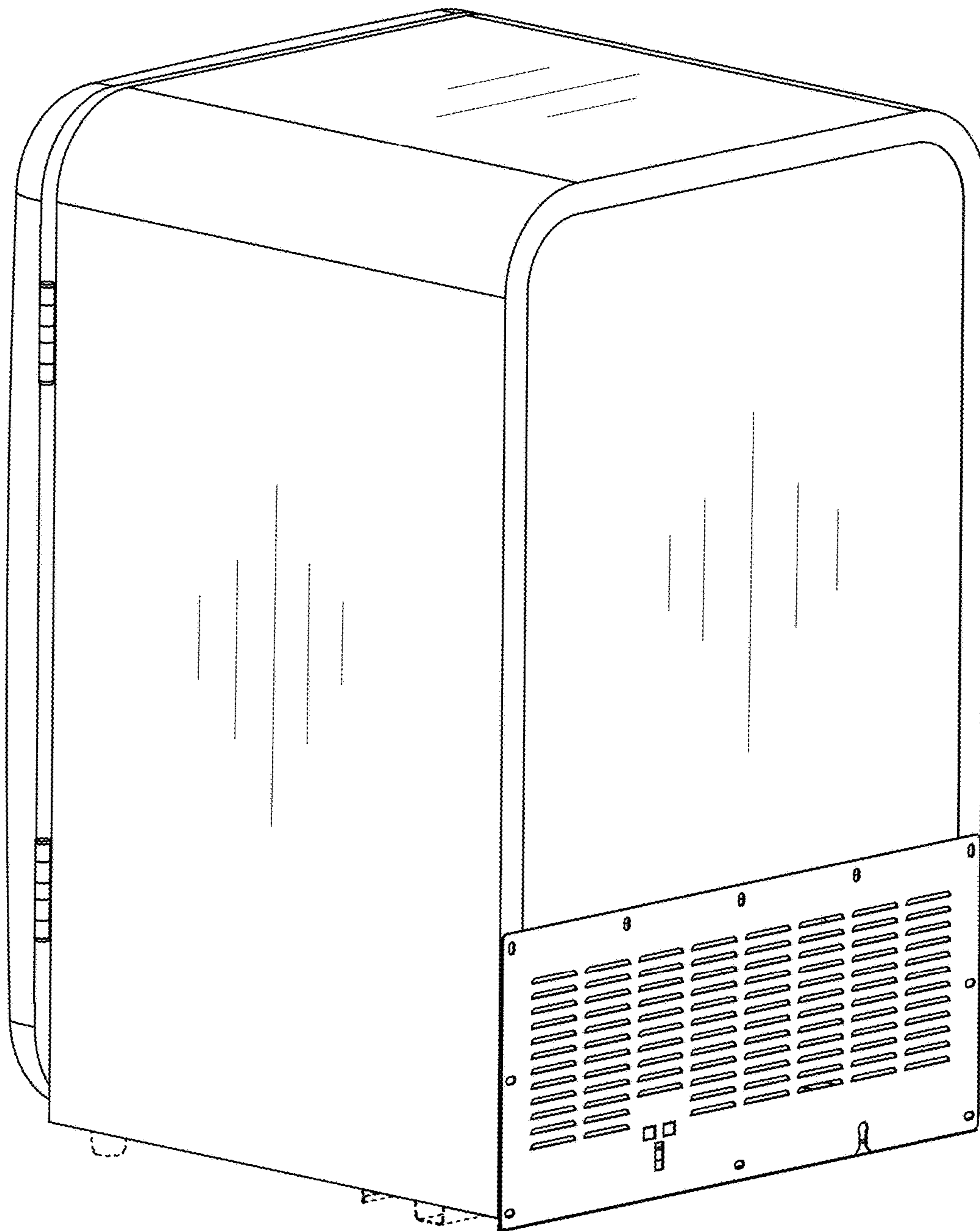
