(57) **CLAIM**

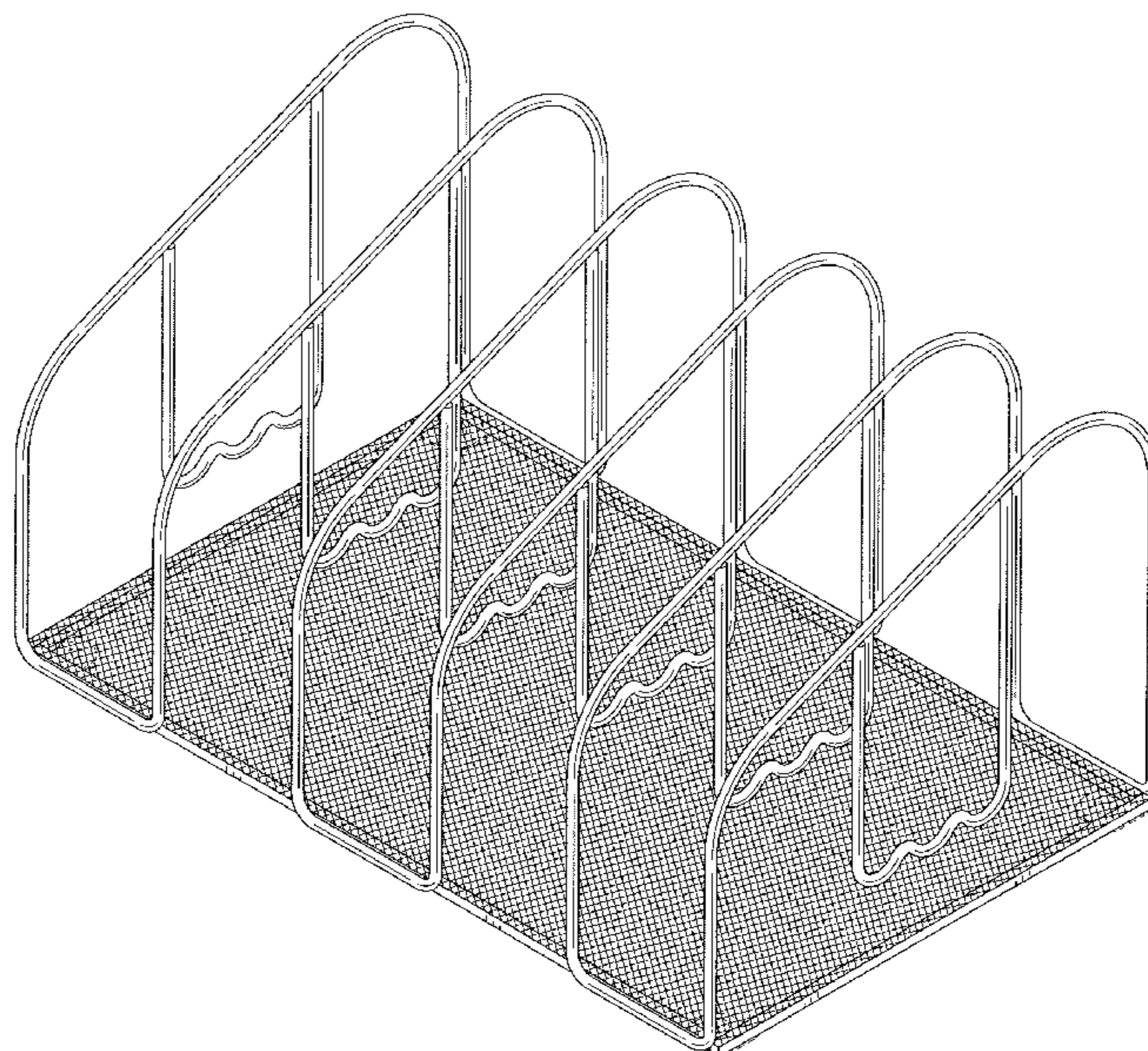
The ornamental design for a folder rack, as shown and described.

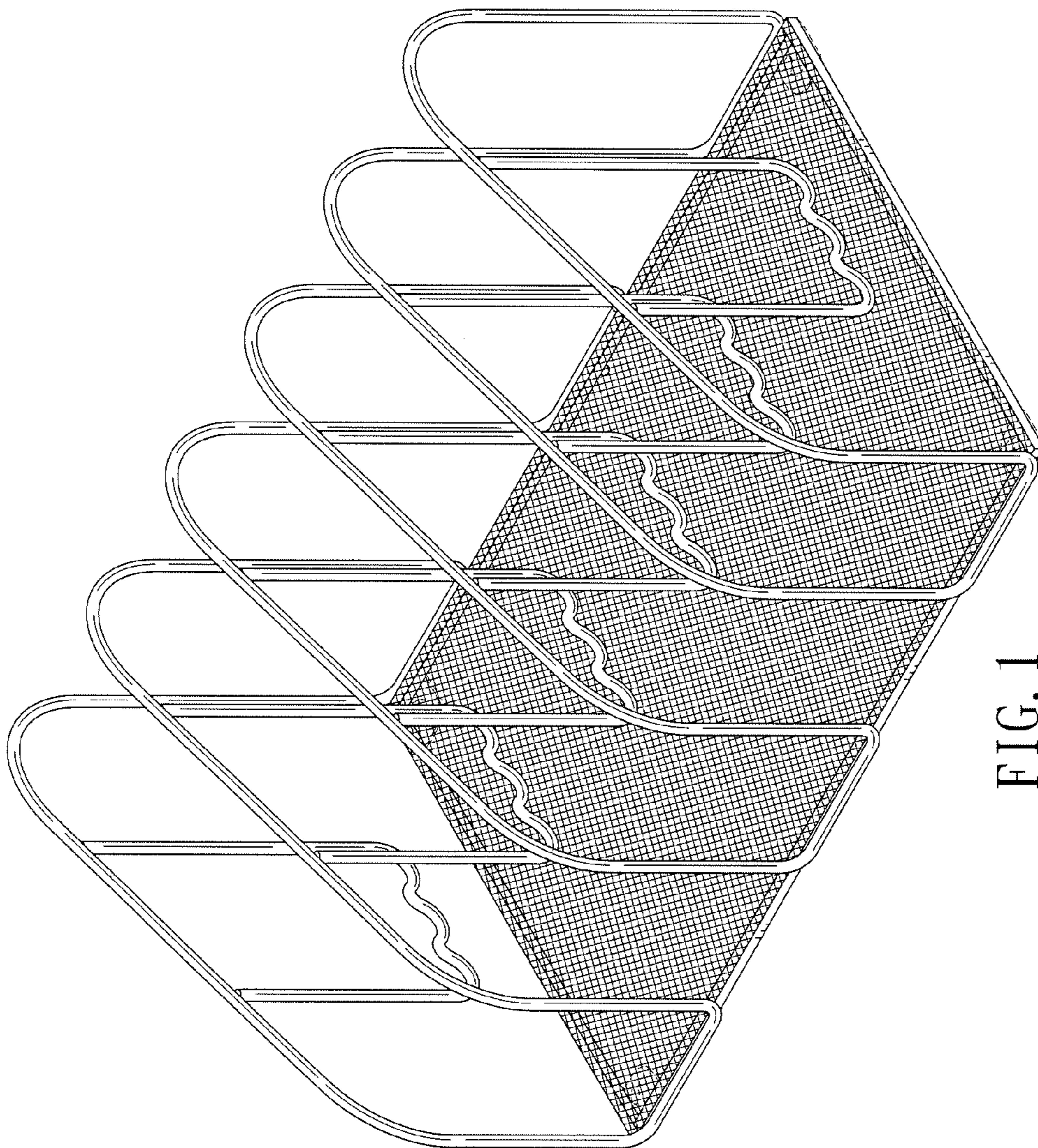

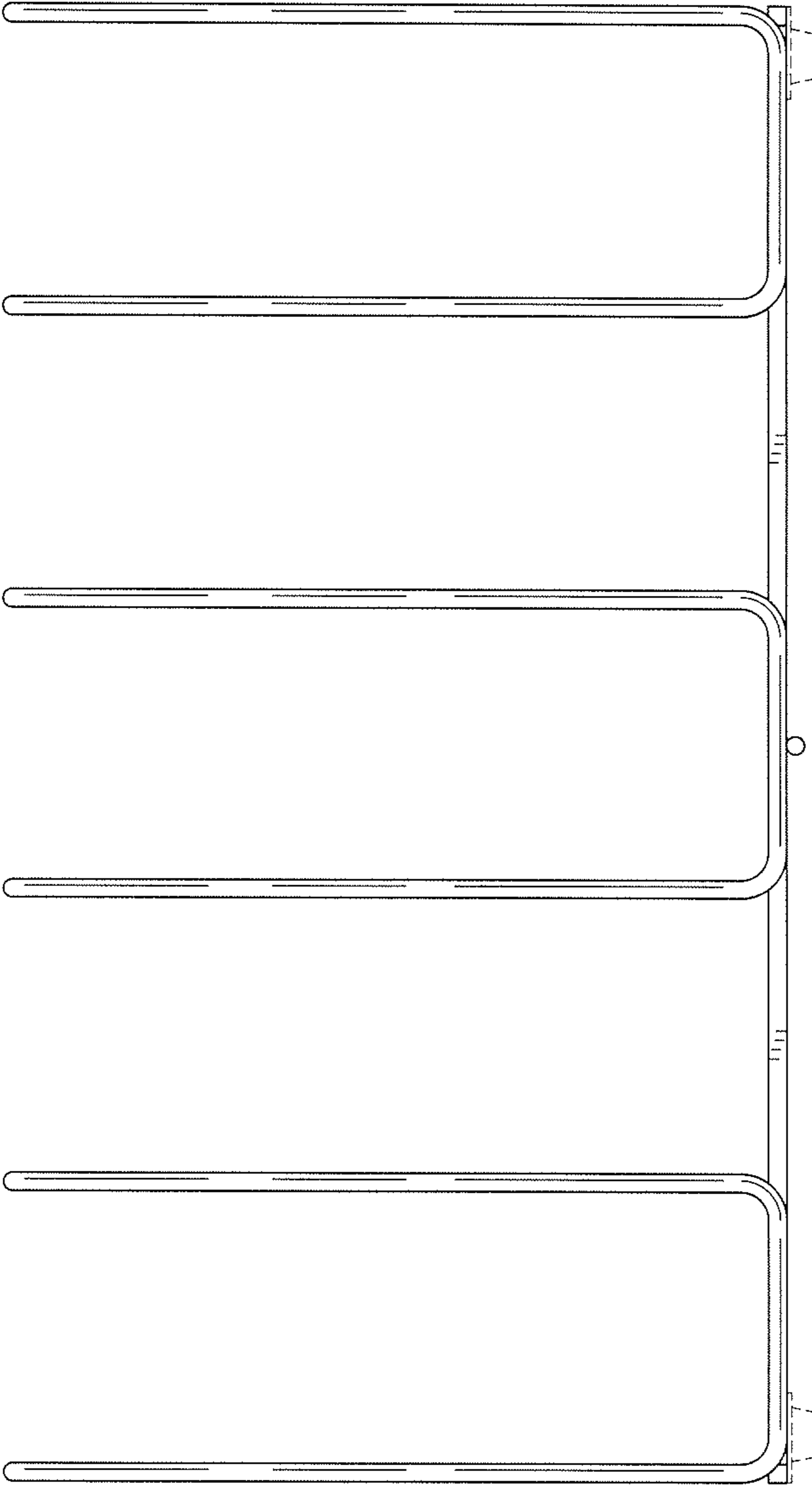

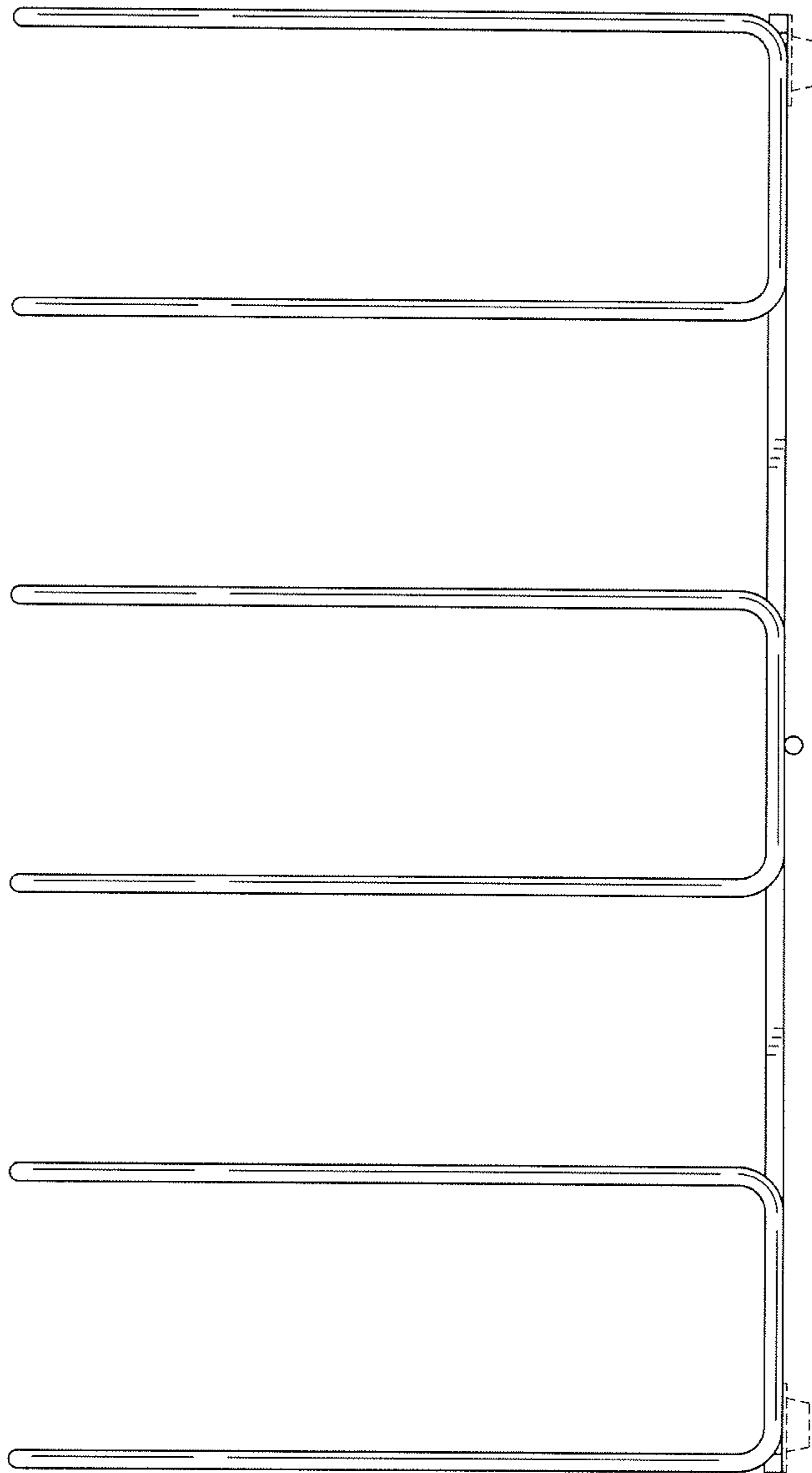

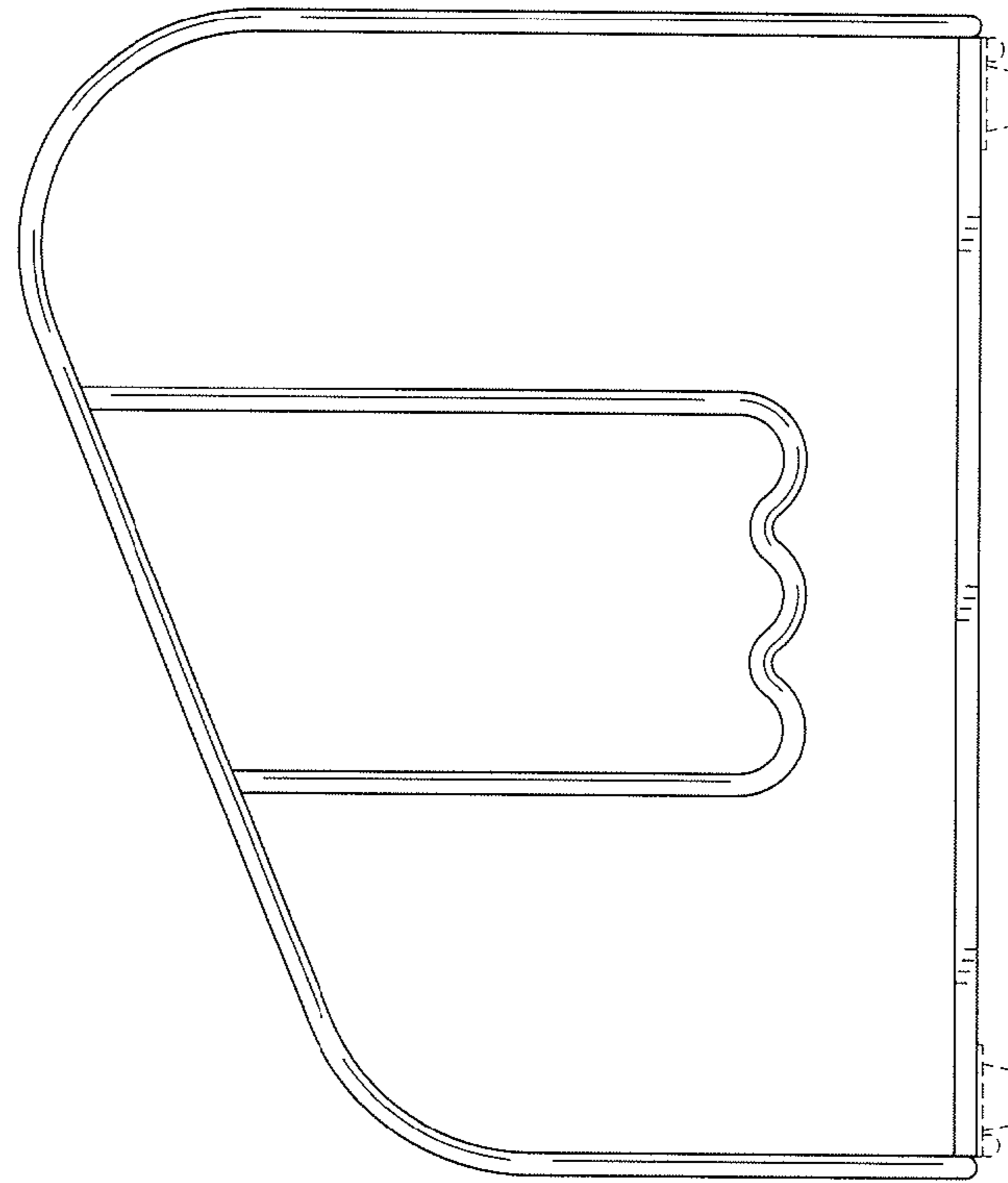

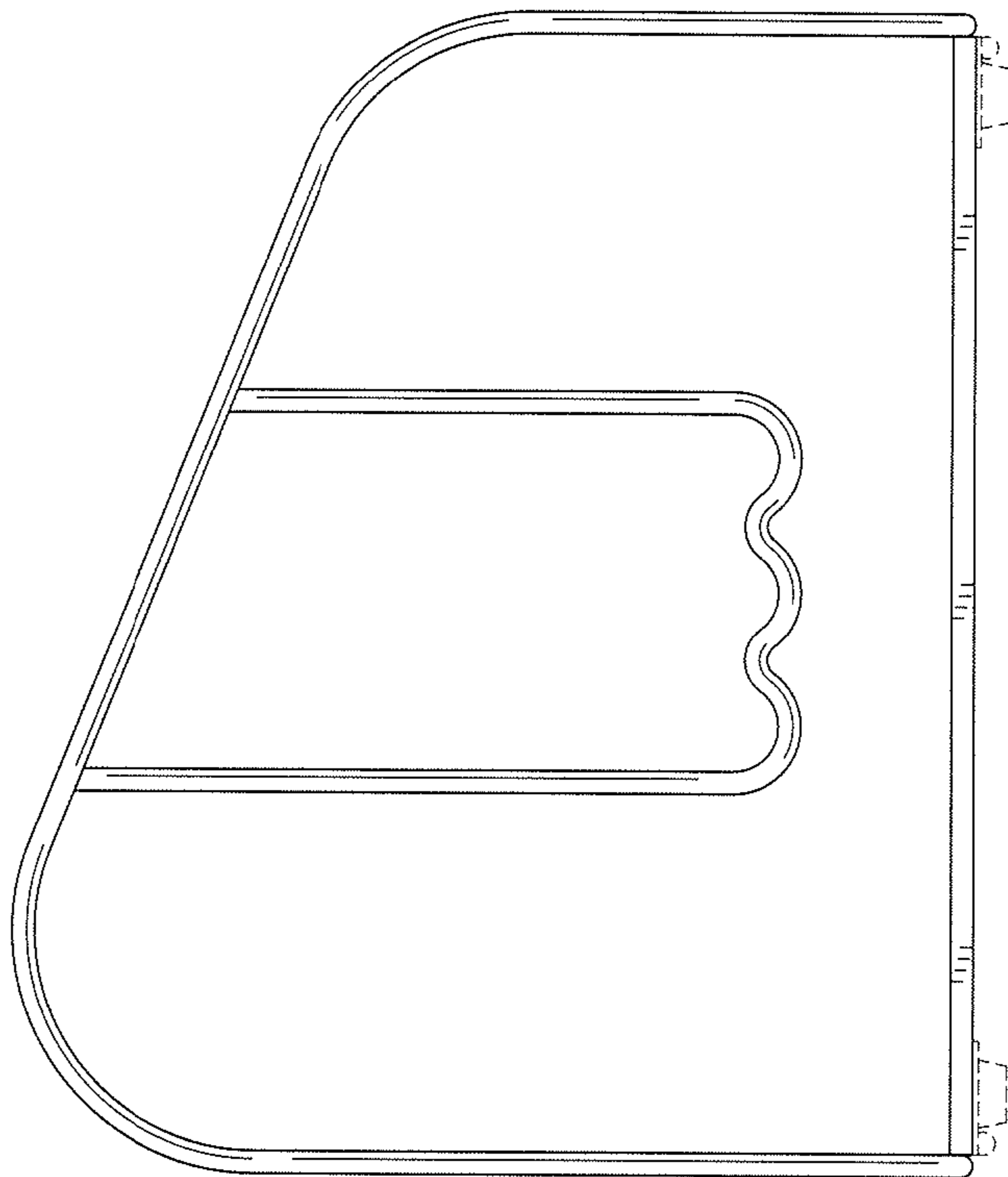

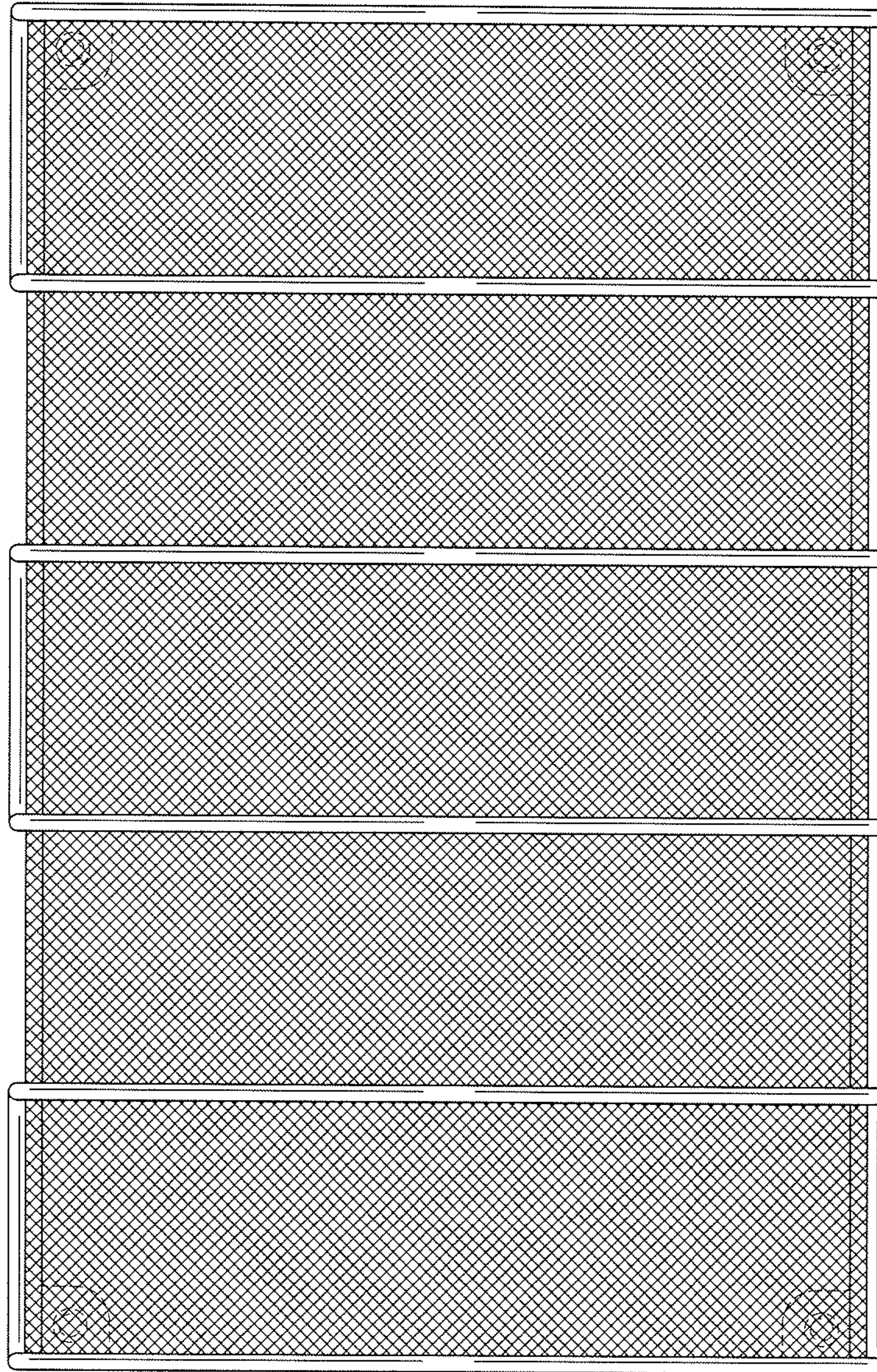

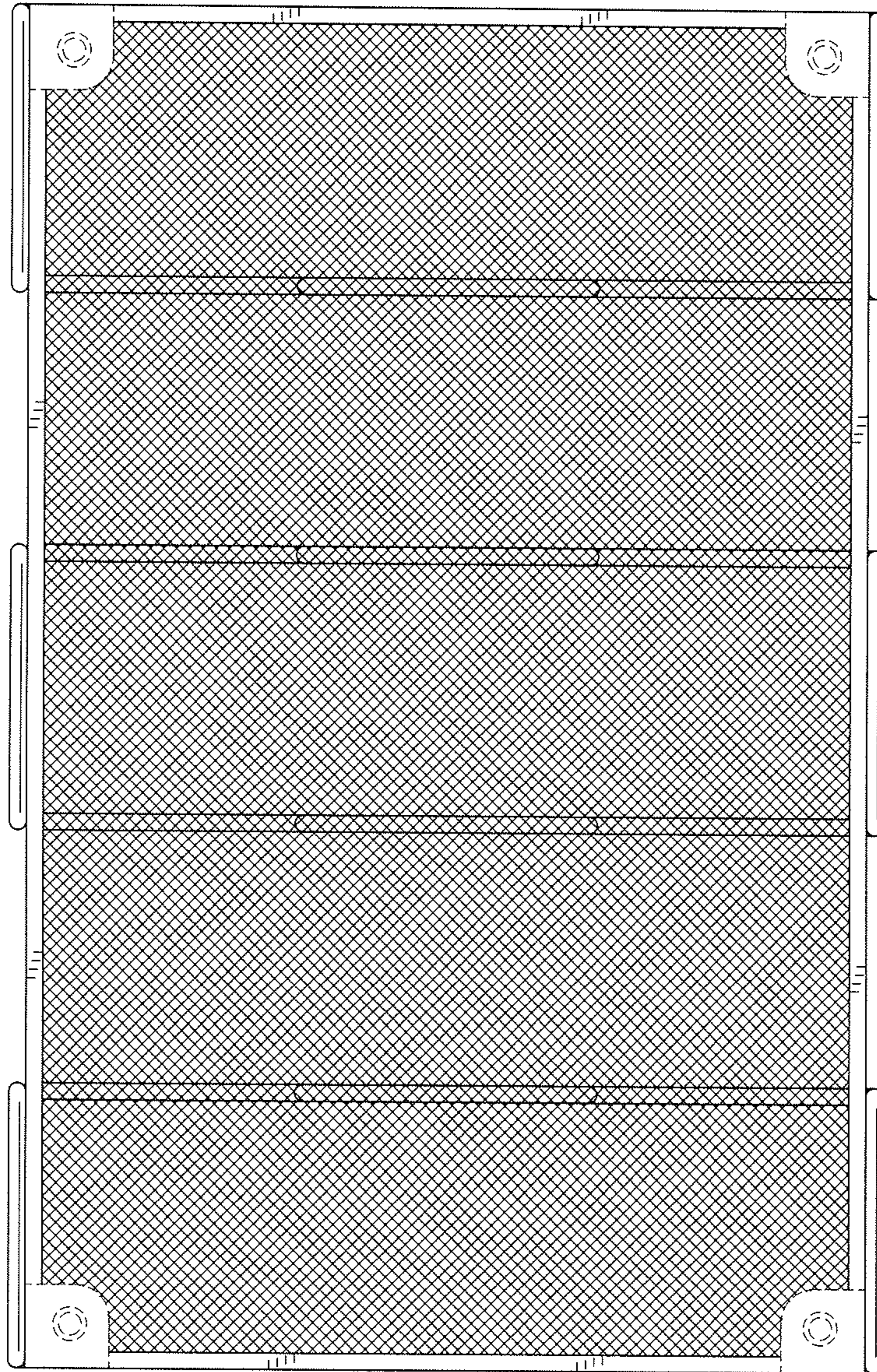
