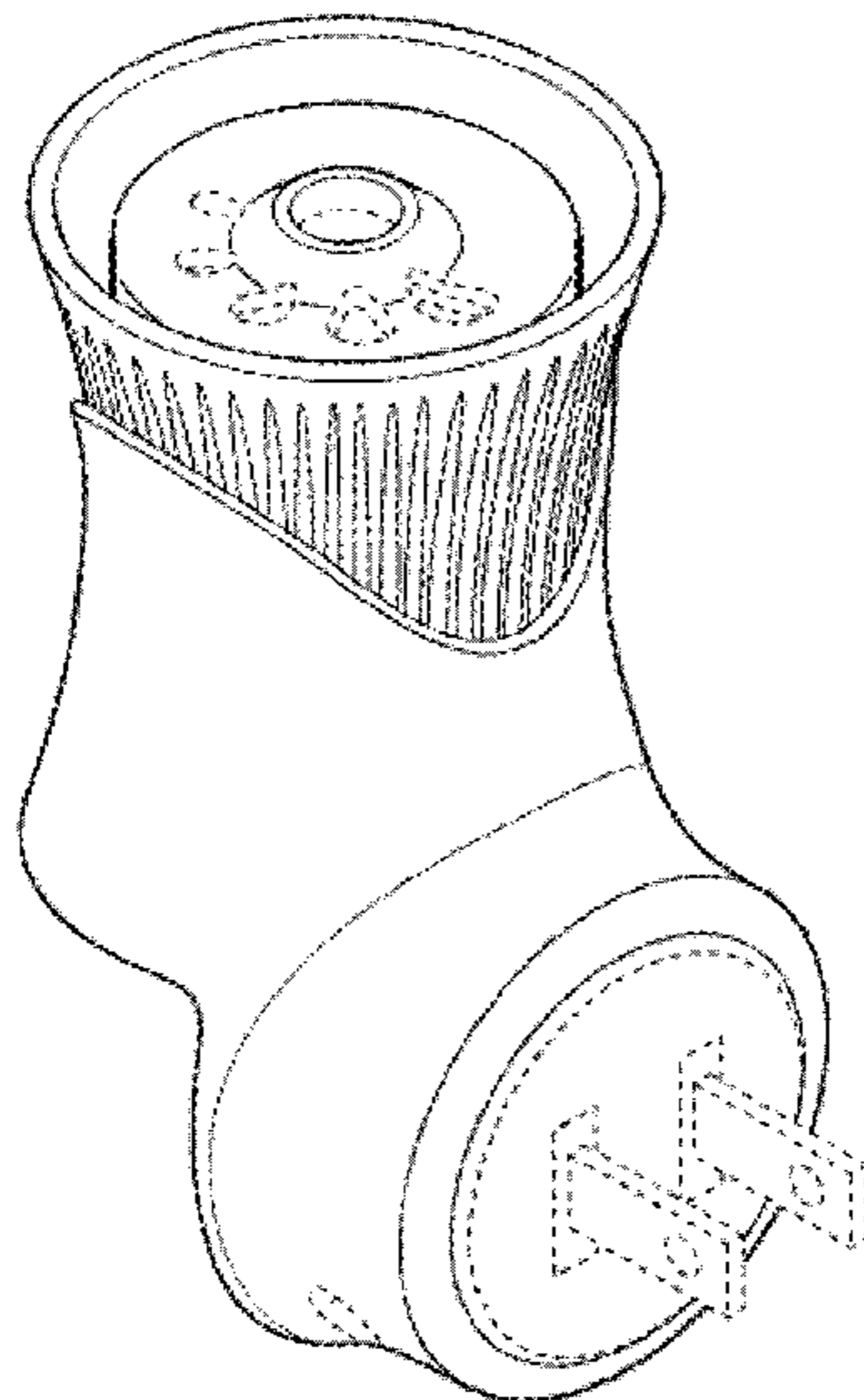
FIG. 1 is a perspective view of front the volatile substance dispenser;

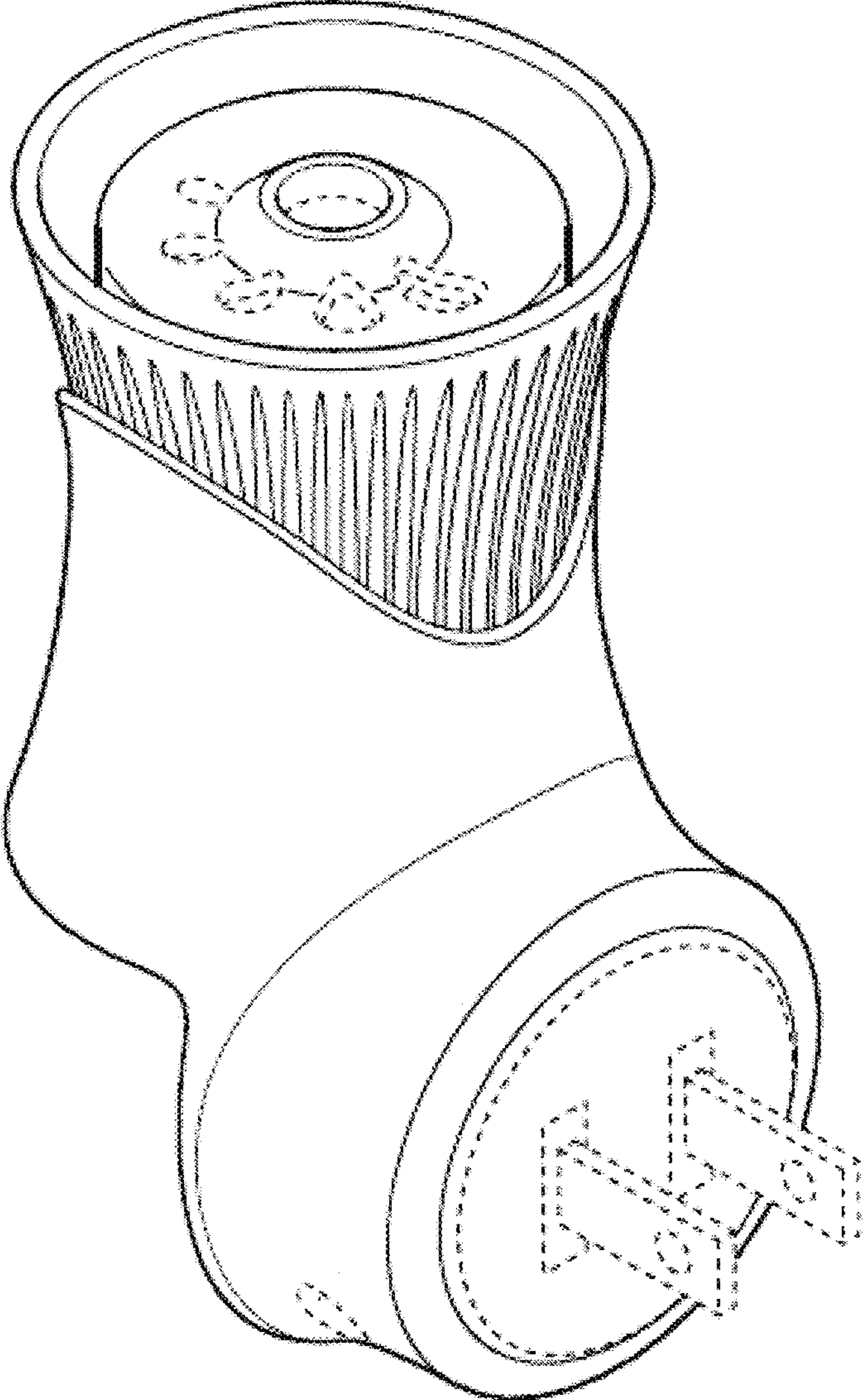
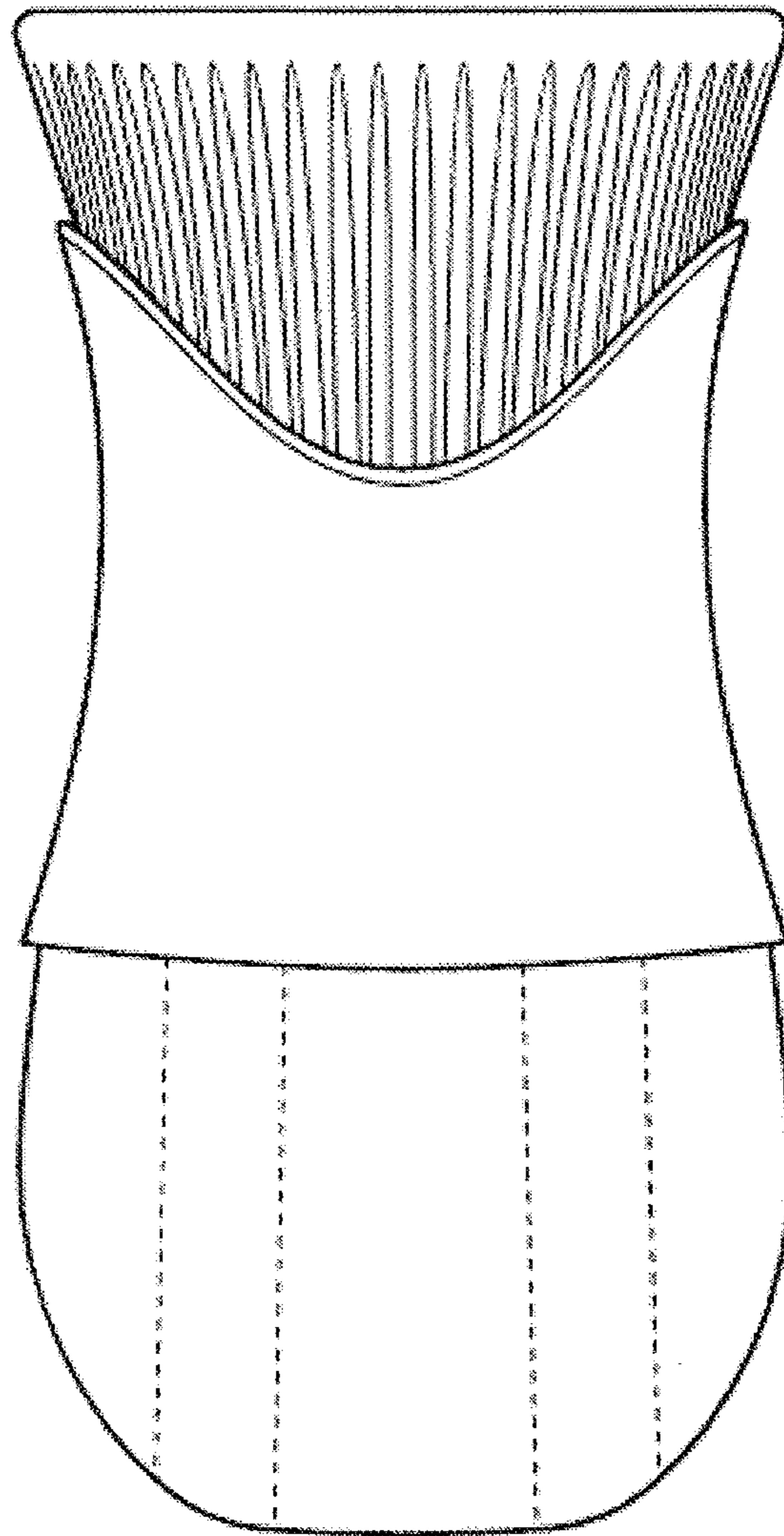
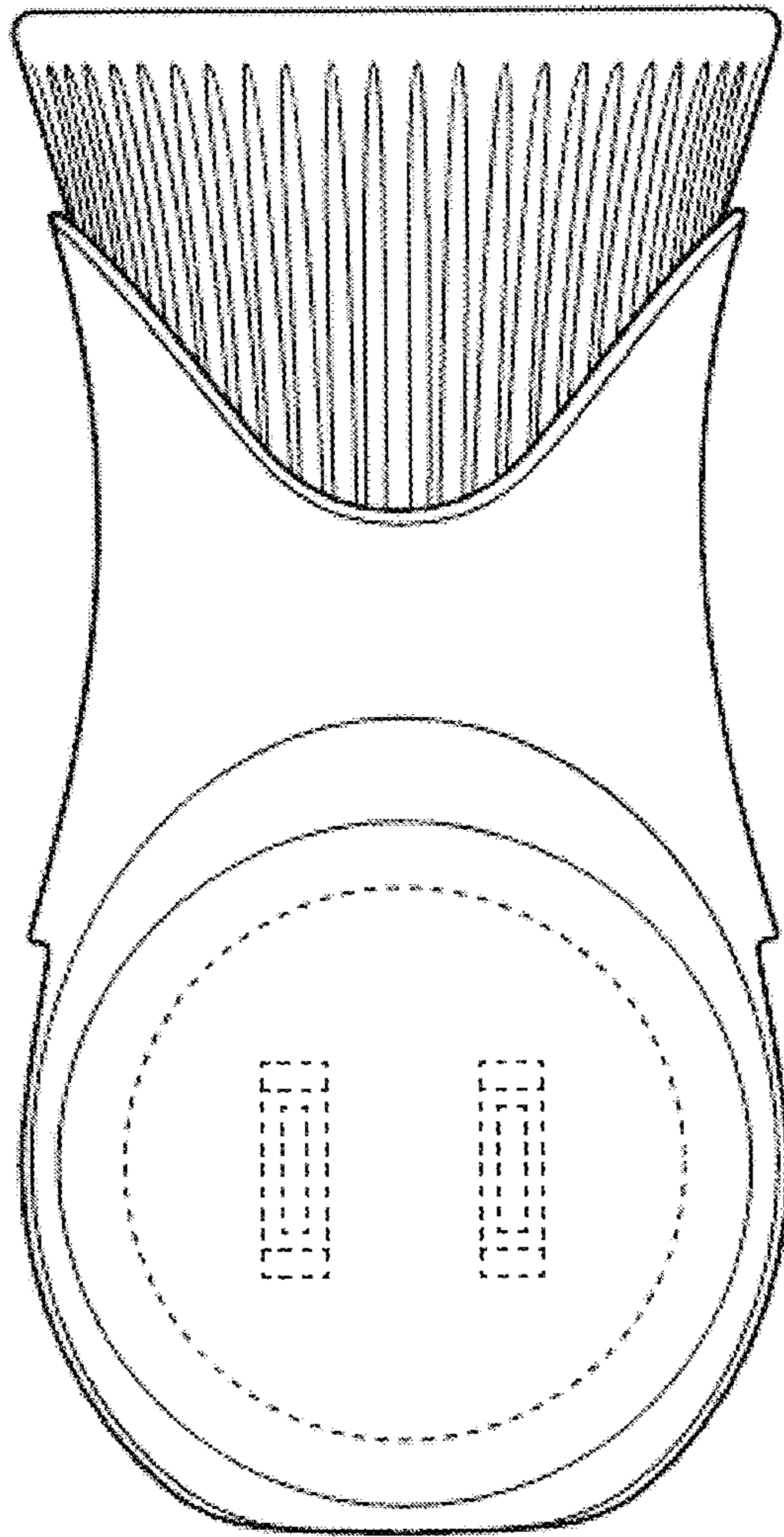

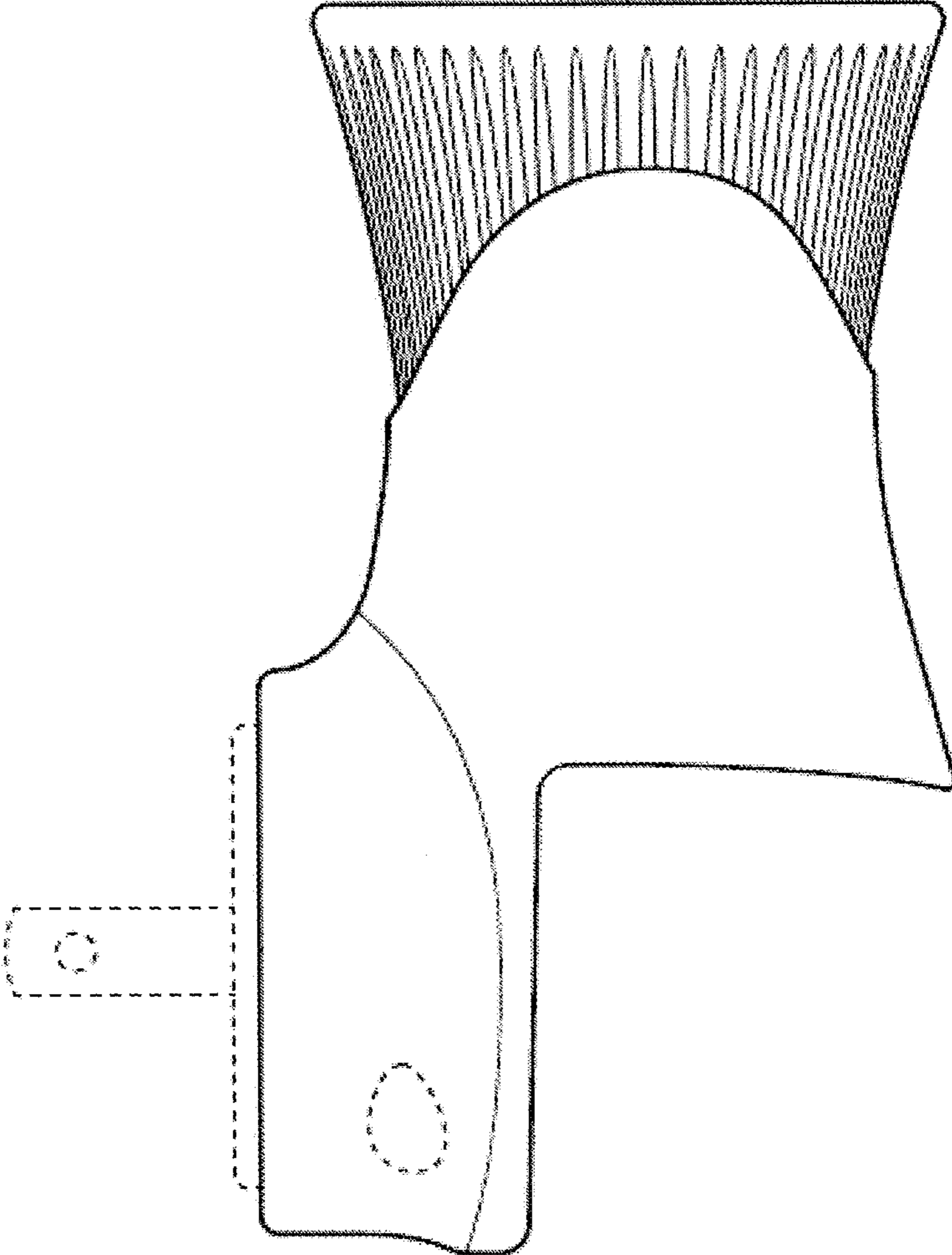

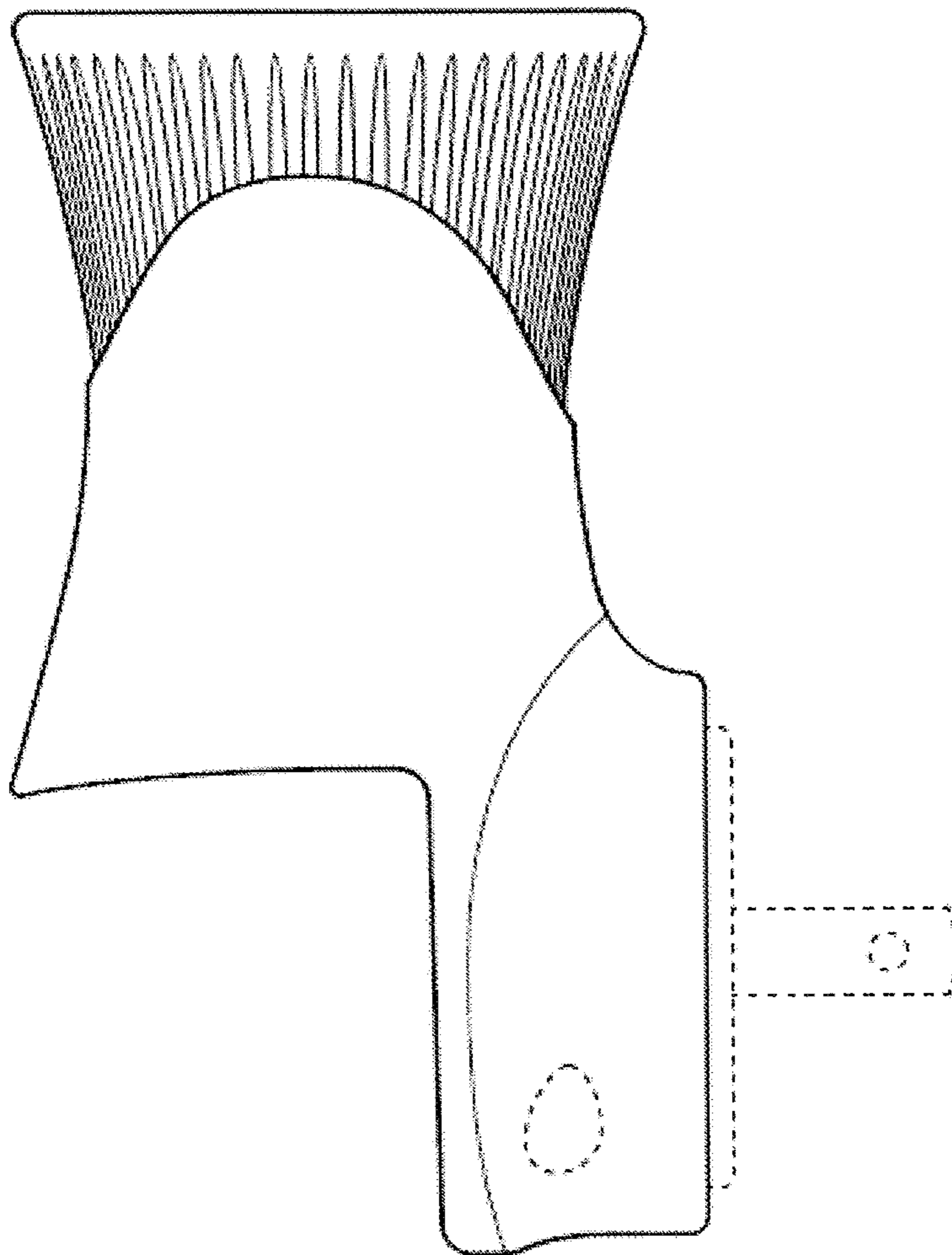
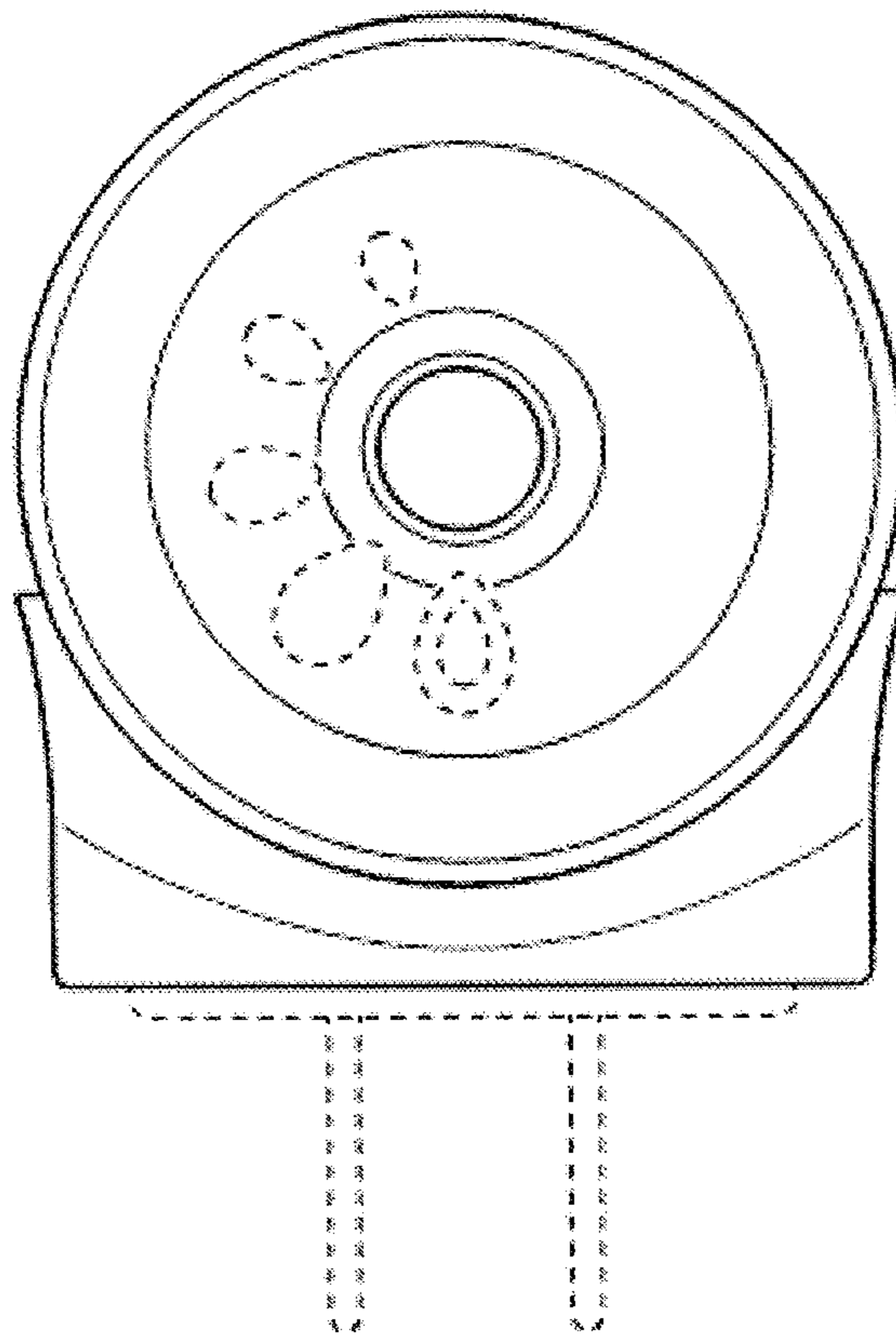

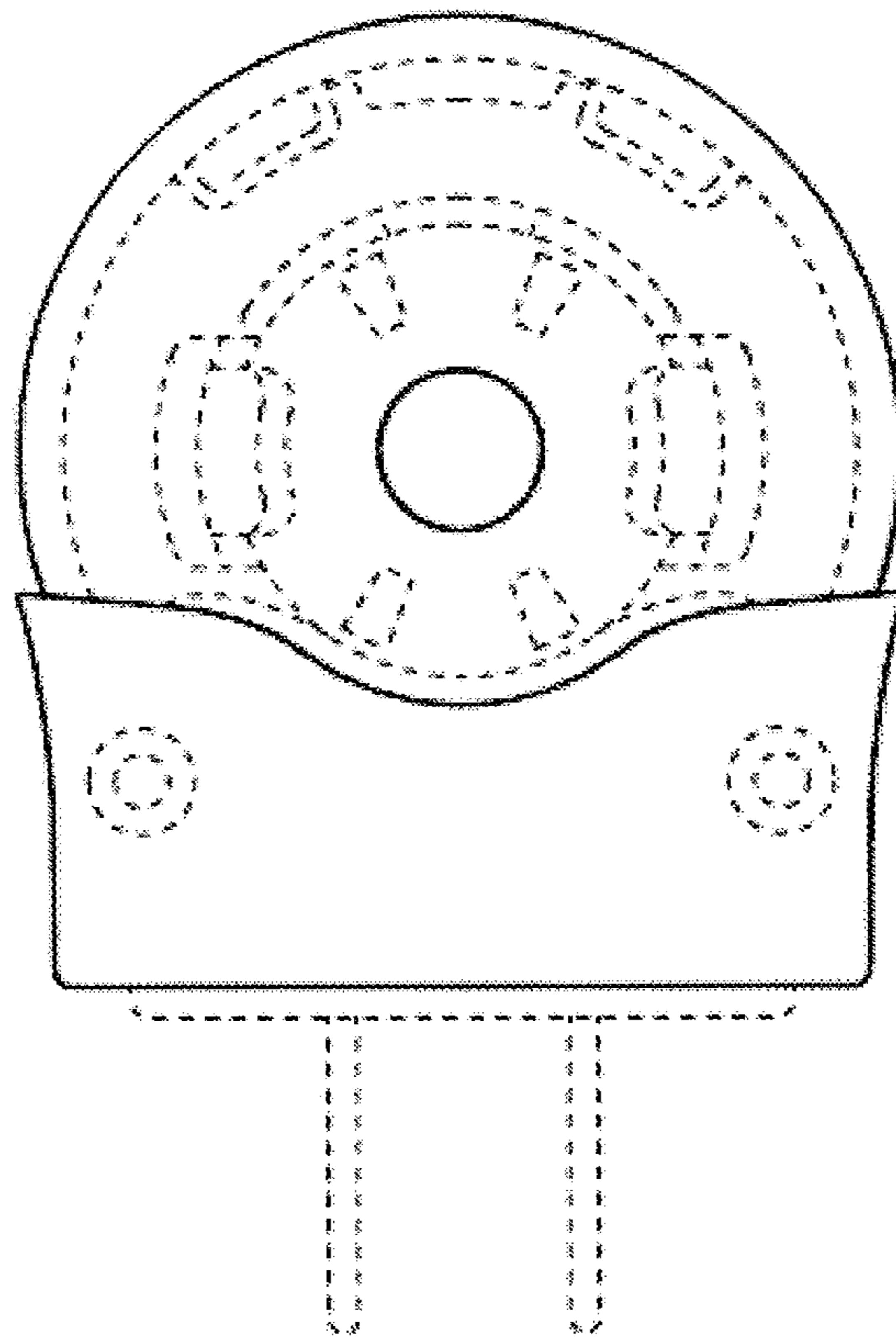
