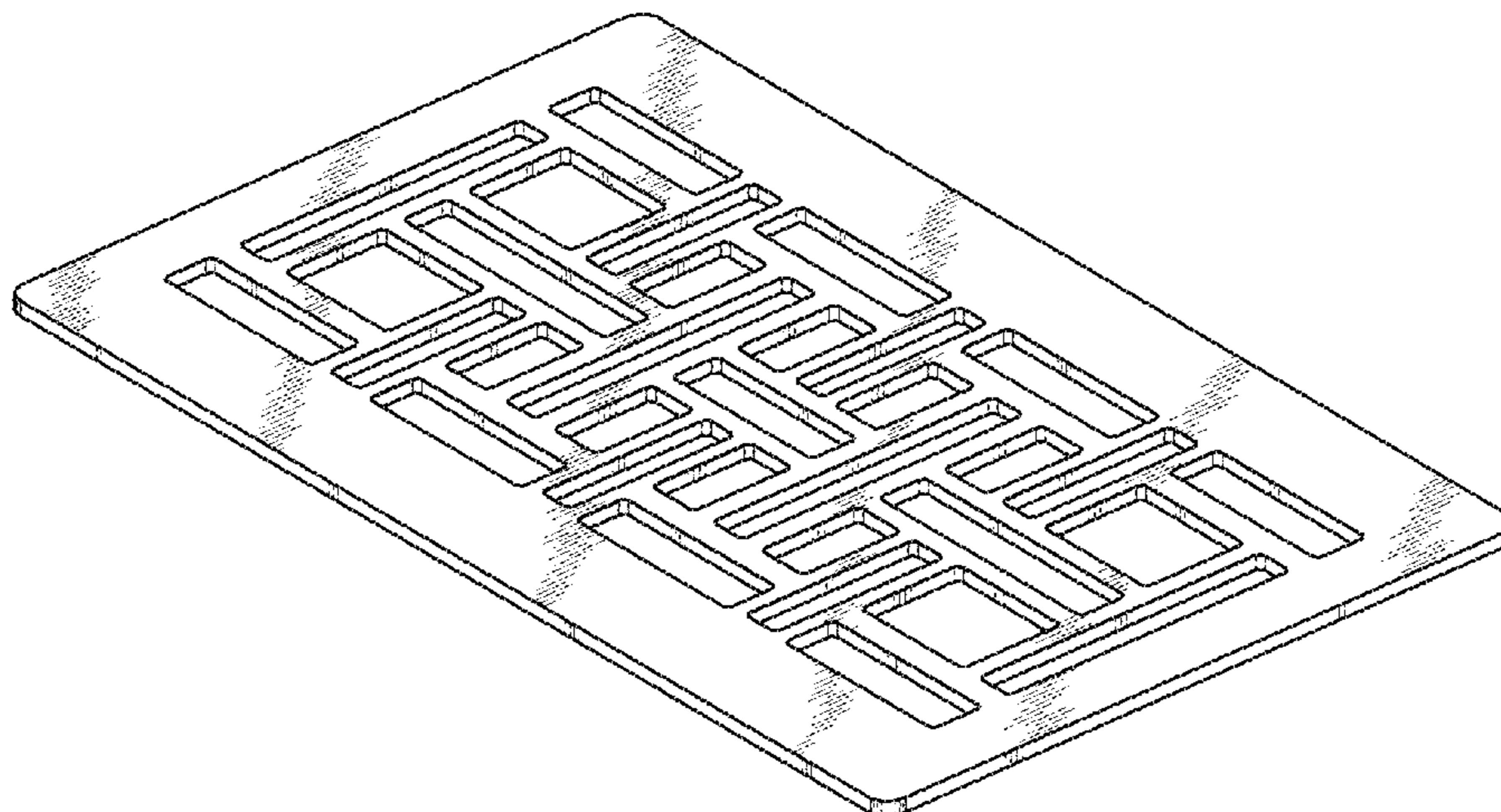
(57) **CLAIM**

The ornamental design for a floor register grille, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the floor register grille showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a front elevation view thereof, the rear elevation view being identical;  
FIG. 4 is a side elevation view thereof, both sides being identical;  
FIG. 5 is a top perspective view of a second embodiment of the floor register grille;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a front elevation view thereof, the rear elevation view being identical; and,  
FIG. 8 is a side elevation view thereof, both sides being identical.

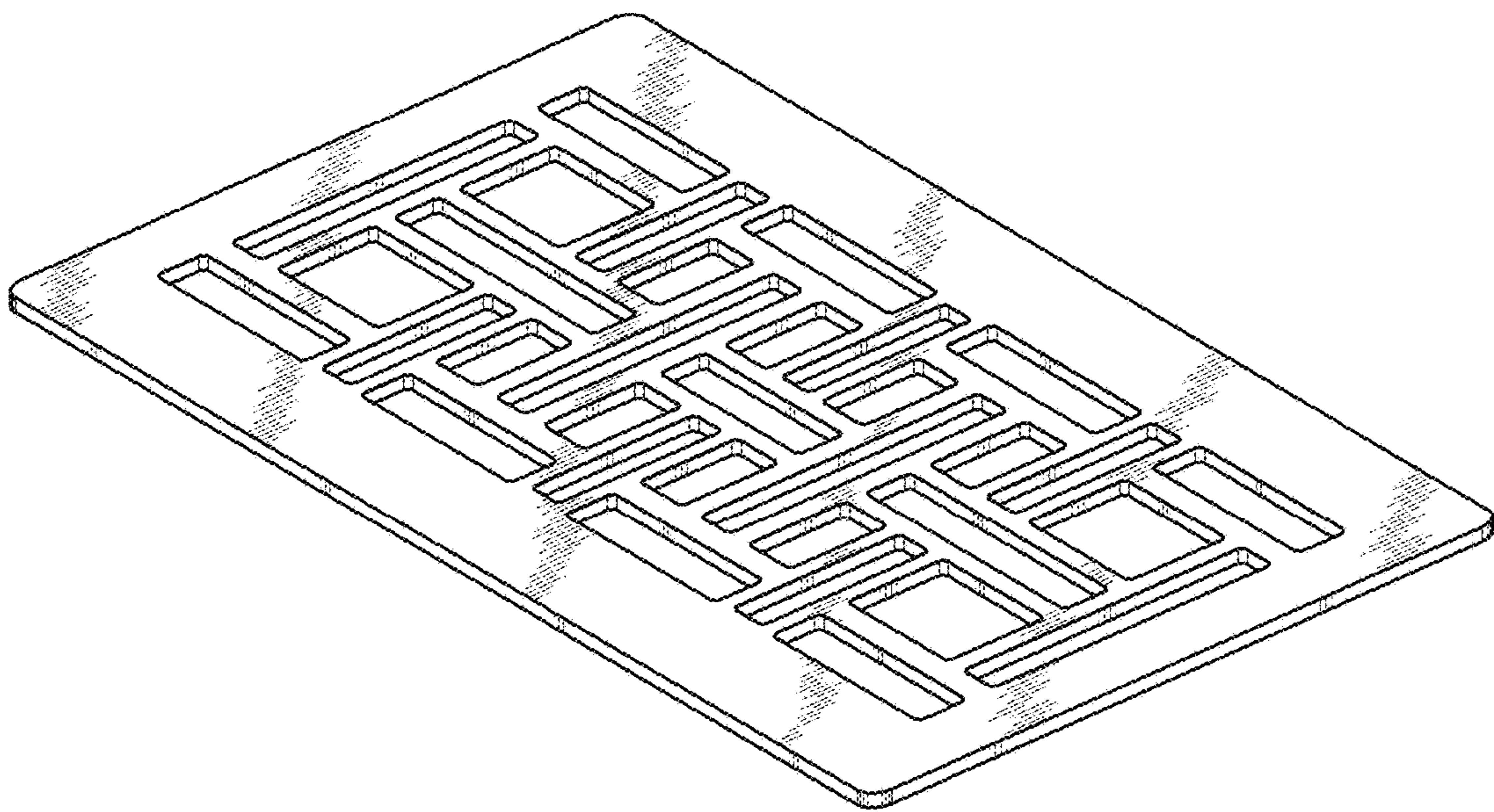

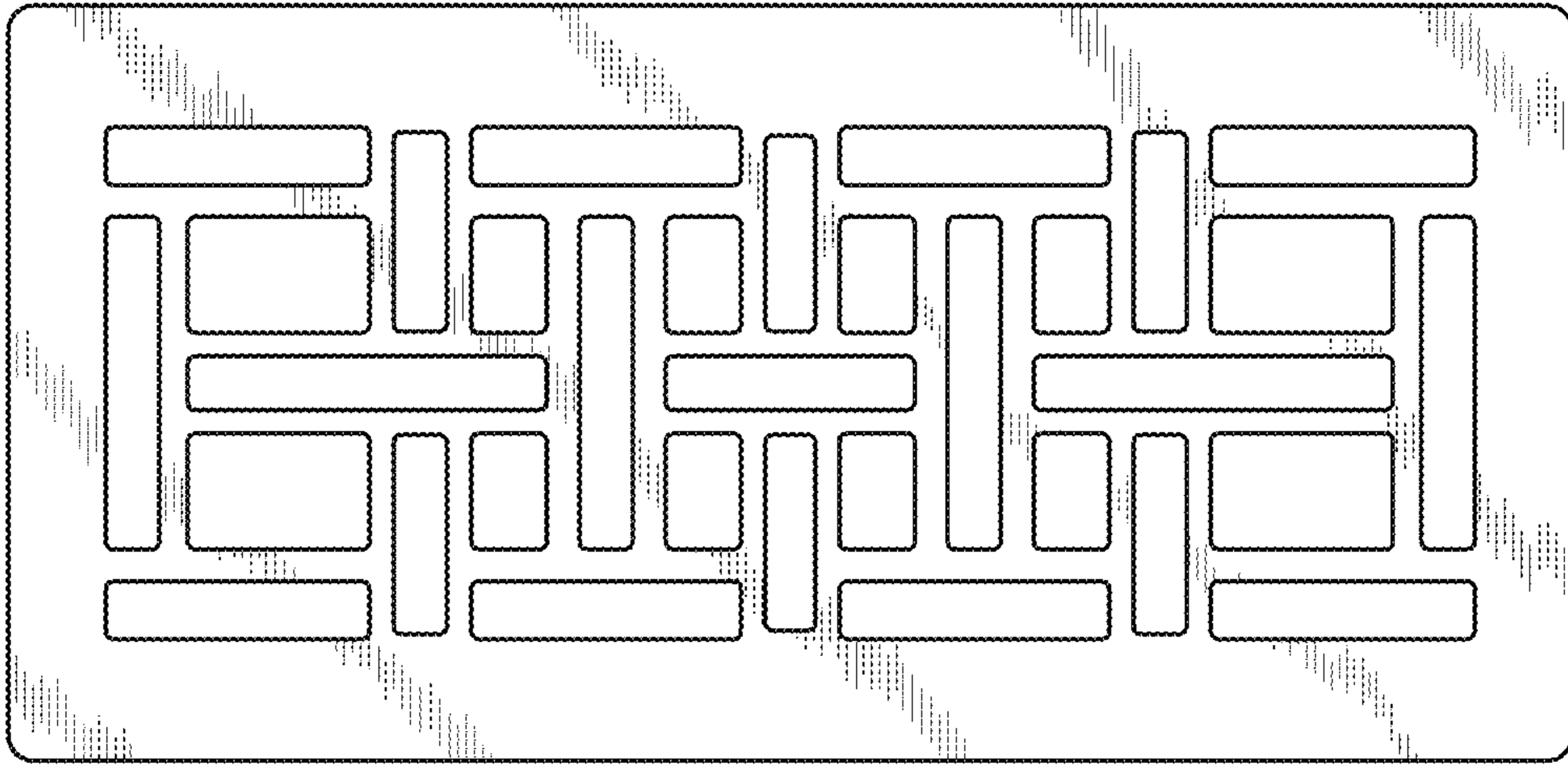

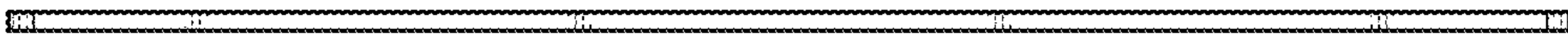

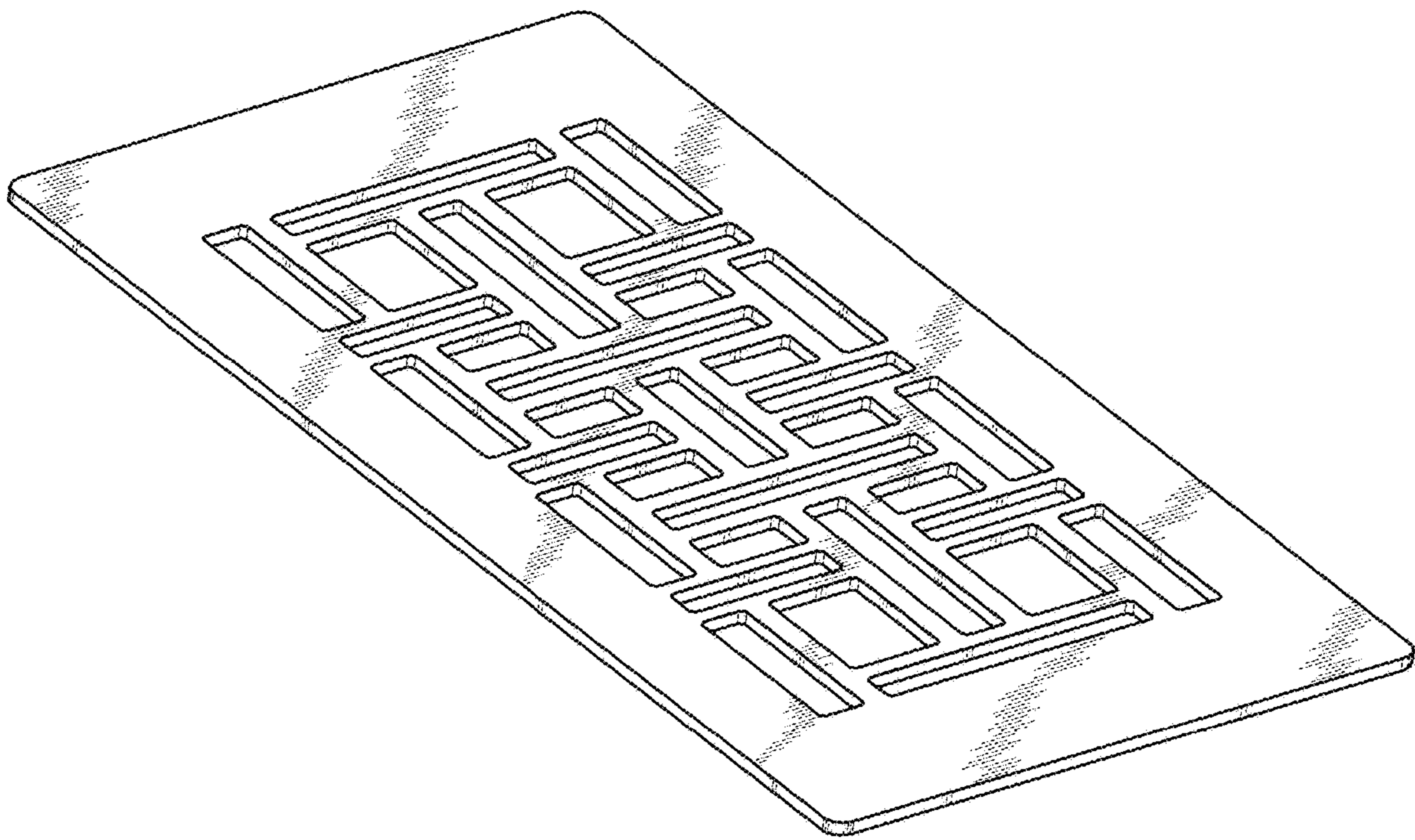

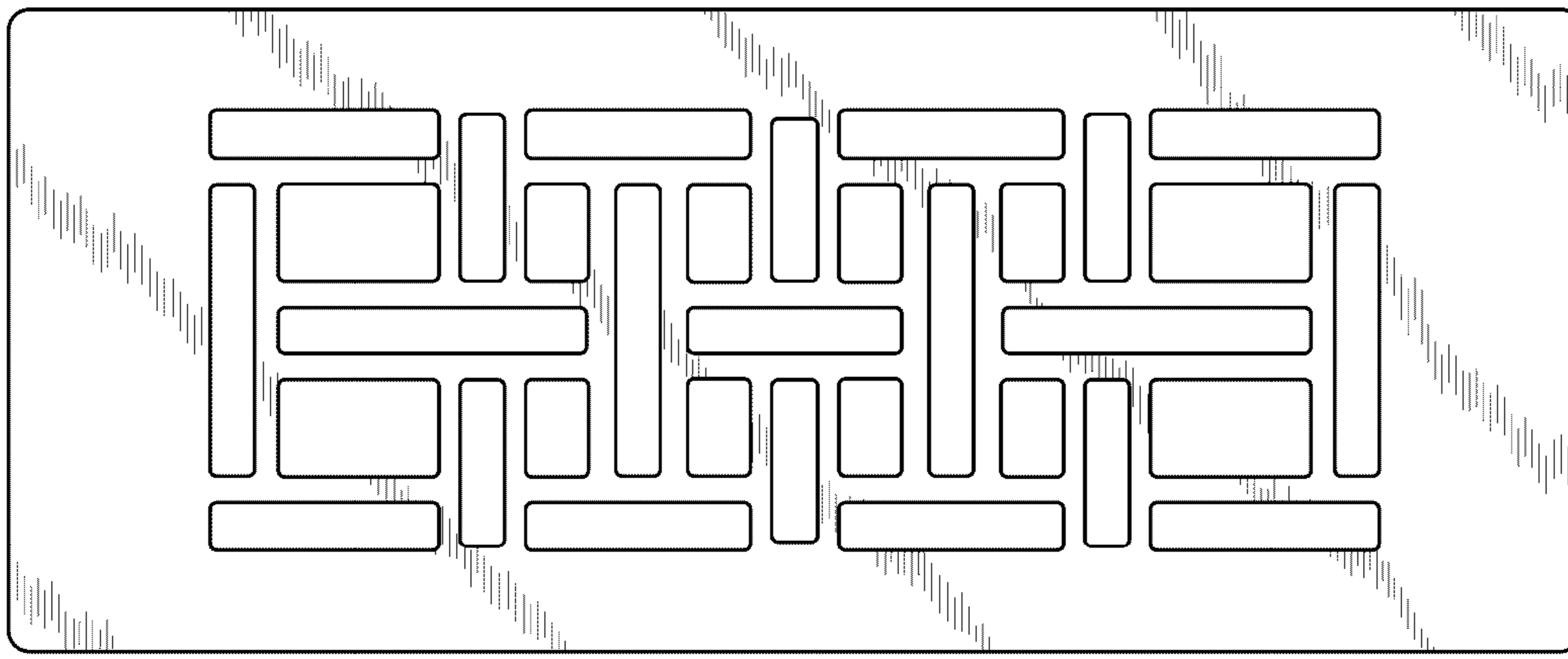
