**DESCRIPTION**

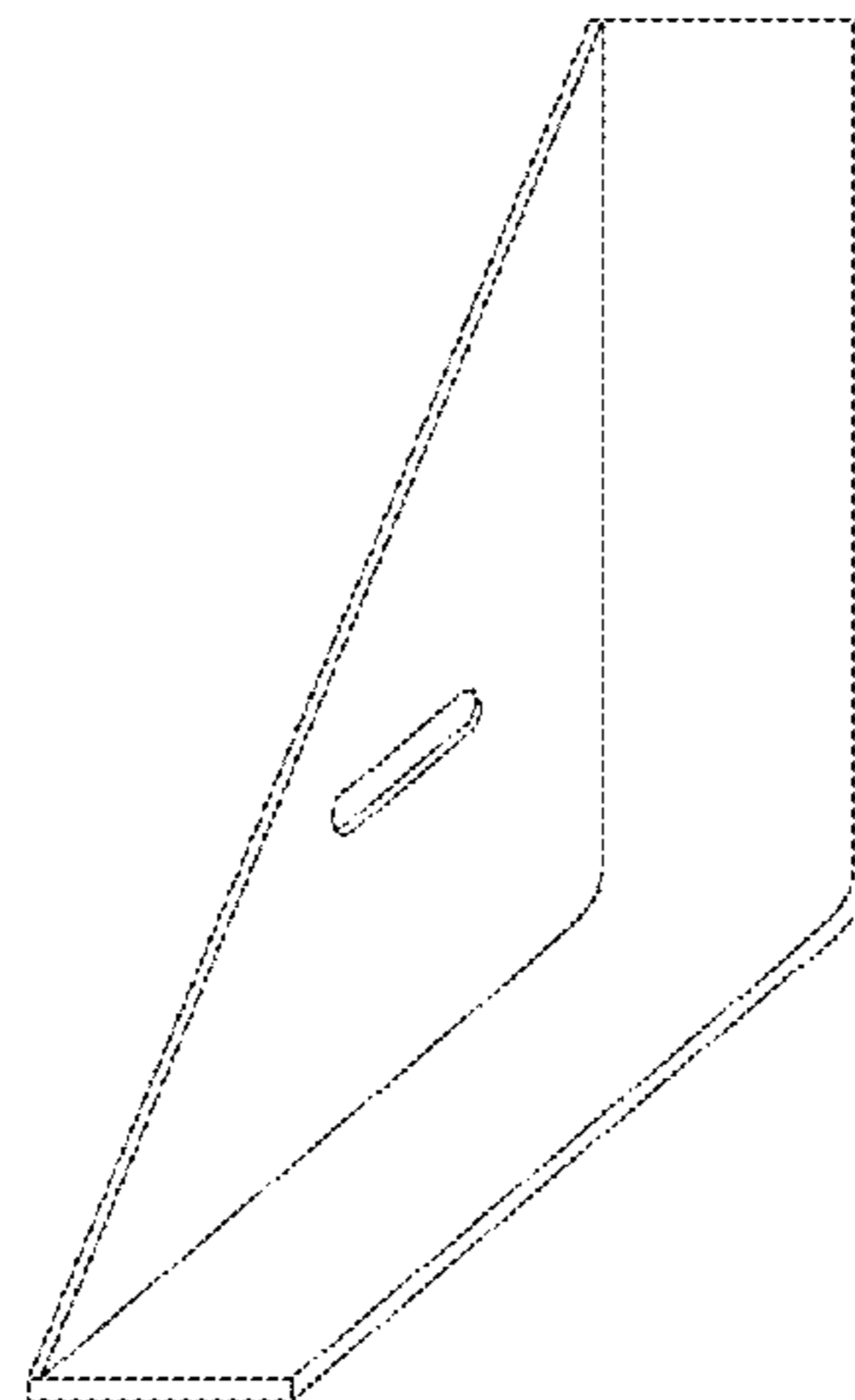
1. Anti flood barrier

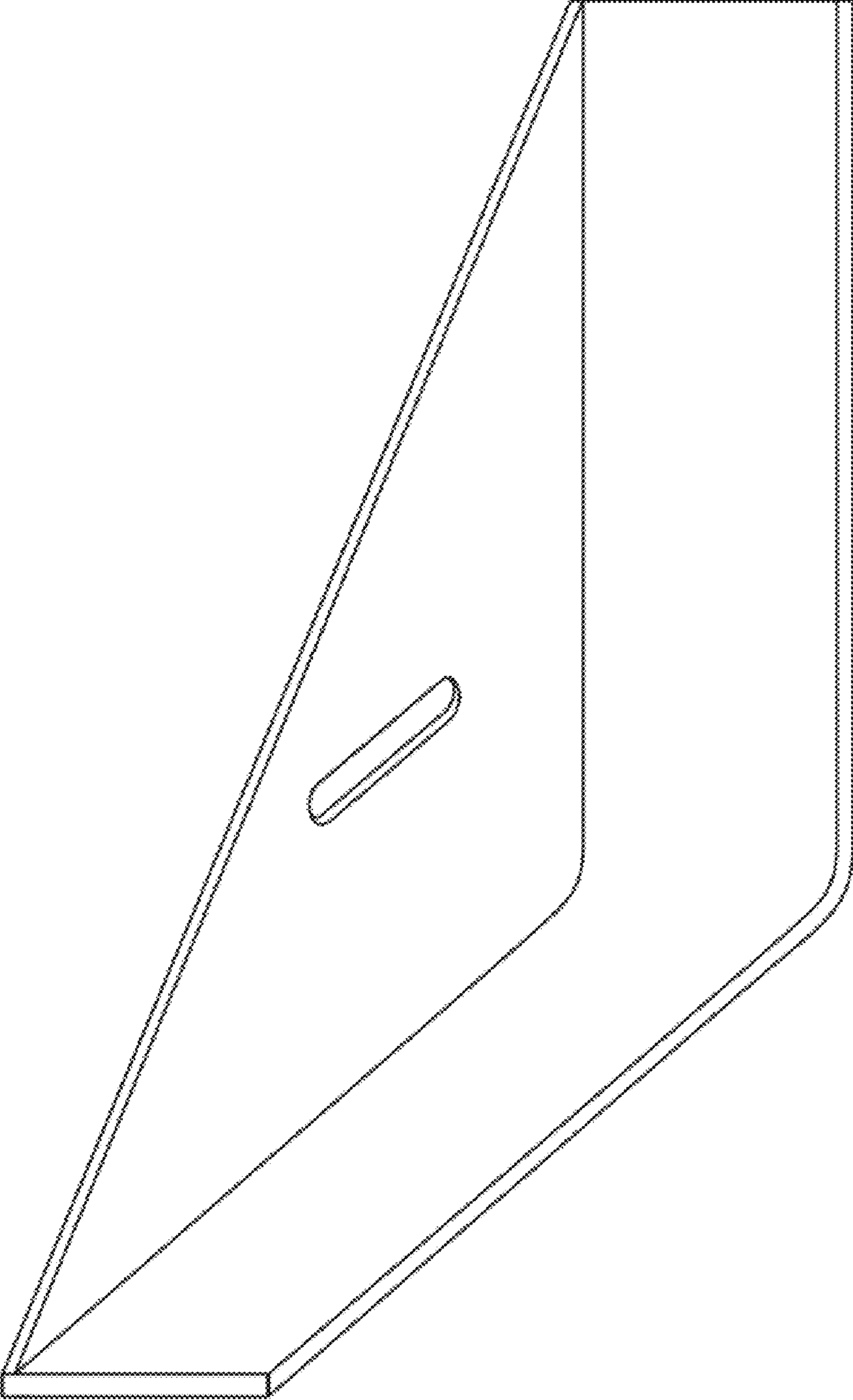

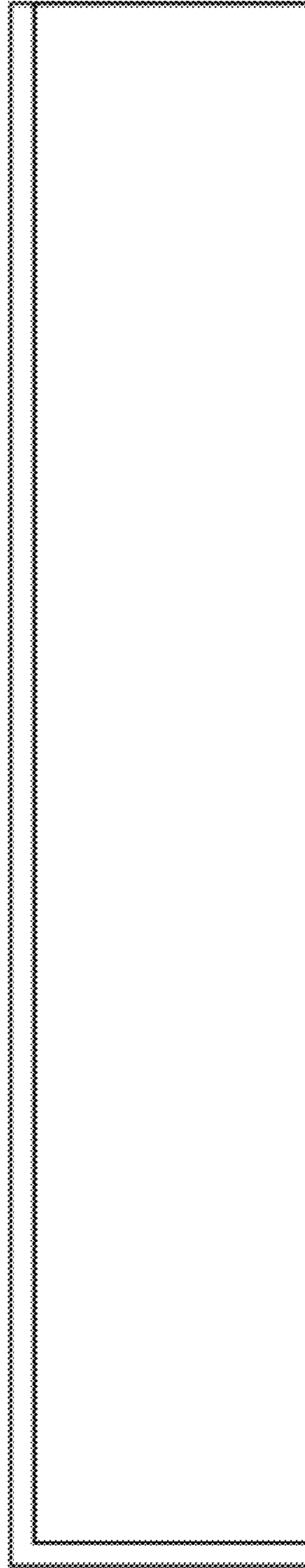

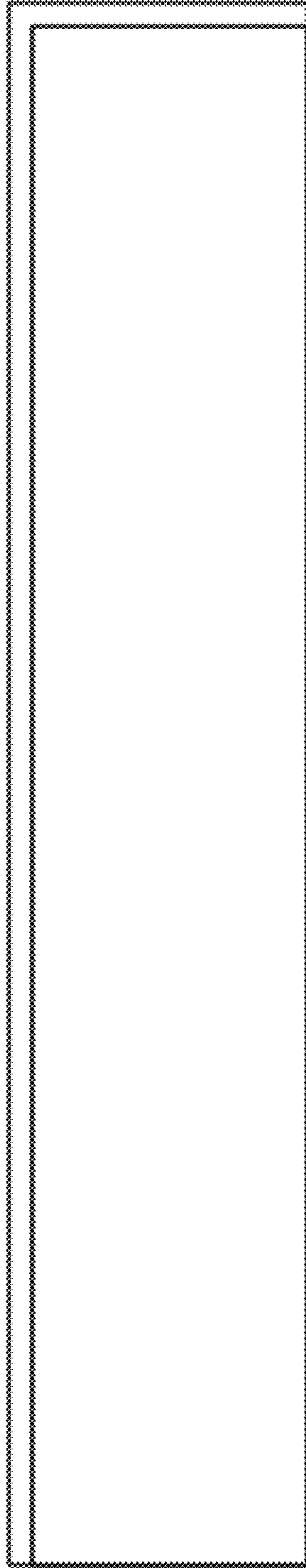

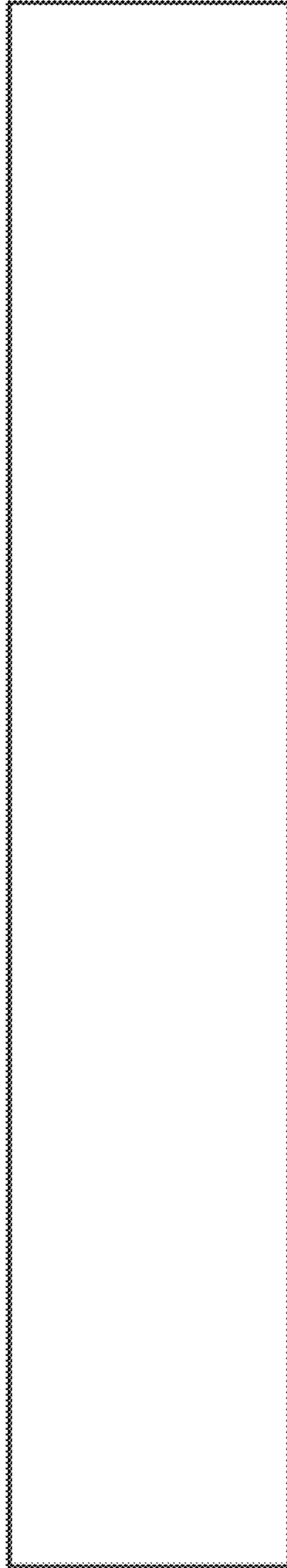

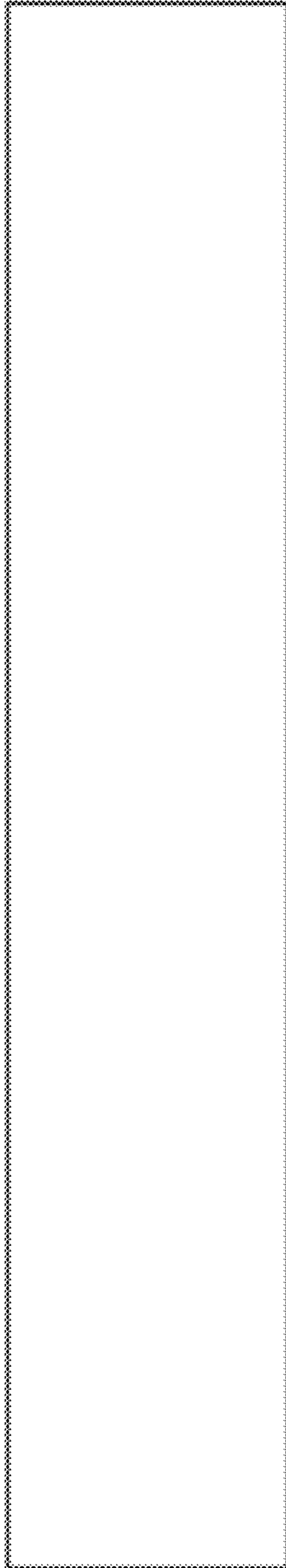

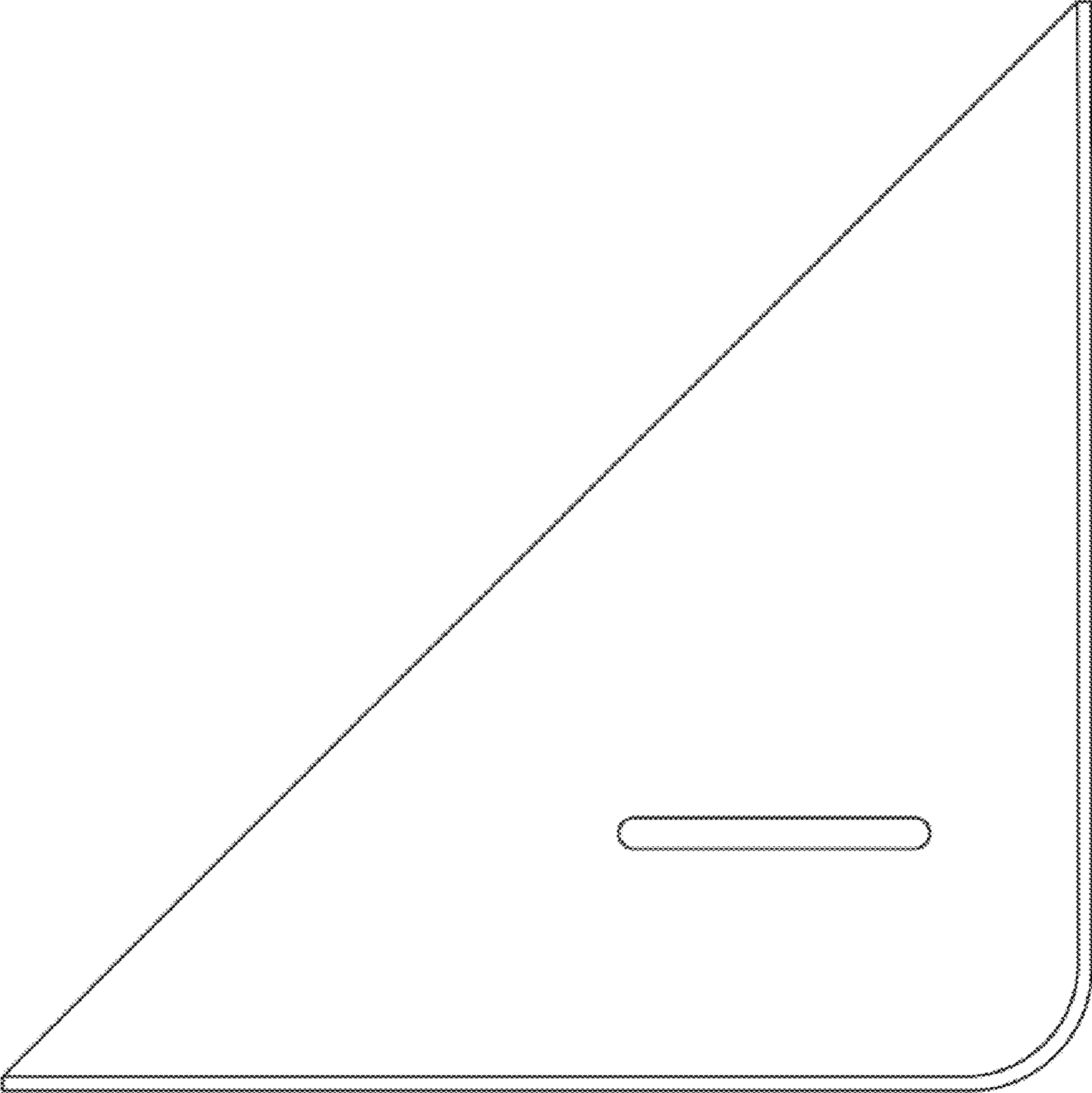
