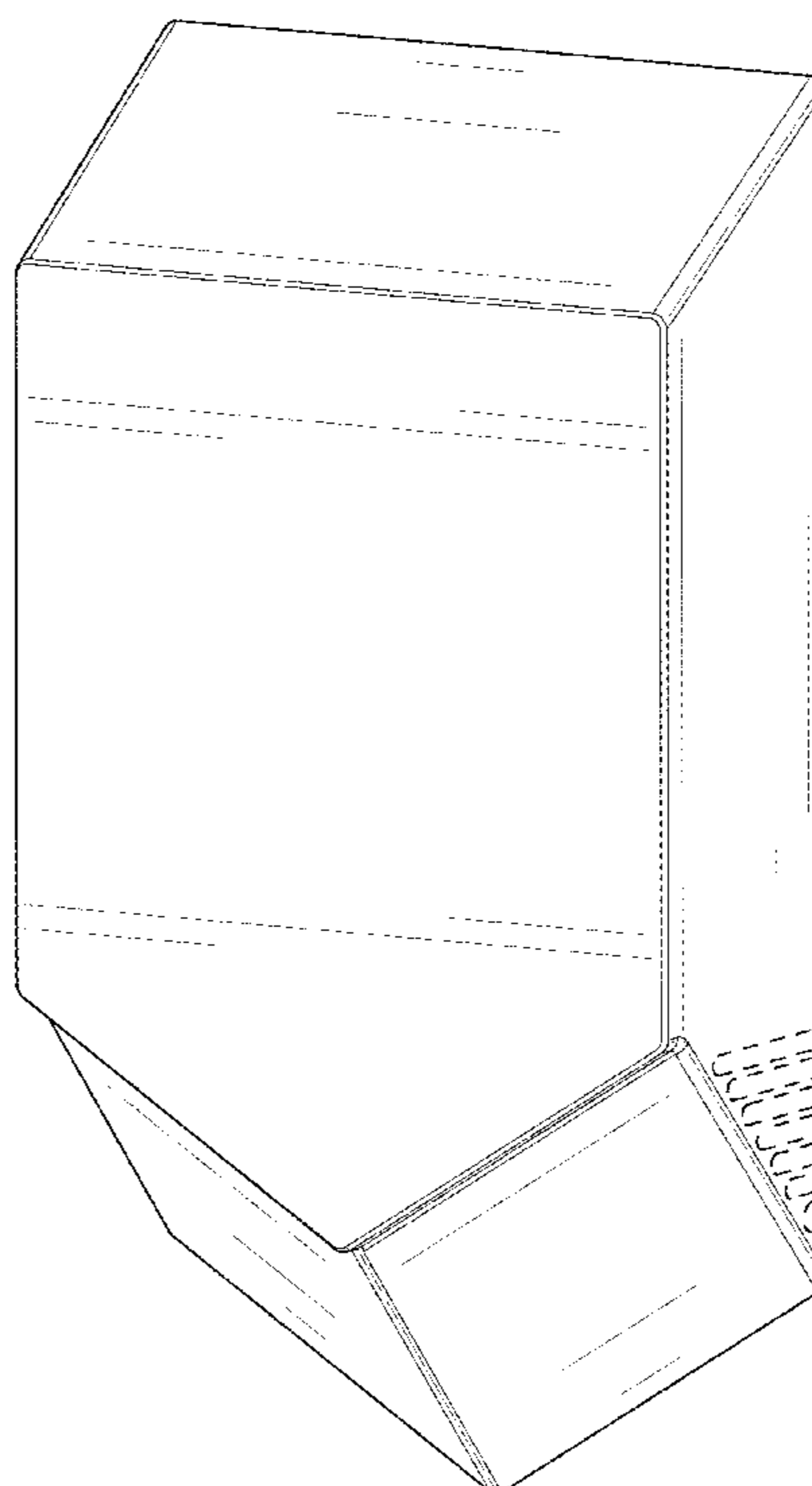
(57) **CLAIM**

We claim the ornamental design for a hand dryer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hand dryer showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a back view thereof;  
FIG. 4 is a side view thereof;  
FIG. 5 is a side view of the opposite side of FIG. 4;  
FIG. 6 is a top view thereof; and,

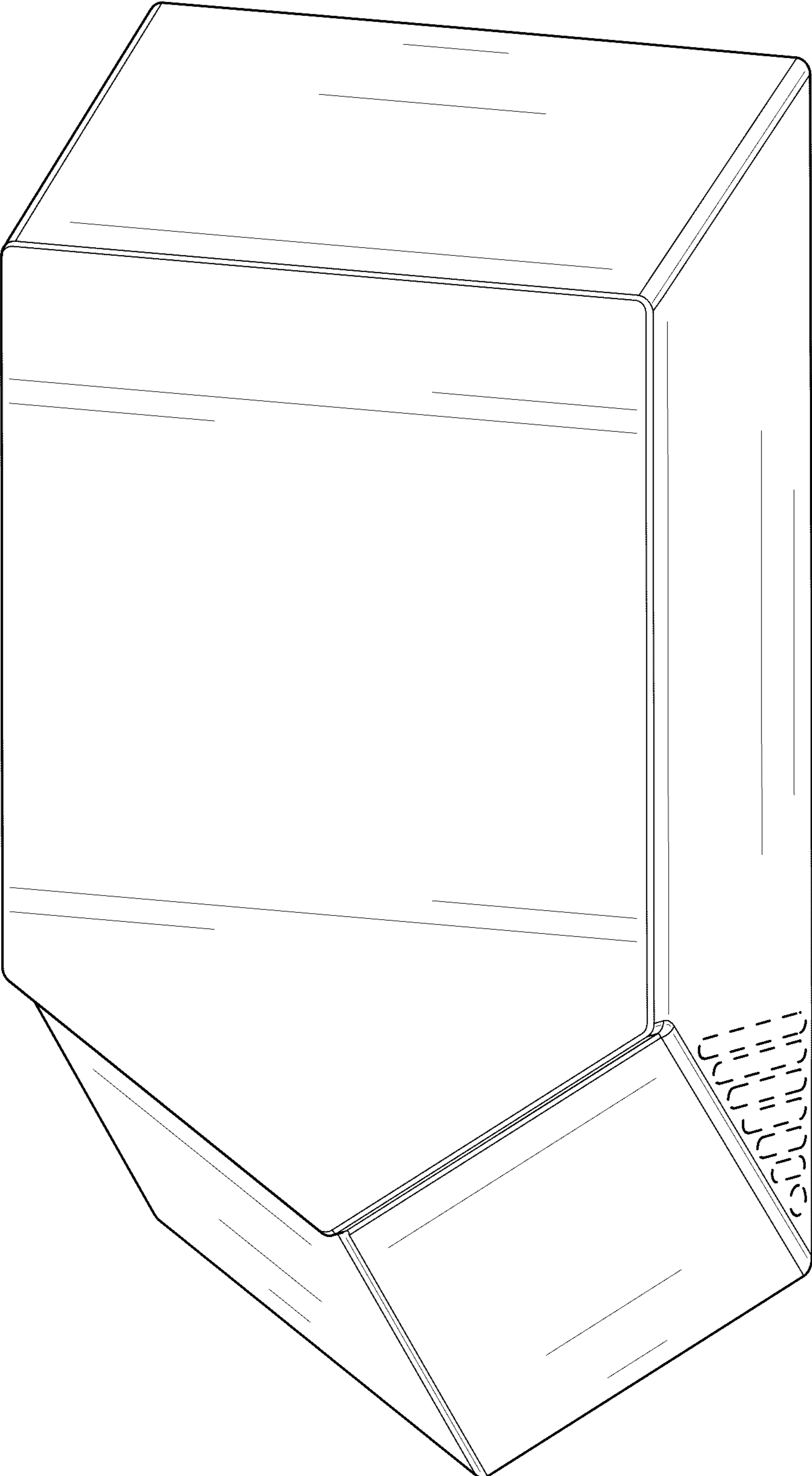

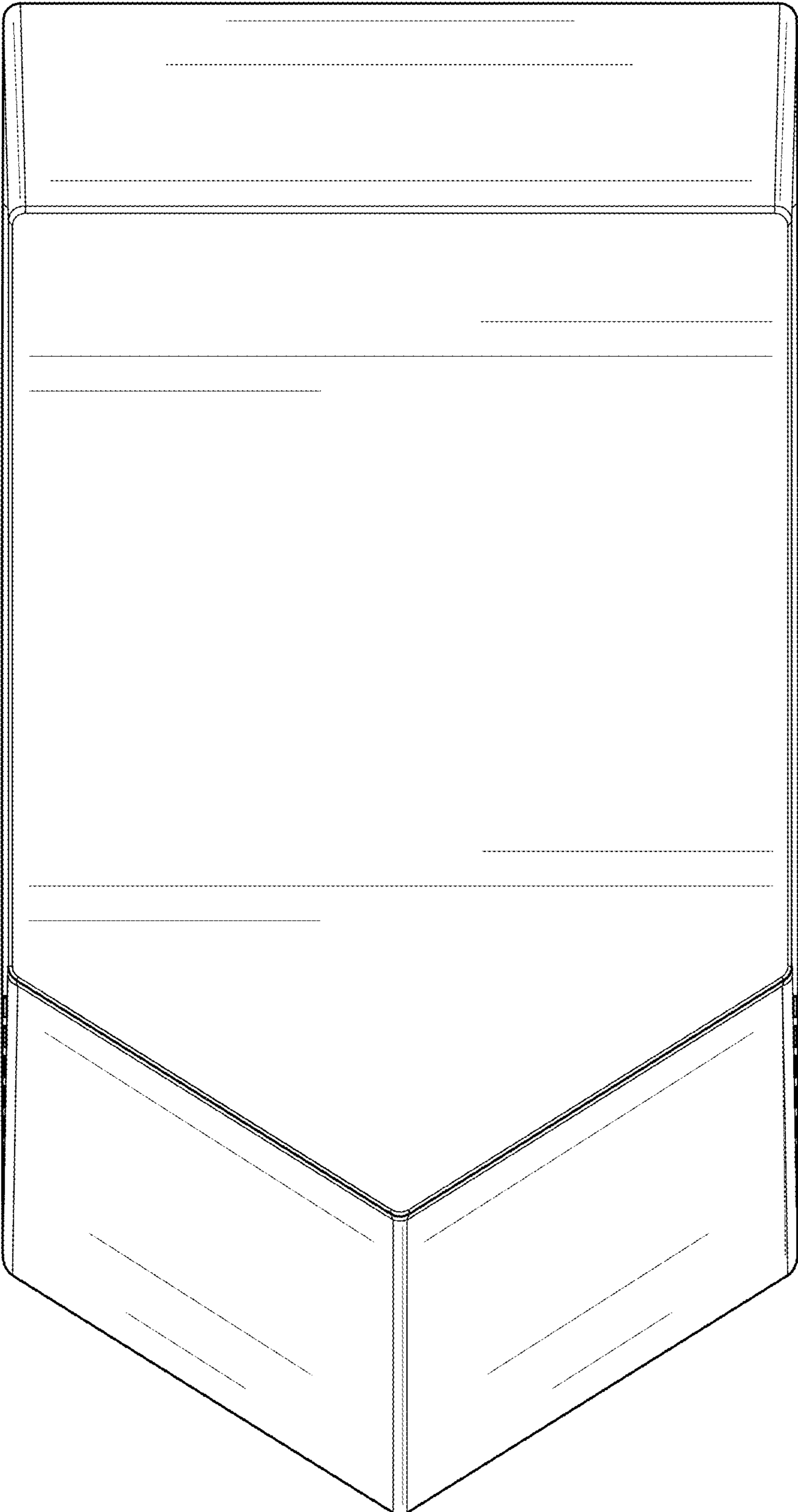

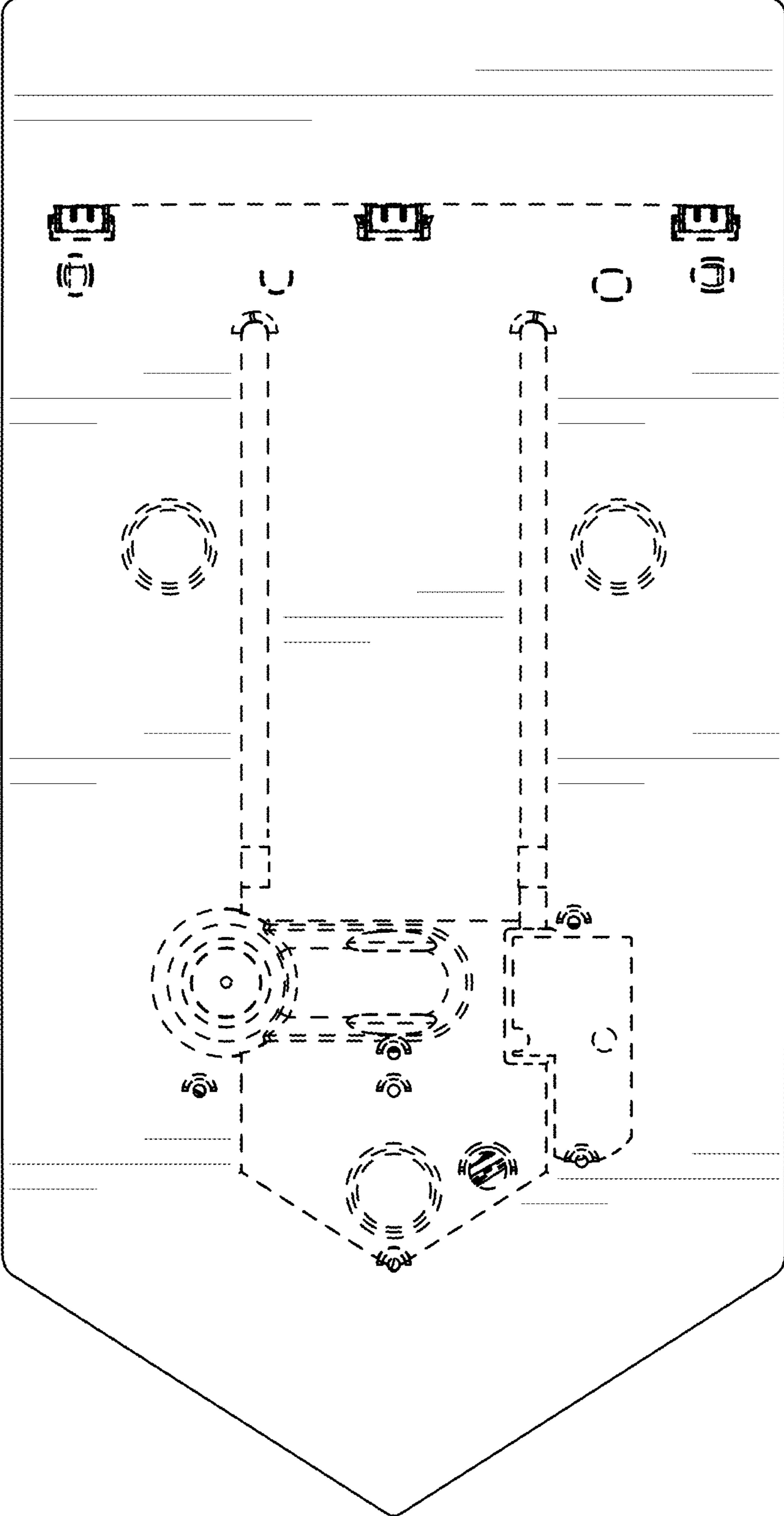

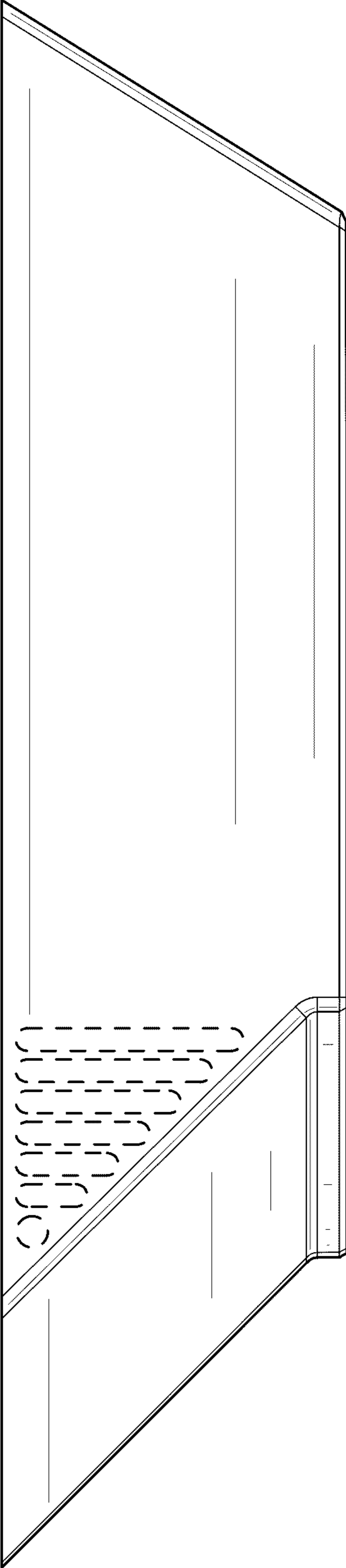

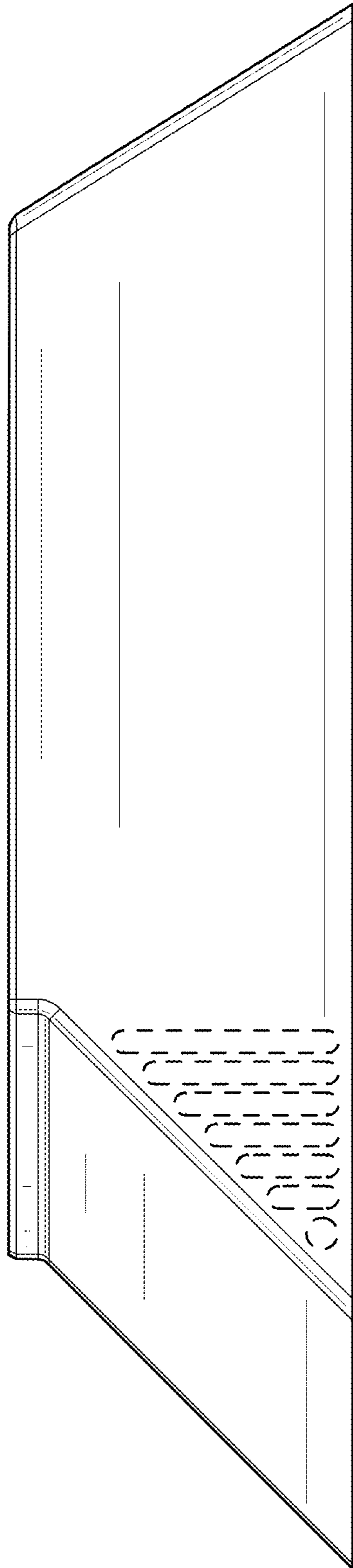

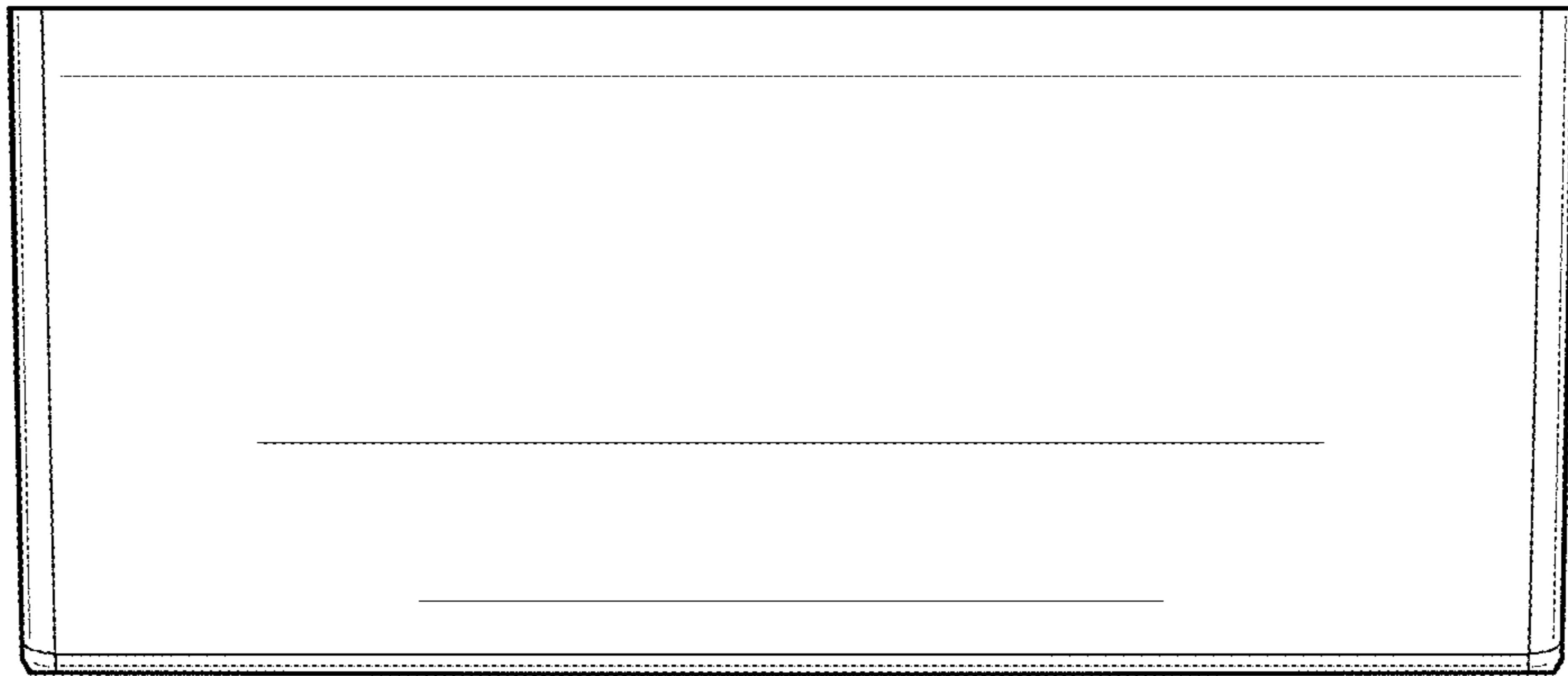

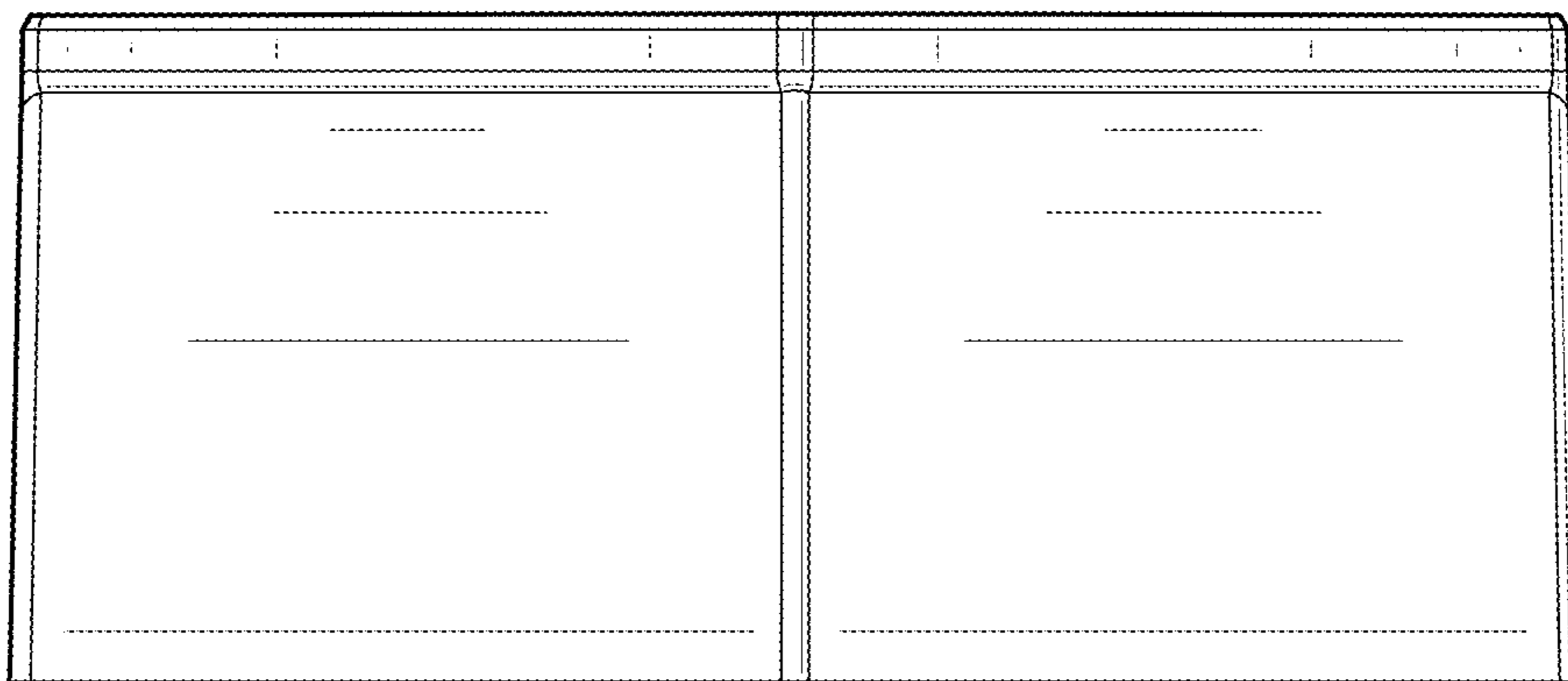
