DESCRIPTION

FIG. 1 is a bottom plan view of a working glove showing our new design;

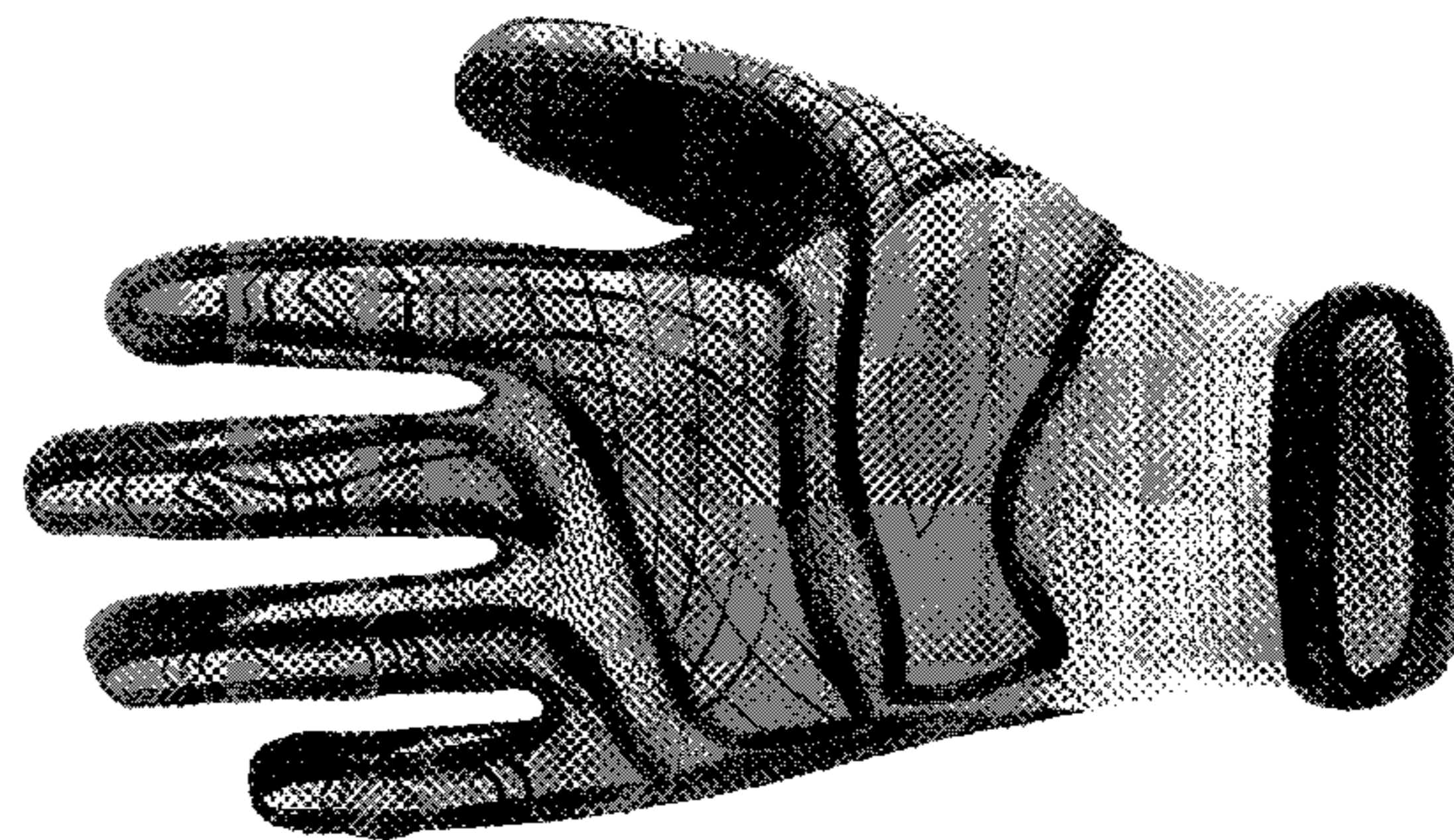

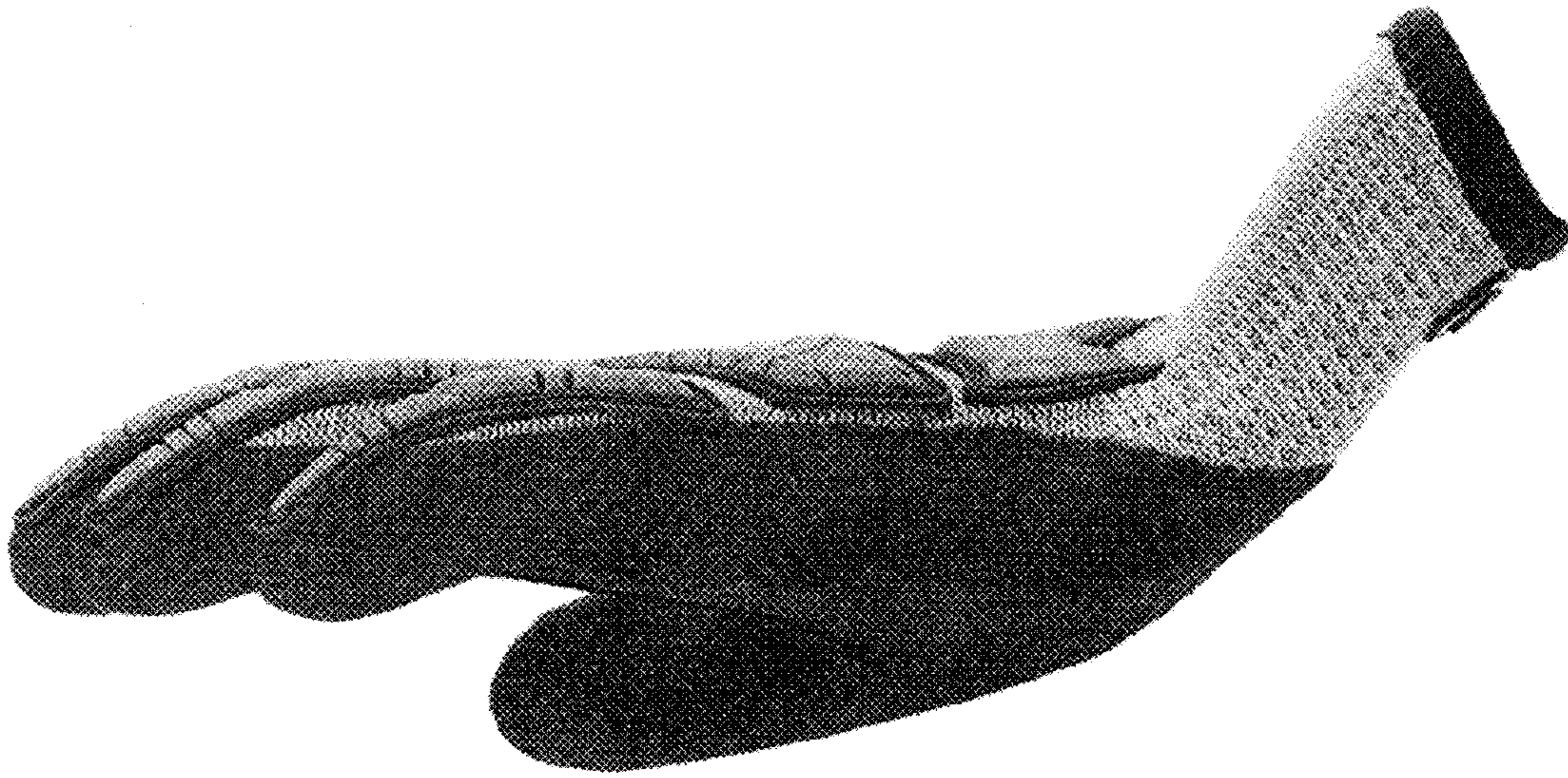

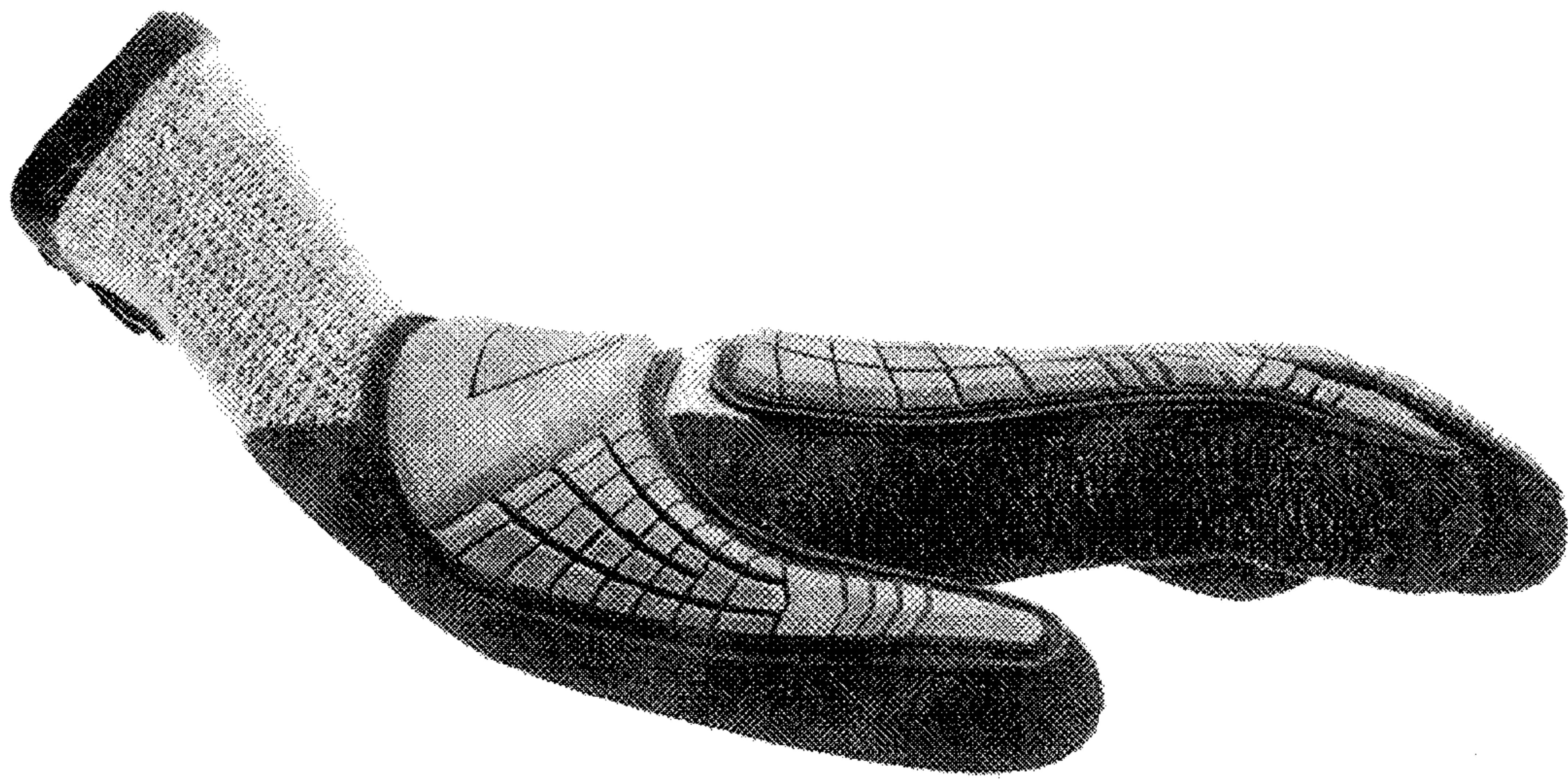
