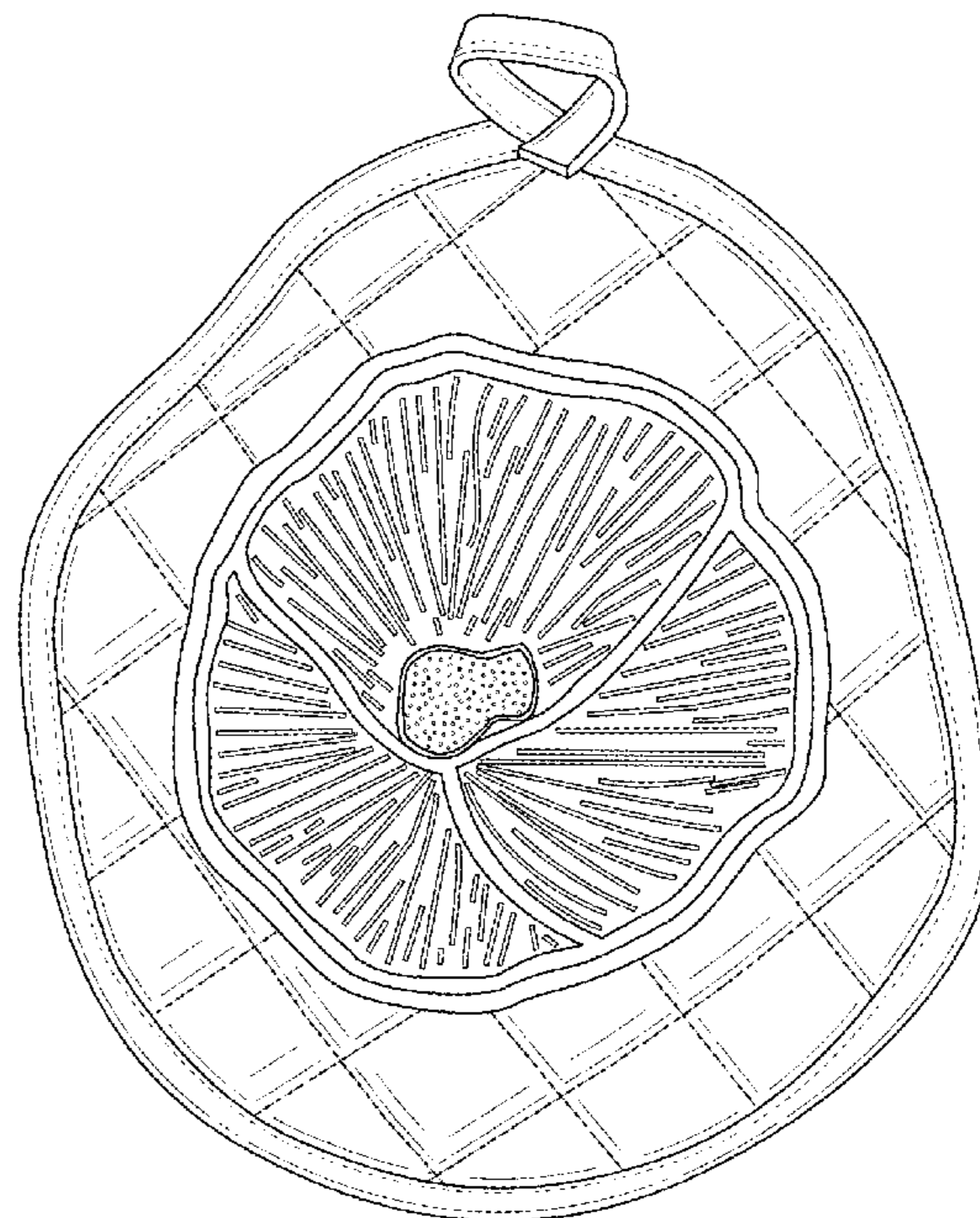
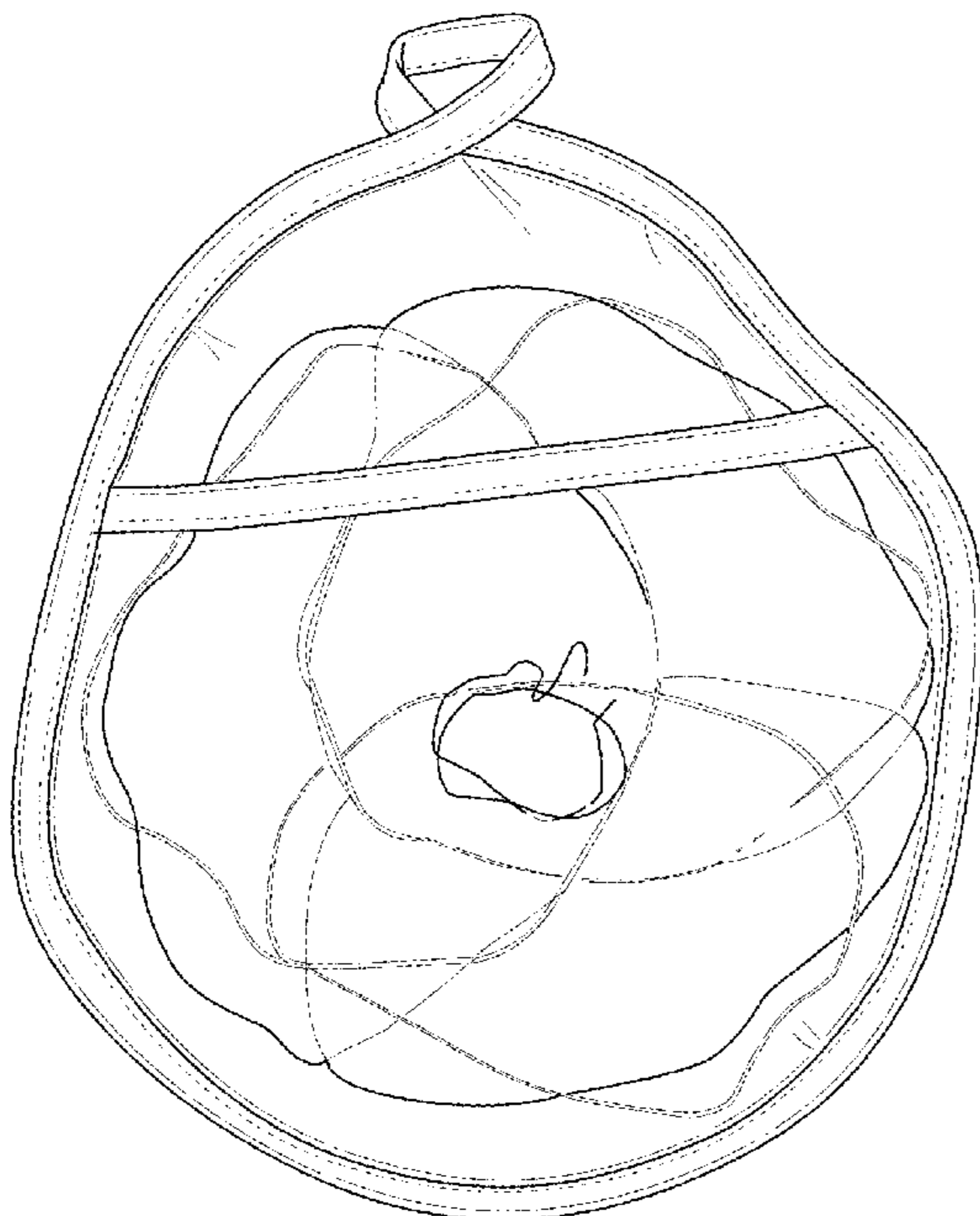
(57) **CLAIM**

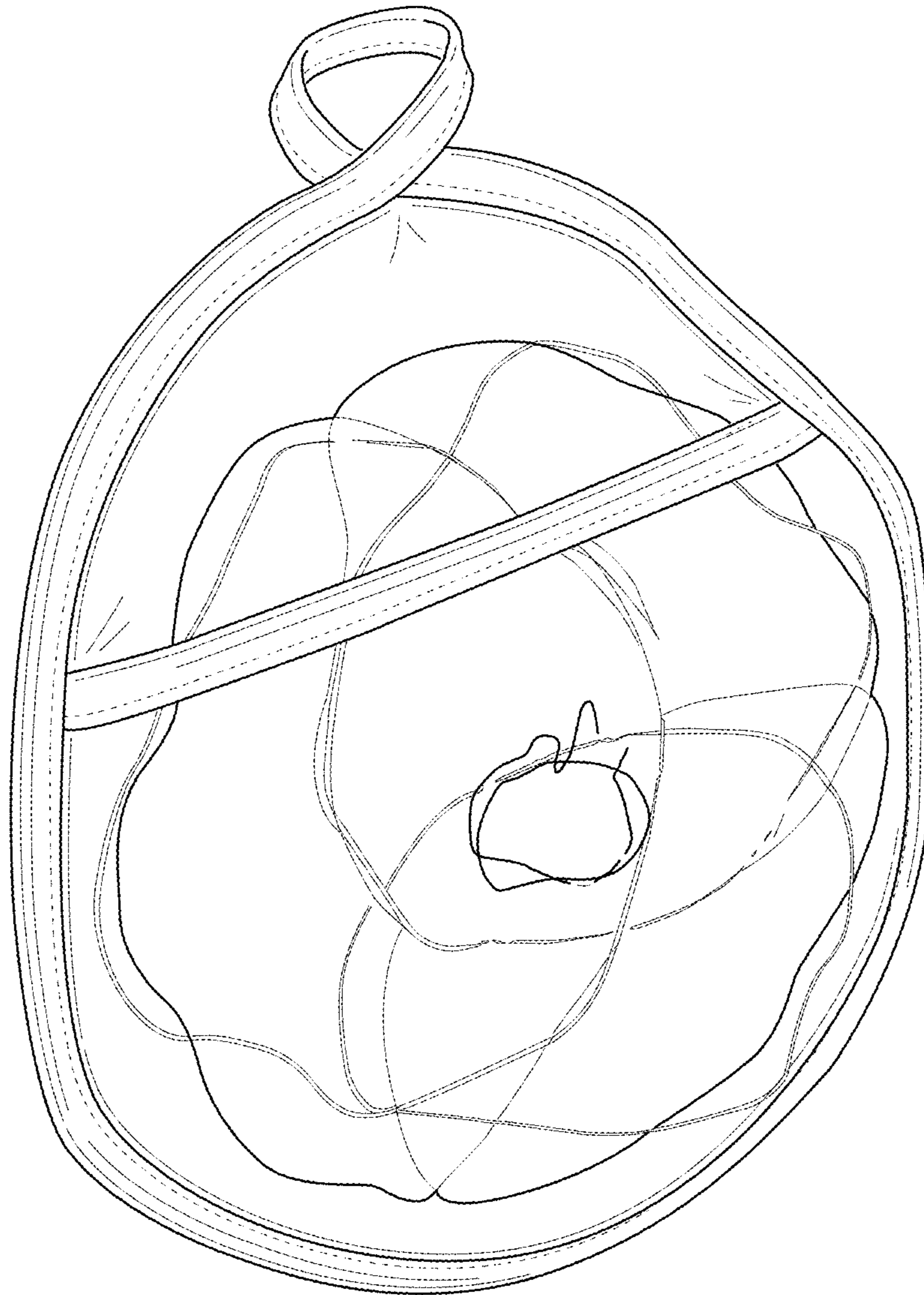
I claim, the ornamental design for a pot holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view, showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a left side view thereof; and, FIG. 7 is a right side view thereof. 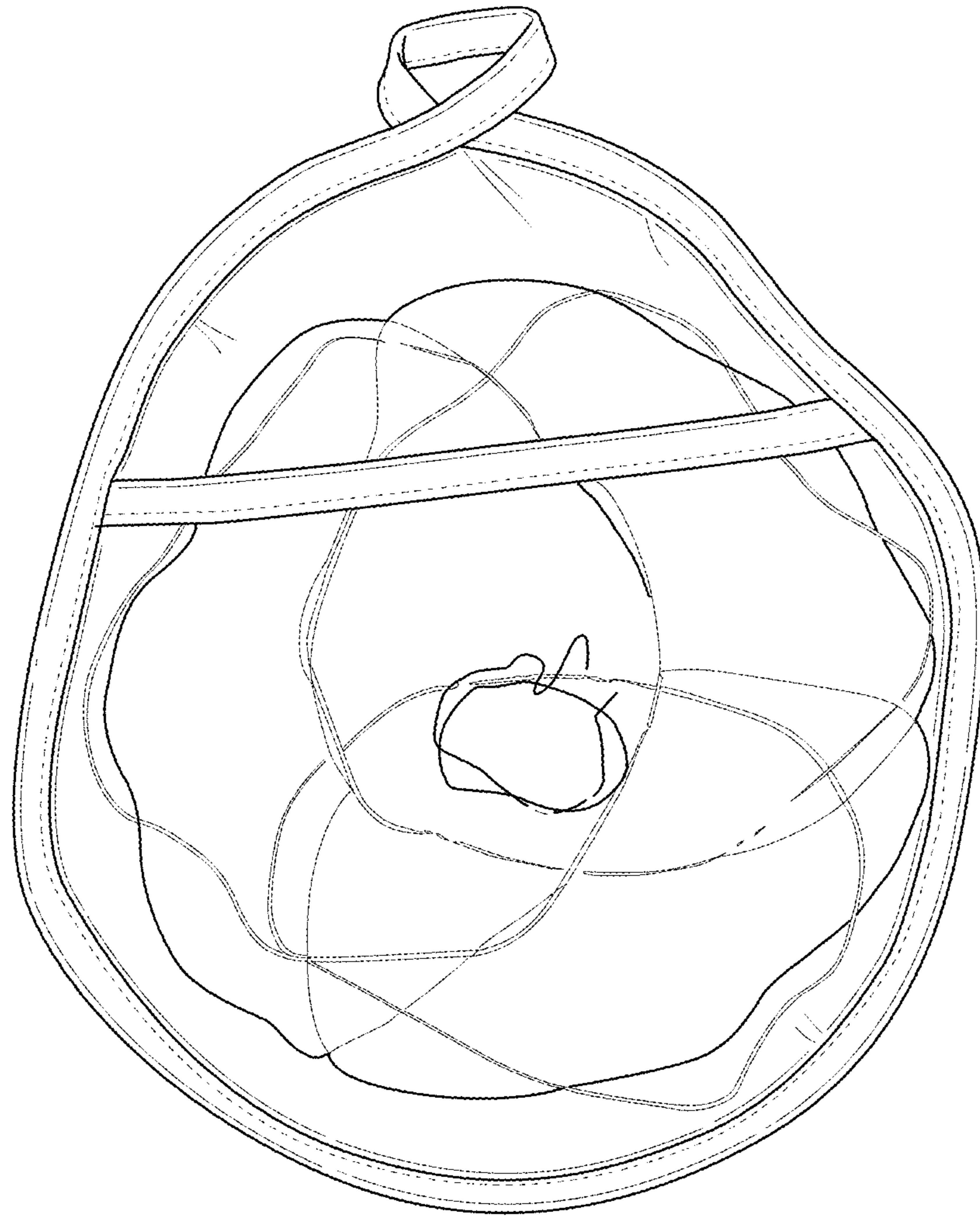

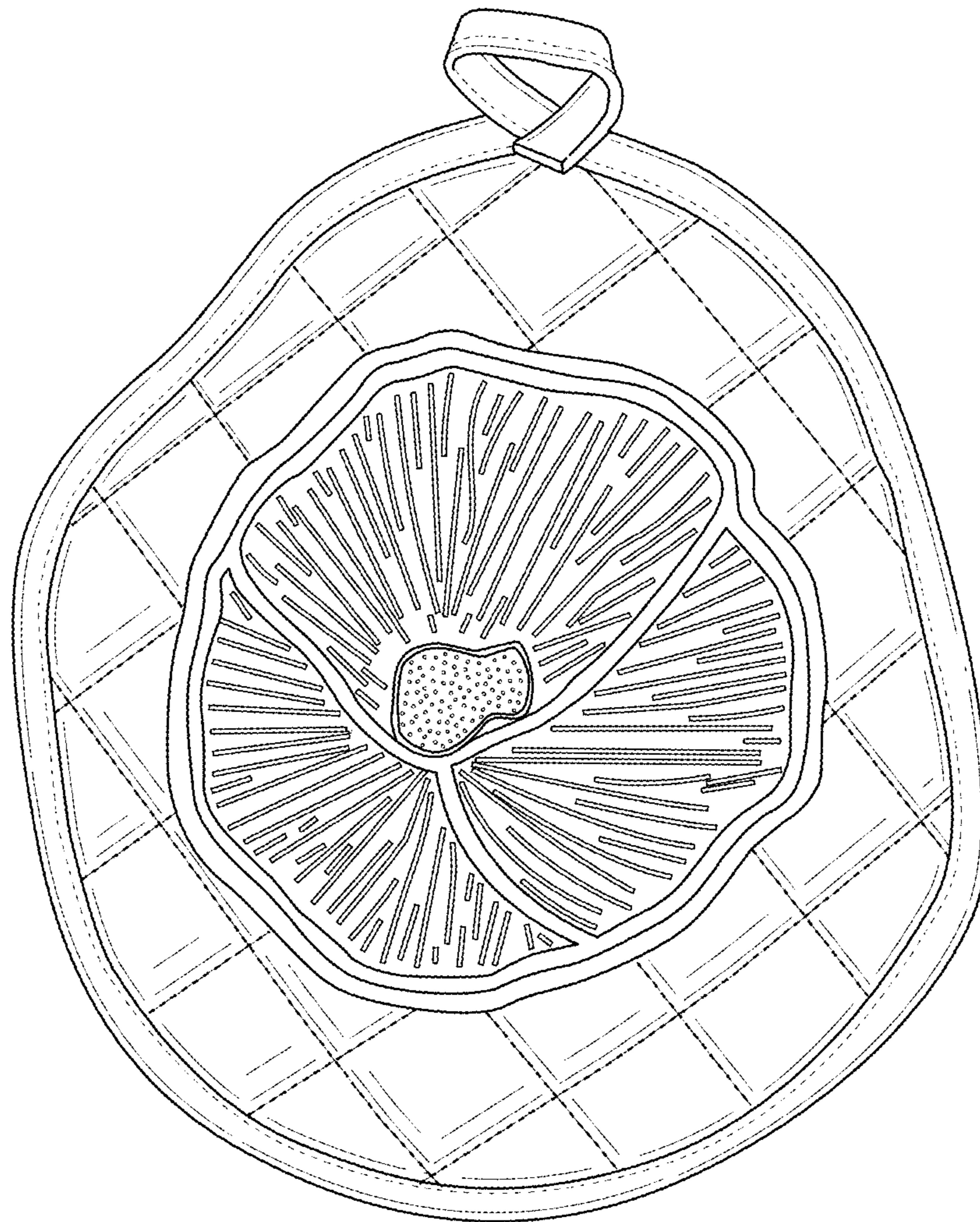
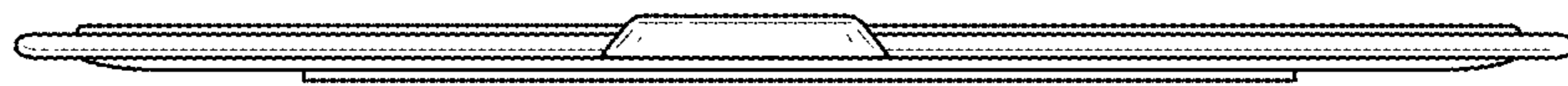


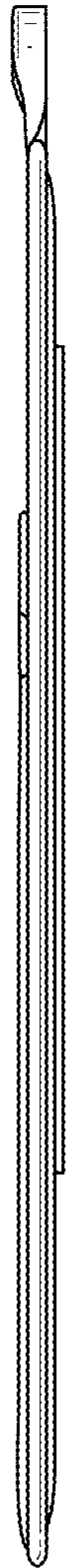
